(57) **CLAIM**

The ornamental design for a food container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the food container, showing my new design;

FIG. 2 is a front elevation view of the design illustrated in FIG. 1;

FIG. 3 is a rear elevation view of the design illustrated in FIG. 1;

FIG. 4 is a right side elevation view of the design illustrated in FIG. 1;

FIG. 5 is a left side elevation view of the design illustrated in FIG. 1;

FIG. 6 is a top view of the design illustrated in FIG. 1;

FIG. 7 is a bottom view of the design illustrated in FIG. 1;

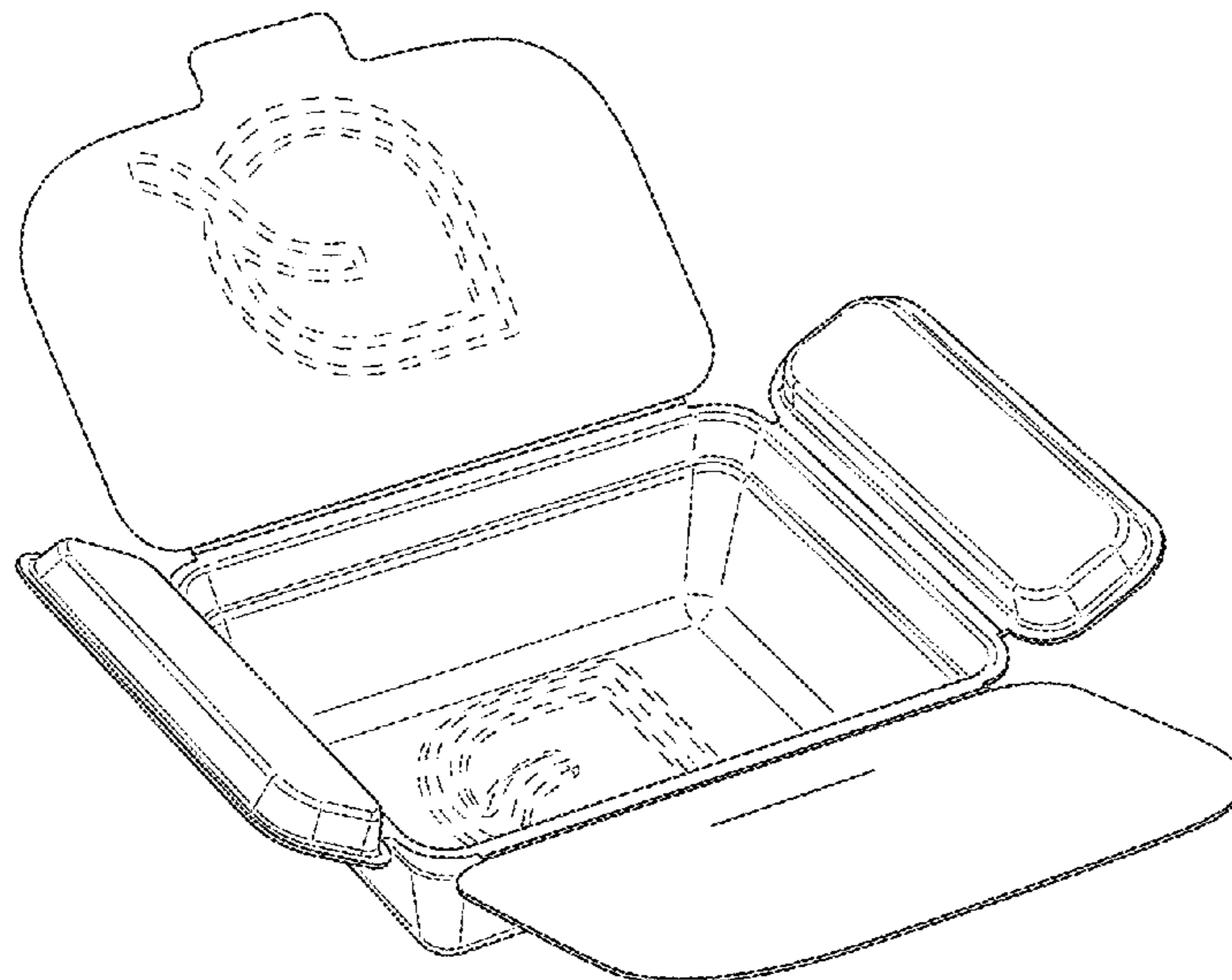
FIG. 8 is a top view of the design illustrated in FIG. 1 showing the flaps of the design in an alternate position;

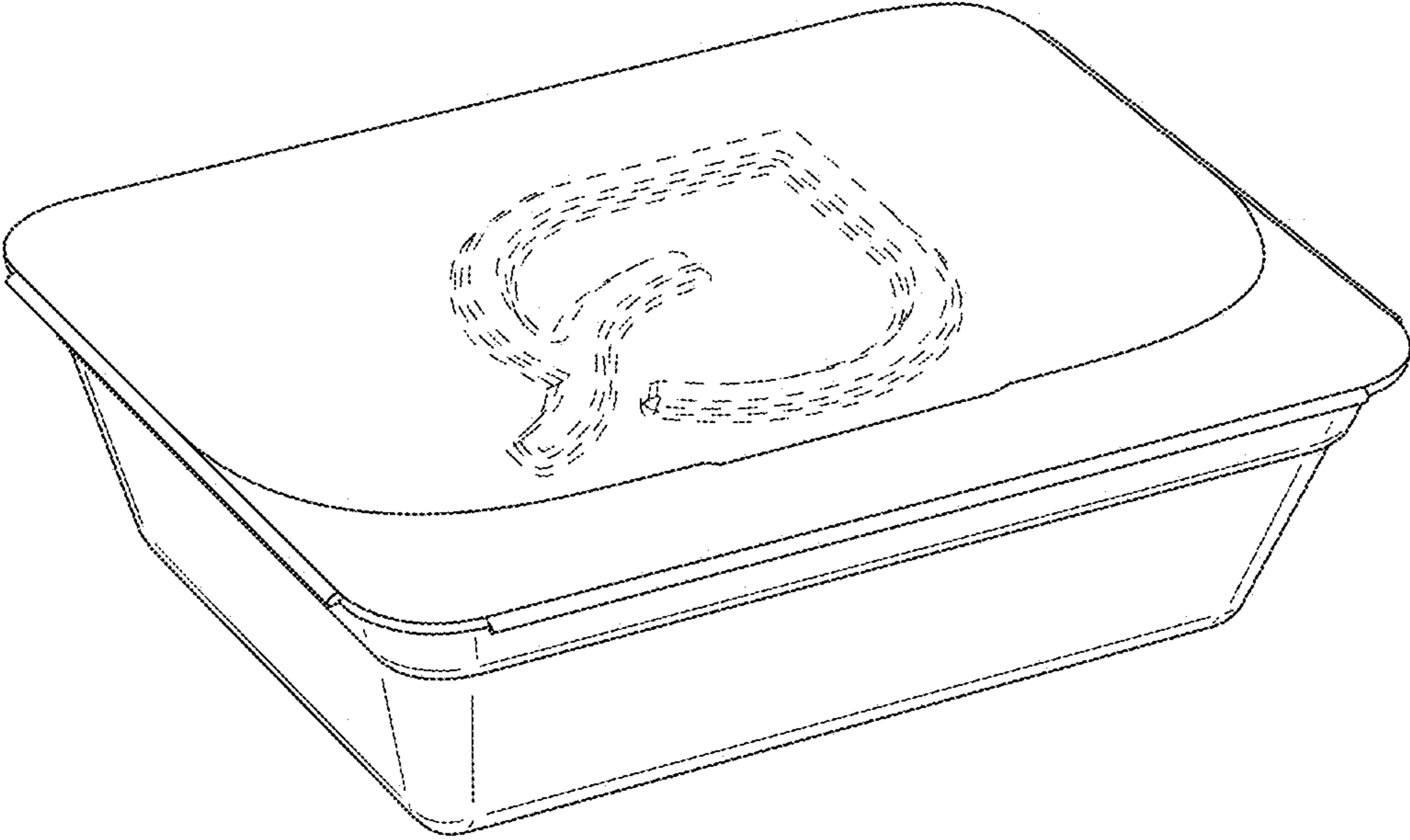

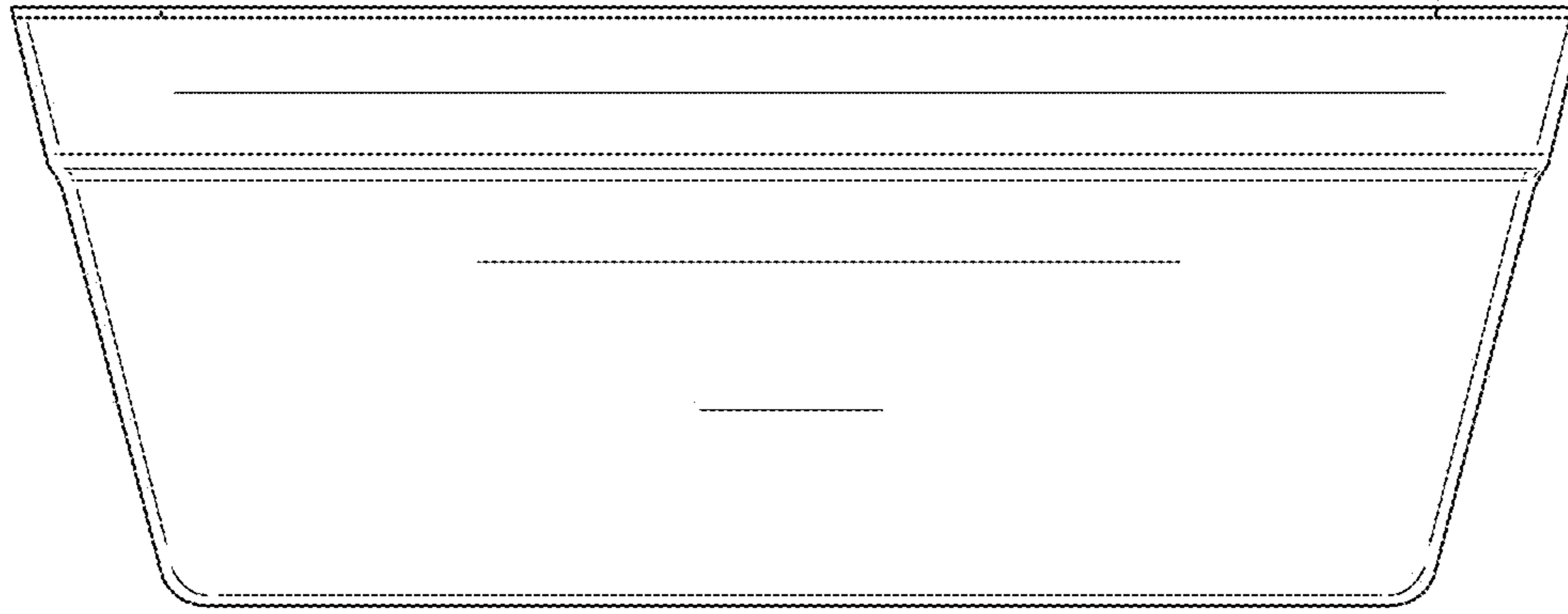

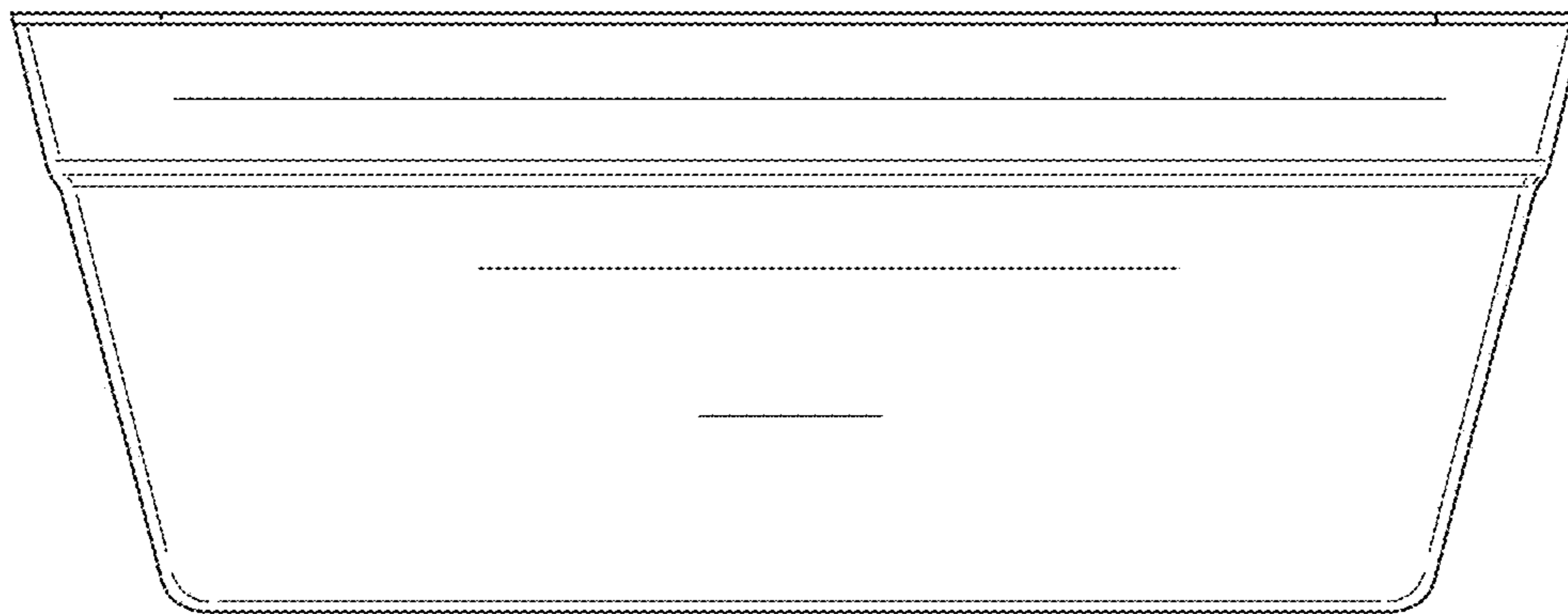

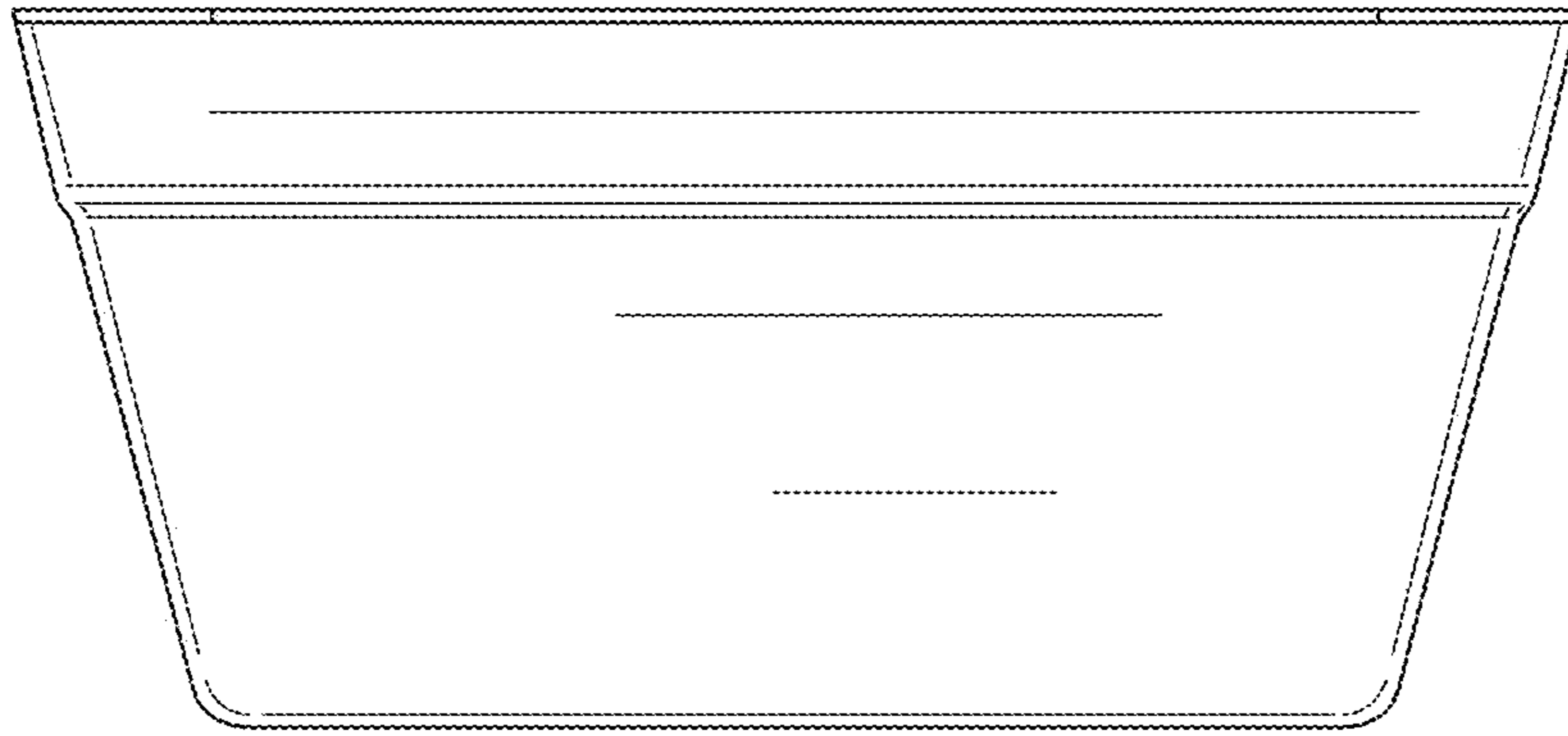

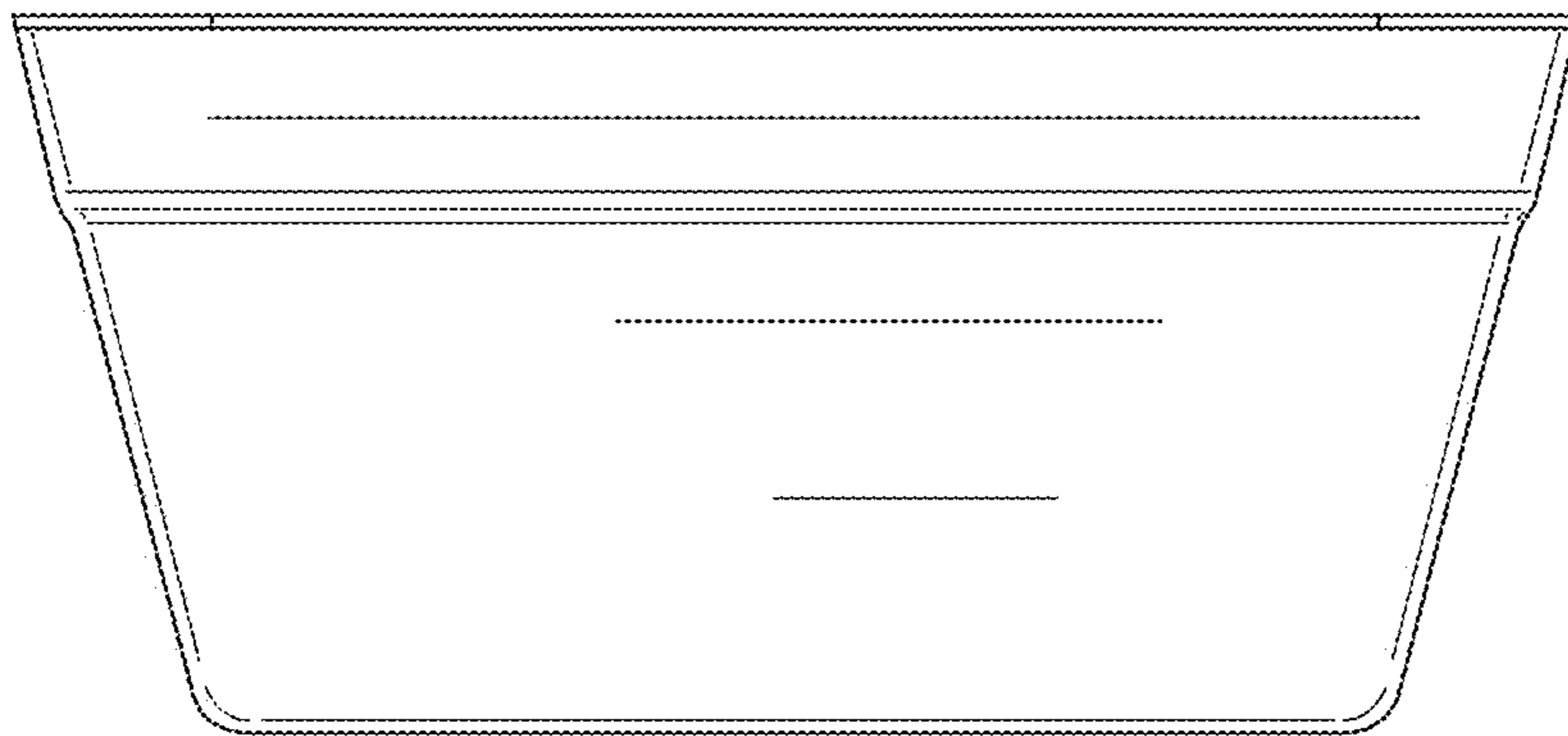

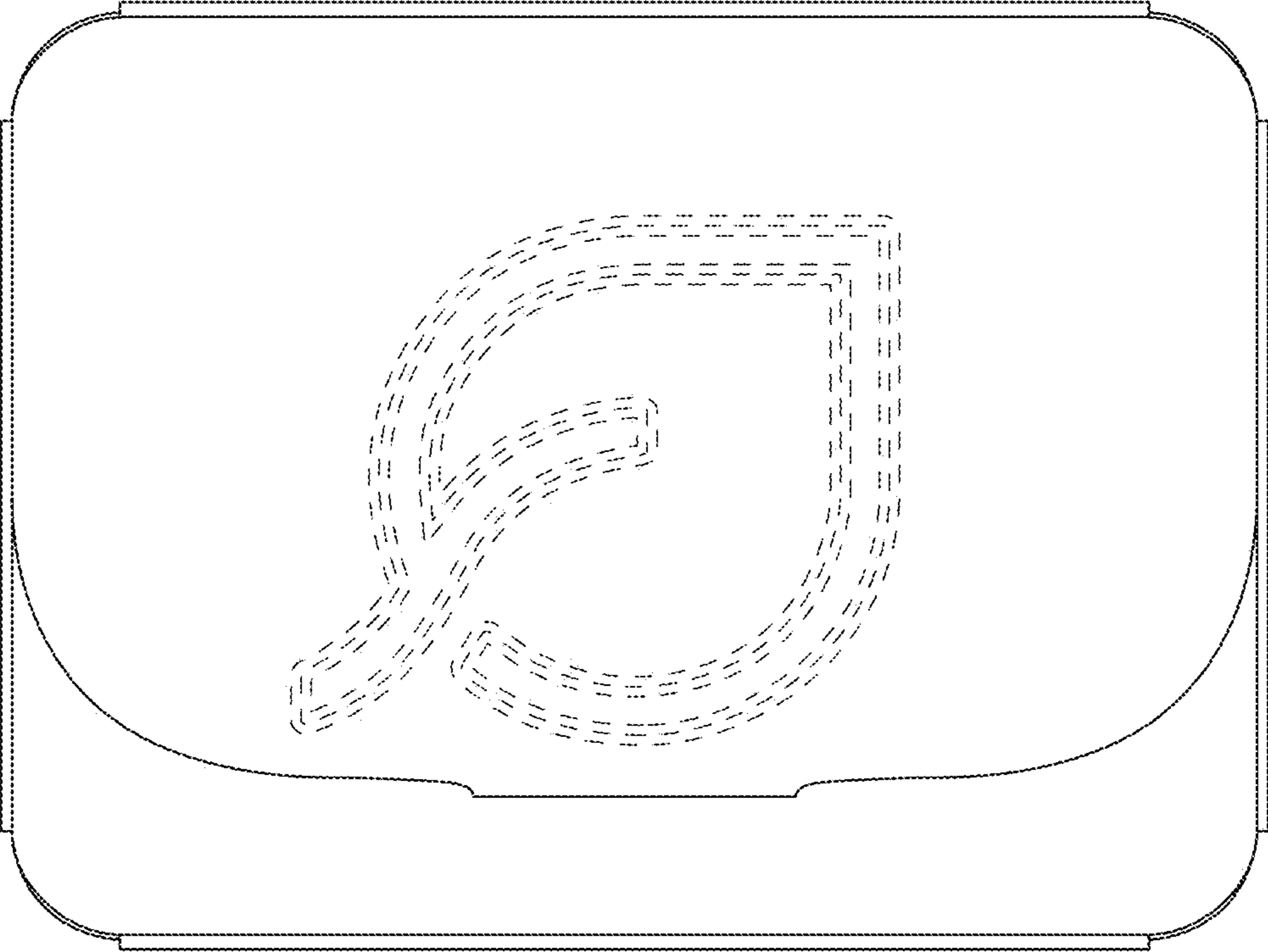

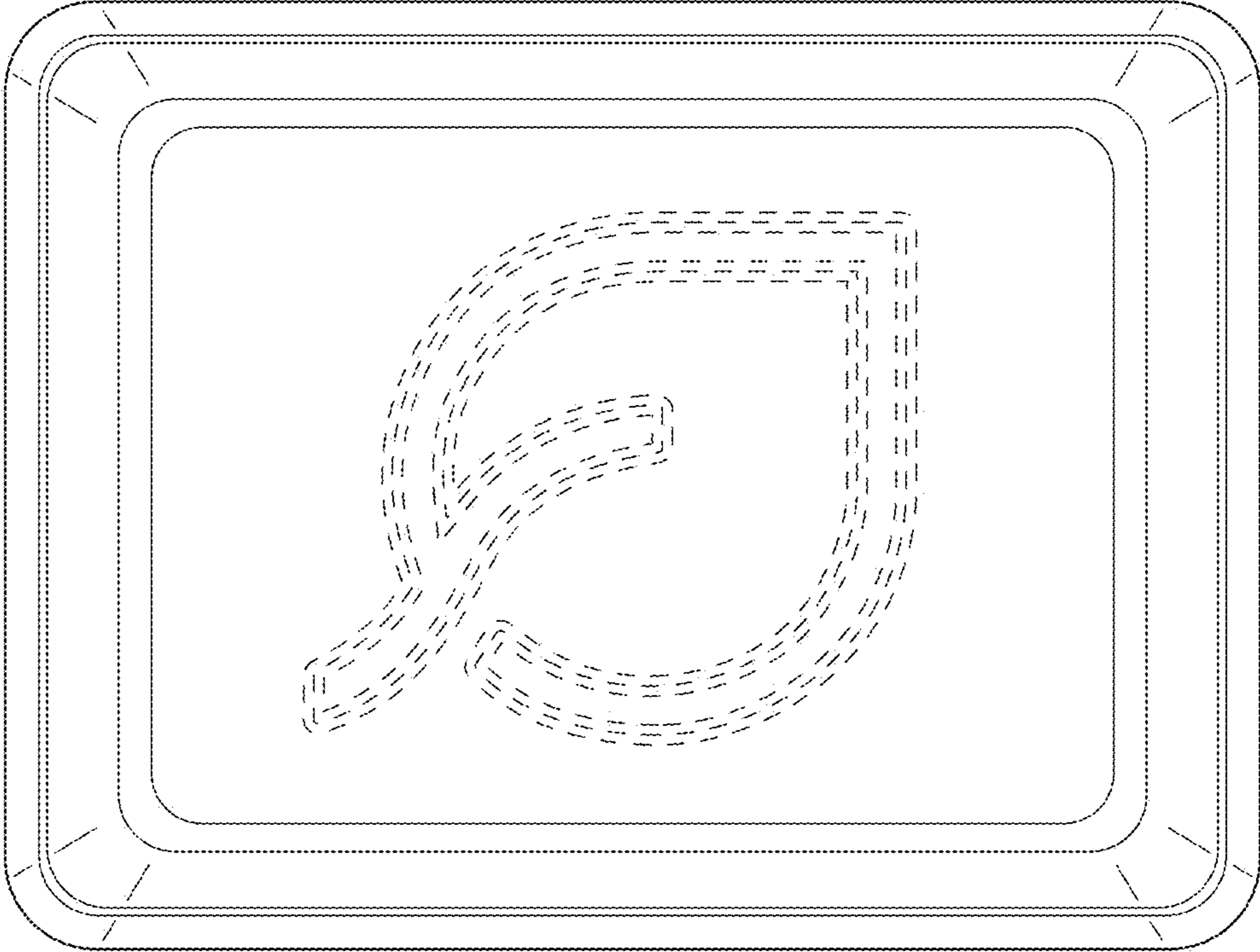

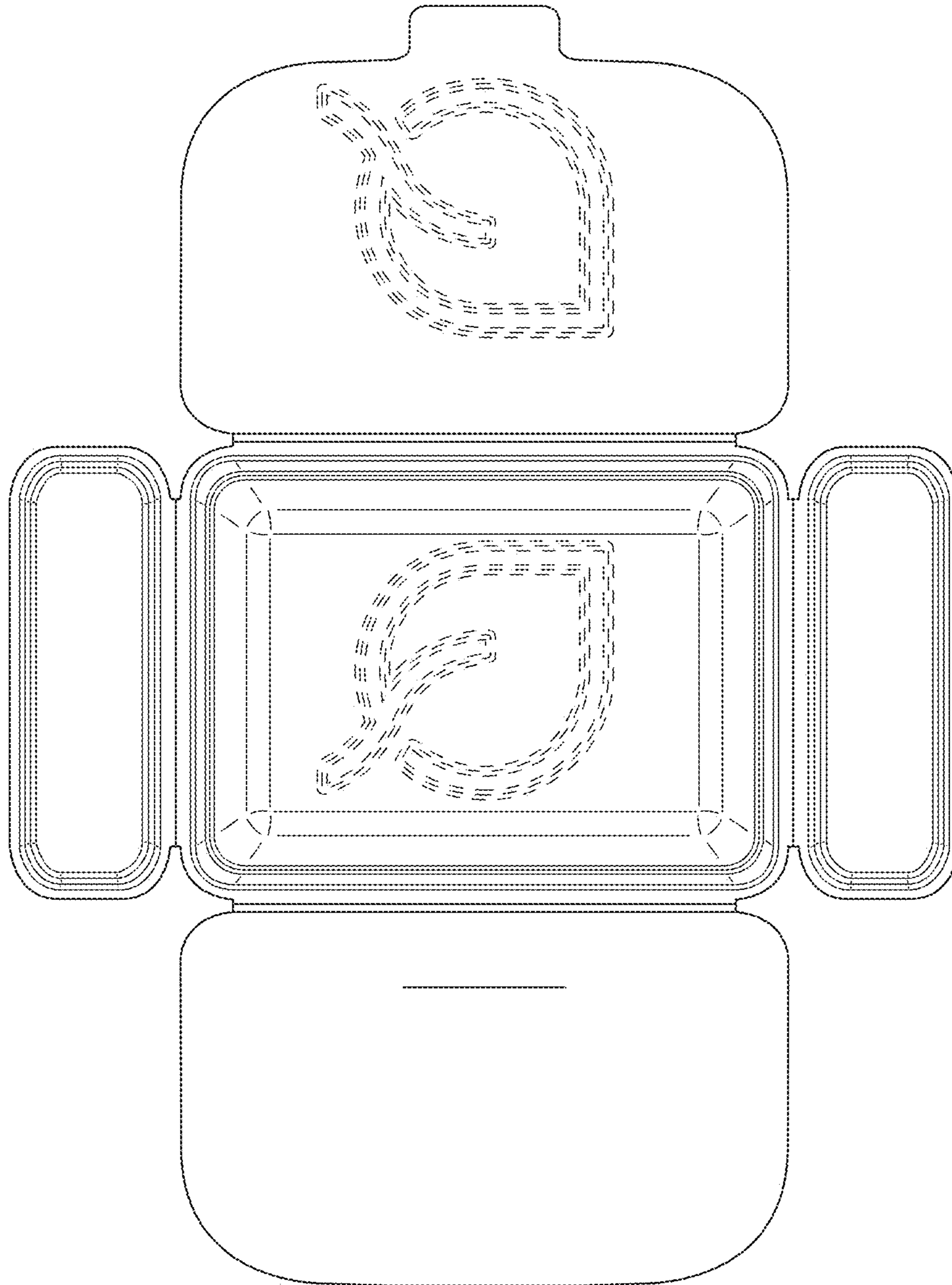

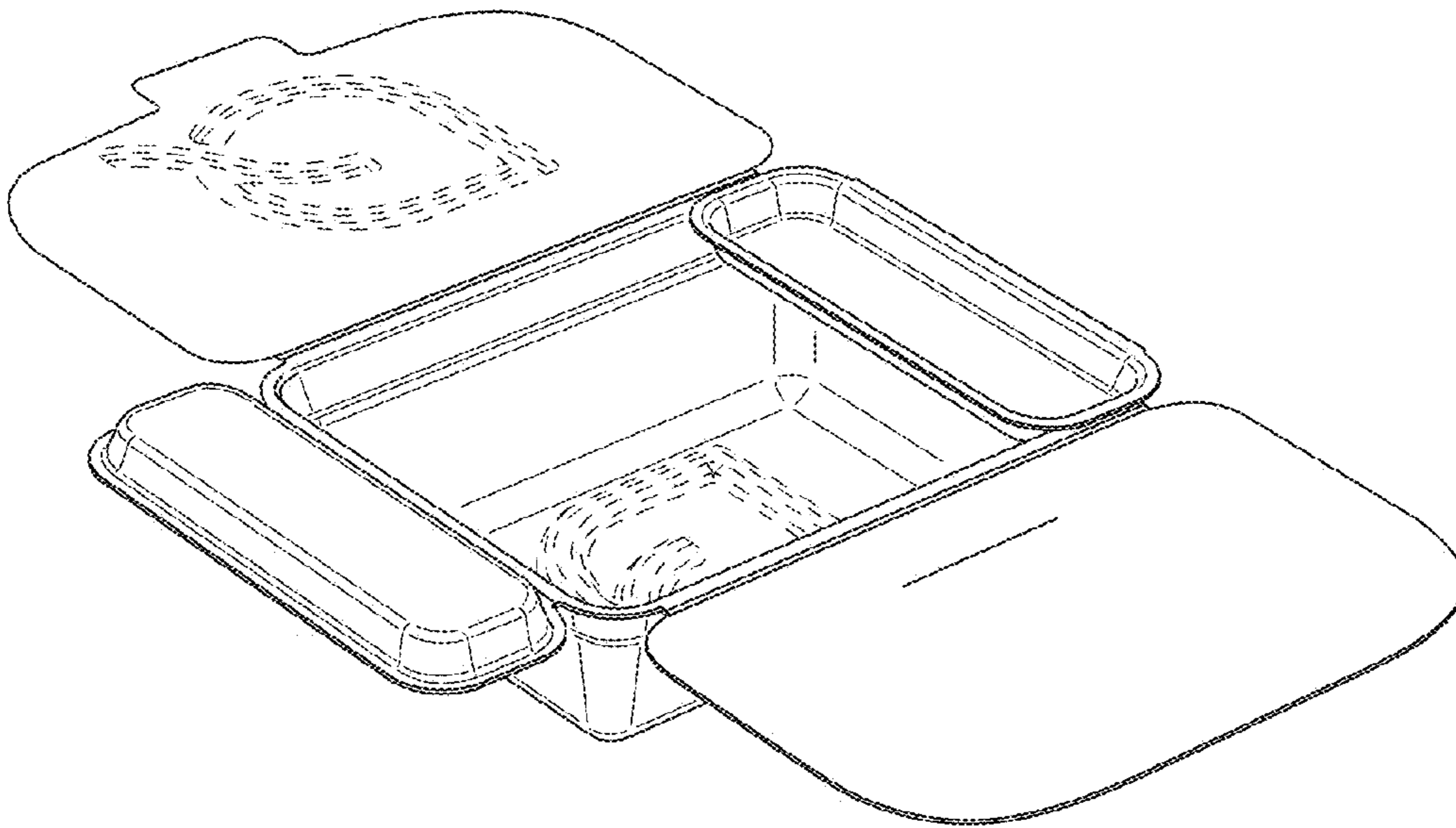

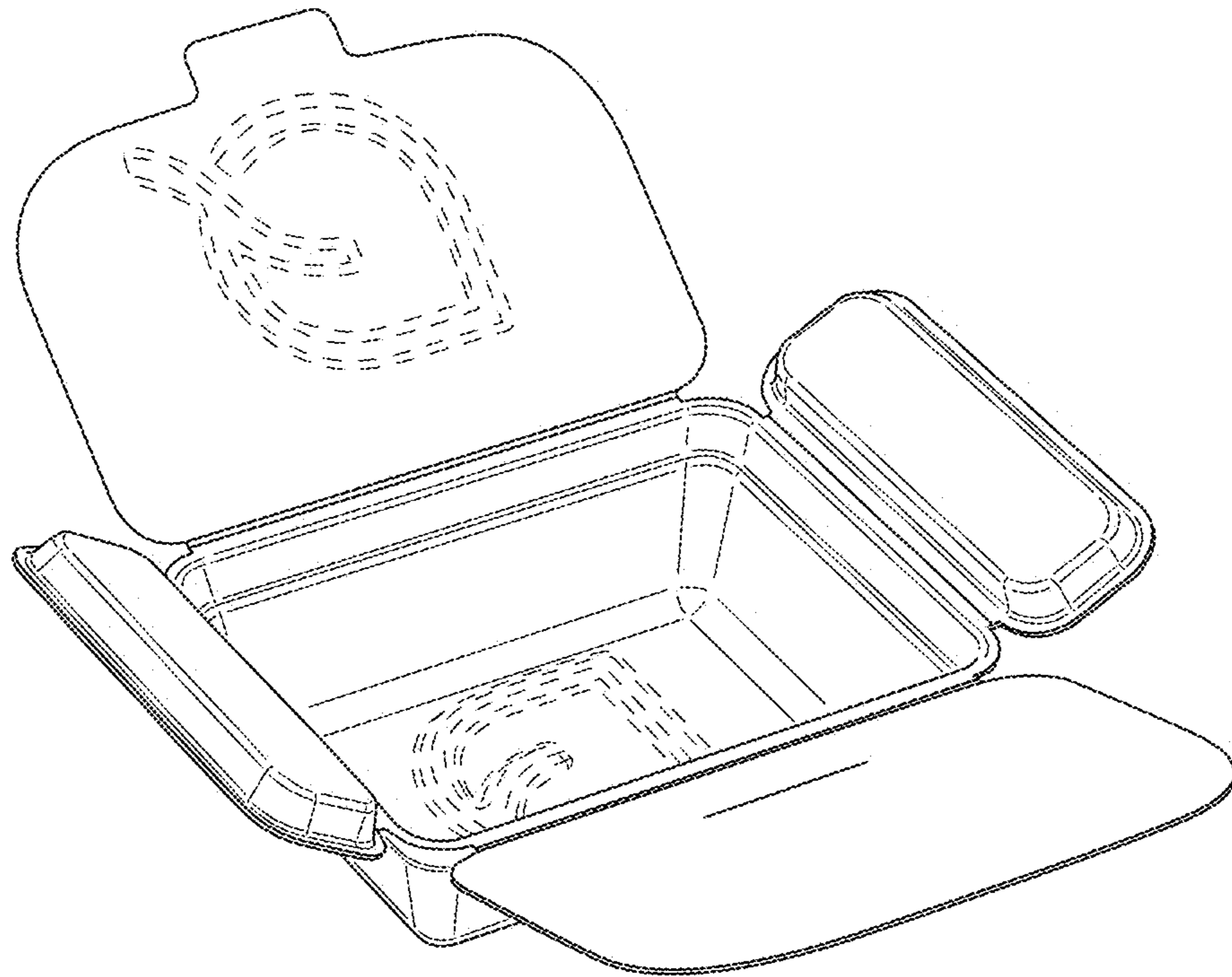
