**DESCRIPTION**

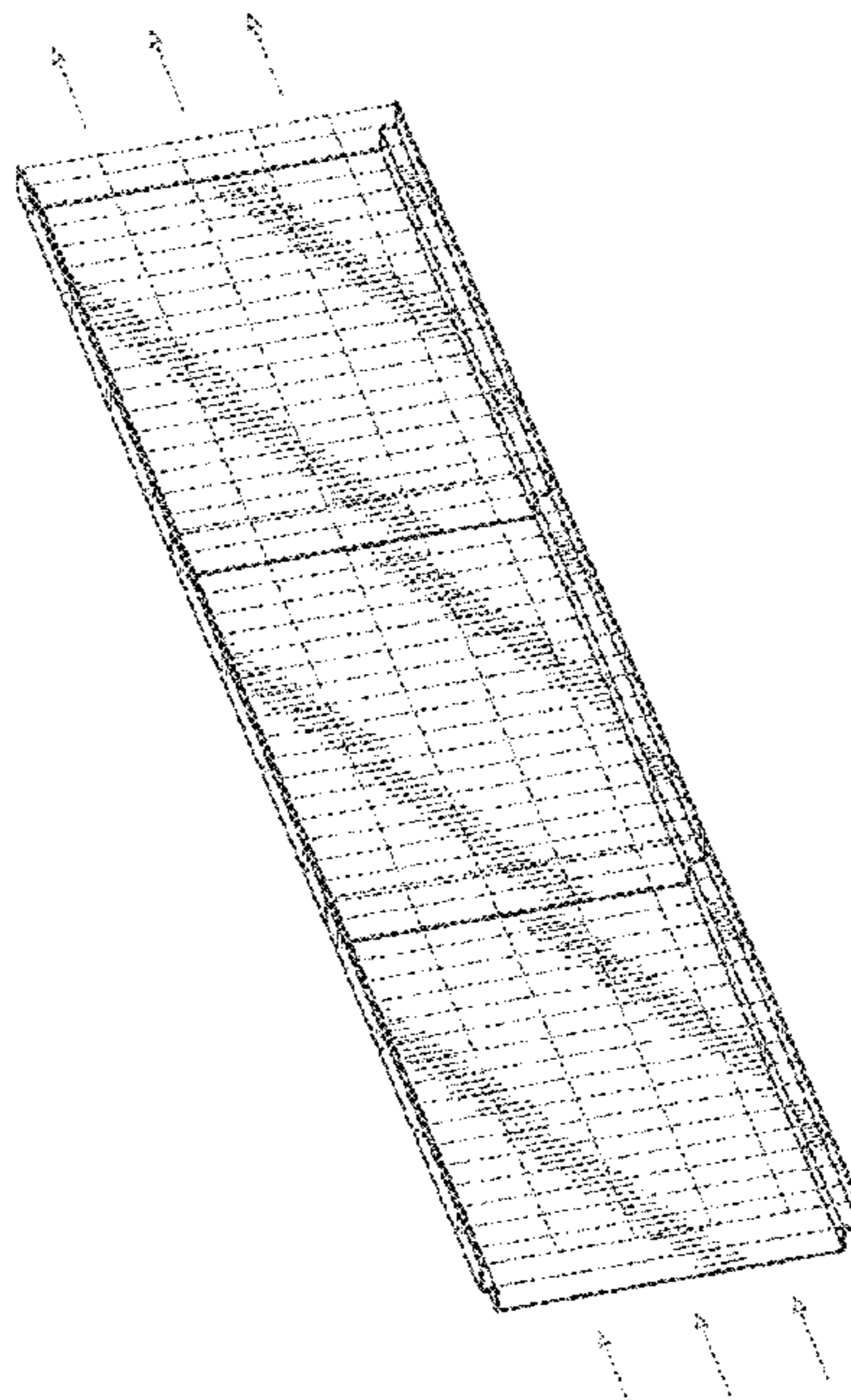
FIG. 1 is a perspective view of a thermal solar cell showing my new design;

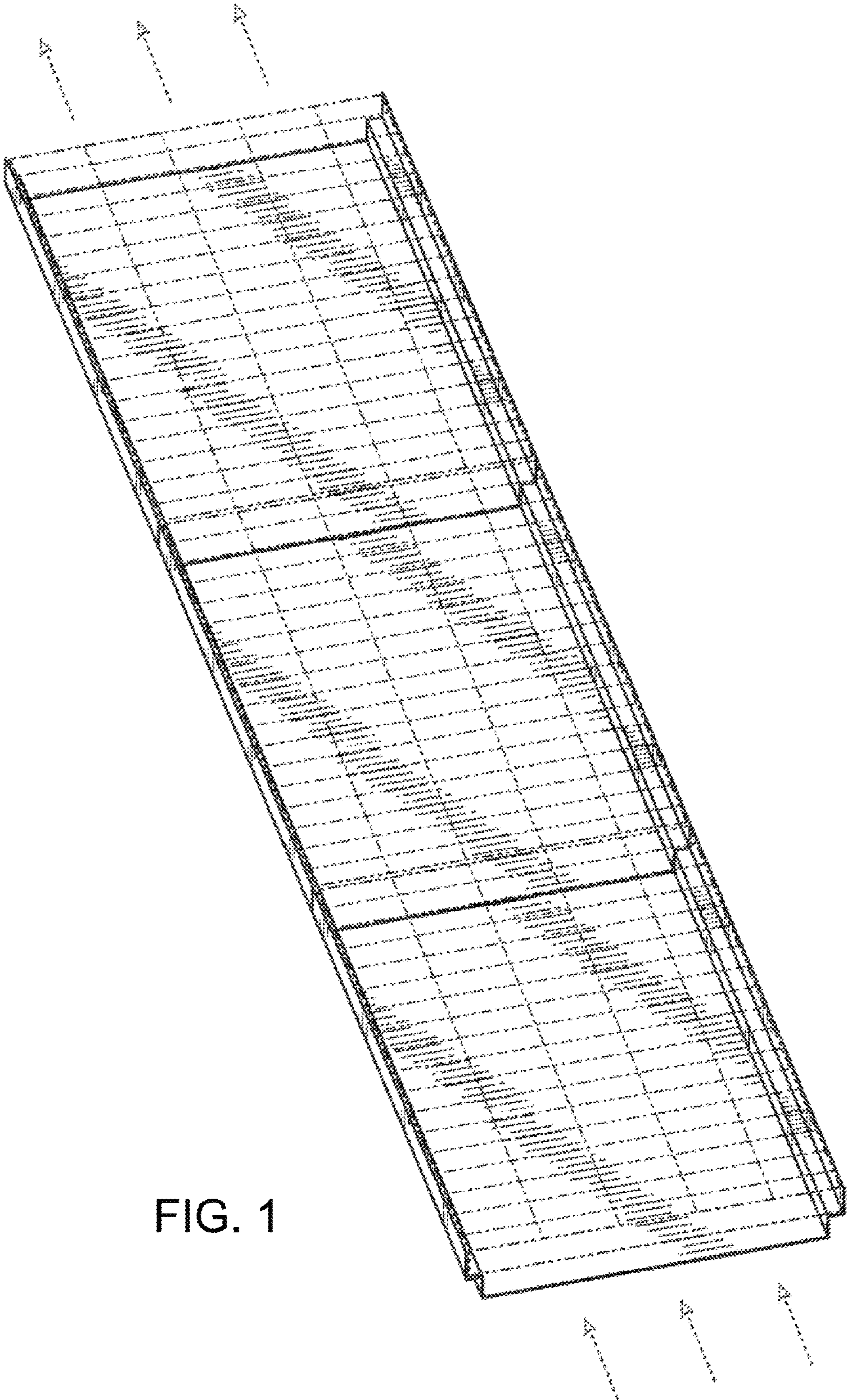

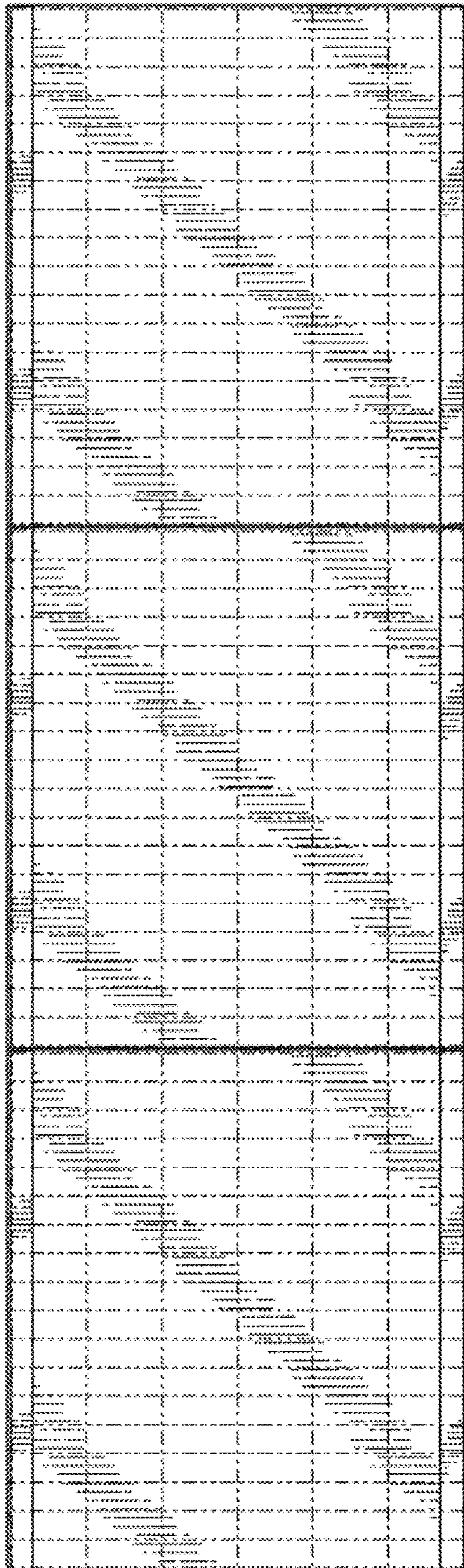

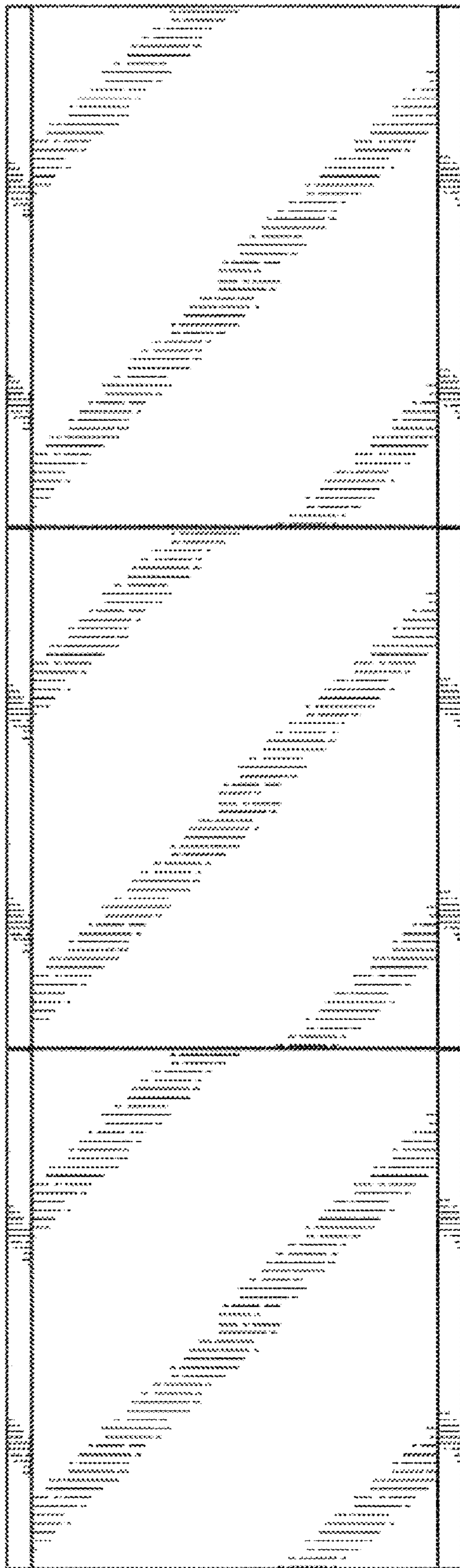

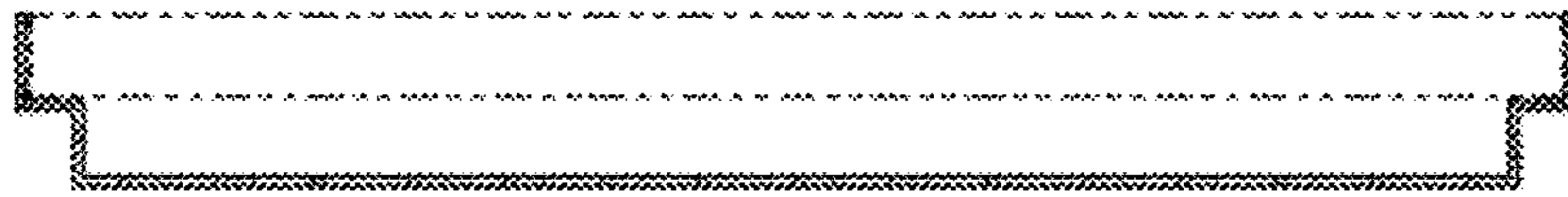

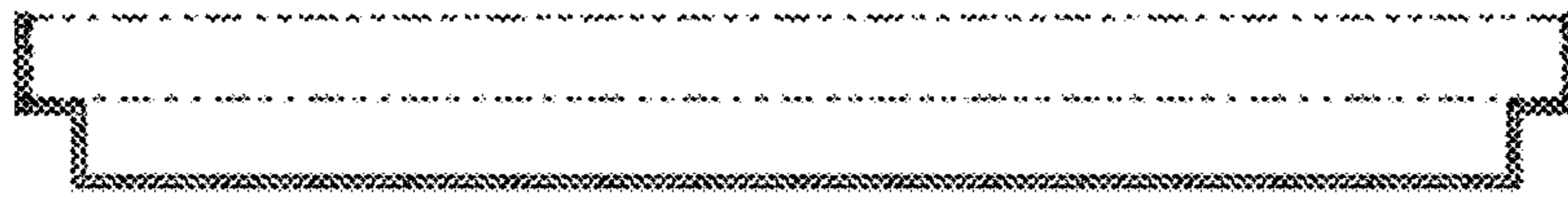

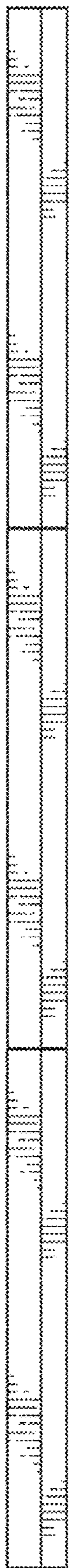

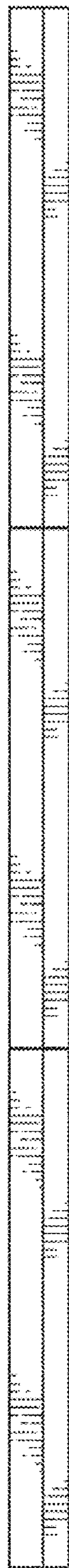
