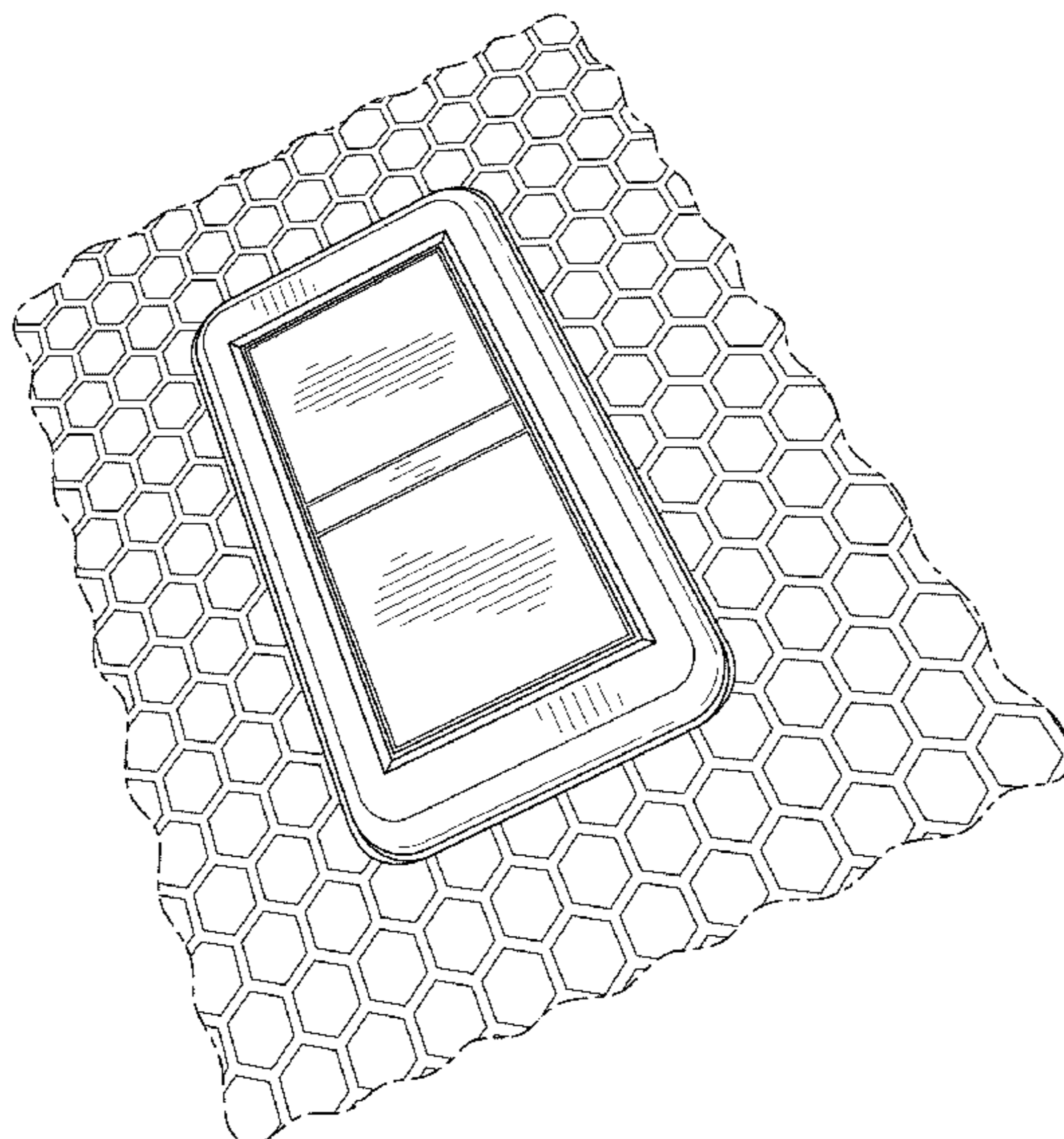
(57) **CLAIM**

The ornamental design for an electronic component badge plate, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an electronic component badge plate showing our new design; FIG. 2 is an elevational view thereof; FIG. 3 is a side elevational view thereof; and, FIG. 4 is a perspective view thereof shown on an exemplary loudspeaker body. 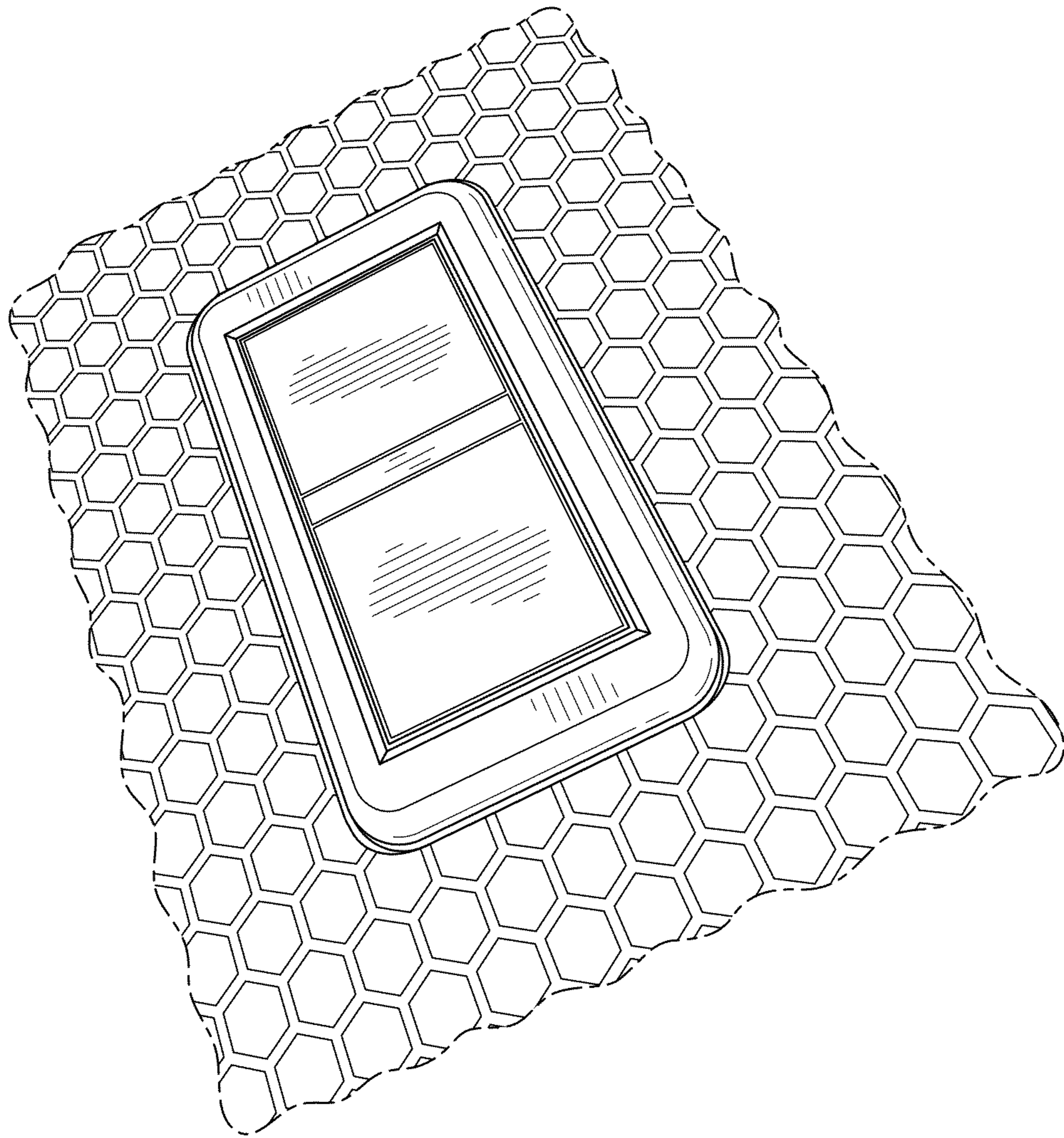

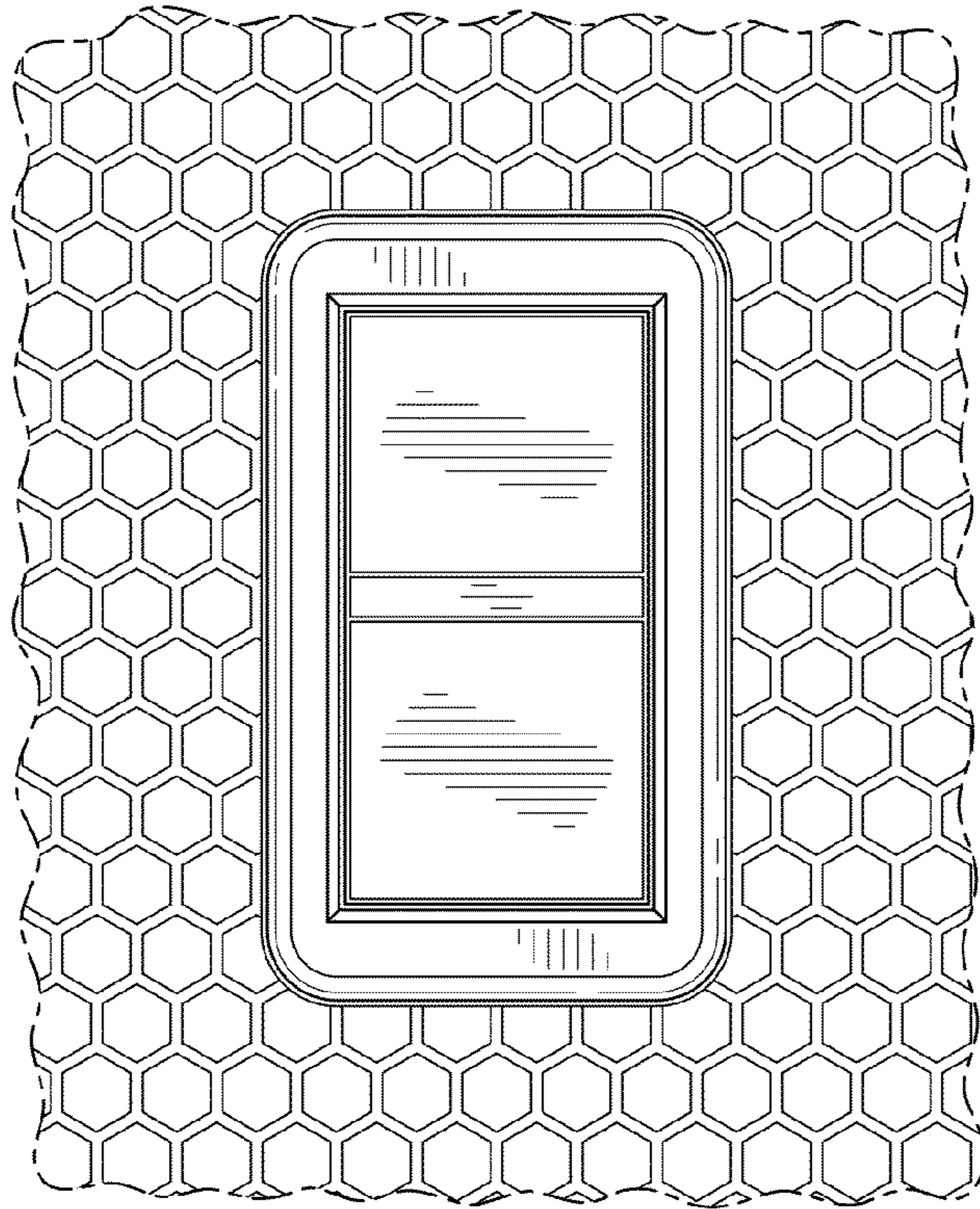

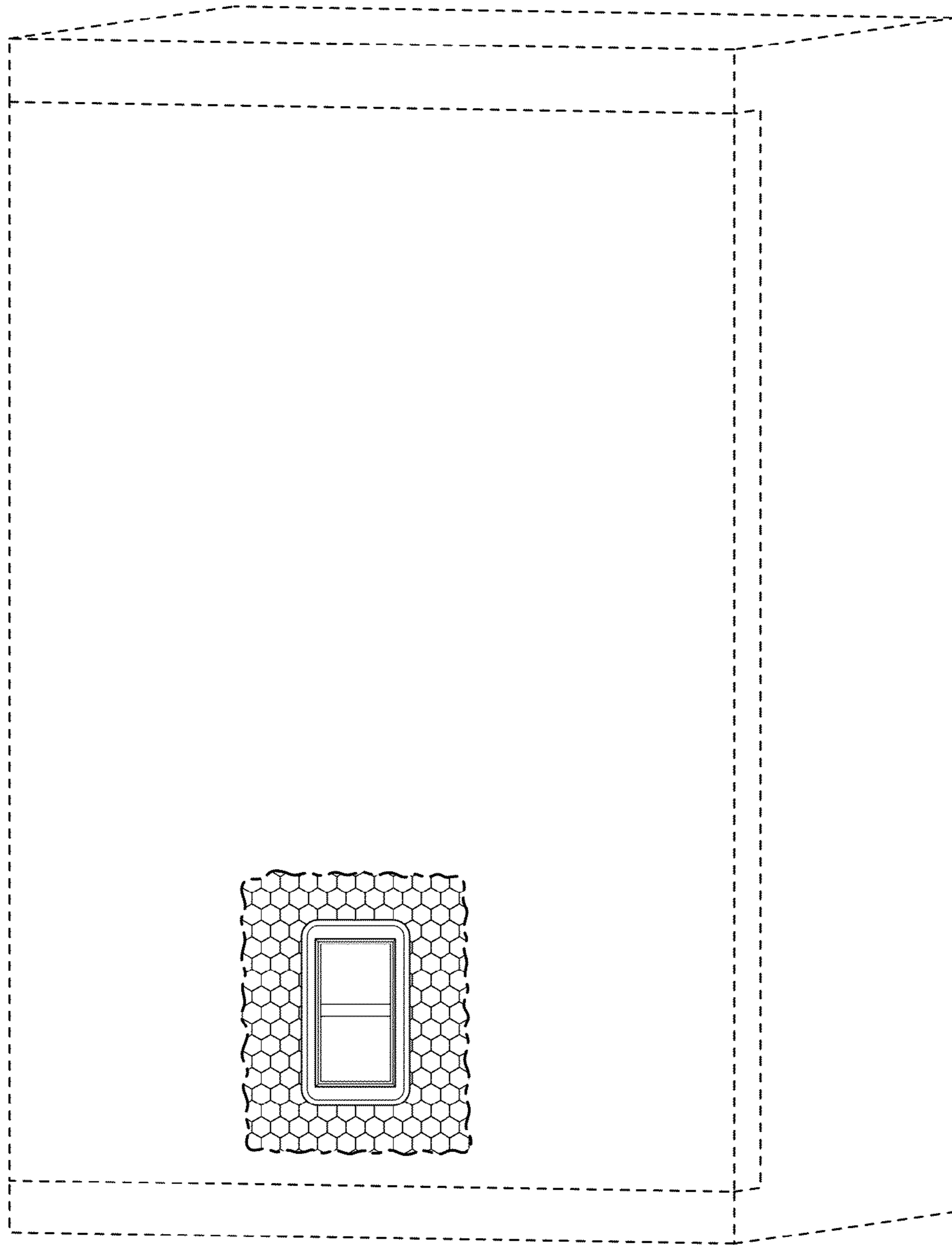
