DESCRIPTION

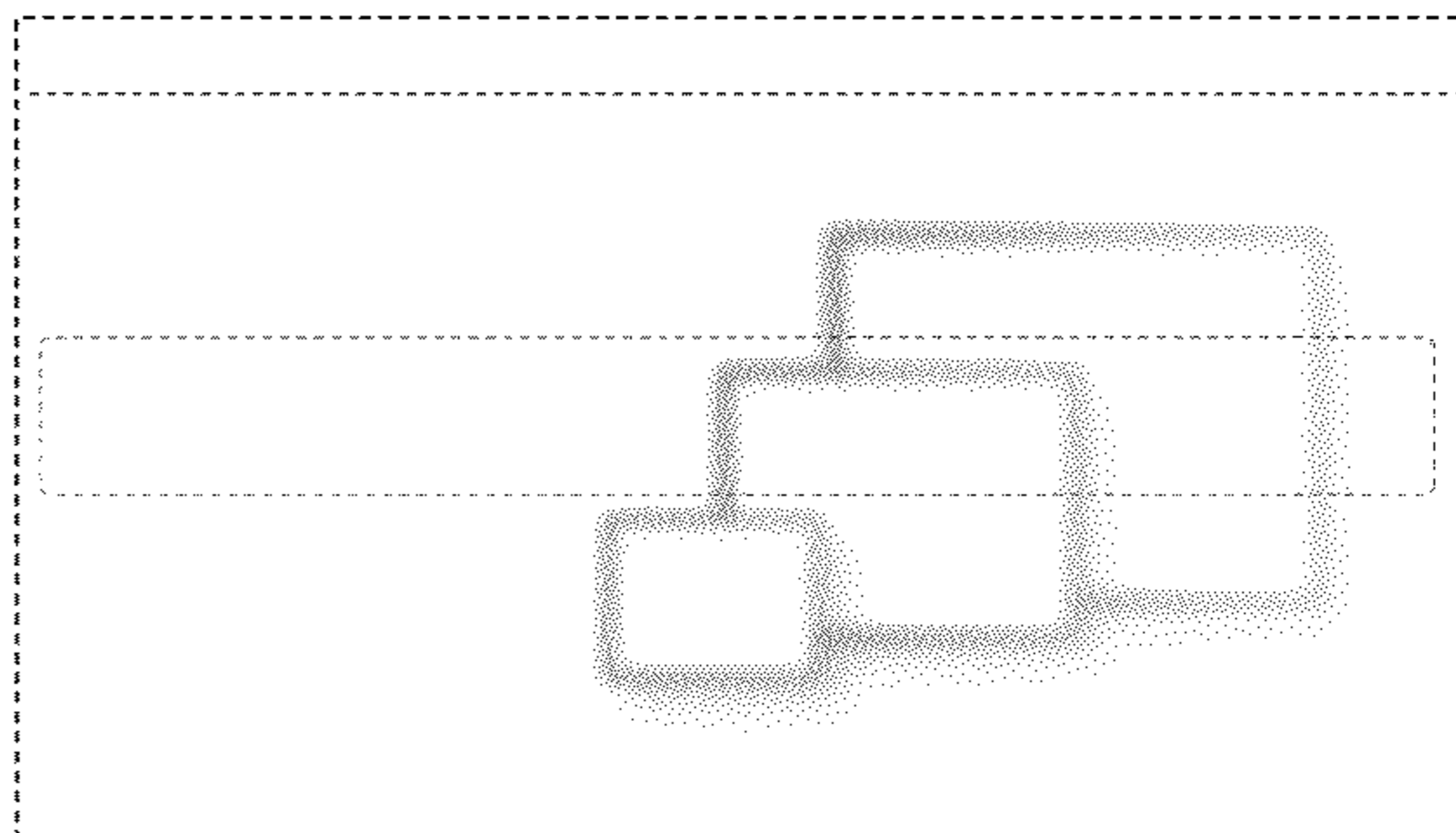
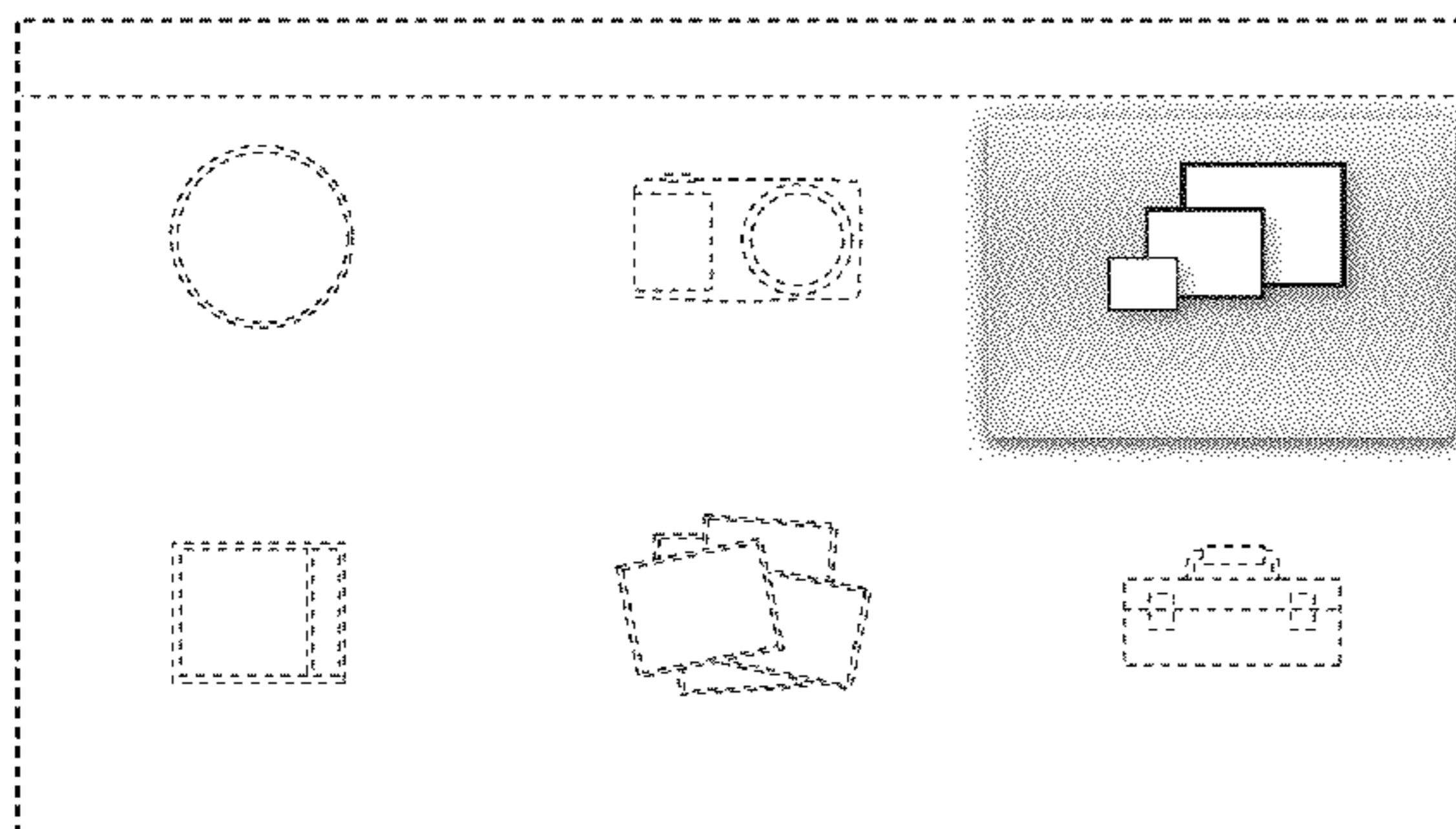
FIG. 1 is a front view of a first image of a display panel or screen with animated graphical user interface showing our new design; and,

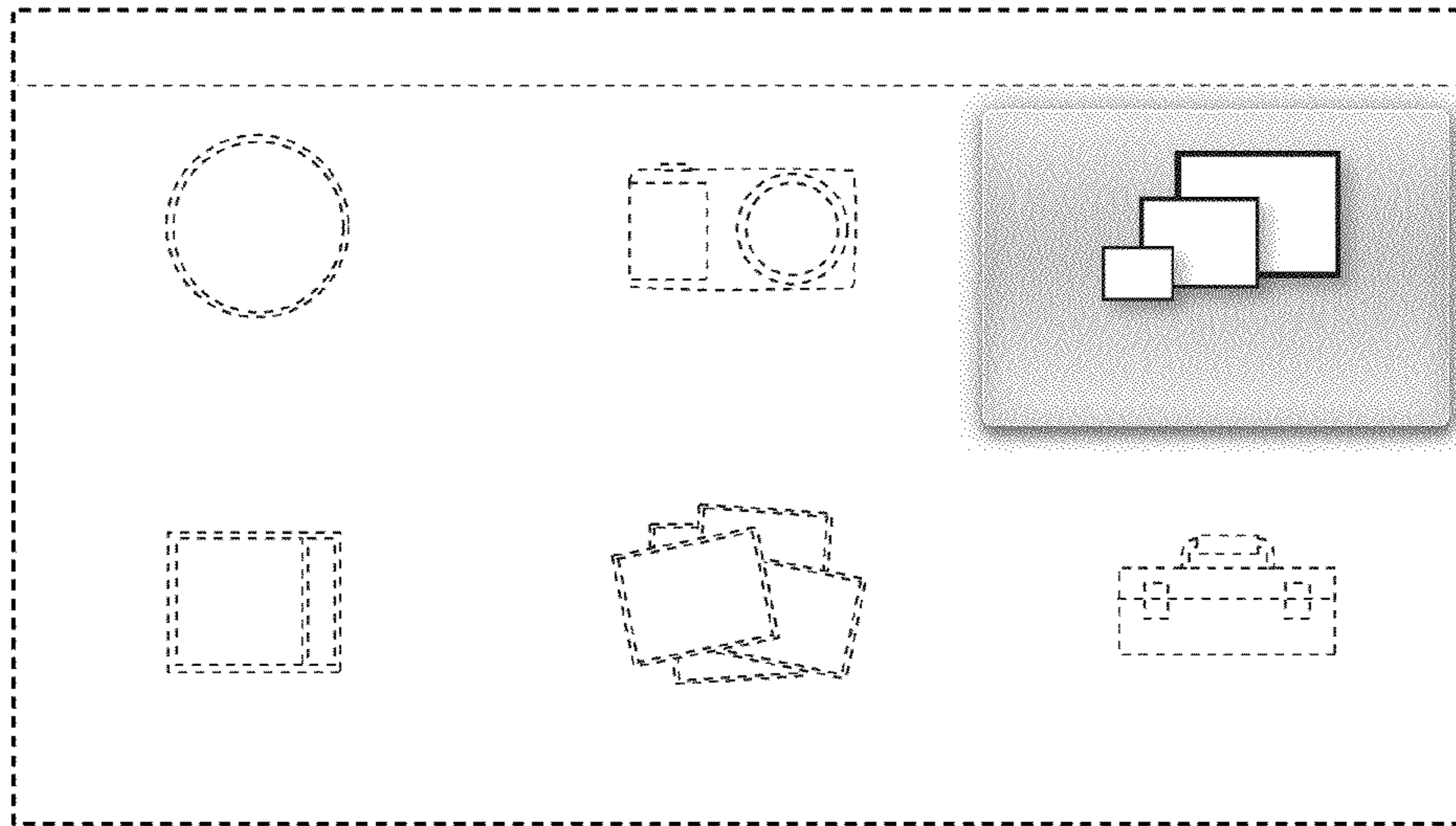

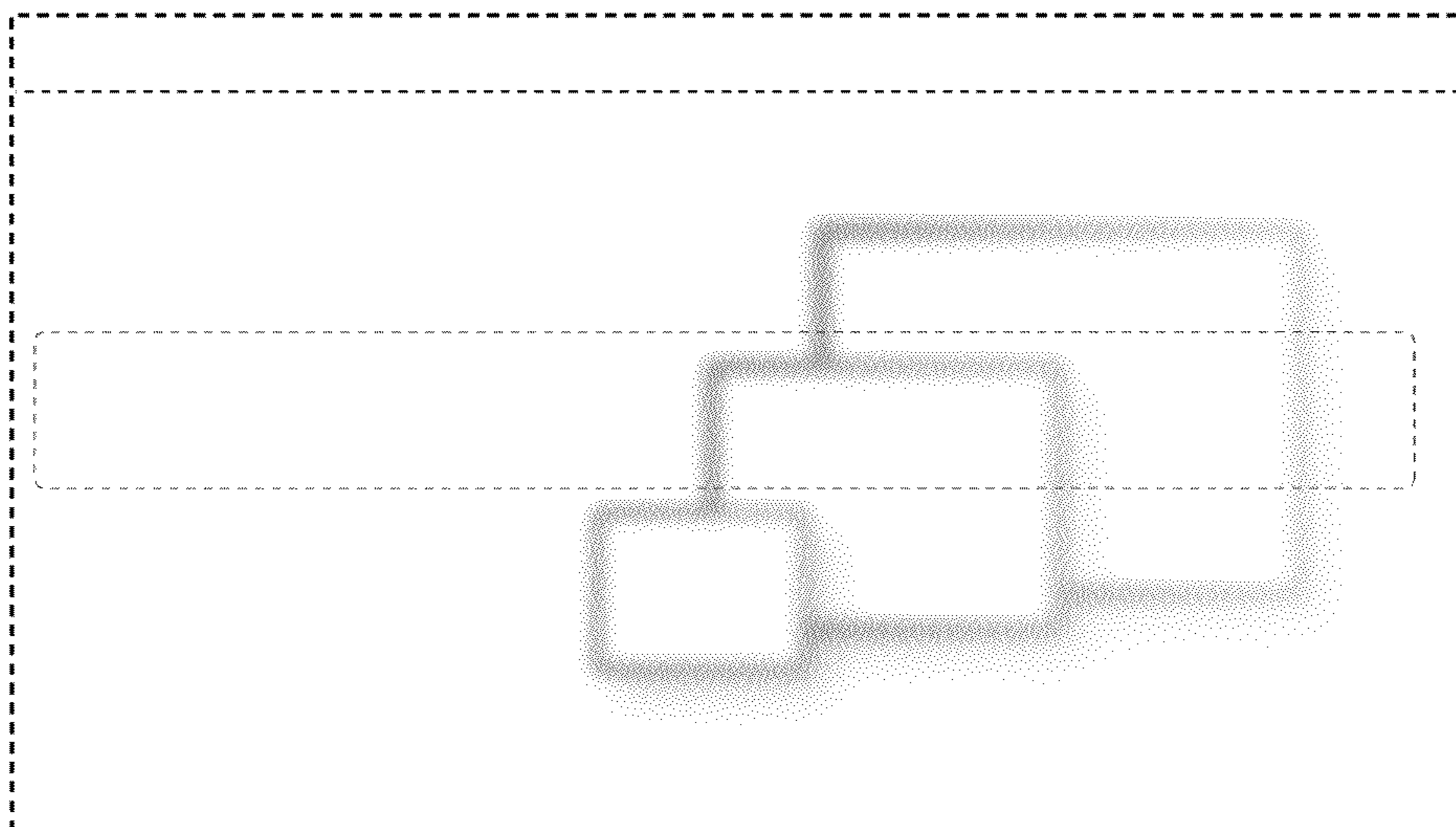
