FIG. 1 is a front view of a display screen or portion thereof with icon showing my new design;

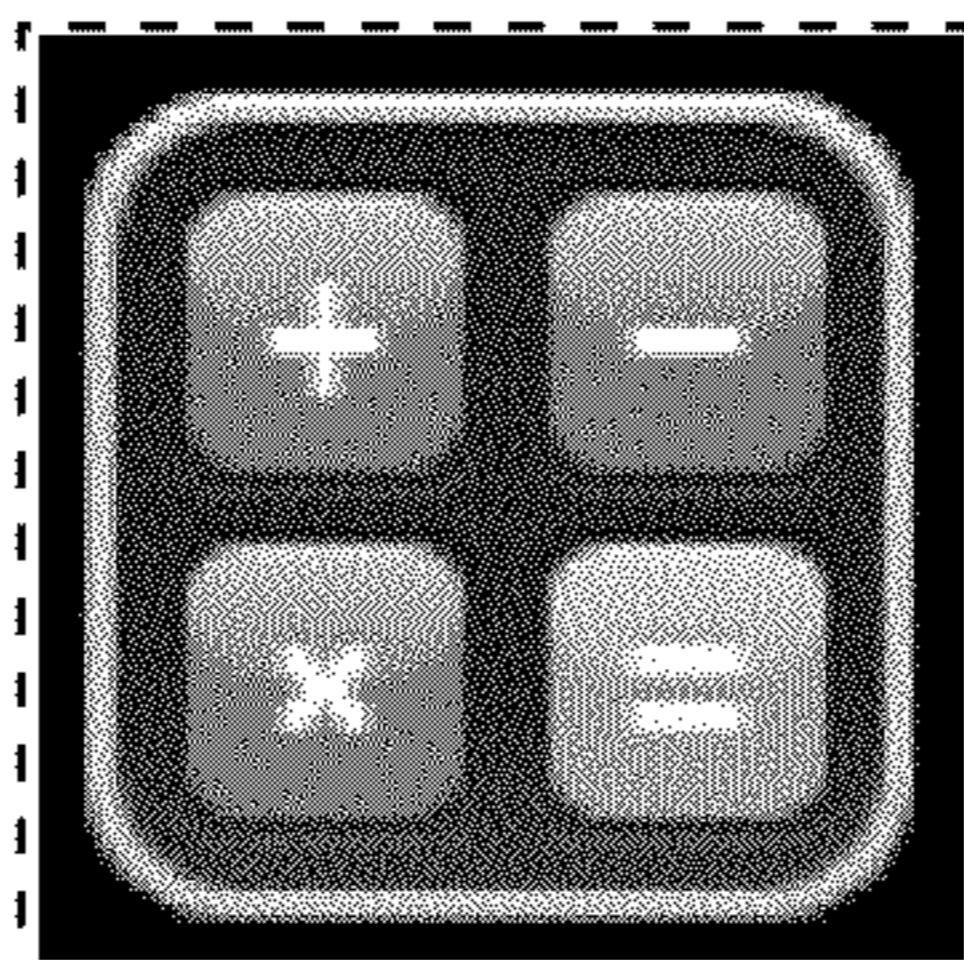
FIG. 2 is a front view of a second embodiment thereof;

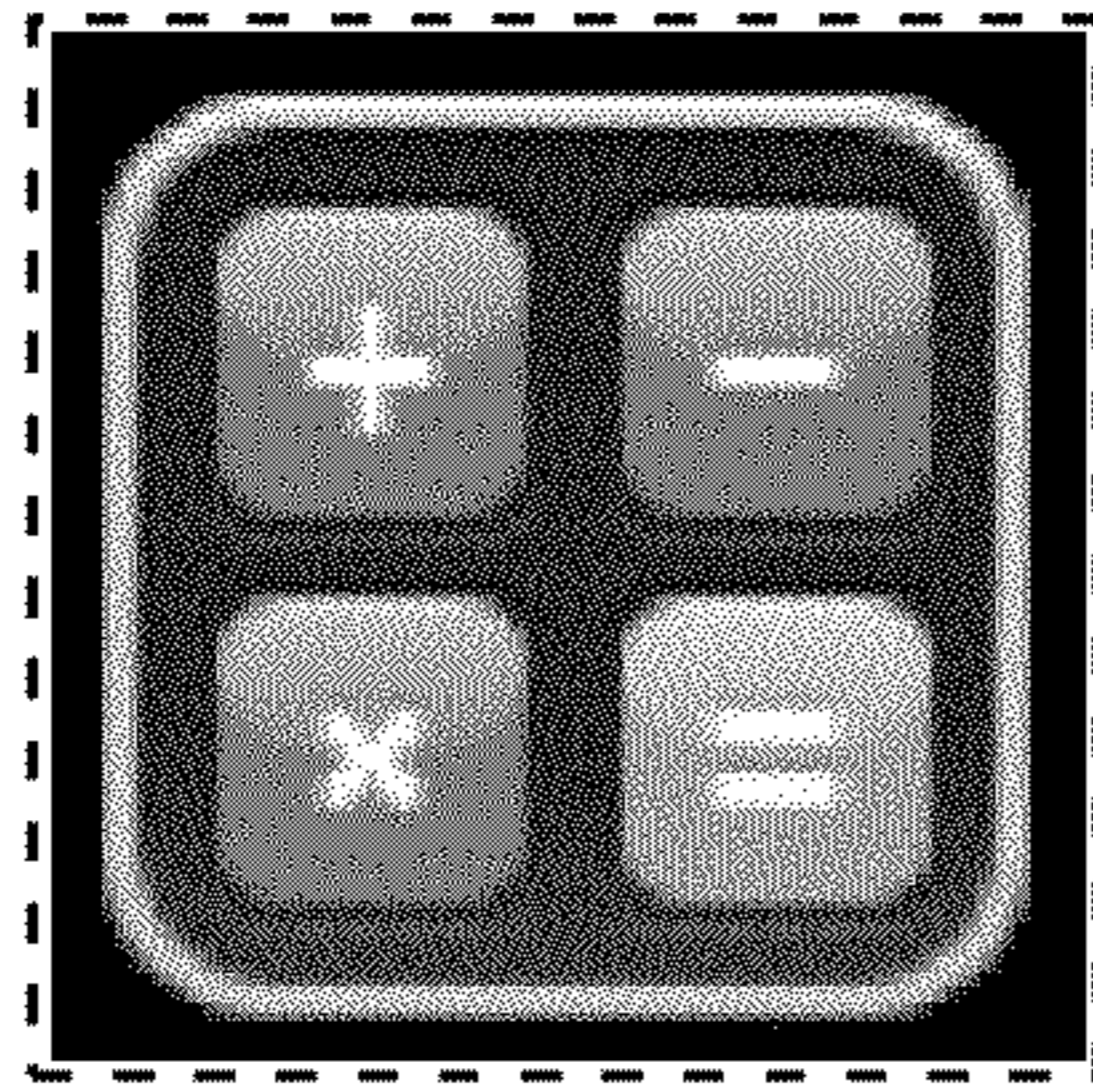

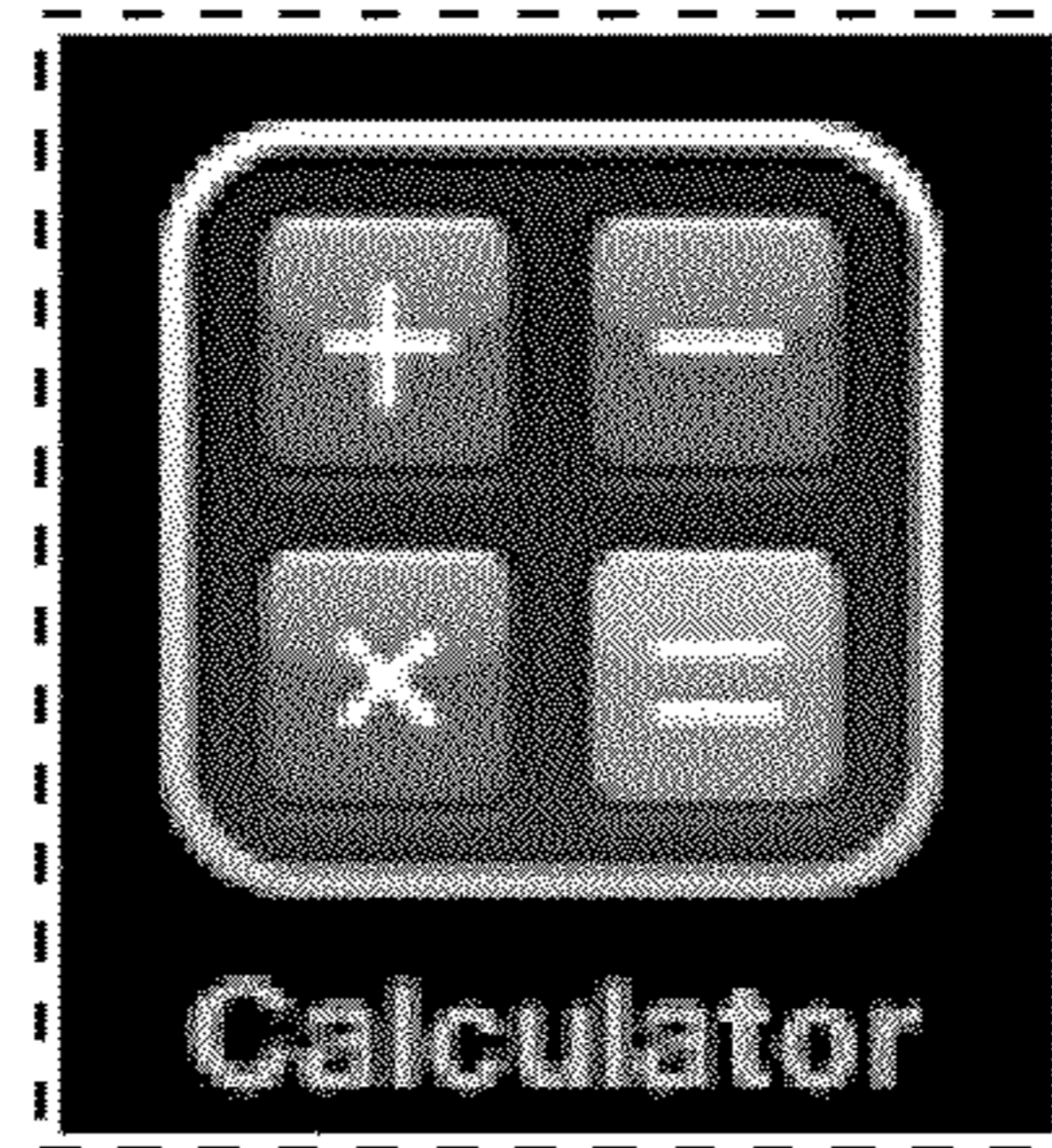

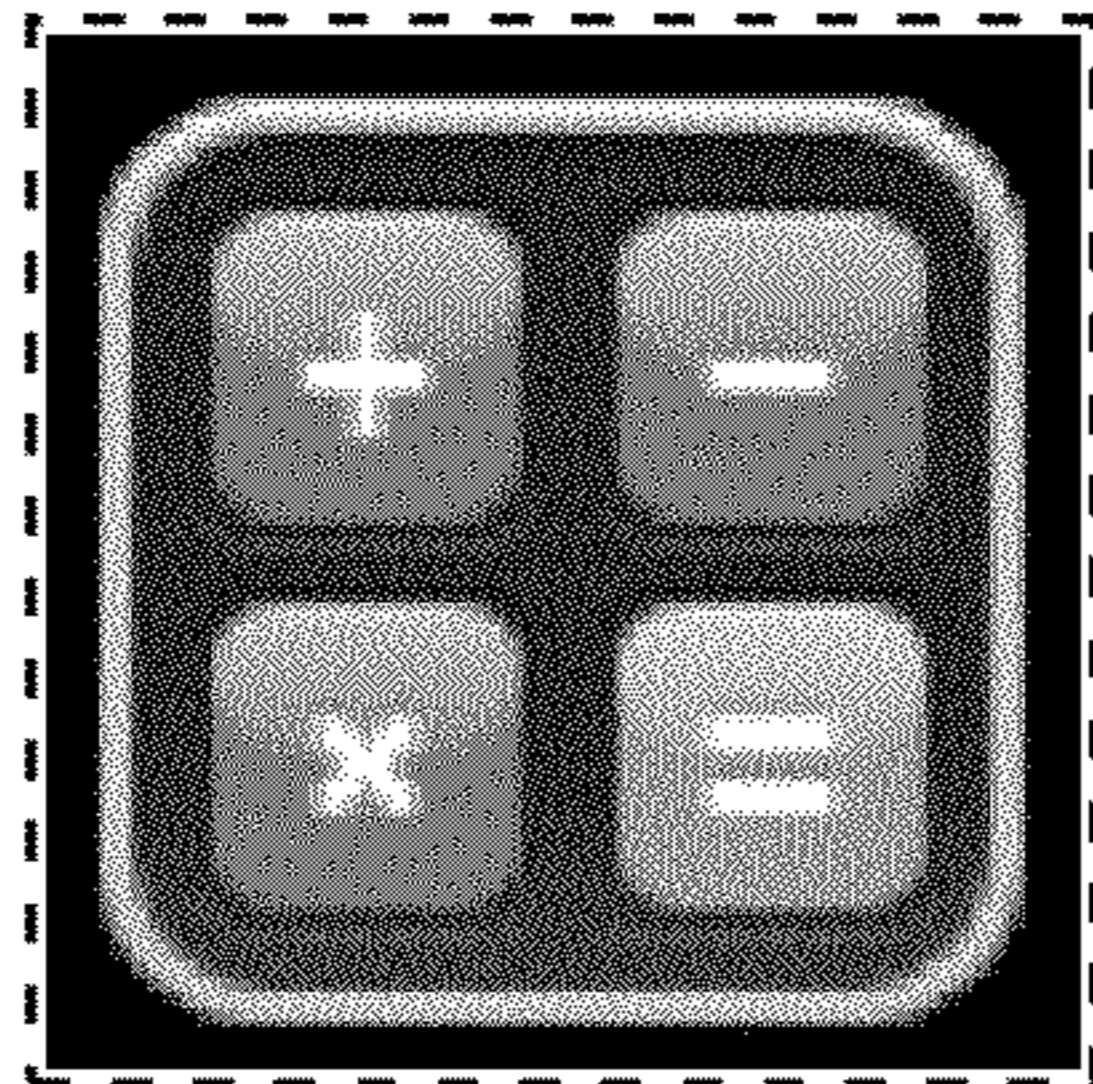

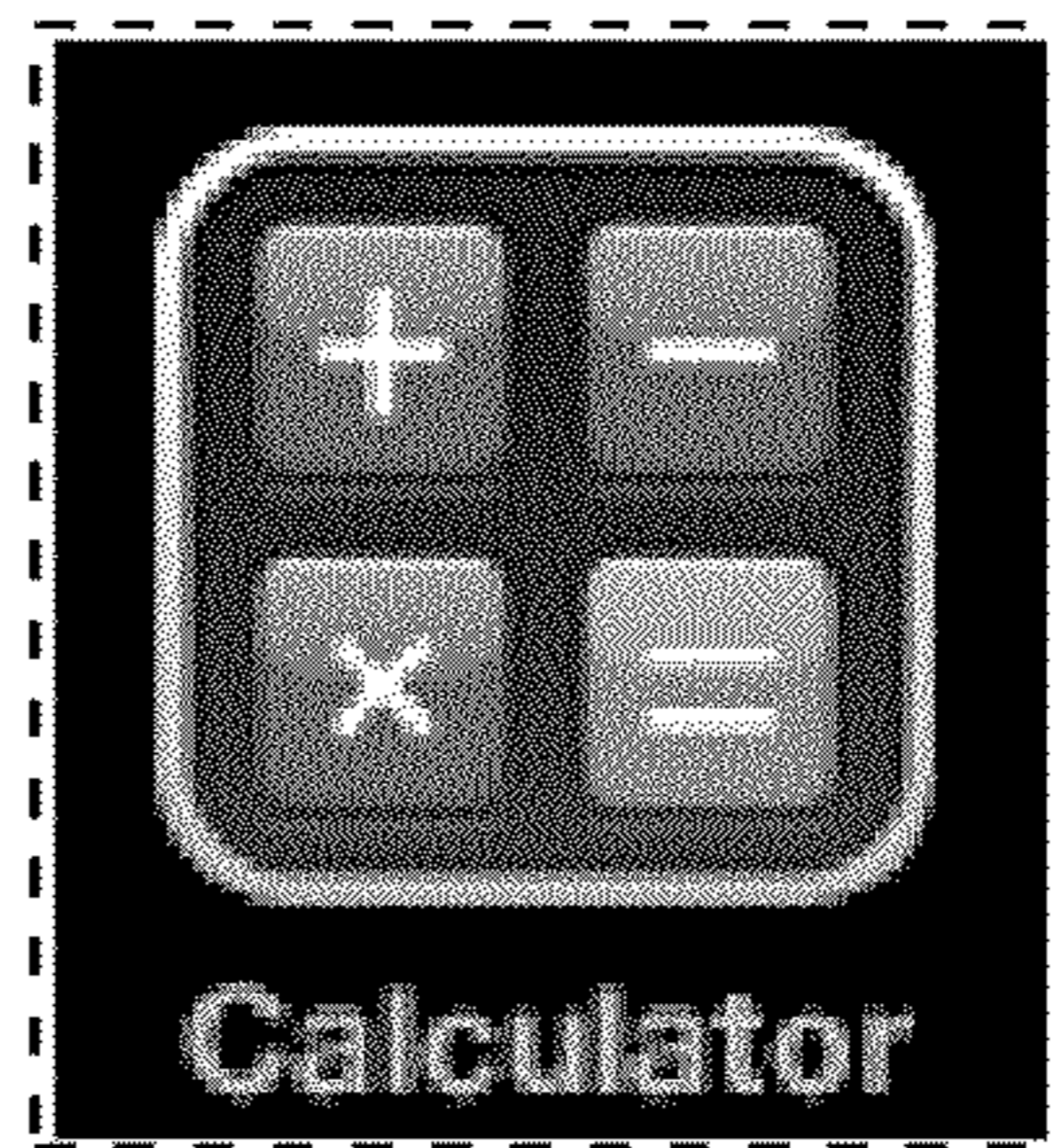
