(57) **CLAIM**

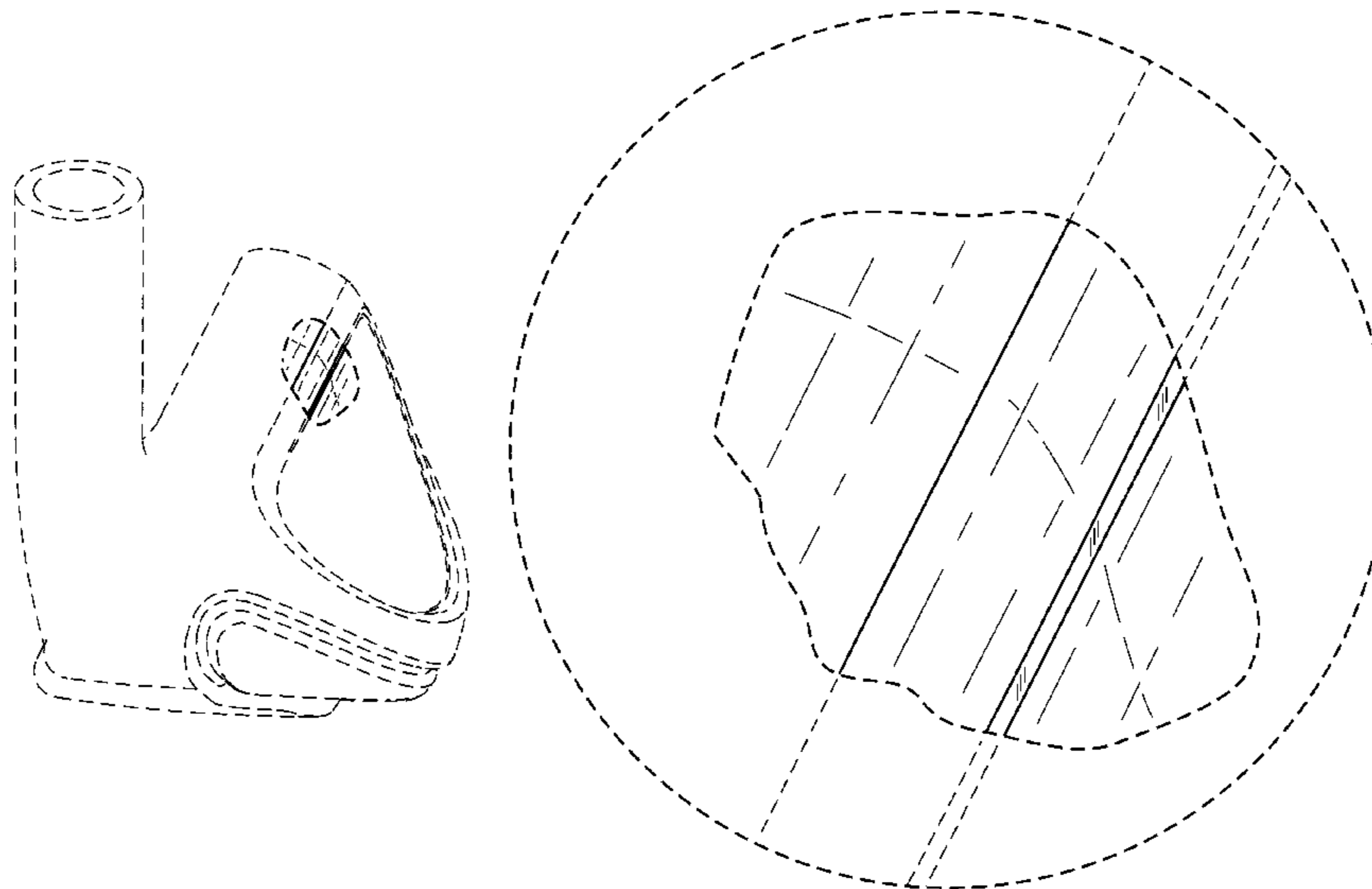
The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view embodying the inventive design; FIG. 2 is a heel-side elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a toe-side elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is an enlarged view of the claimed design as seen in FIG. 2.

The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design, while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

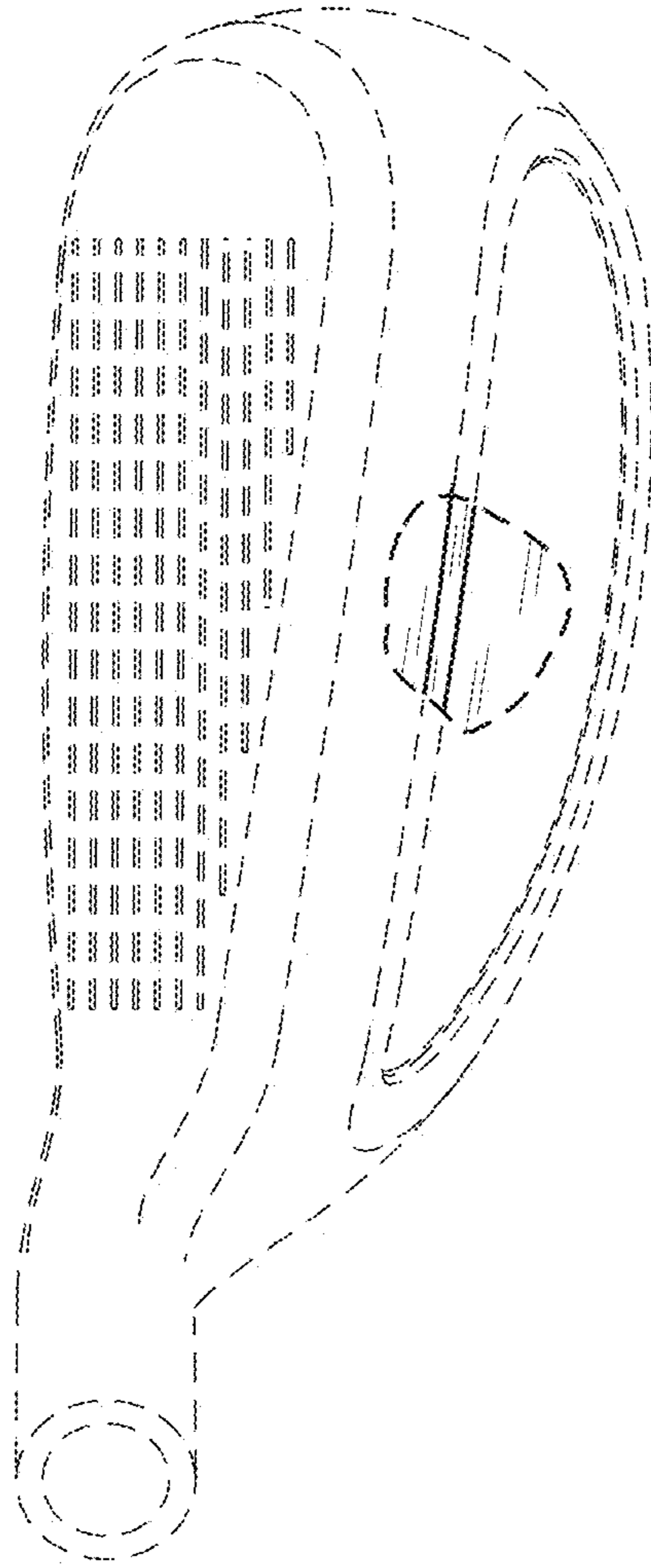

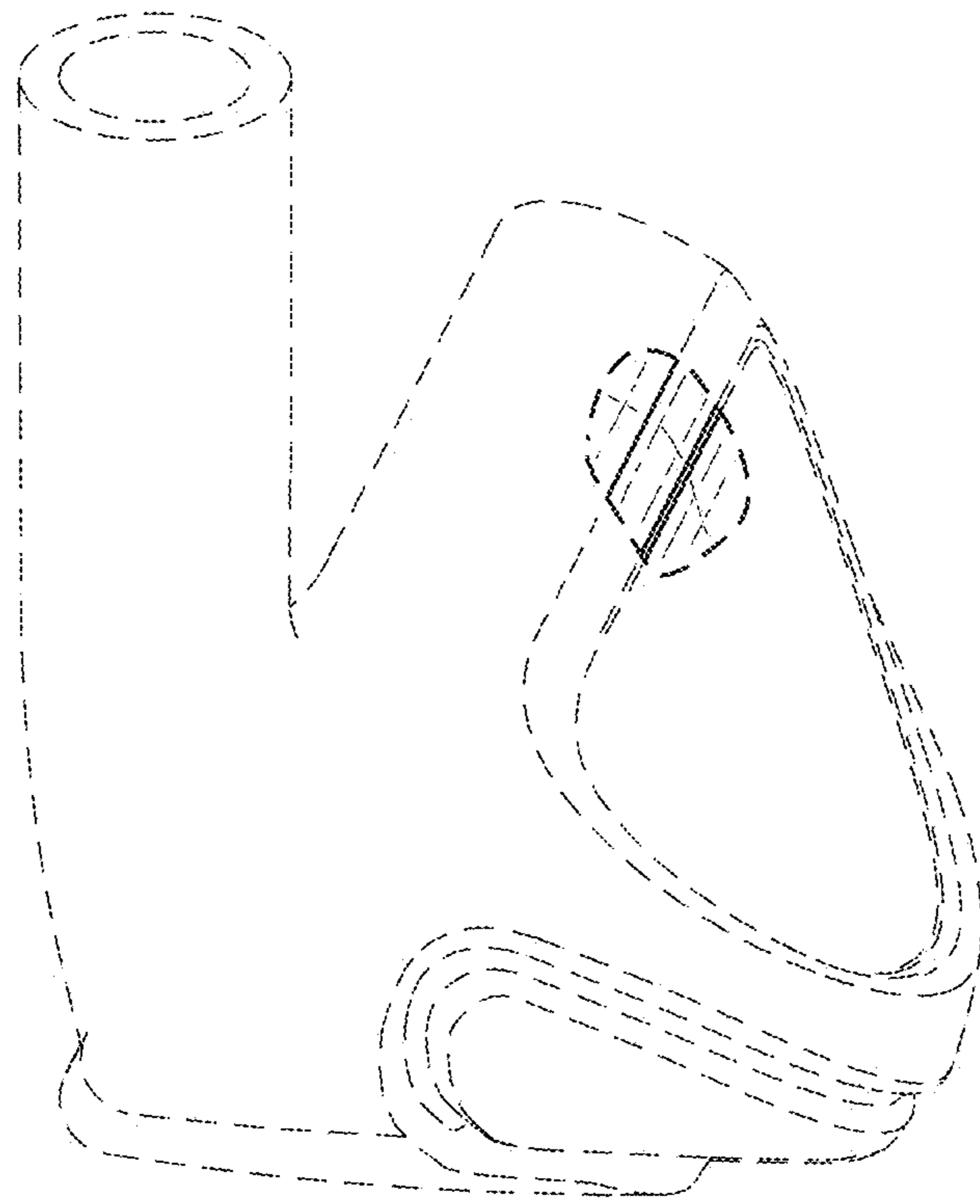

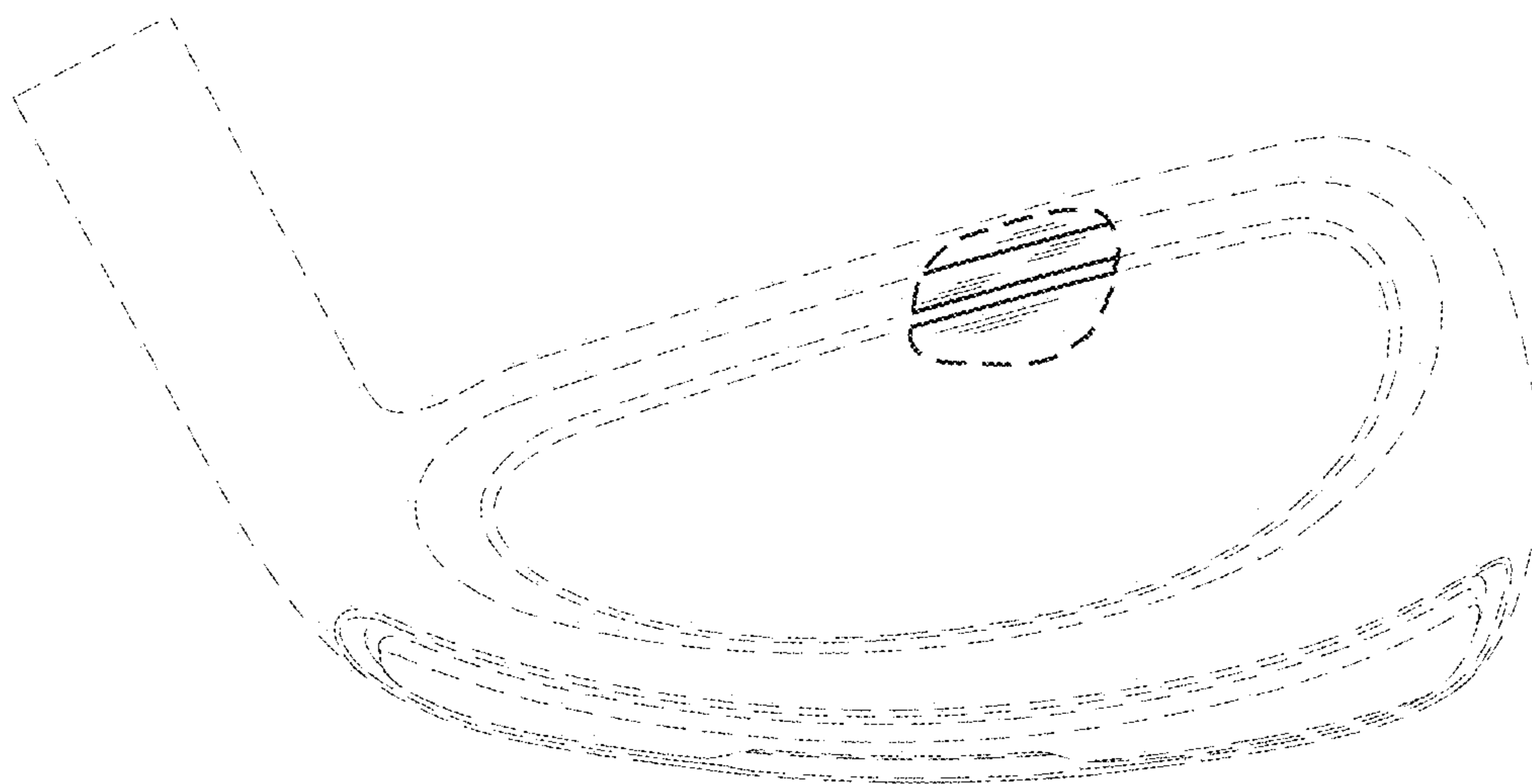

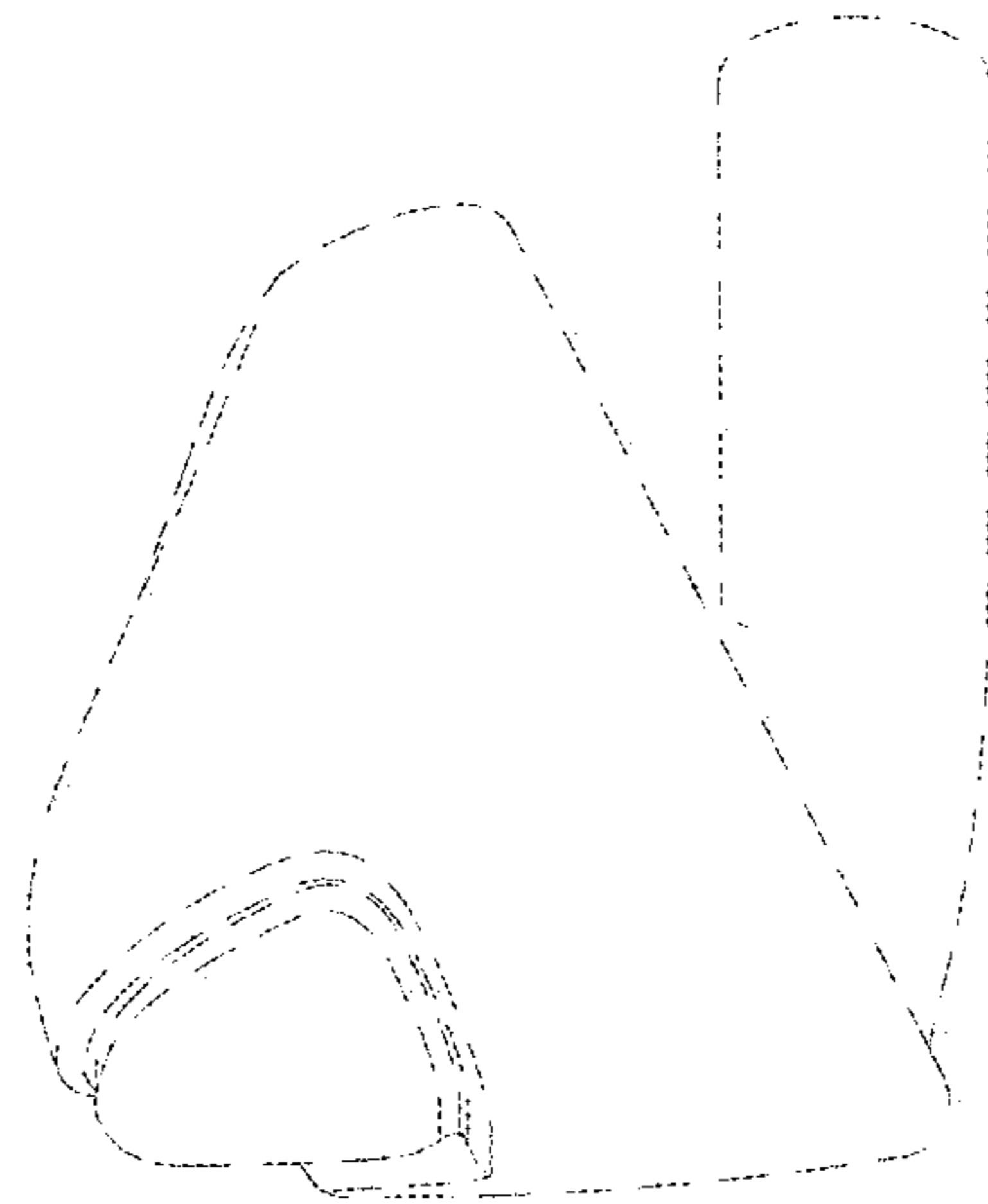

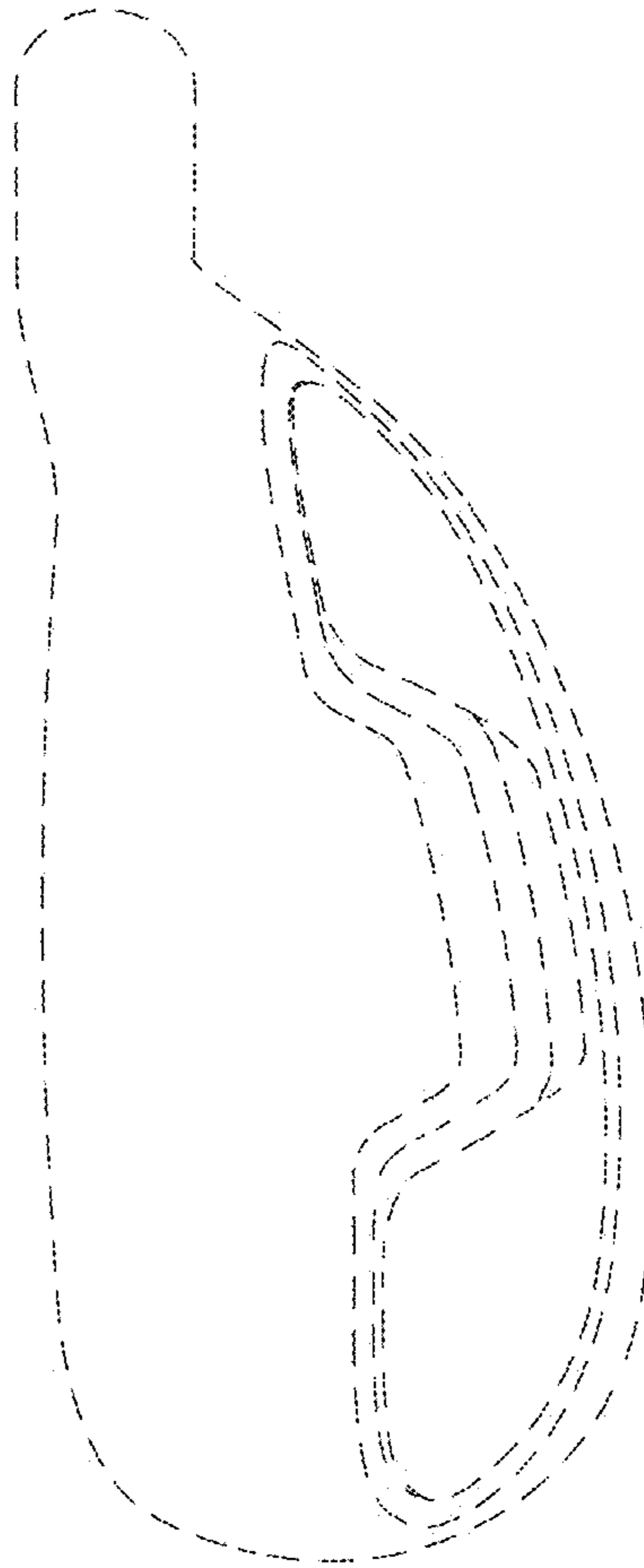

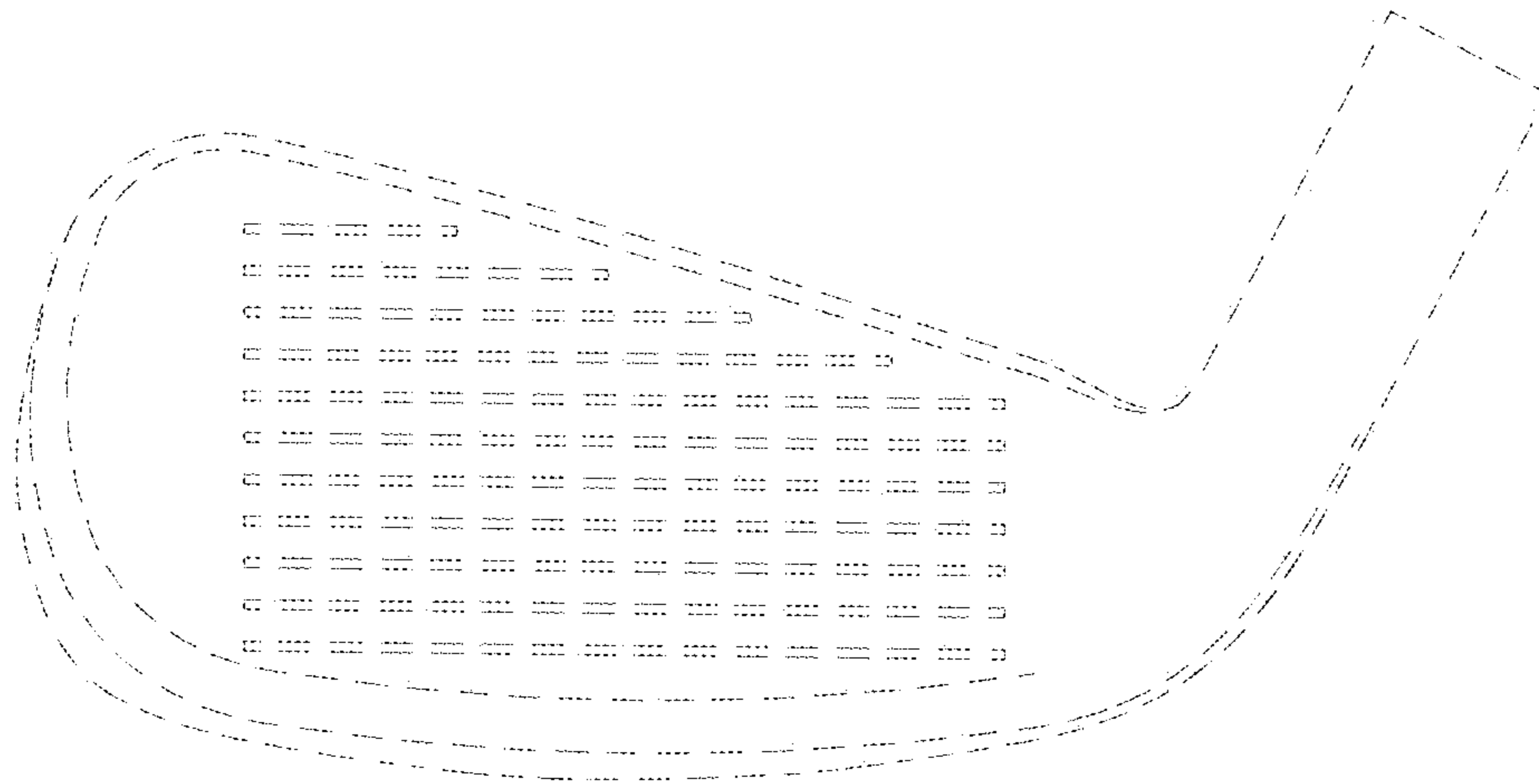

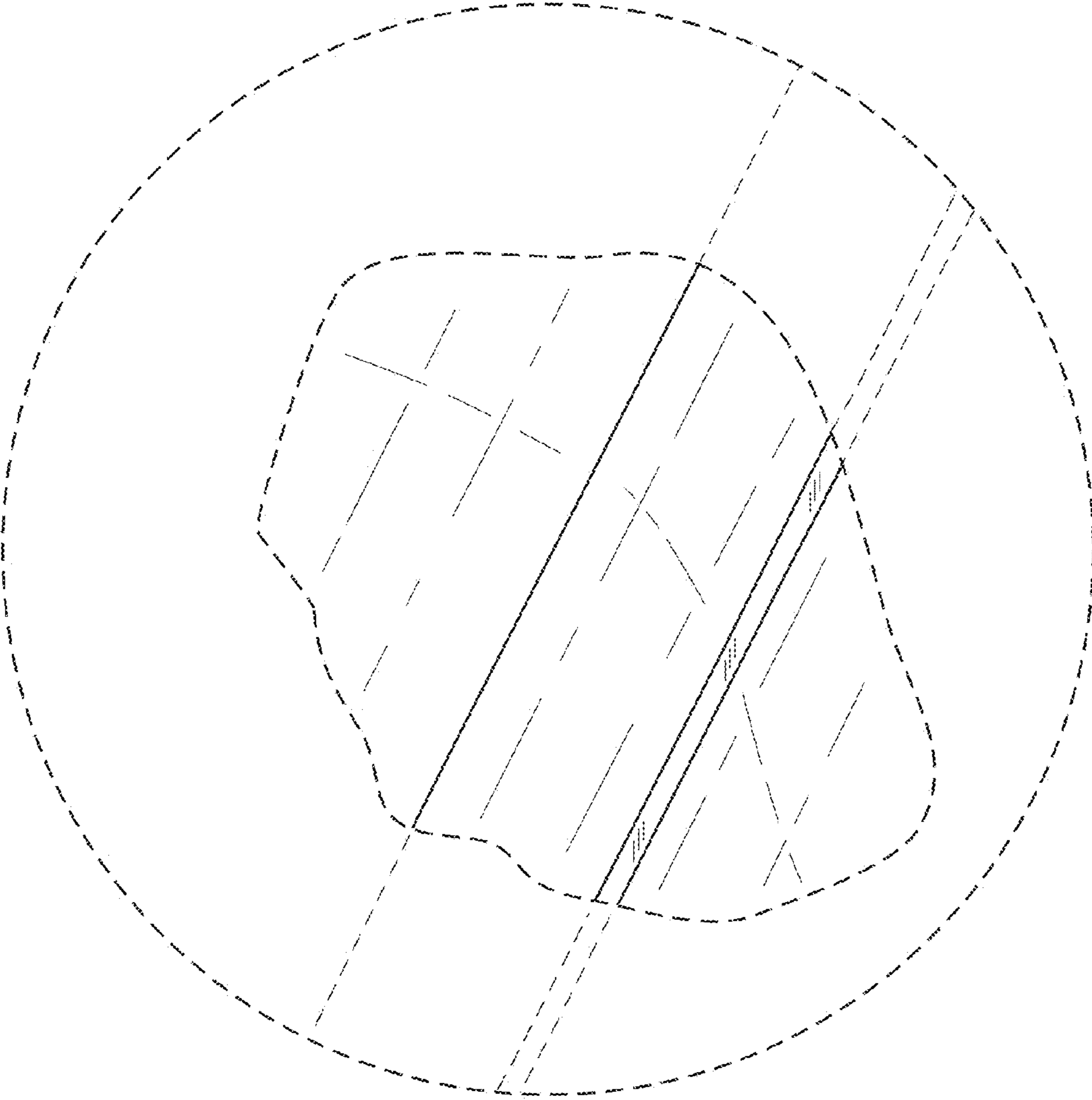
