FIG. 3 is a rear view of the netted garment of the present invention.

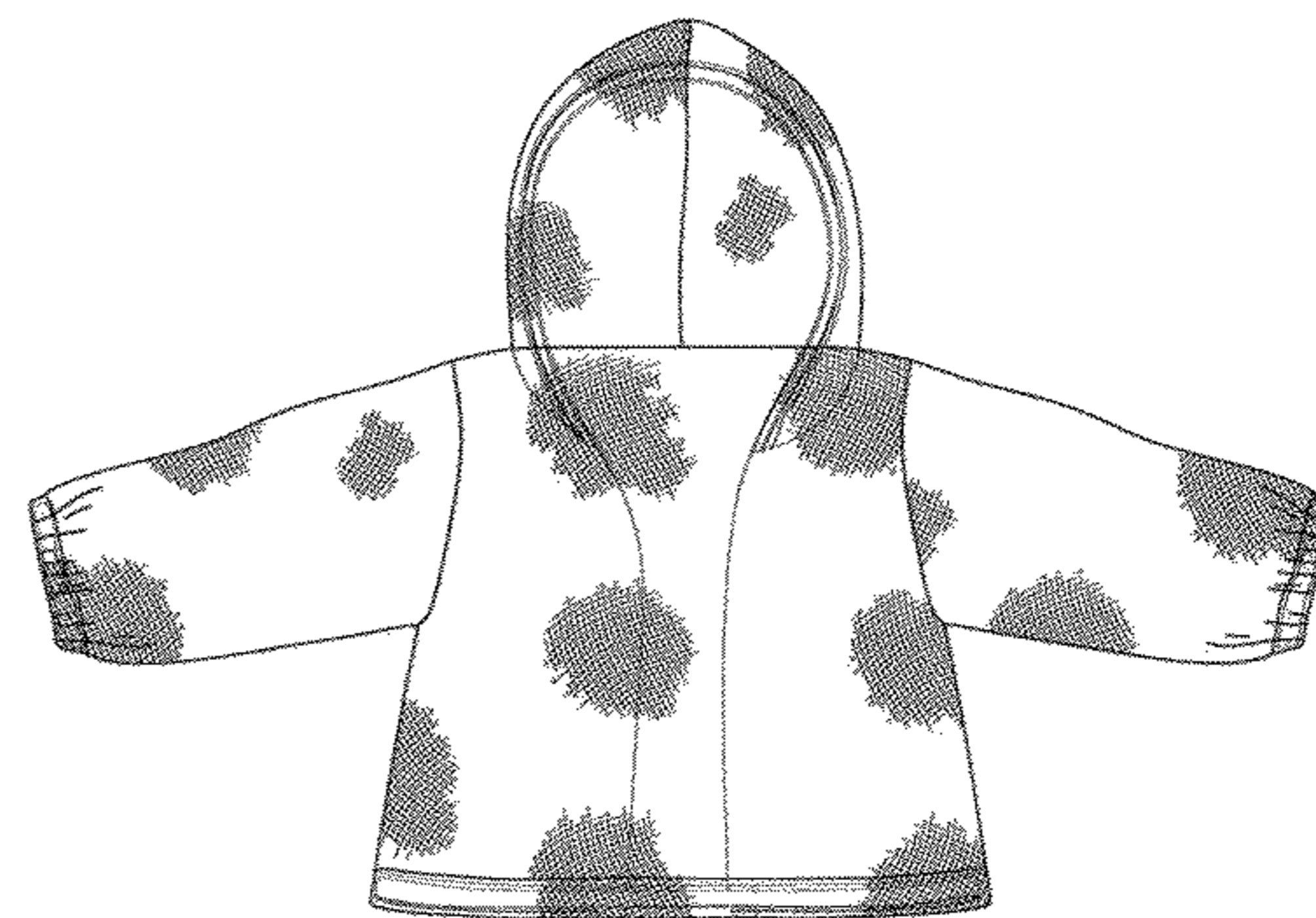
FIG. 4 is a side view of the netted garment of the present invention.

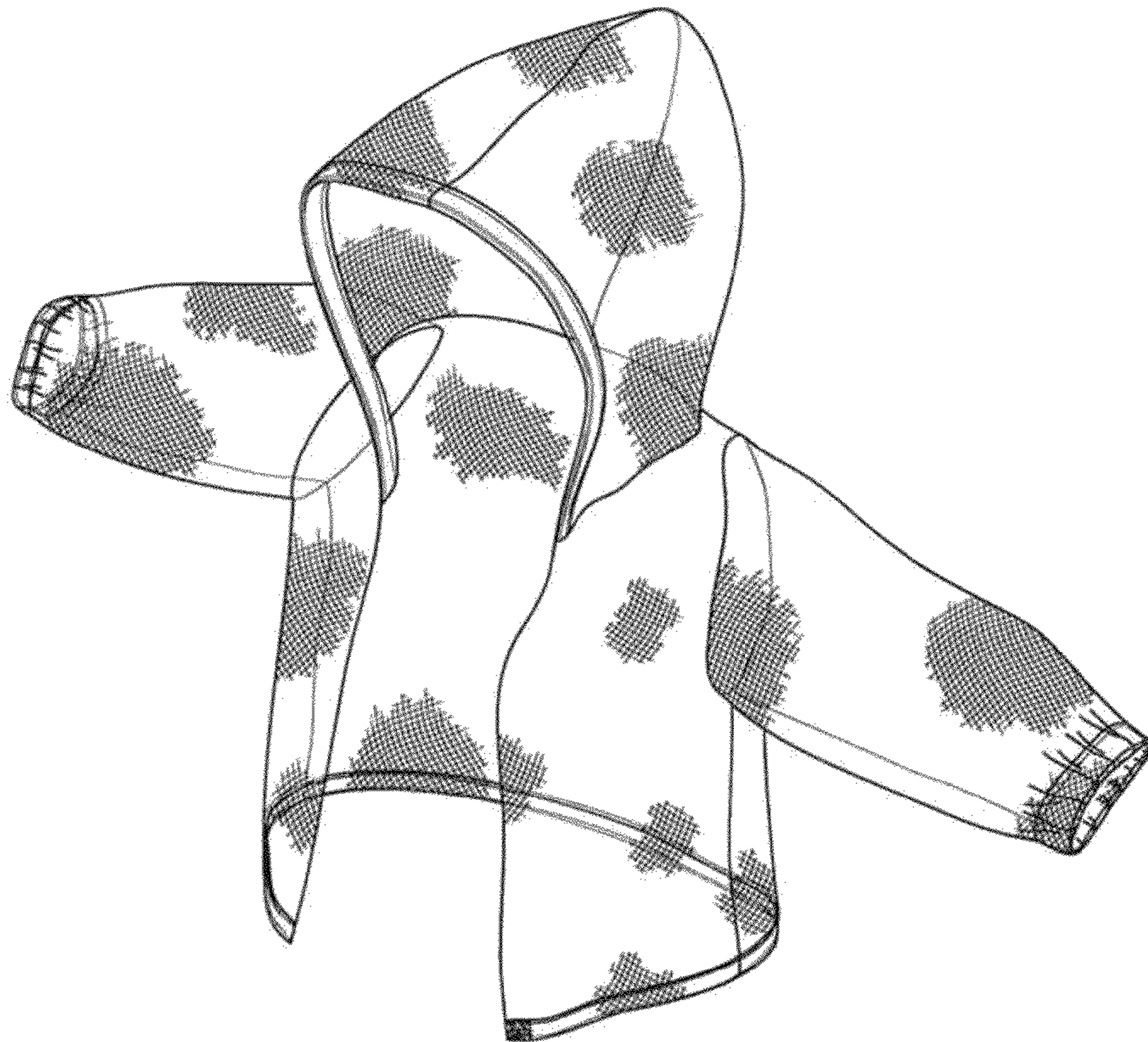

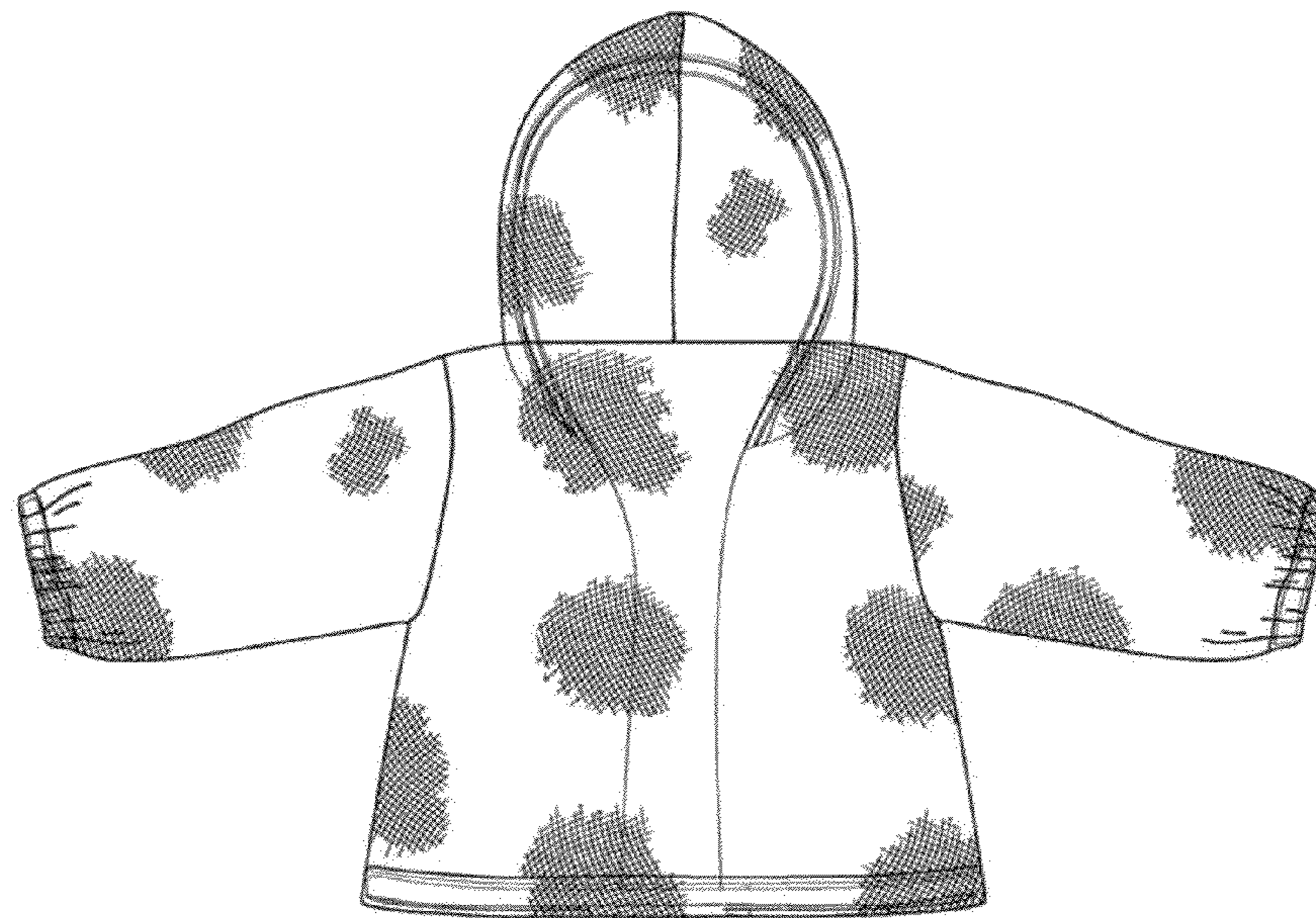
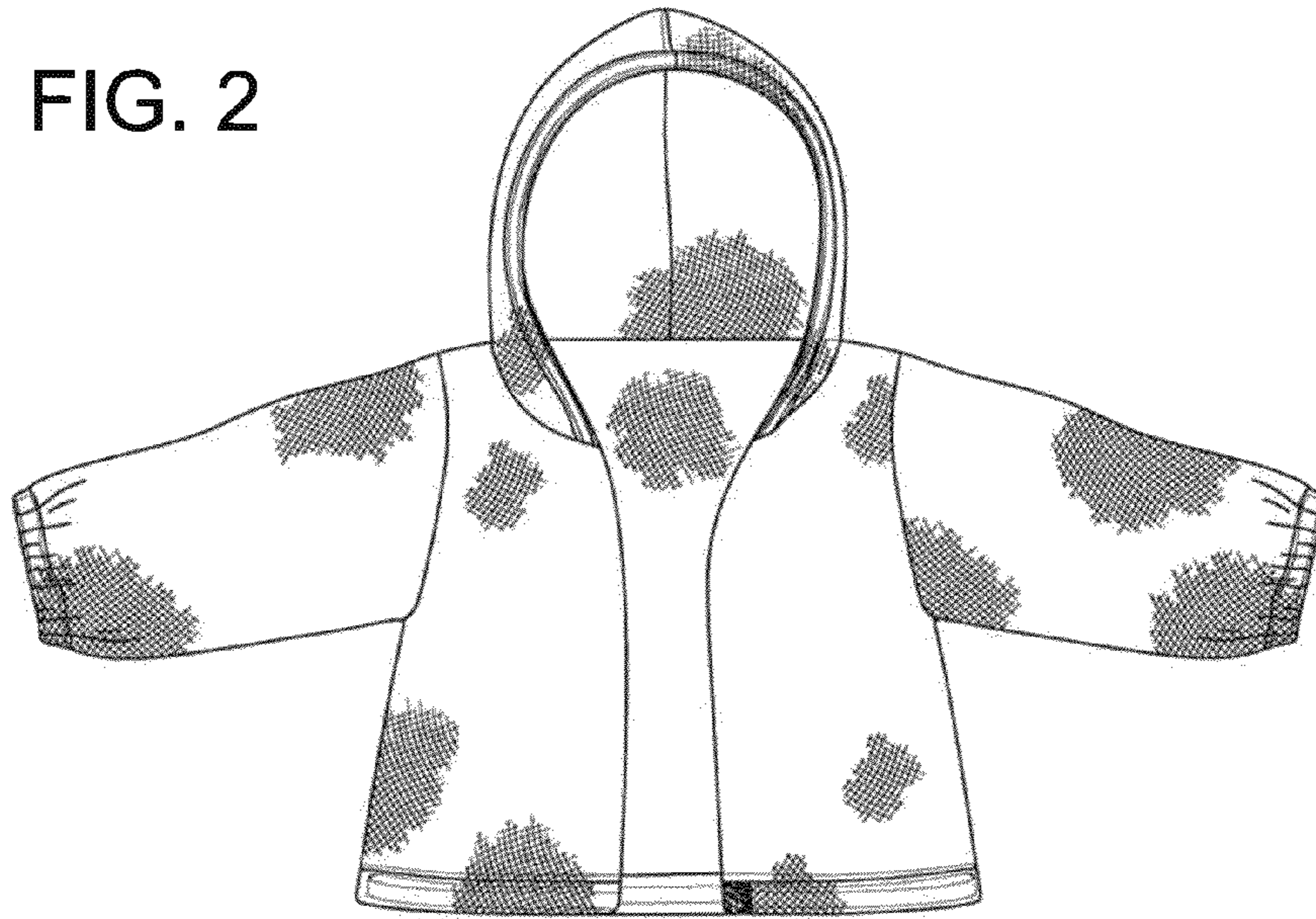

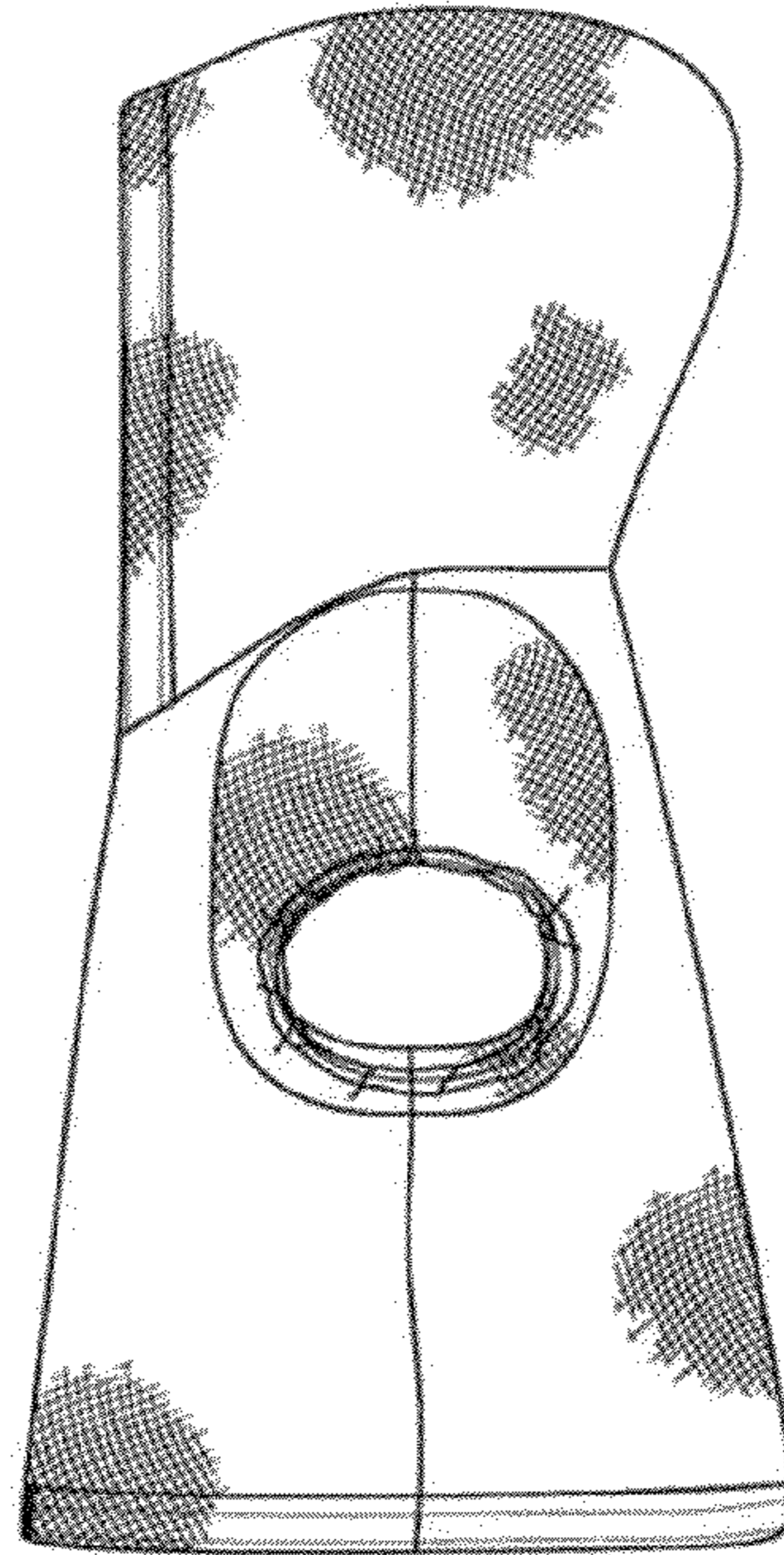
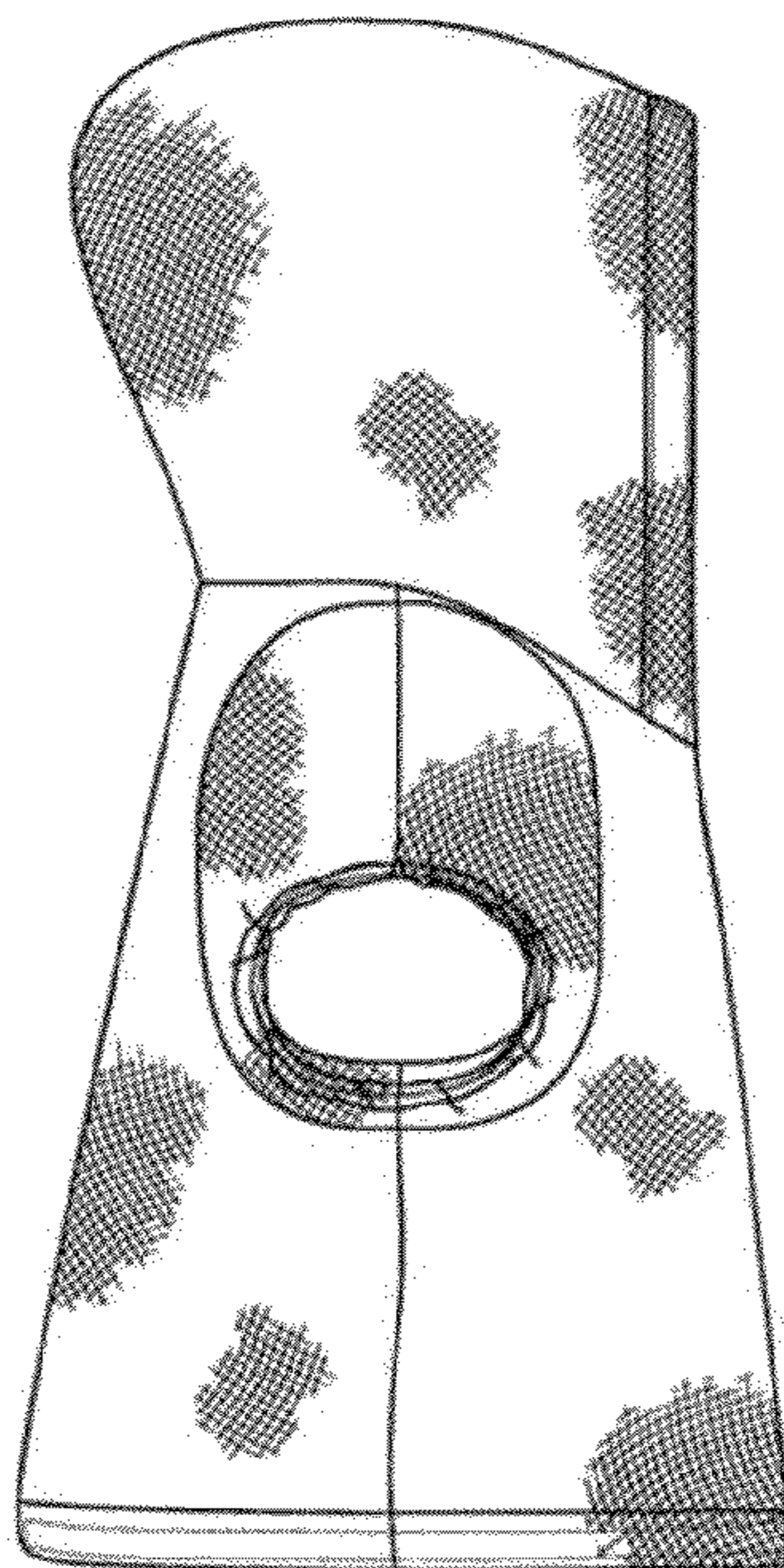

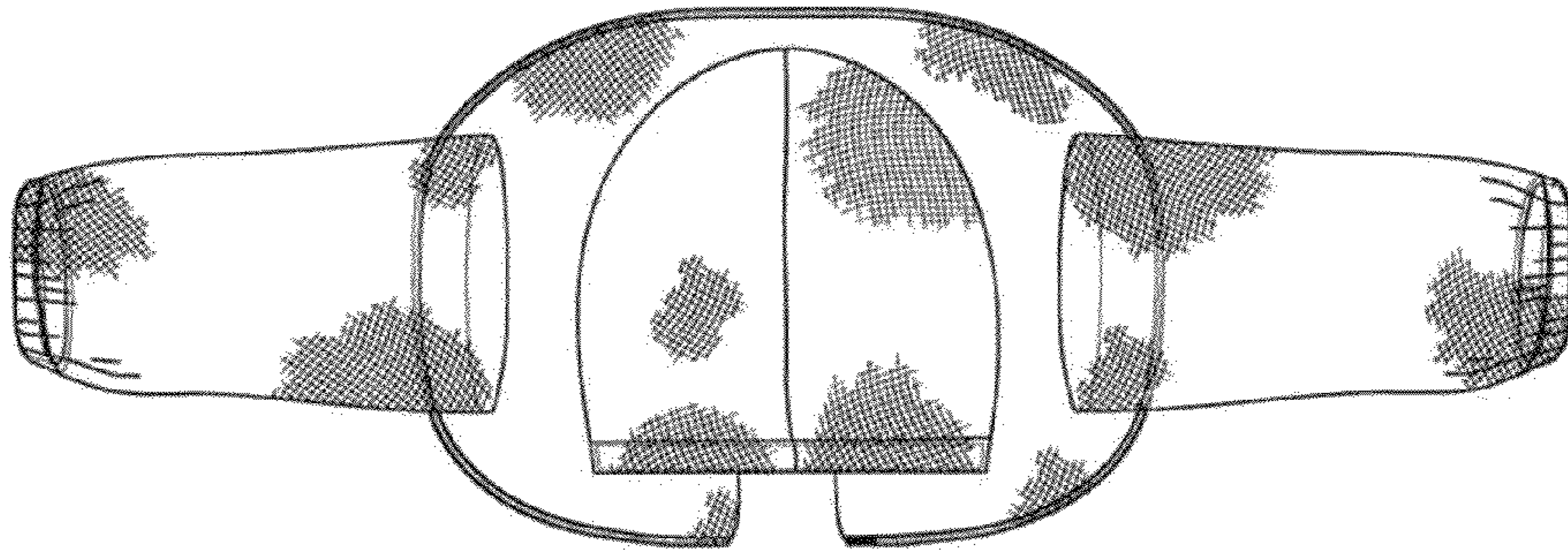

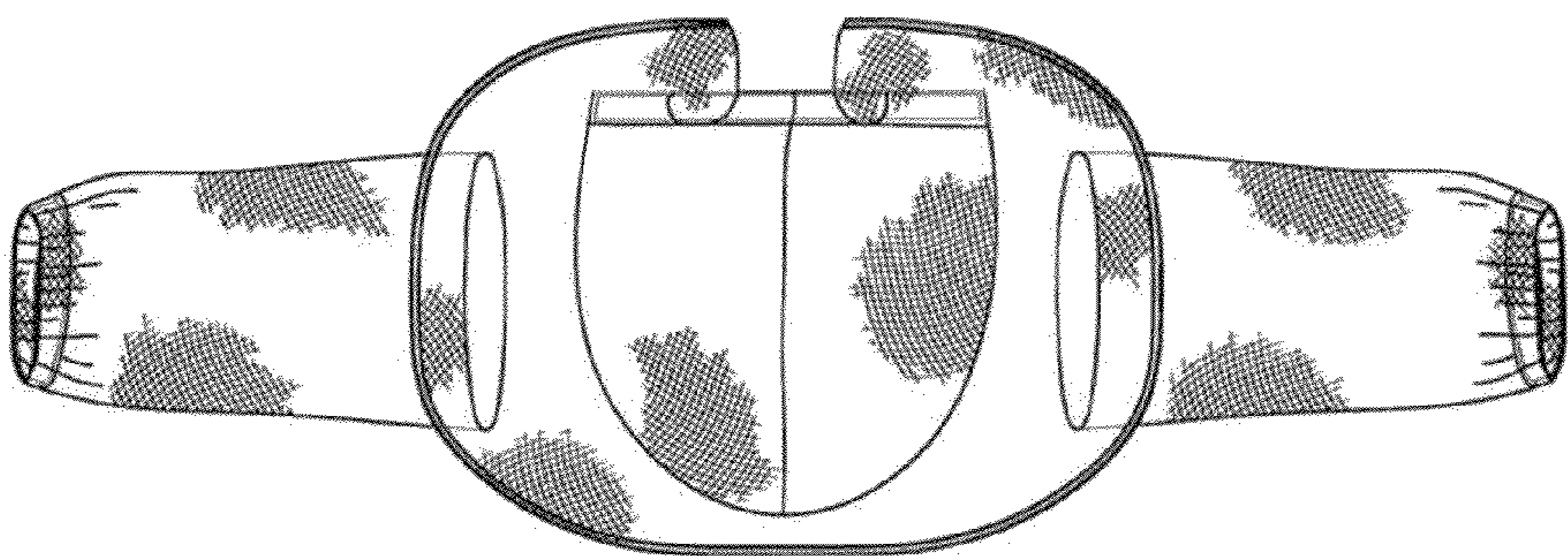
