(57) **CLAIM**
The ornamental design for a wrap, as shown and described.

DESCRIPTION

FIG. 1 is a top view of Embodiment 1 of the wrap showing my new design thereof;
FIG. 2 is a bottom view thereof;
FIG. 3 is a top view of Embodiment 2 of the wrap showing my new design thereof; and,
FIG. 4 is a bottom view thereof.
The wrap has a nominal thickness.
The dash, dash lines shown in FIGS. 1-4 of the wrap represent surface pattern and are part of the claimed design.

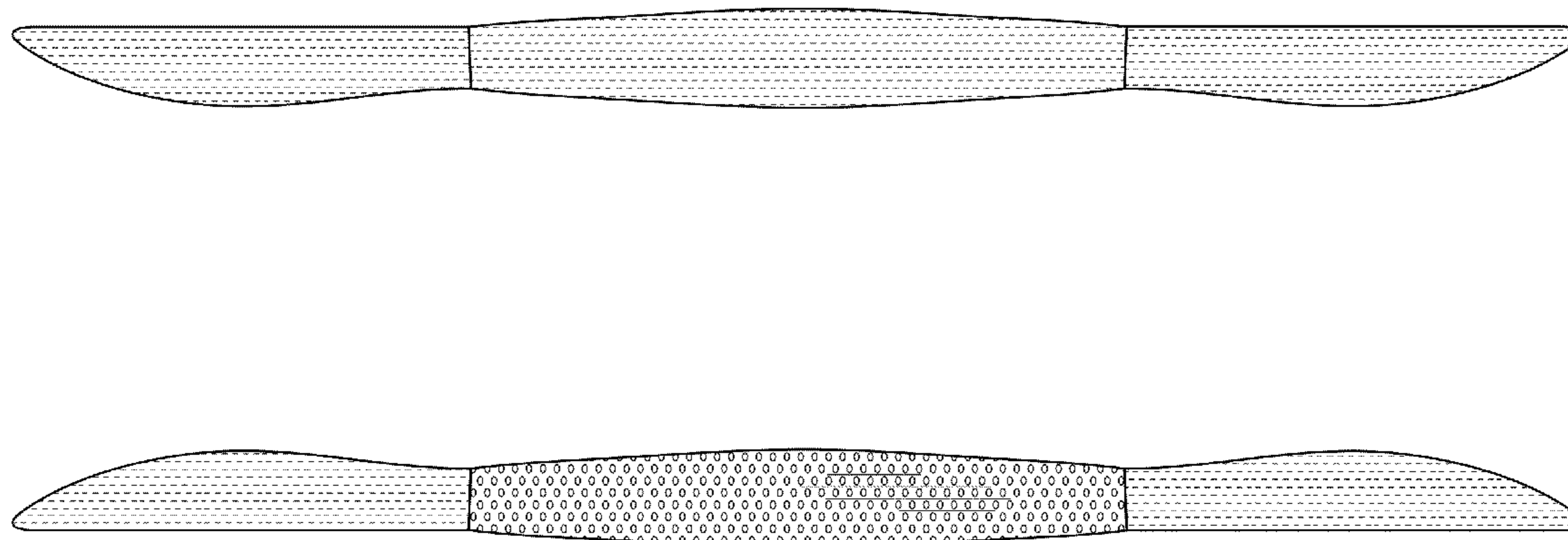

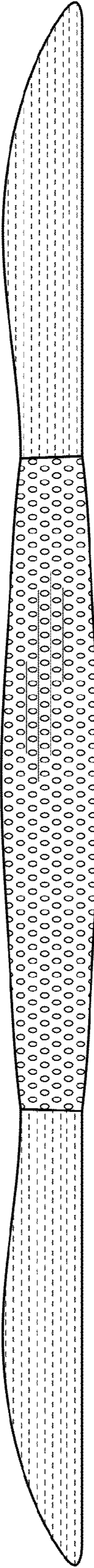

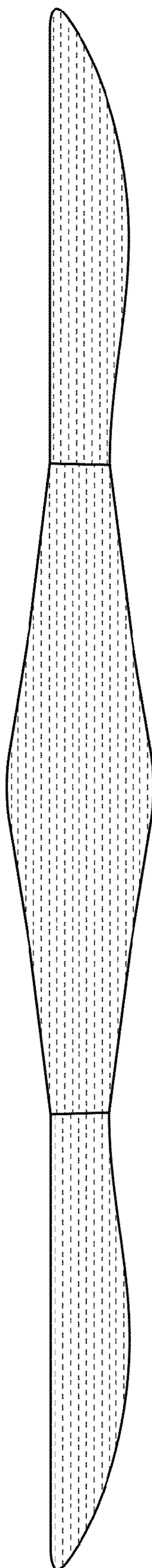

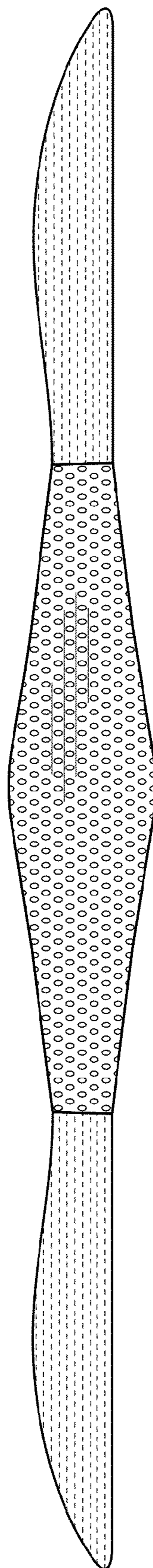
