(57) **CLAIM**

The ornamental design for an electric toothbrush with cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electric toothbrush with cap;

FIG. 2 is a front view thereof;

FIG. 3 is a right side view thereof, the left side being a mirror image;

FIG. 4 is an enlarged top plan view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is an enlarged bottom plan view thereof;

FIG. 7 is front perspective view thereof with the cap omitted for clarity of illustration only;

FIG. 8 is a rear perspective view of the design as shown in FIG. 7;

FIG. 9 is a front view of the design as shown in FIG. 7;

FIG. 10 is a right side view of the design as shown in FIG. 7;

FIG. 11 is an enlarged top plan view of the design as shown in FIG. 7;

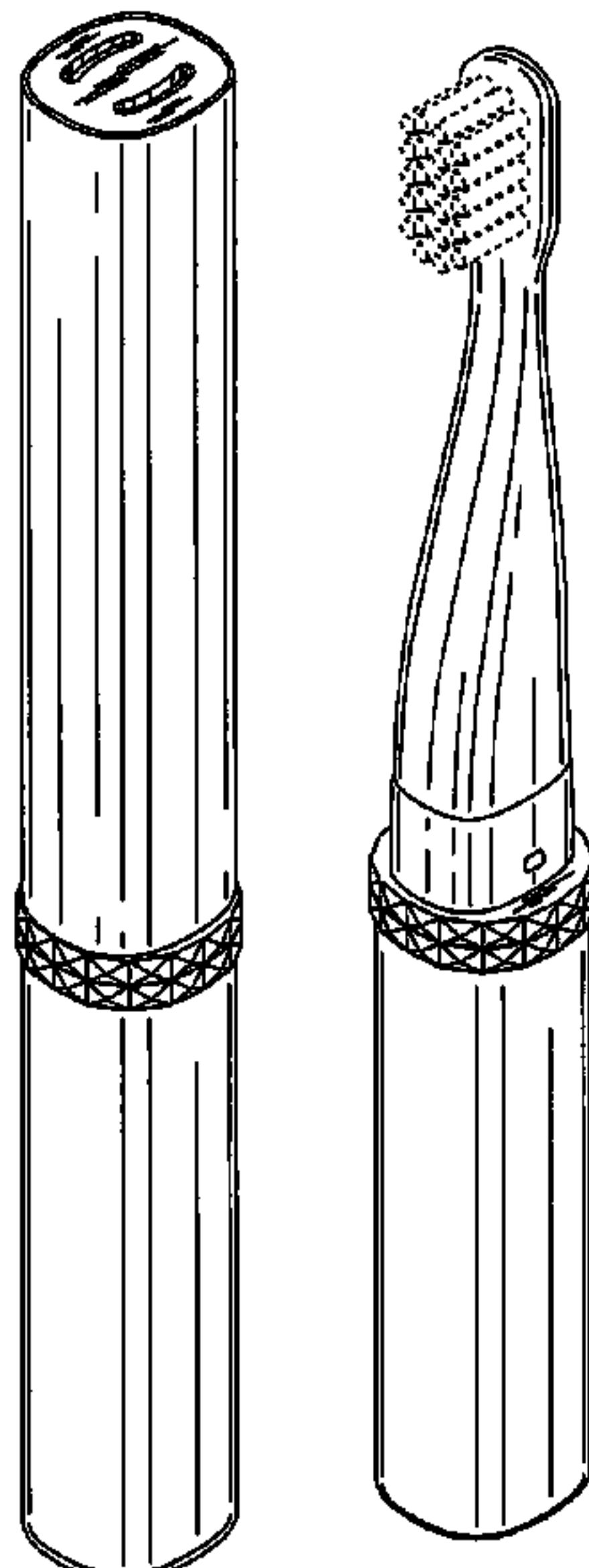
FIG. 12 is a rear view of the design as shown in FIG. 7;

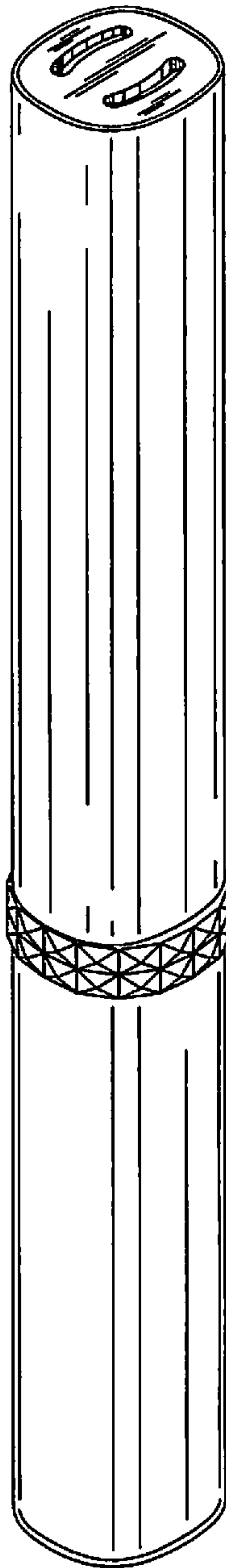

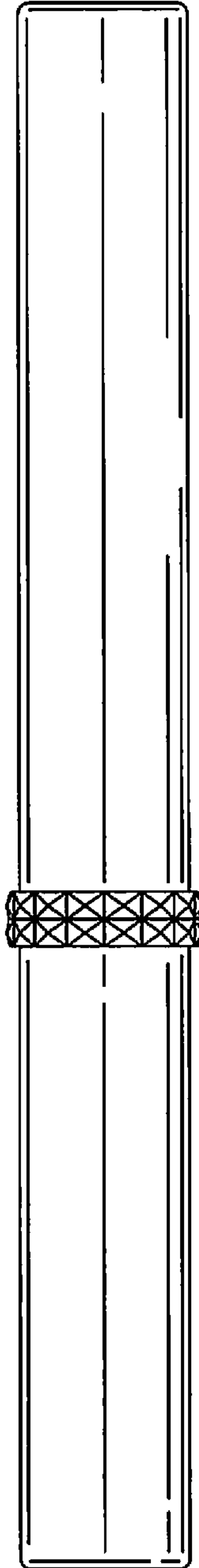

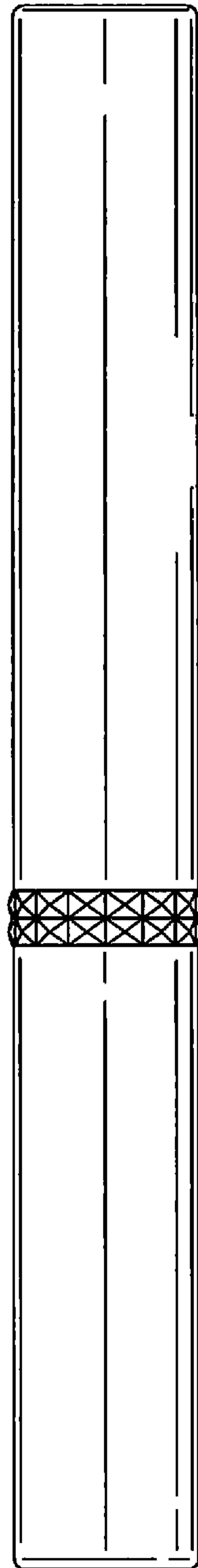

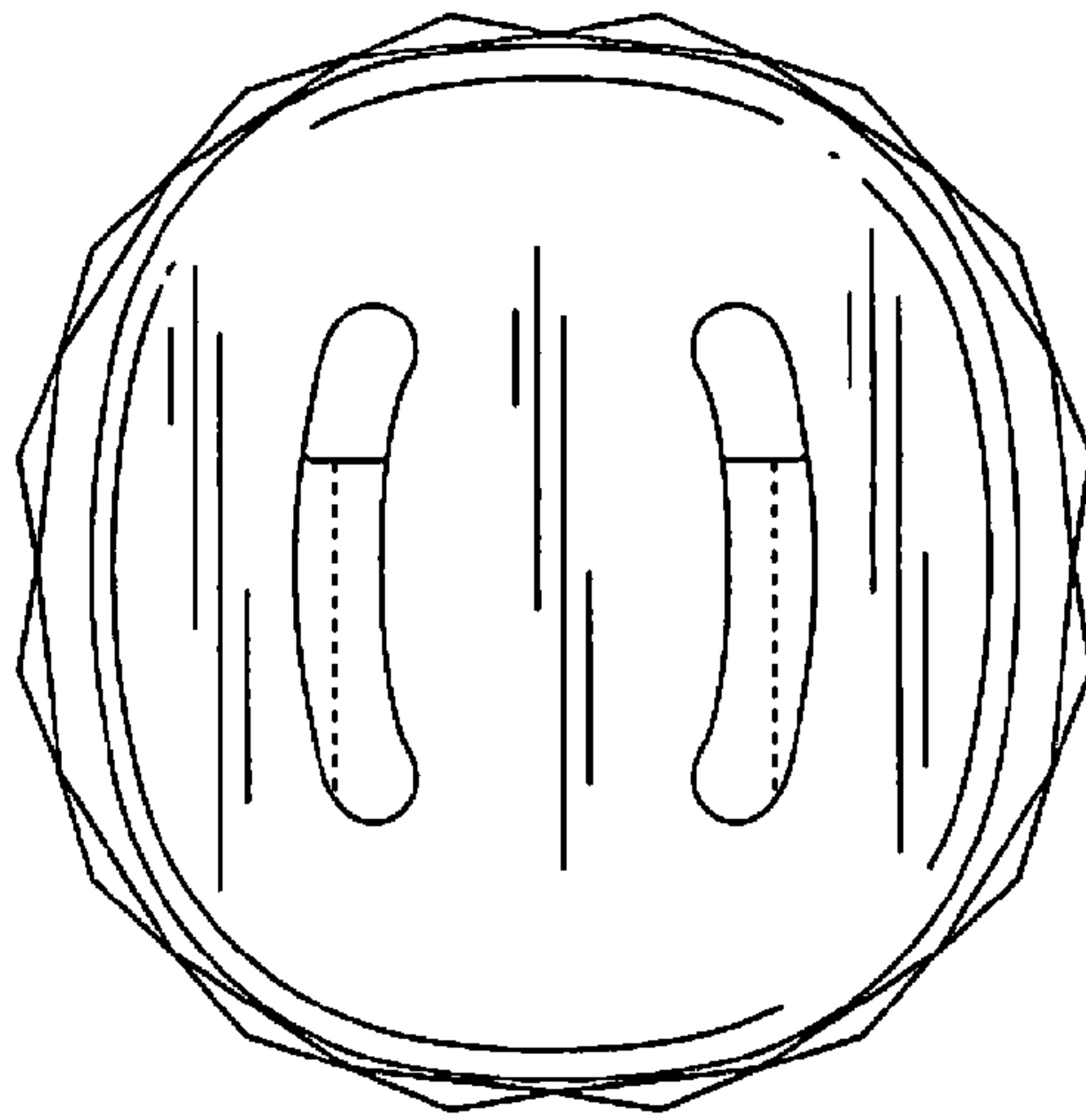

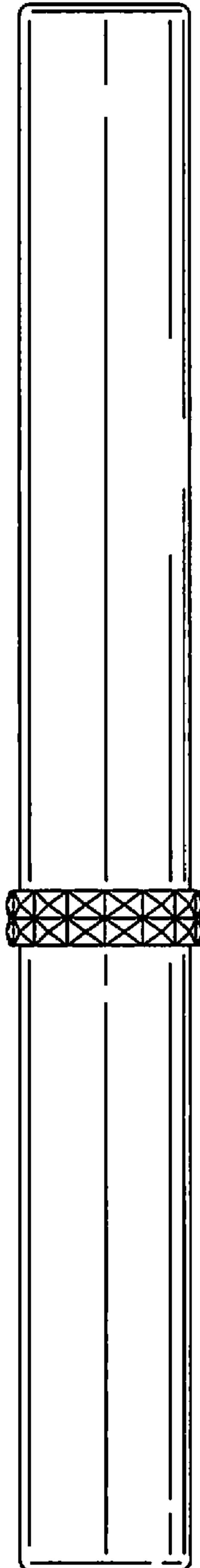

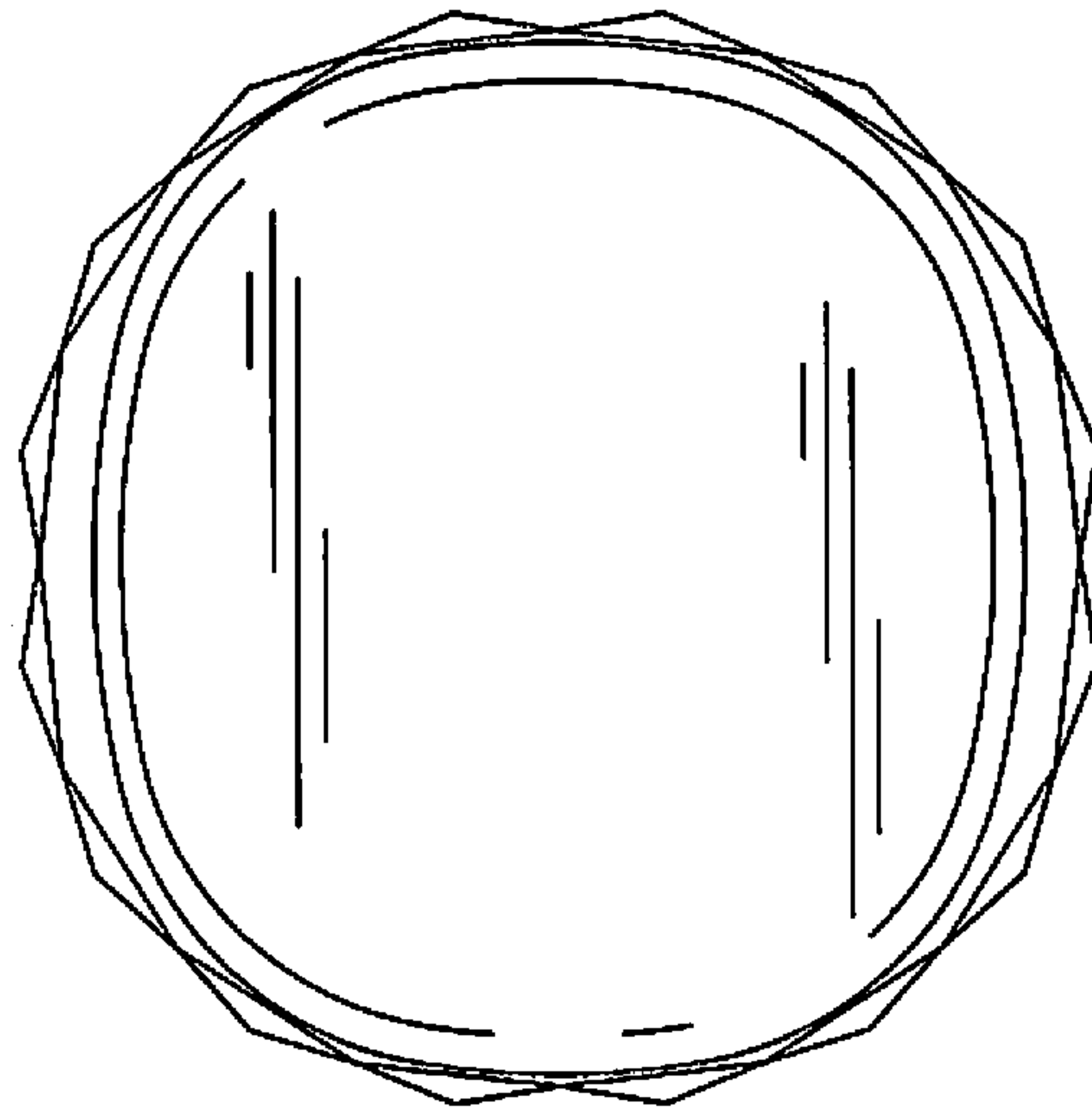

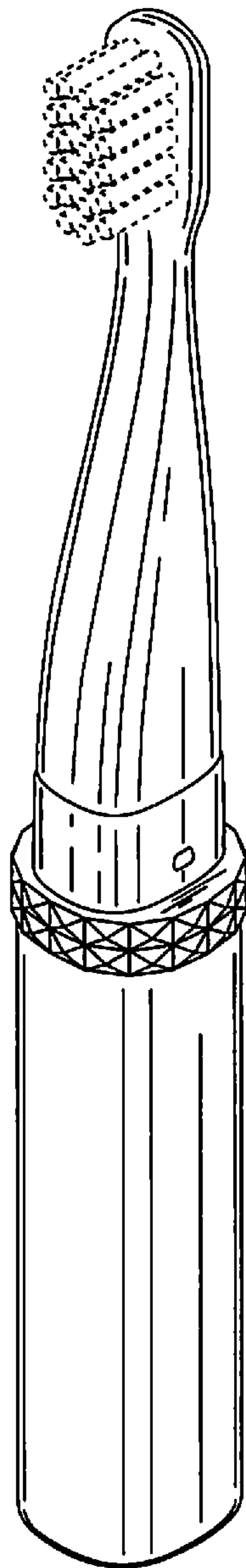

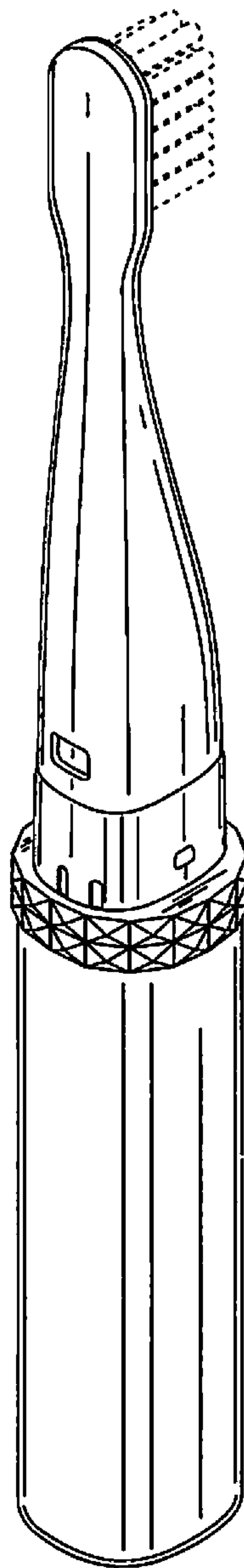

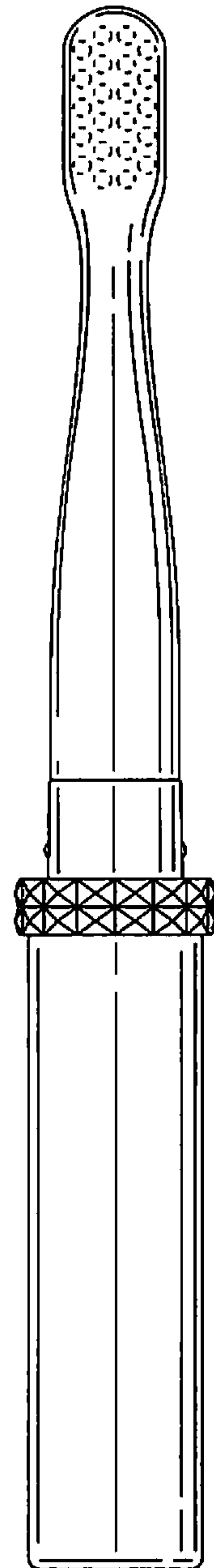

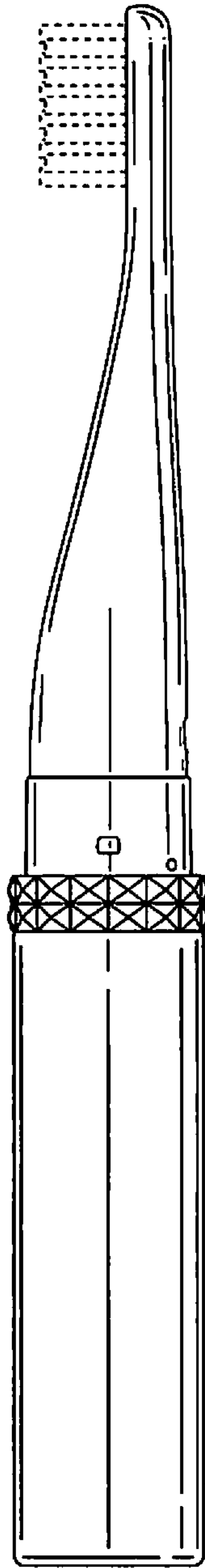

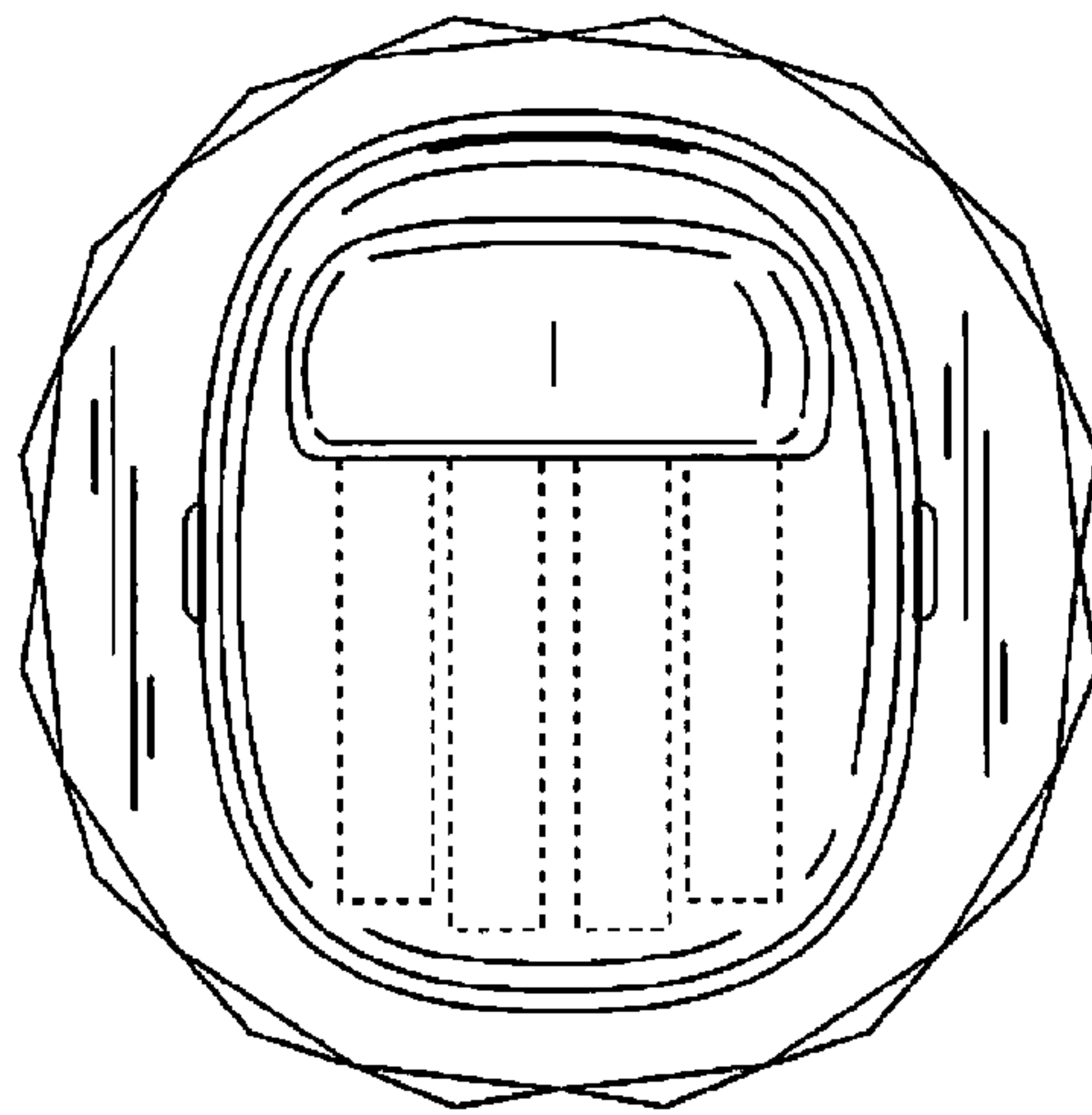

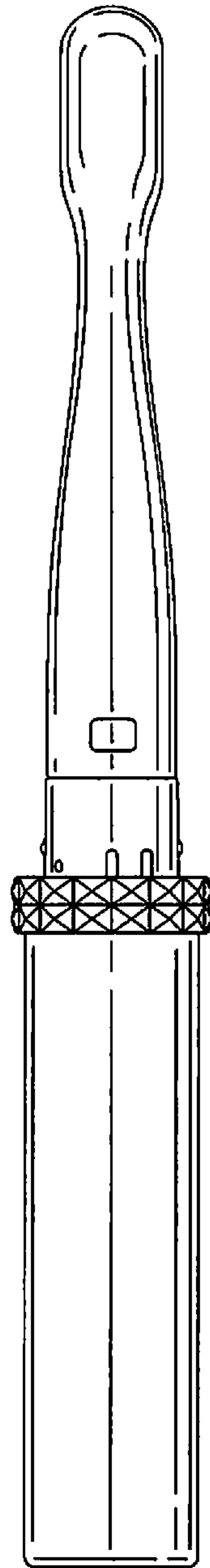

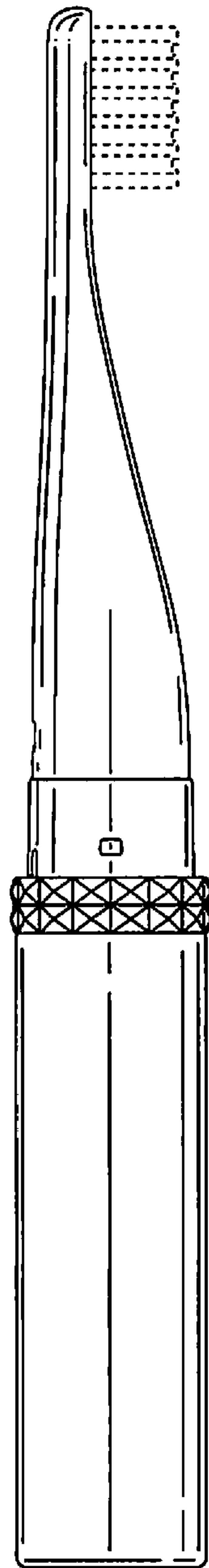
