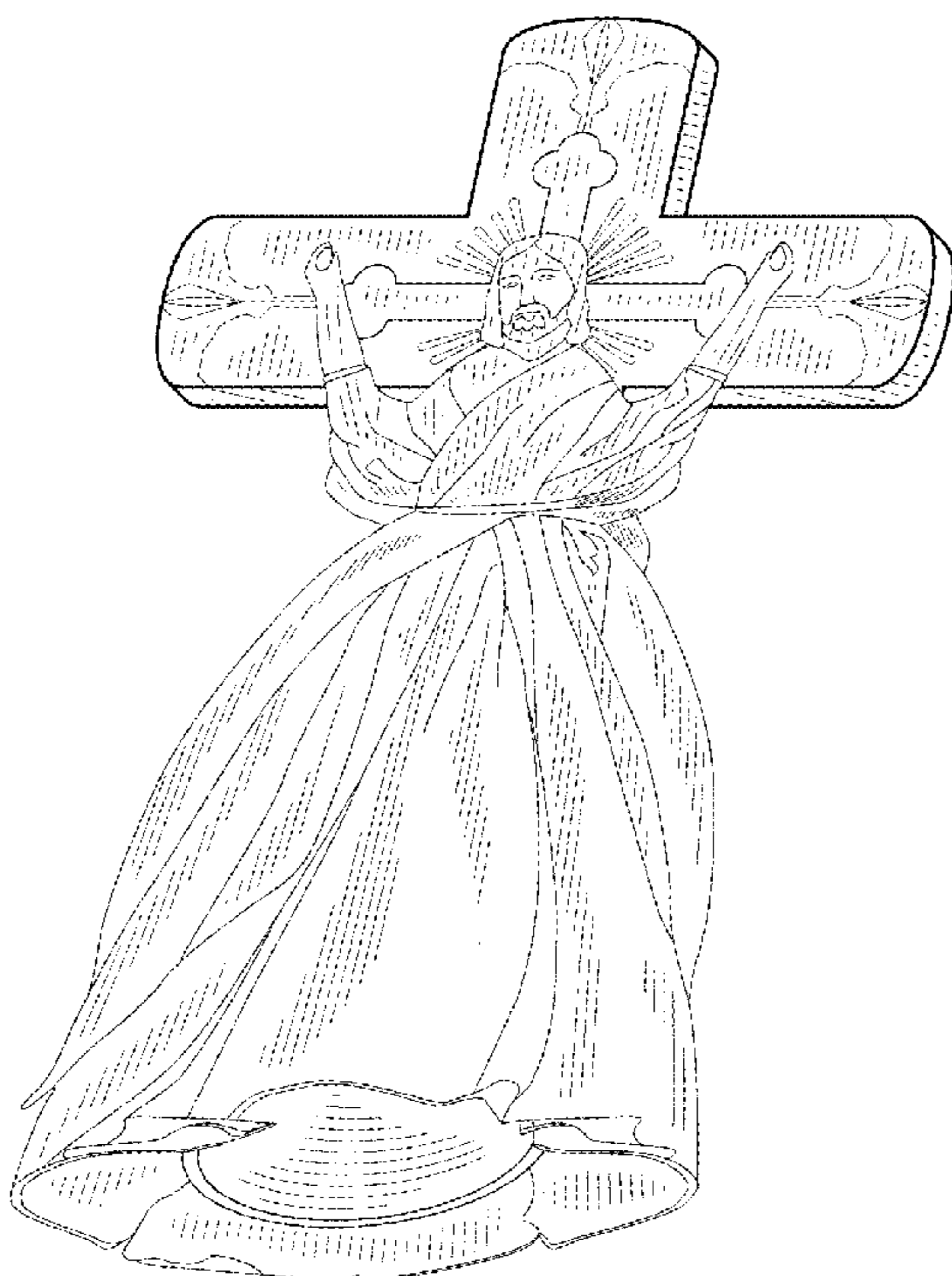
(57) **CLAIM**

I claim the ornamental design for a Christmas tree topper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a Christmas tree topper, showing my new design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a right-side elevational view thereof;

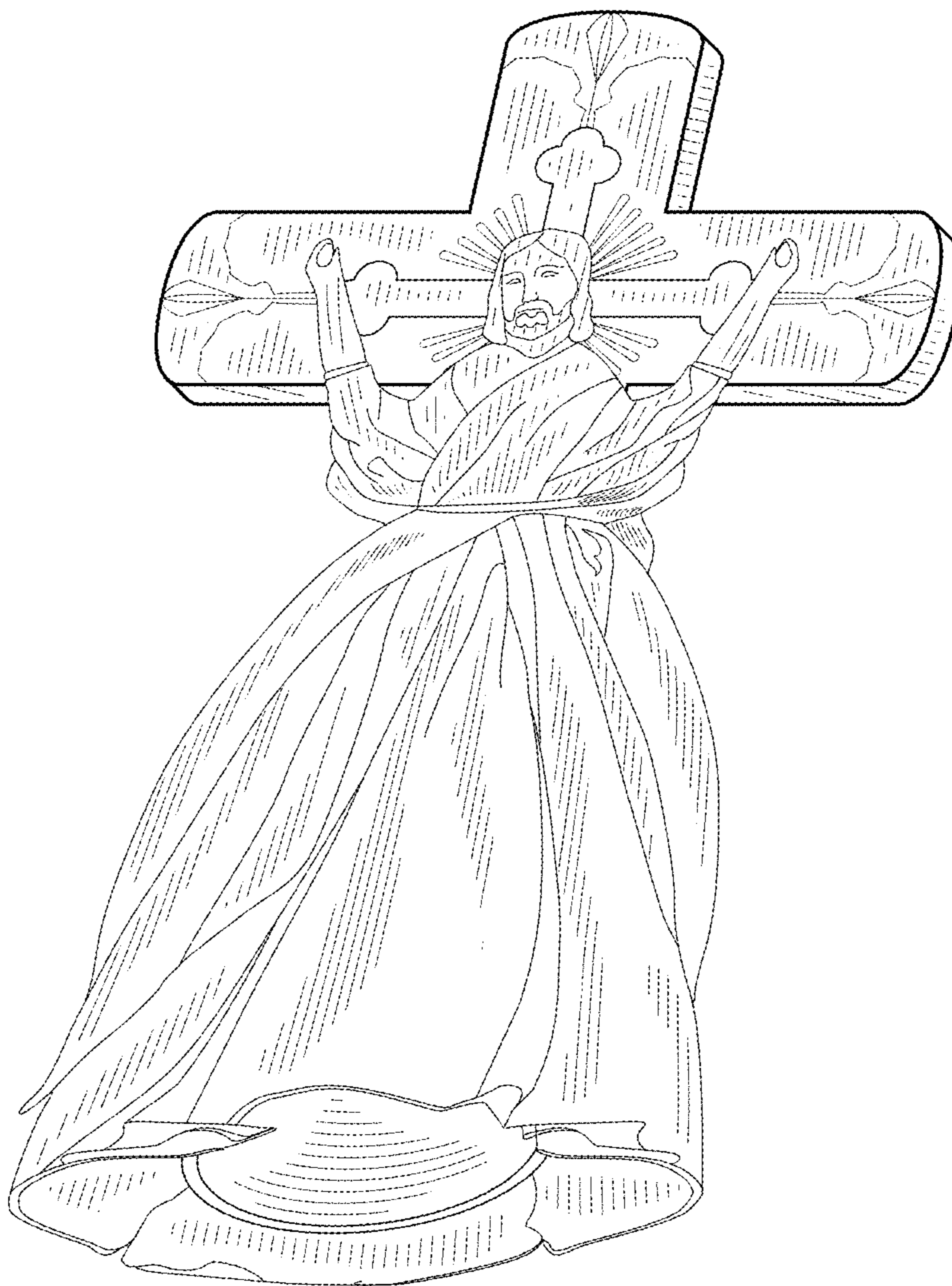

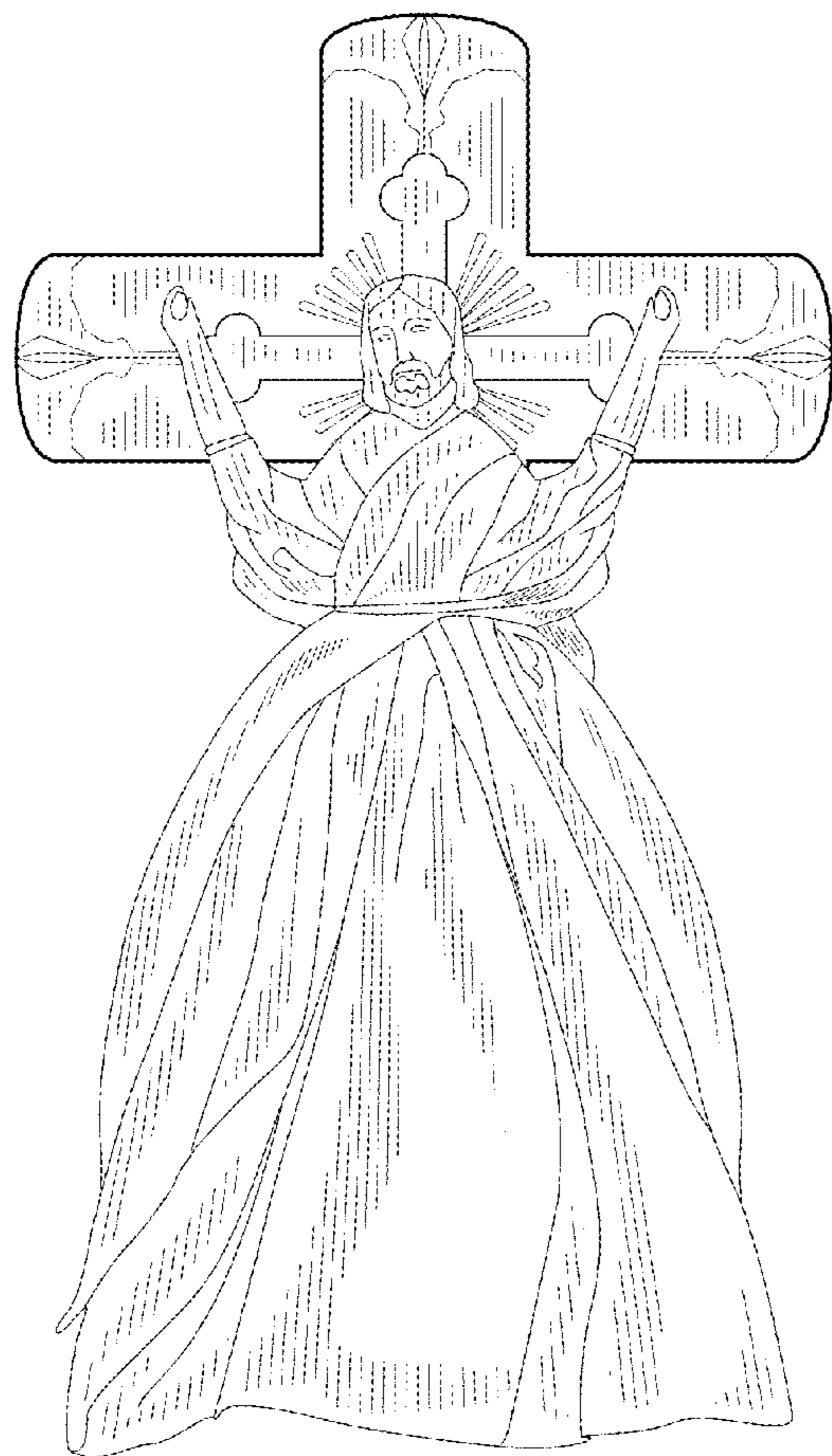

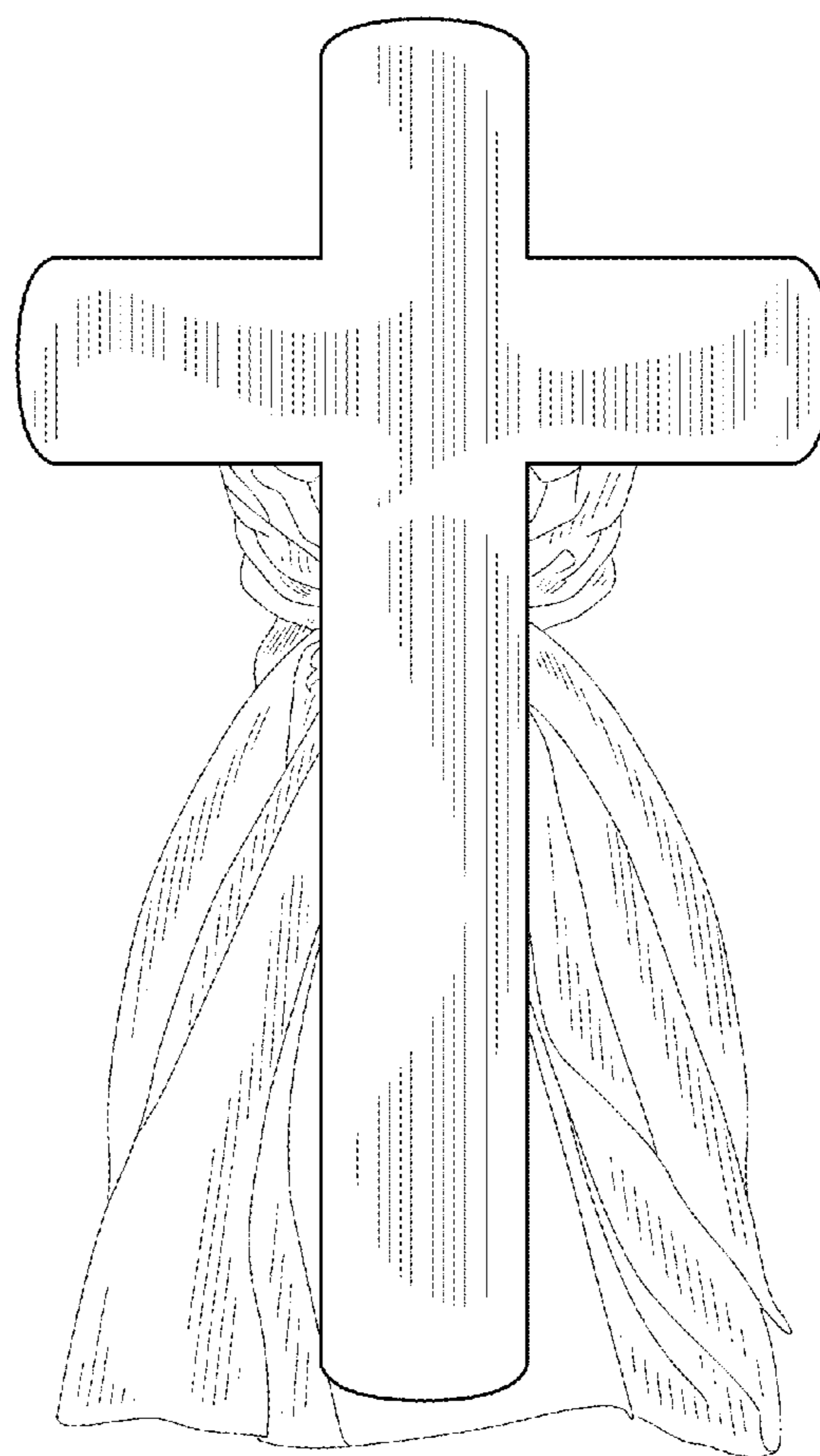

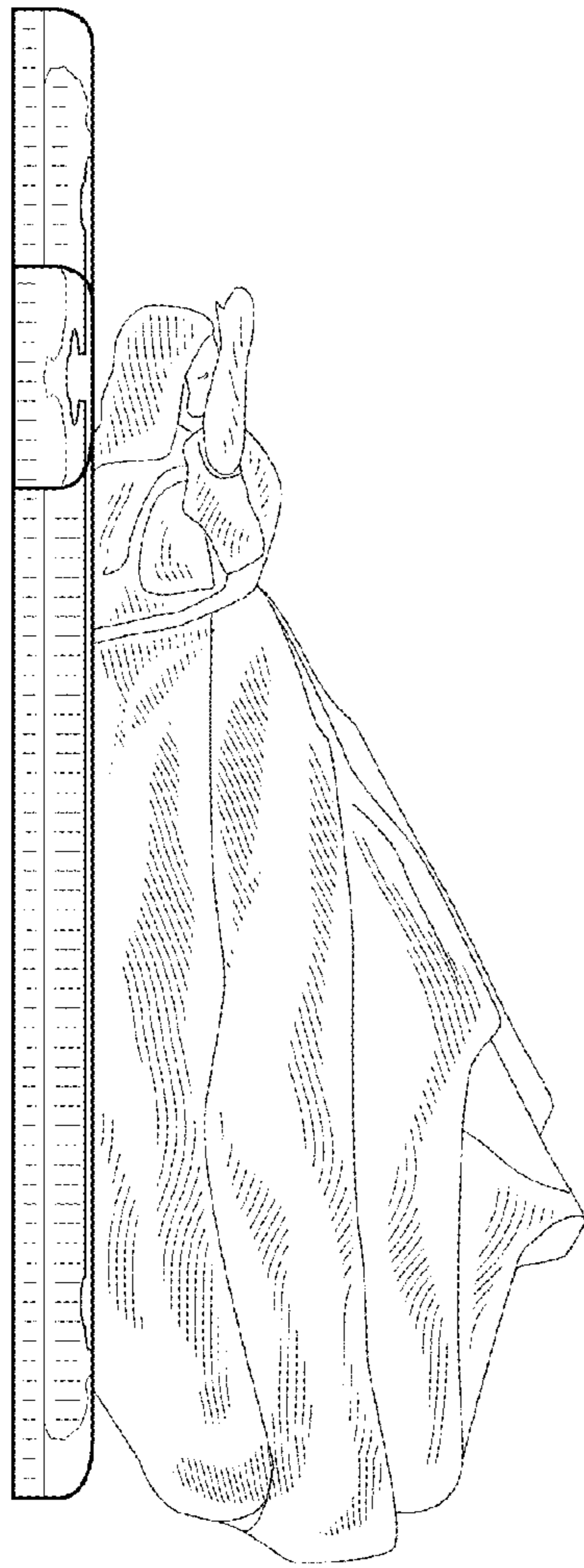

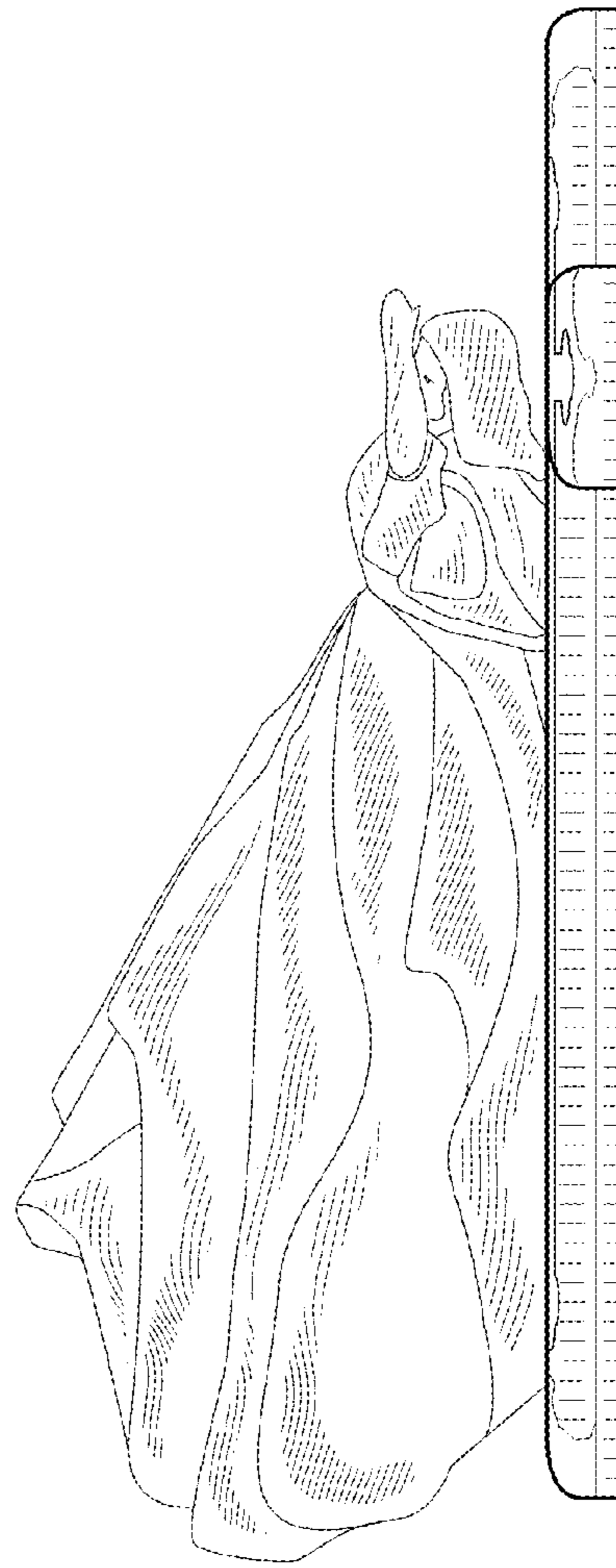

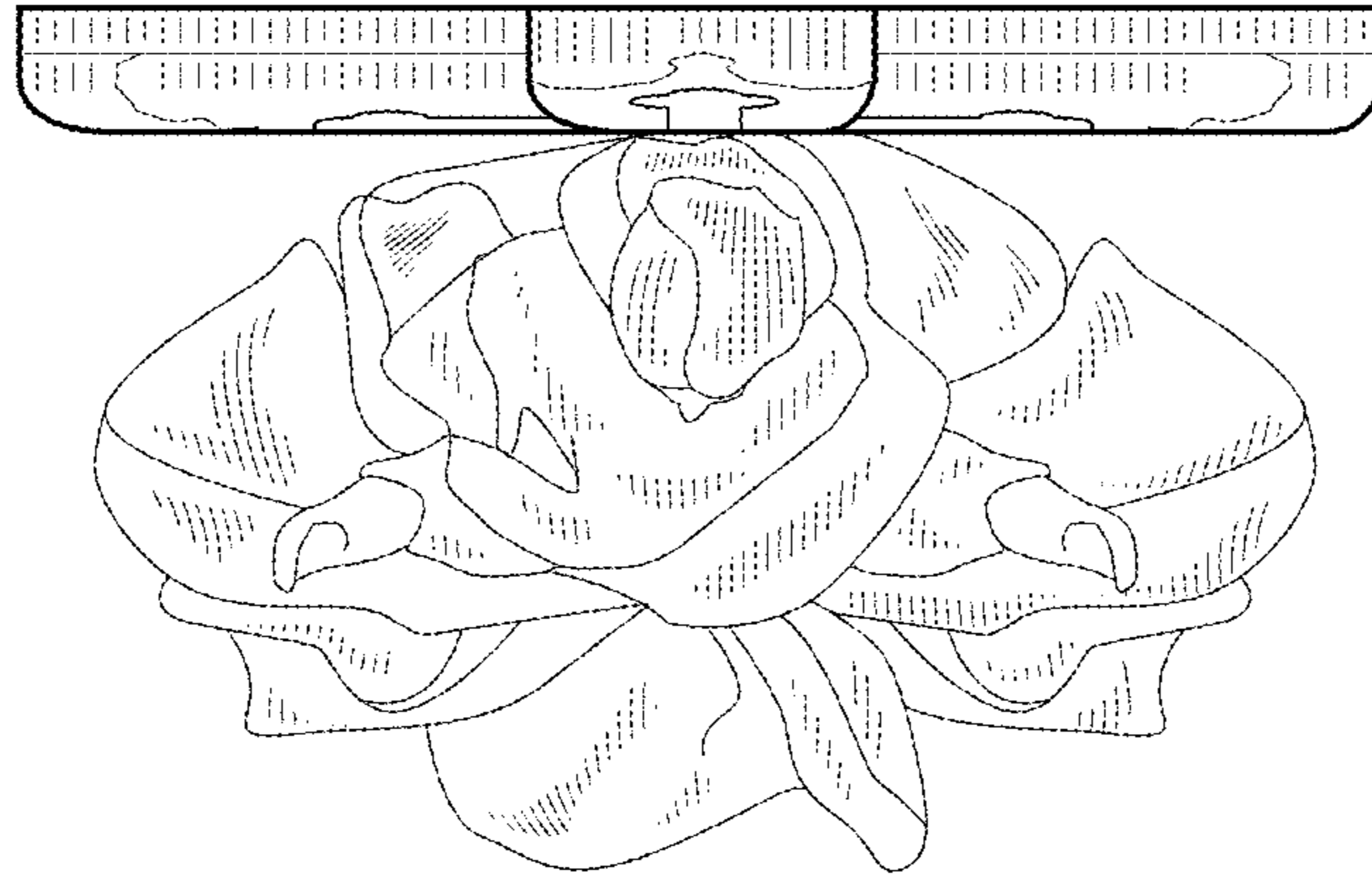

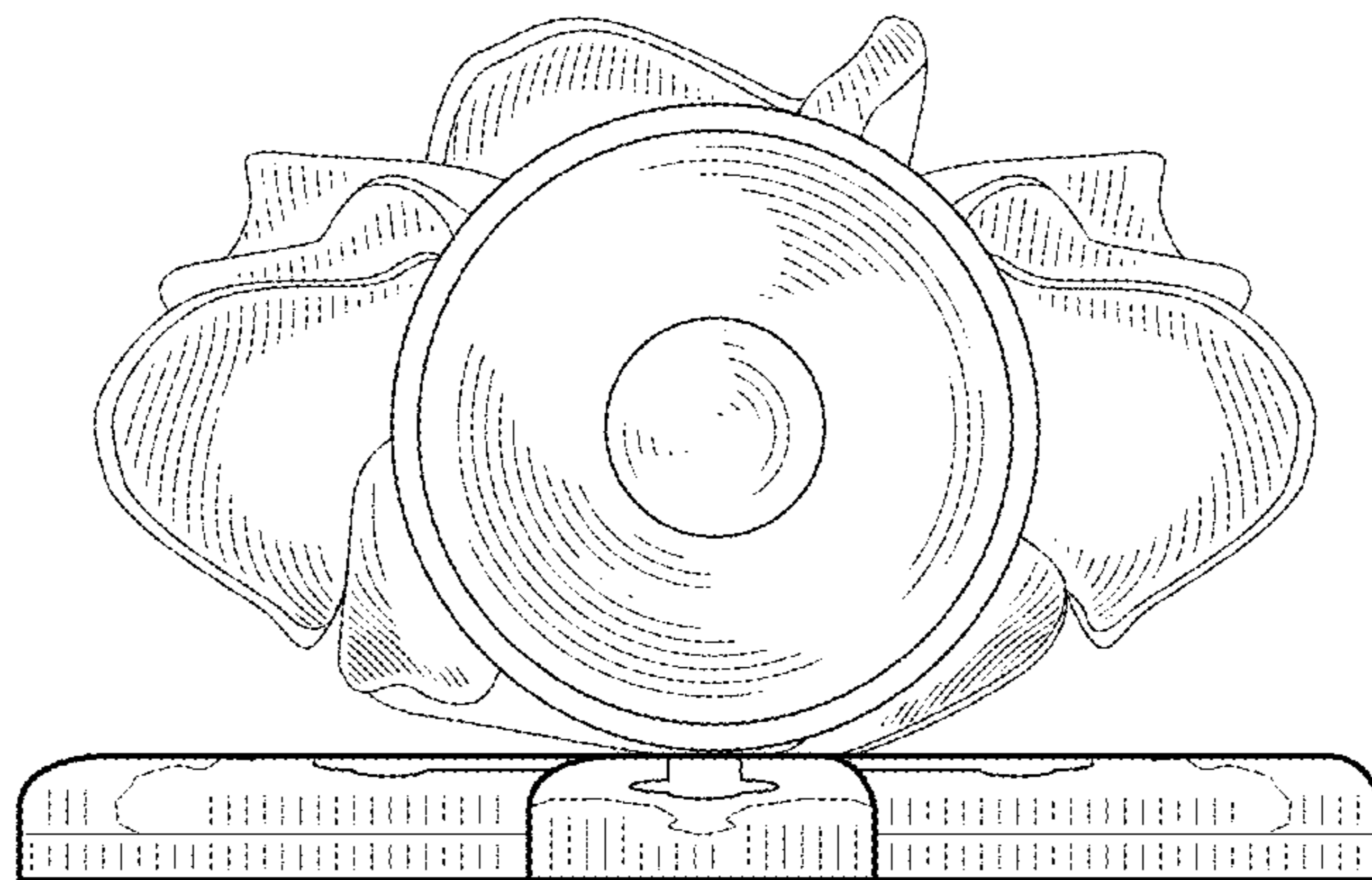
