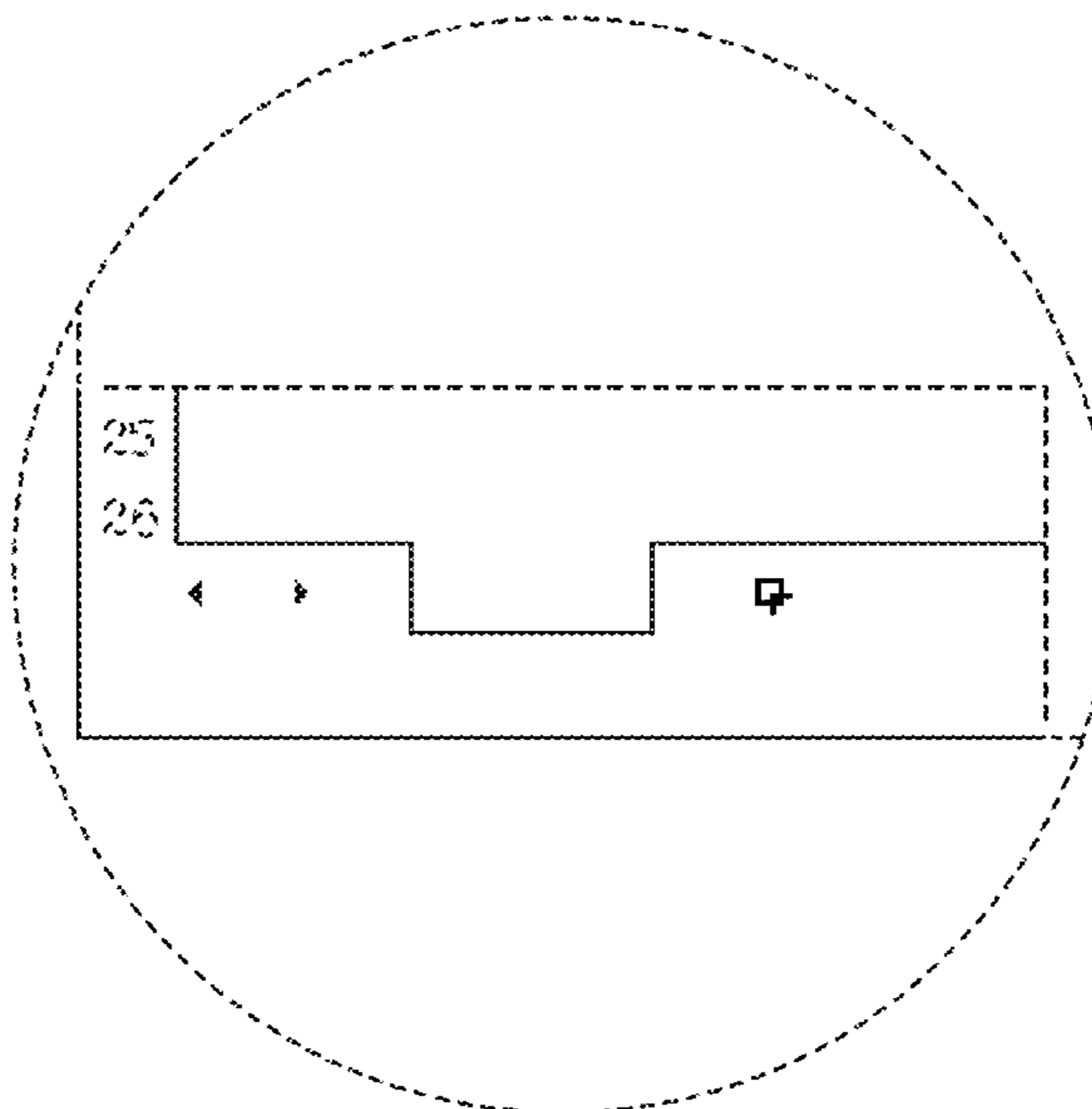
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing our new design; and
FIG. 2 is a front view of a display screen with graphical user interface of FIG. 1 with a region for enlargement; and,
FIG. 3 is an enlarged view of the region on FIG. 2 which is circumscribed by broken line and identified as FIG. 3.
The broken line showing of the alphanumeric characters, the remainder of the graphical user interface, and display screen is for environmental purposes only and forms no part of the claimed design.

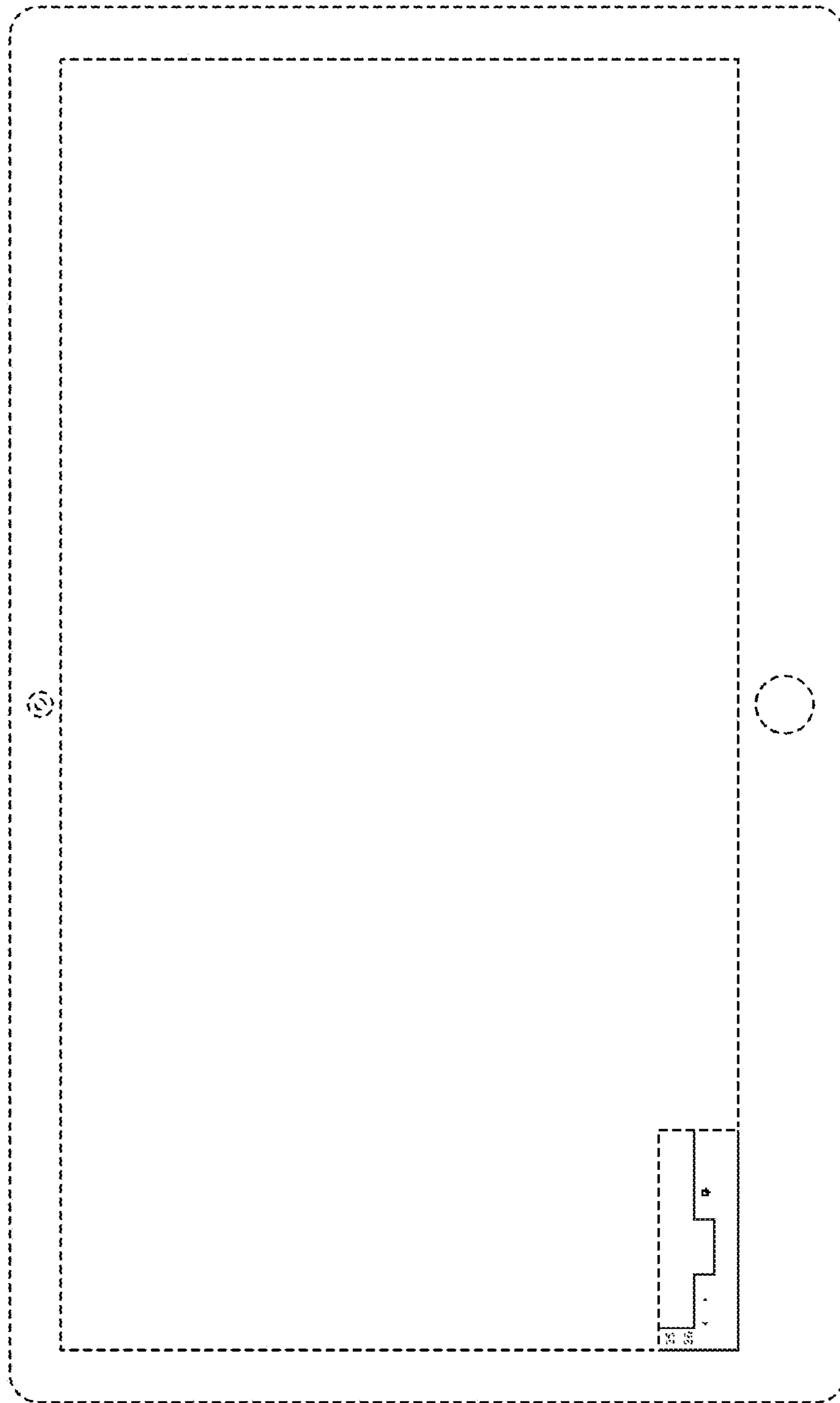

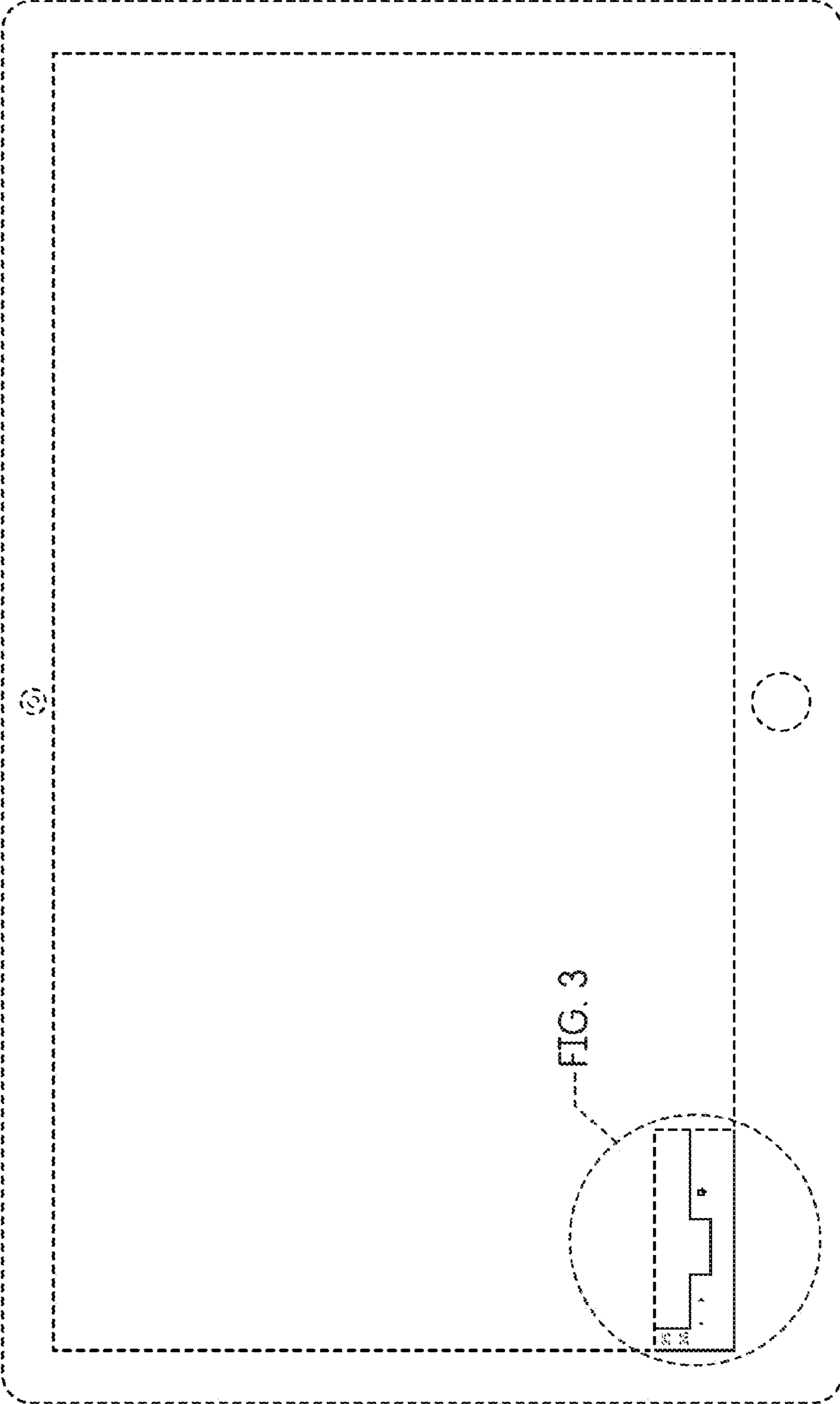

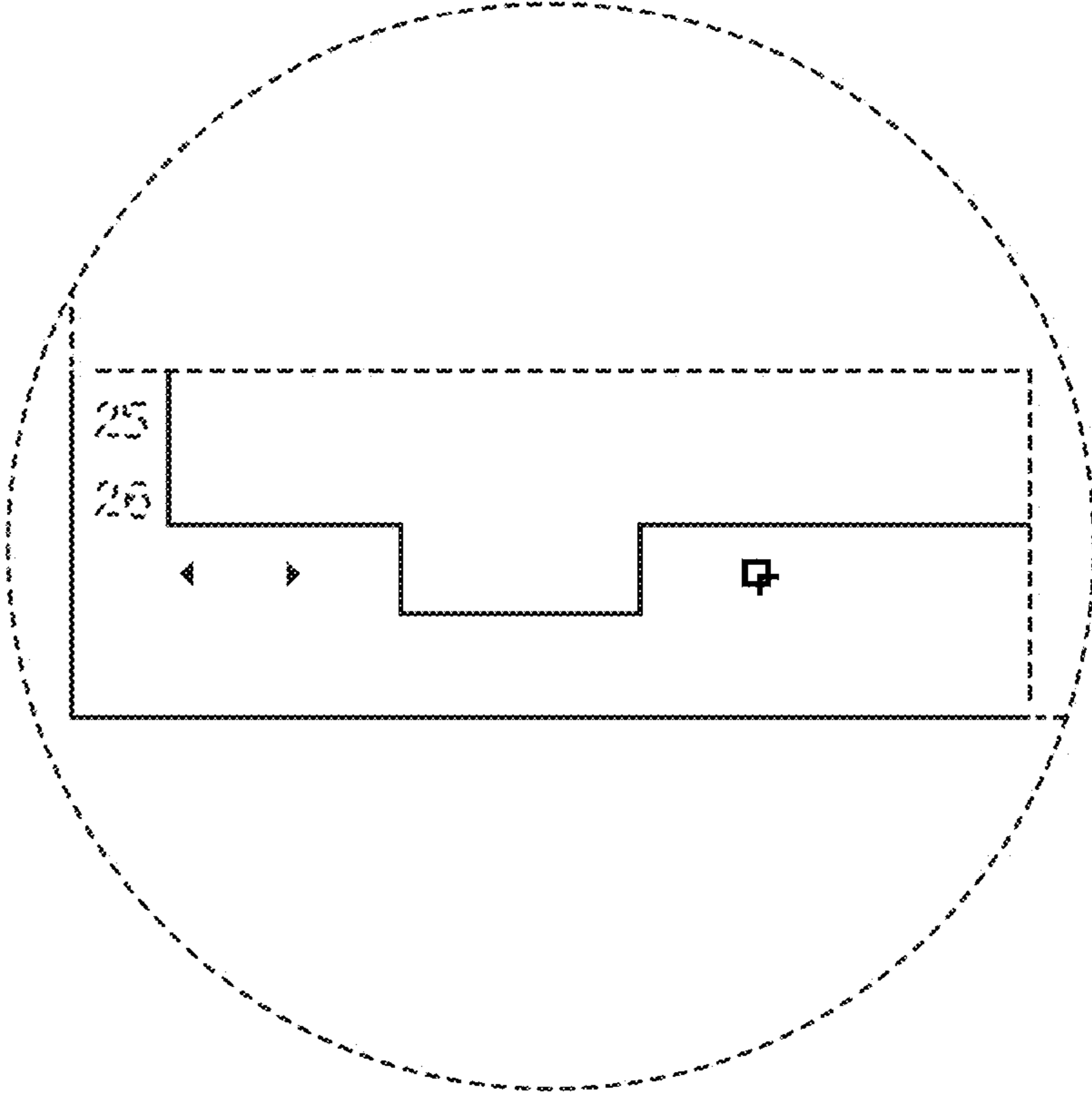
