I claim the ornamental design for a soccer vuvuzela maraca, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a soccer vuvuzela maraca, showing my new design;

 FIG. 7 is a bottom plan thereof.

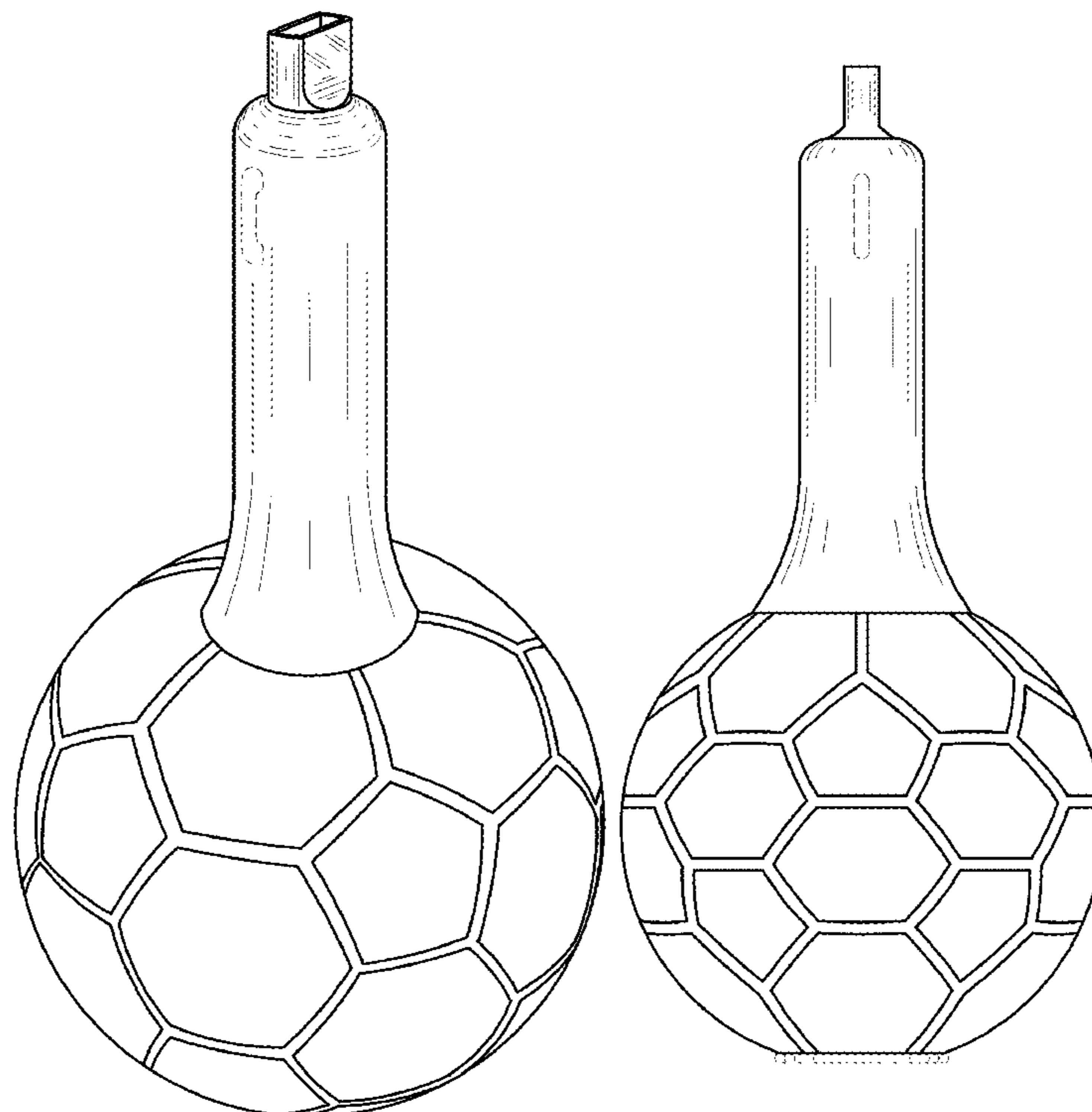

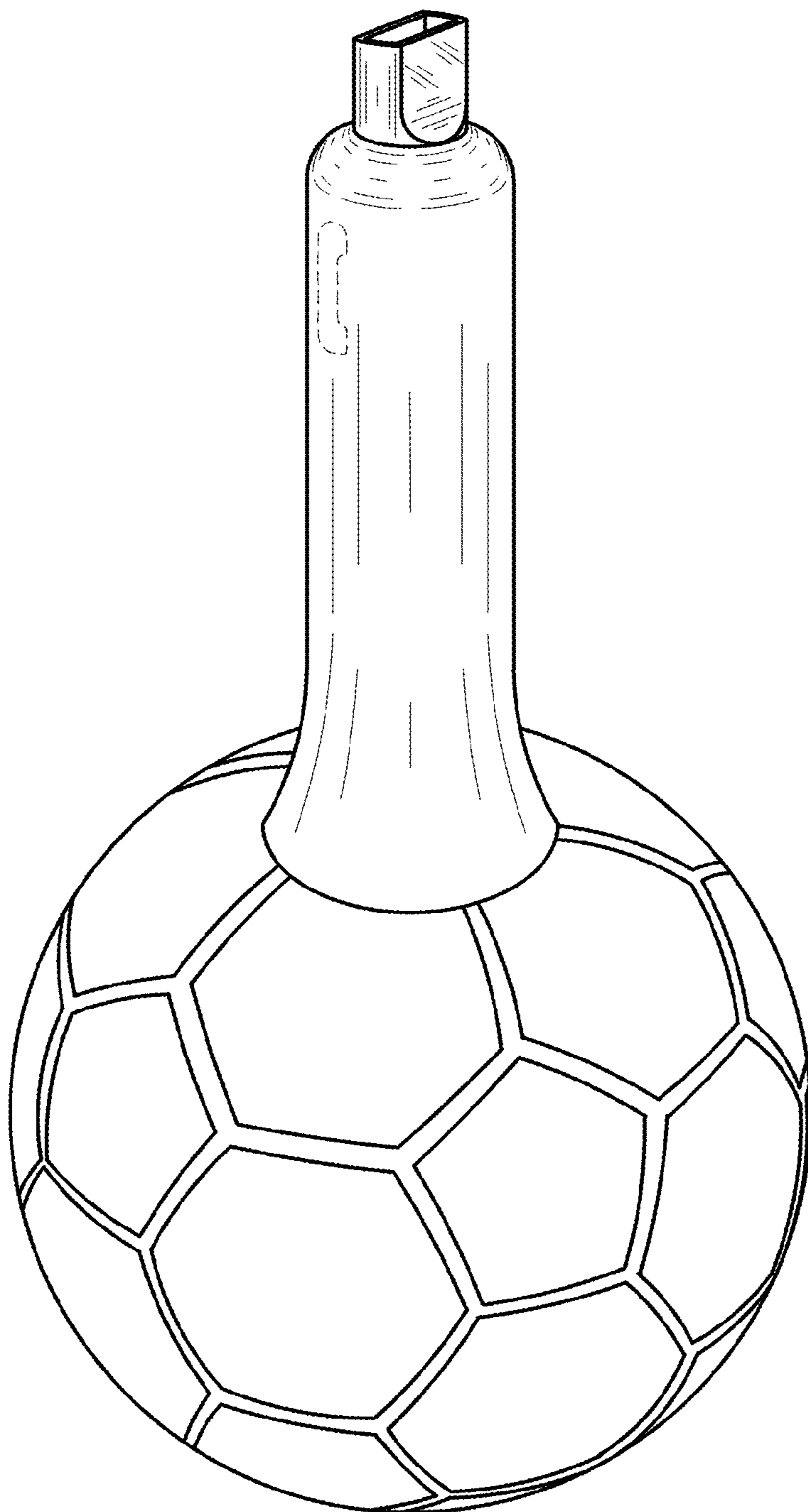

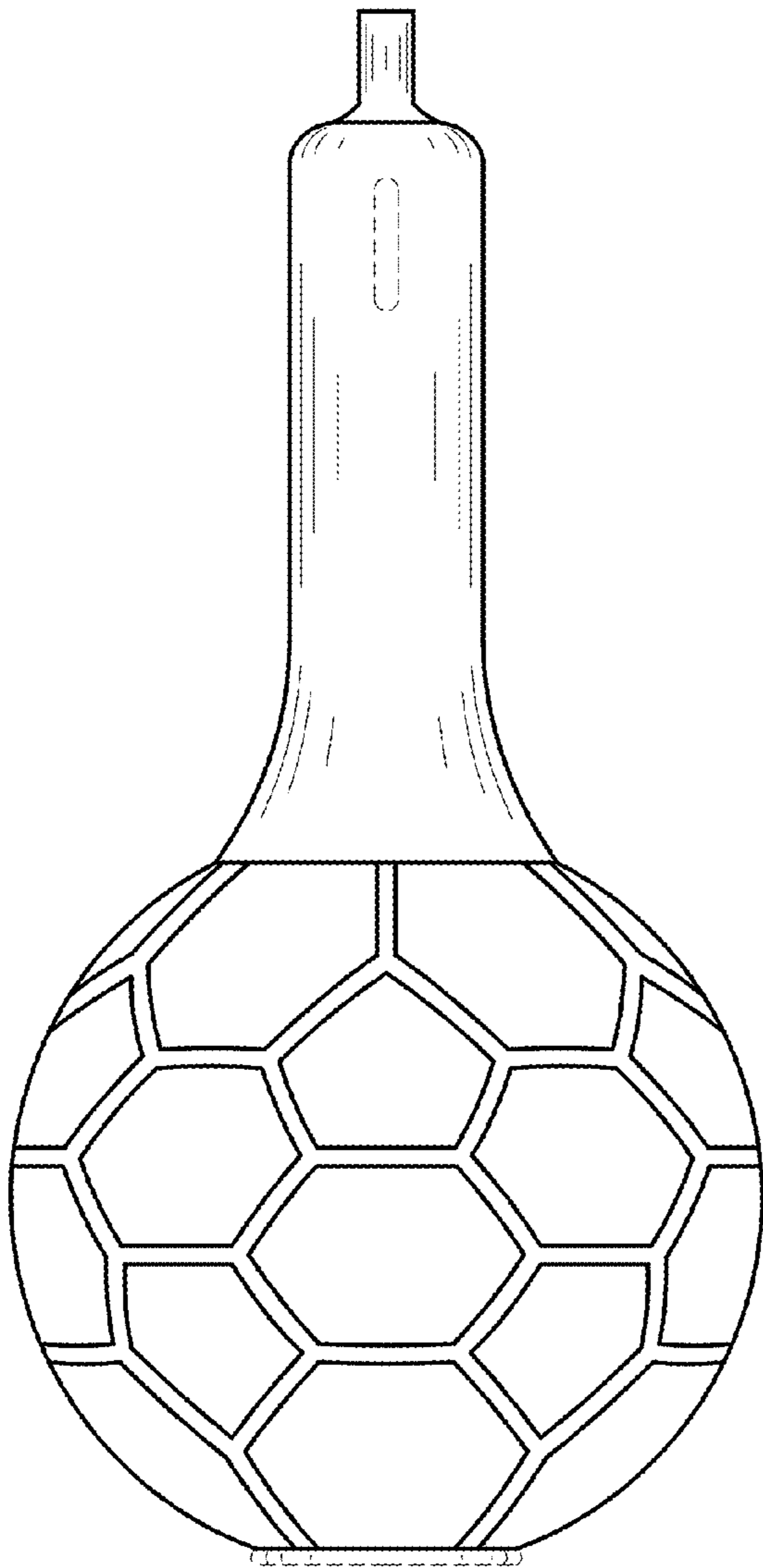

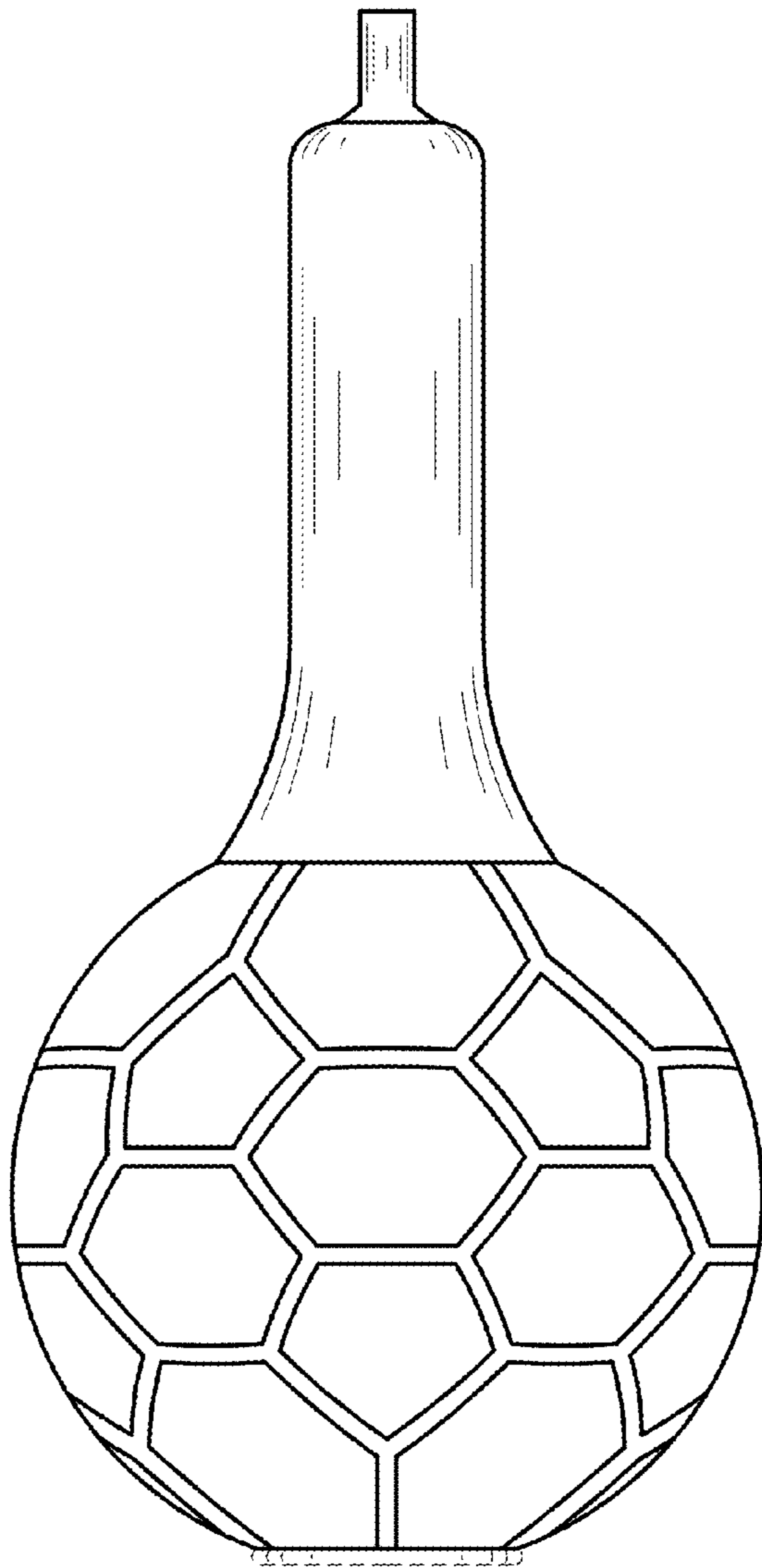

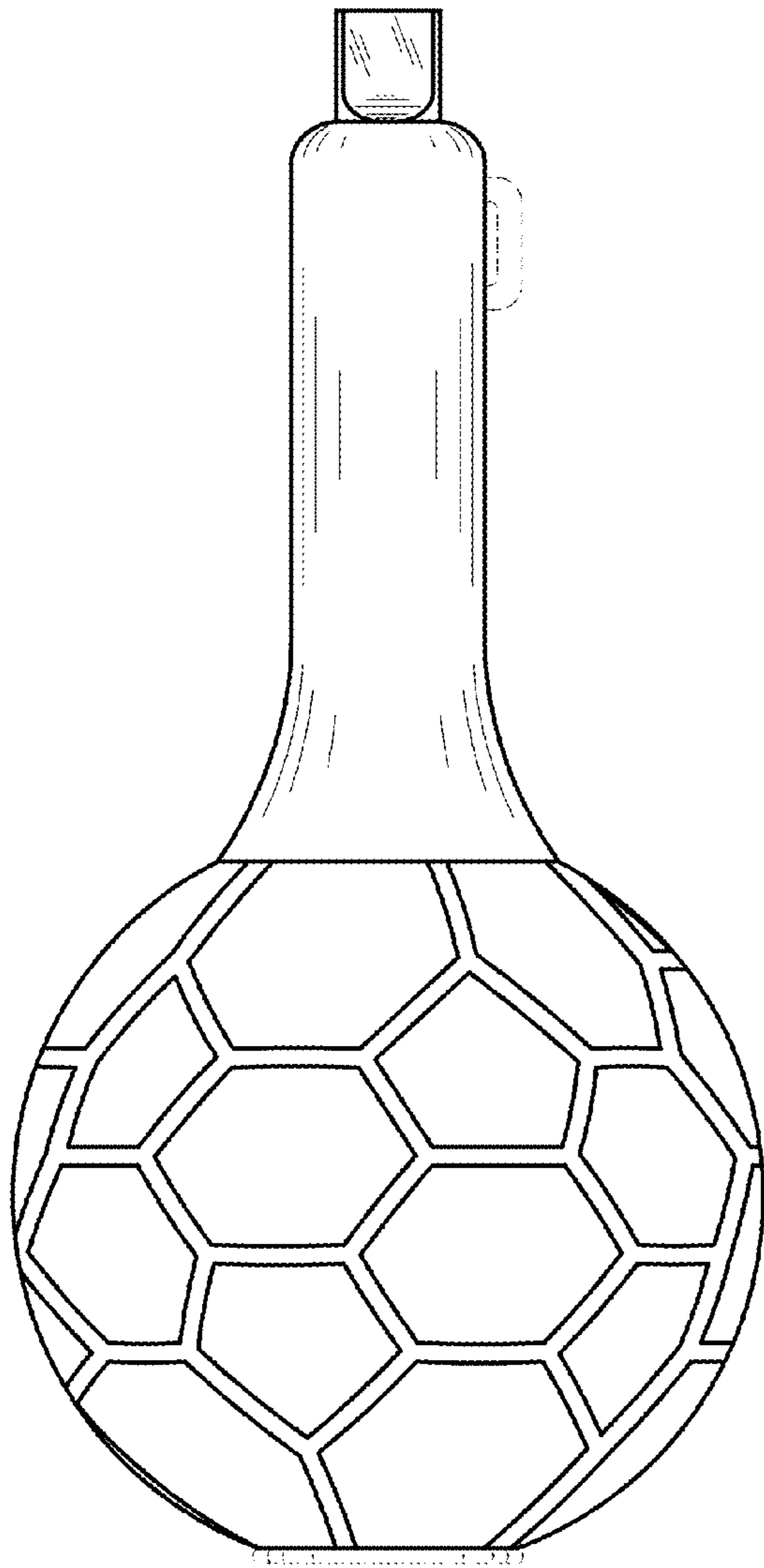

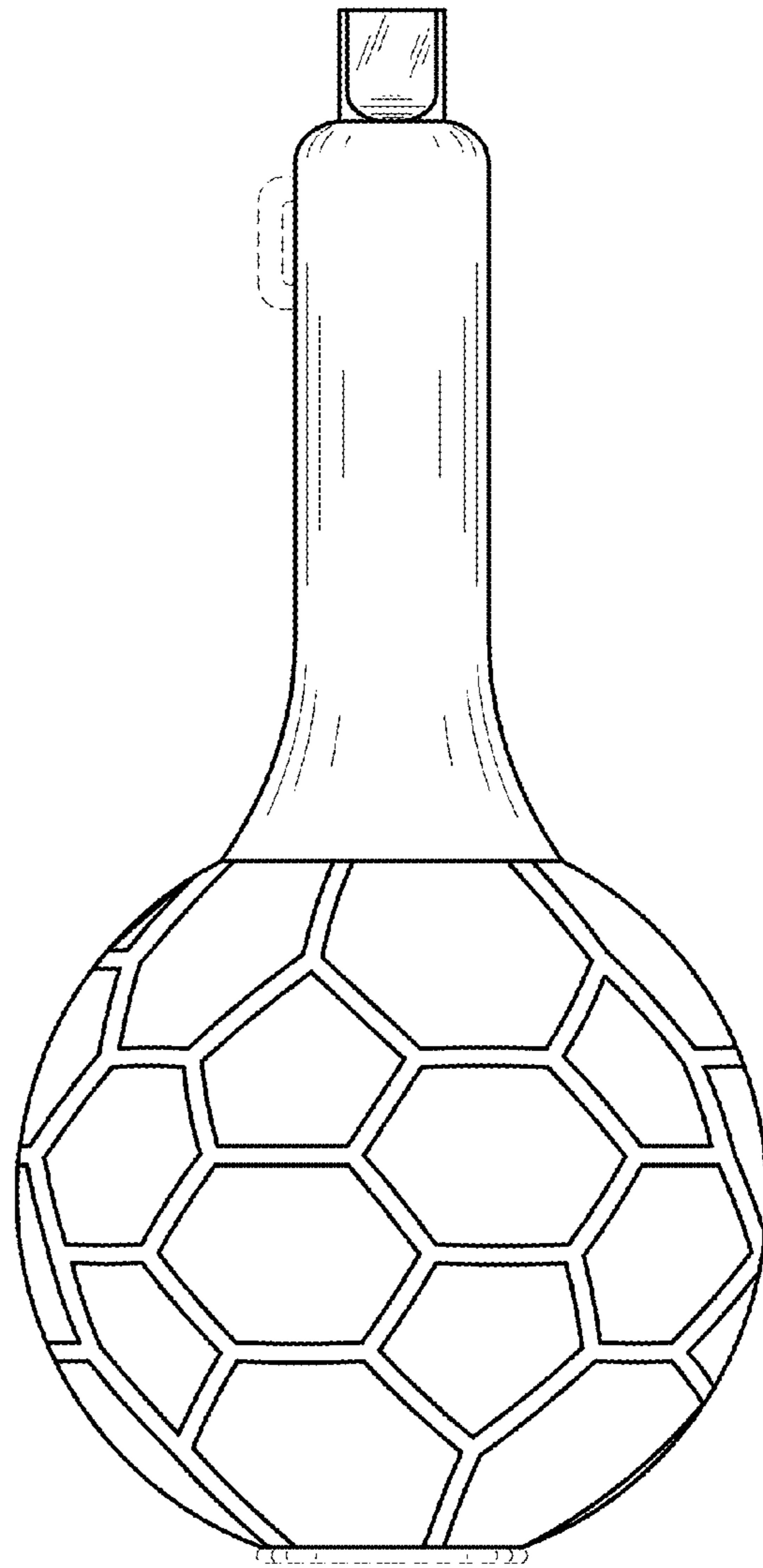

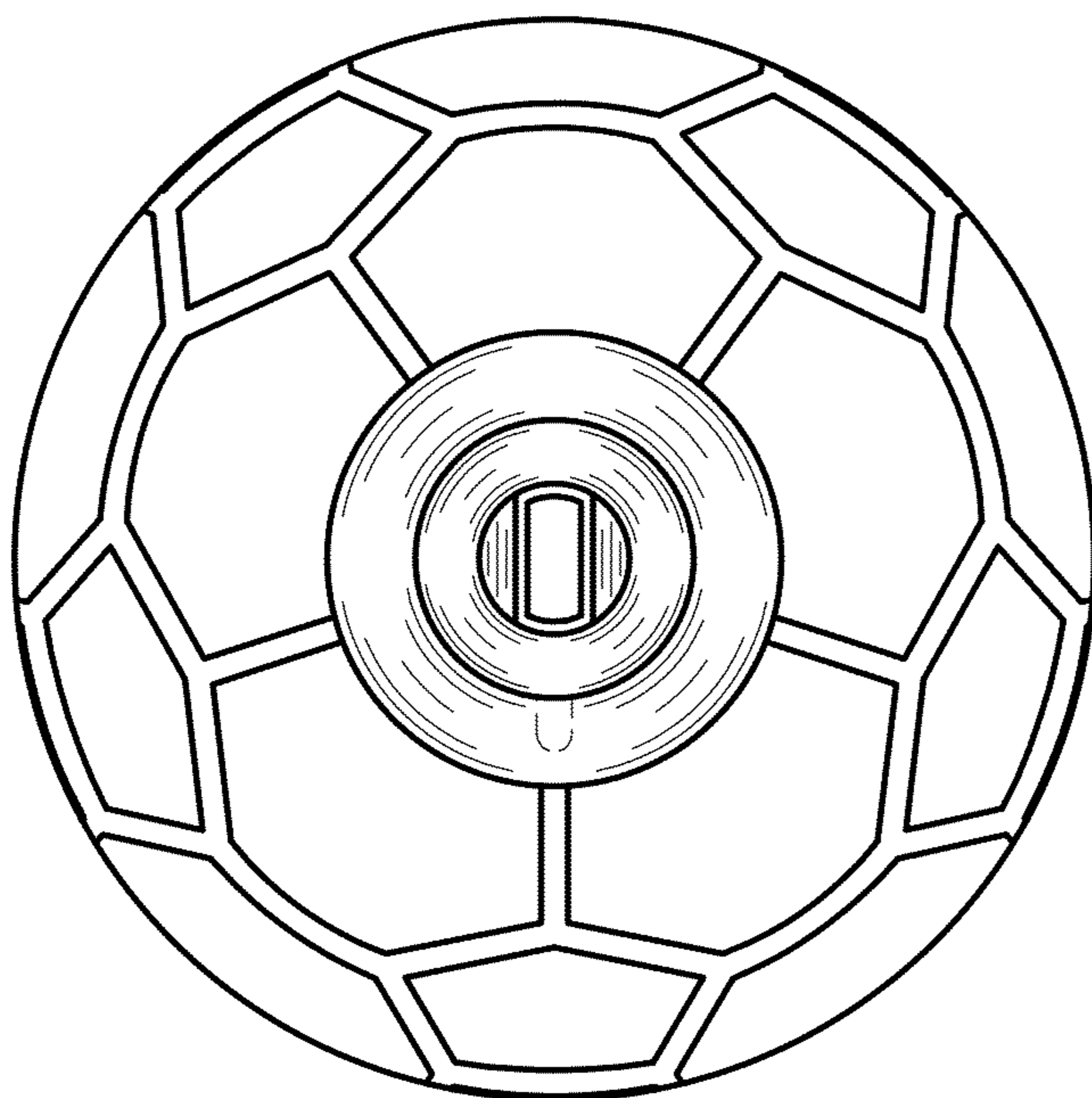

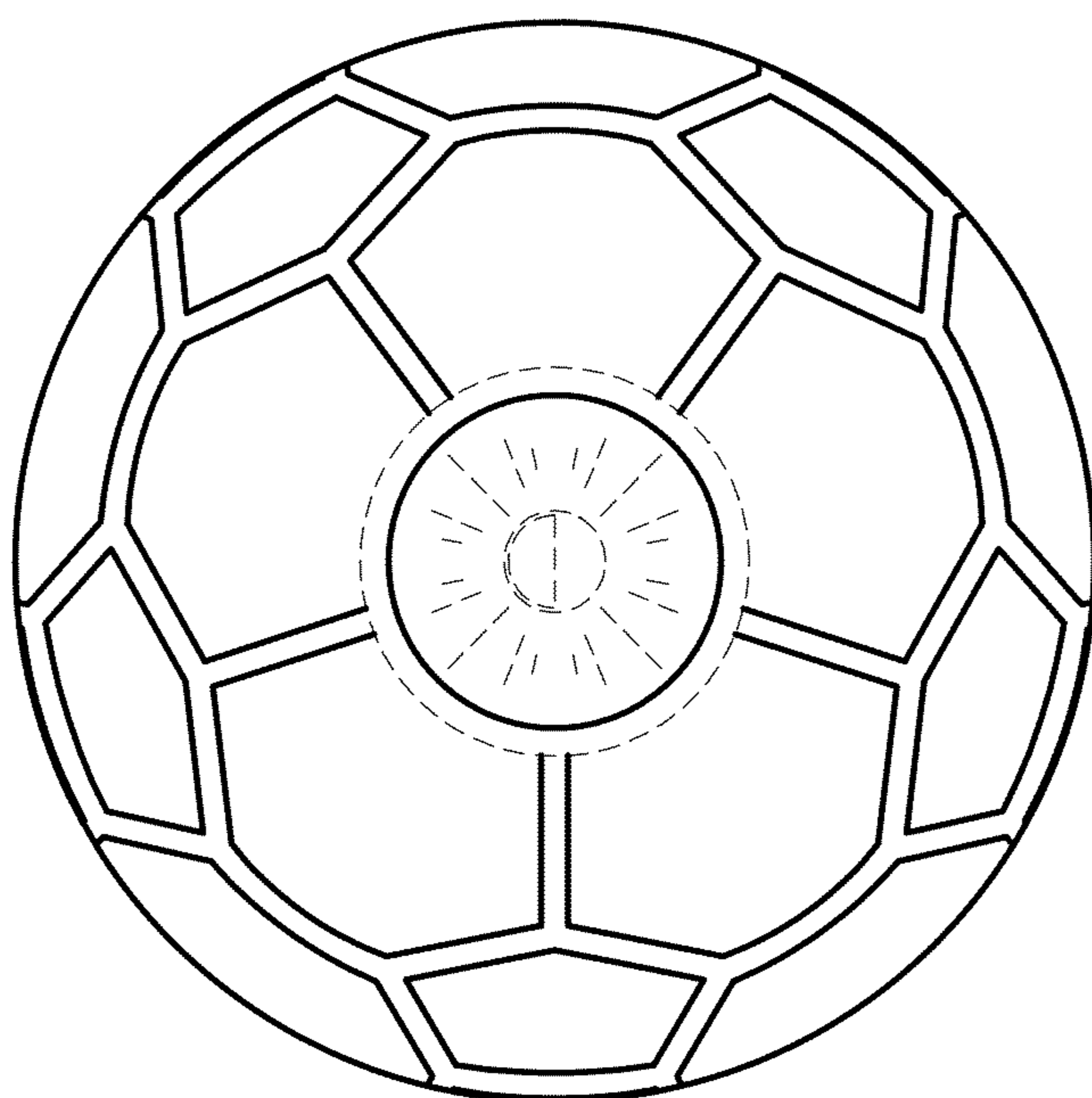
