FIG. 1 is a perspective view of the exercise device according to the new design.

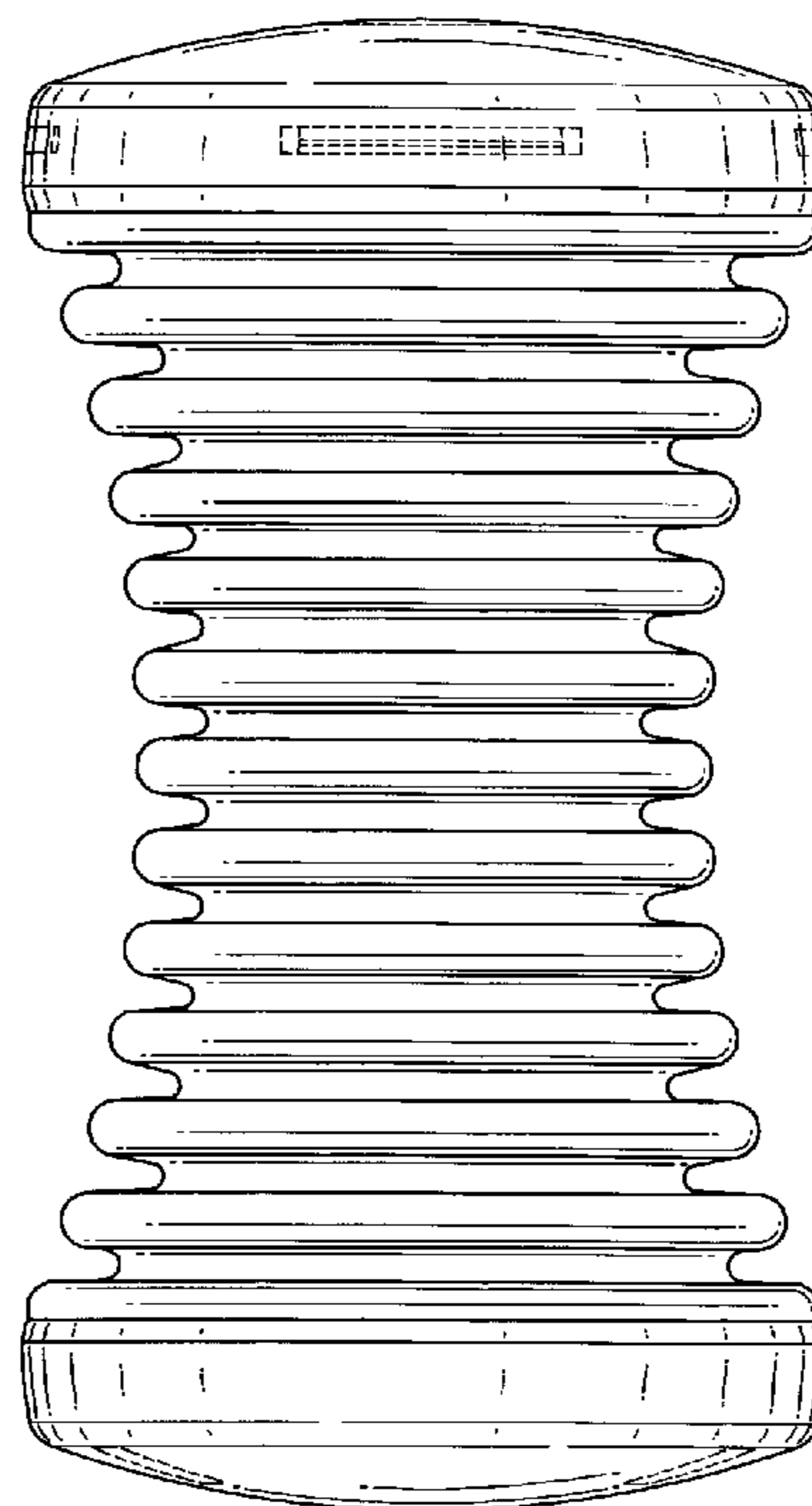
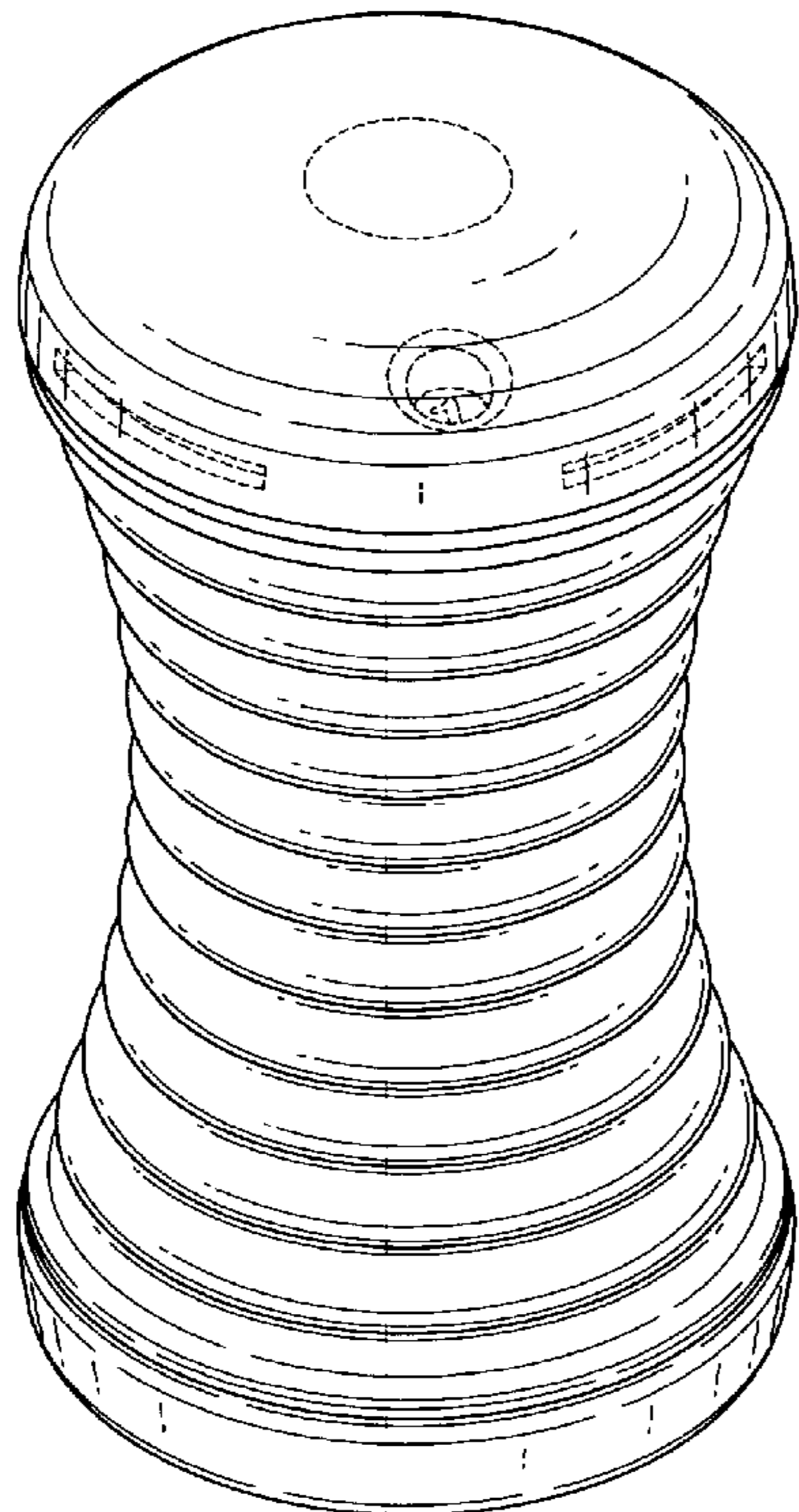
FIG. 2 is a front view thereof.

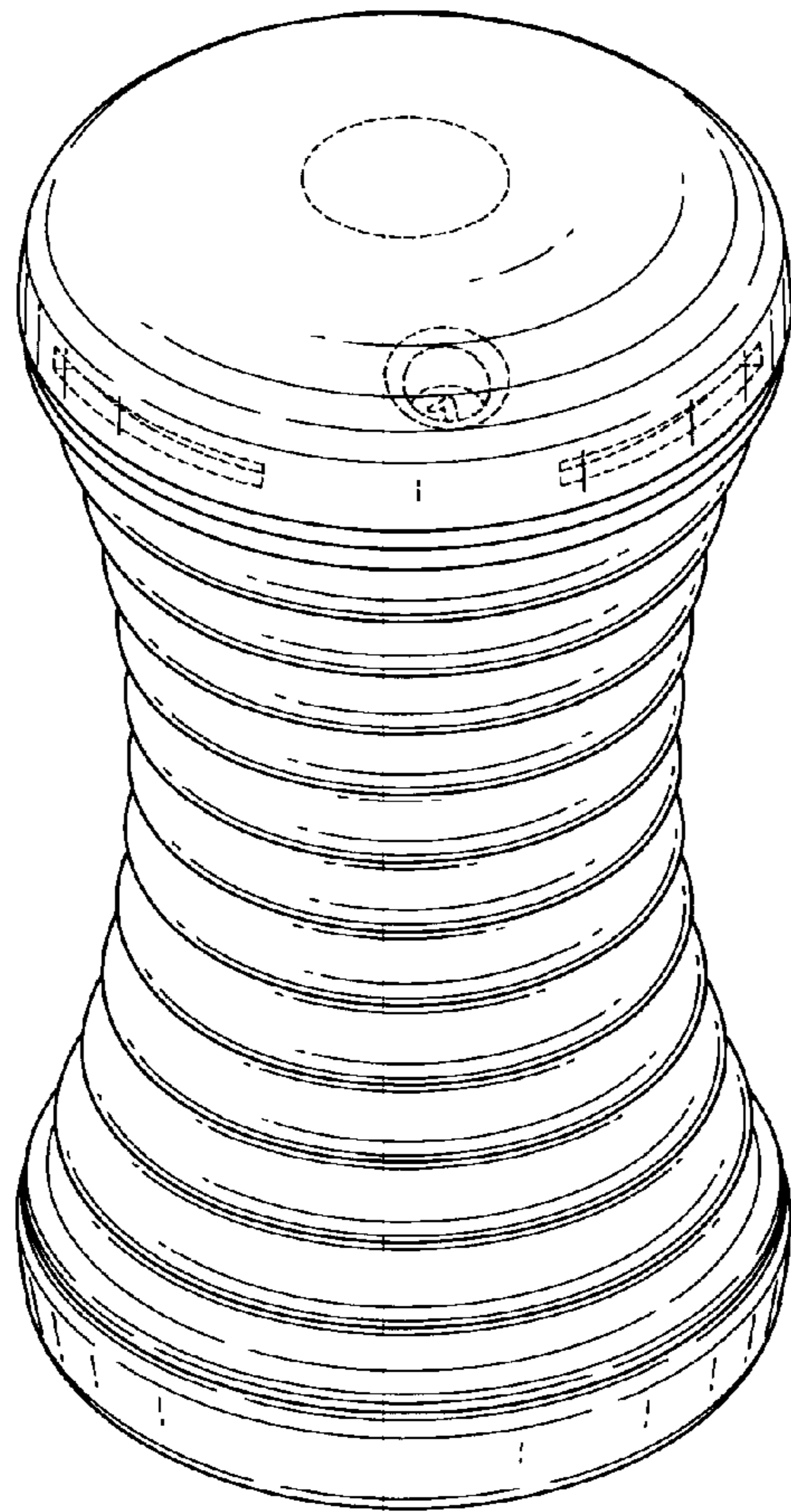

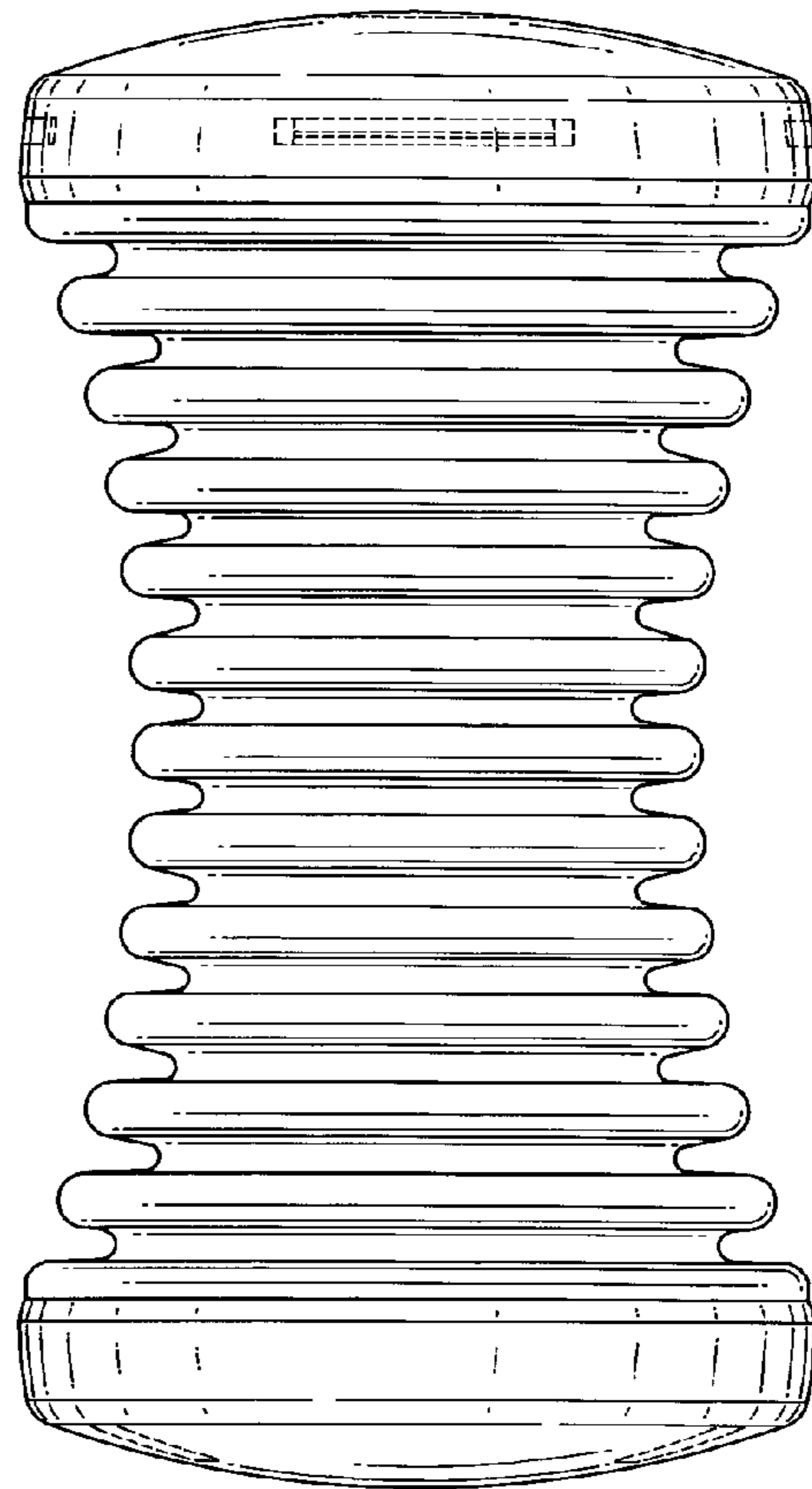

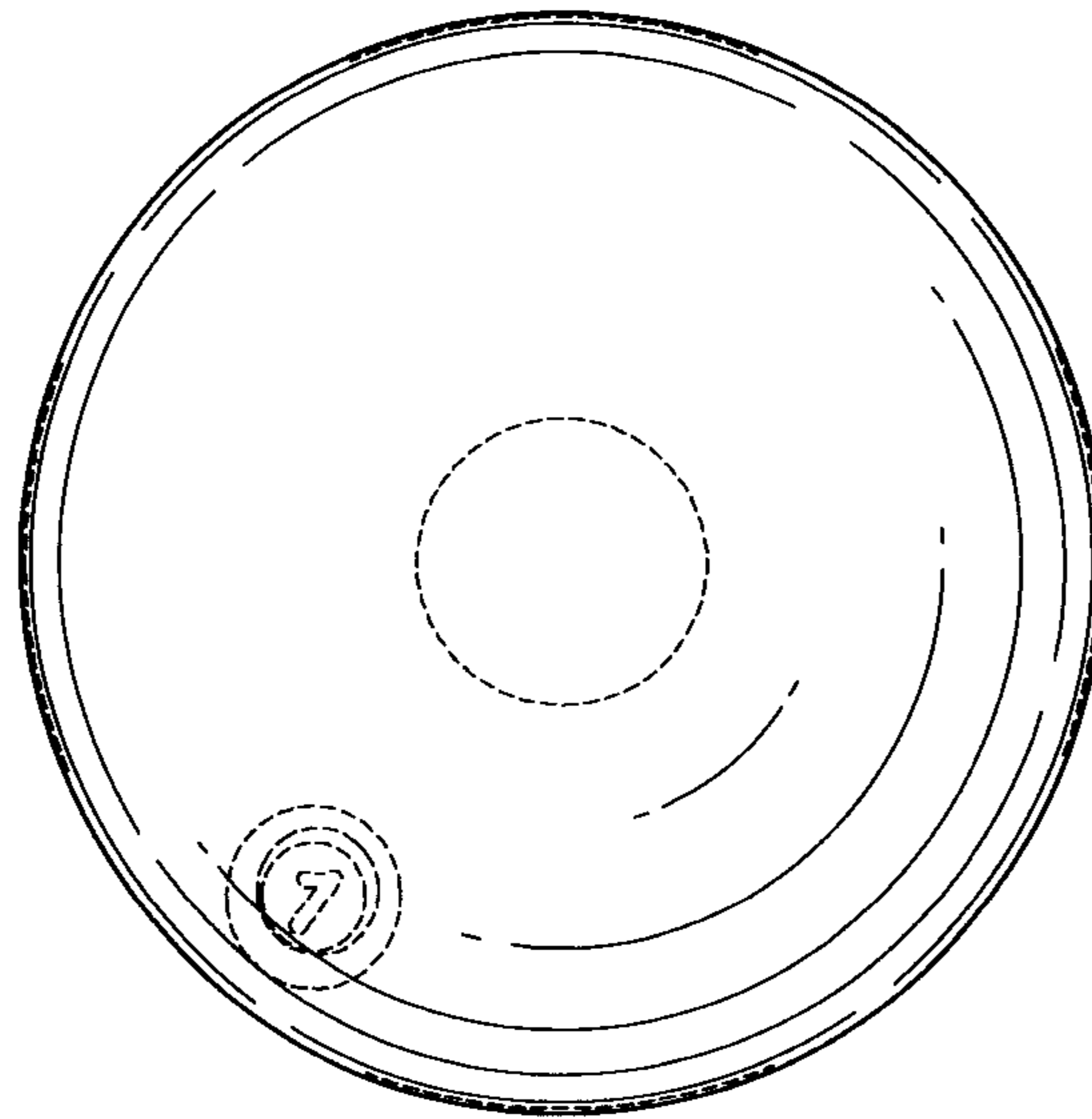

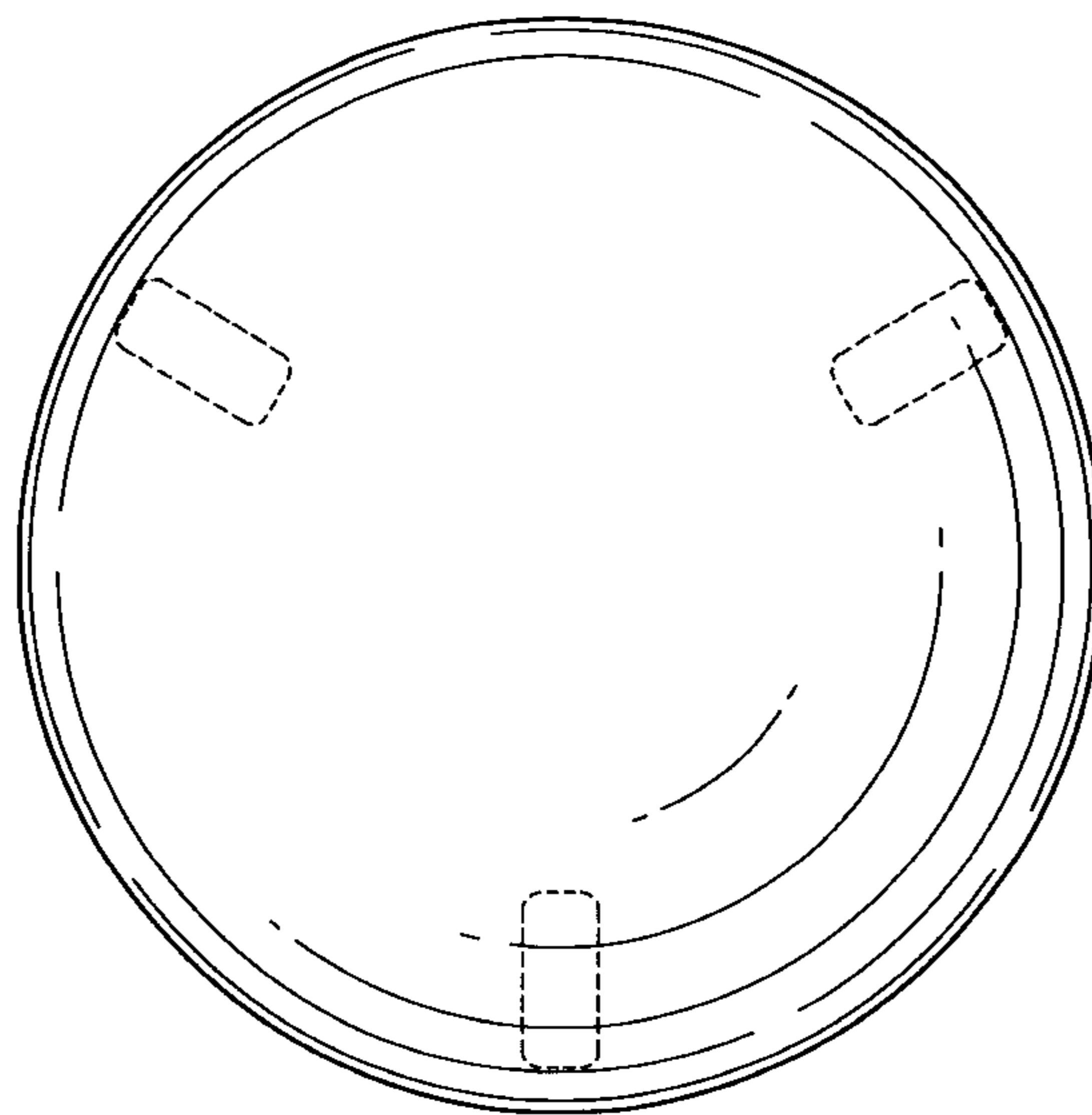
