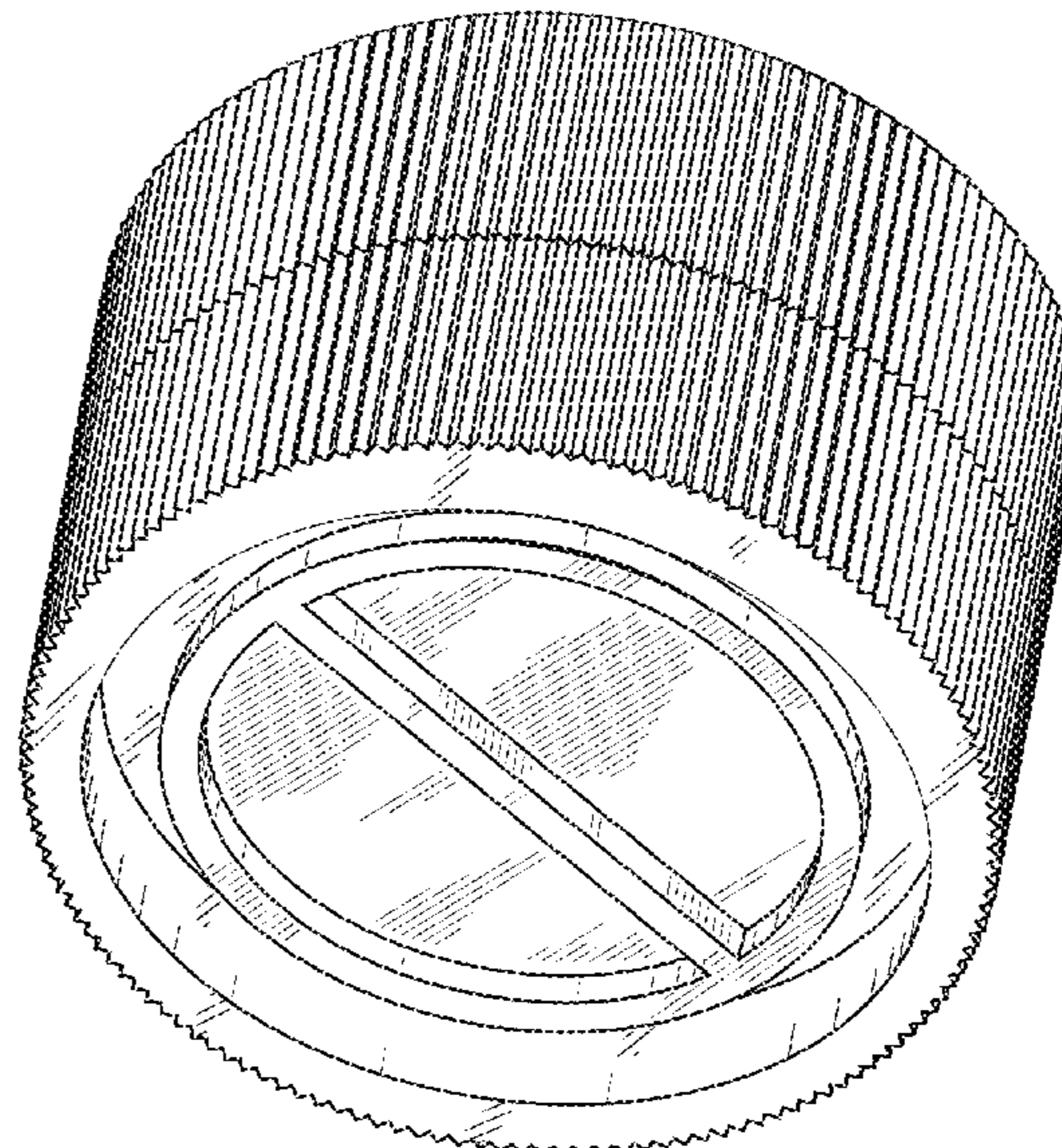
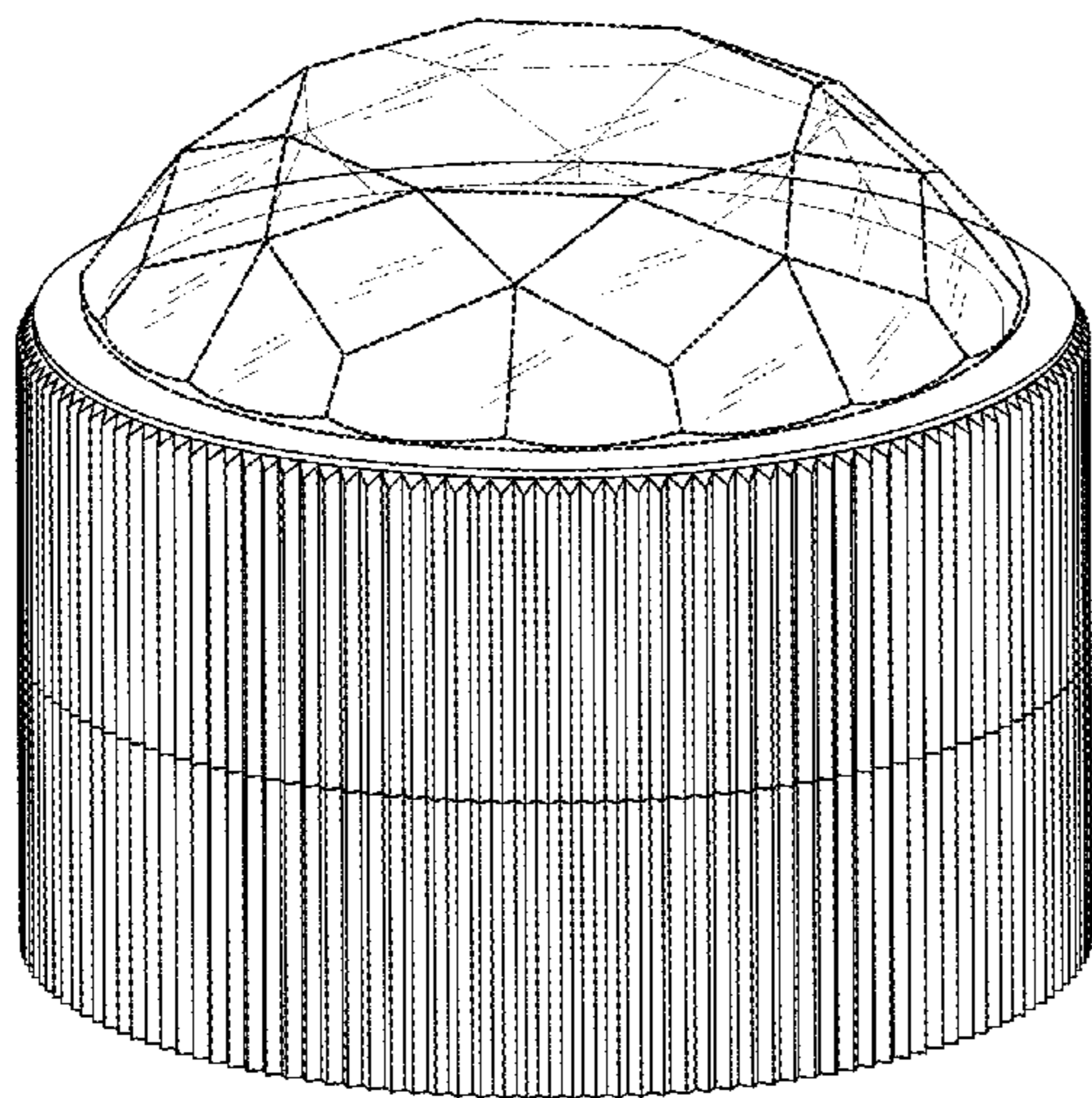
(57) **CLAIM**

I claim the ornamental design for a waterproof lamp, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a waterproof lamp, showing my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a front elevational view thereof, the rear elevational view, left-side elevational view, and right-side elevational view all being identical thereto;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

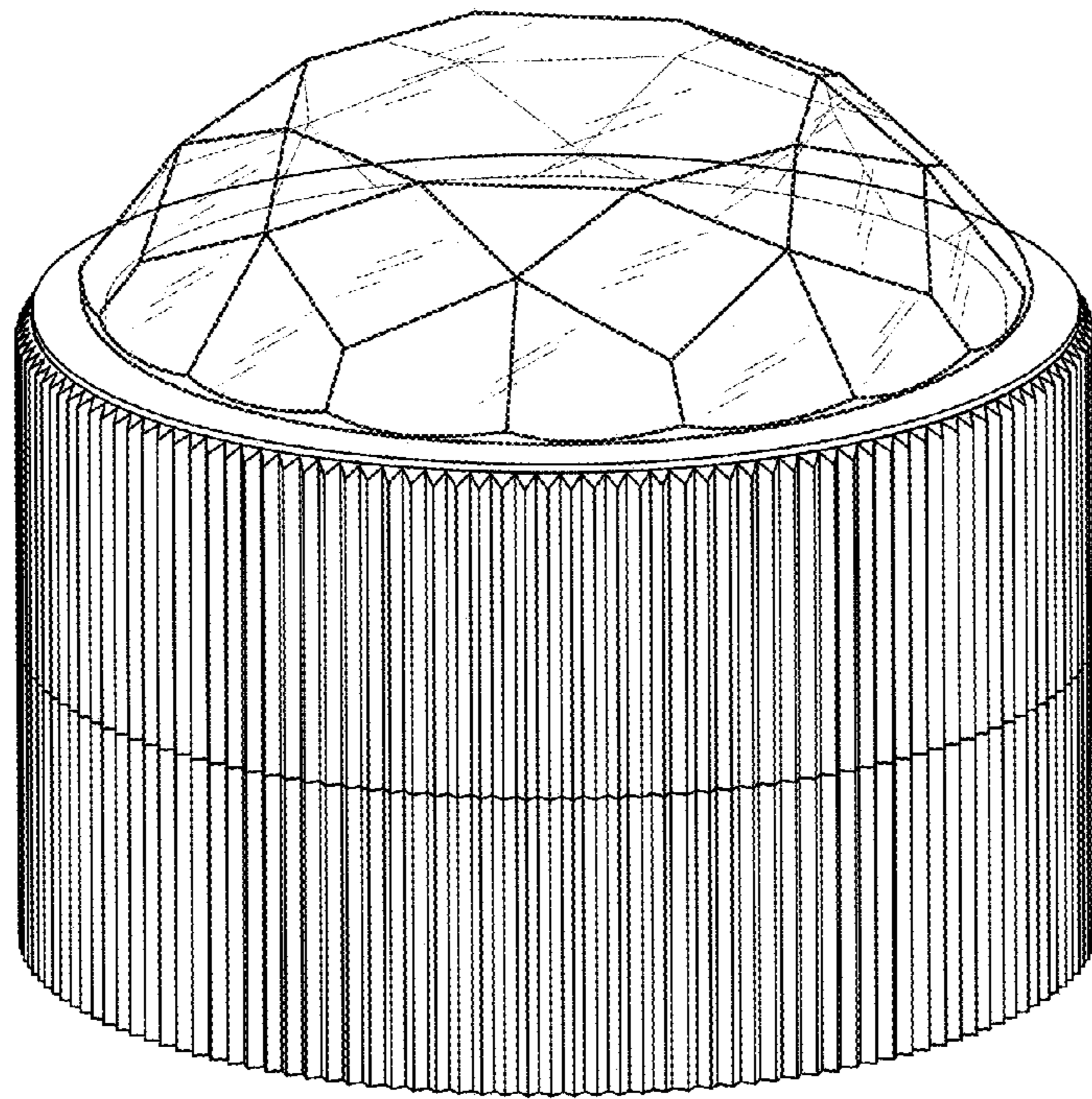

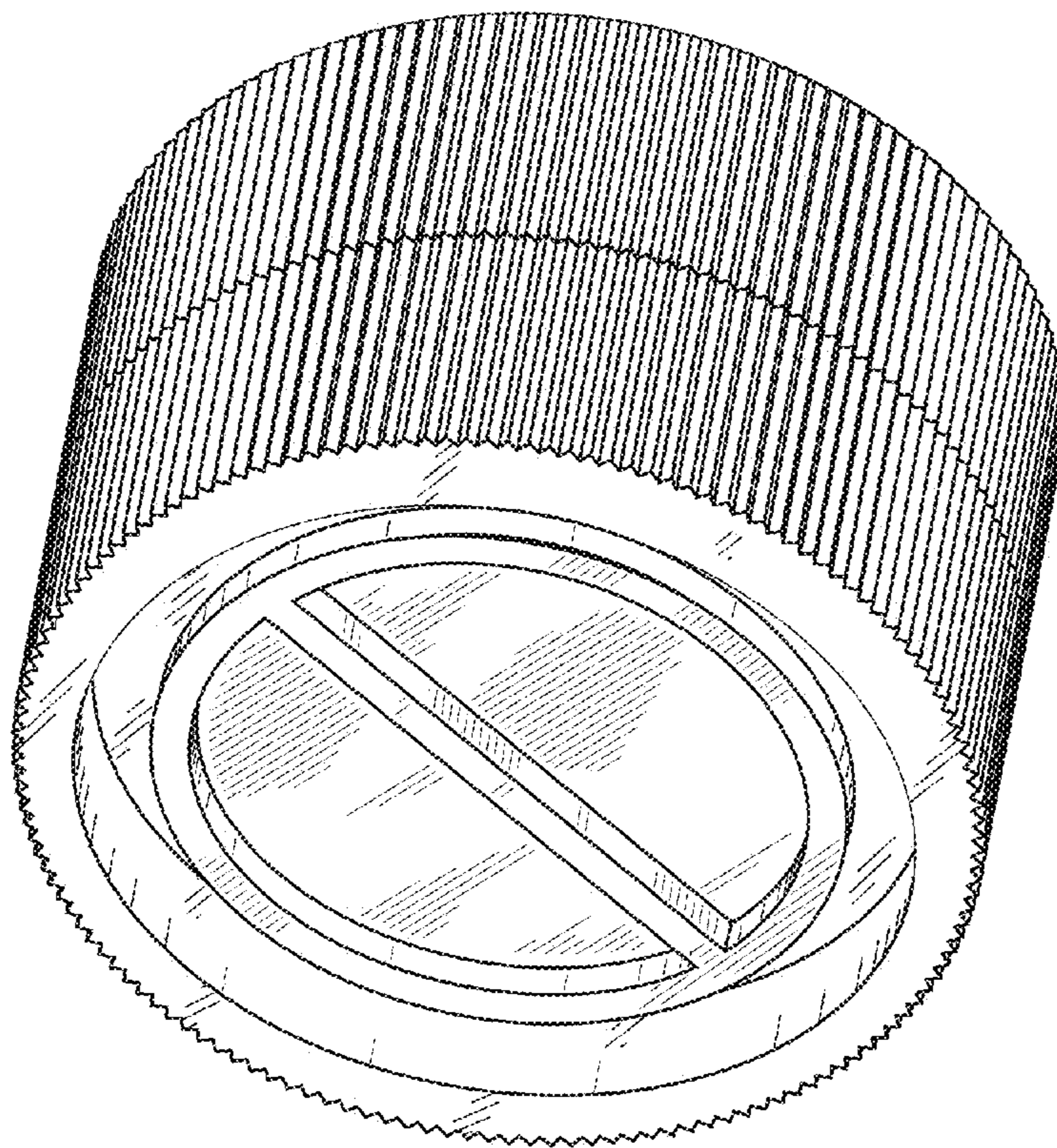

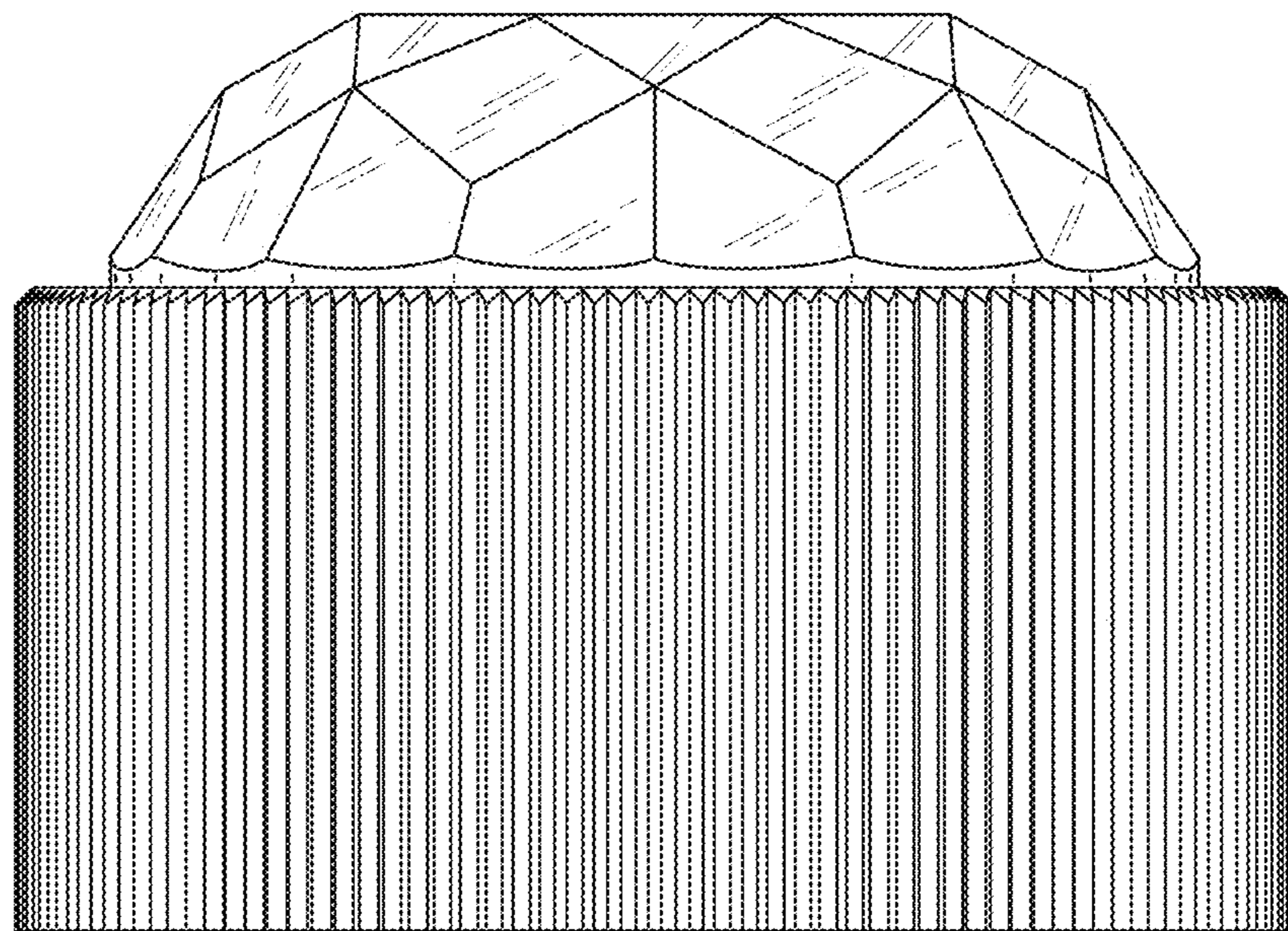

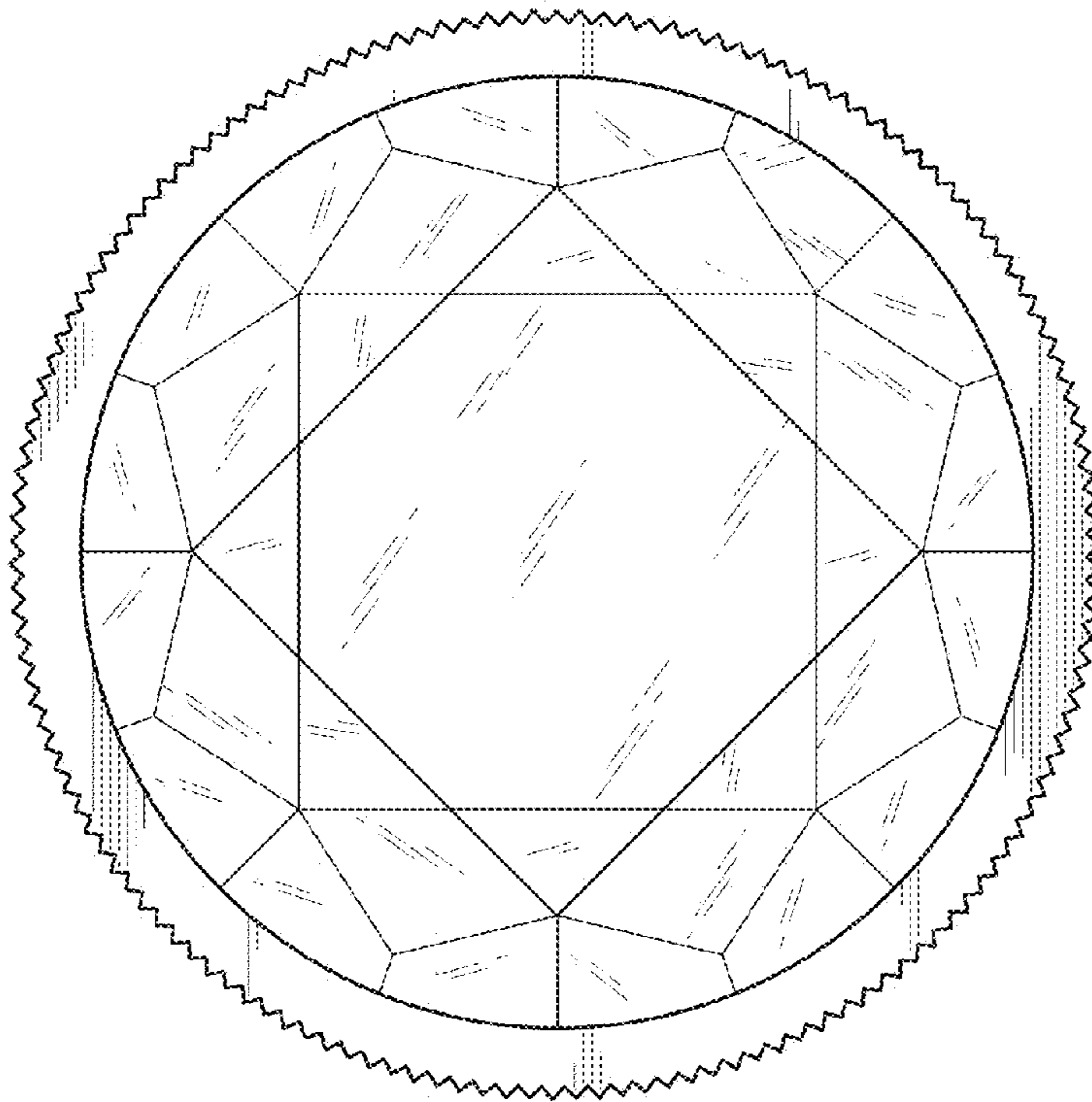

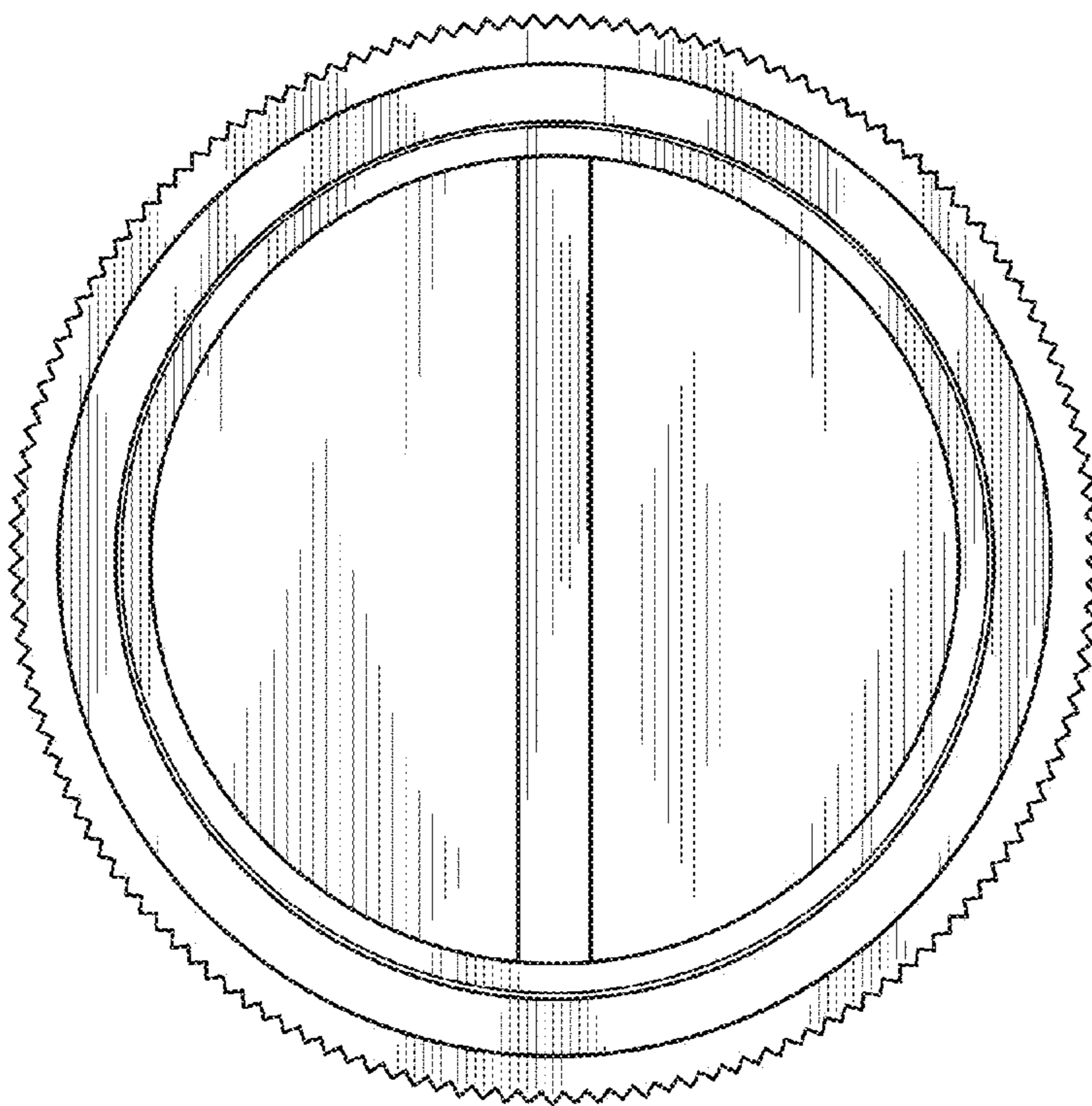
