(57) **CLAIM**

The ornamental design for a Buddha planter, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, side perspective view of a Buddha planter, according to my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a top, front perspective view thereof;
FIG. 4 is a bottom plan view thereof; and,
FIG. 5 is a front elevation view thereof, including broken lines which show plants and which form no part of the claimed design.

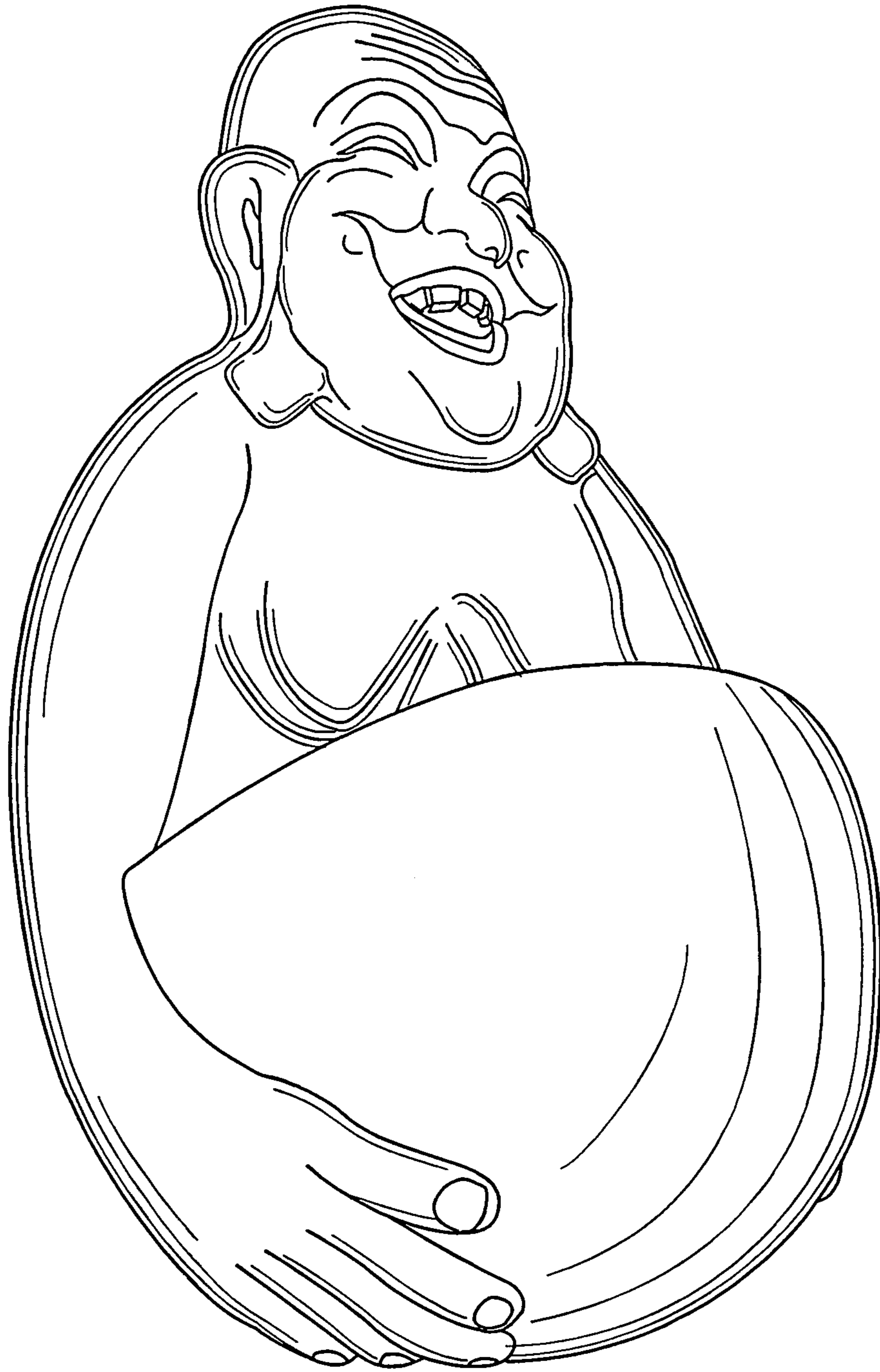

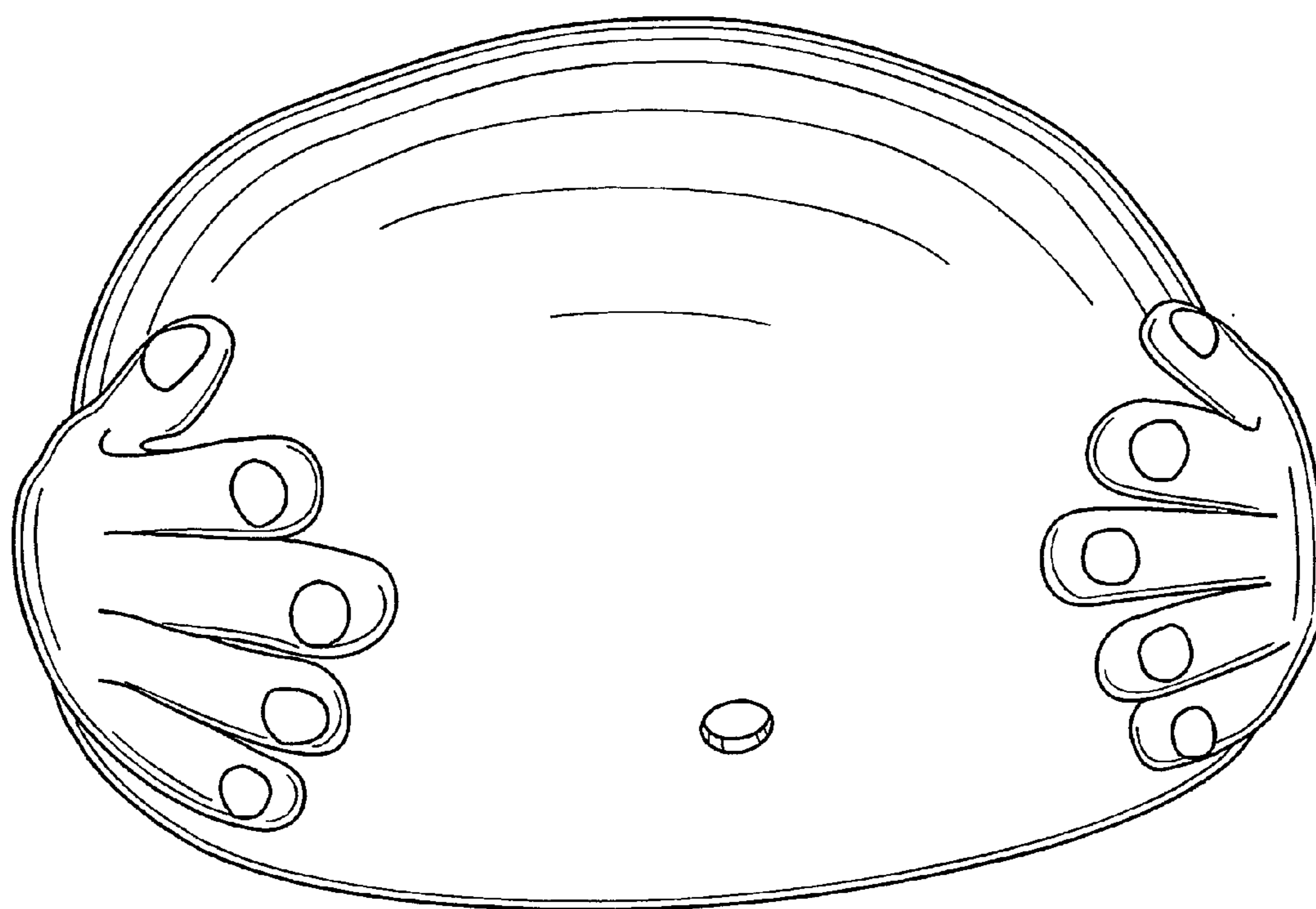
