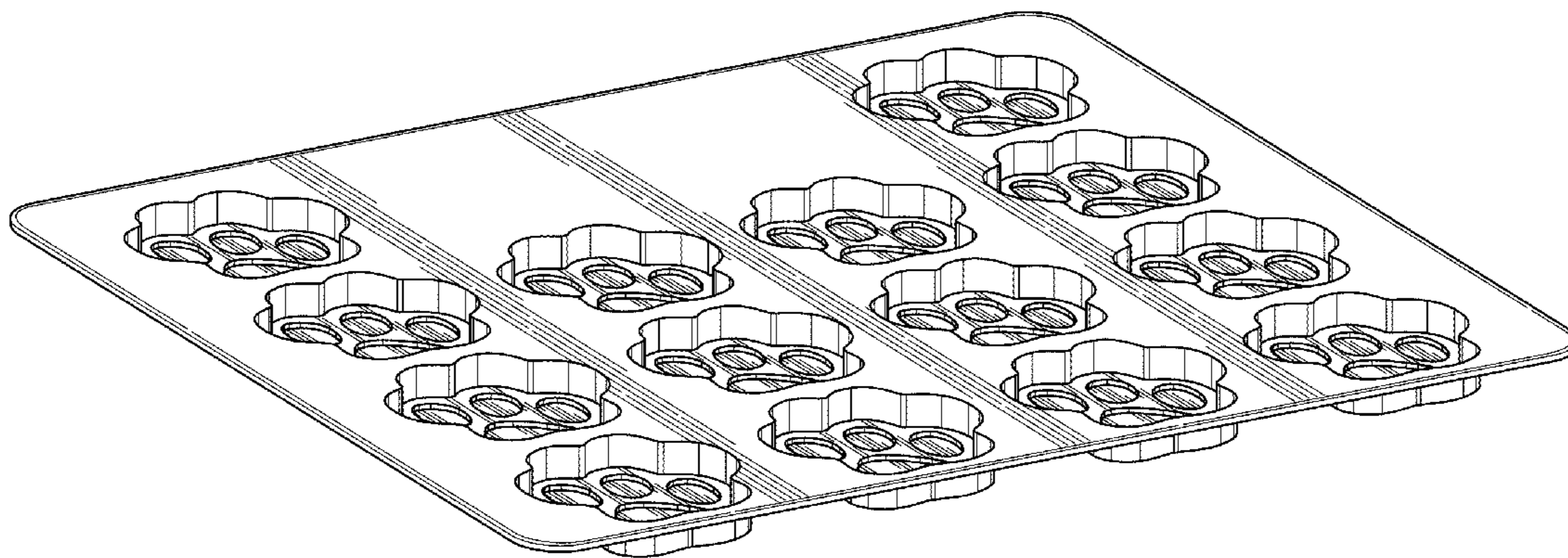
The ornamental design for a tray for making dog paw treats,

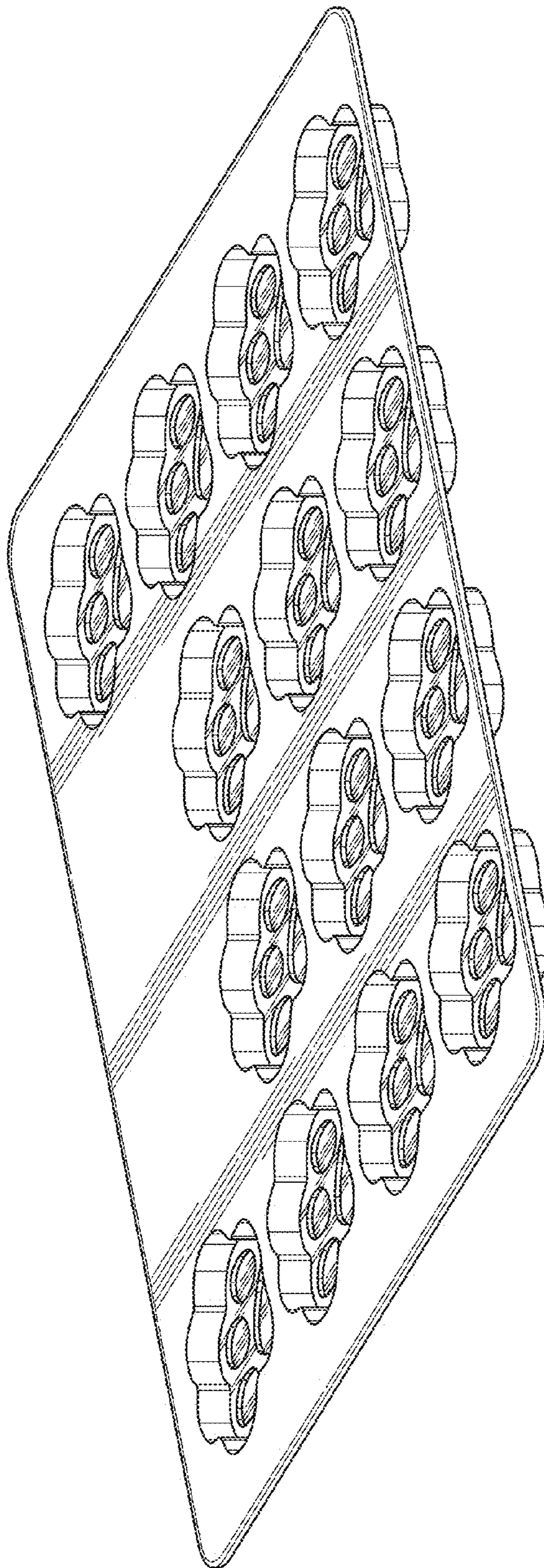

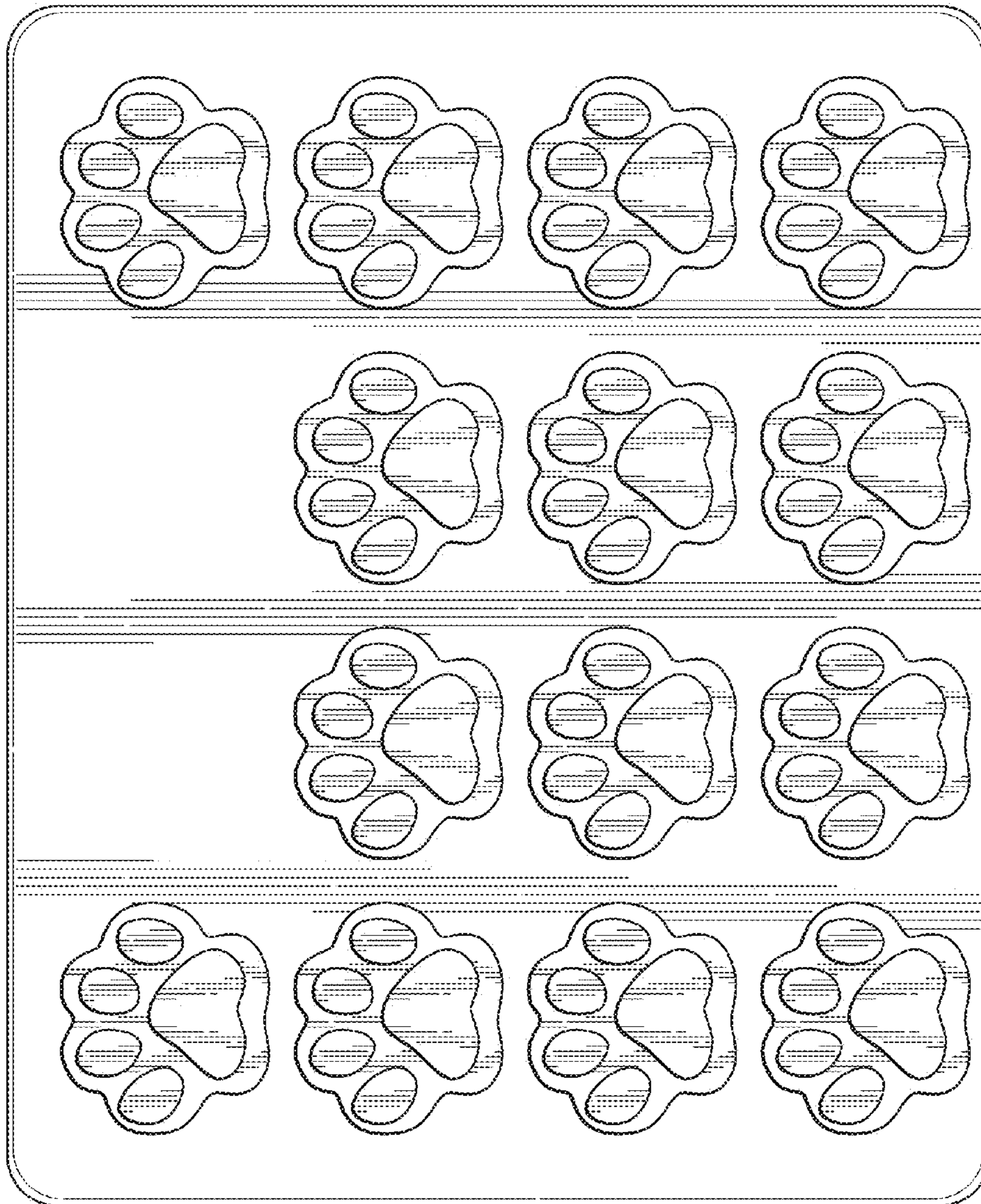

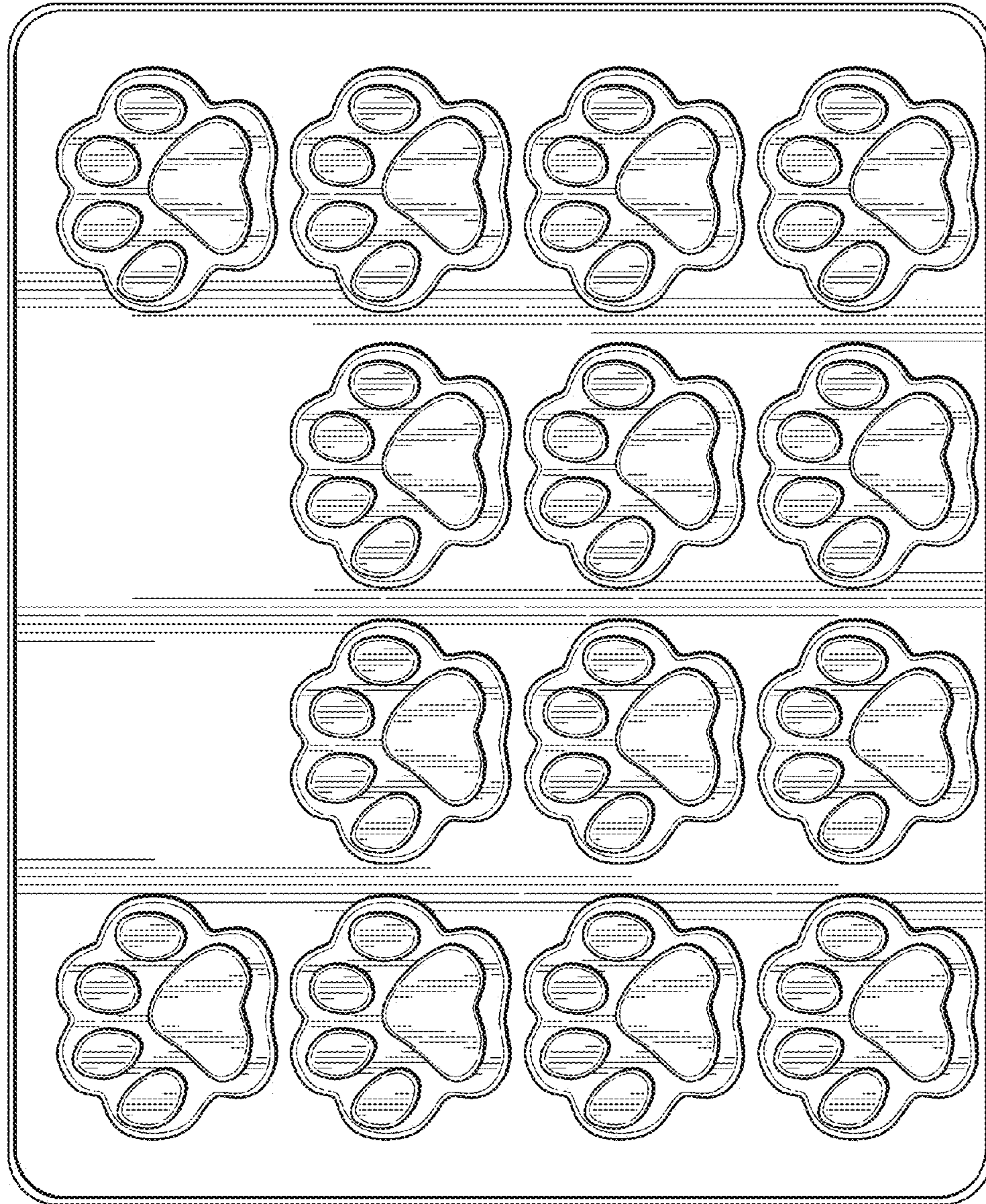

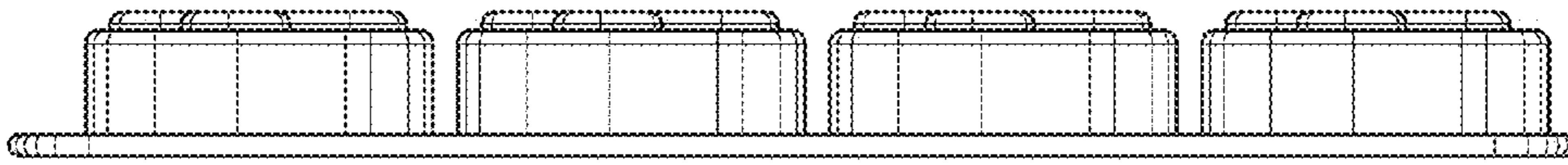

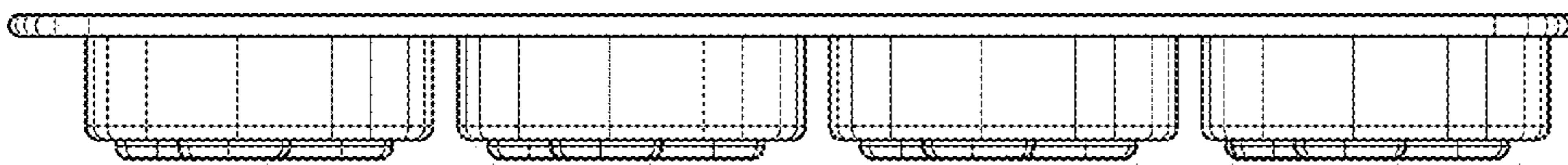

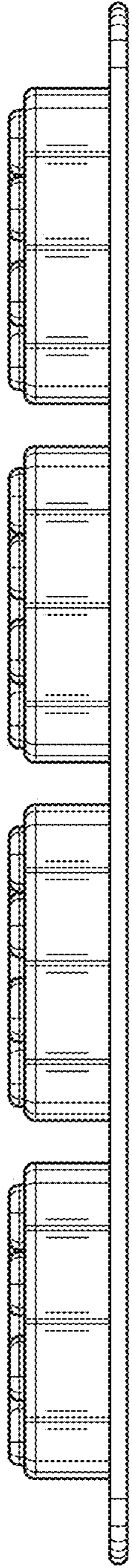

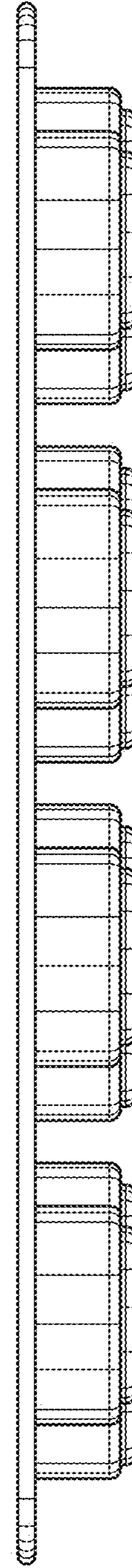
