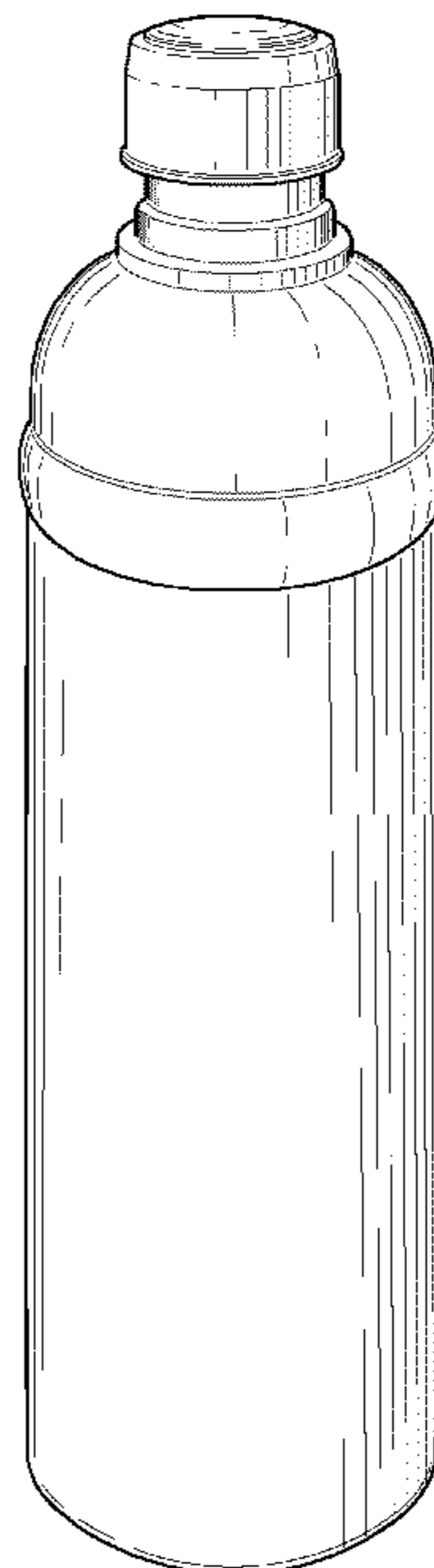
FIG. 1 is a perspective view of a pet water bottle showing my new design;

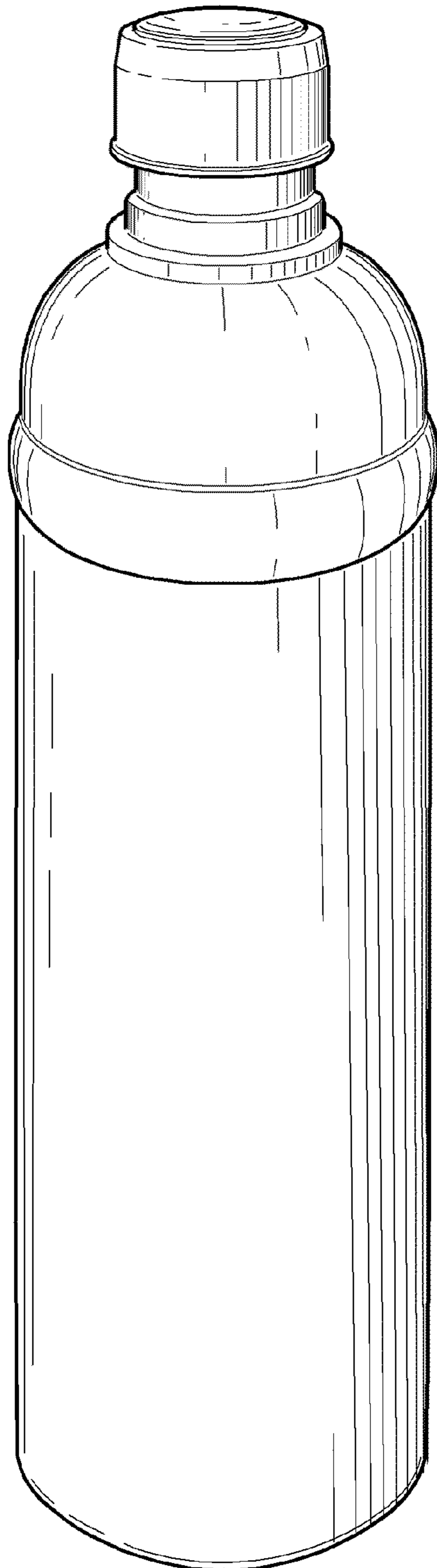

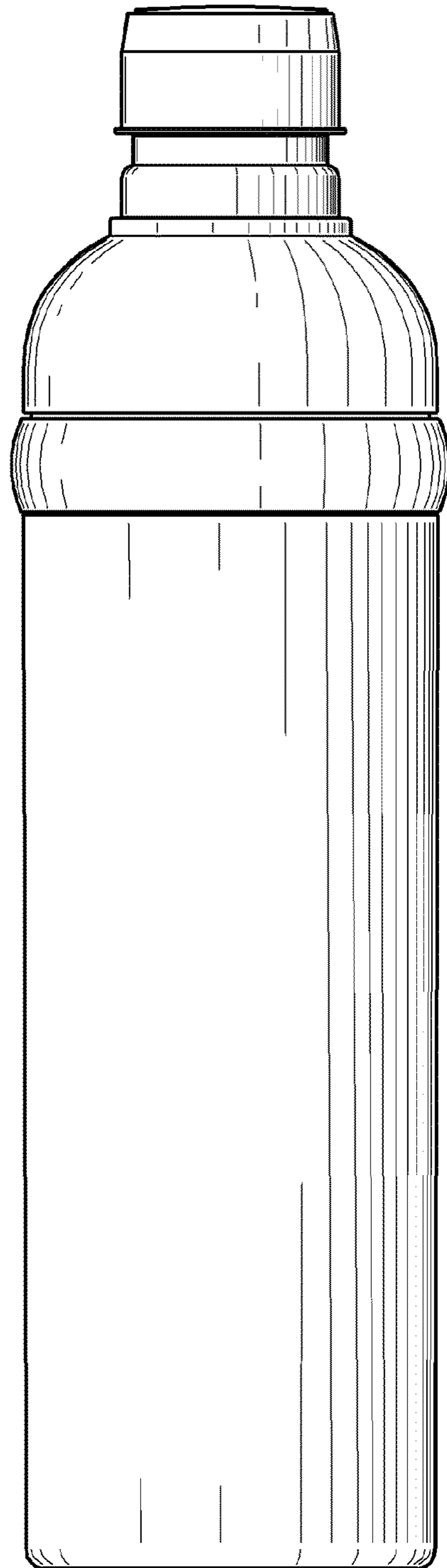

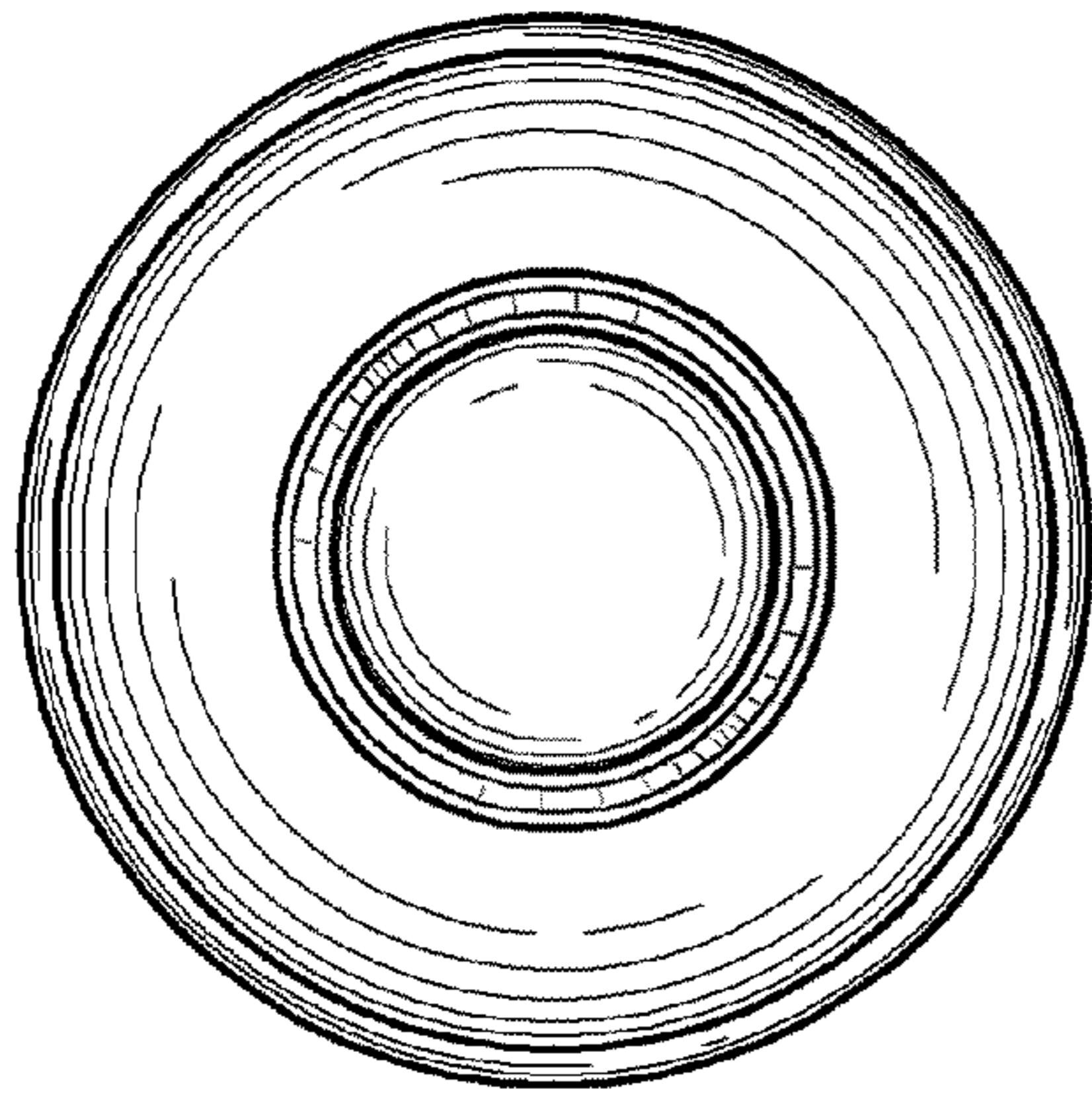

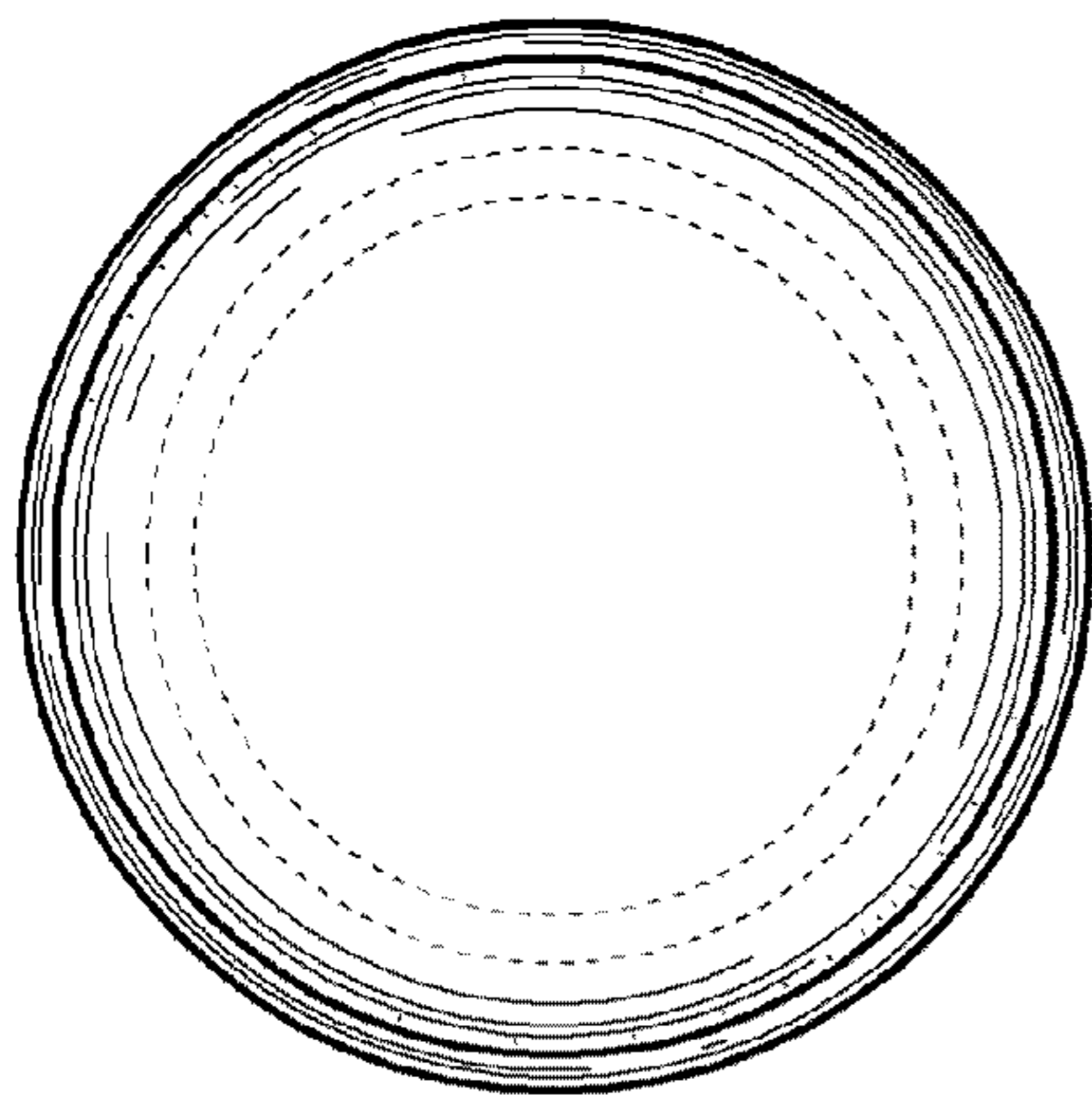

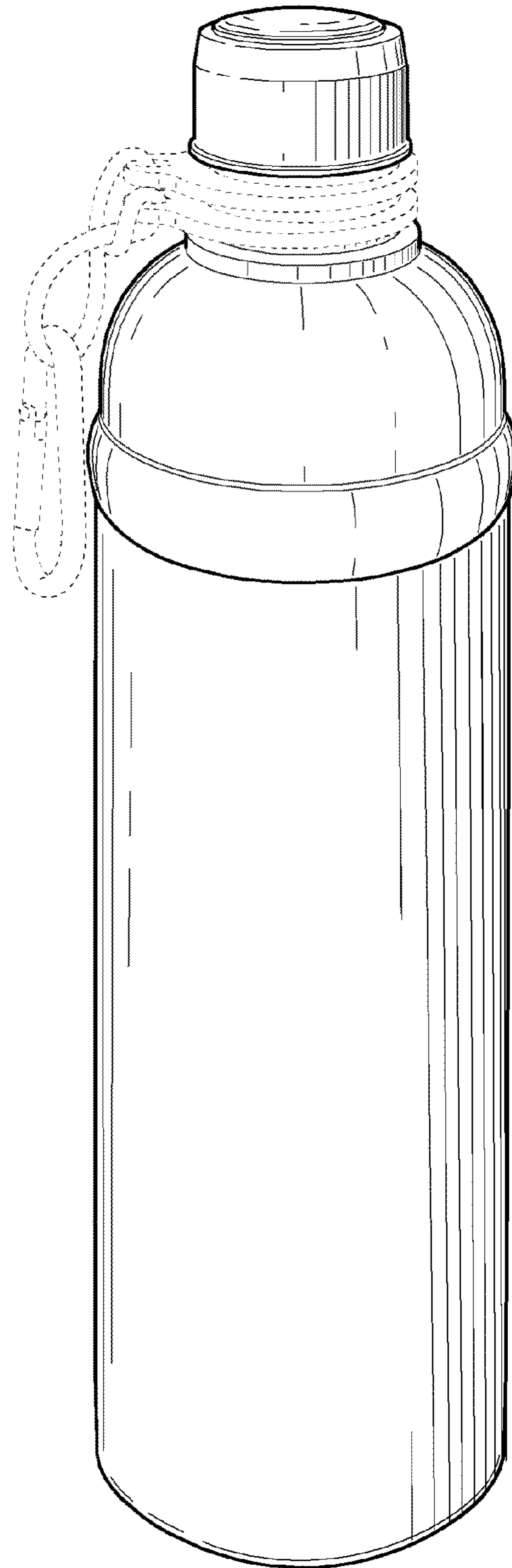

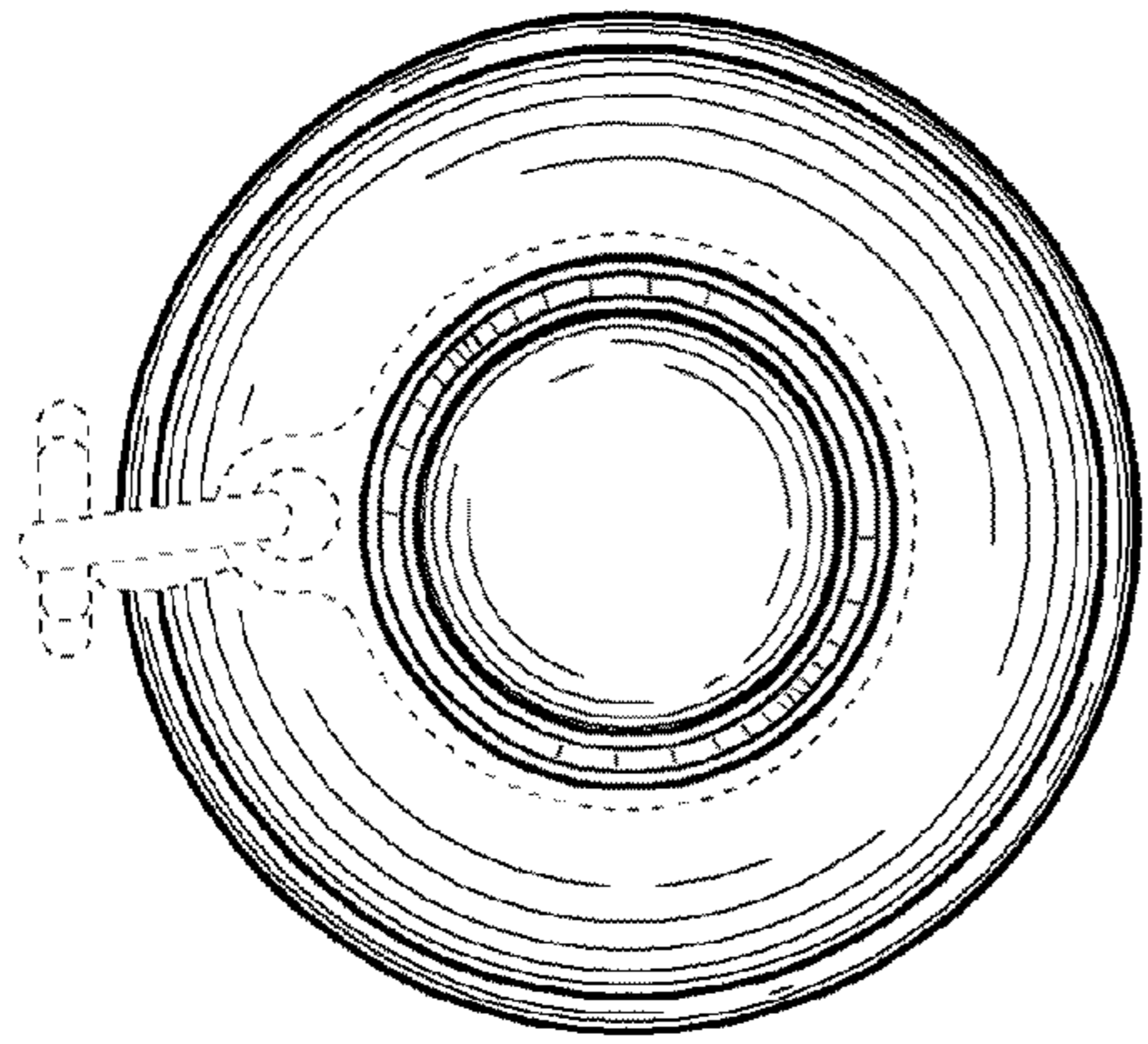

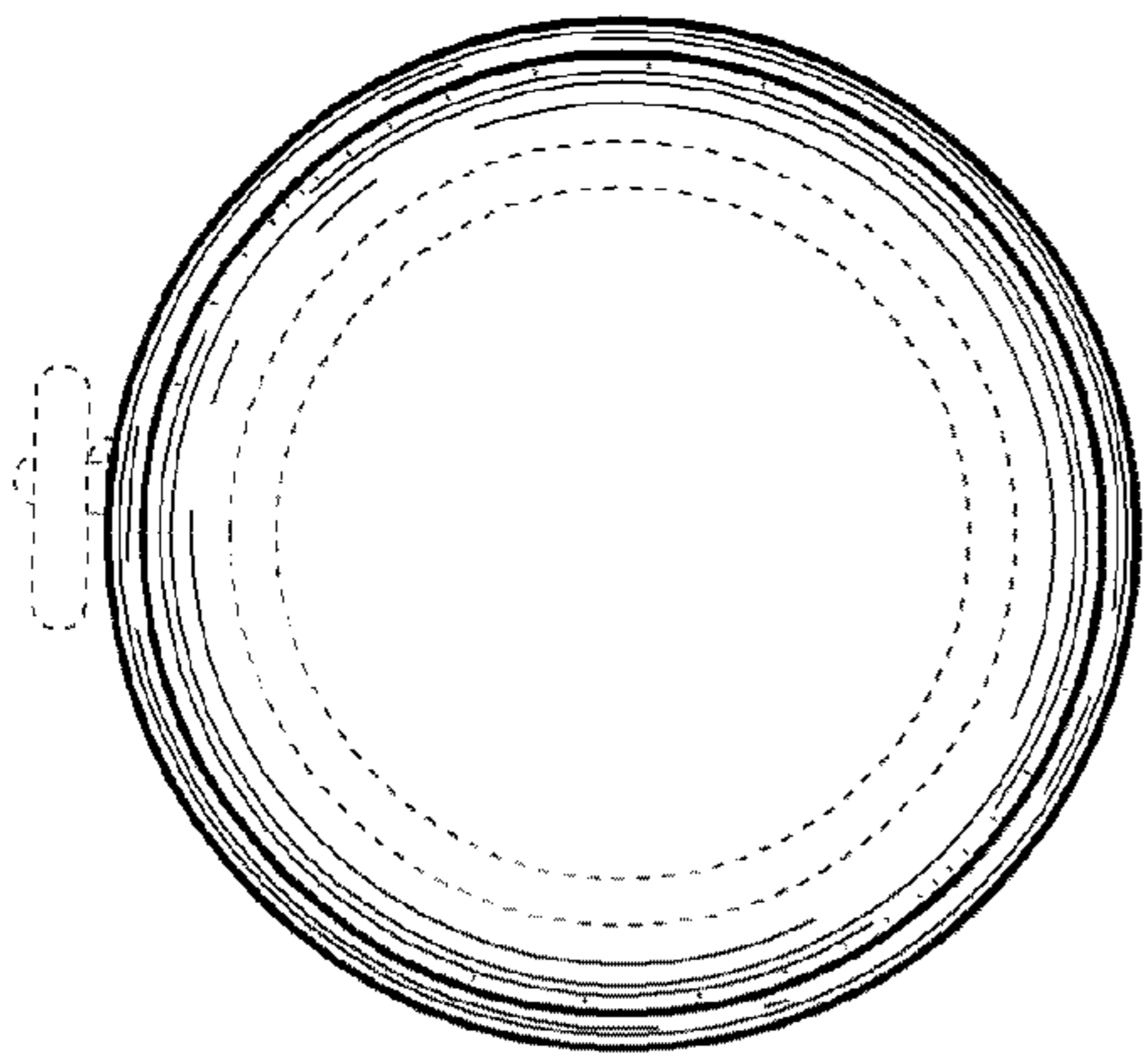

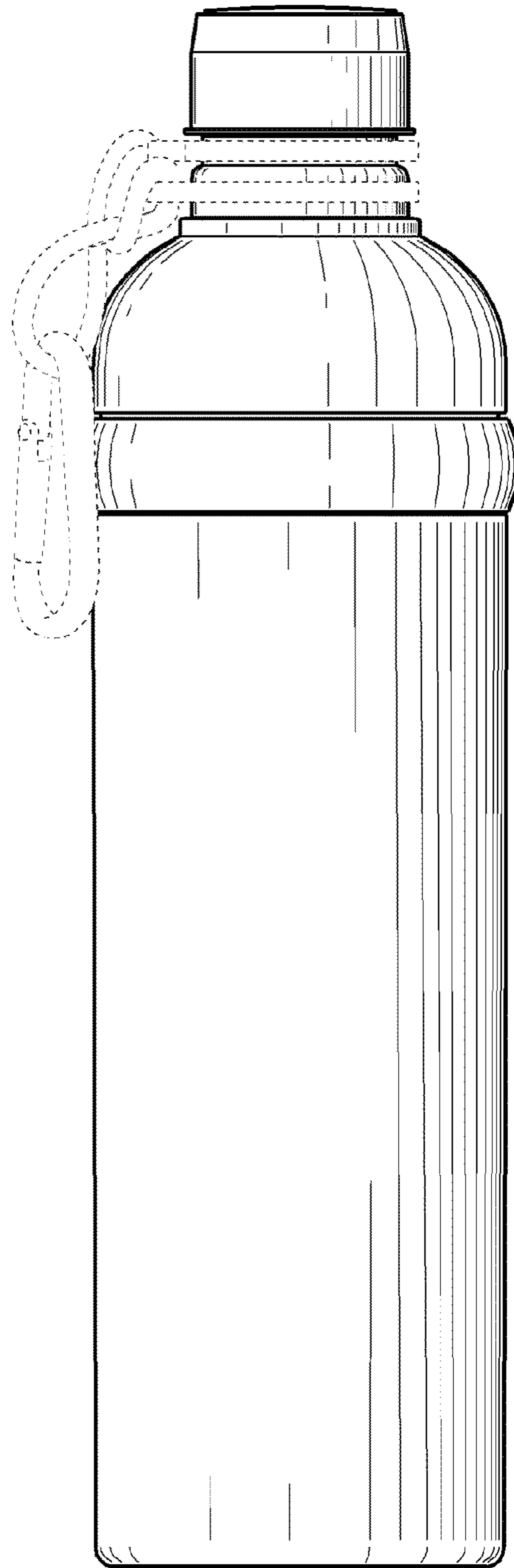

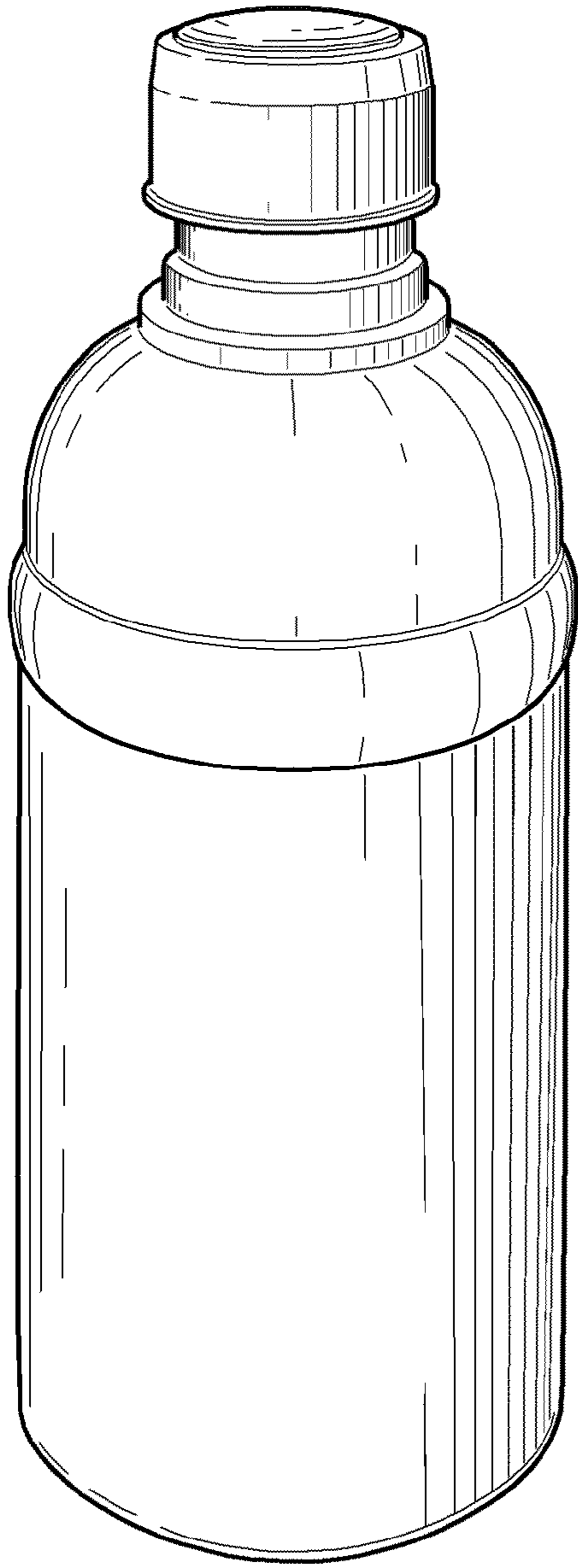

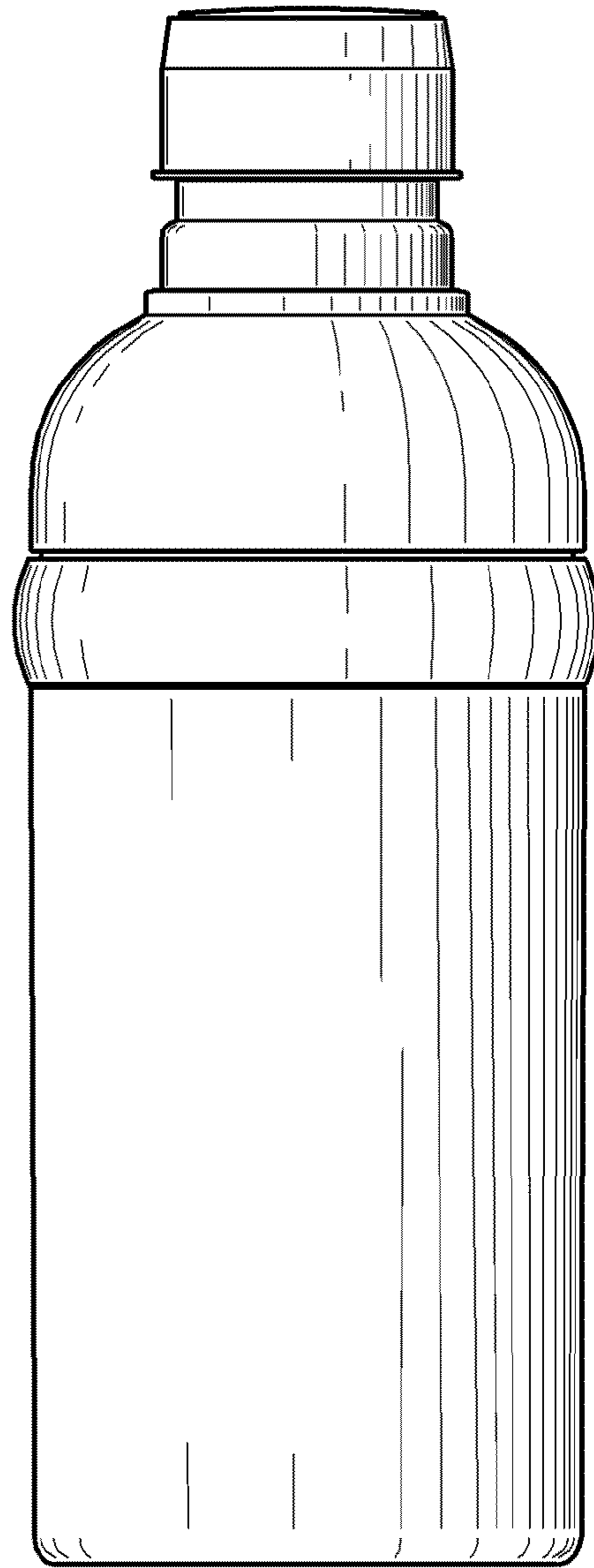

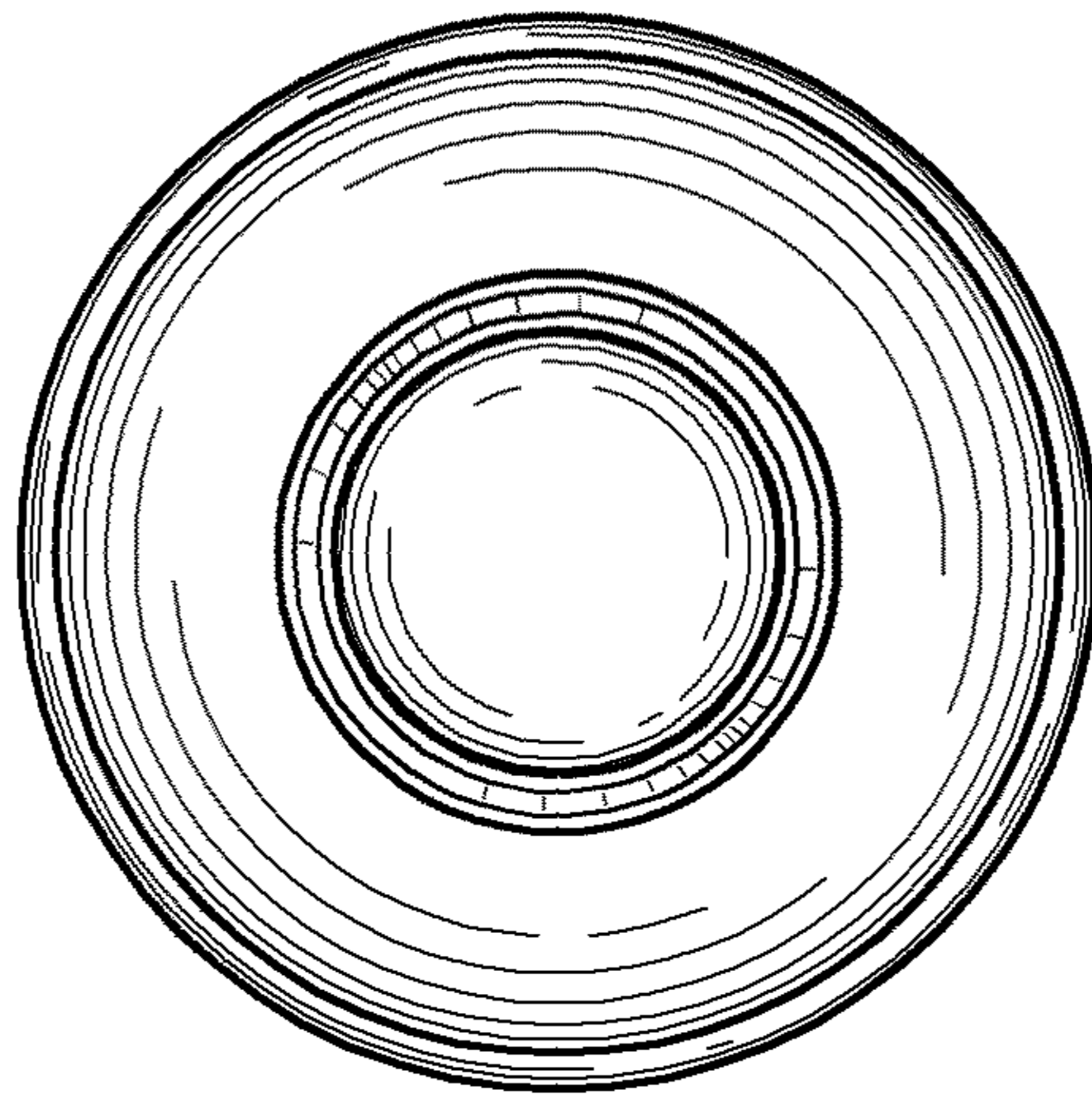

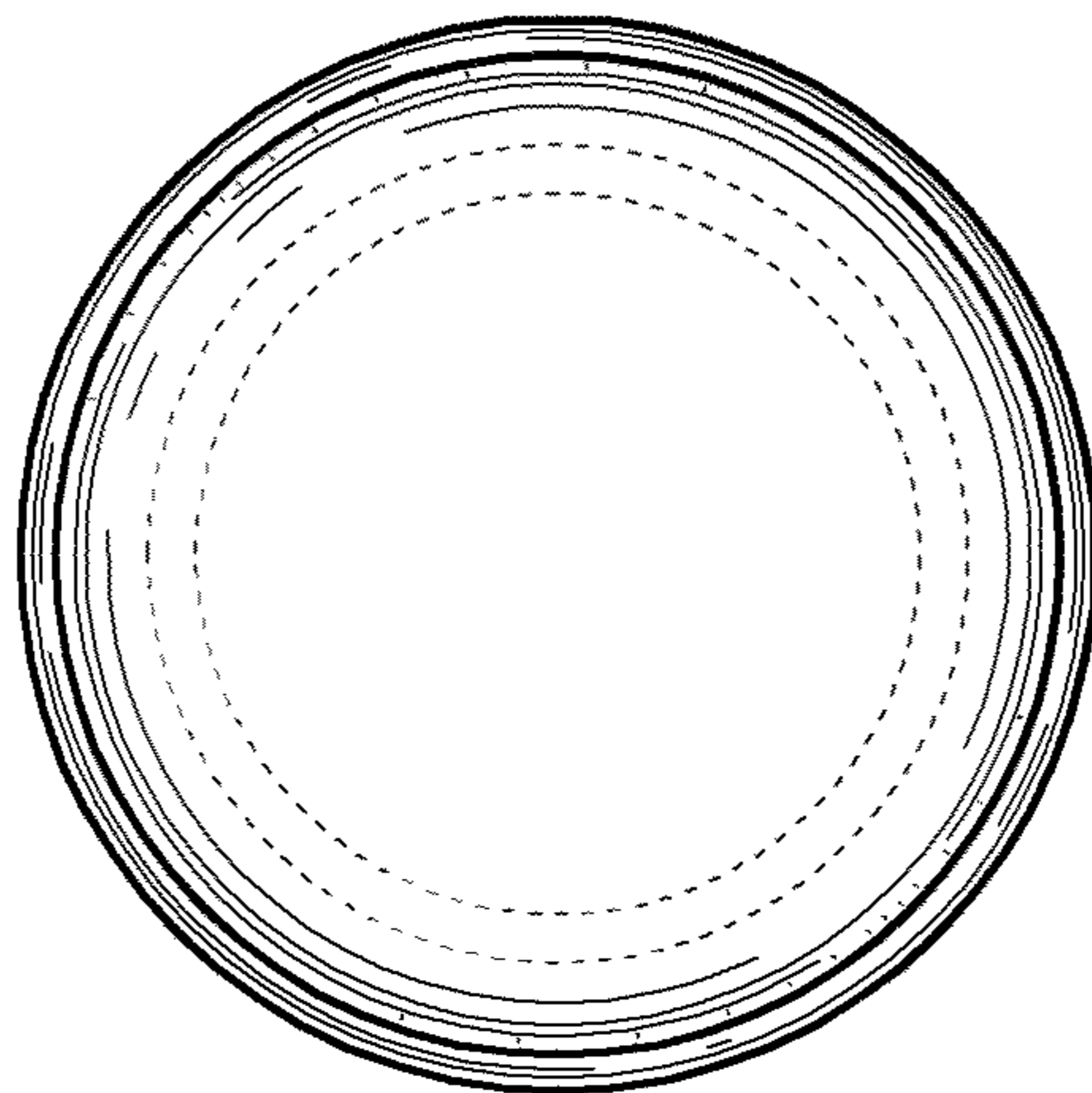
