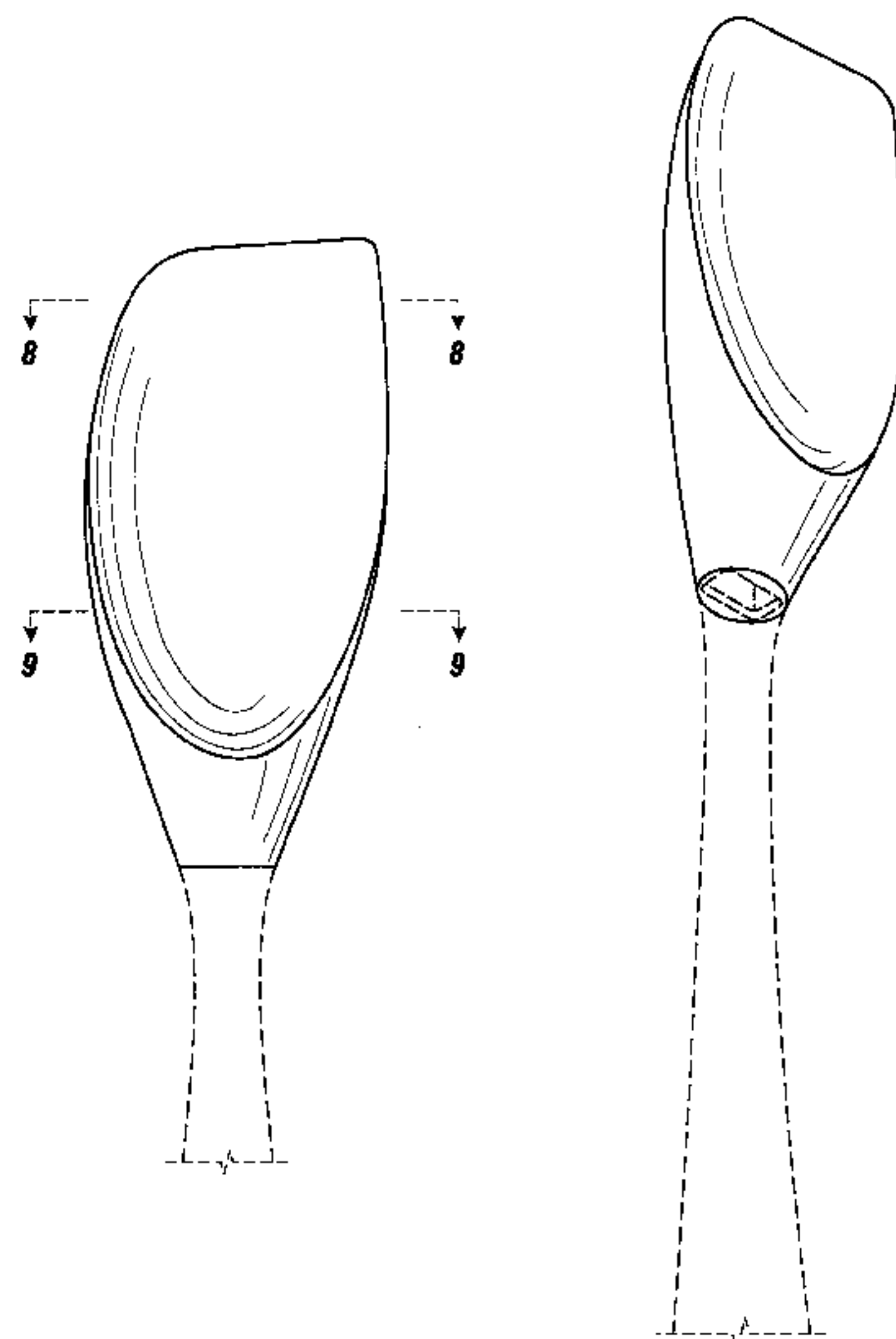
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of a sauté spoon showing our new design;  
 FIG. 2 is a front, left, bottom perspective view thereof;  
 FIG. 3 is a rear, right, bottom perspective view thereof;  
 FIG. 4 is a front, left, top perspective view thereof;  
 FIG. 5 is a rear, right, top perspective view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a cross sectional view taken along lines 8-8 of FIG. 1;  
 FIG. 9 is a cross sectional view taken along lines 9-9 of FIG. 1;  
 FIG. 10 is a right side view of FIG. 1;  
 FIG. 11 is a rear view thereof; and,  
 FIG. 12 is a left side view thereof.

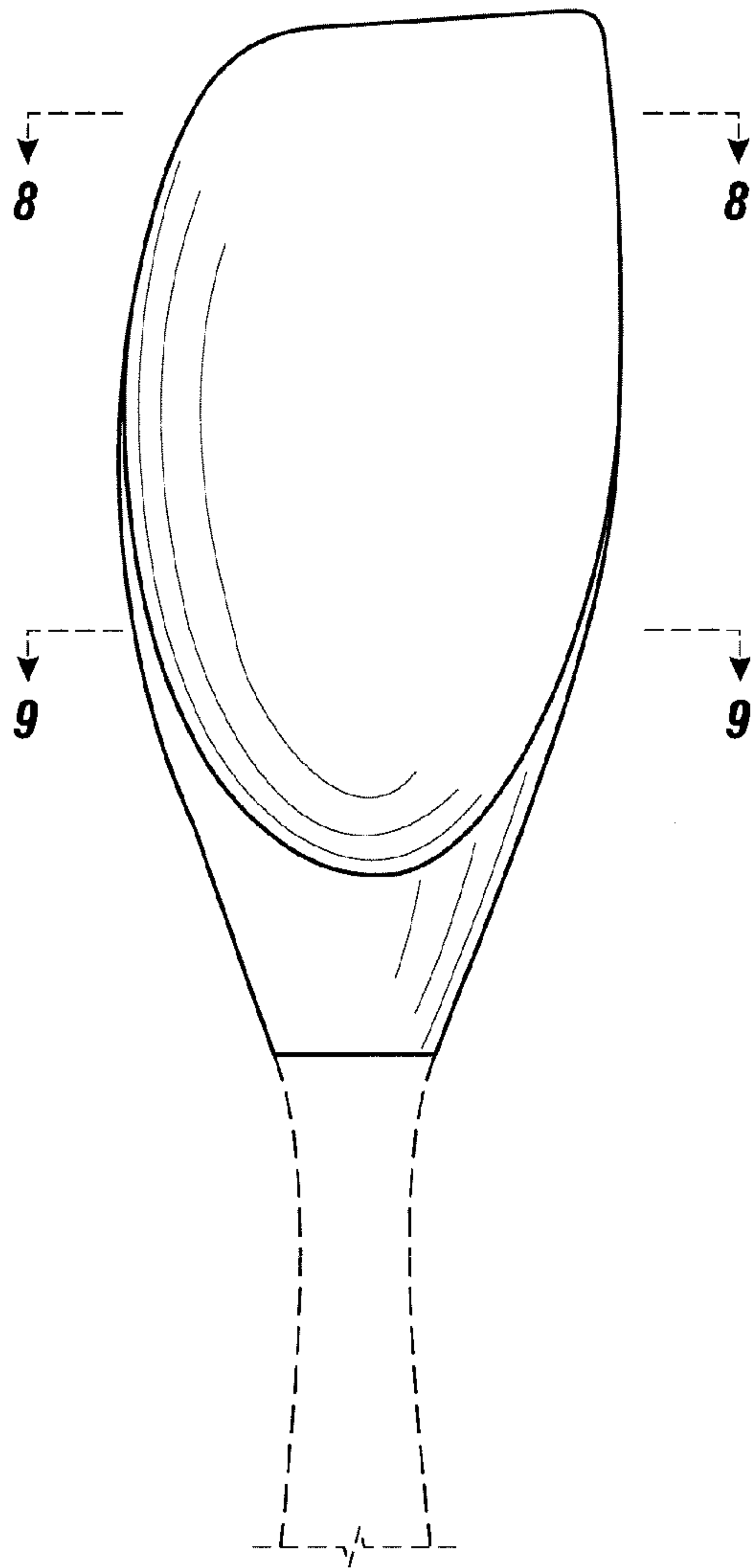

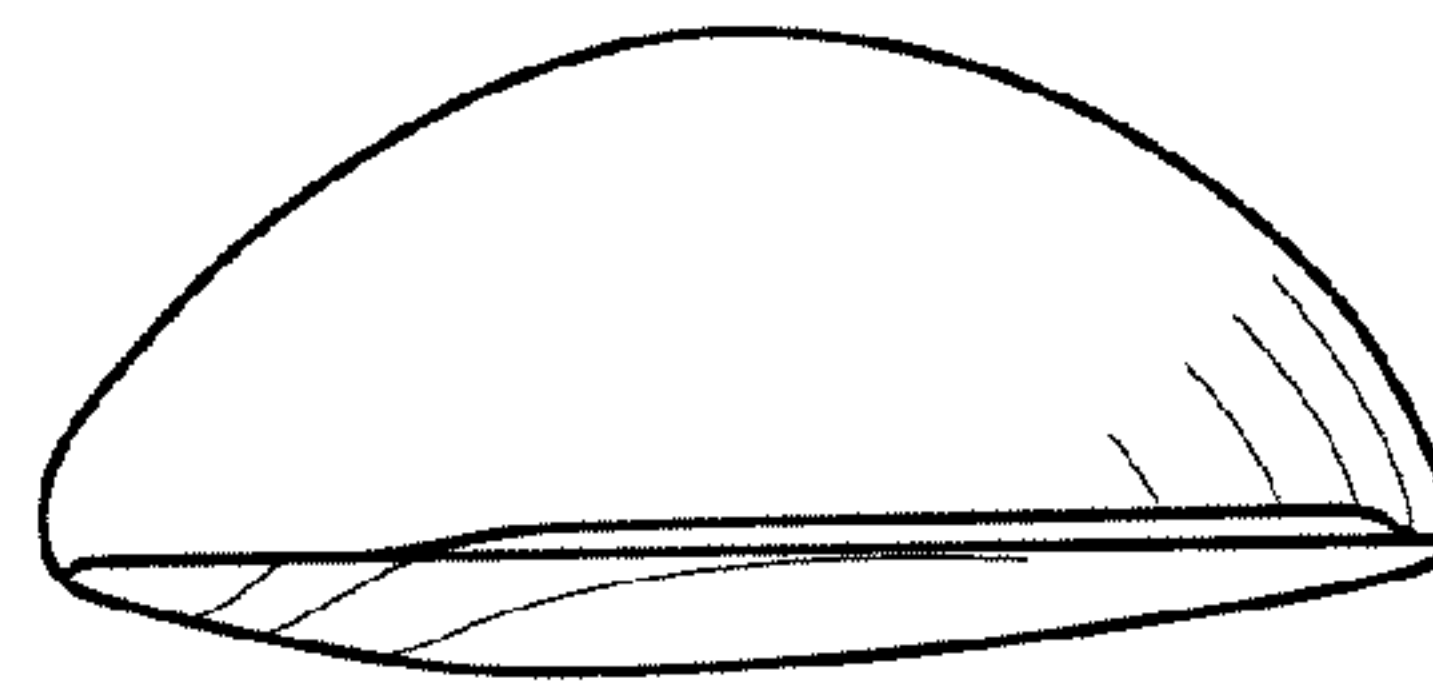

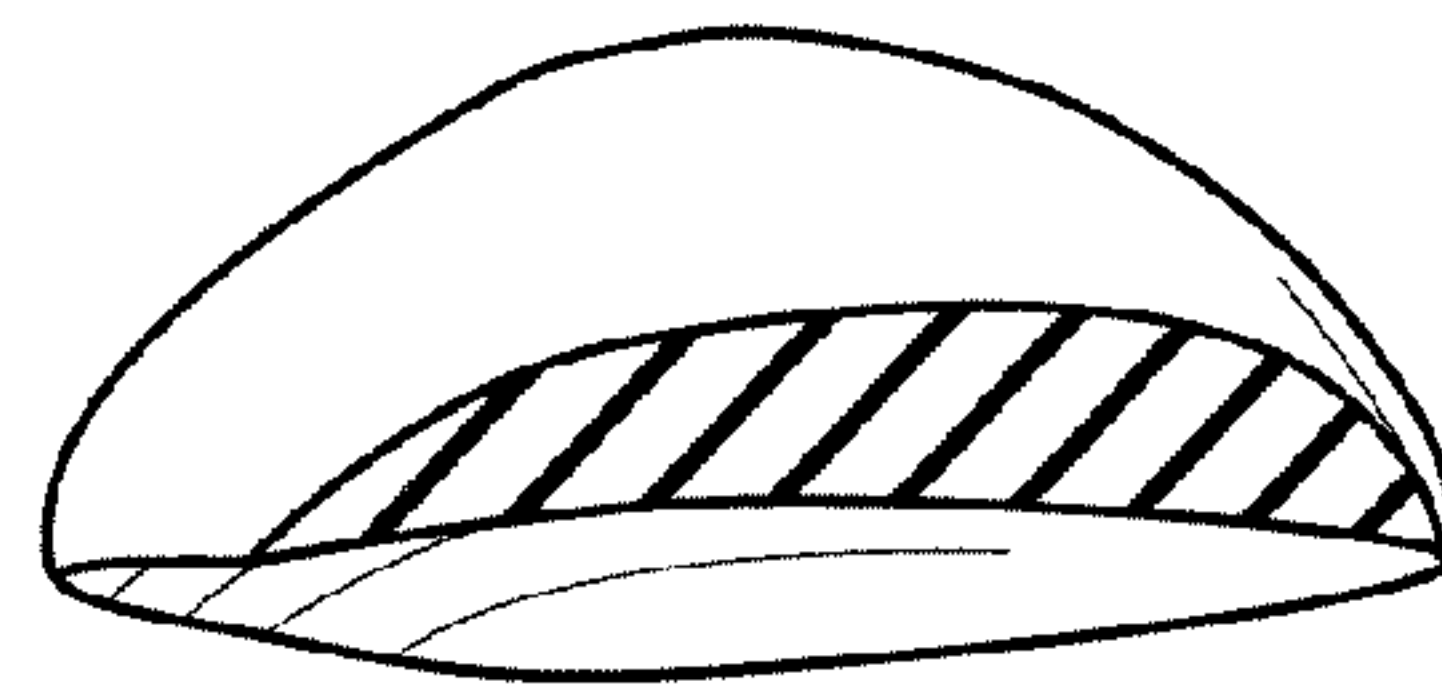

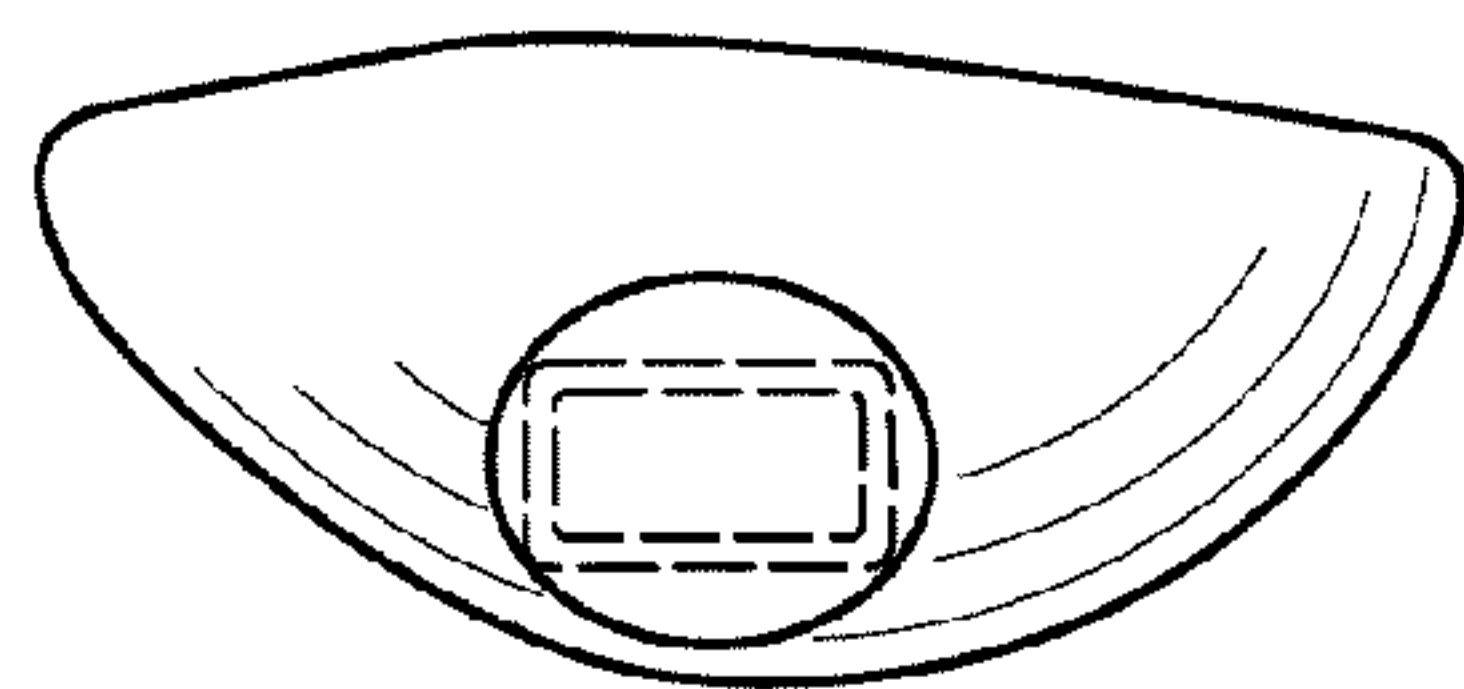

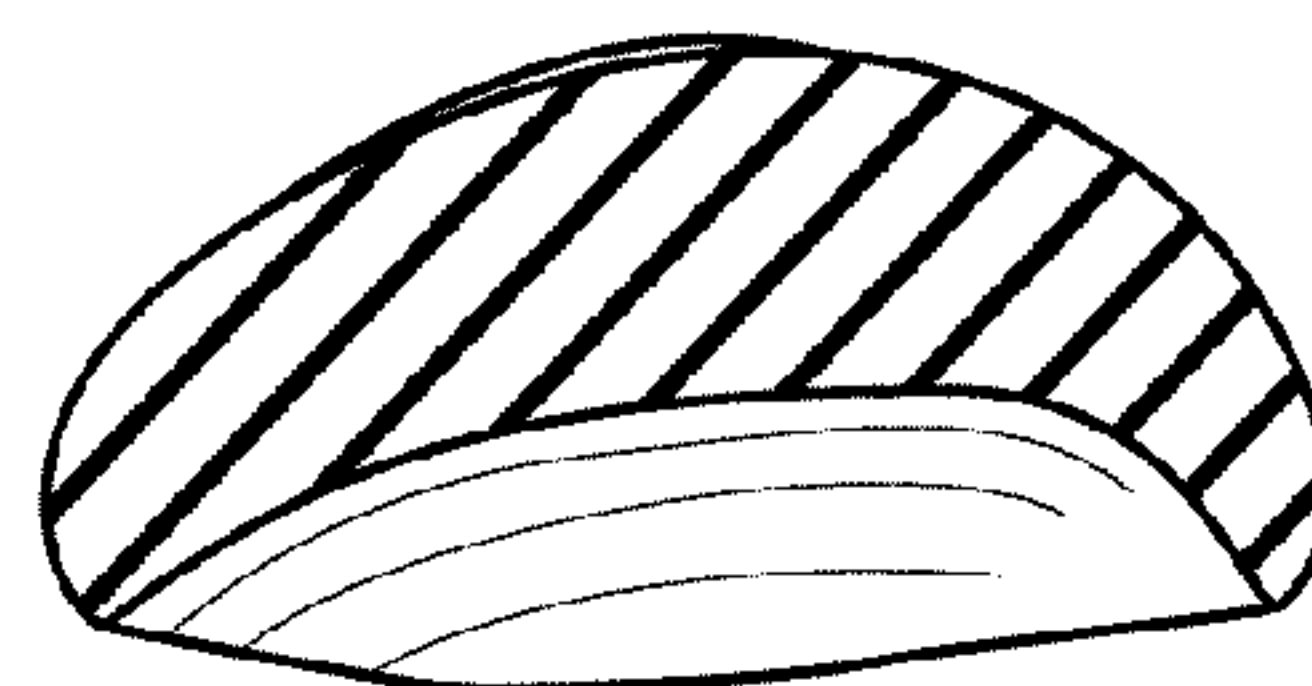

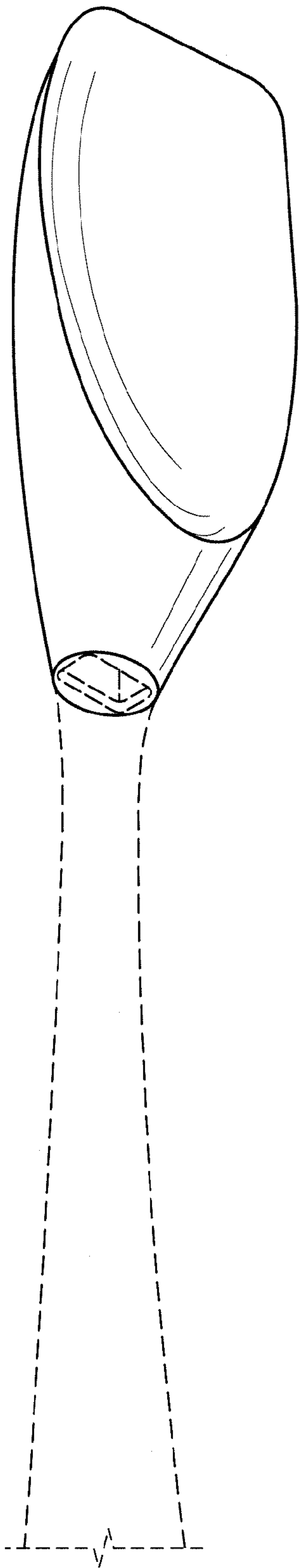

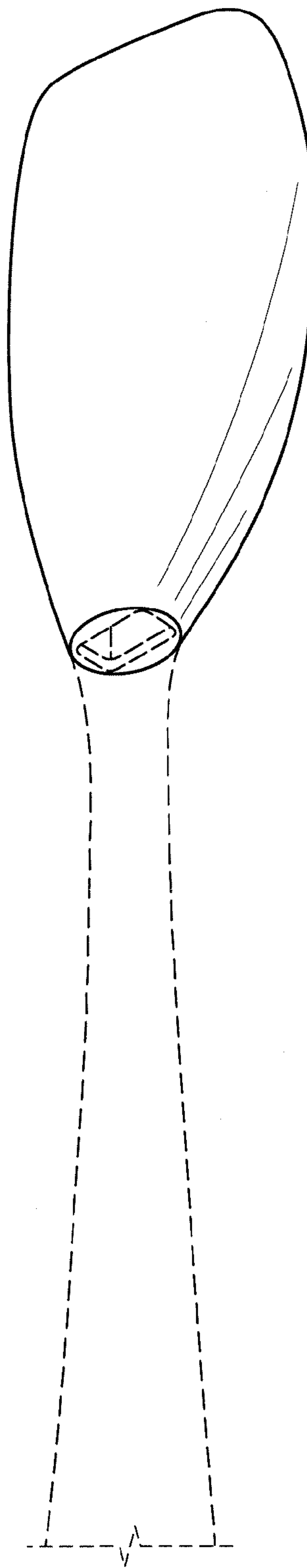

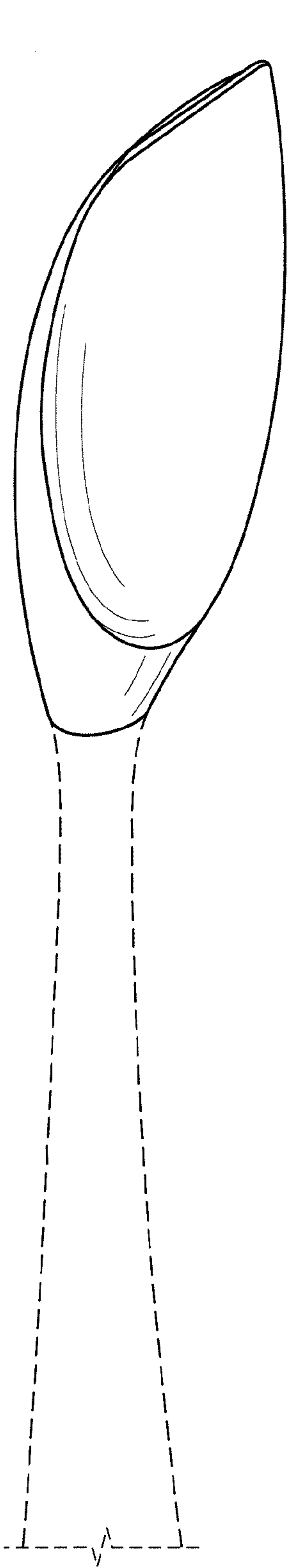

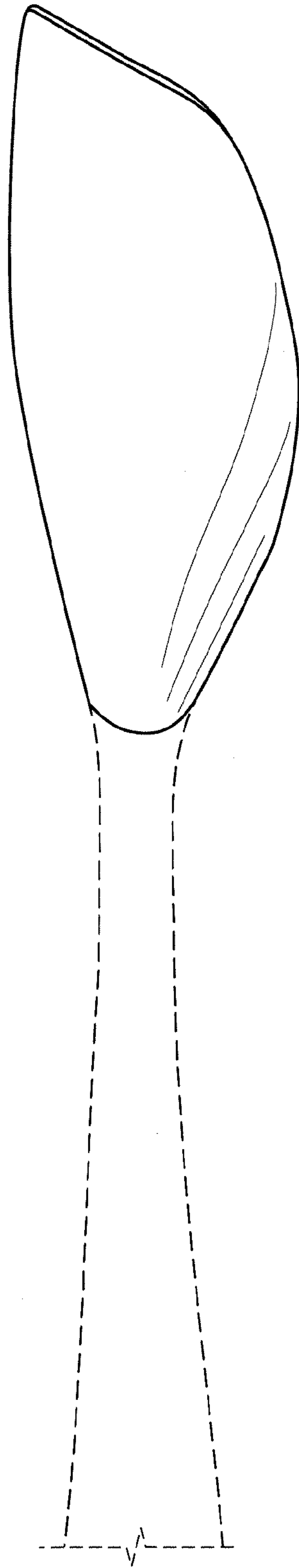

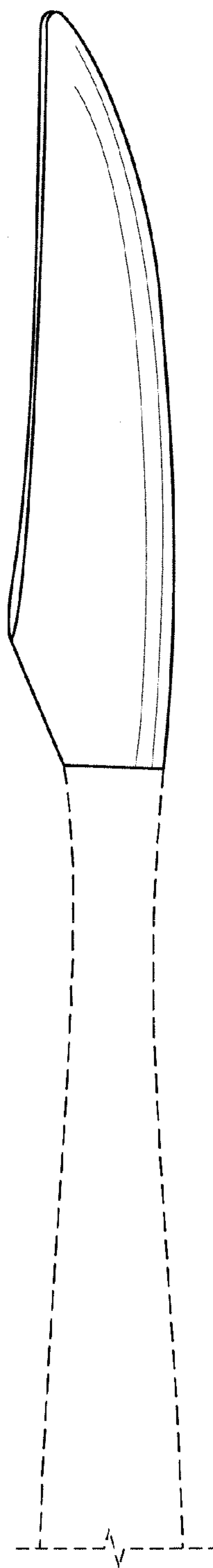

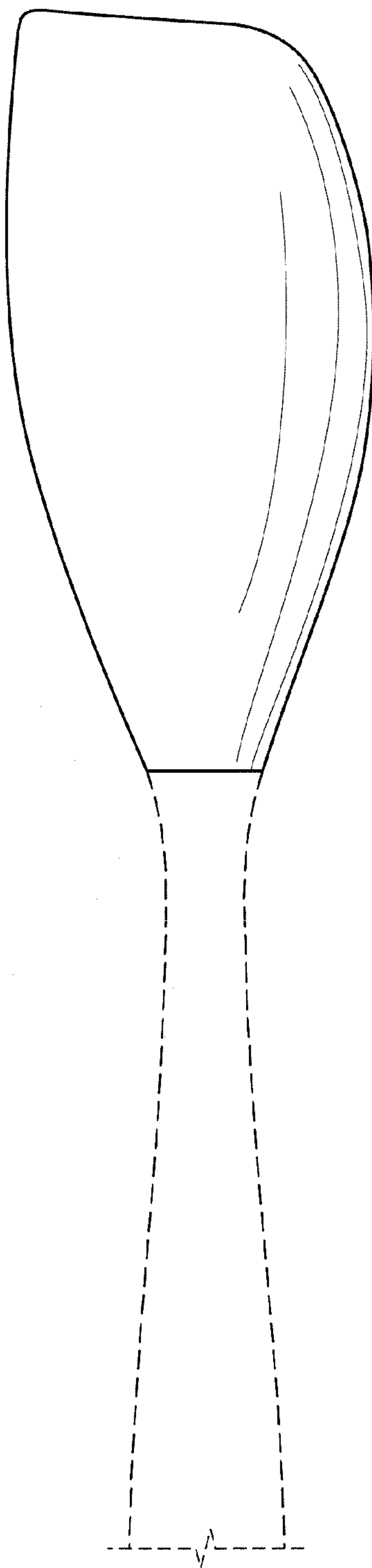

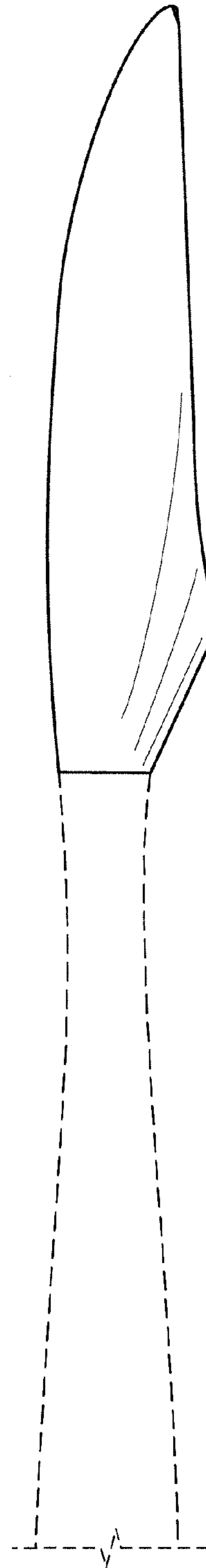
