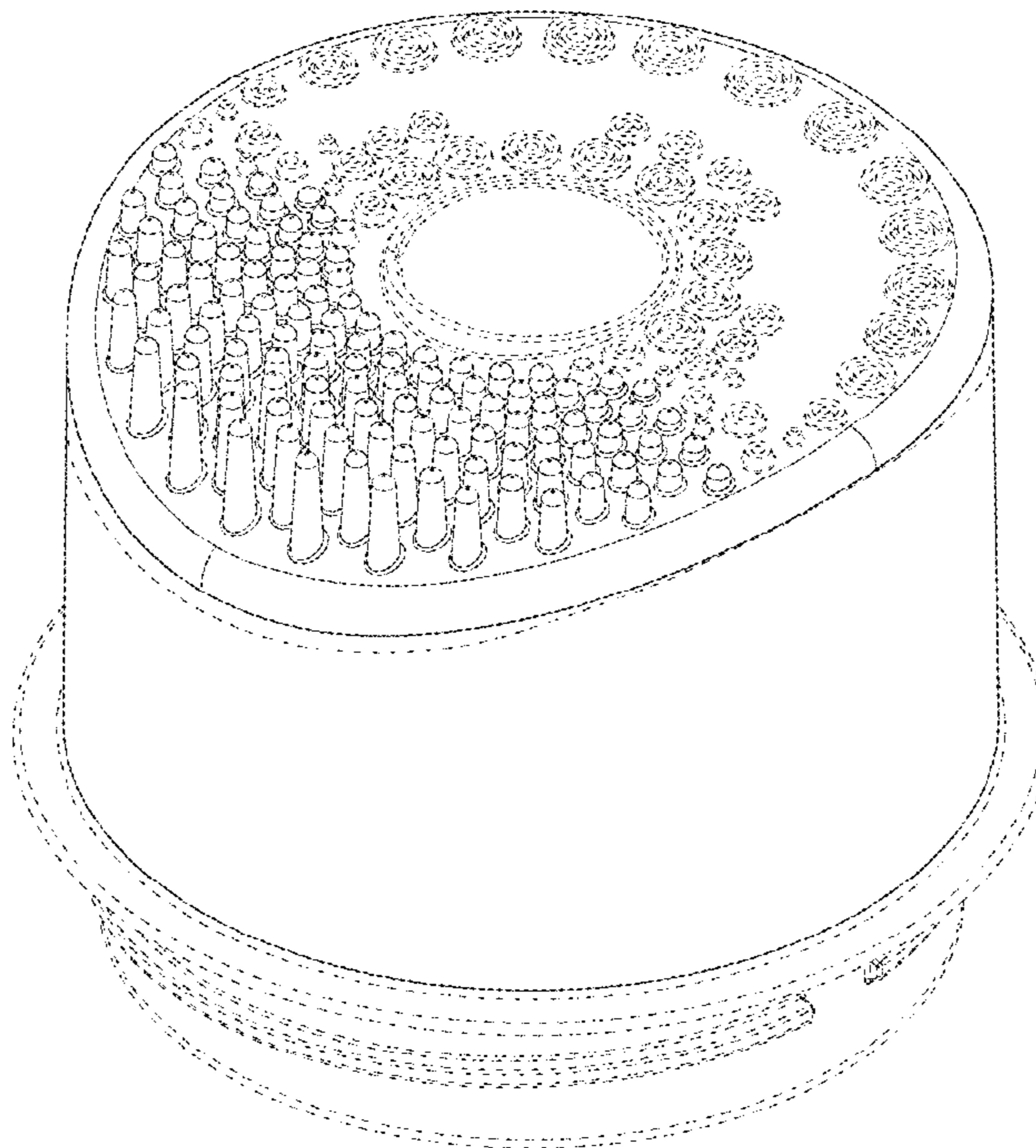
(57) **CLAIM**

The ornamental design for a dispensing cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dispensing cap;
 FIG. 2 is an alternative perspective view of the dispensing cap of FIG. 1;
 FIG. 3 is a side view of the dispensing cap of FIG. 1;
 FIG. 4 is a rear view of the dispensing cap of FIG. 1;
 FIG. 5 is a side view of the dispensing cap of FIG. 1, opposite the side view shown in FIG. 3;
 FIG. 6 is a front view of the dispensing cap of FIG. 1;
 FIG. 7 is a top view of the dispensing cap of FIG. 1; and,
 FIG. 8 is a bottom view of the dispensing cap of FIG. 1.

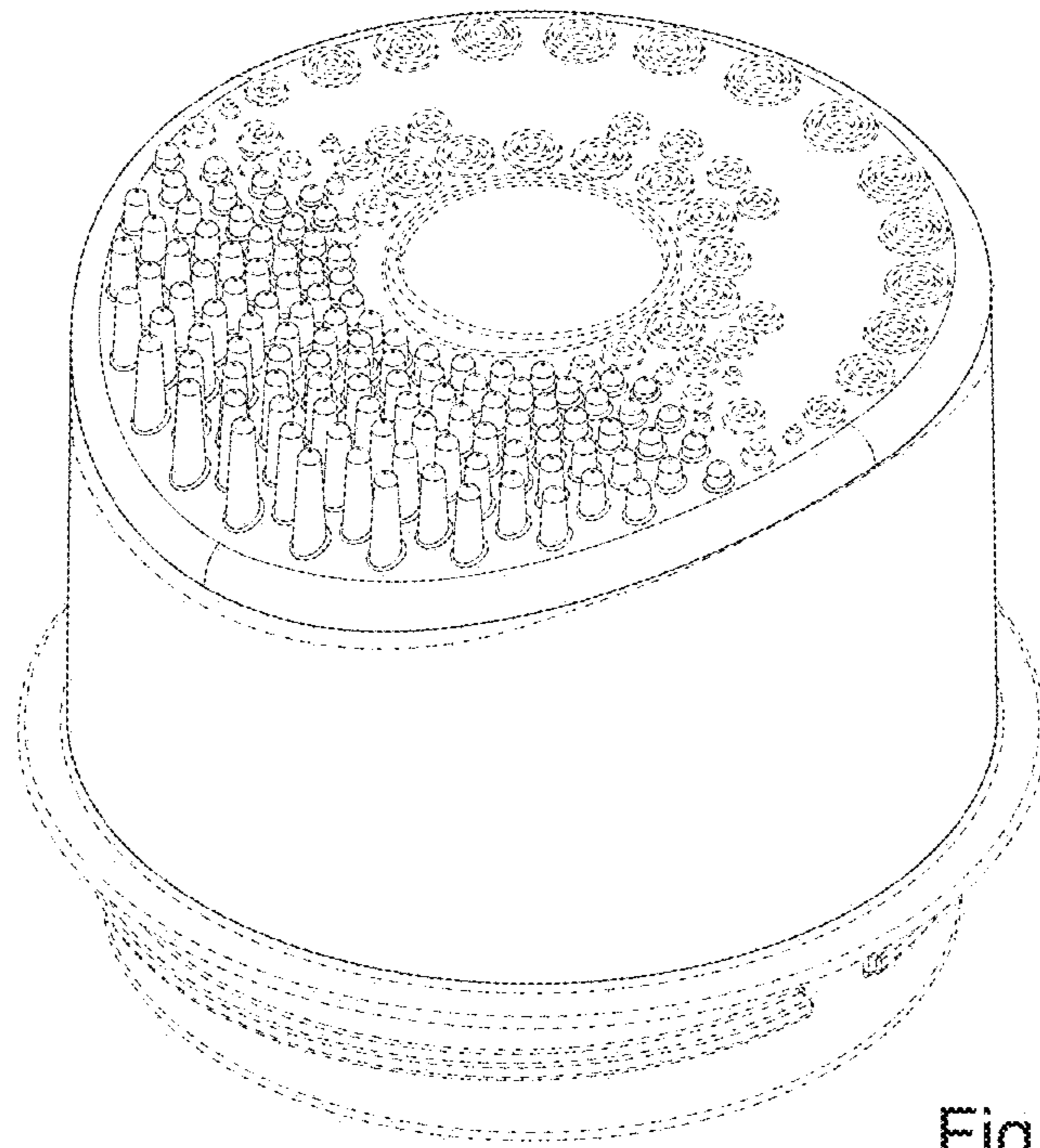

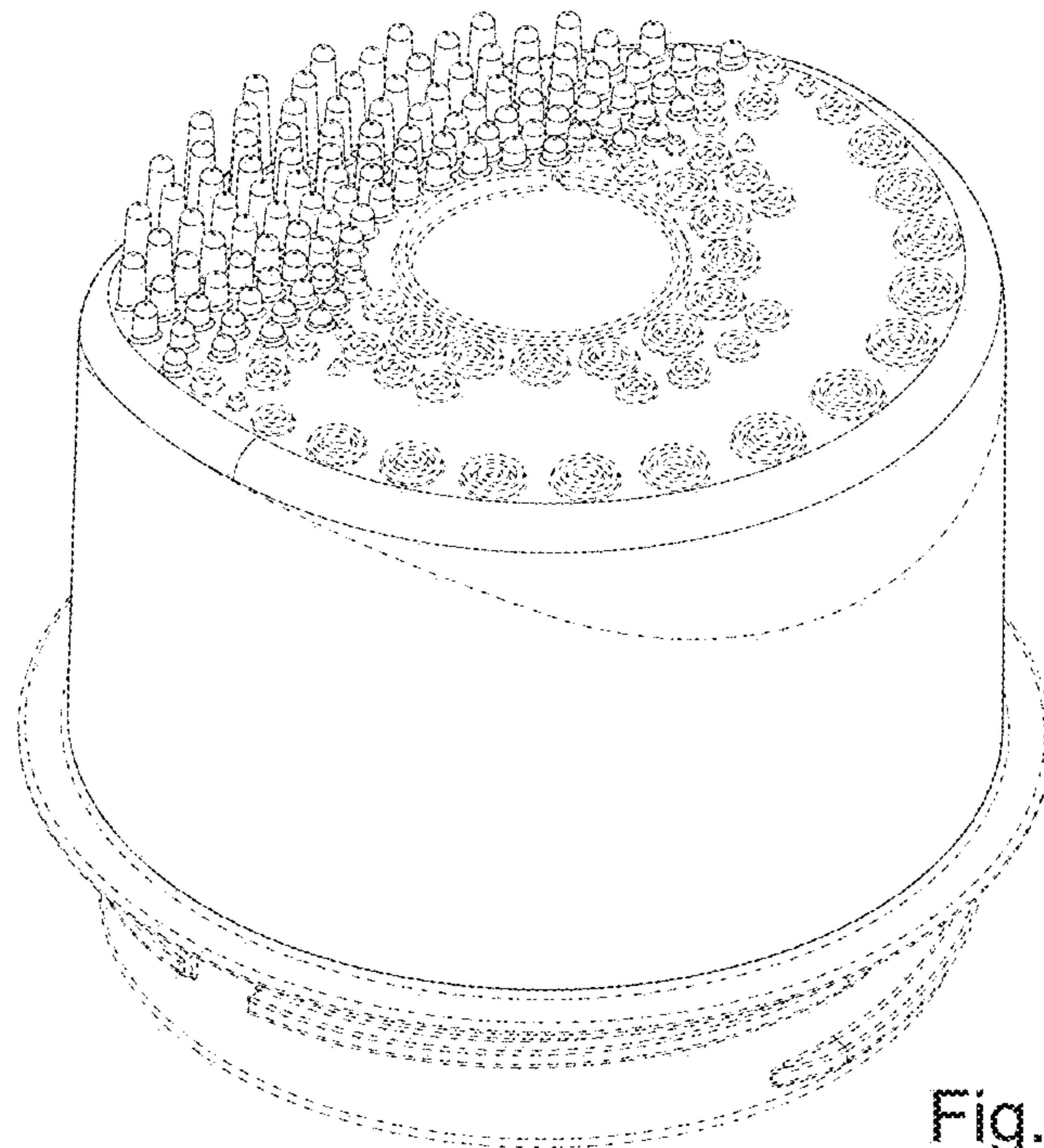

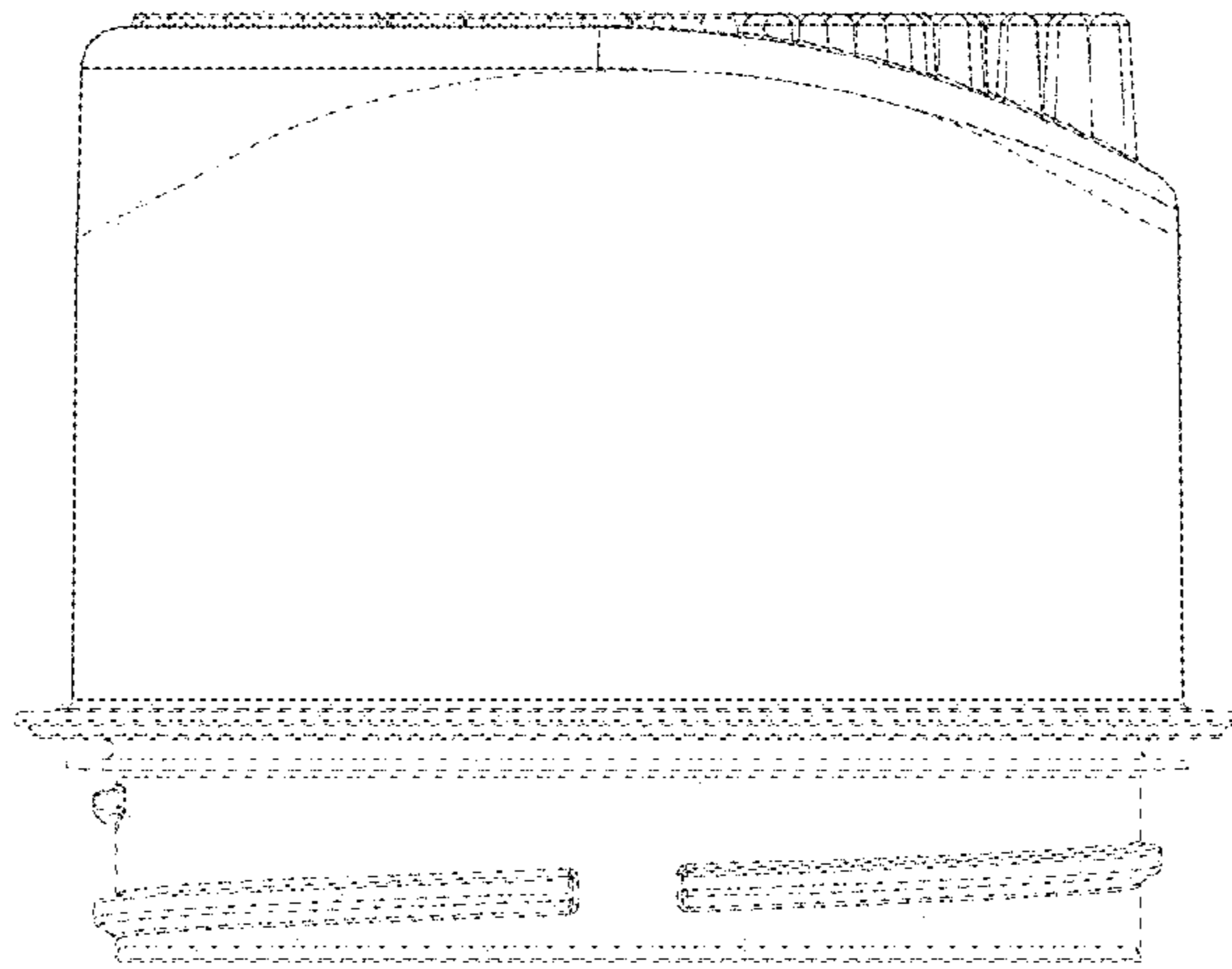

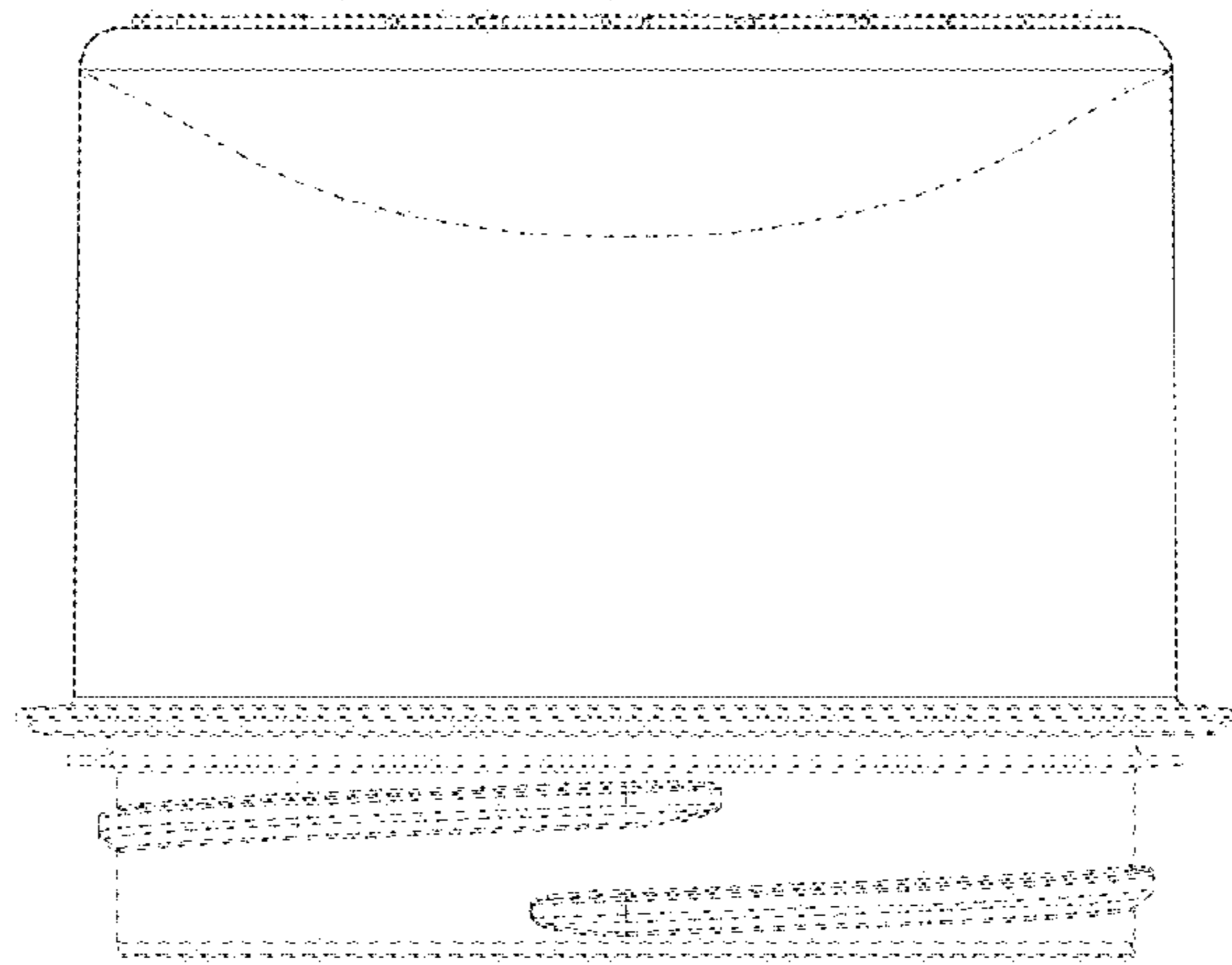

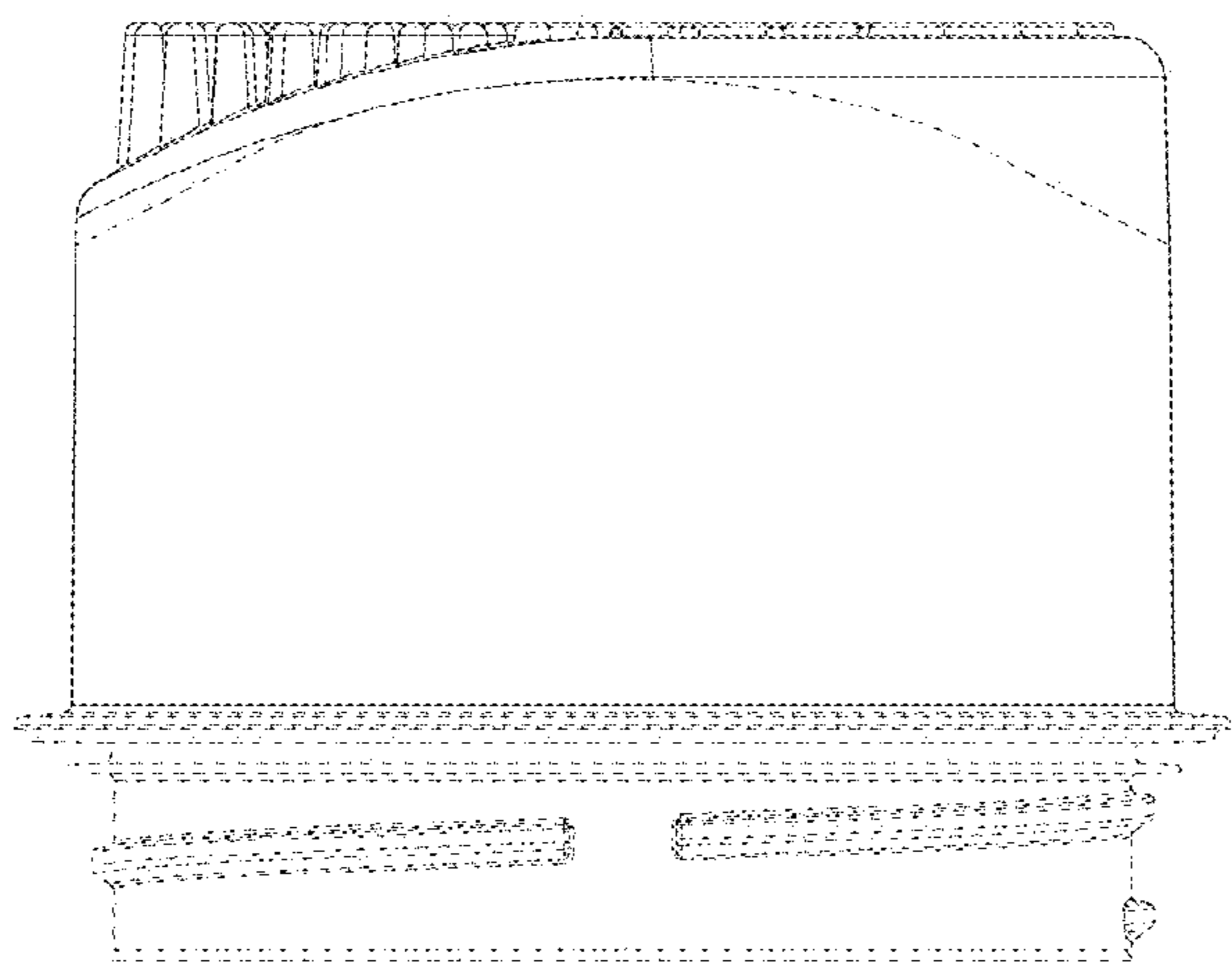

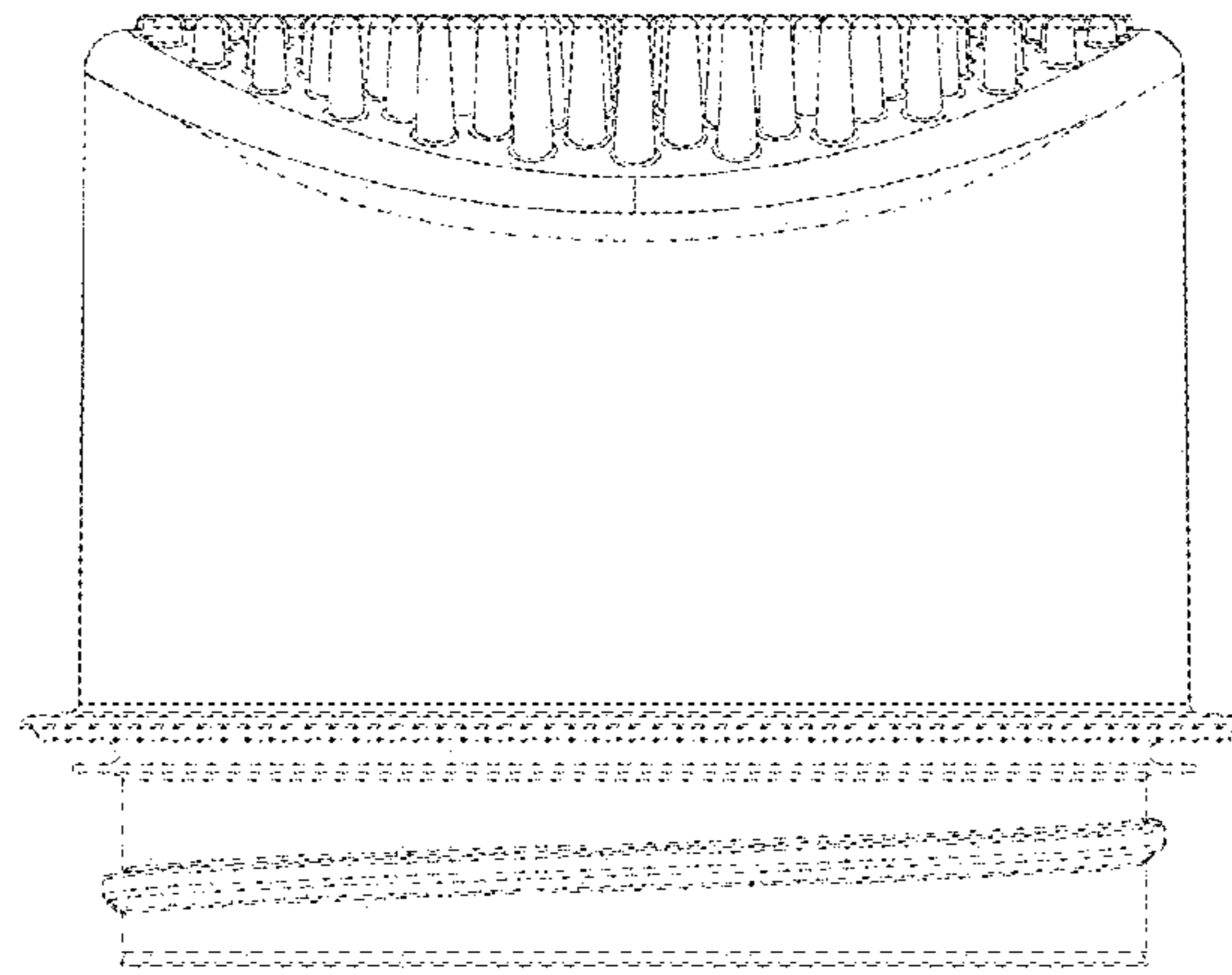

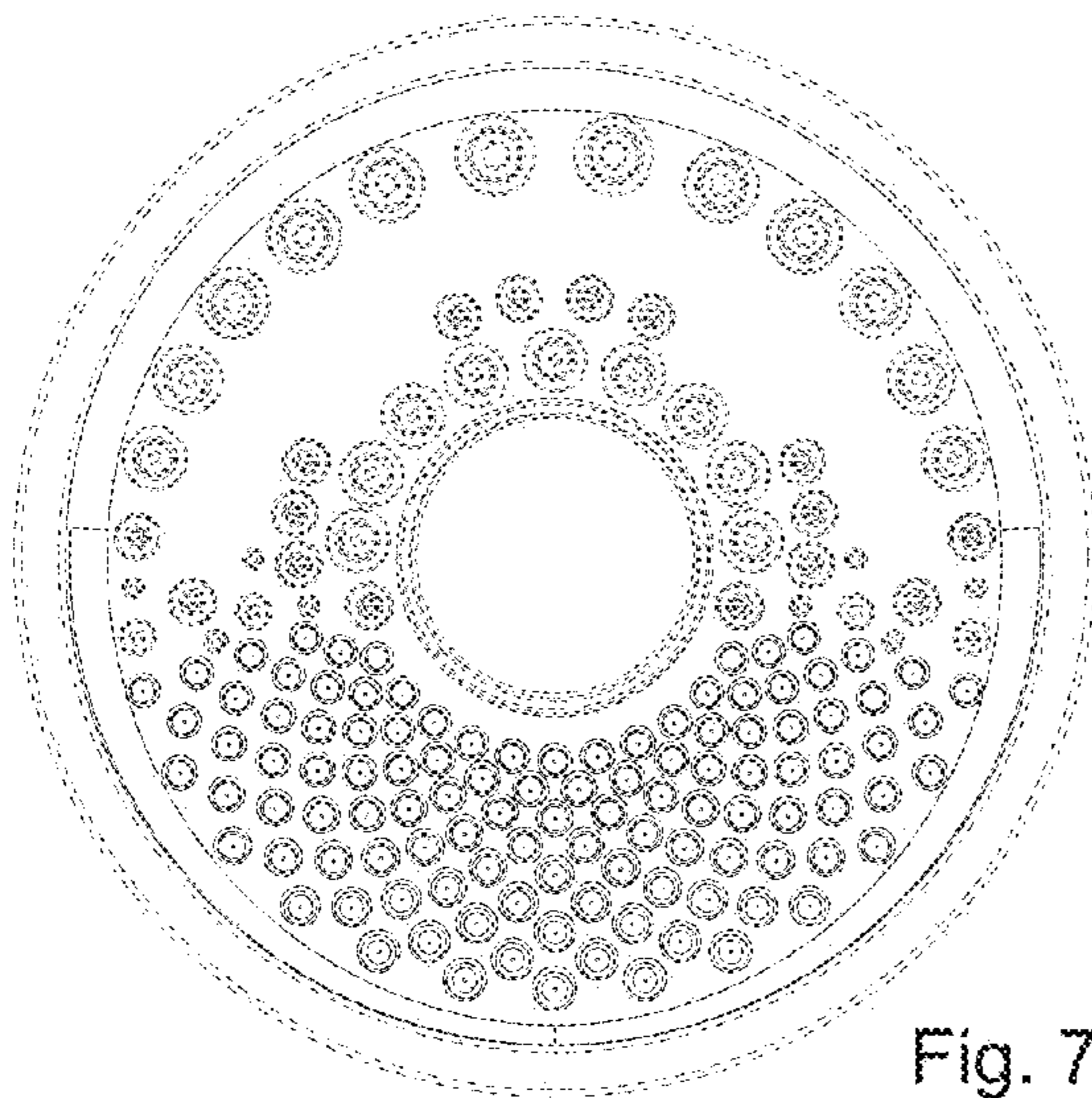

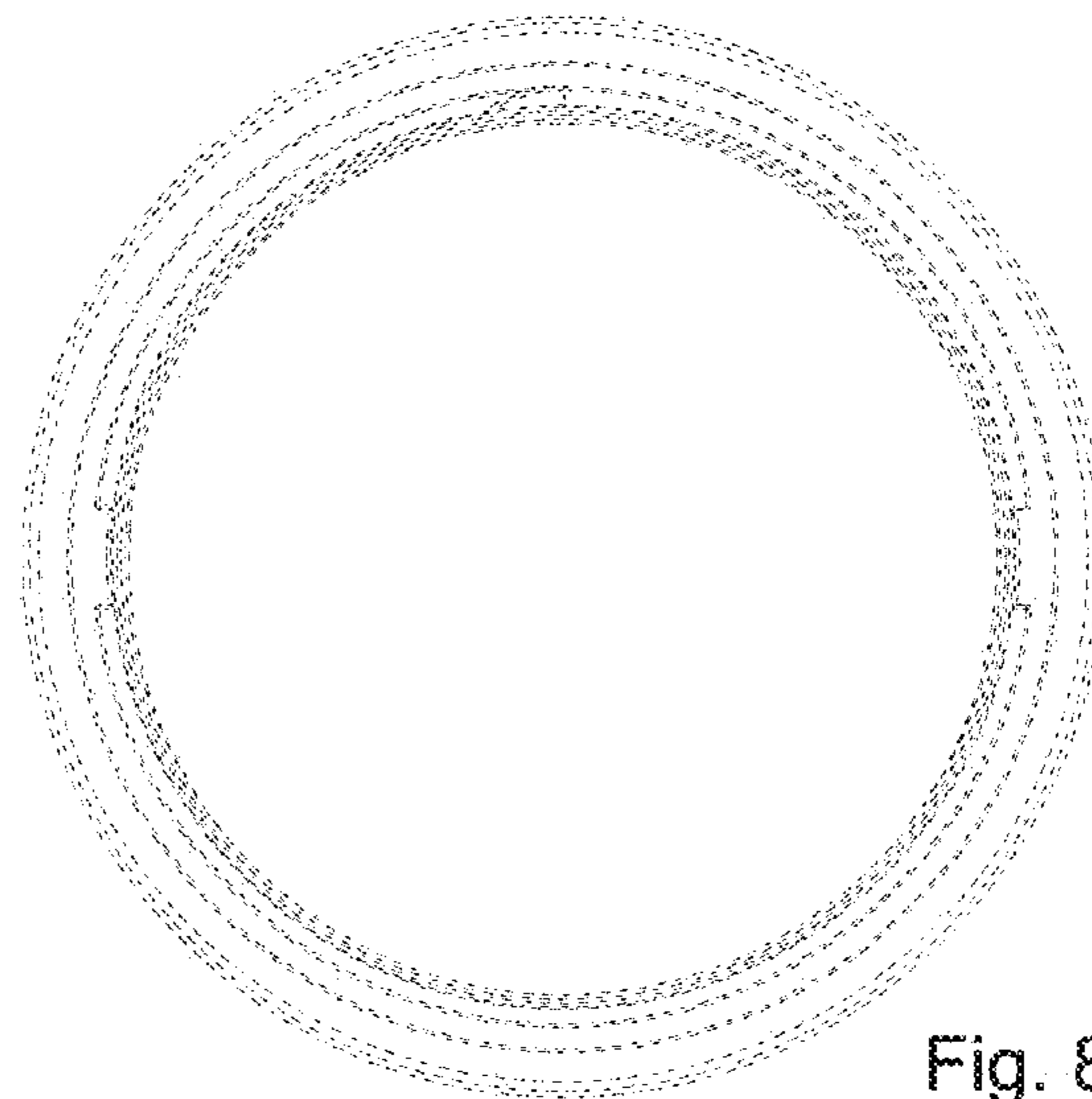
