(57) **CLAIM**

The ornamental design for an illuminated, musical Christmas table top decoration of the 12 days of Christmas, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of an illuminated, musical Christmas table top decoration of the 12 days of Christmas showing my new design, the base shown in broken lines as not forming part of the claimed design;

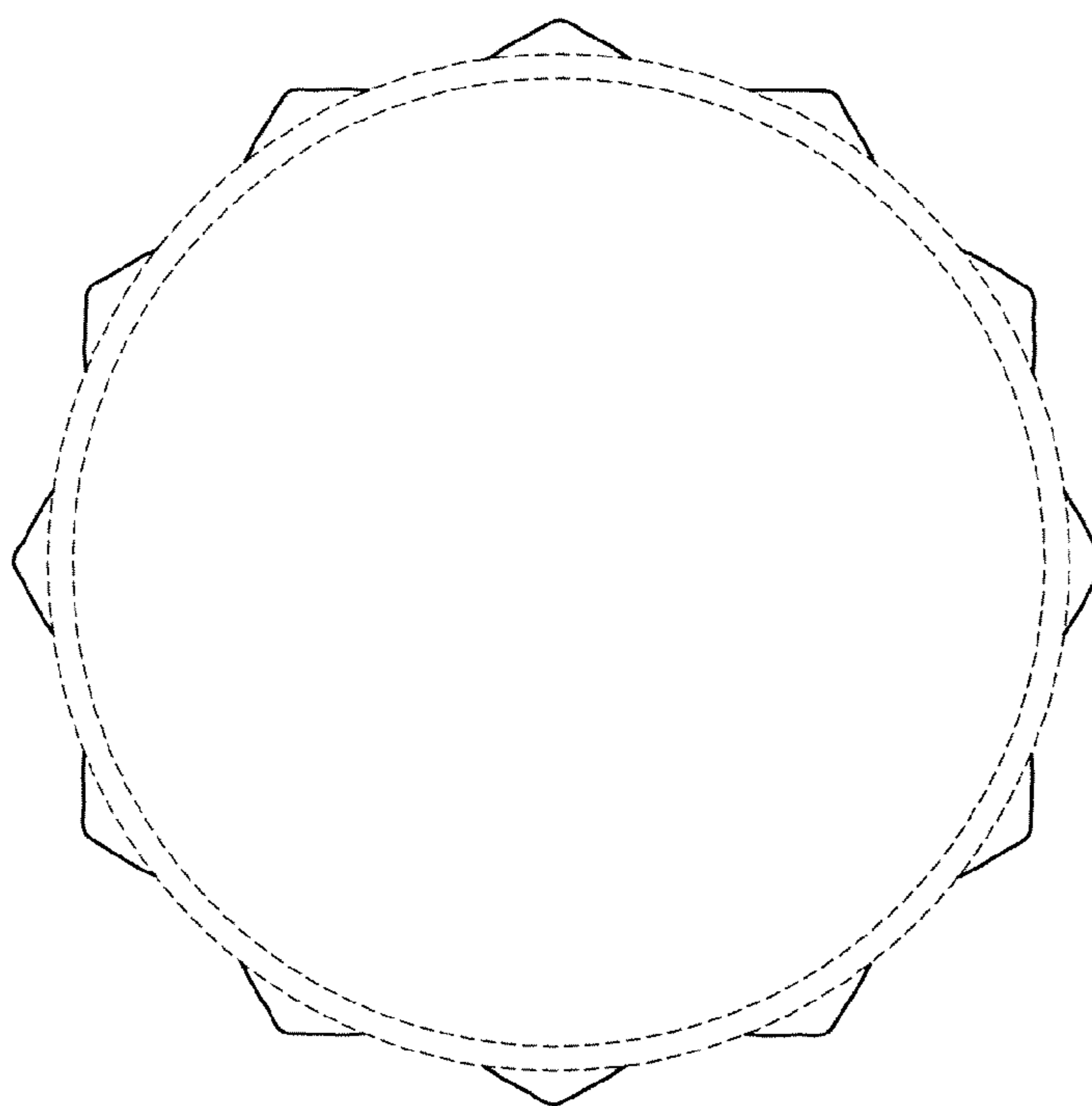
