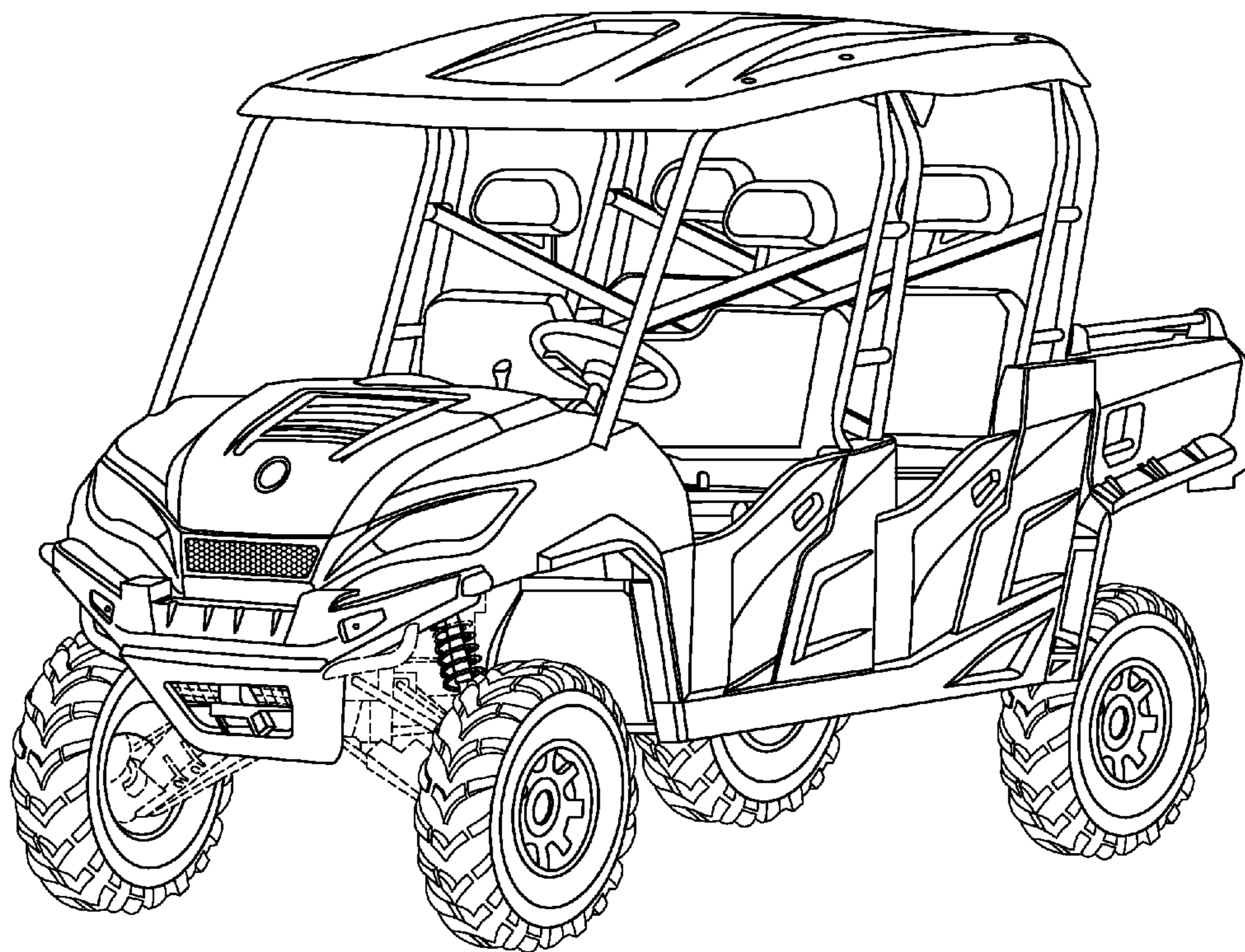
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of an all terrain vehicle according to the present invention;
FIG. 2 is a rear elevational view thereof of an all terrain vehicle according to the present invention;
FIG. 3 is a right side view elevation view of an all terrain vehicle according to the present invention;
FIG. 4 is a left side view elevation view of an all terrain vehicle according to the present invention;

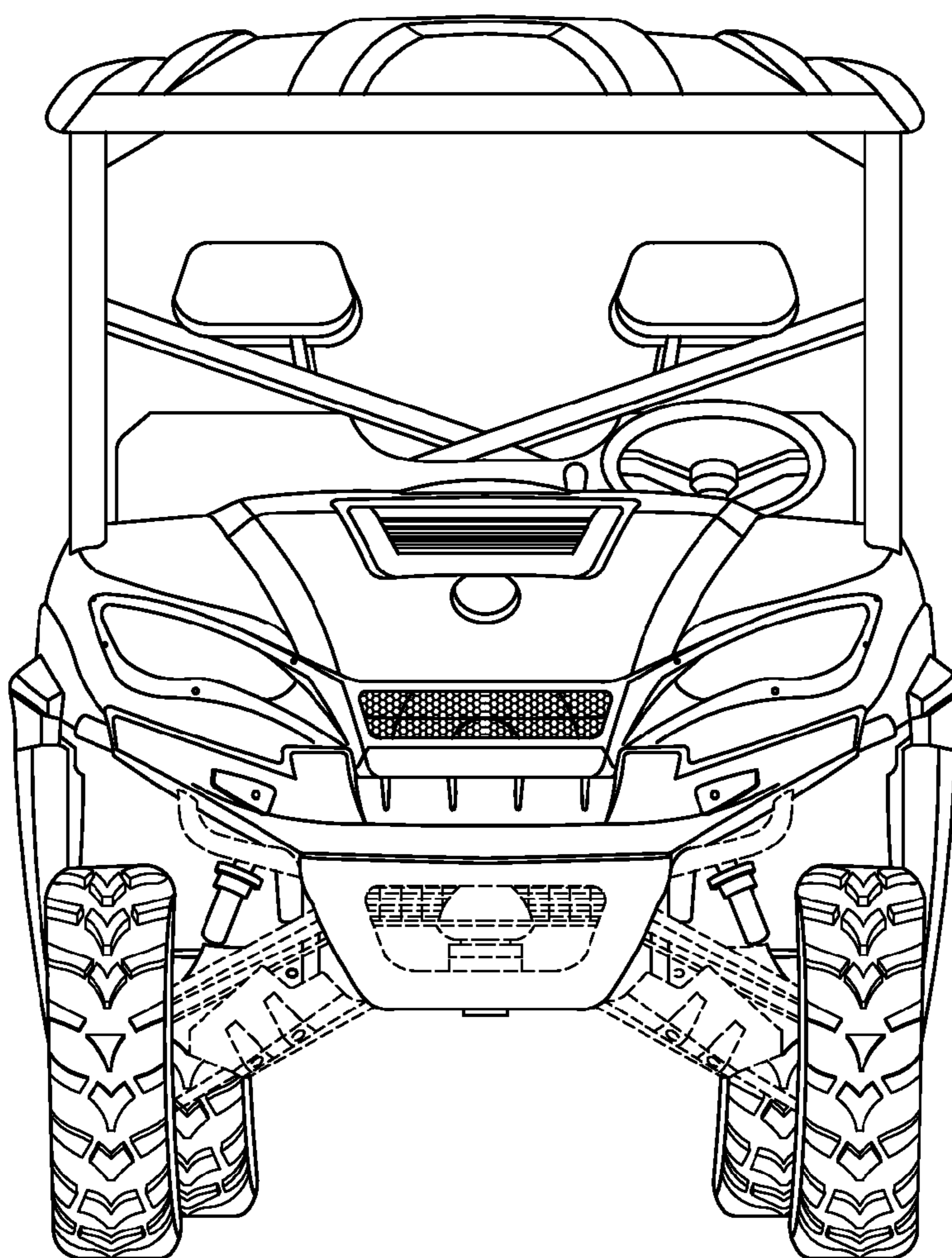

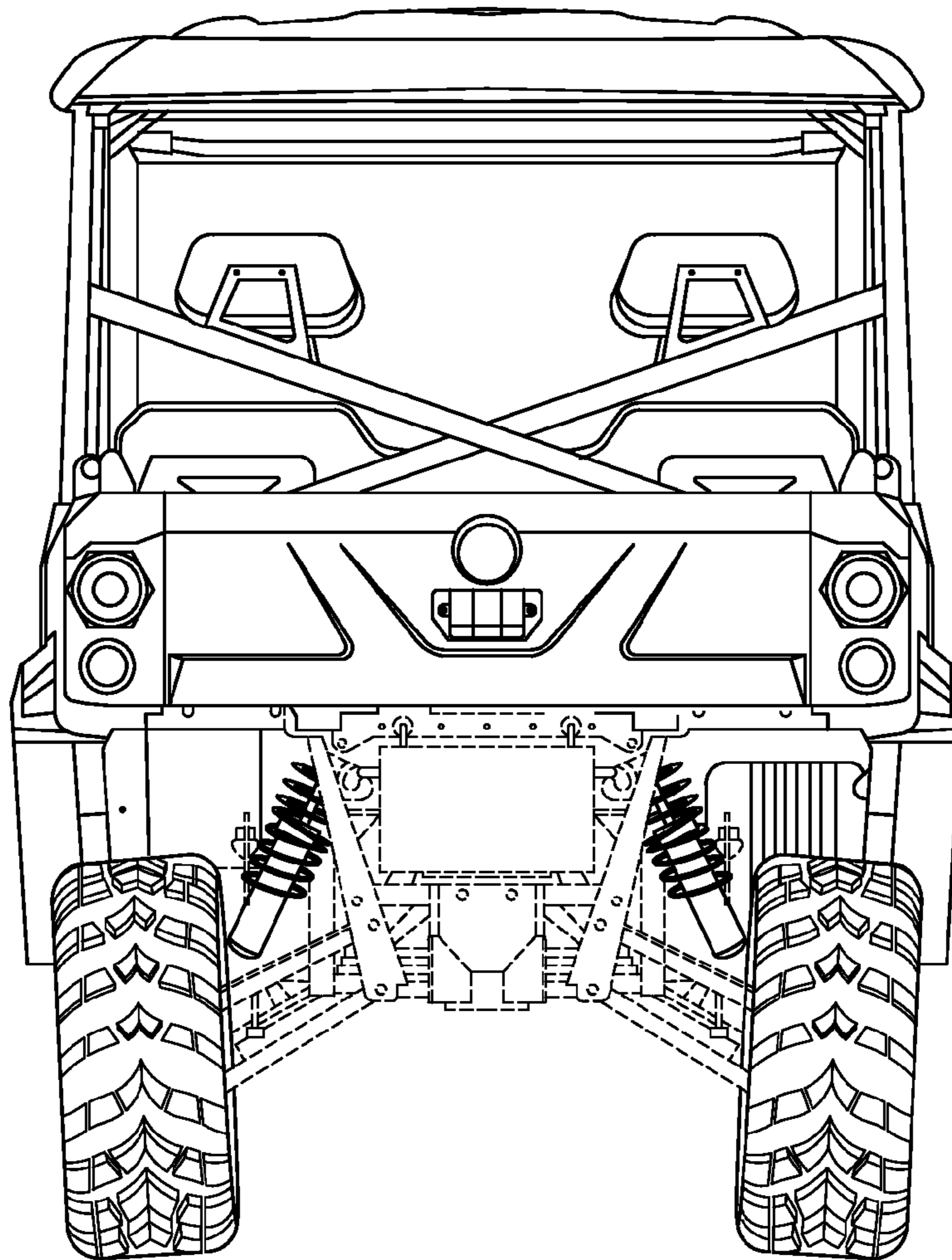

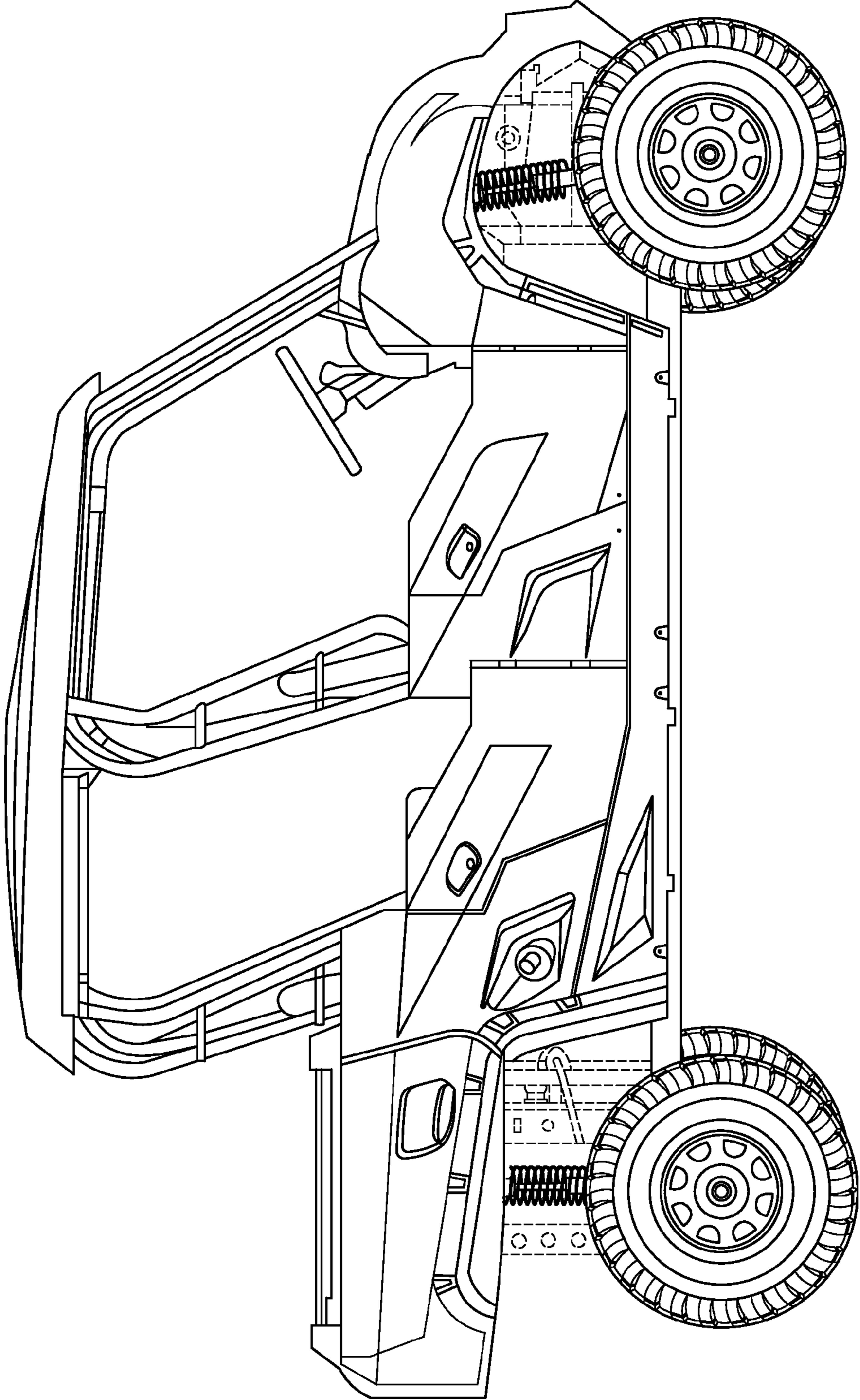

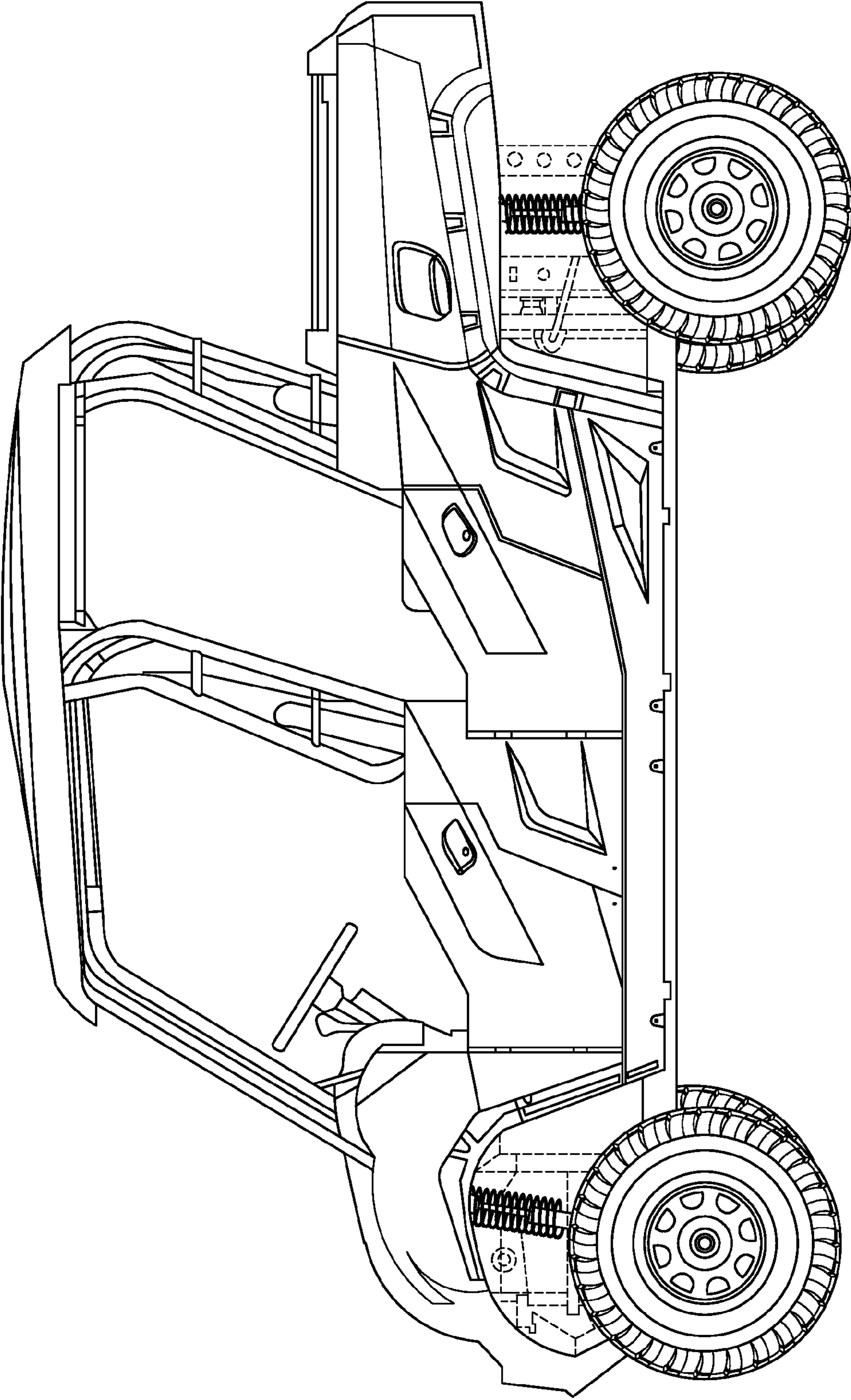

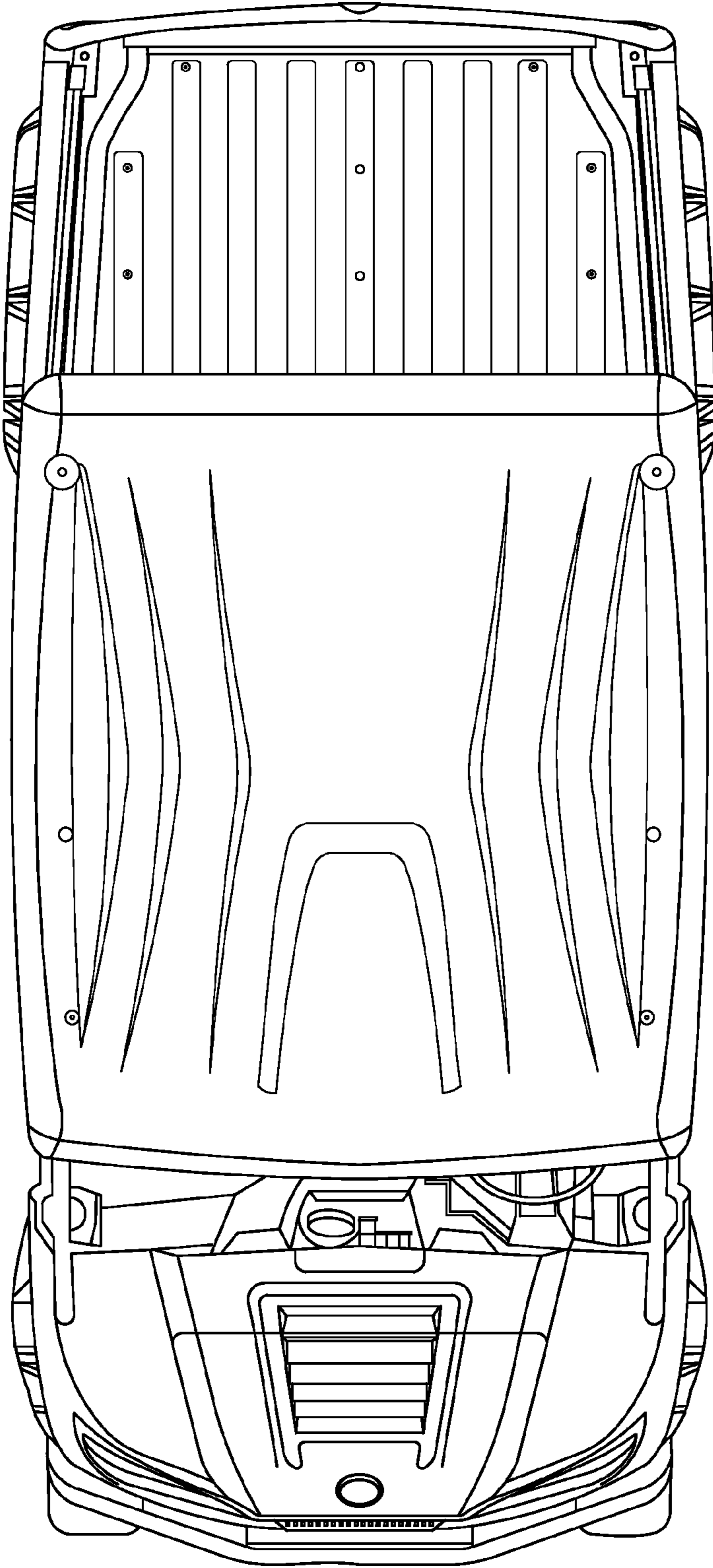

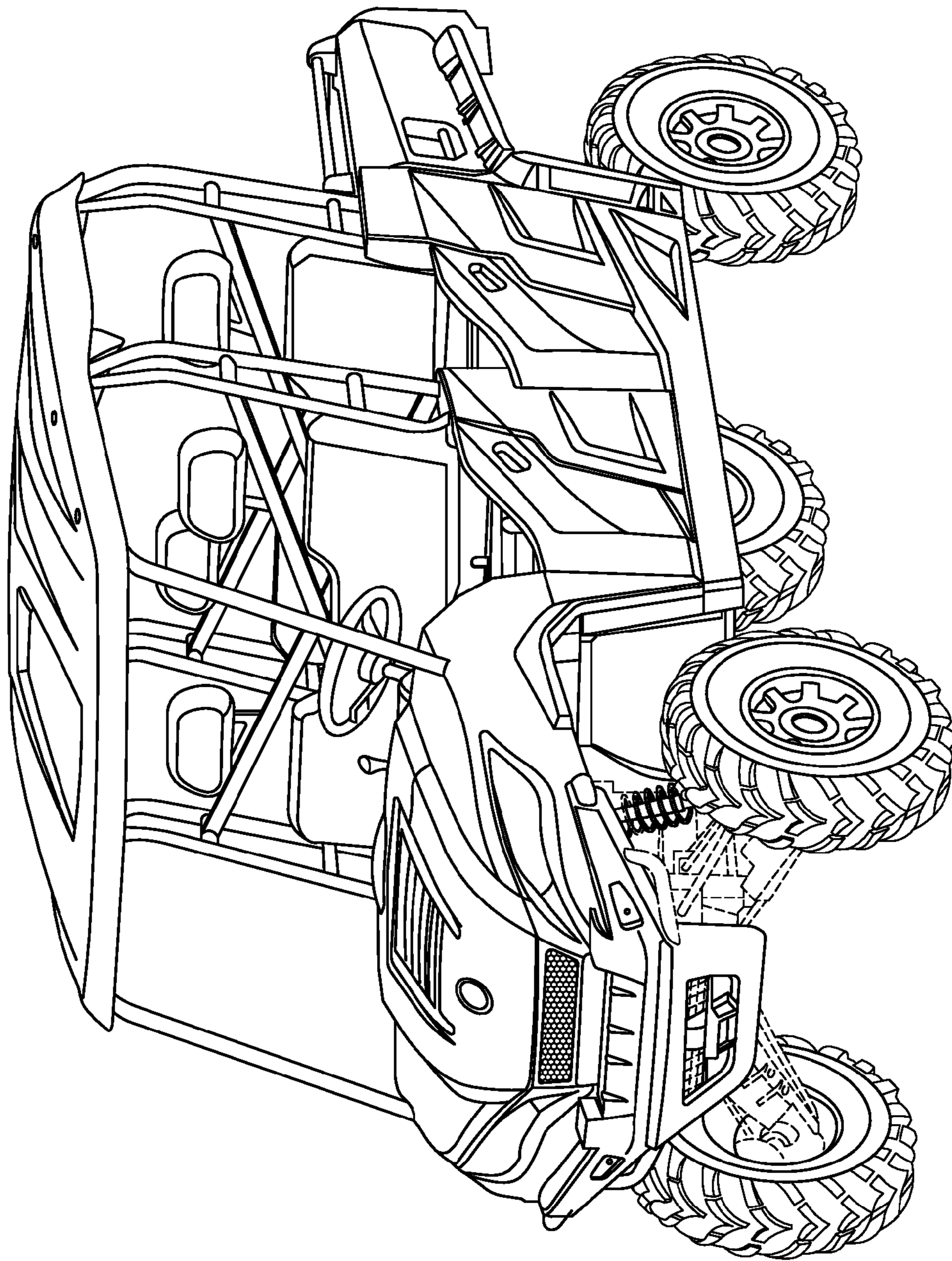
