The ornamental design for a motorcycle or motorcycle replica, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the right side of a motorcycle or motorcycle replica.

FIG. 2 is a perspective view from the left side thereof.

FIG. 3 is a perspective view from the right side thereof.

FIG. 4 is a perspective view from the left side thereof.

FIG. 5 is a front elevation view thereof.

FIG. 6 is a rear elevation view thereof.

FIG. 7 is a right side elevation view thereof.

FIG. 8 is a left side elevation view thereof.

FIG. 9 is a top plan view thereof; and,

FIG. 10 is a bottom plan view thereof.

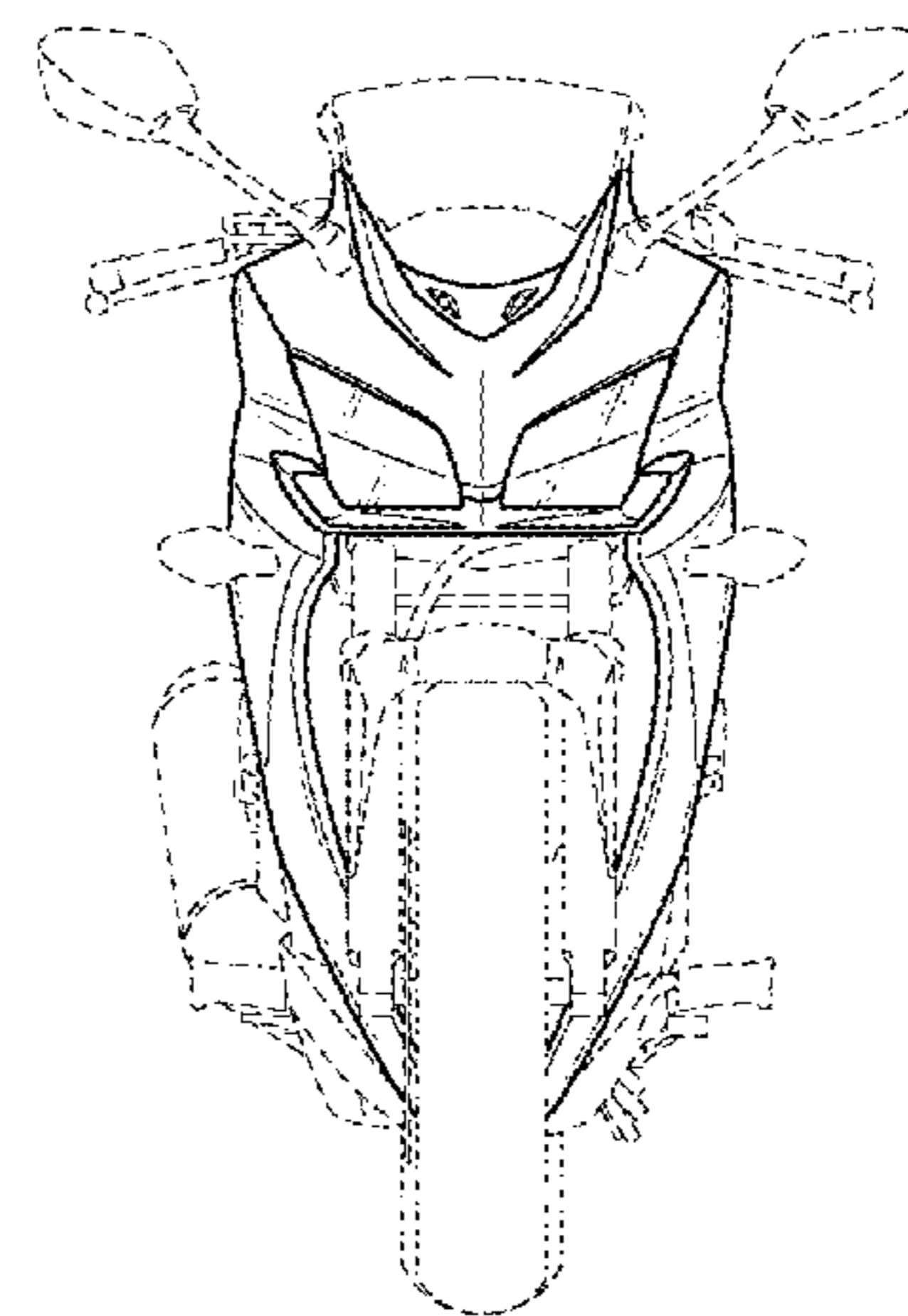
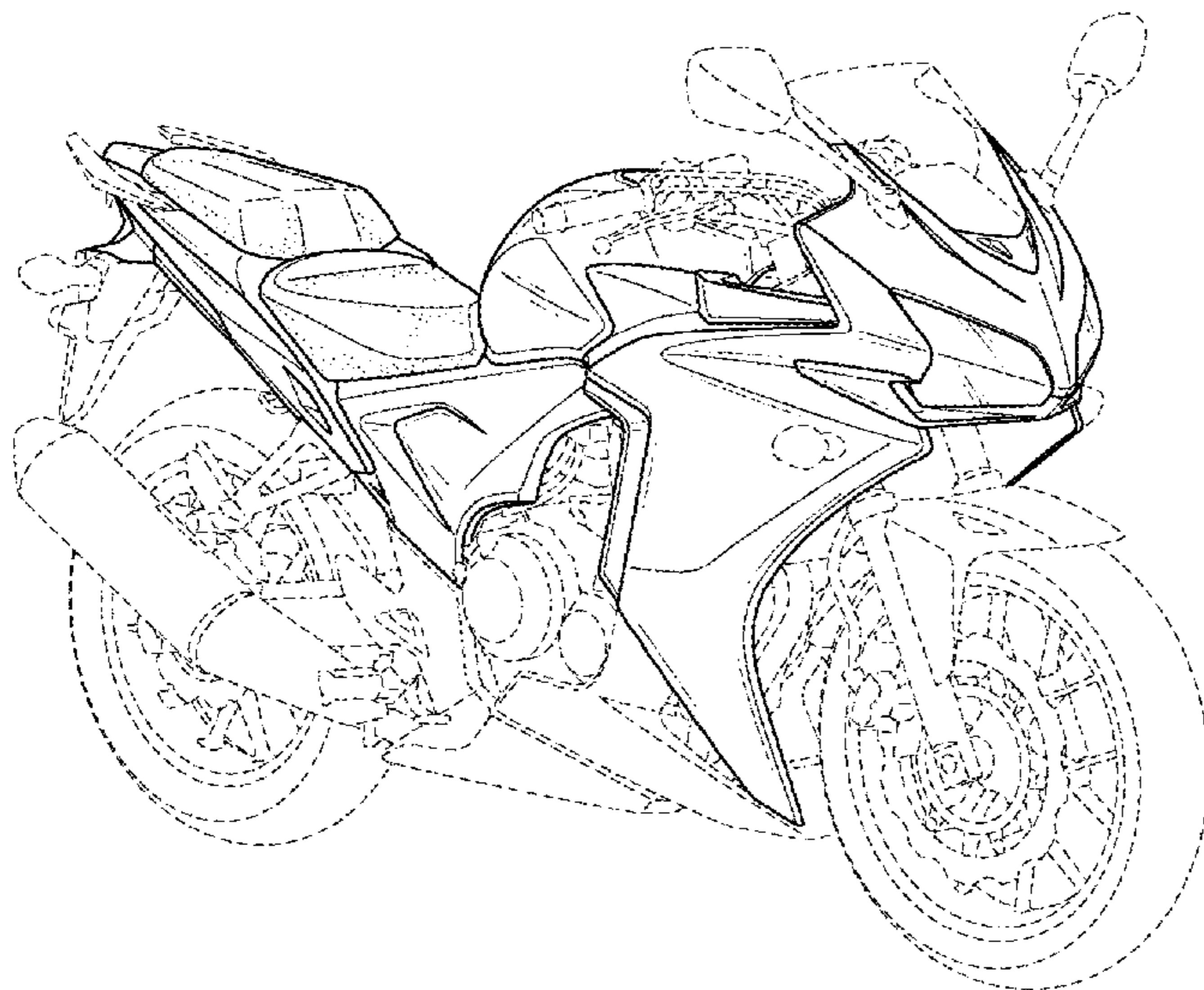

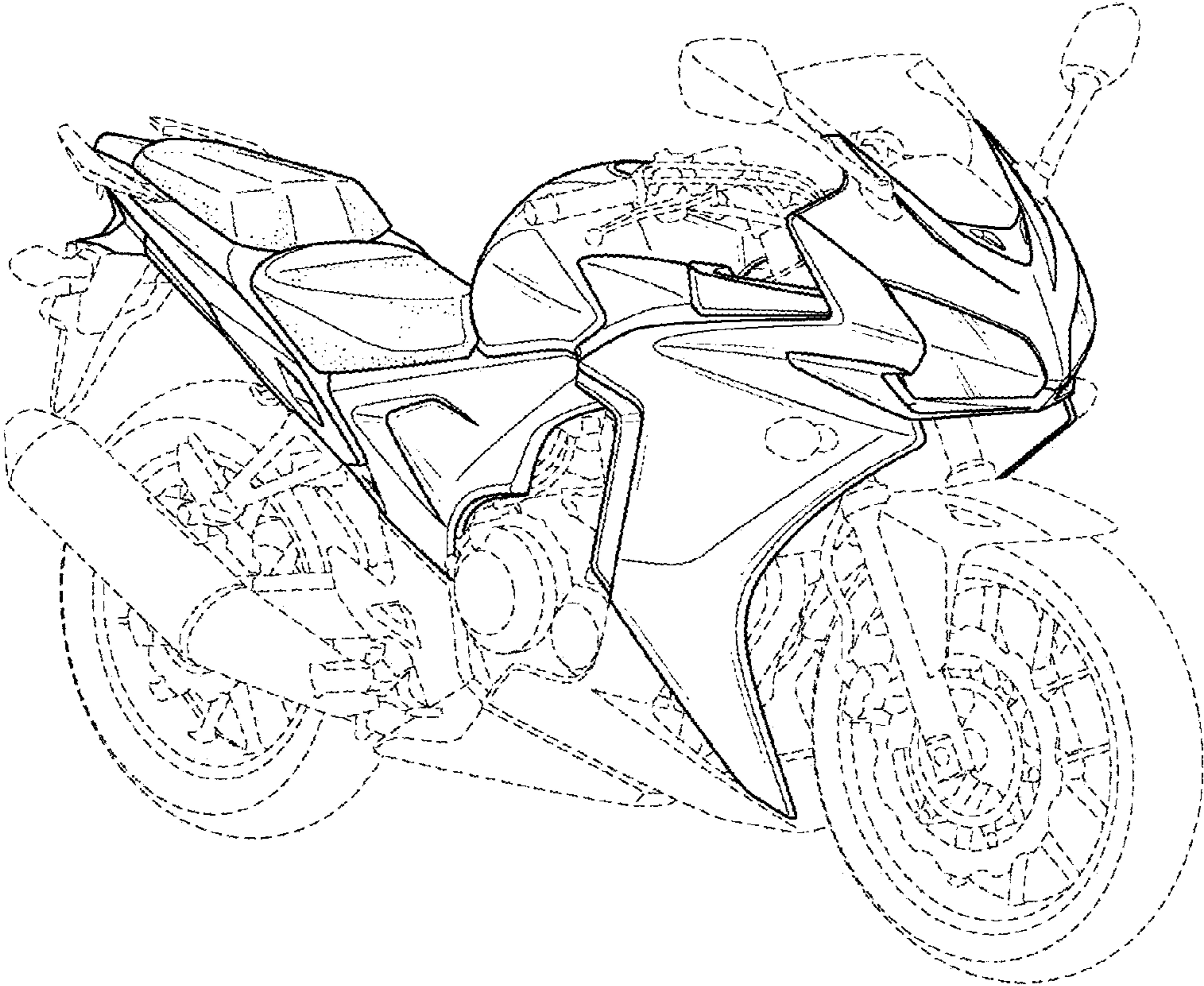

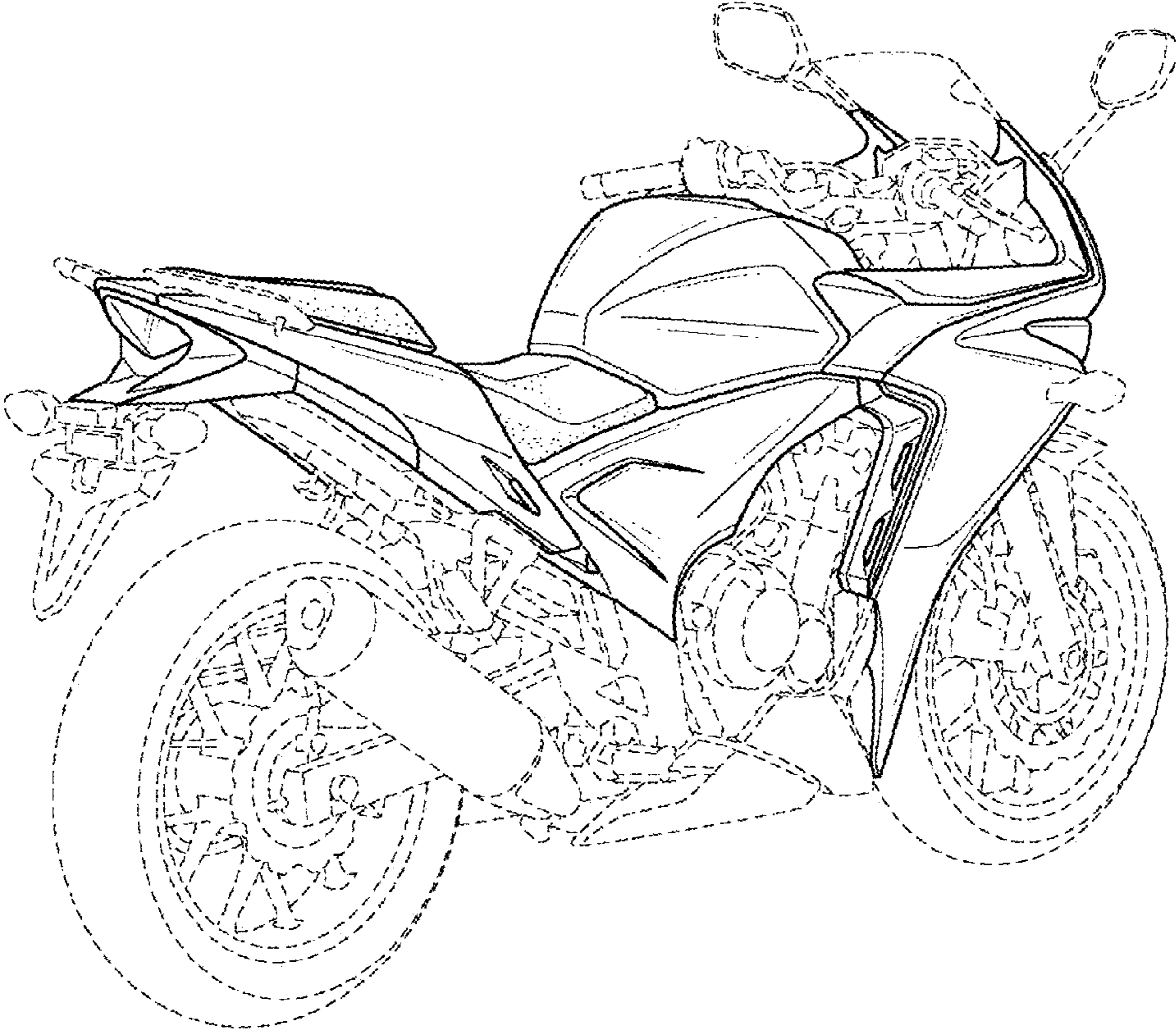

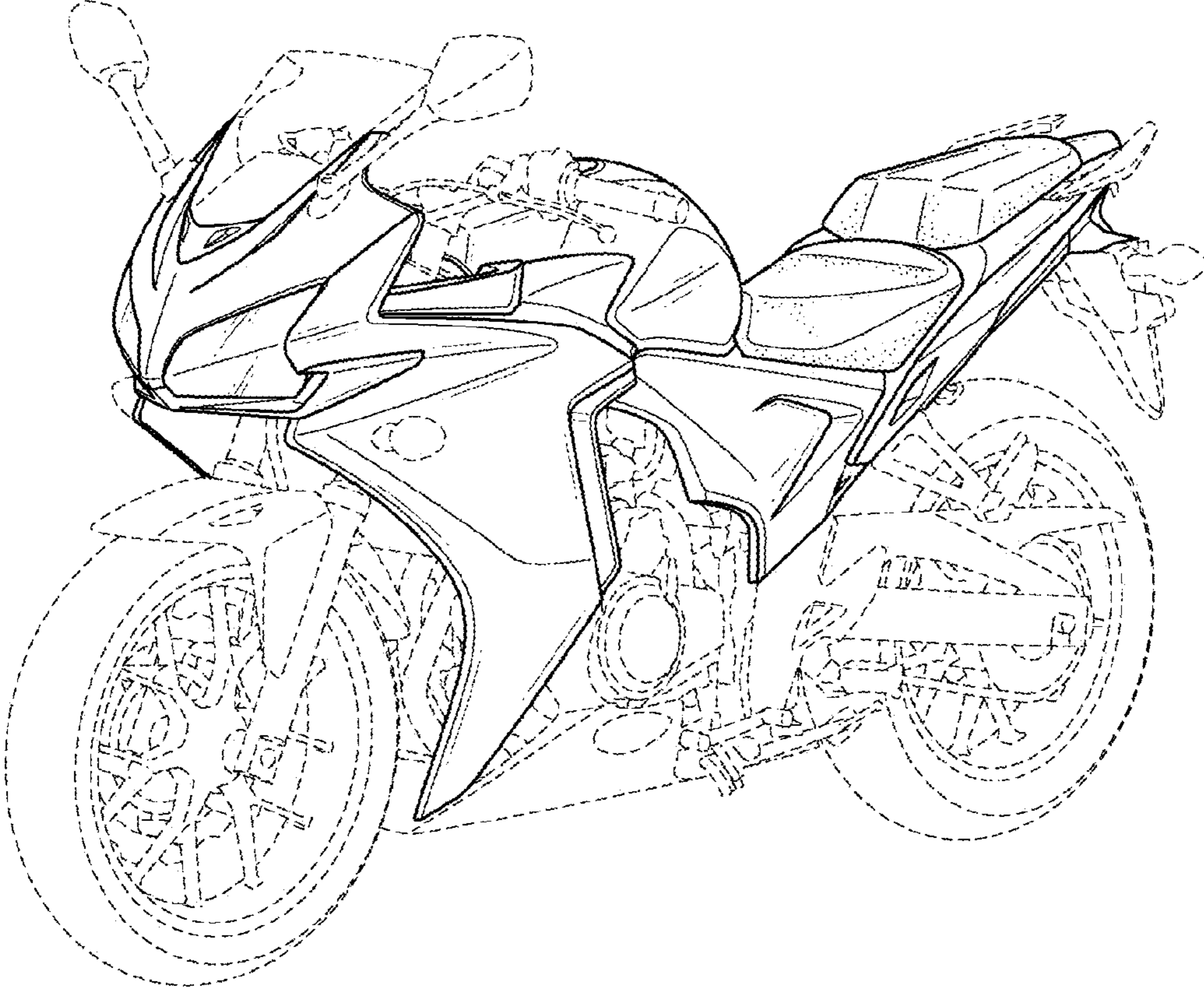

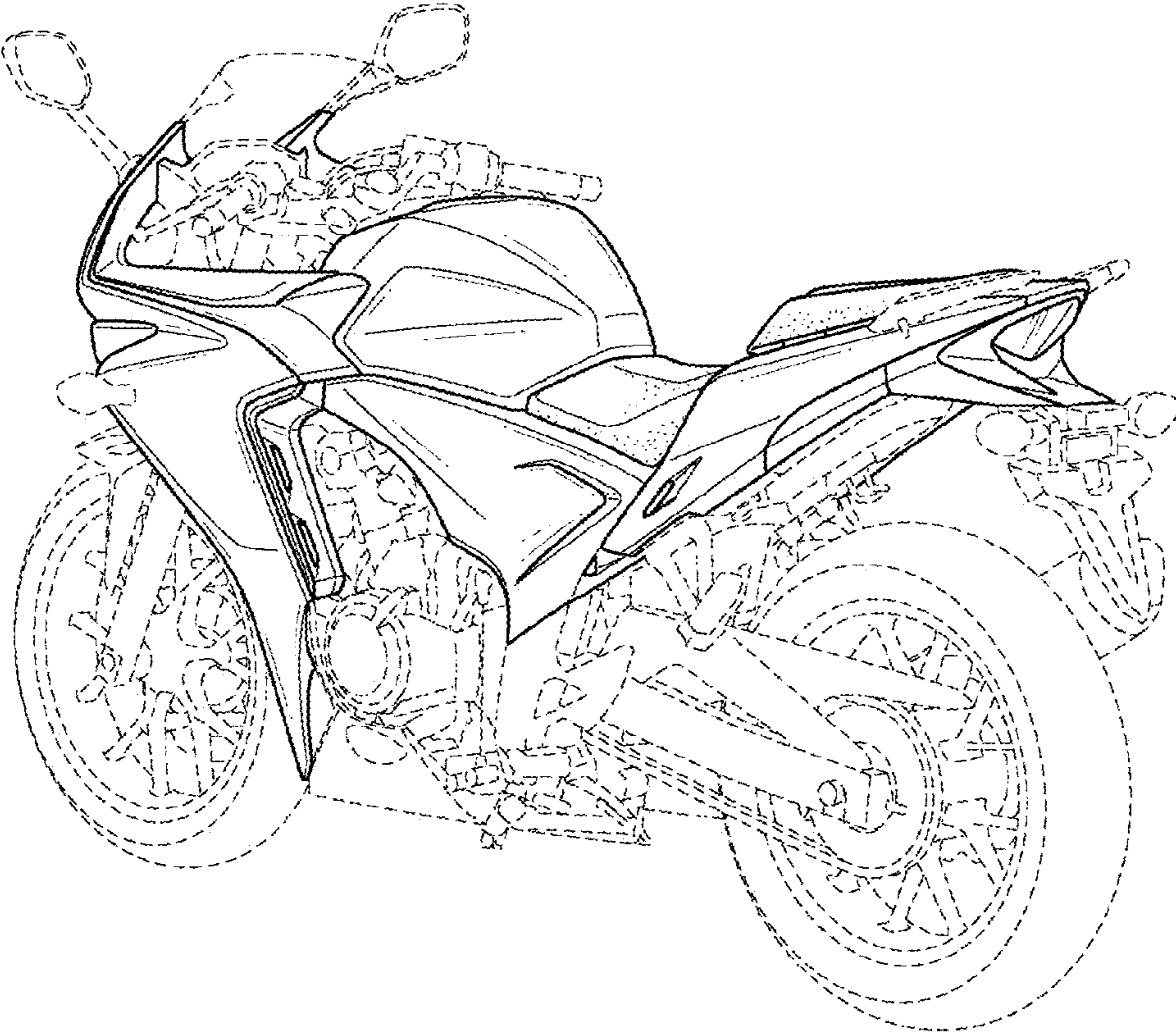

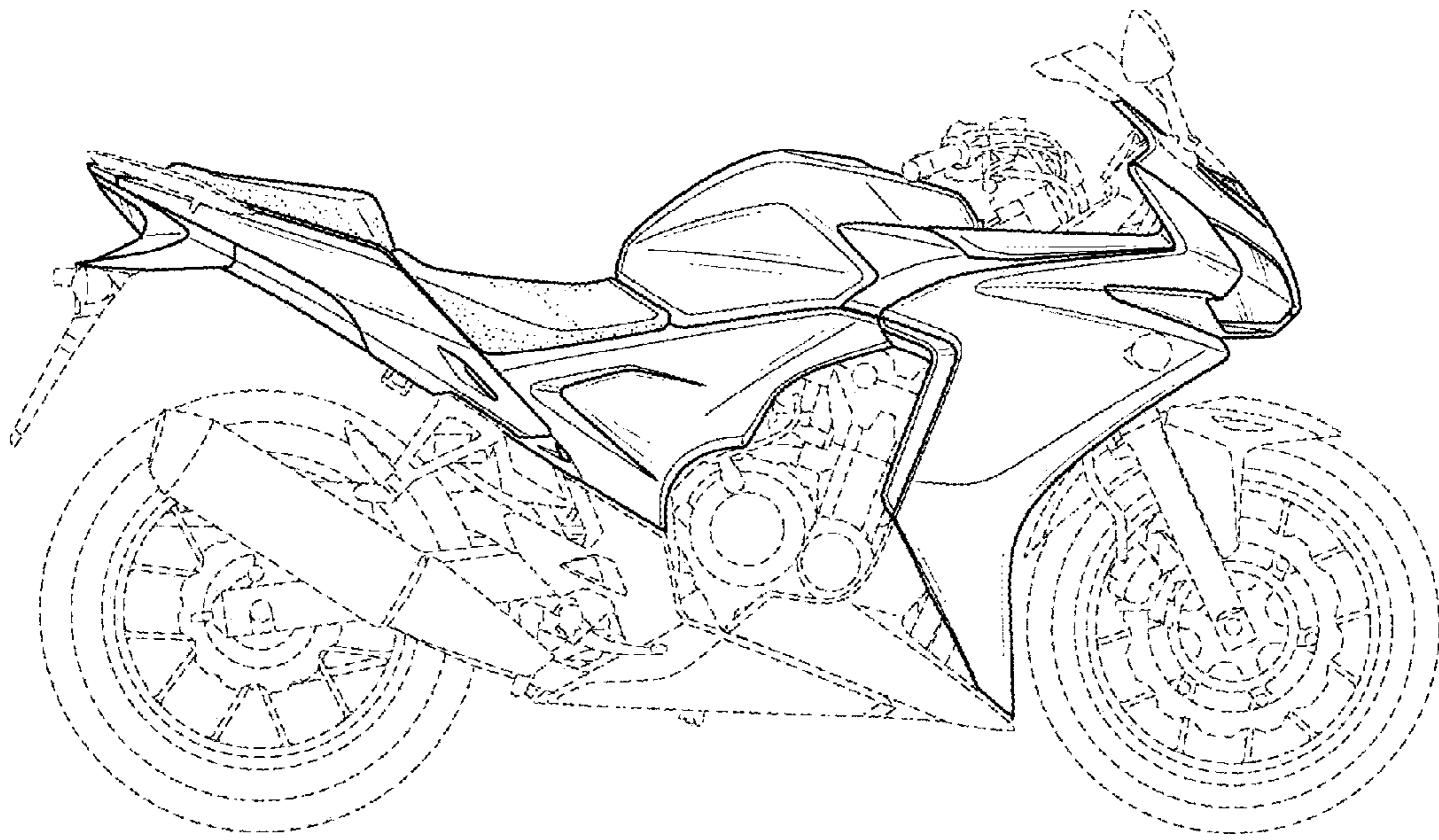

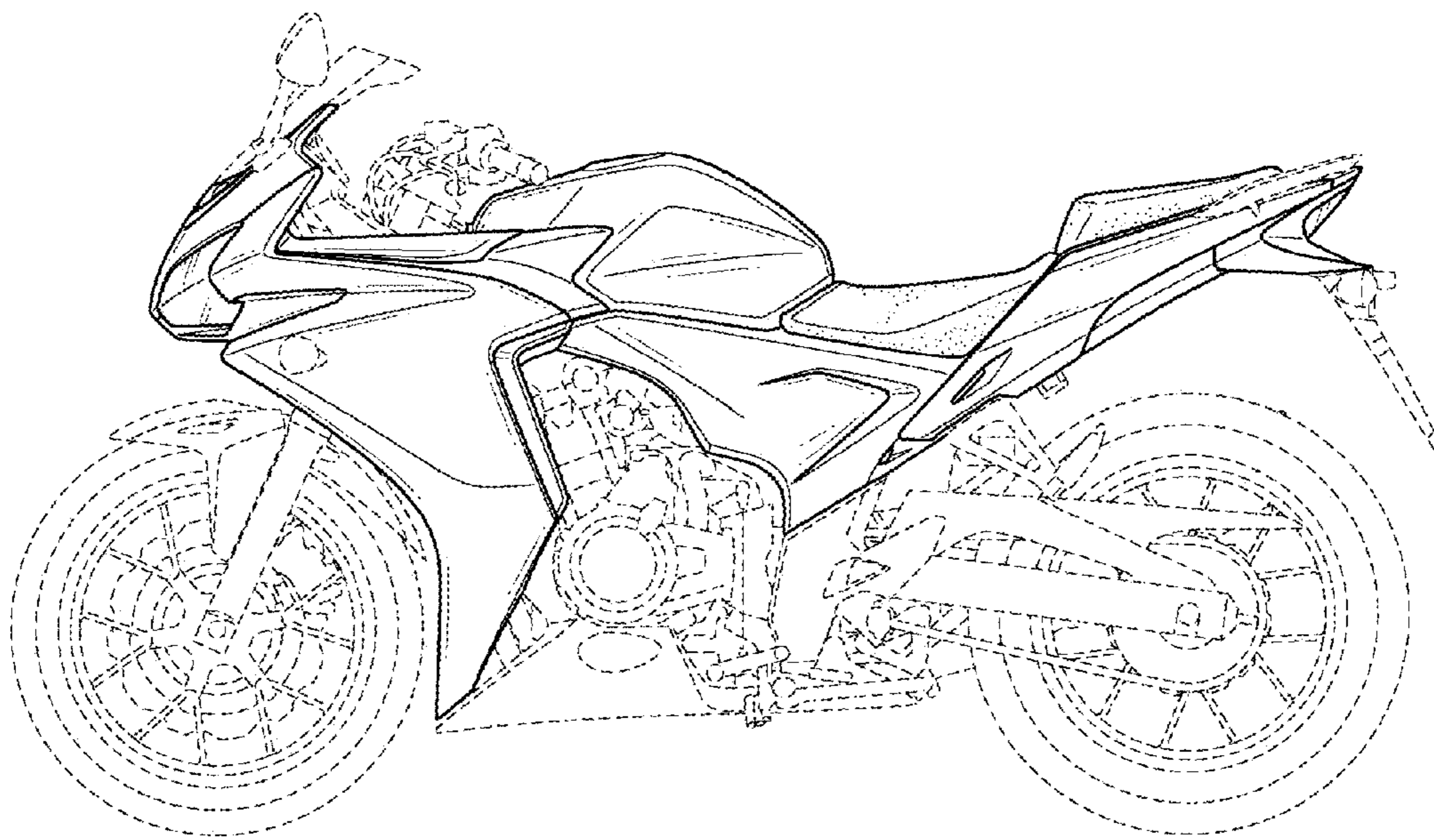

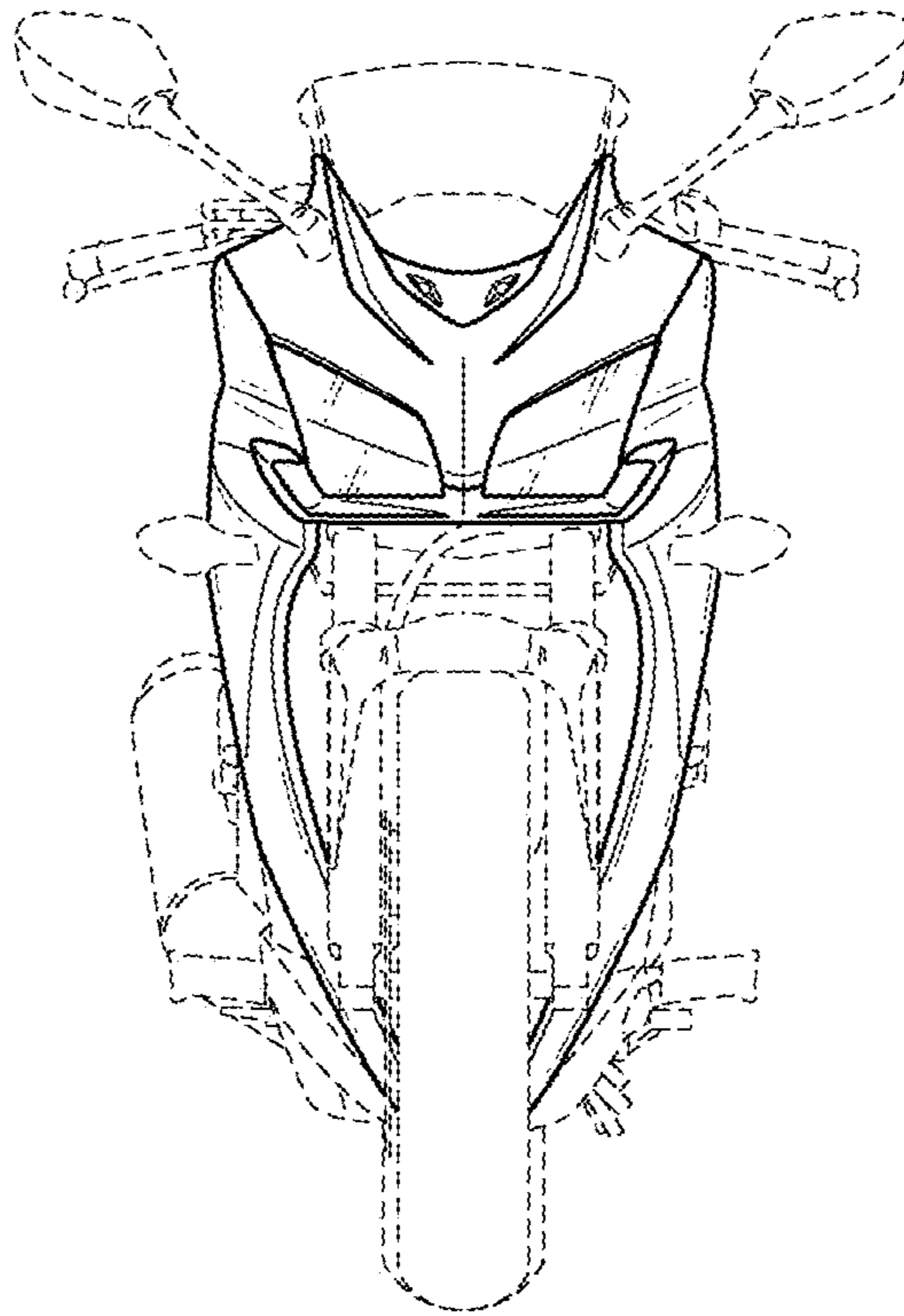

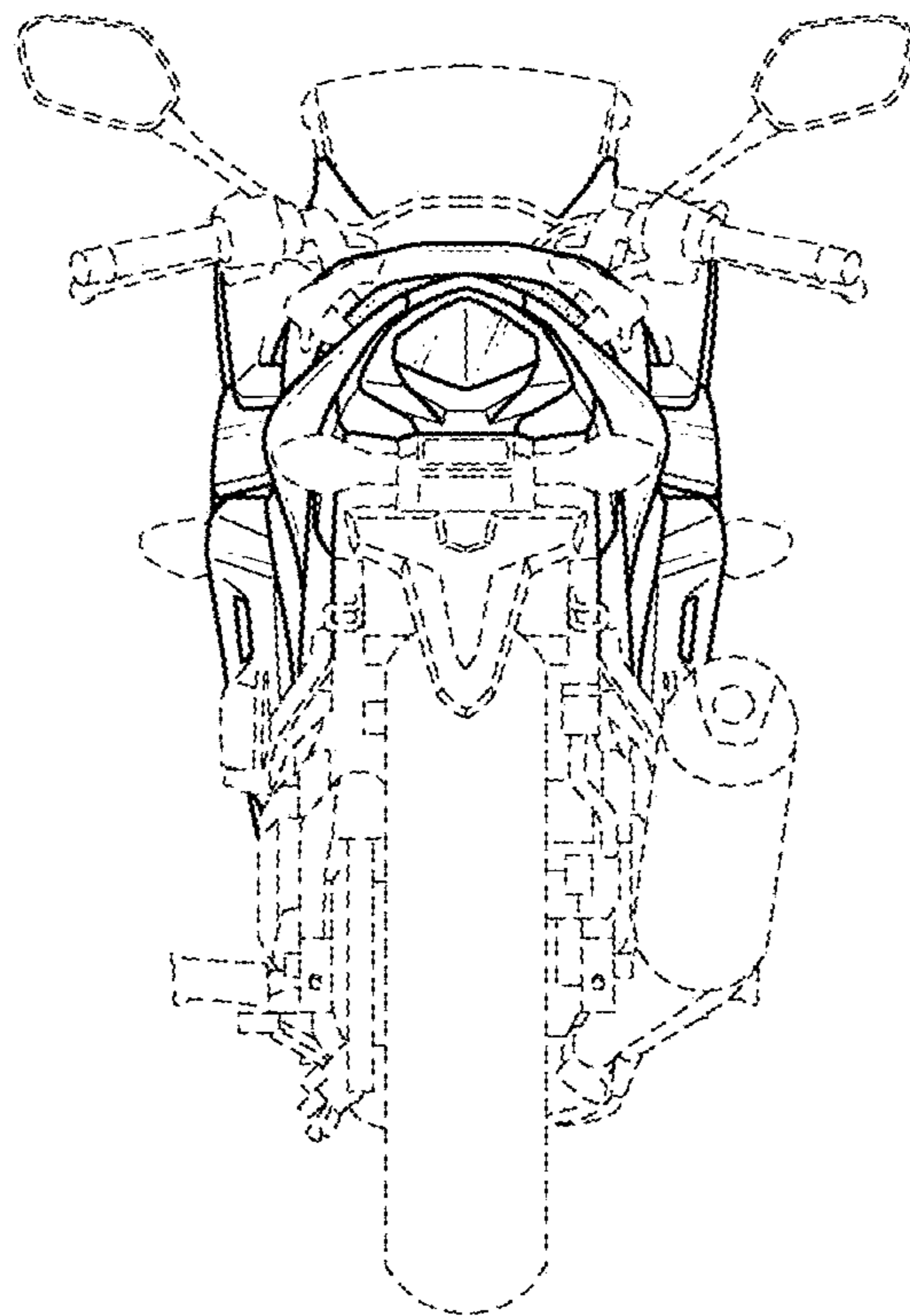

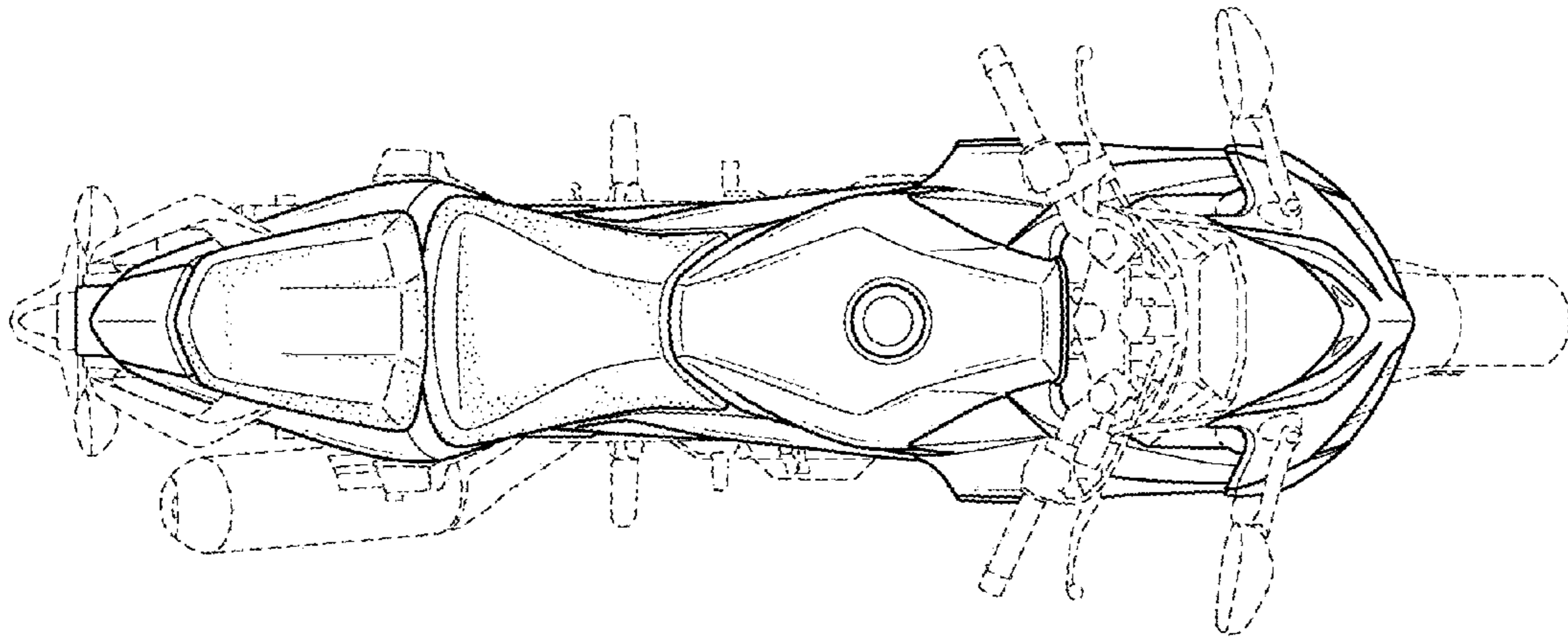
