DESCRIPTION

FIG. 1 is a front perspective view of a docking station showing our new design;
FIG. 2 is a front view of the docking station of FIG. 1;
FIG. 3 is a rear view of the docking station of FIG. 1;
FIG. 4 is a left-side view of the docking station of FIG. 1;
FIG. 5 is a right-side view of the docking station of FIG. 1;
FIG. 6 is a top plan view of the docking station of FIG. 1;
FIG. 7 is a bottom plan view of the docking station of FIG. 1;

FIG. 8 is a right-side view of the docking station of FIG. 1 in a folded state.

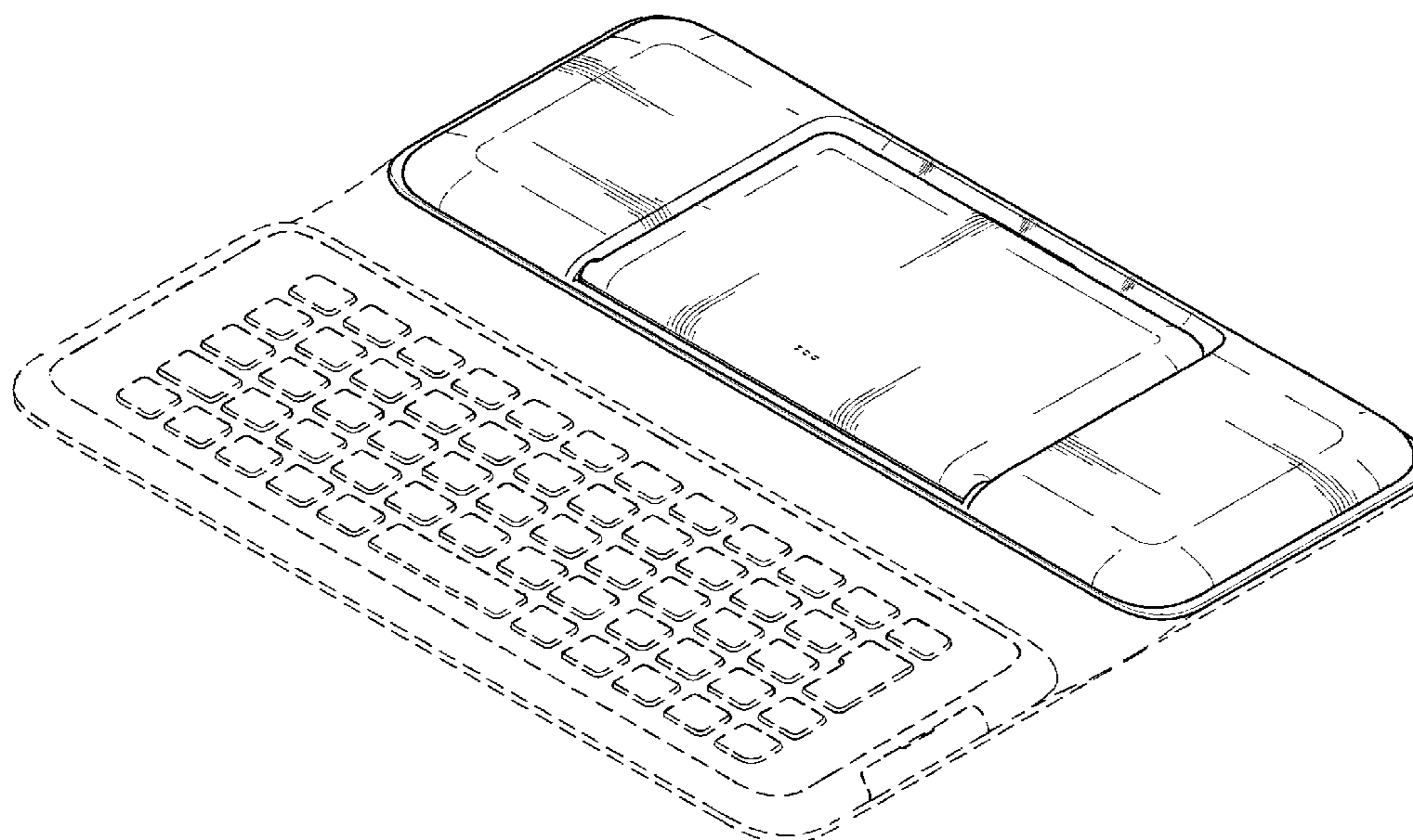

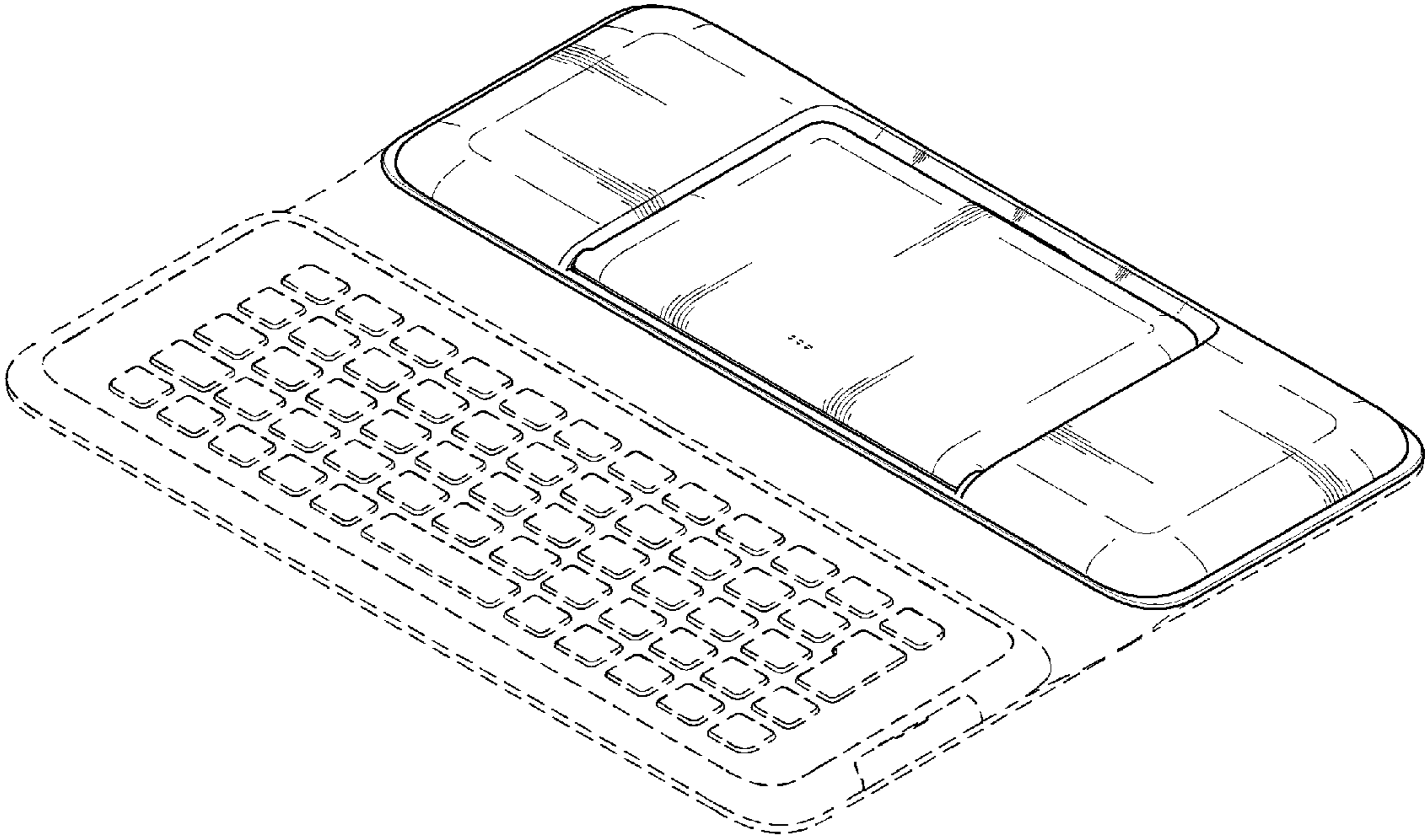

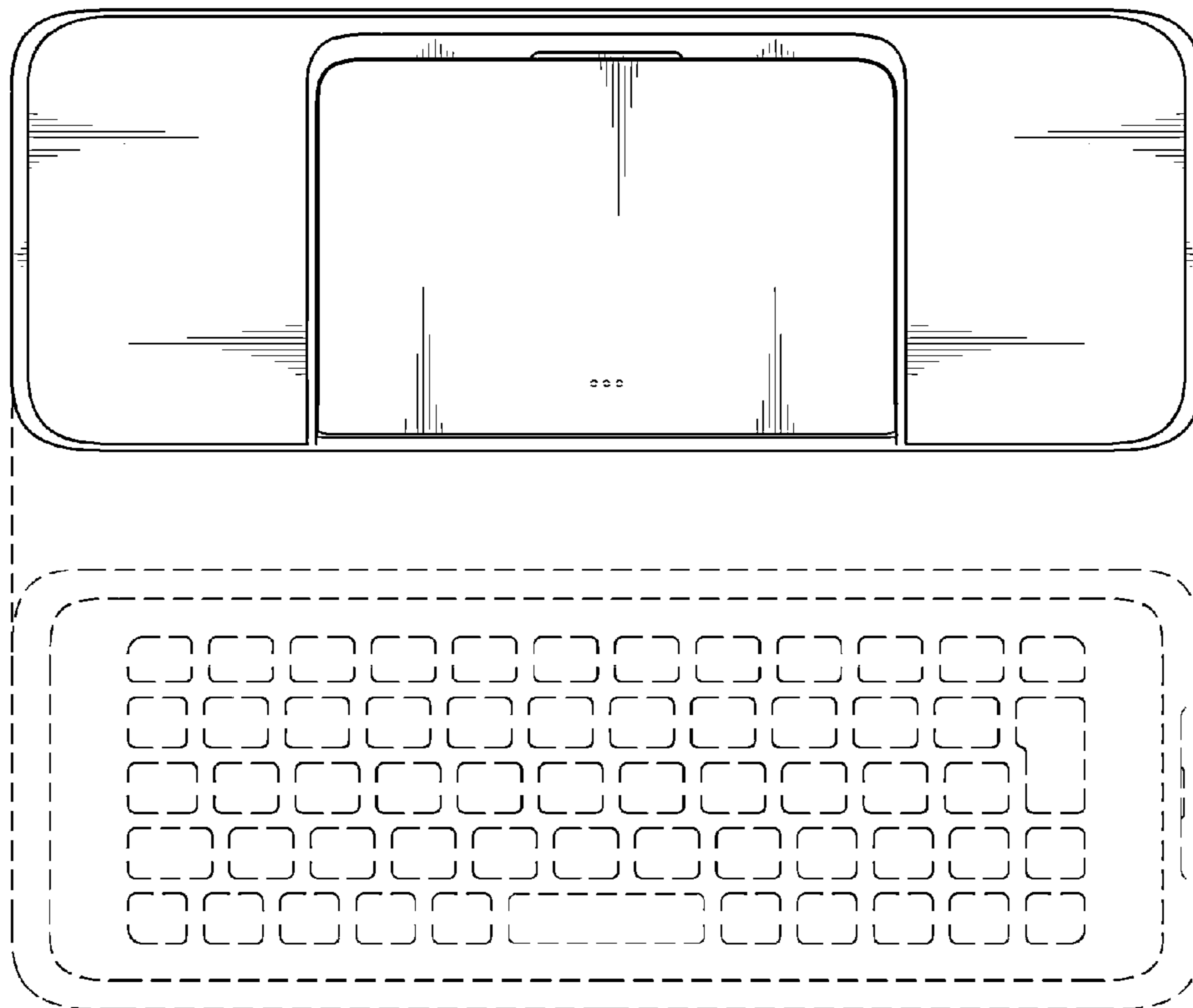

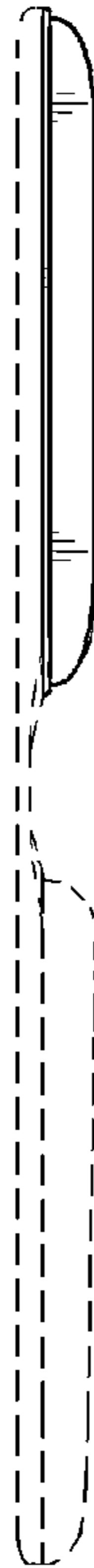

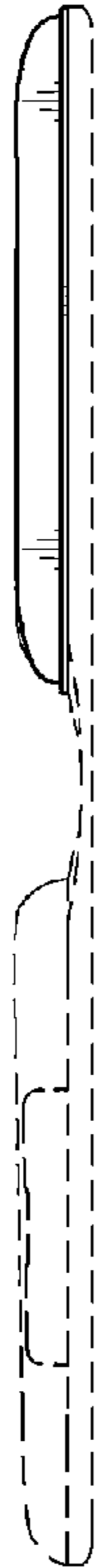

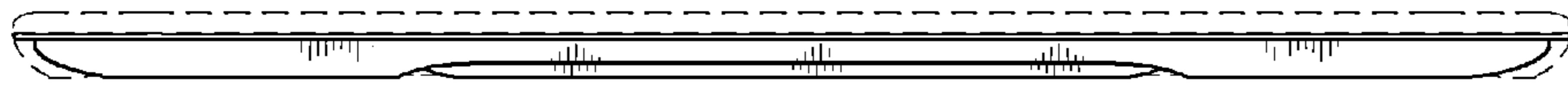

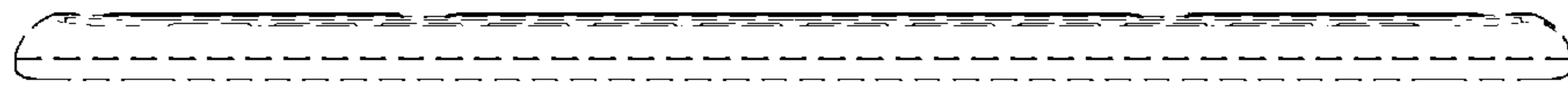
