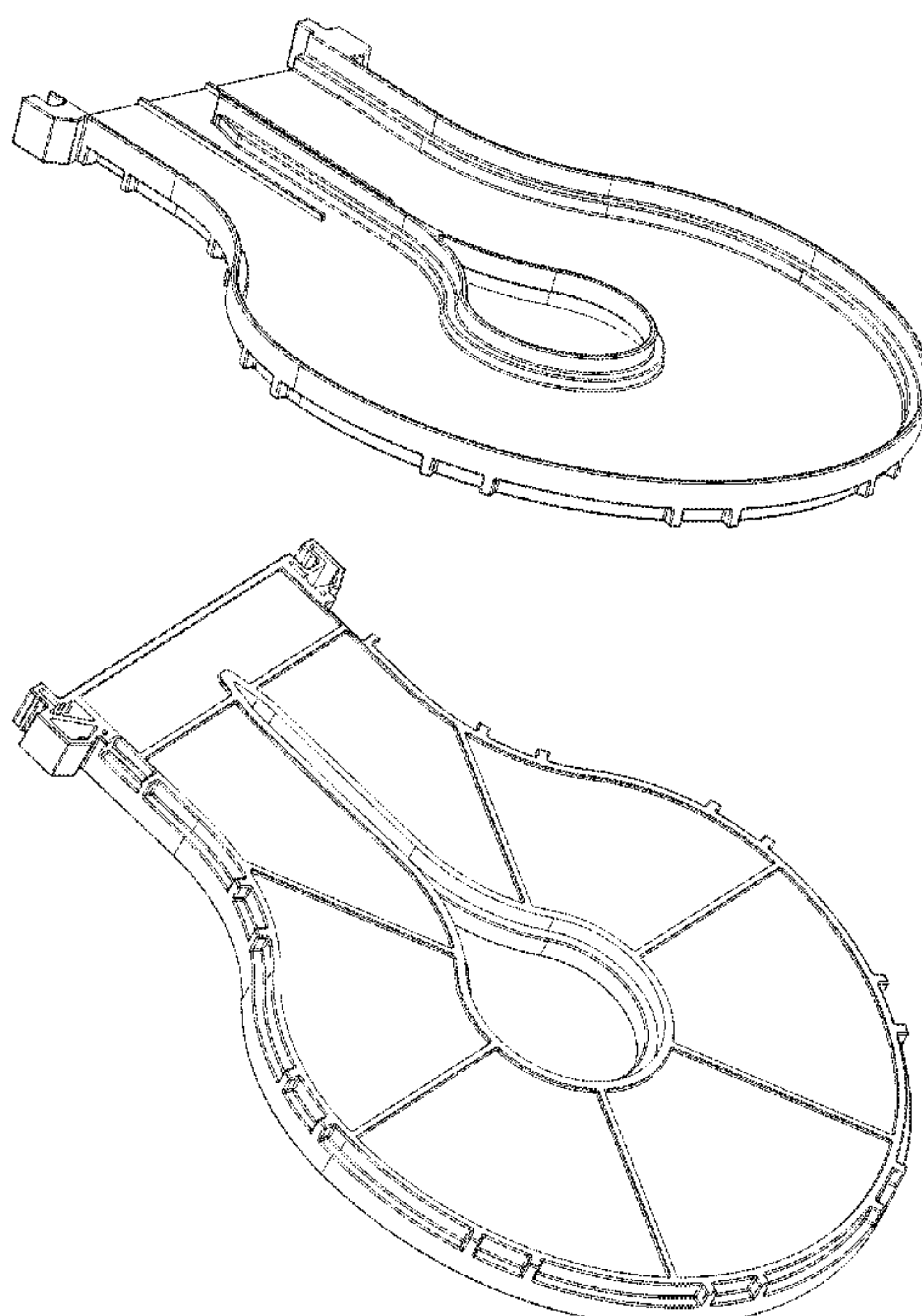
(57) **CLAIM**

The ornamental design for a cul-de-sac track component, as shown and described.

**DESCRIPTION**

FIG. 1 is a front-top perspective view showing a cul-de-sac track component of the toy track set of FIG. 1; FIG. 2 is a bottom-front perspective view of FIG. 1; FIG. 3 is a top-rear perspective view of FIG. 1; FIG. 4 is a bottom-rear perspective view of FIG. 1; FIG. 5 is a top side view of FIG. 1; FIG. 6 is a bottom side view of FIG. 1; FIG. 7 is a front side view of FIG. 1; FIG. 8 is a rear side view of FIG. 1; FIG. 9 is a left side view of FIG. 1; FIG. 10 is a right side view of FIG. 1; and, FIG. 11 is a cross-sectional view taken from line 11-11 of FIG. 1.

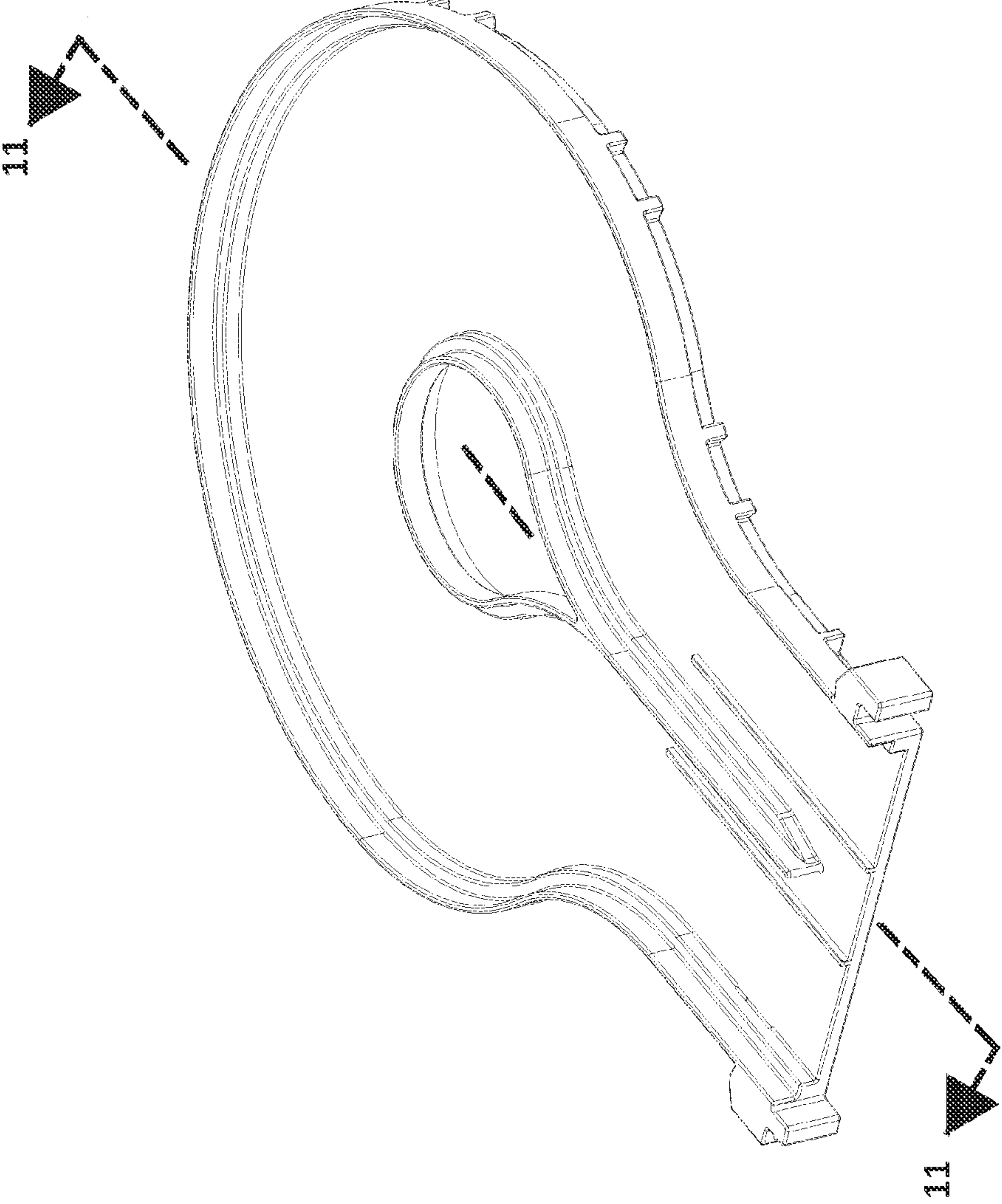

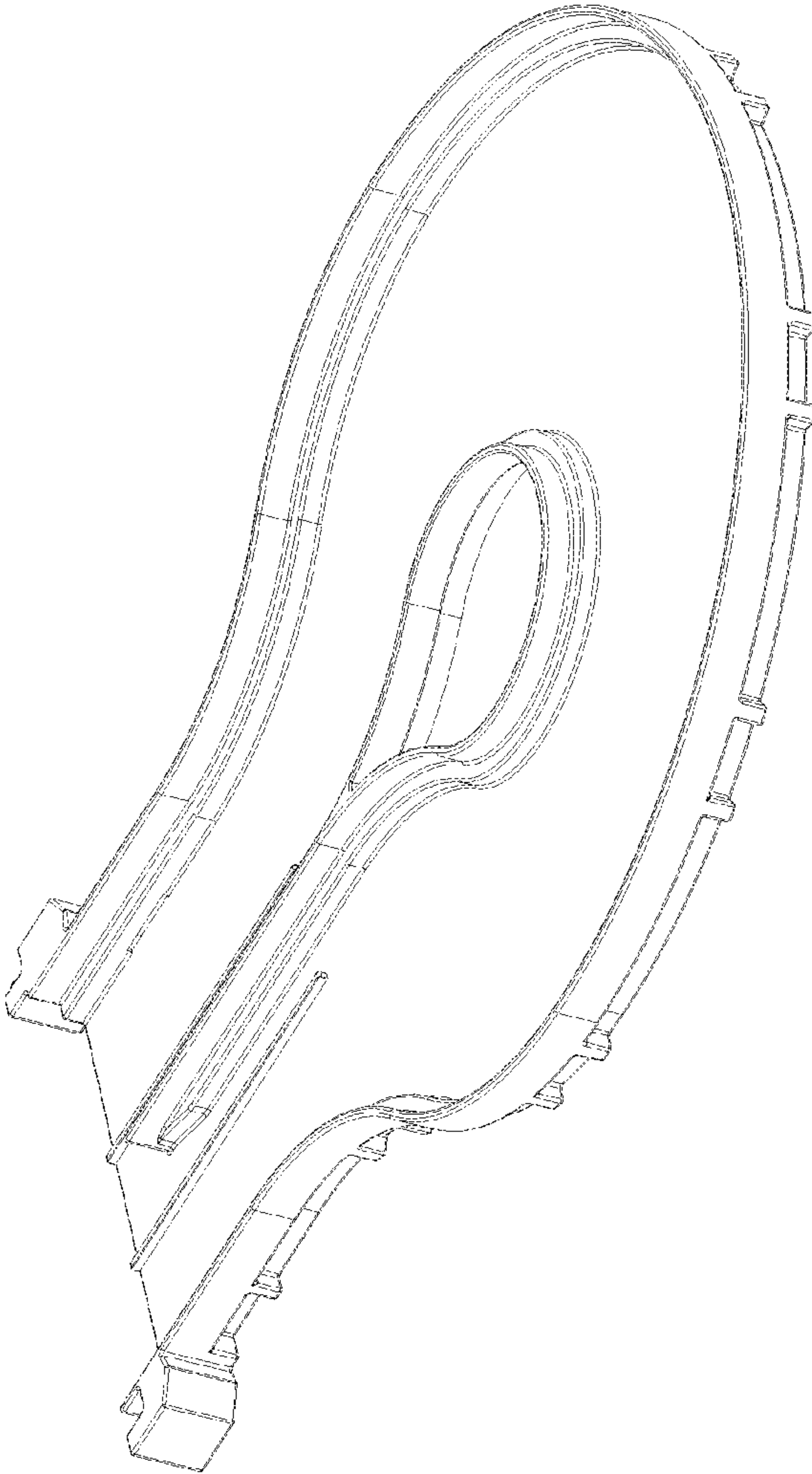

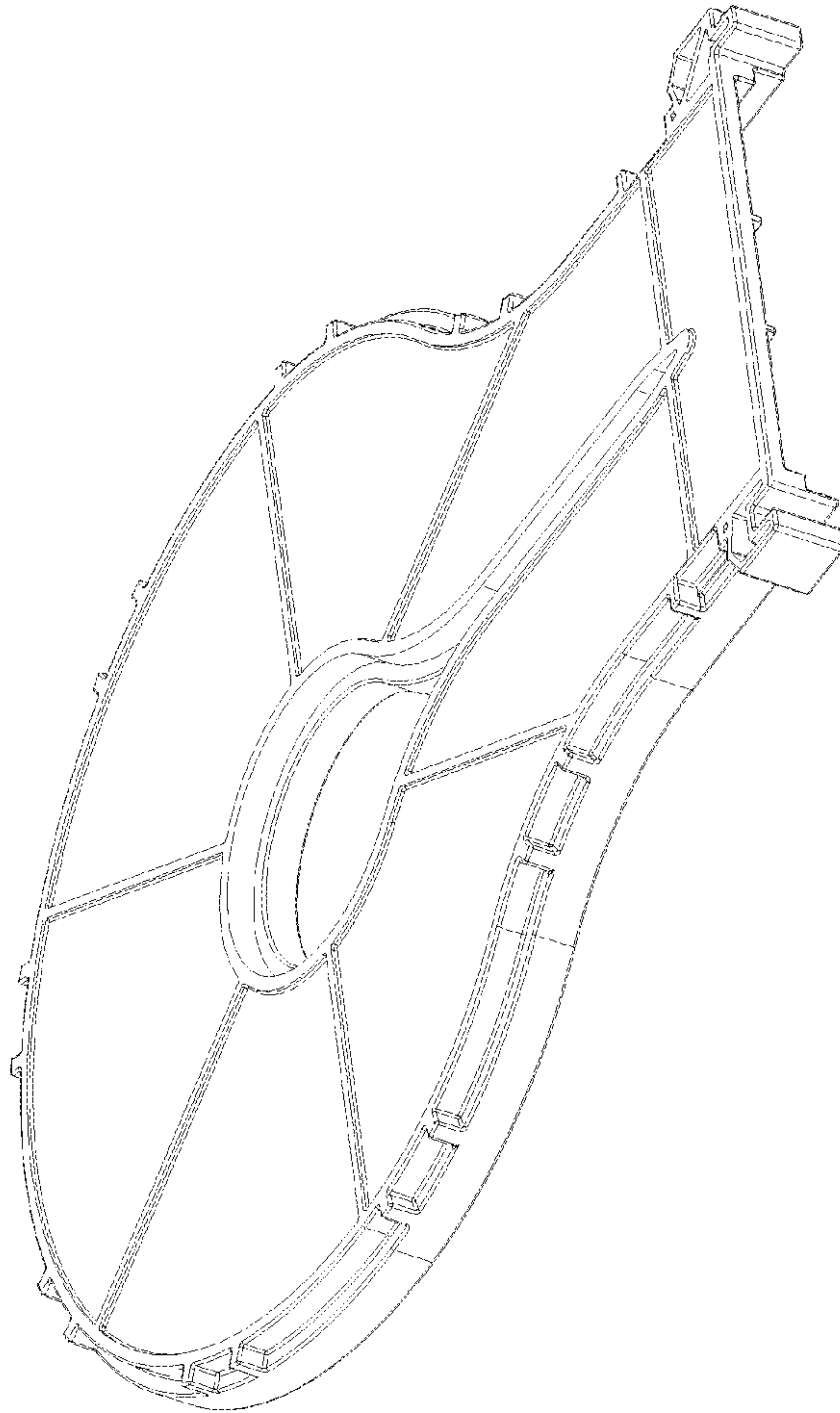

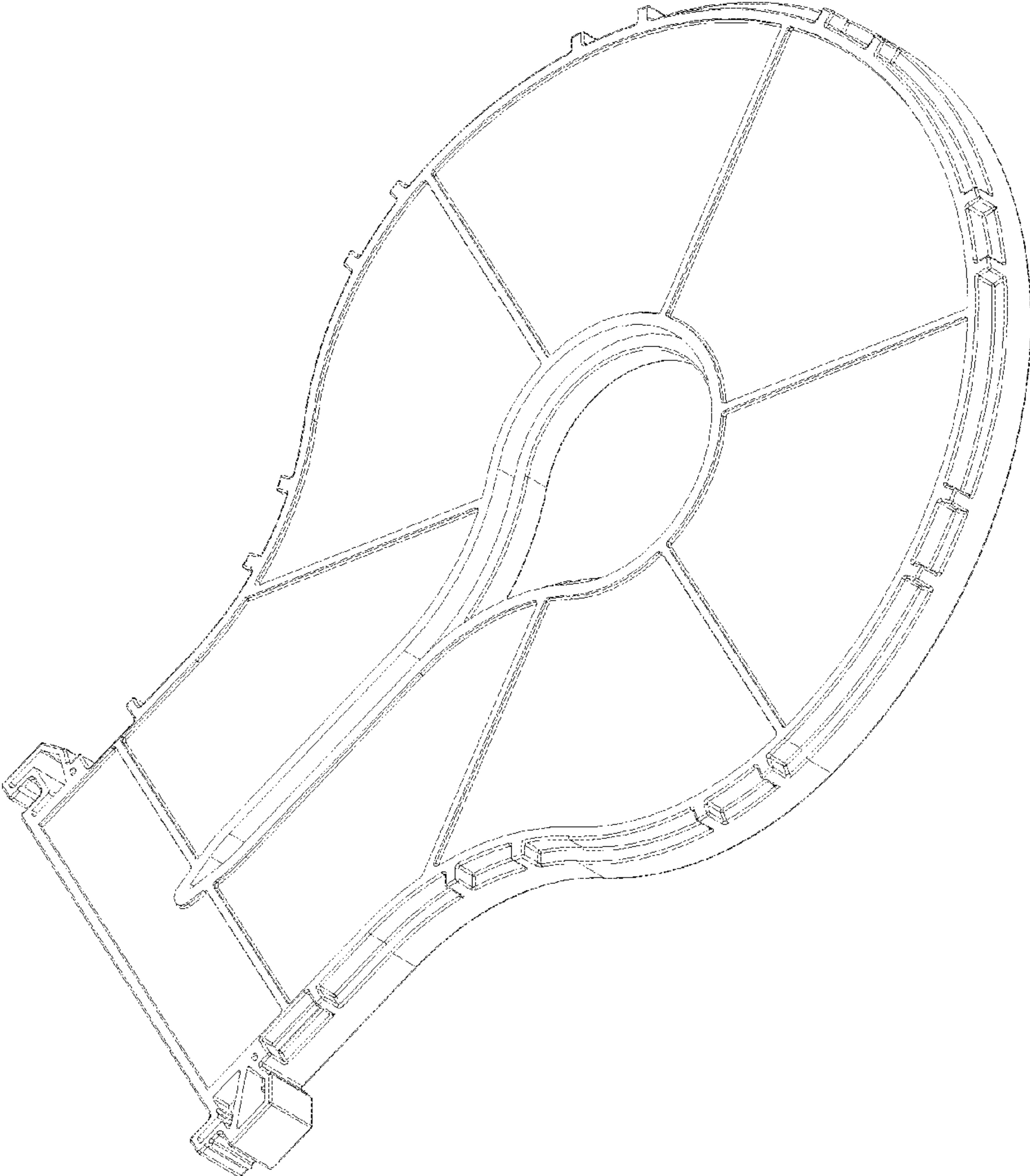

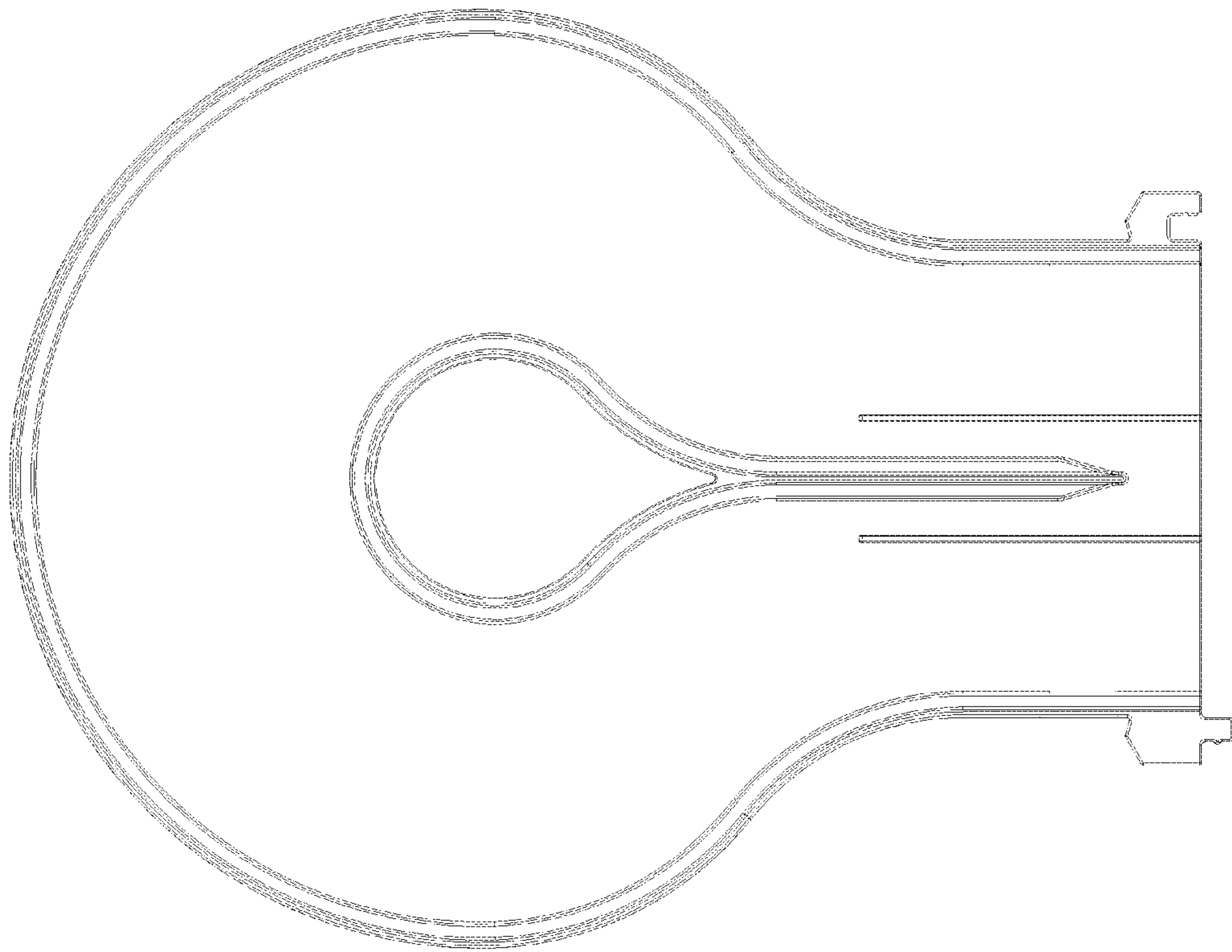

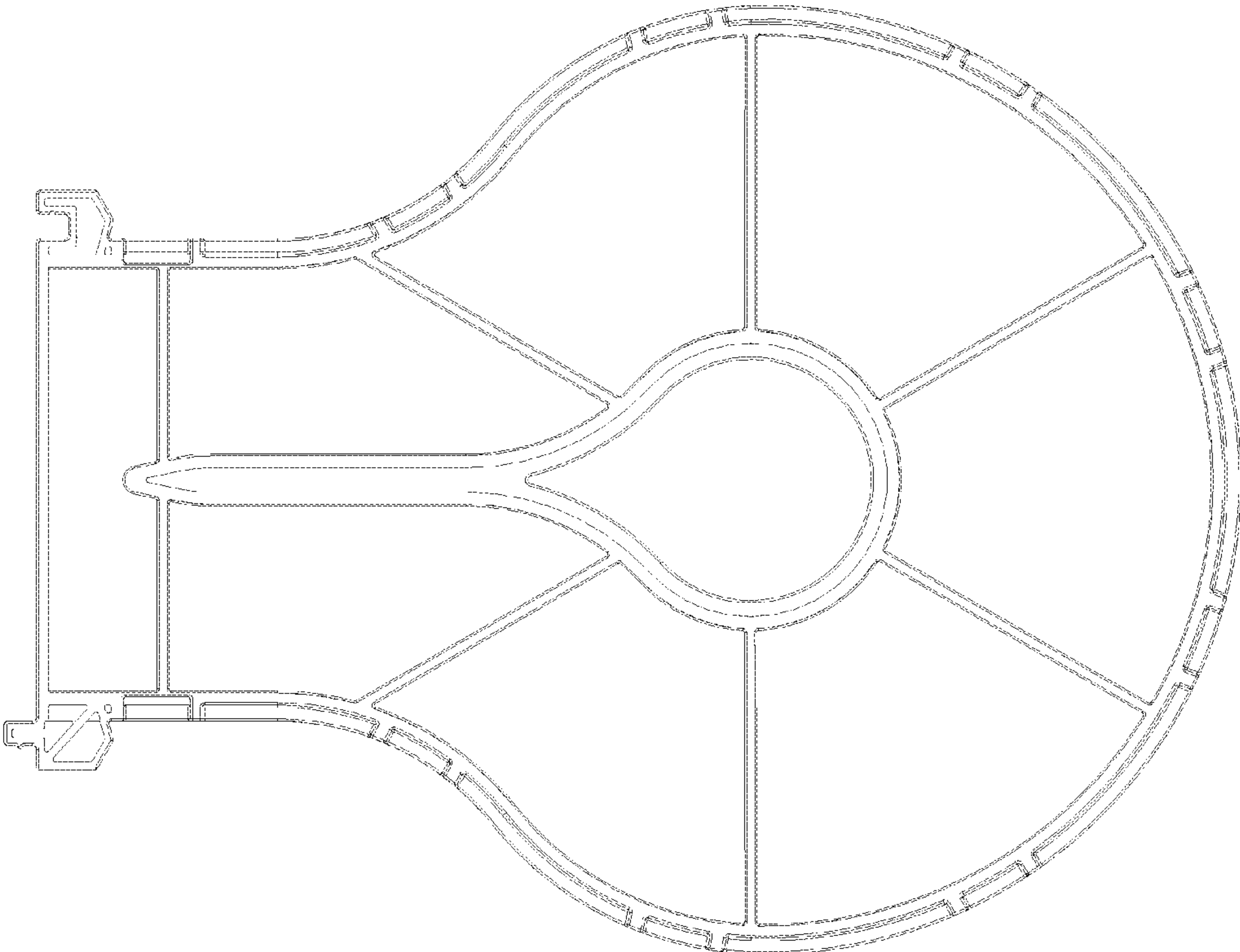

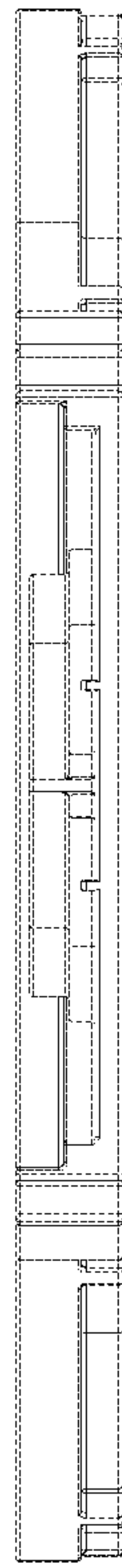

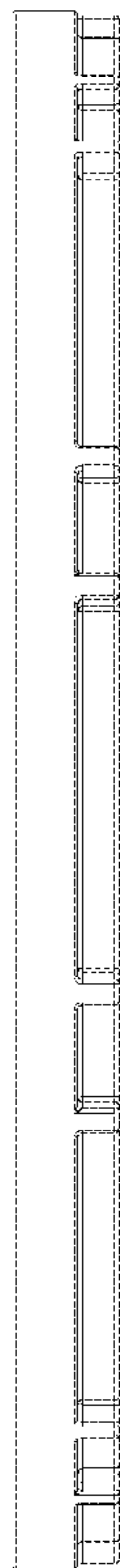

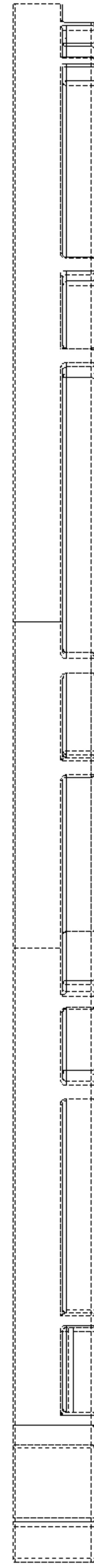
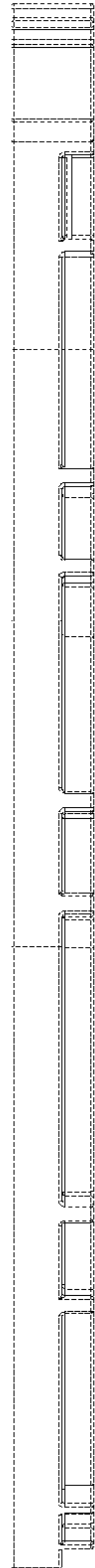

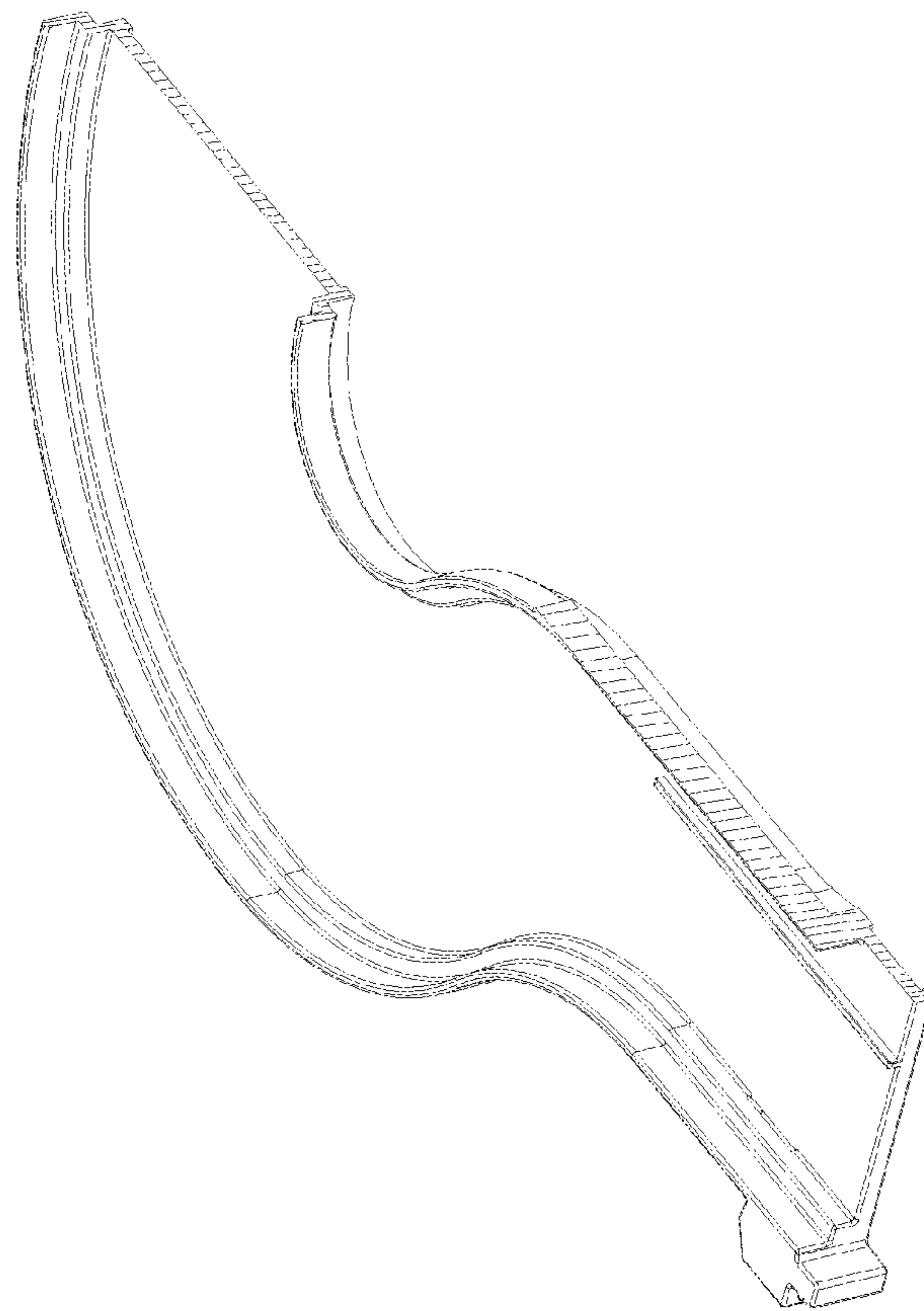
