The ornamental design for facepiece rib, as shown and described.

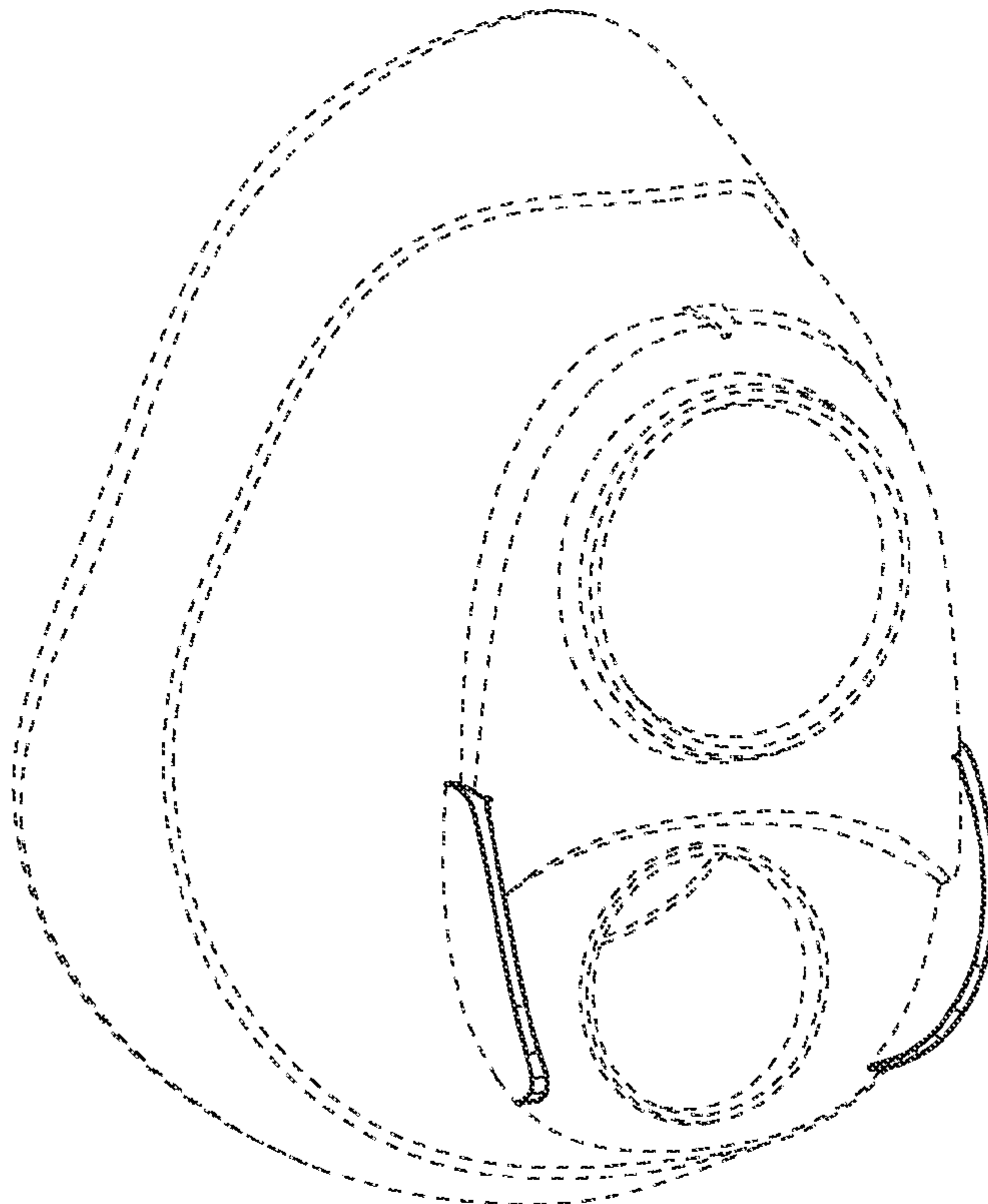
**DESCRIPTION**

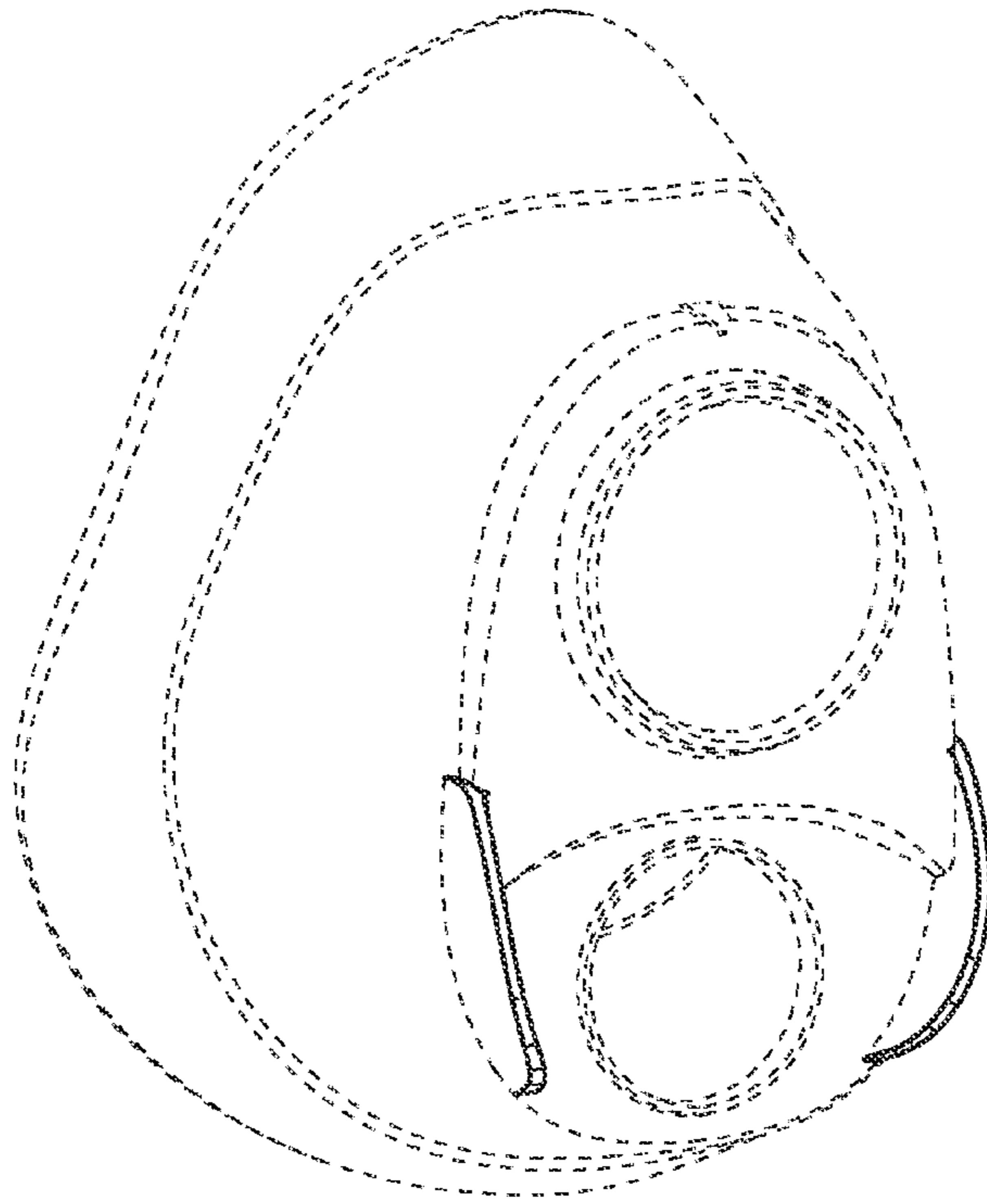
FIG. 1 is a front perspective view showing the new design for facepiece rib;

The broken line showing of a mask is included for the purpose of illustrating environment and forms no part of the claimed design.

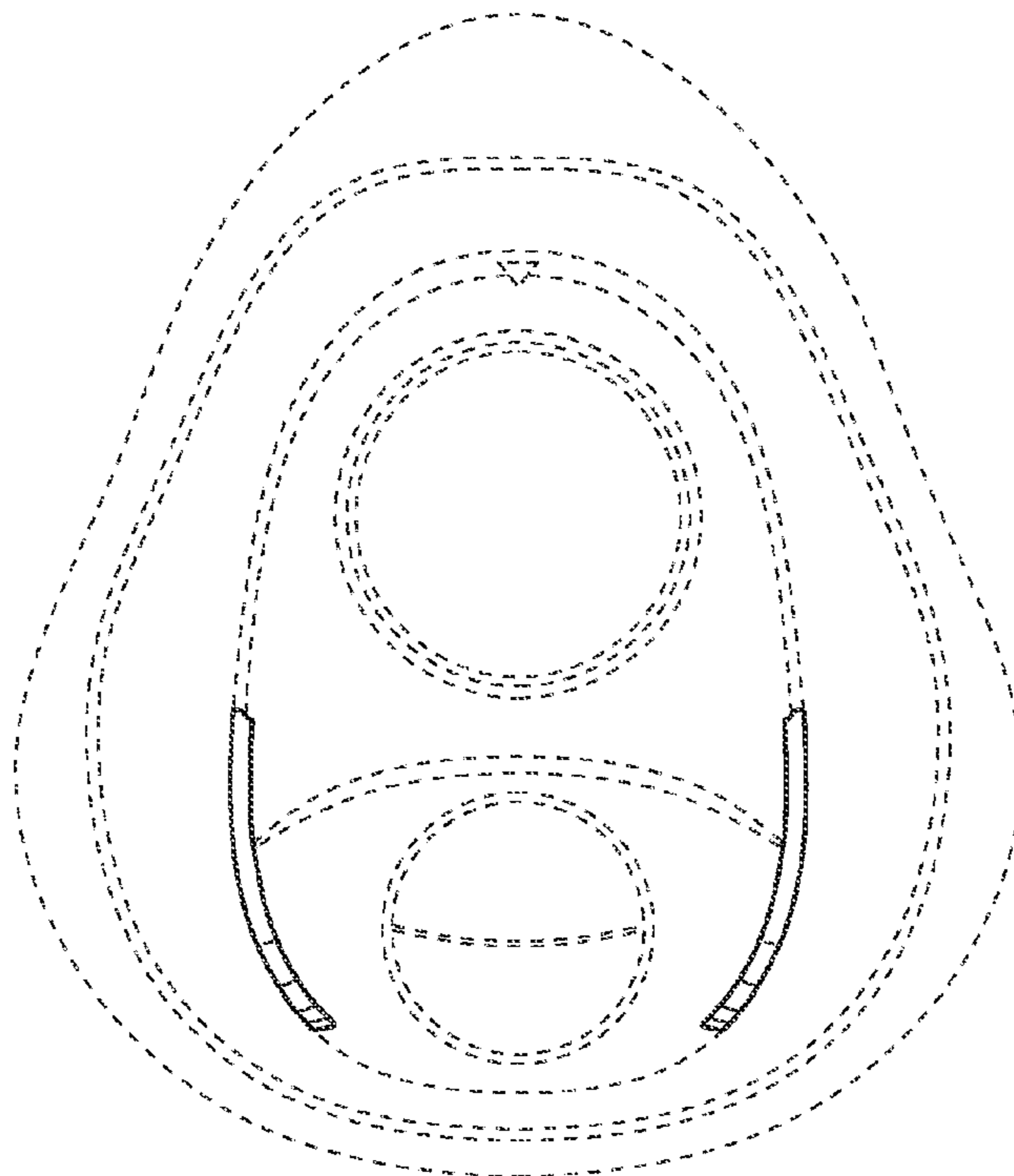
The shading is provided to illustrate contour only and is not an indication of surface texture or sheen.

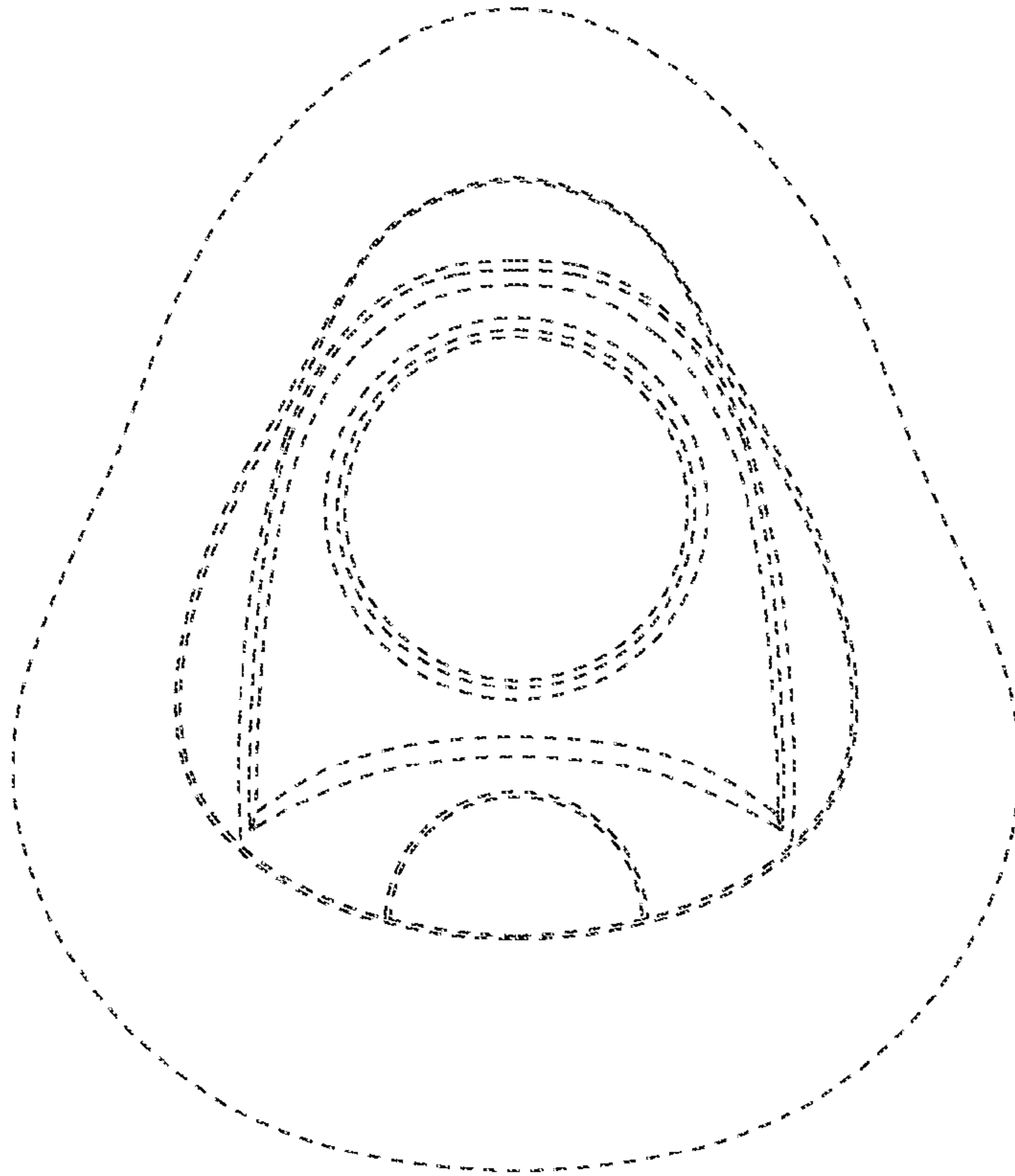




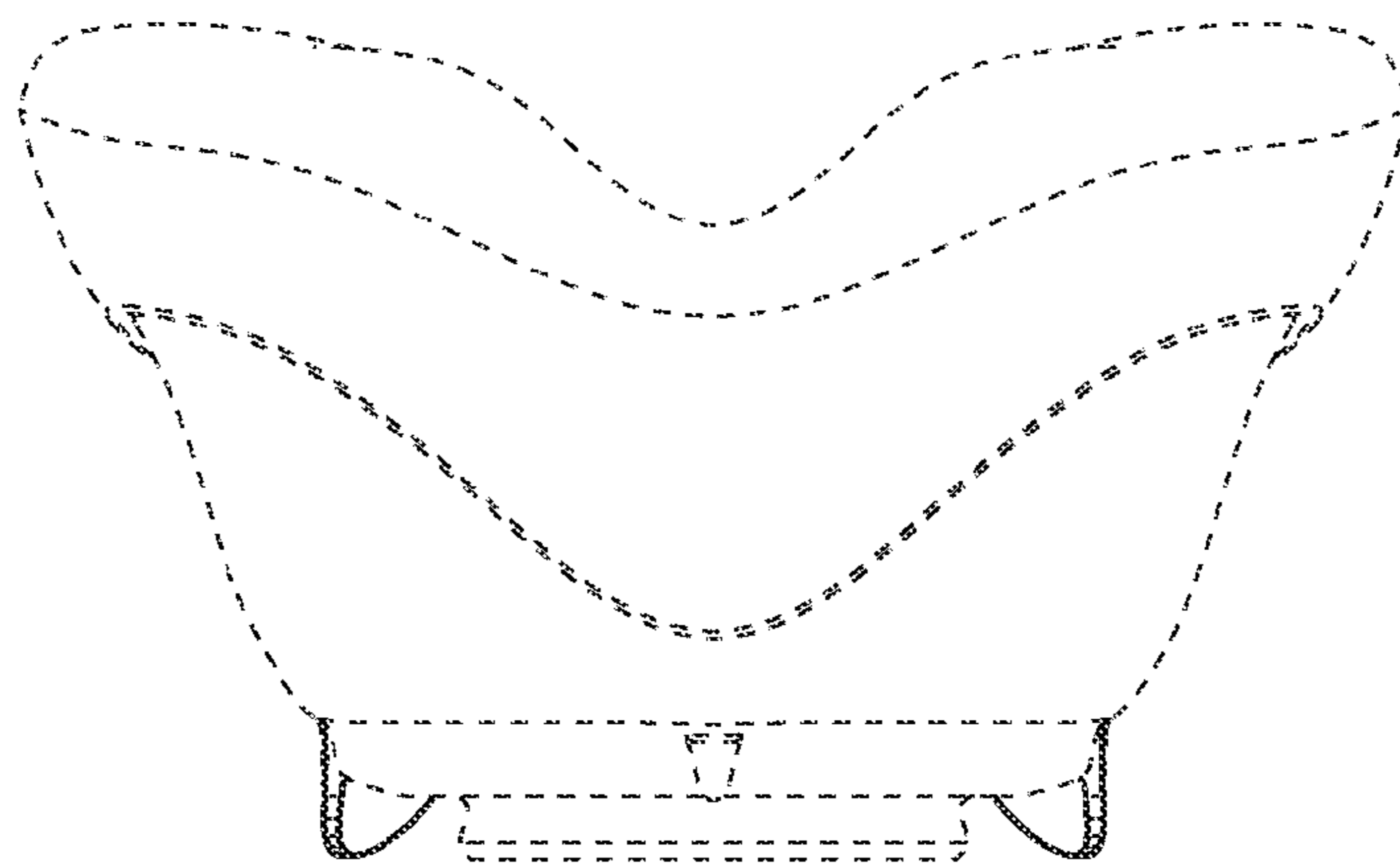

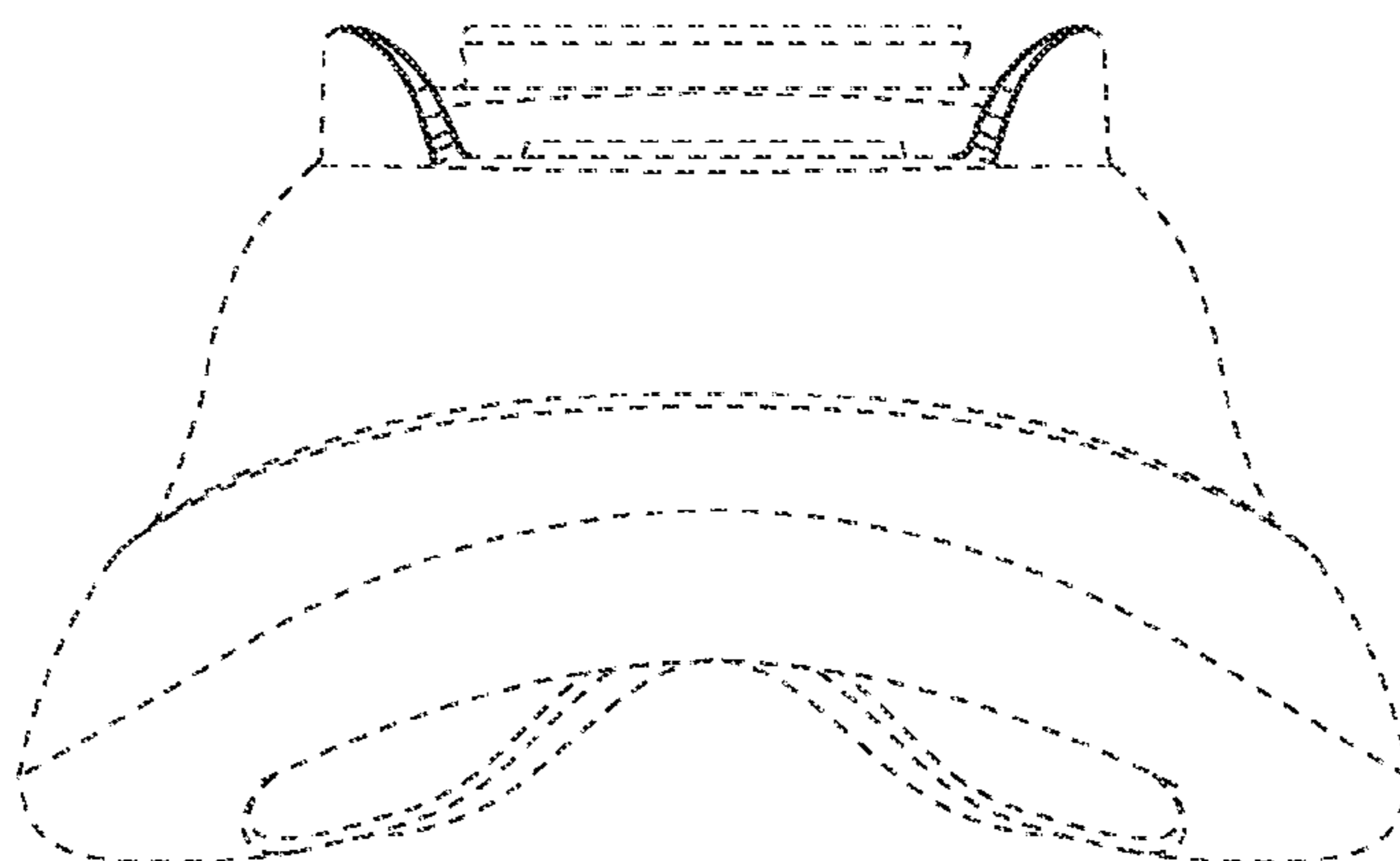

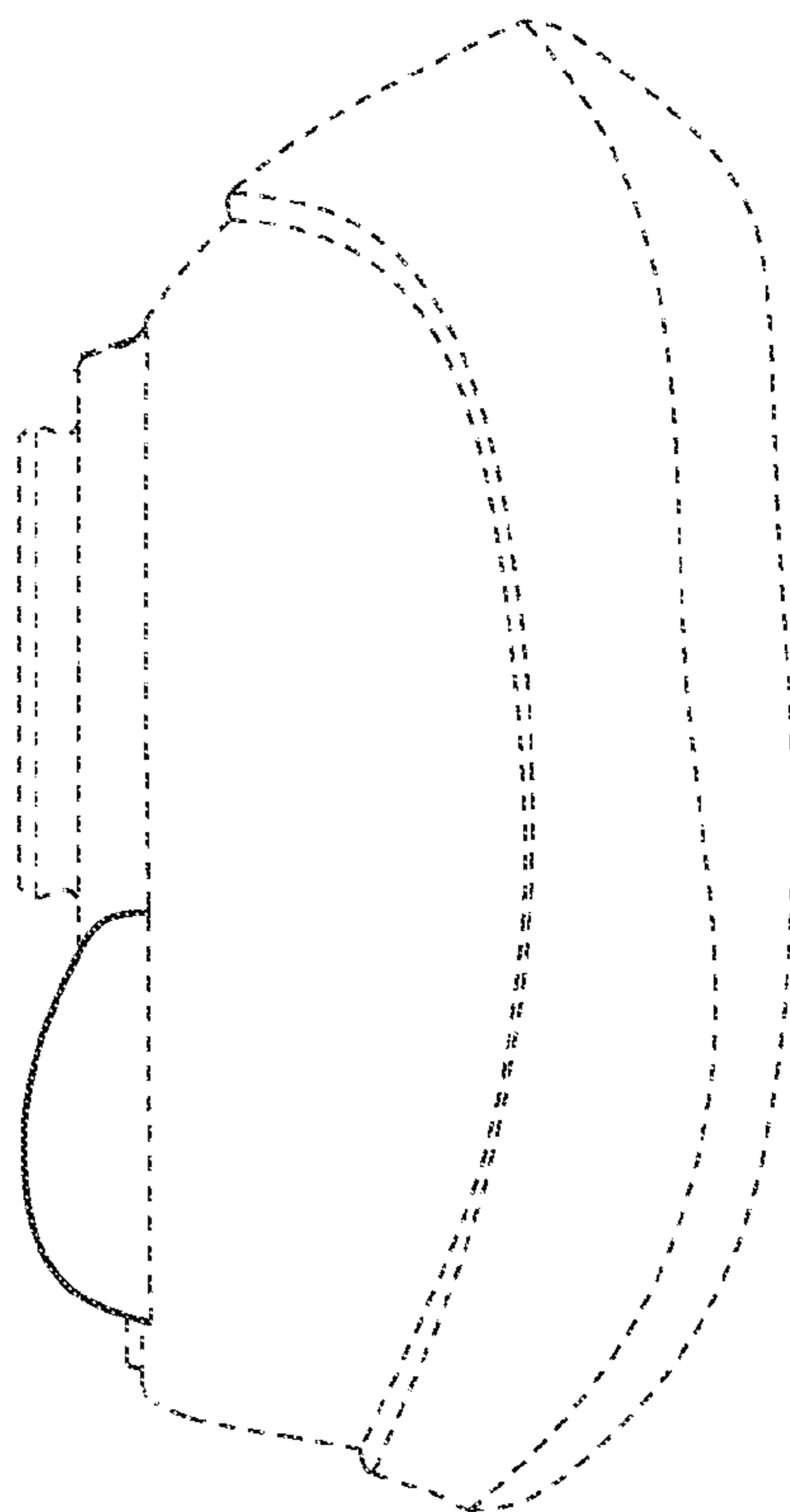
