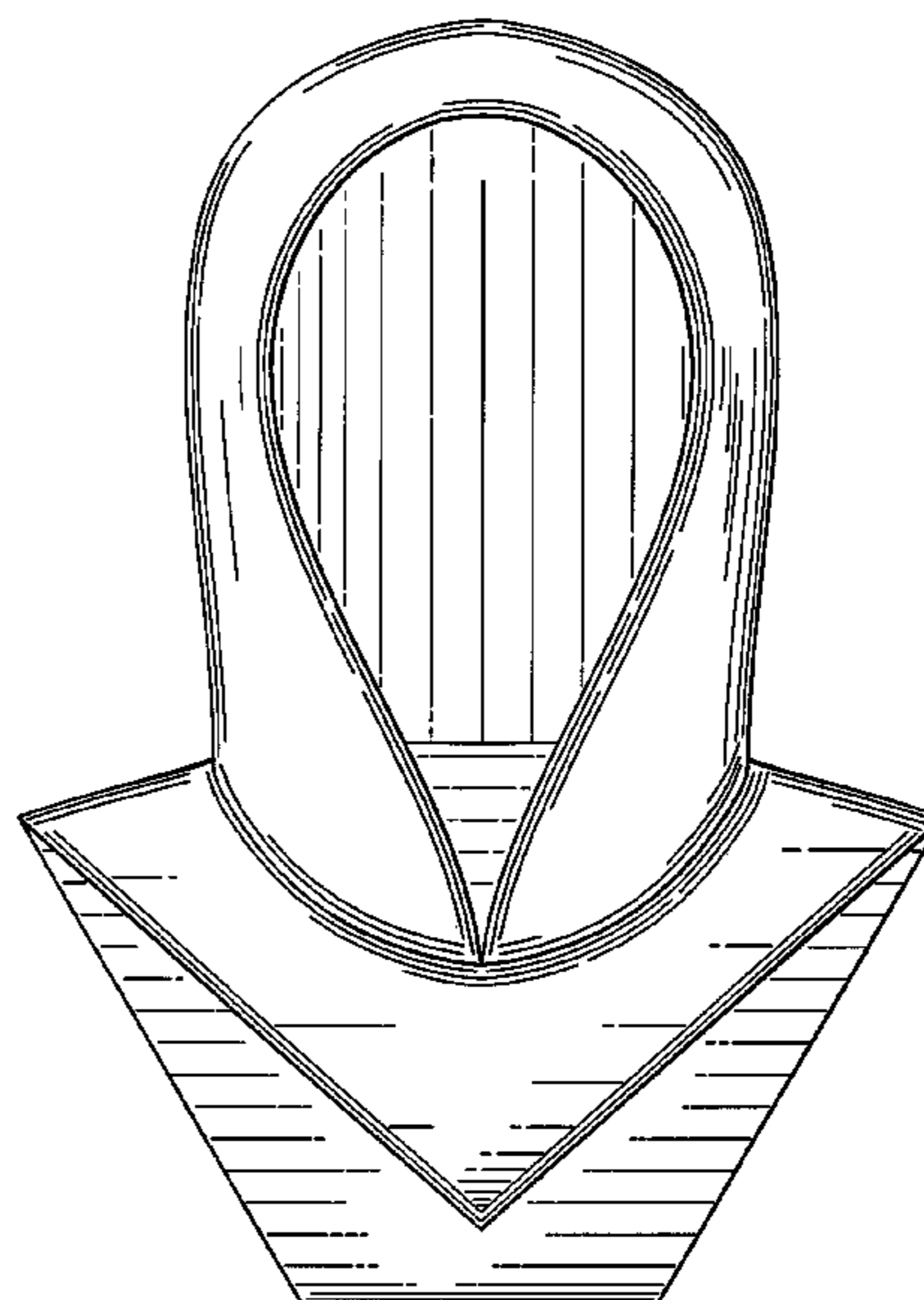
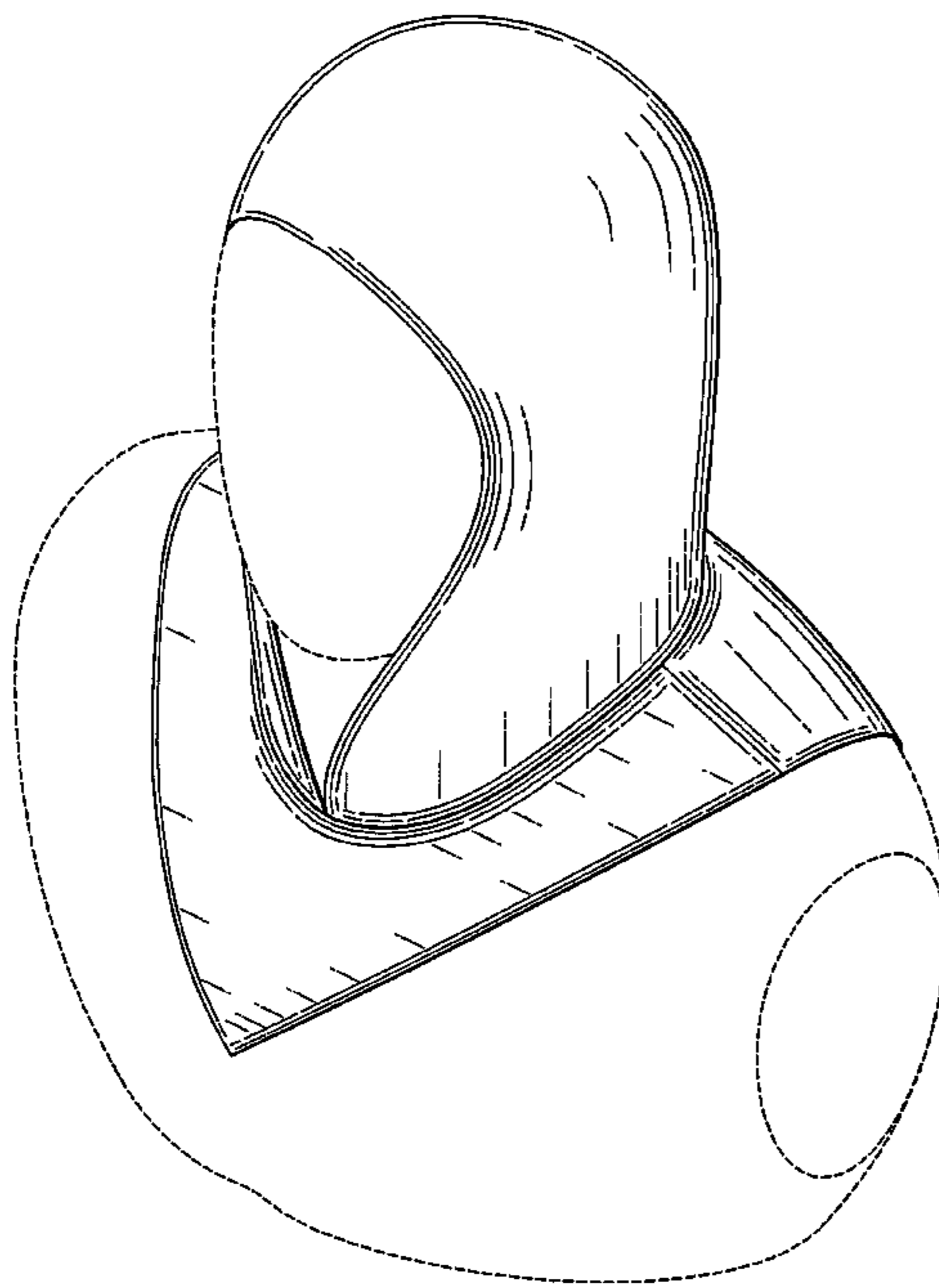
(57) **CLAIM**

The ornamental design for a hooded garment, as shown and described.

DESCRIPTION

FIG. 1 is a front/right side perspective view of a hooded garment showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. In the drawings, the broken lines showing a mannequin illustrate environment and form no part of the claimed design.

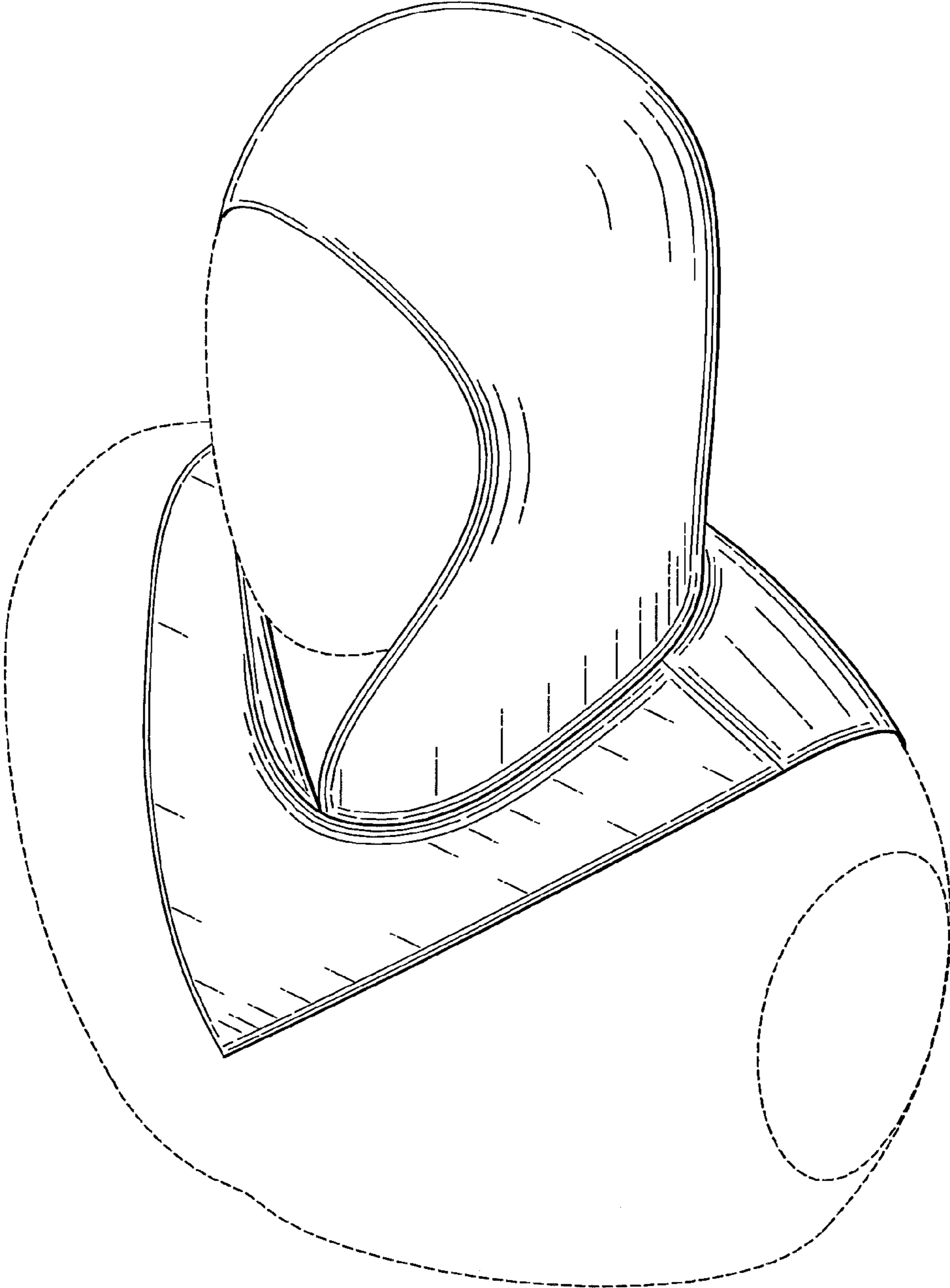

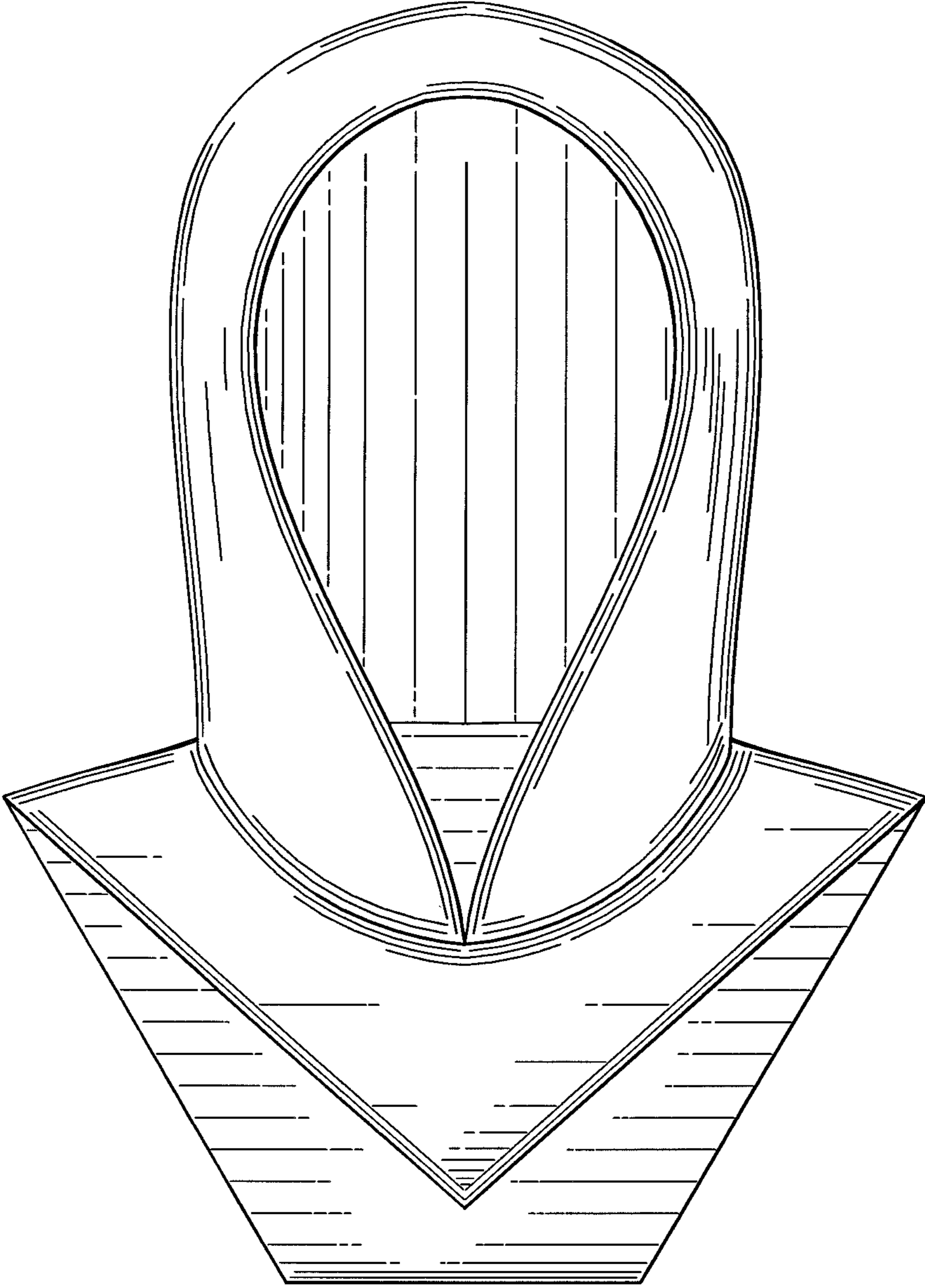

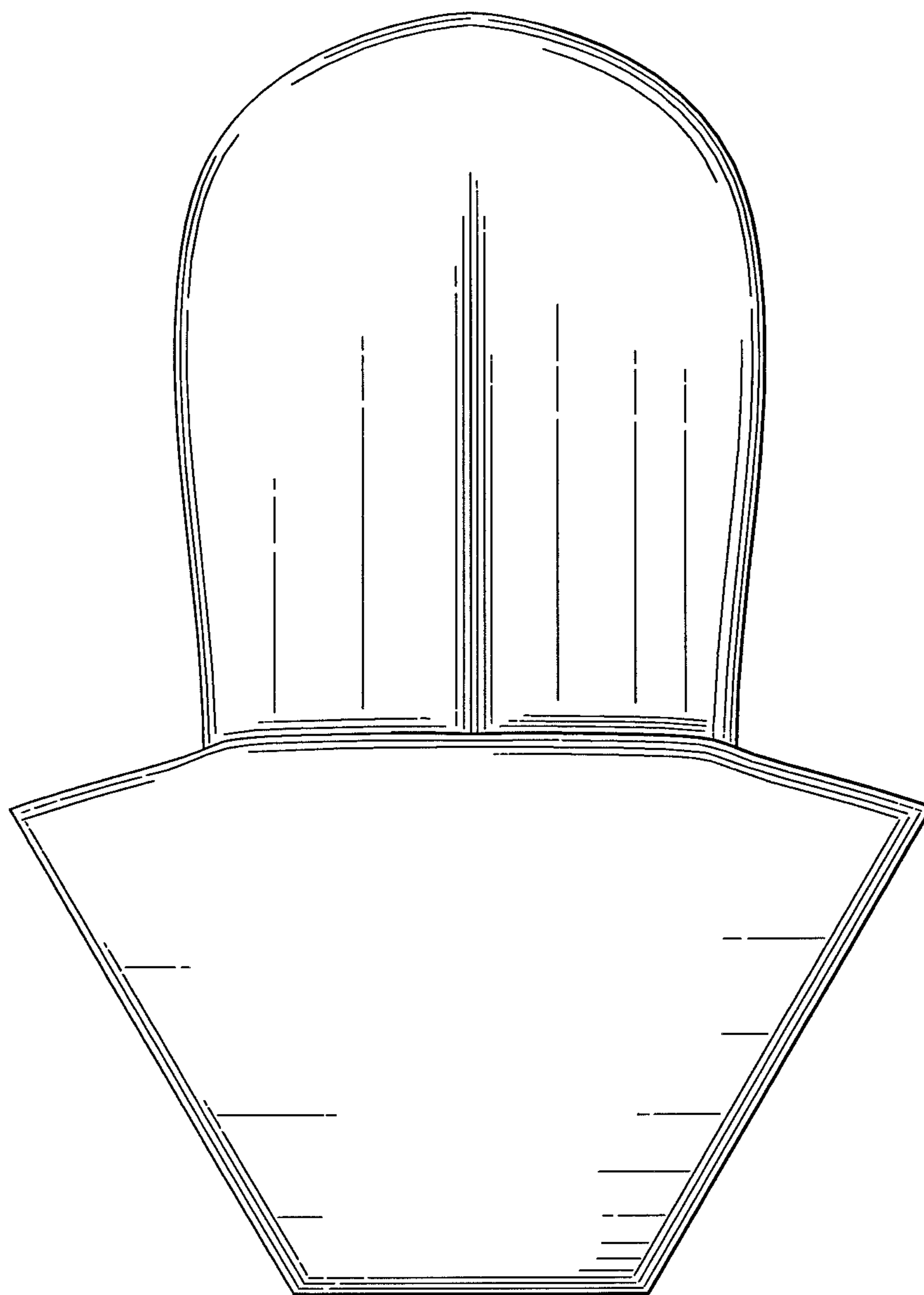

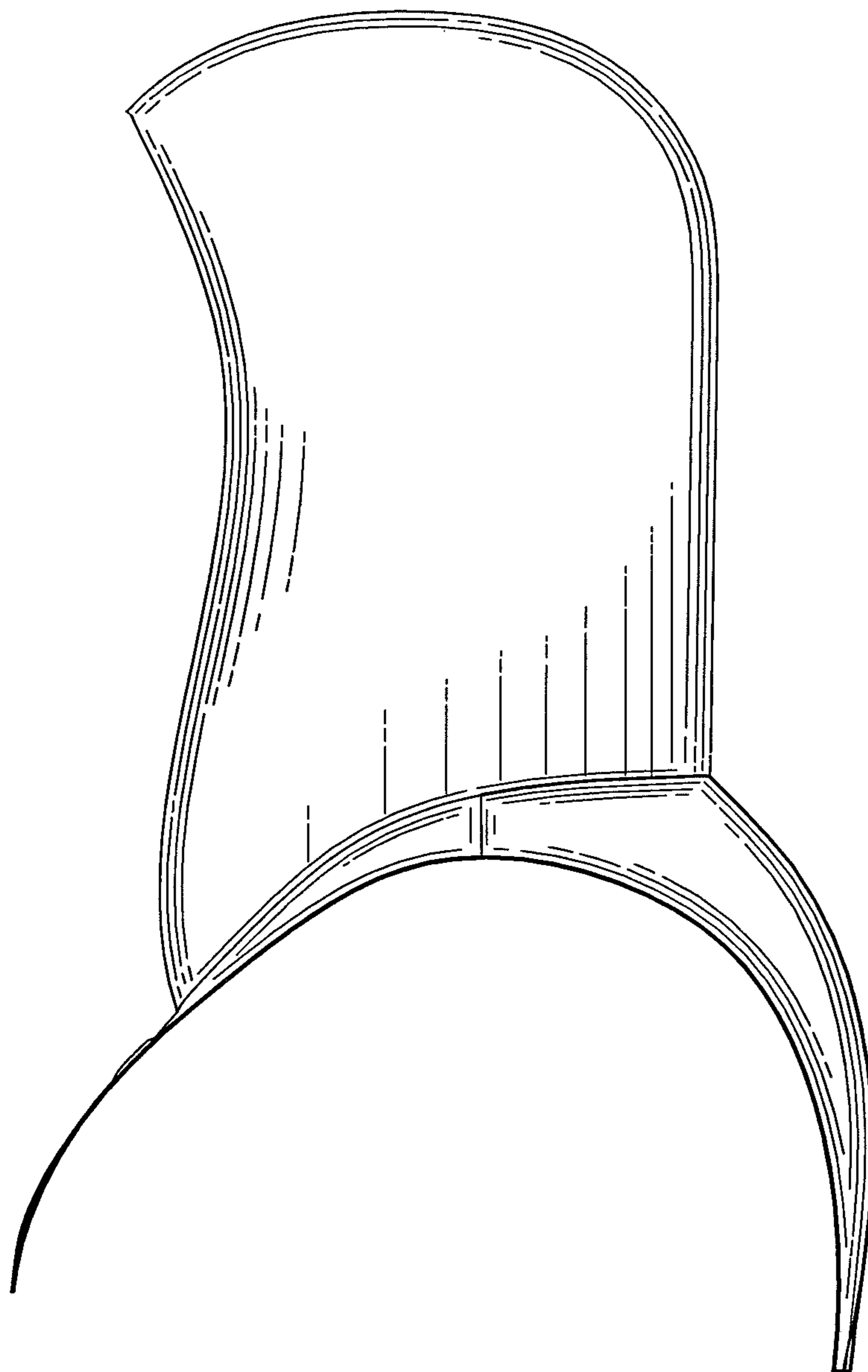

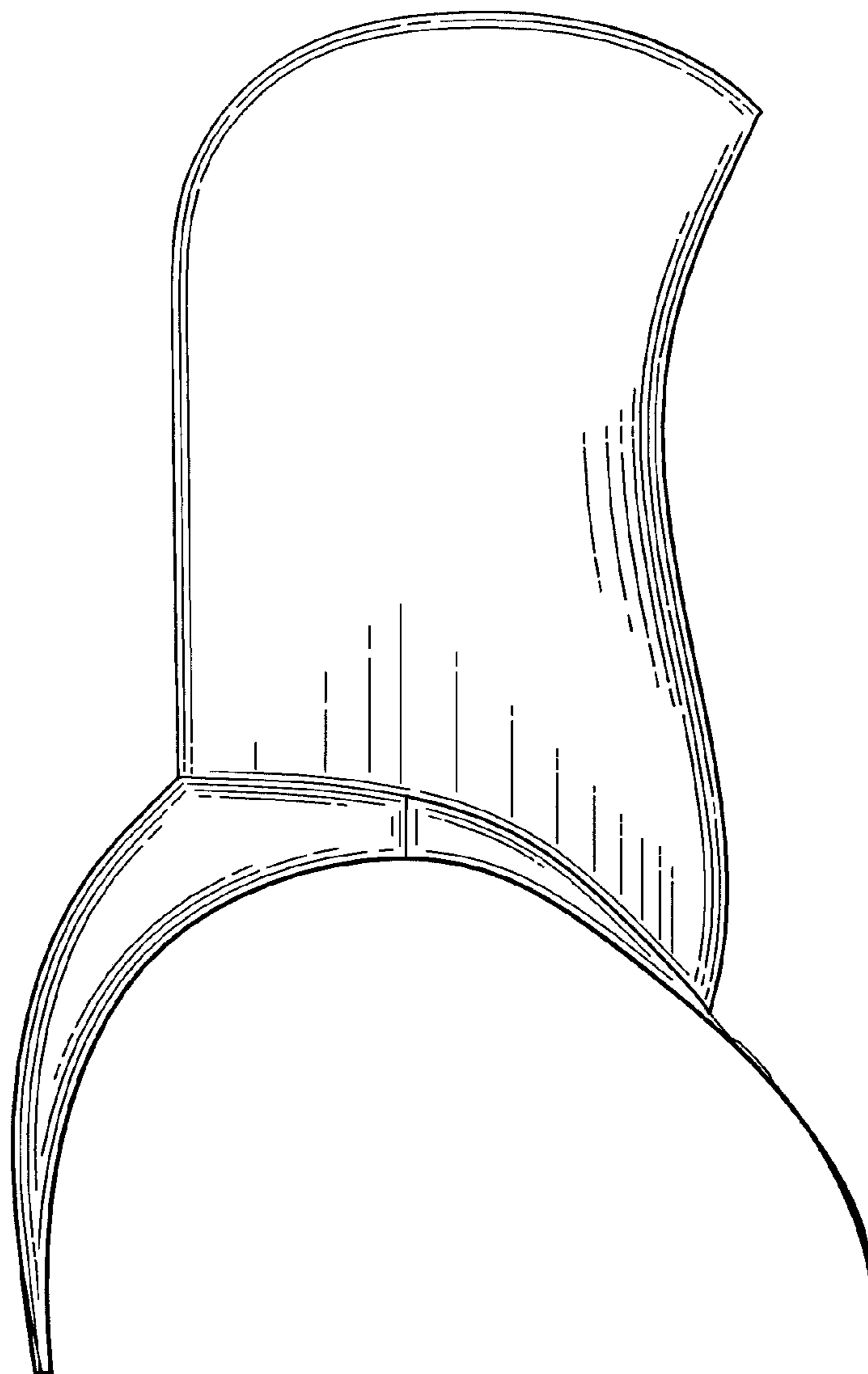

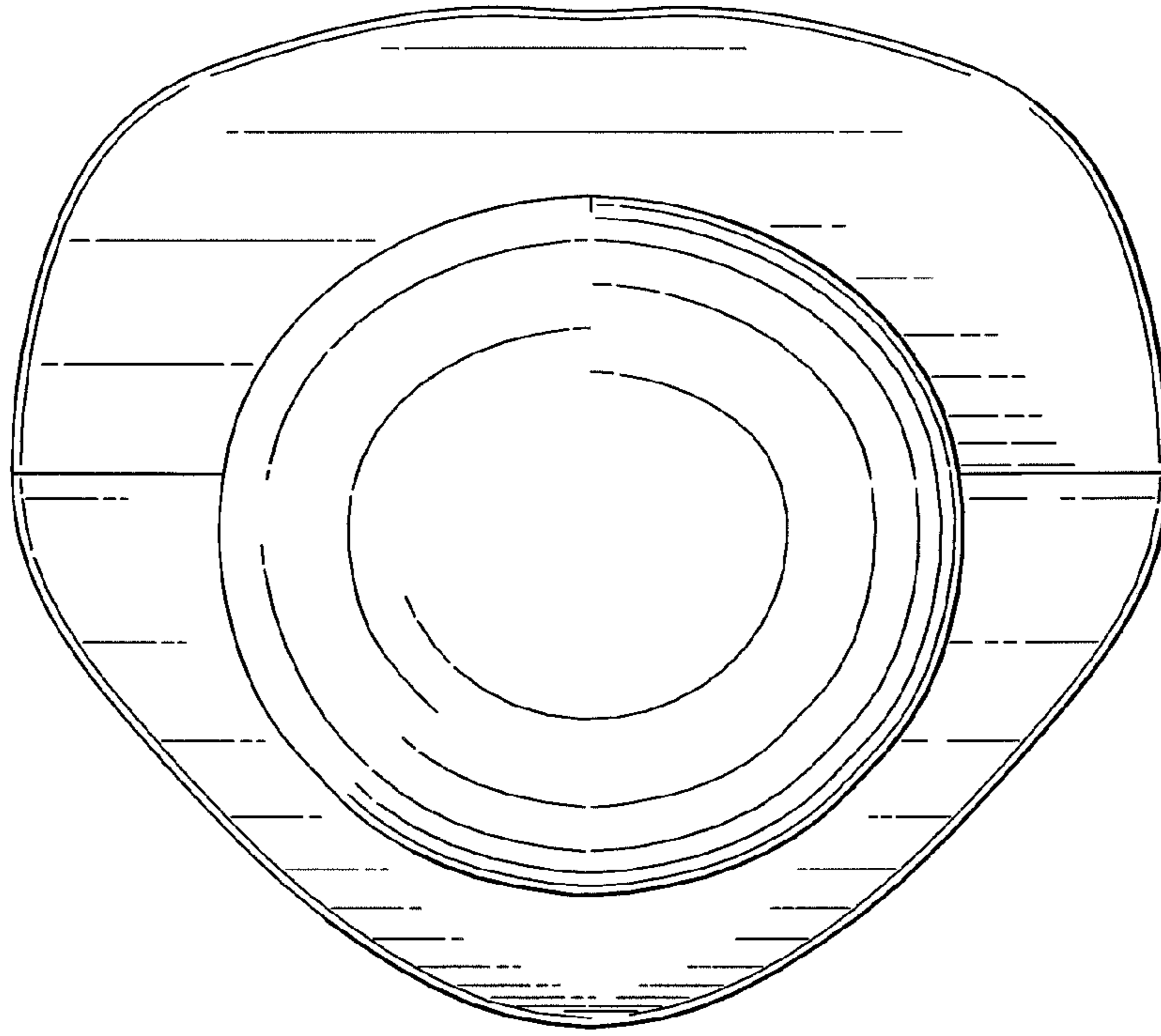

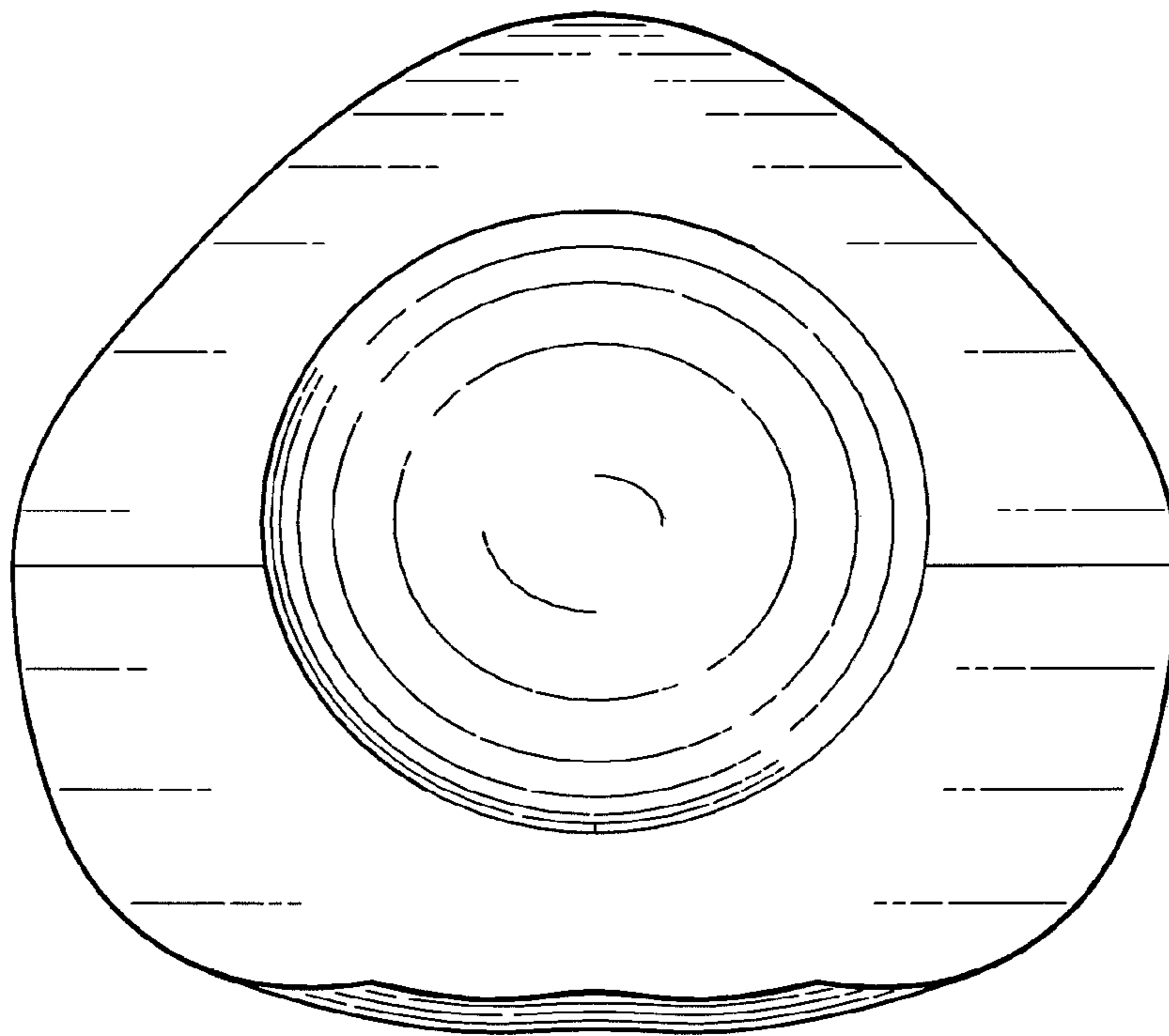
