(57) **CLAIM**

The ornamental design for a pill box with indicia and writing instrument holder, as shown.

FIG. 1 is a perspective view of a pill box showing my new design.

FIG. 2 is a perspective view of the open pill box in FIG. 1.

FIG. 3 is a bottom plan view of the open pill box in FIG. 1;

FIG. 4 is a right side elevation view of the pill box in FIG. 1.

FIG. 5 is a top plan view of the pill box in FIG. 1.

FIG. 6 is a left side elevation view of the pill box in FIG. 1.

FIG. 7 is a right side elevation view of the open pill box in FIG. 2;

FIG. 8 is an inside front elevation view of the open pill box in FIG. 2;

FIG. 9 is a left side elevation view of the open pill box in FIG. 2;

FIG. 10 is an outside top view of the open pill box in FIG. 2;

FIG. 11 is a perspective view of another embodiment of the open pill box.

FIG. 12 is a right side elevation view of the open pill box in FIG. 11;

FIG. 13 is an inside front elevation view of the open pill box in FIG. 11;

FIG. 14 is a left side elevation view of the open pill box in FIG. 11; and,

FIG. 15 is an outside top view of the open pill box in FIG. 11.

The bottom view of the second embodiment is the same as the bottom view of the first embodiment.

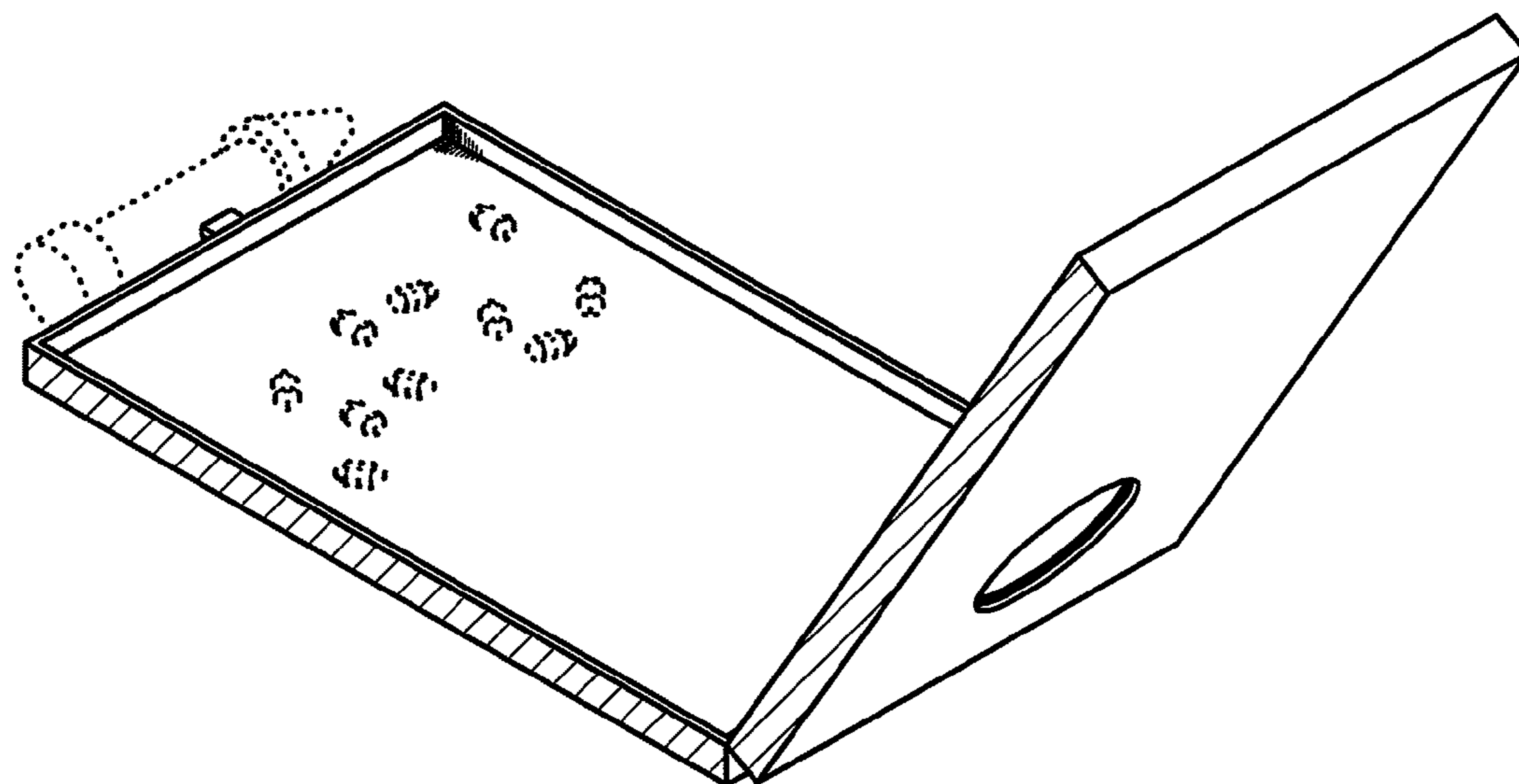

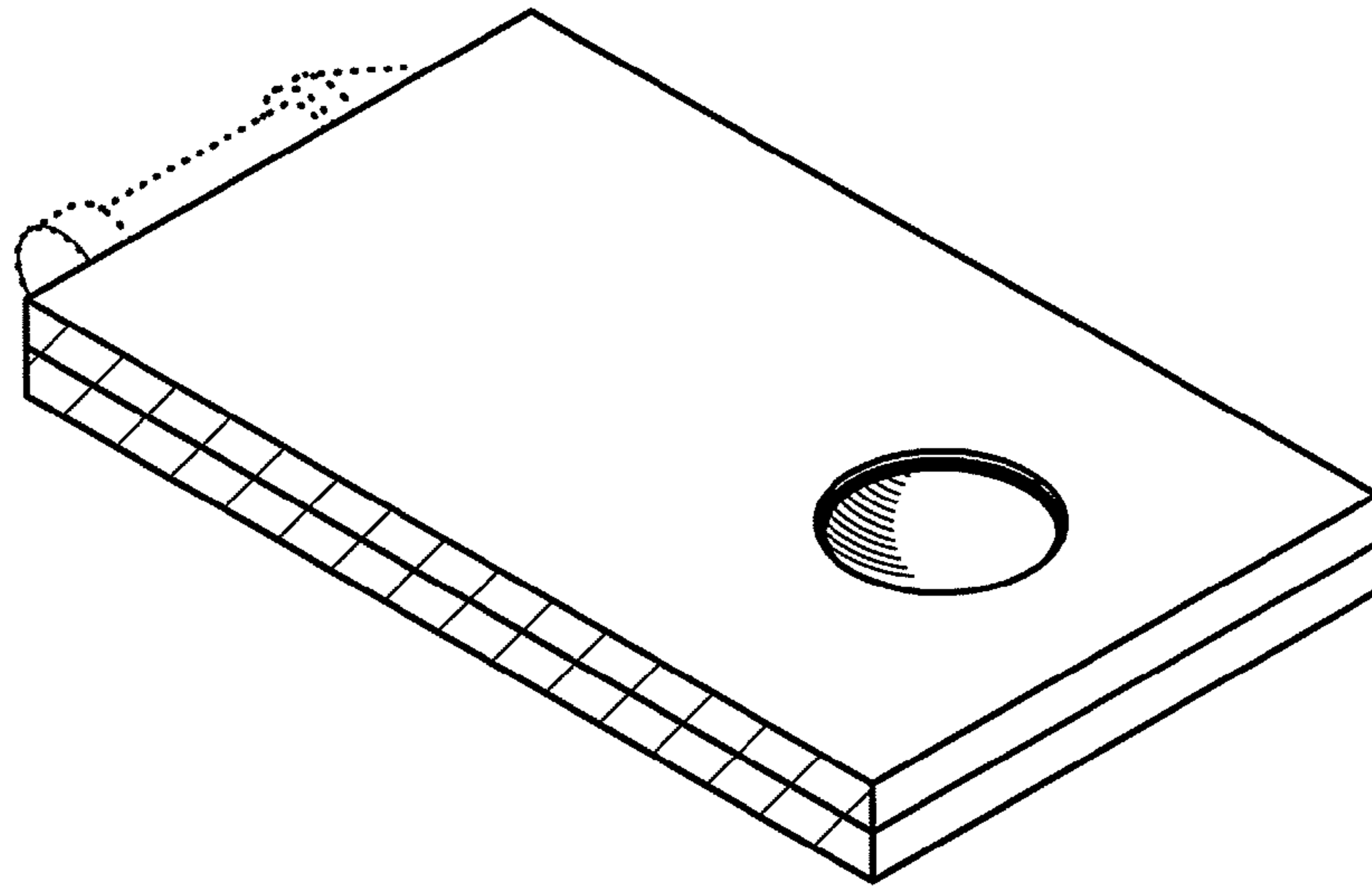

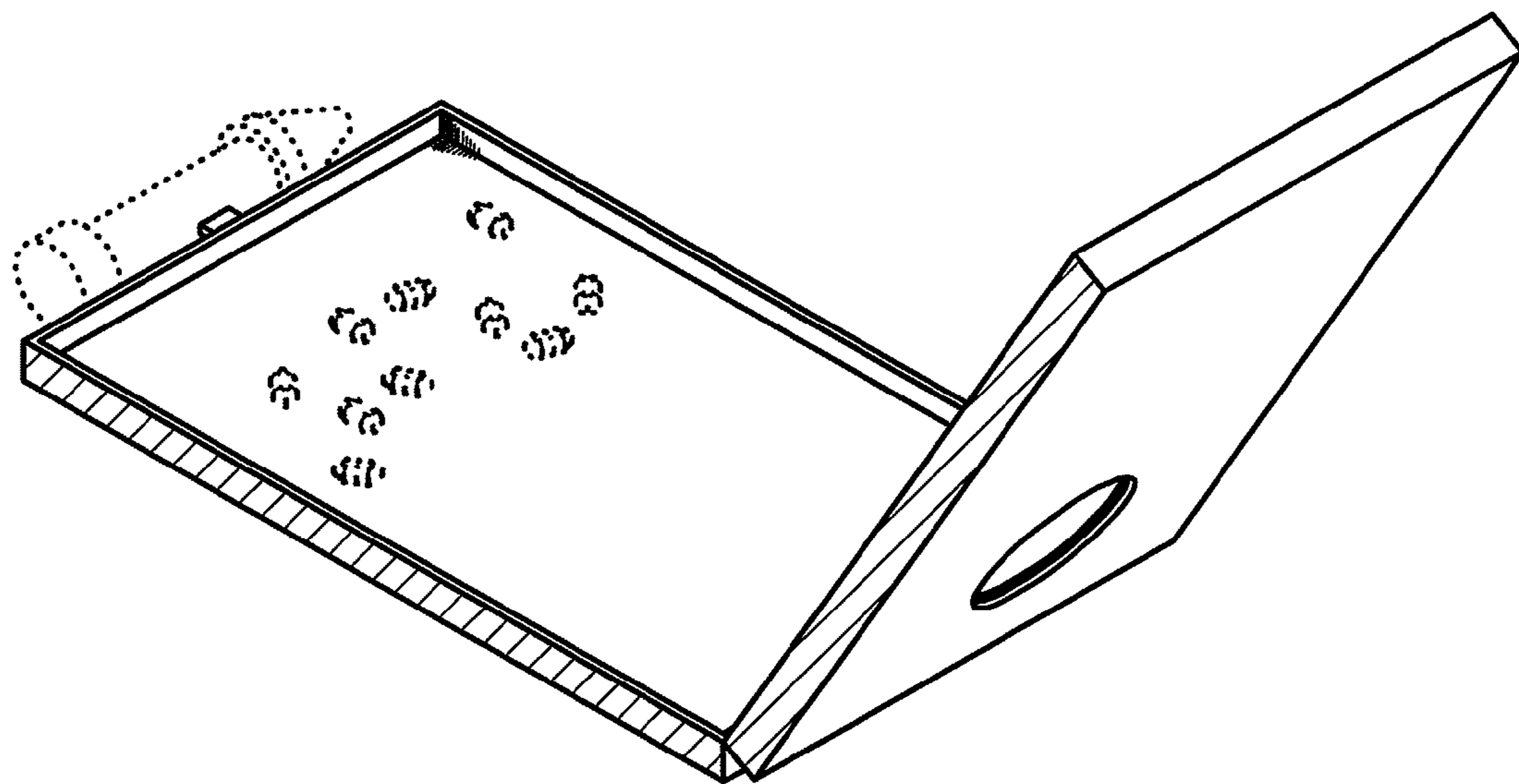

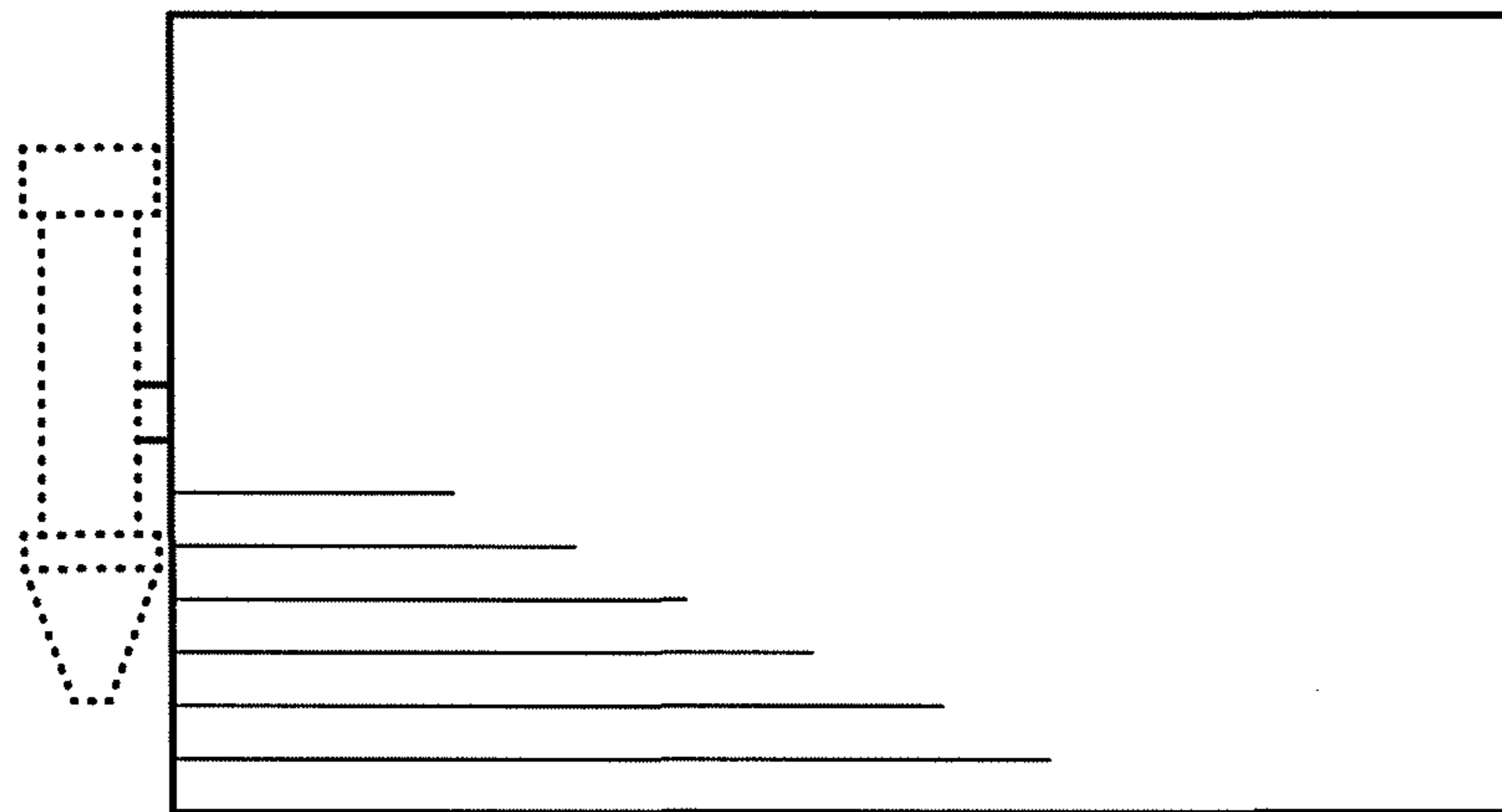

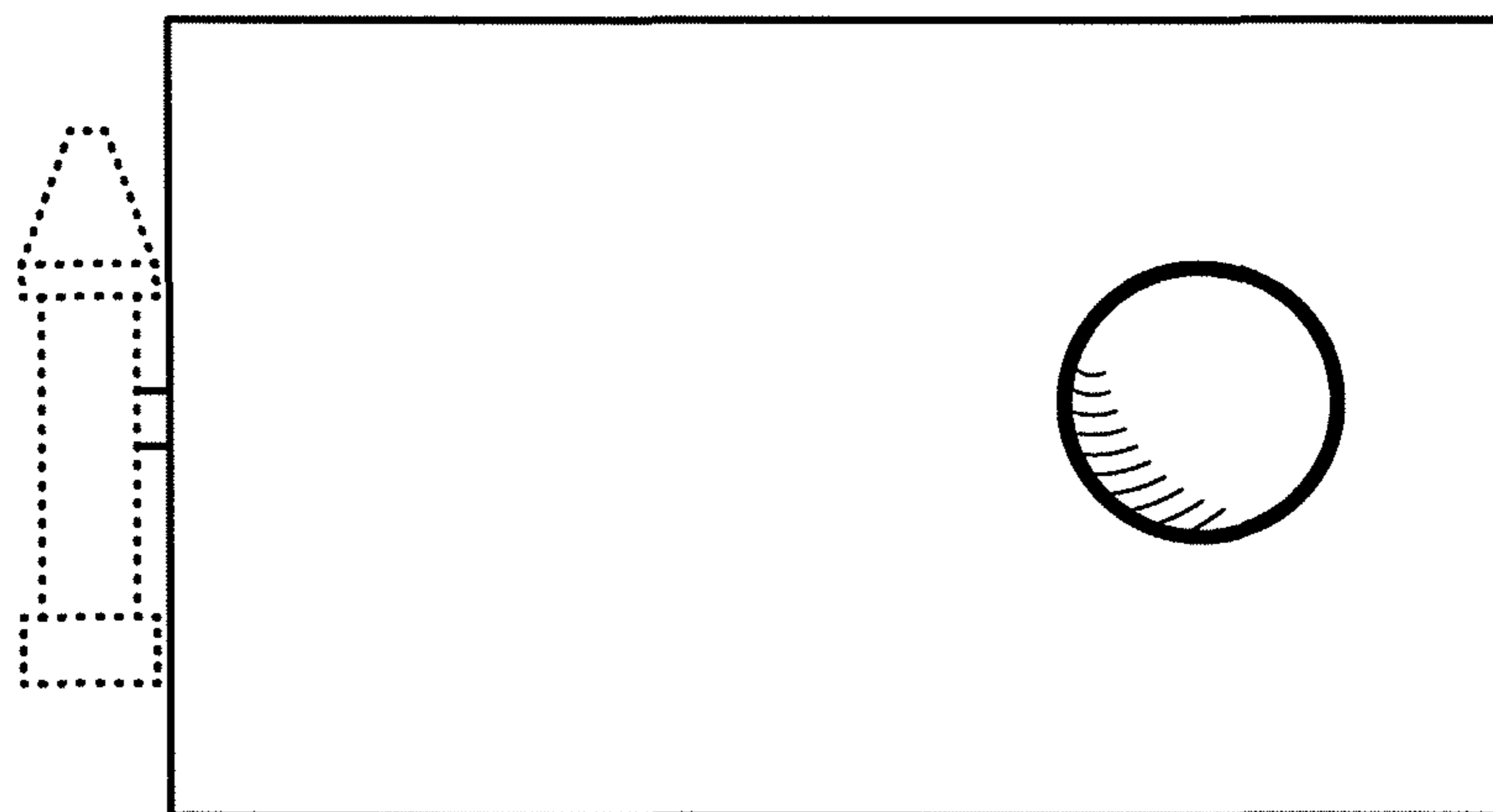

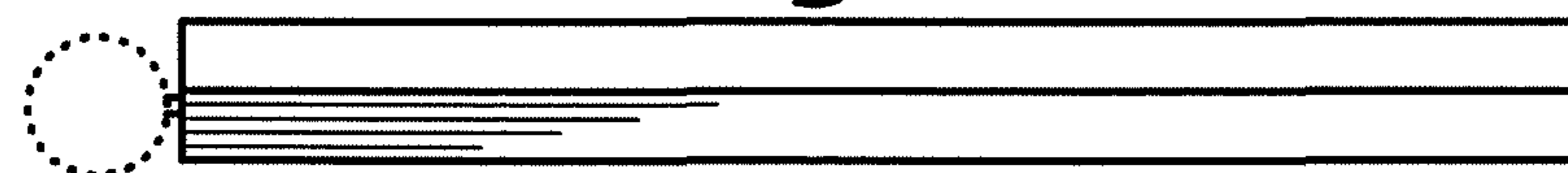

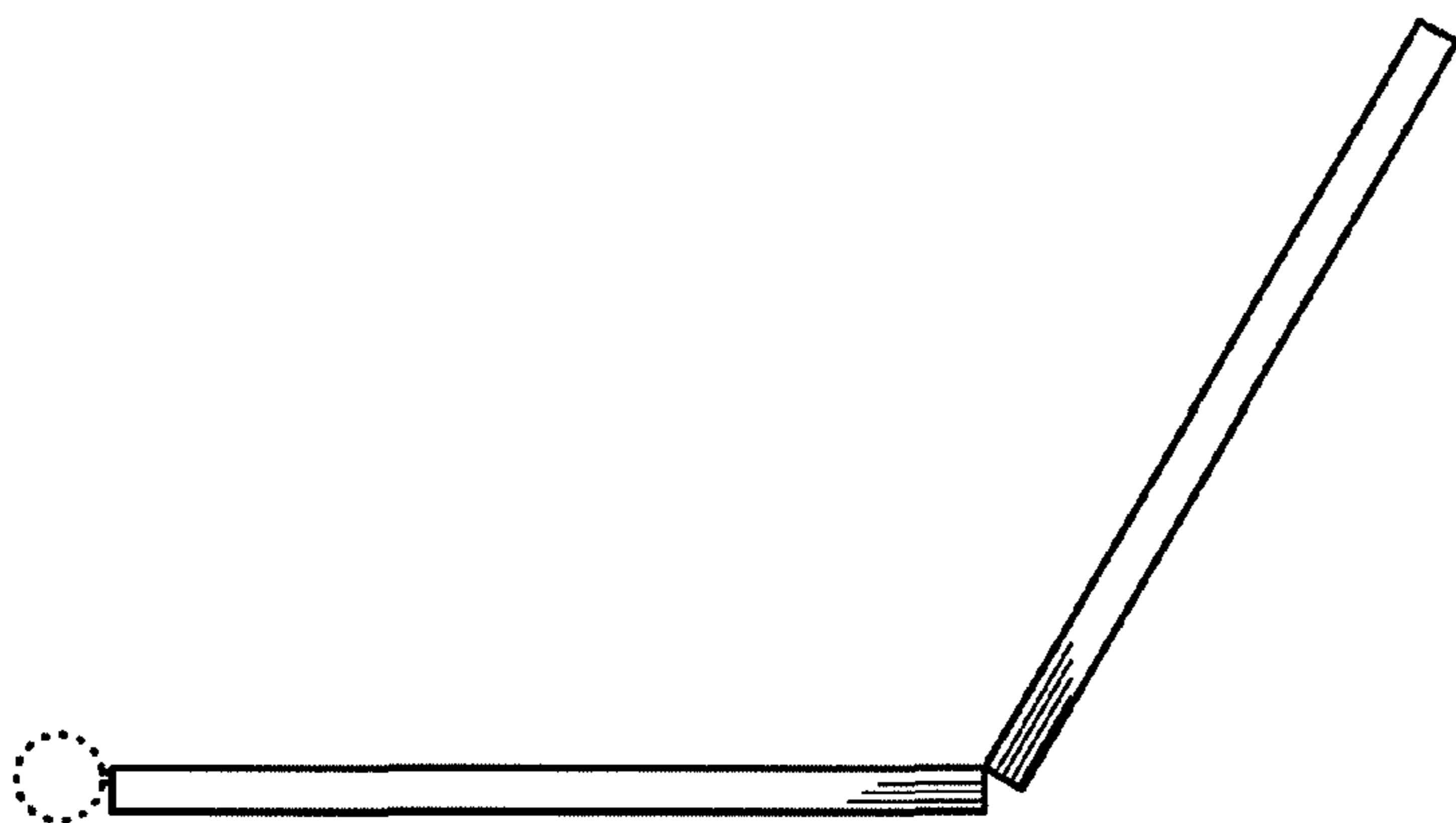

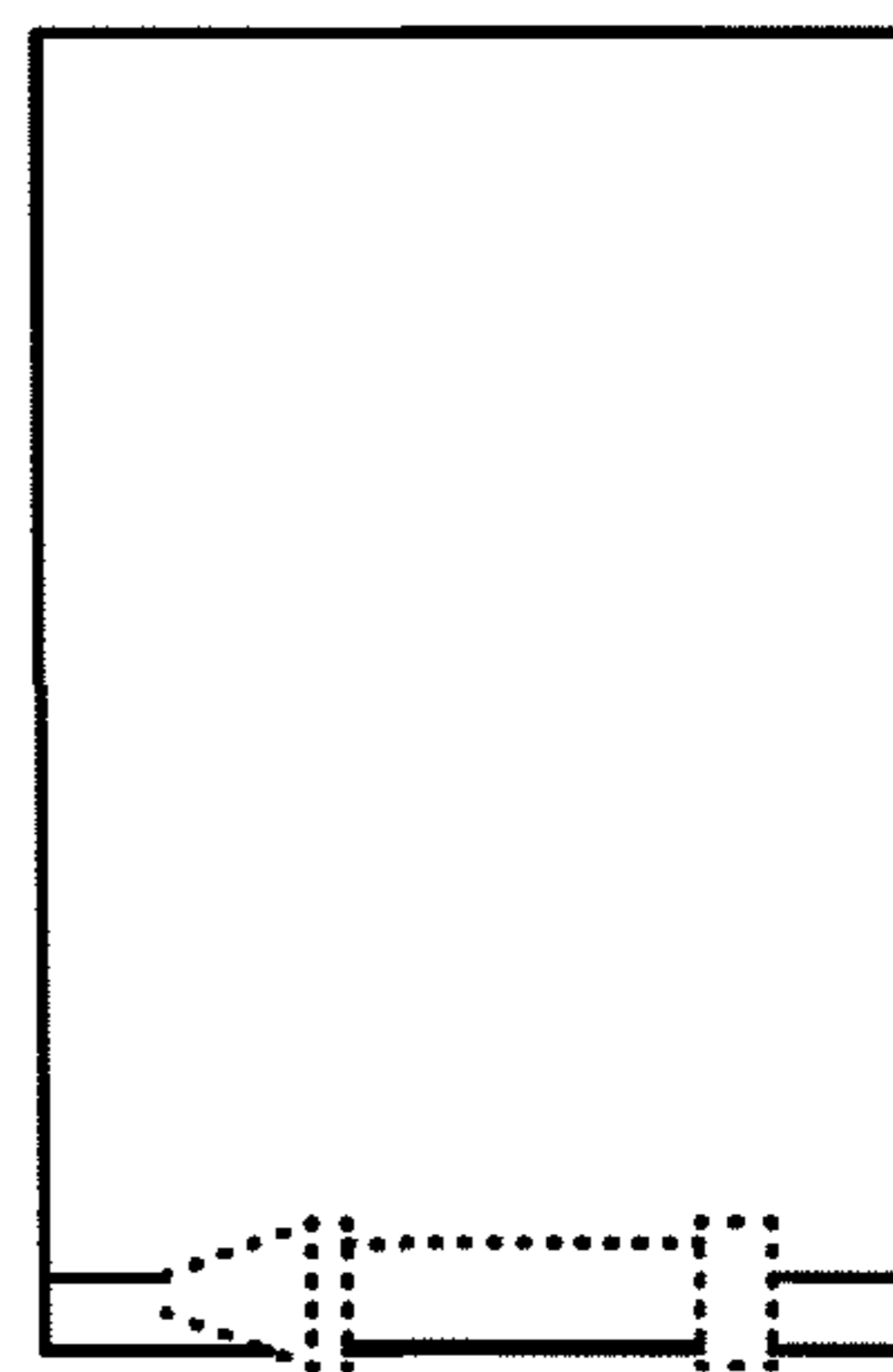

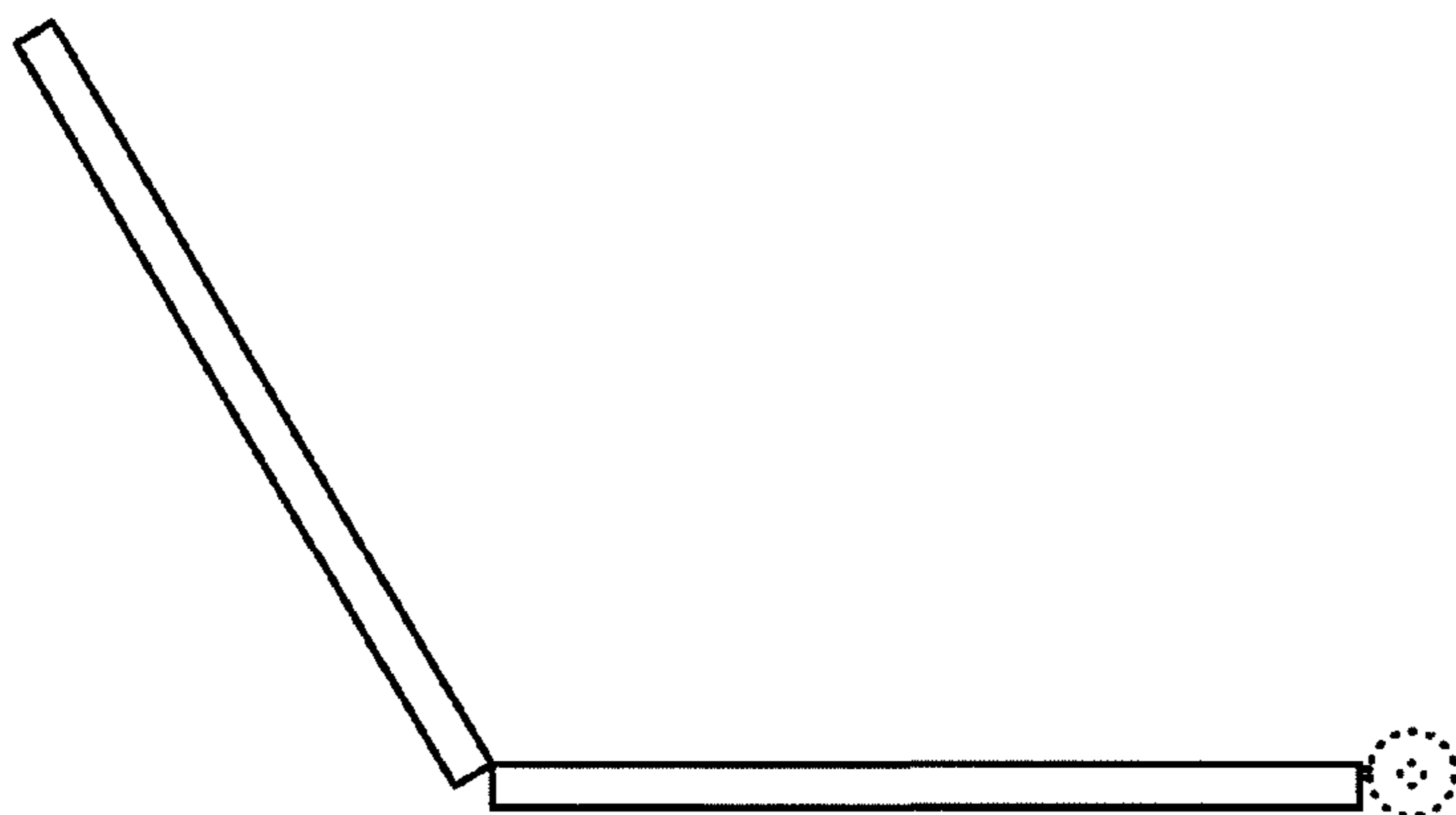

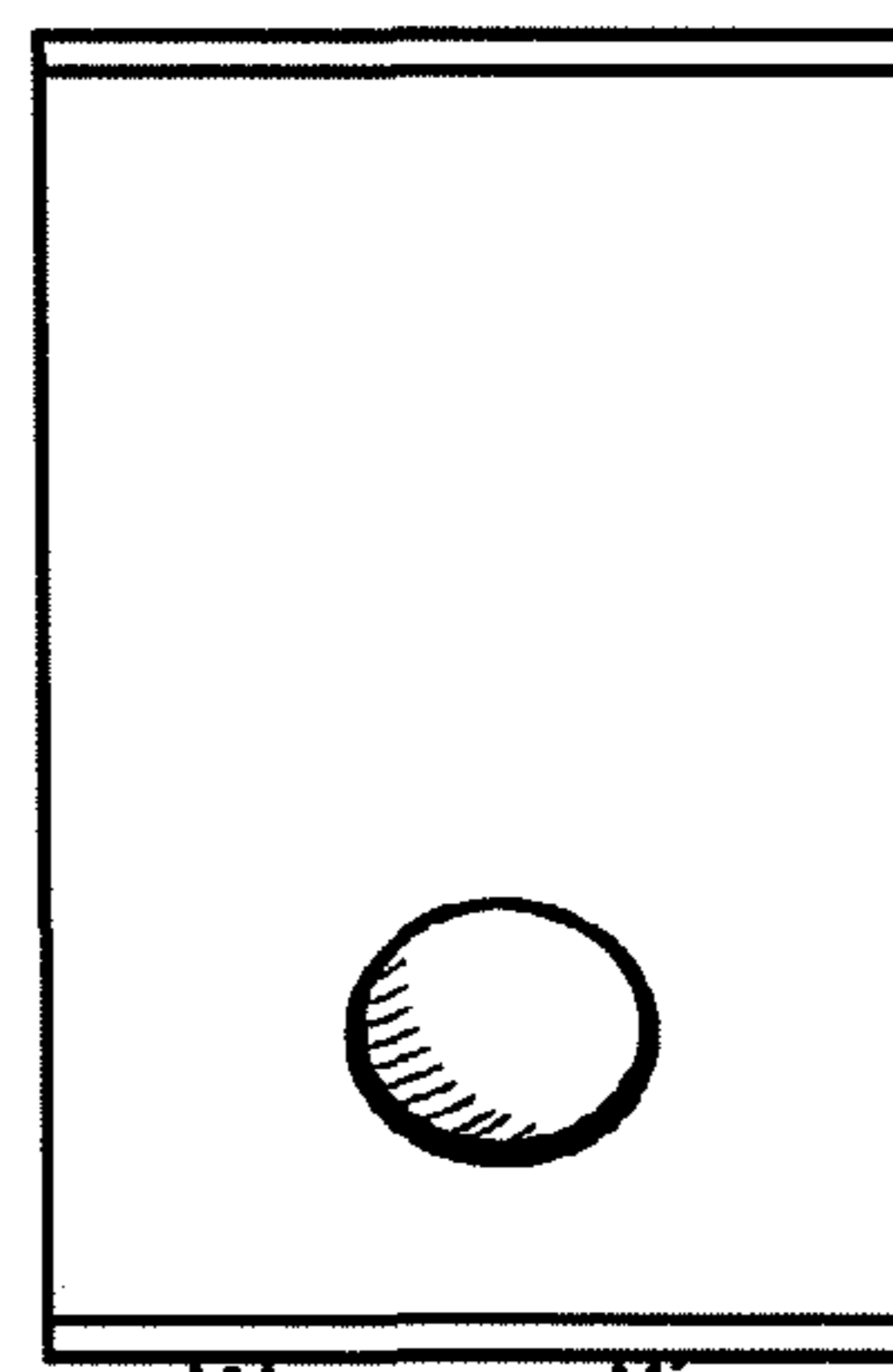

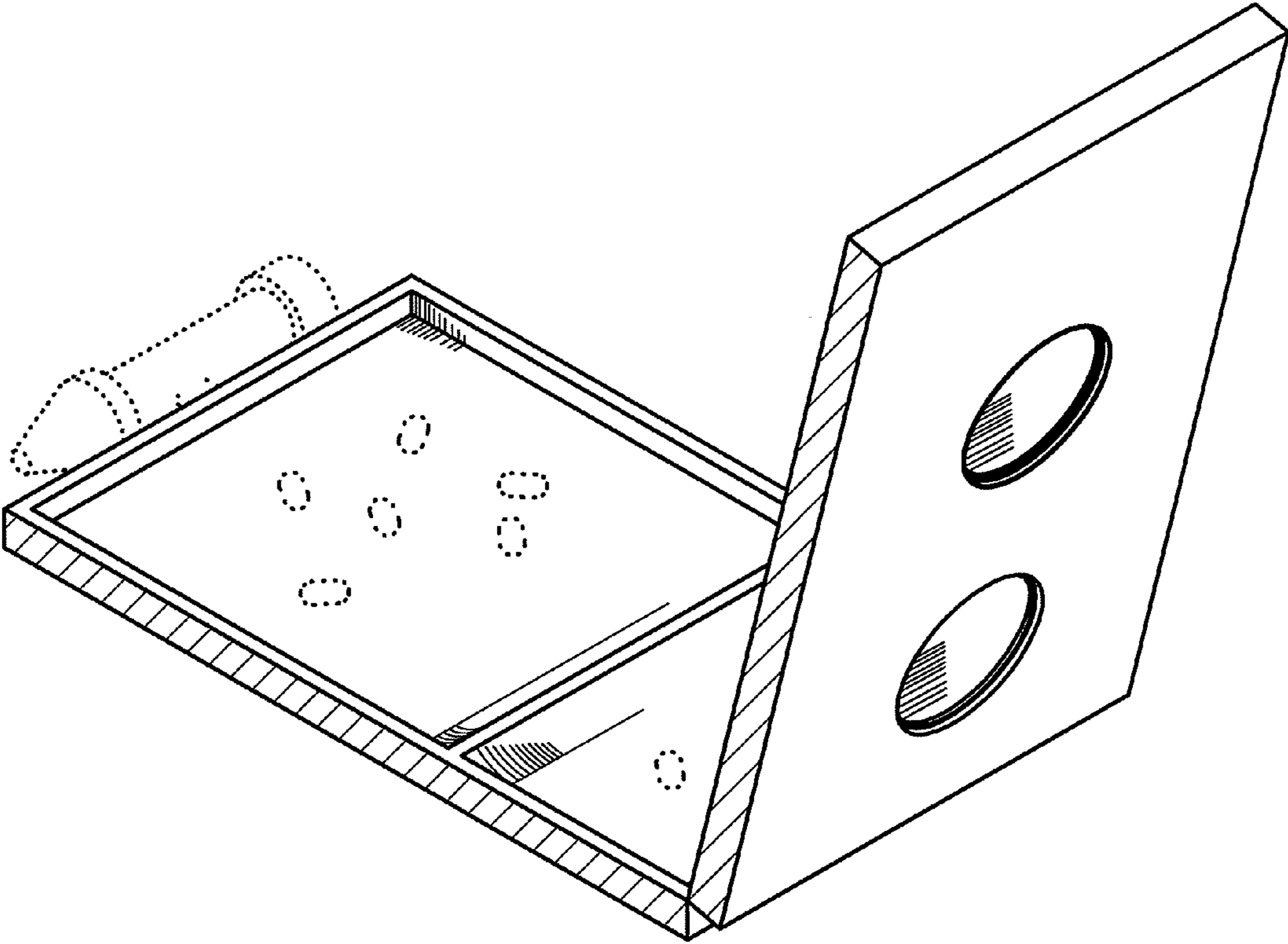

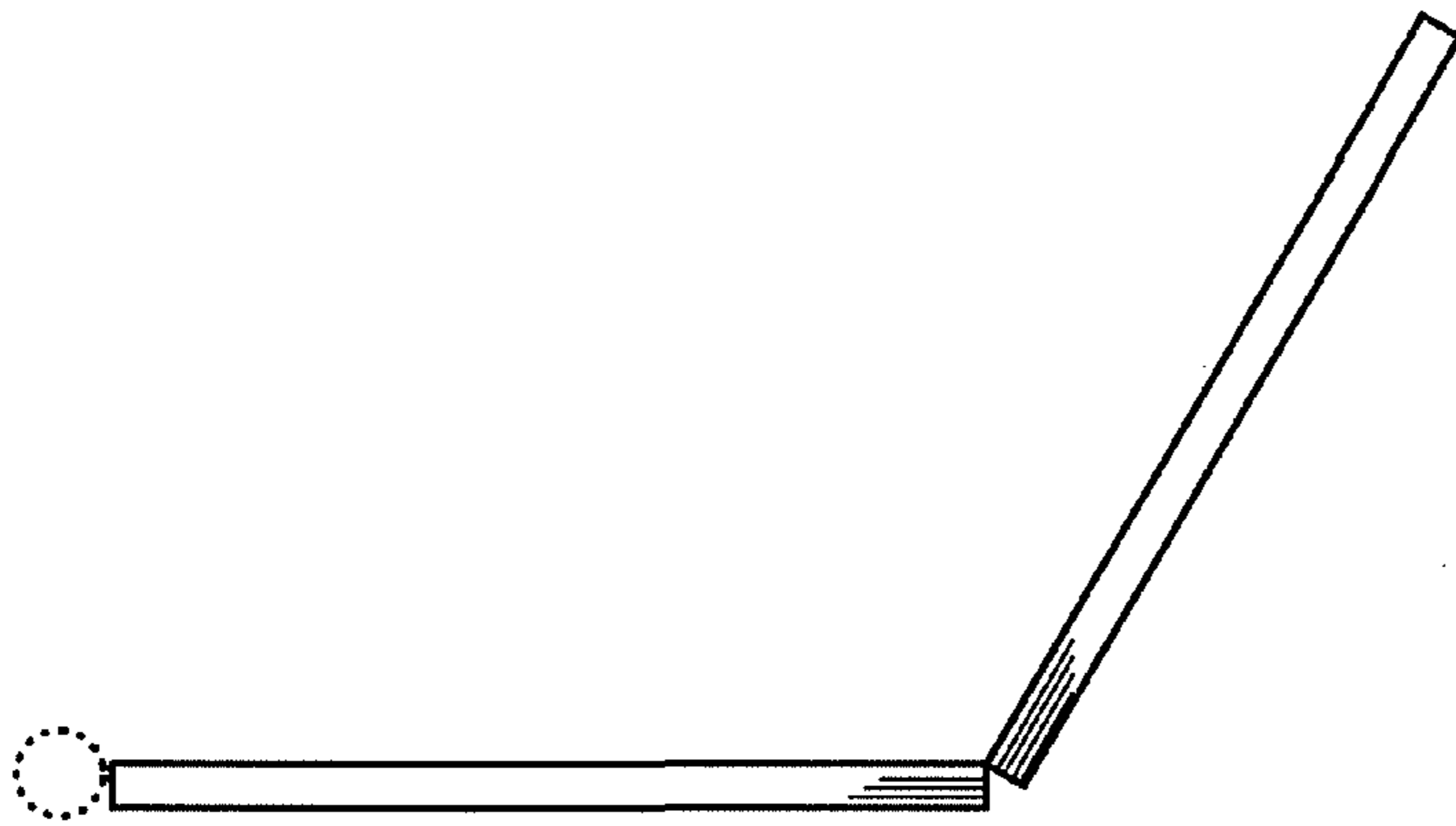

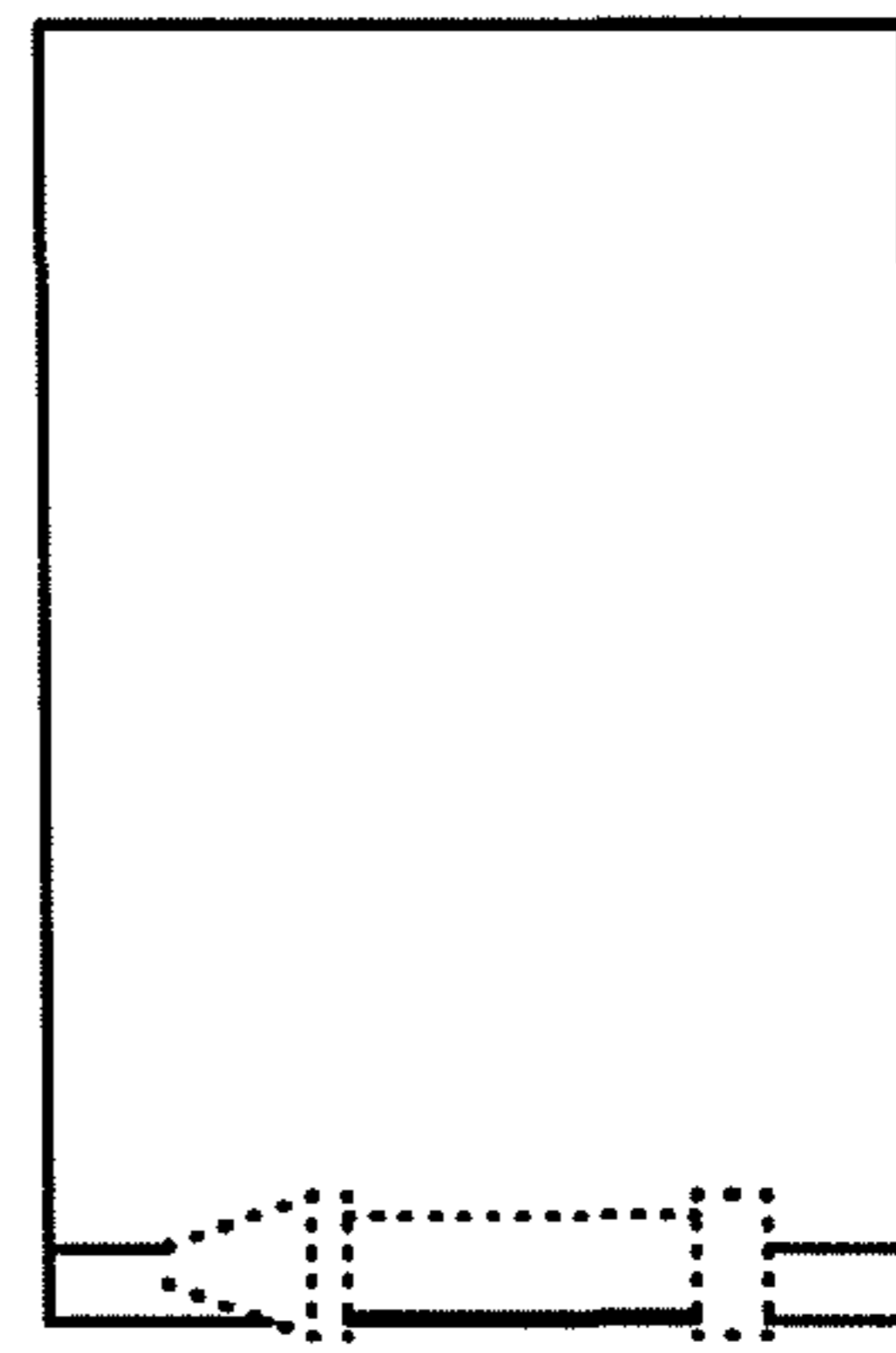

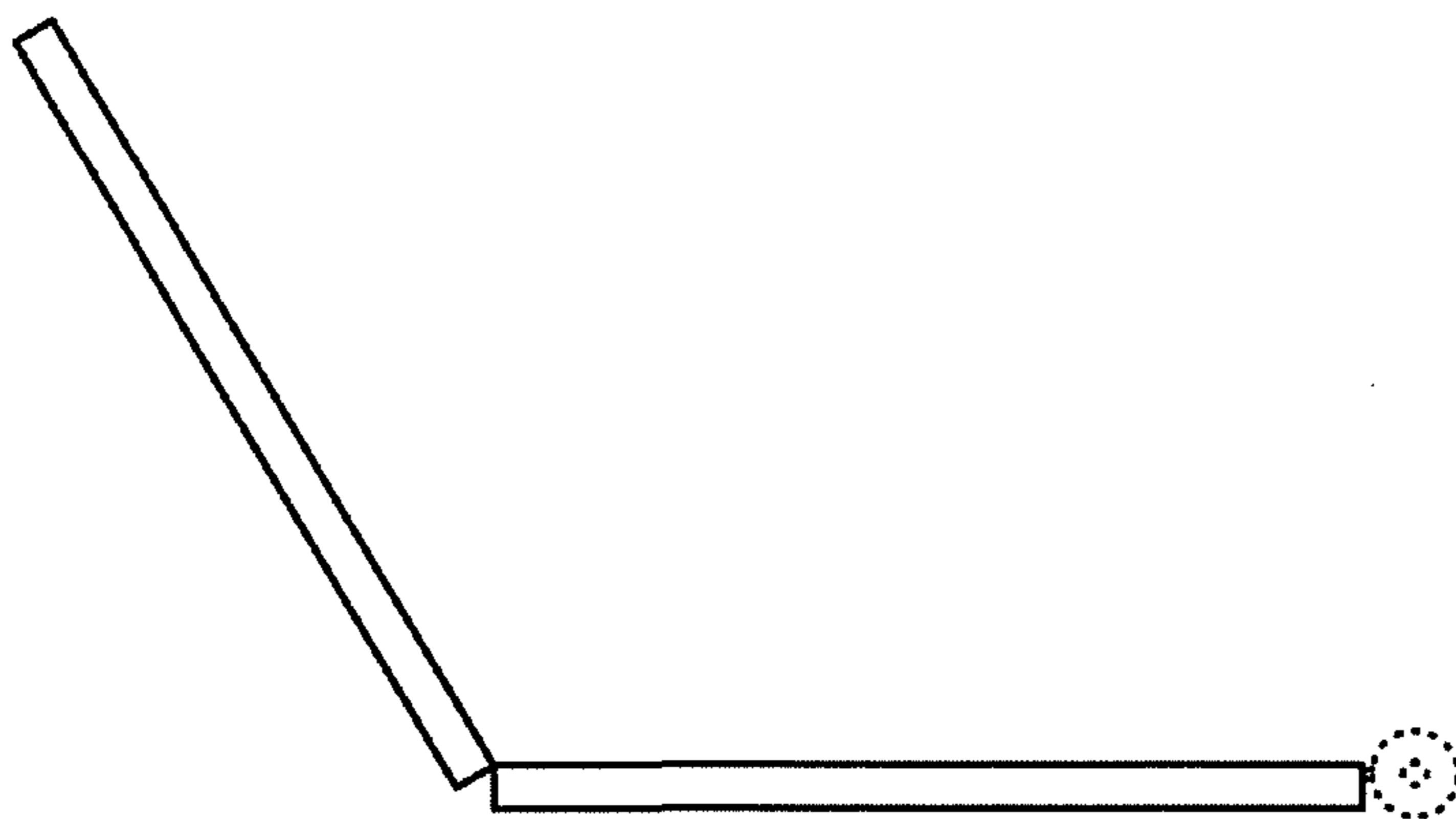
