DESCRIPTION

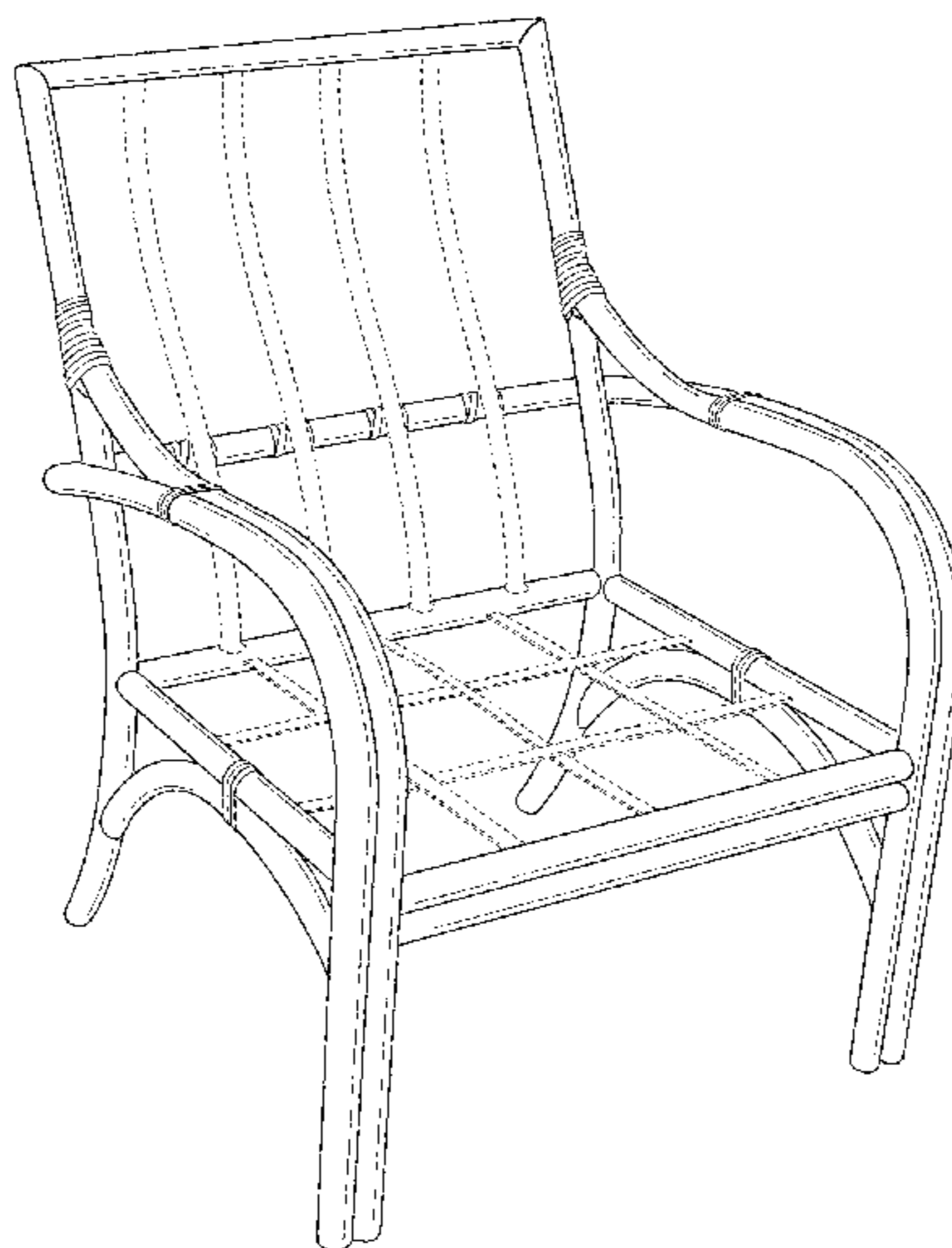

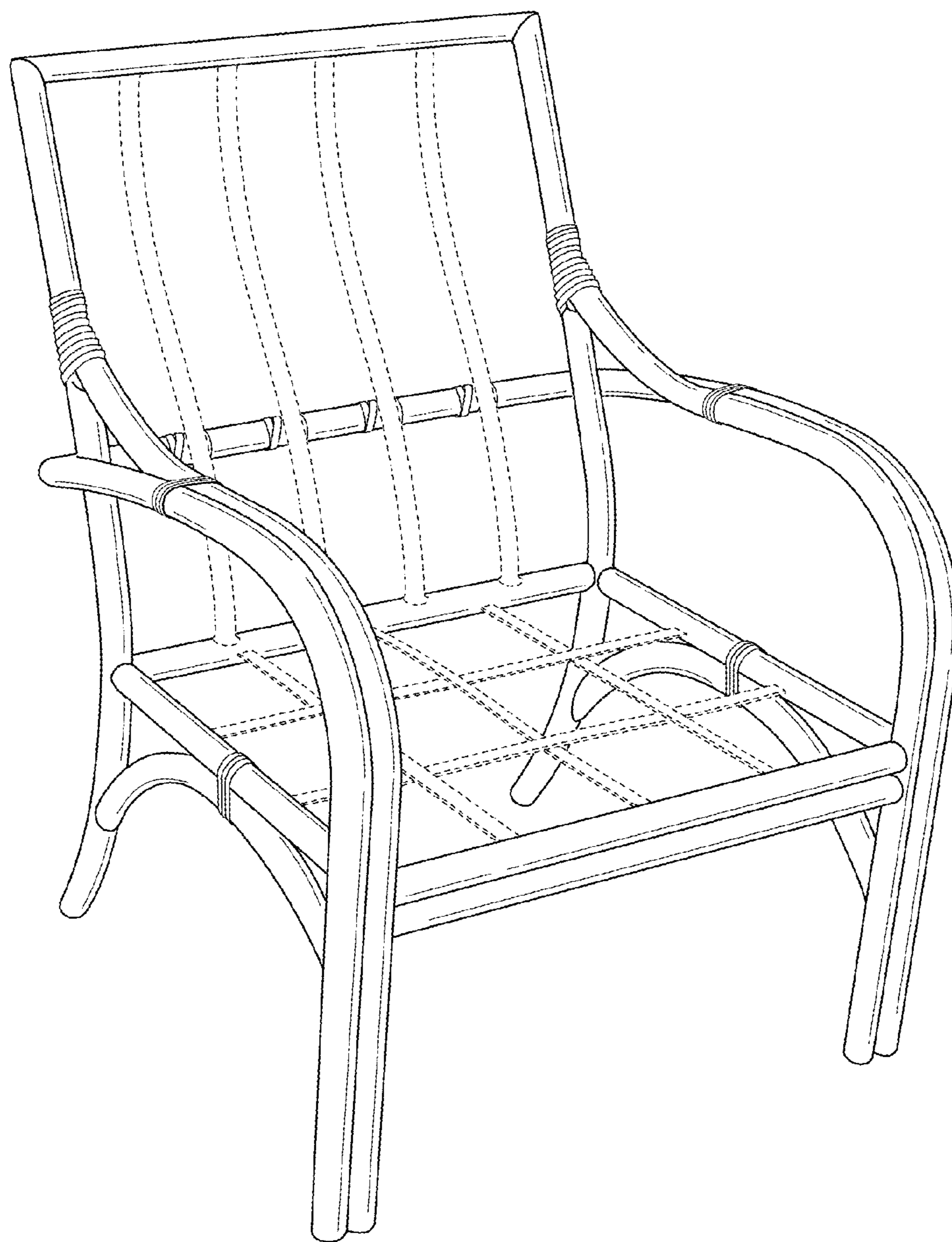

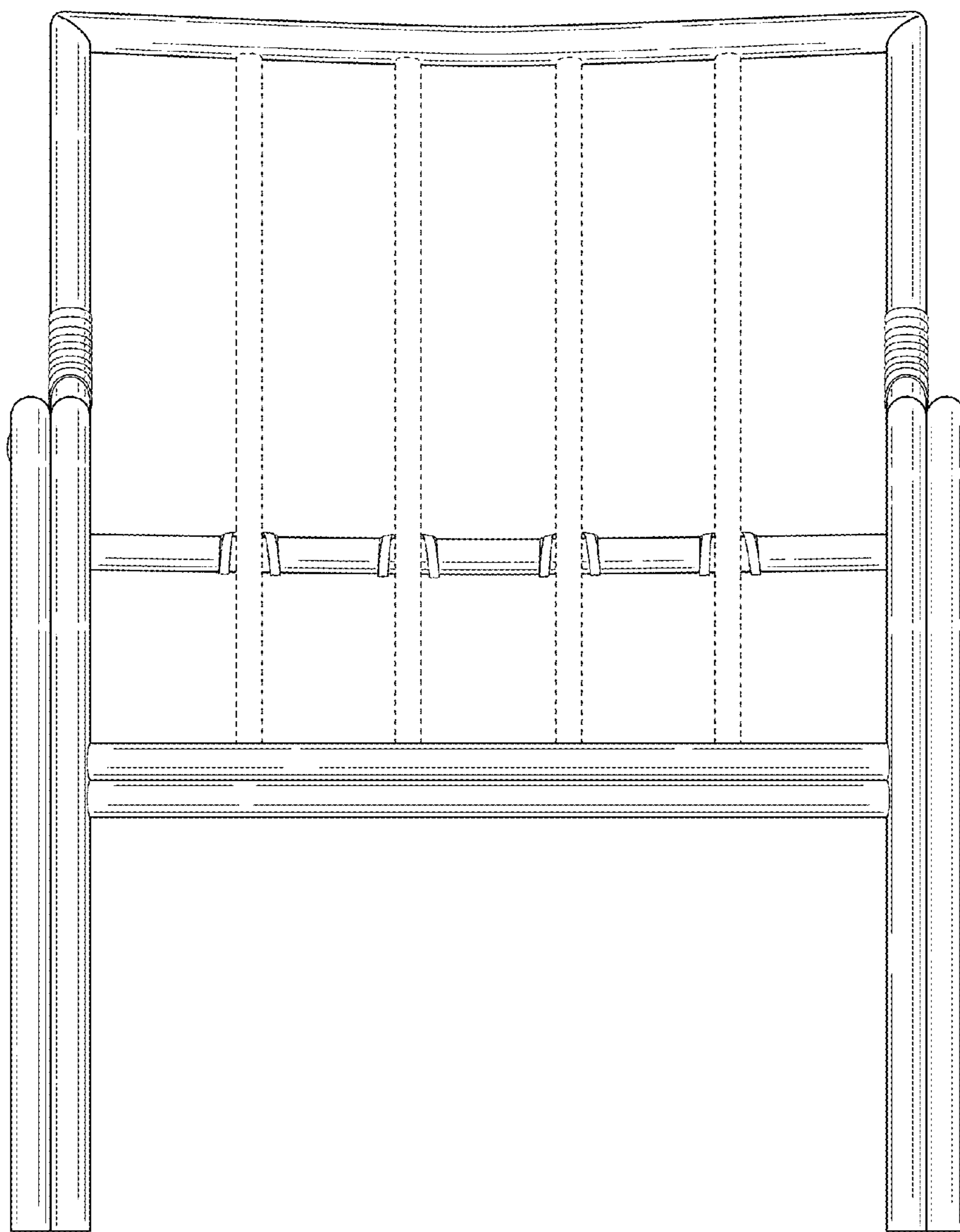

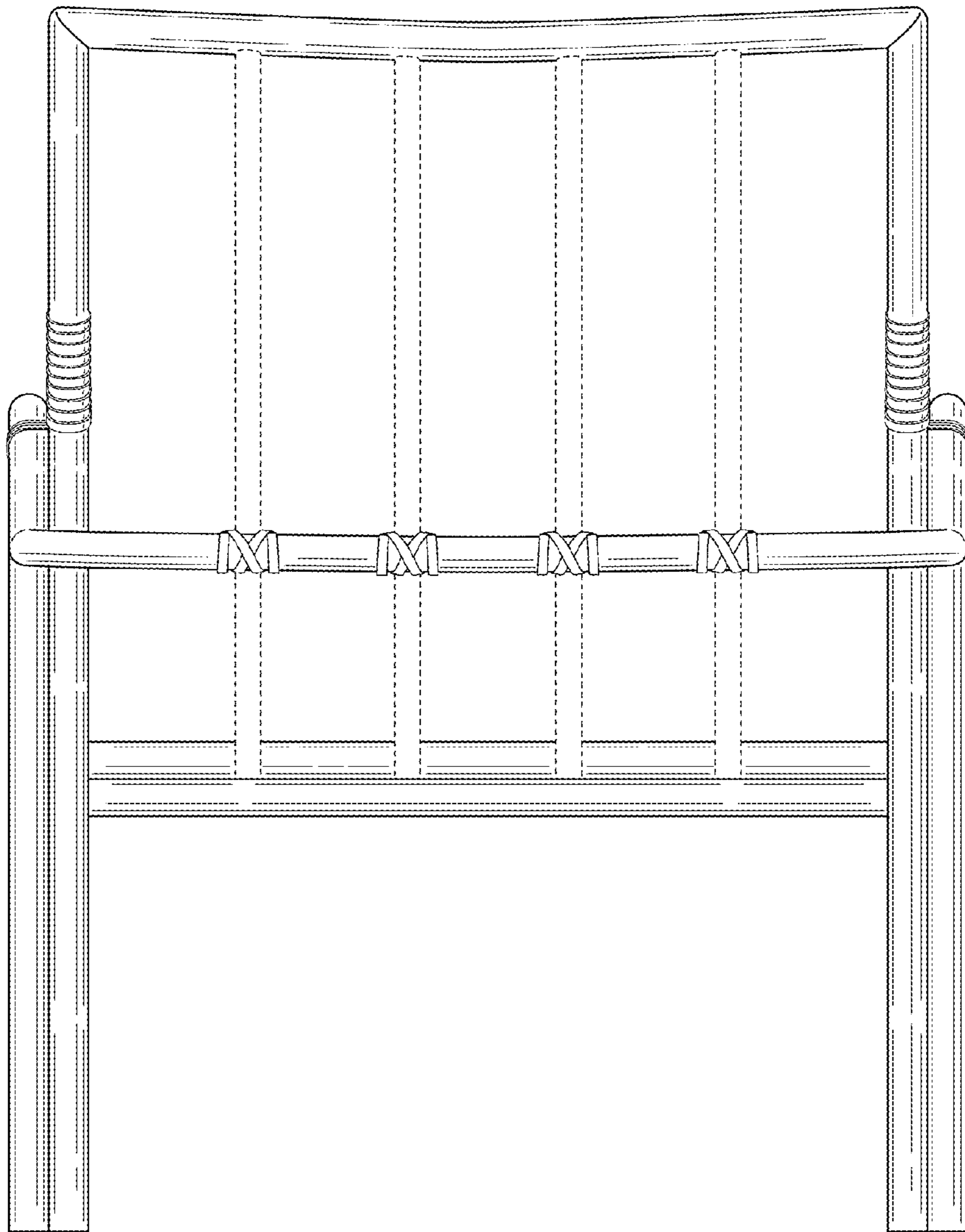

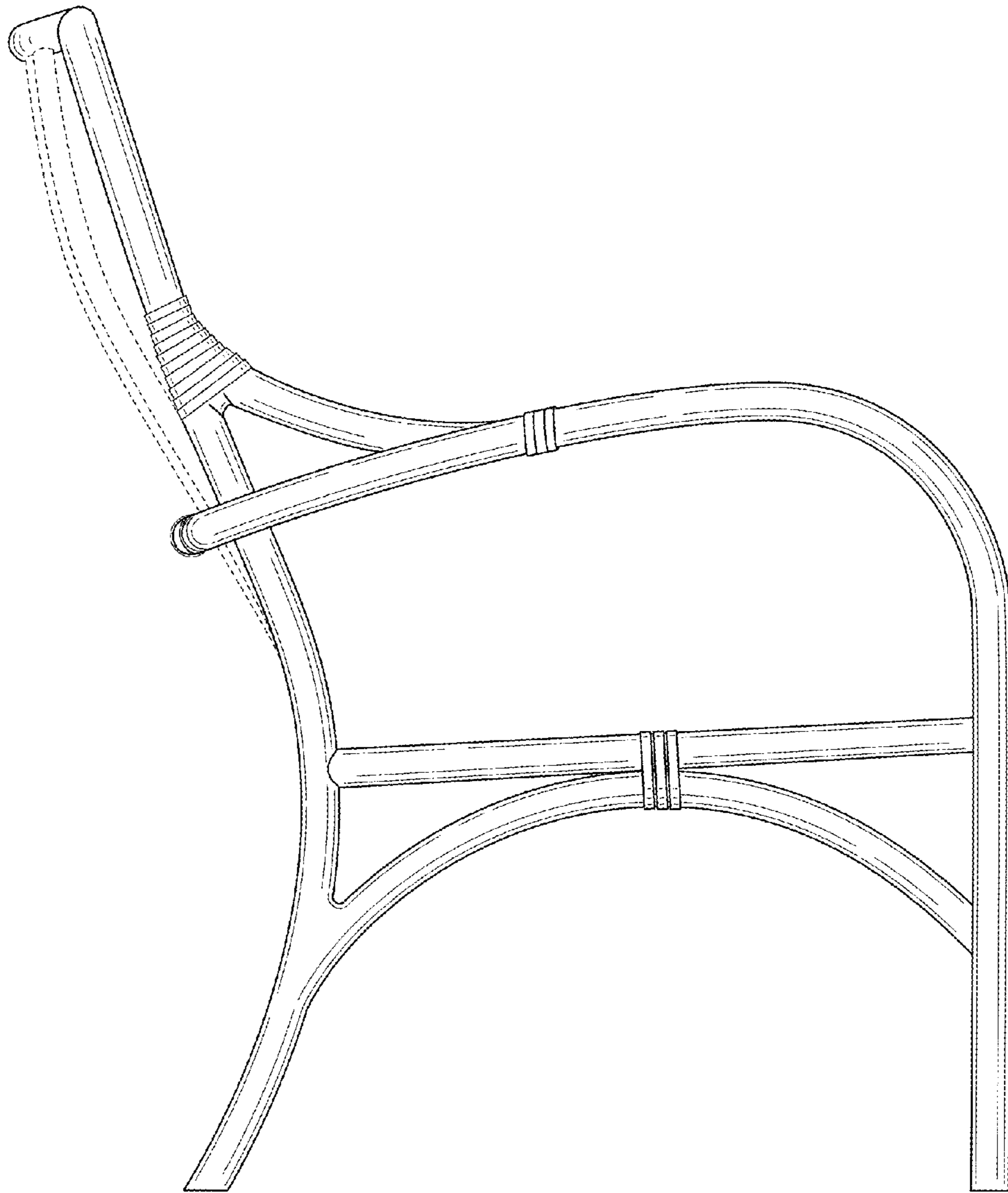

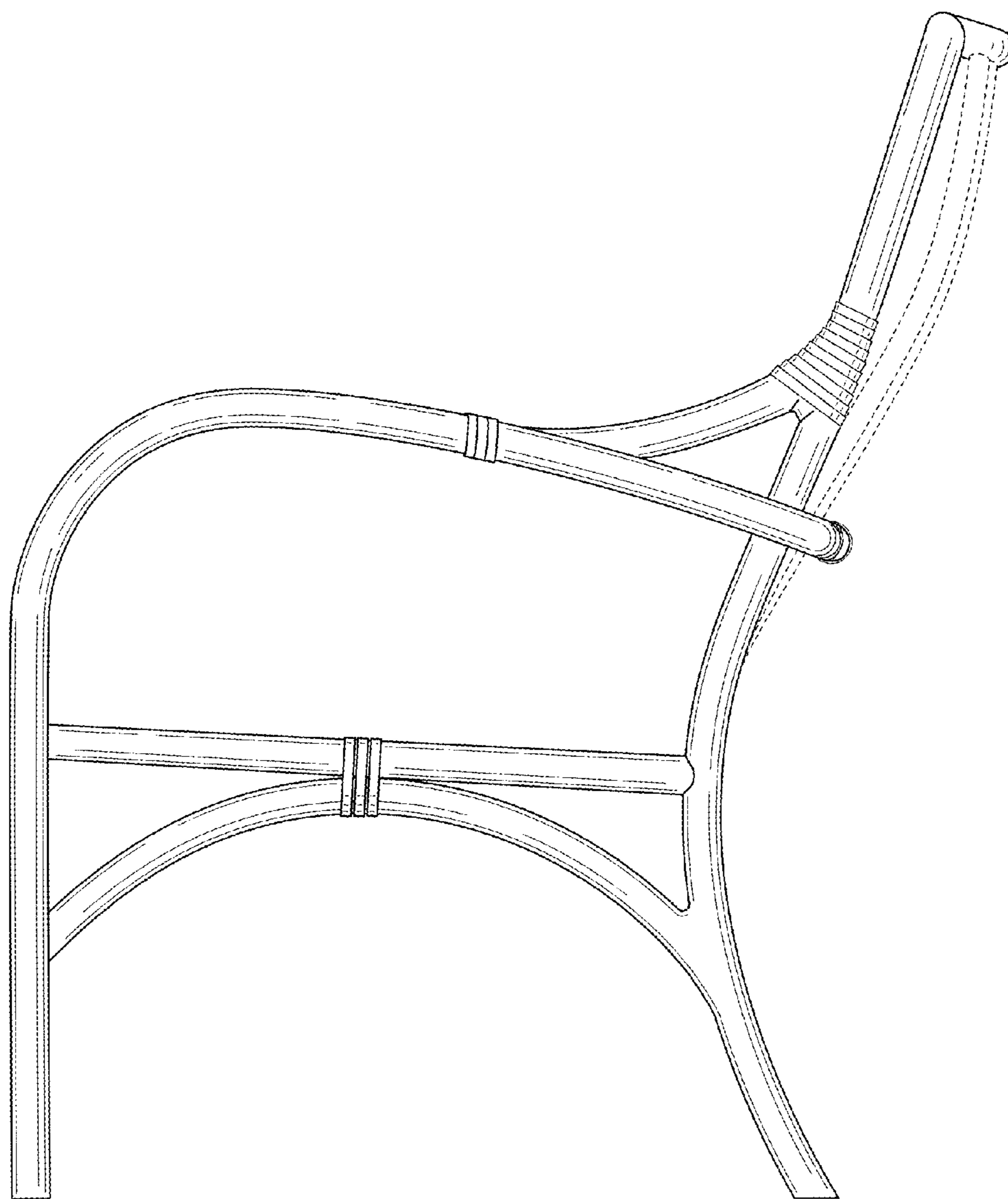

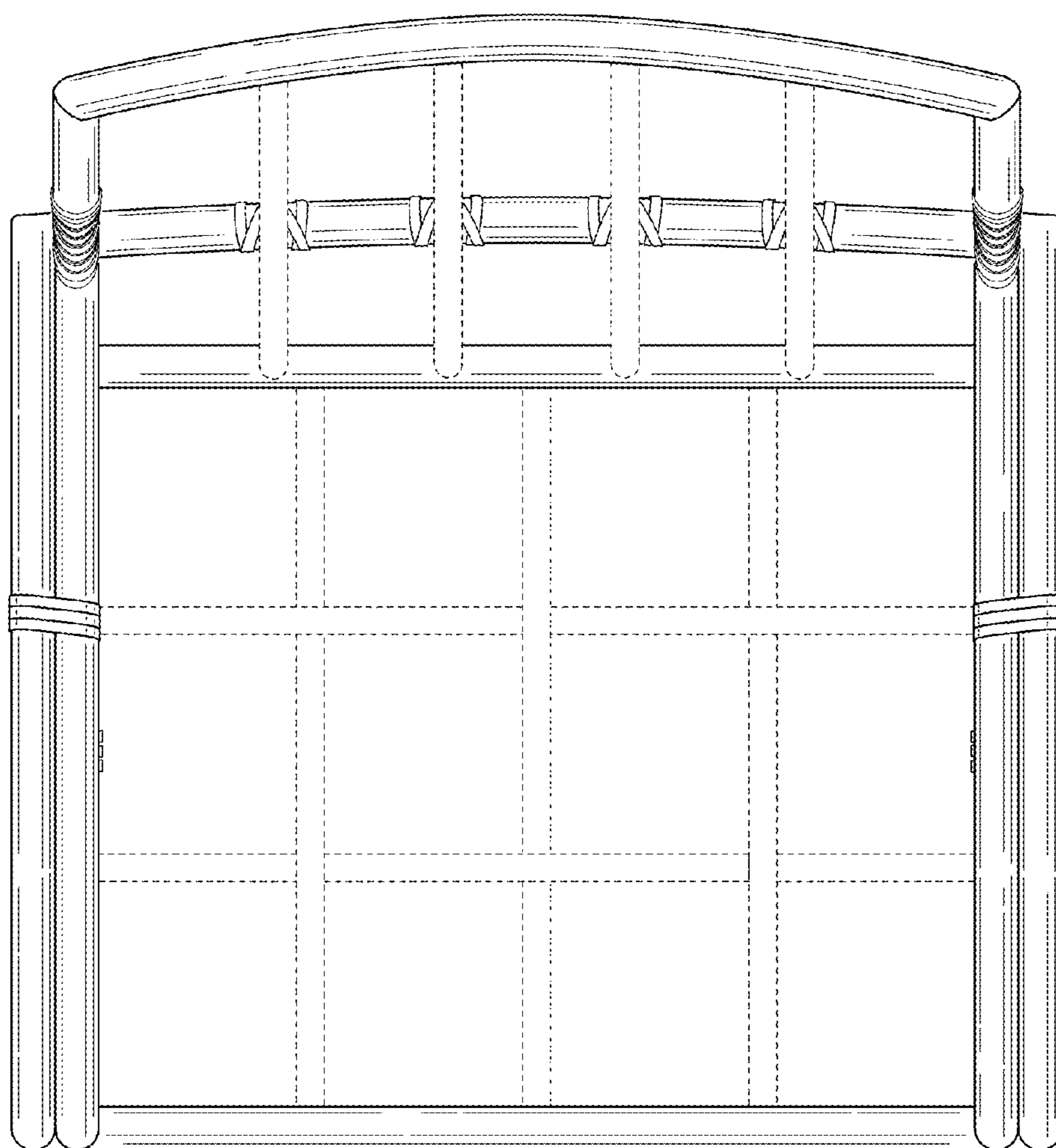

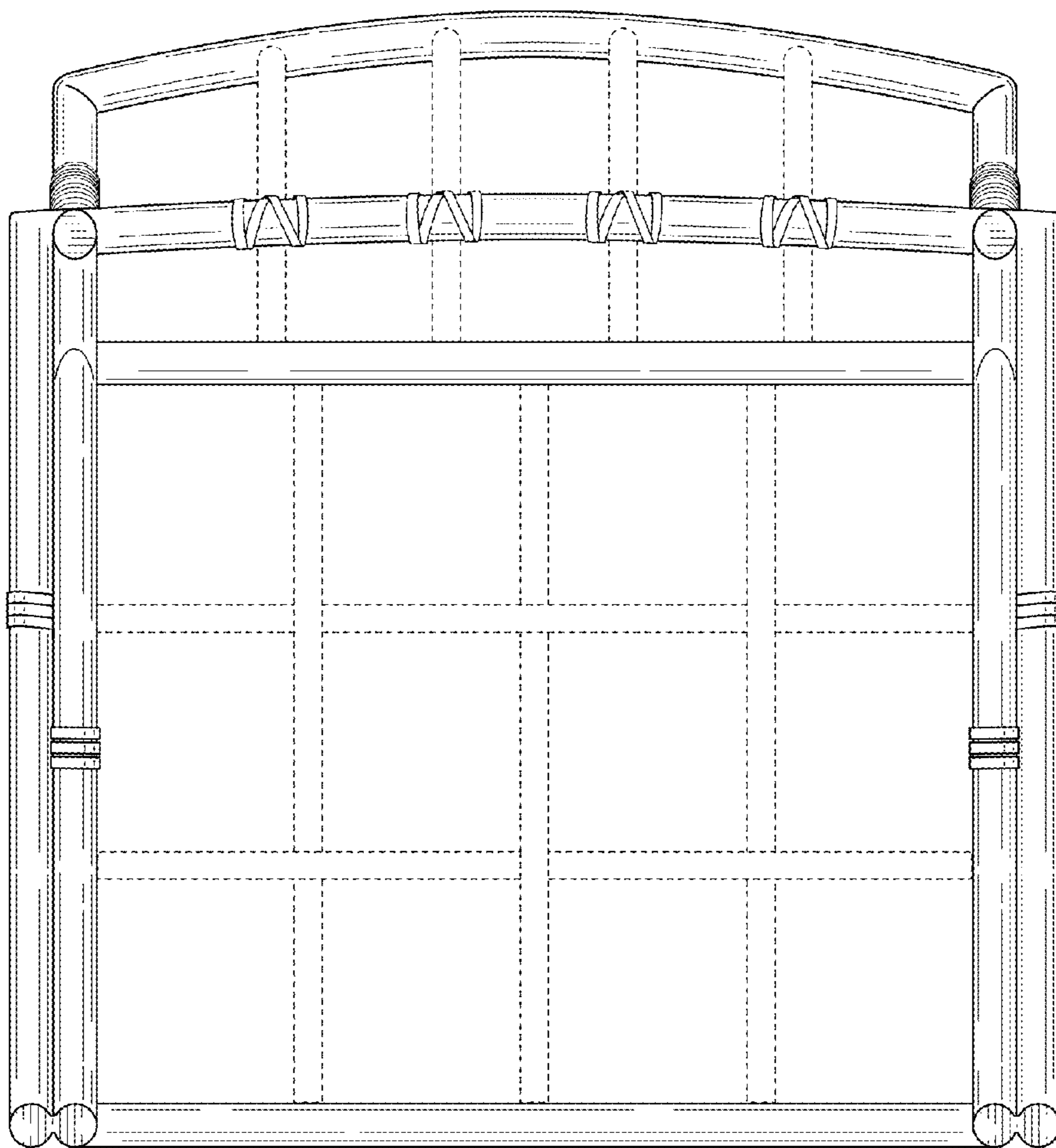

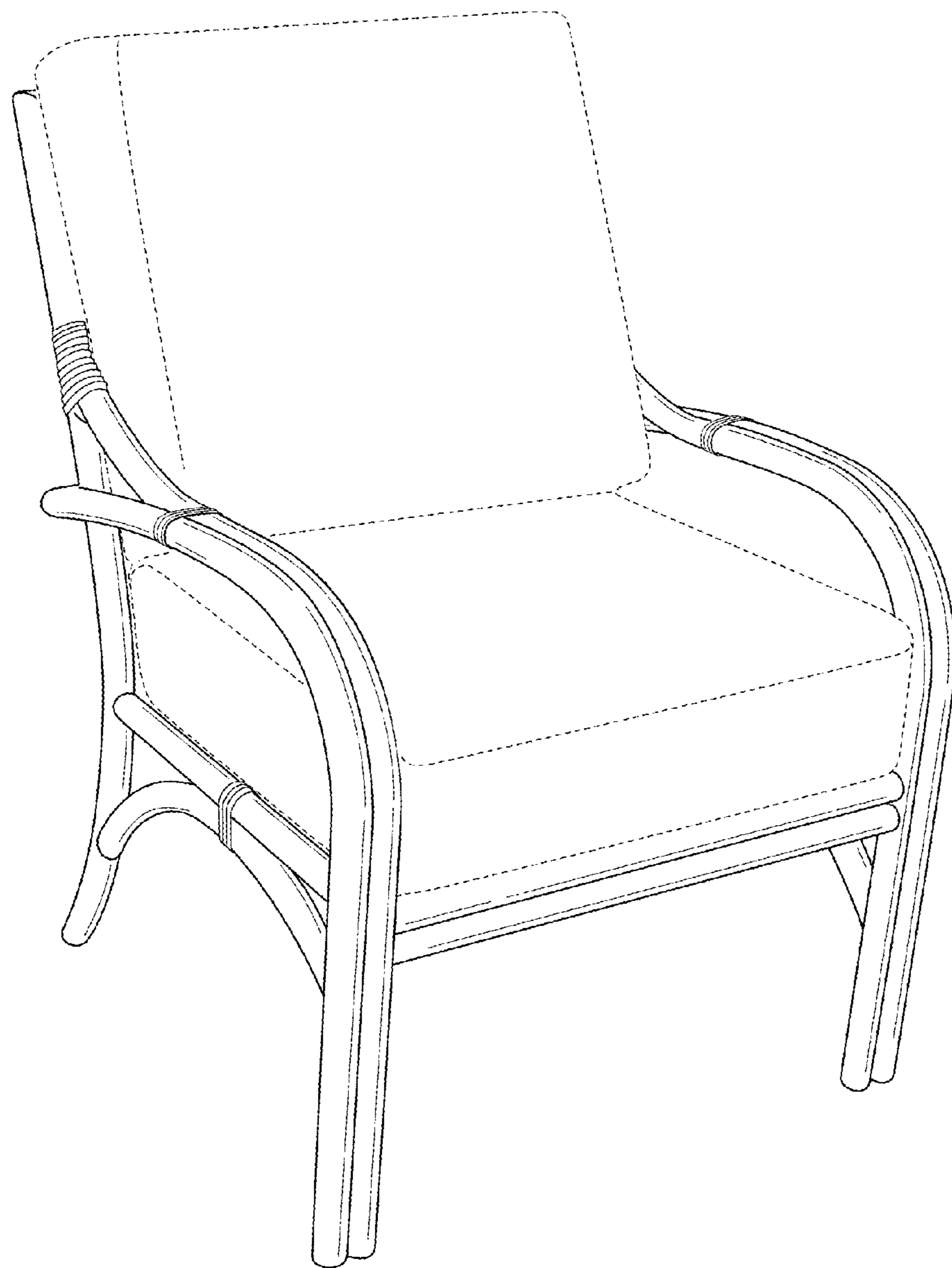
