(57) **CLAIM**

The ornamental design for bakeware with covered rim, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of bakeware with a covered rim; FIG. 2 is a top plan view of the bakeware with the covered rim of FIG. 1;

FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a front elevational view thereof.

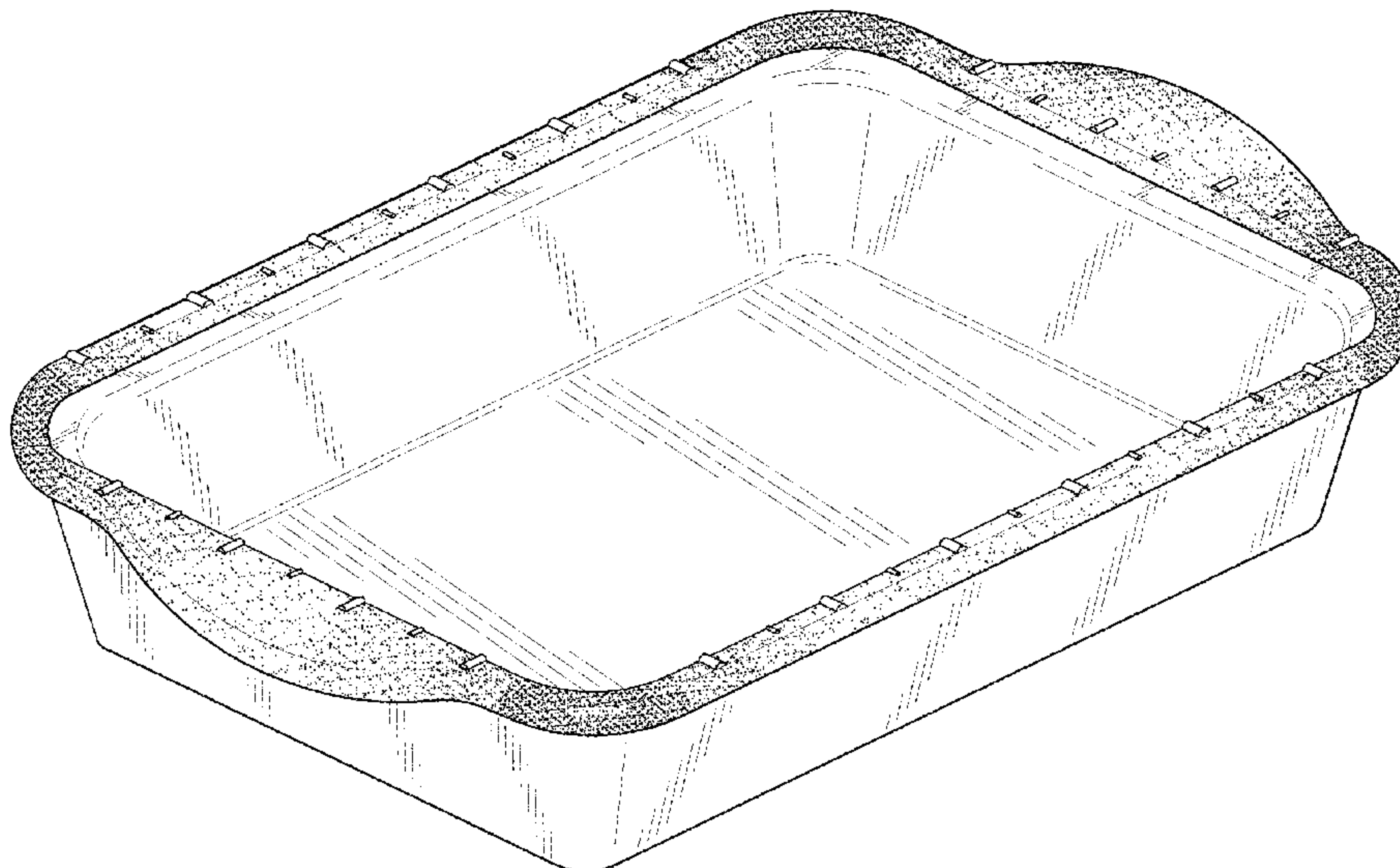

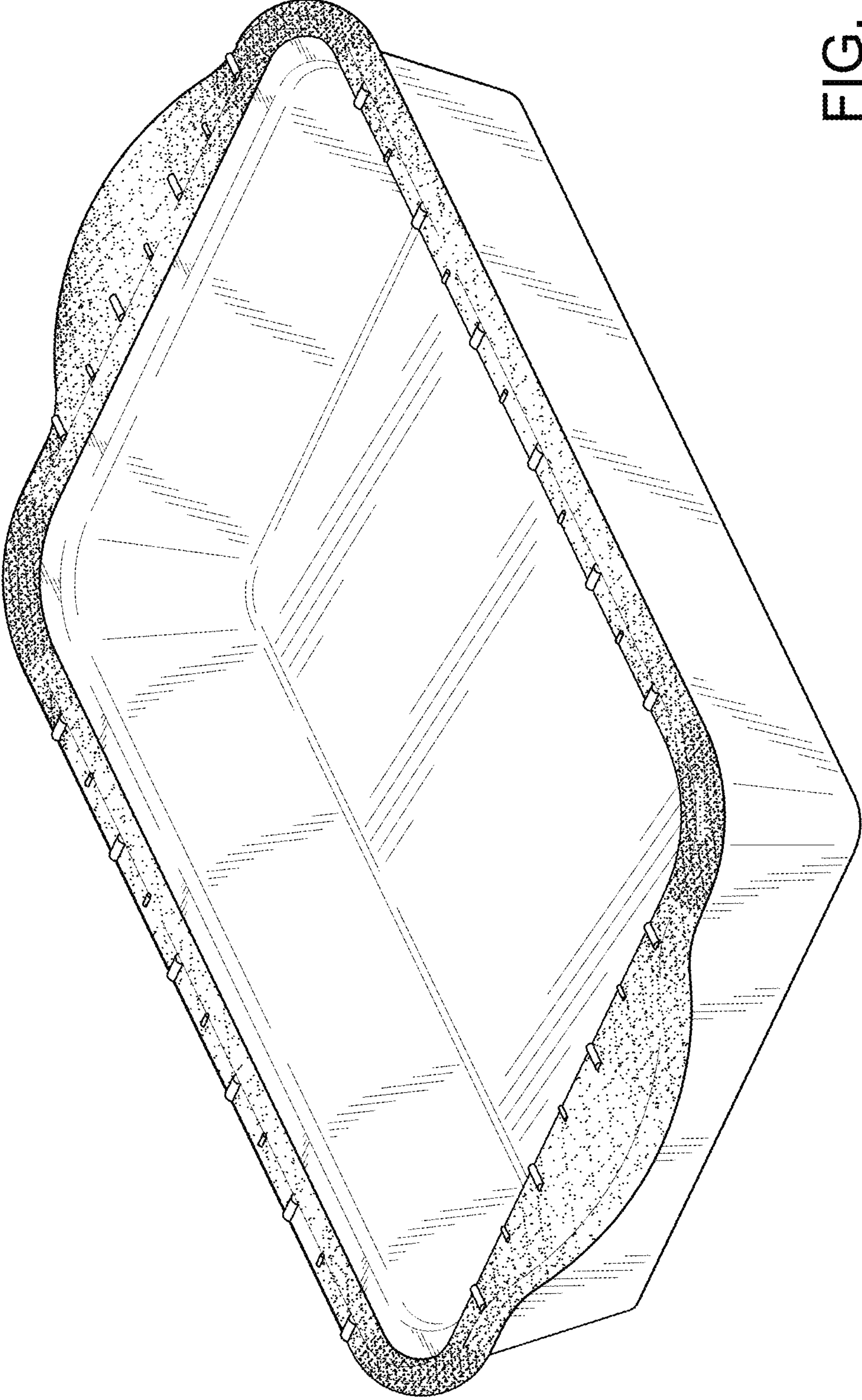

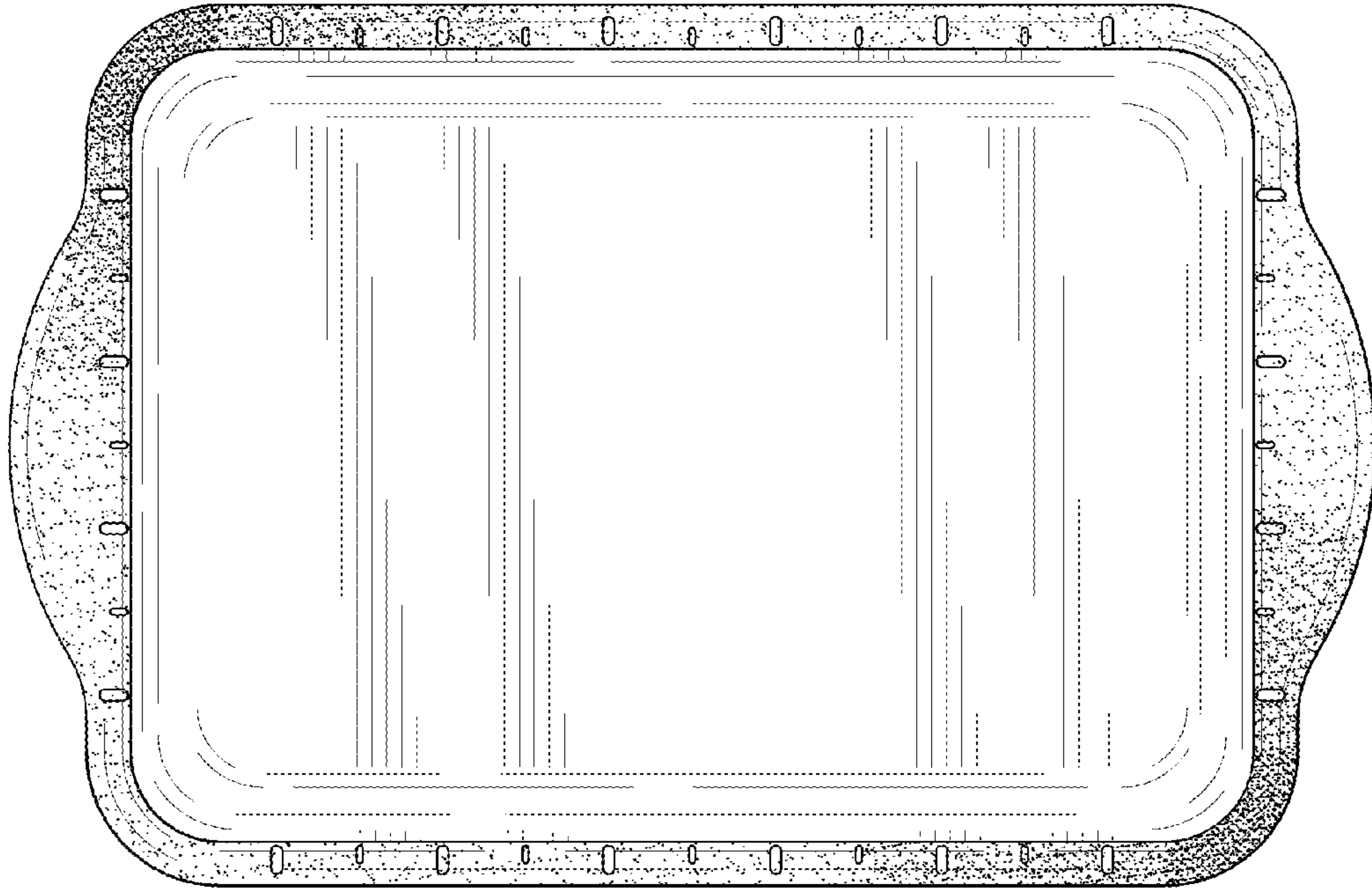

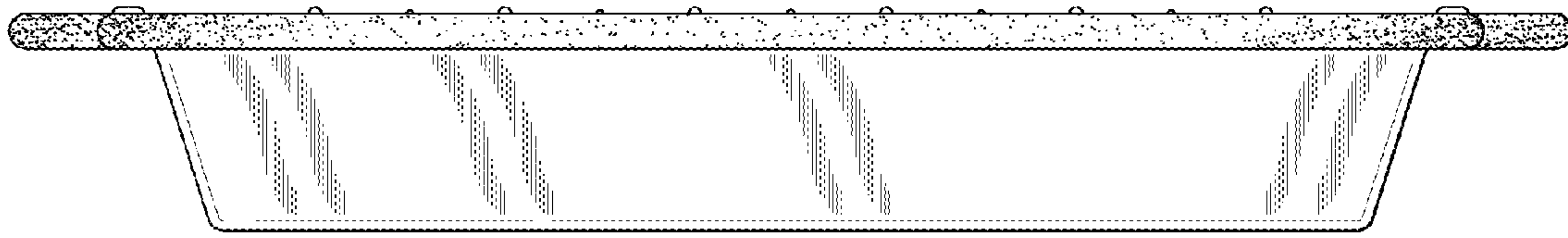

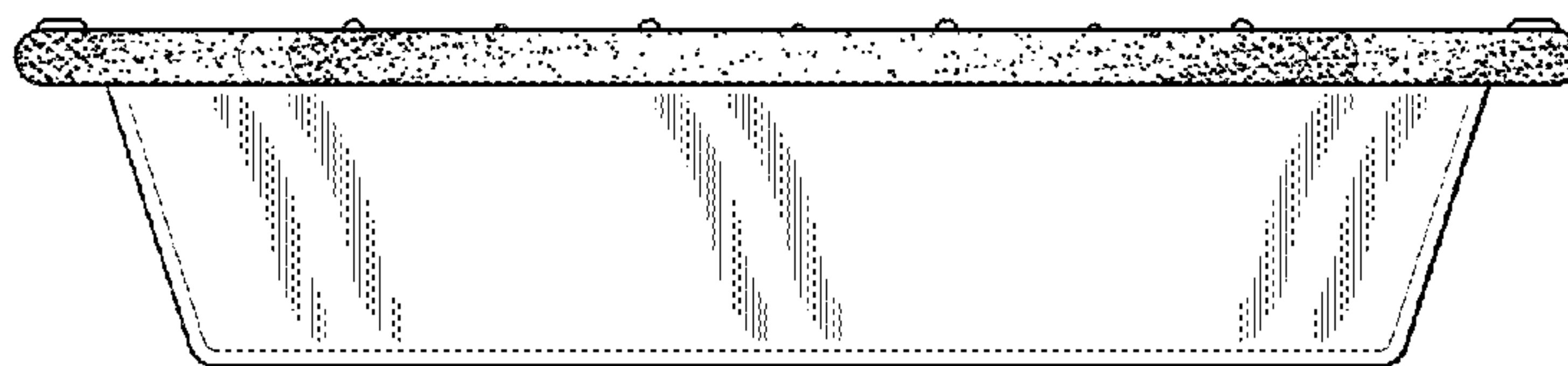
