FIG. 3 is a bottom view of the hot beverage cup lid;

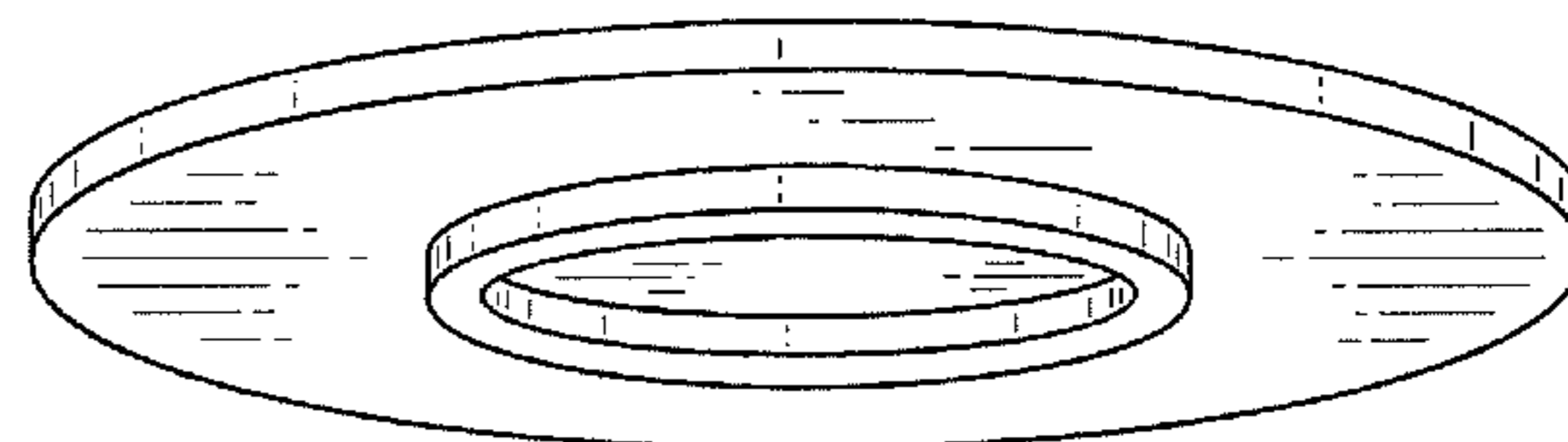
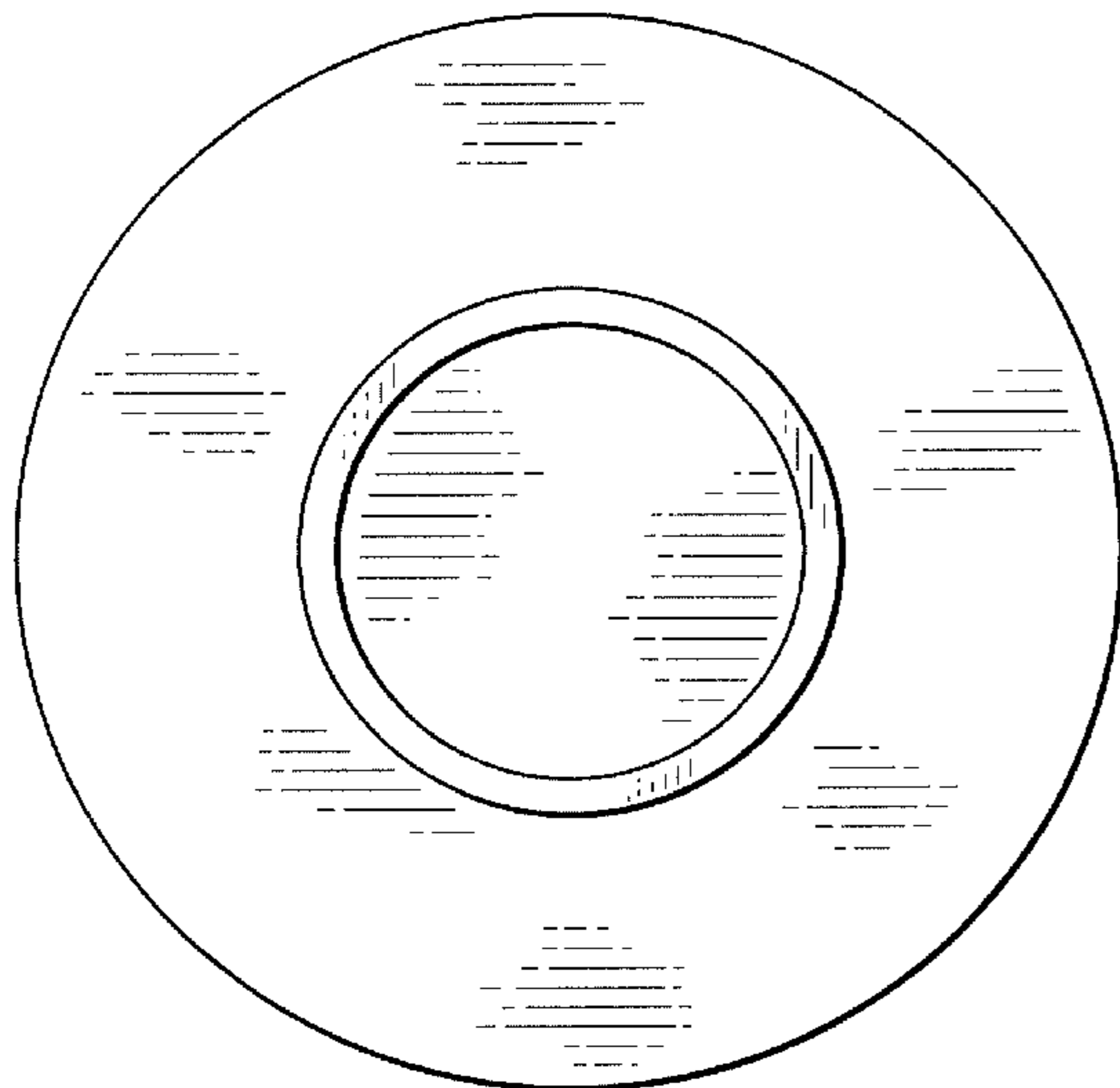
FIG. 4 is a front view of the hot beverage cup lid;

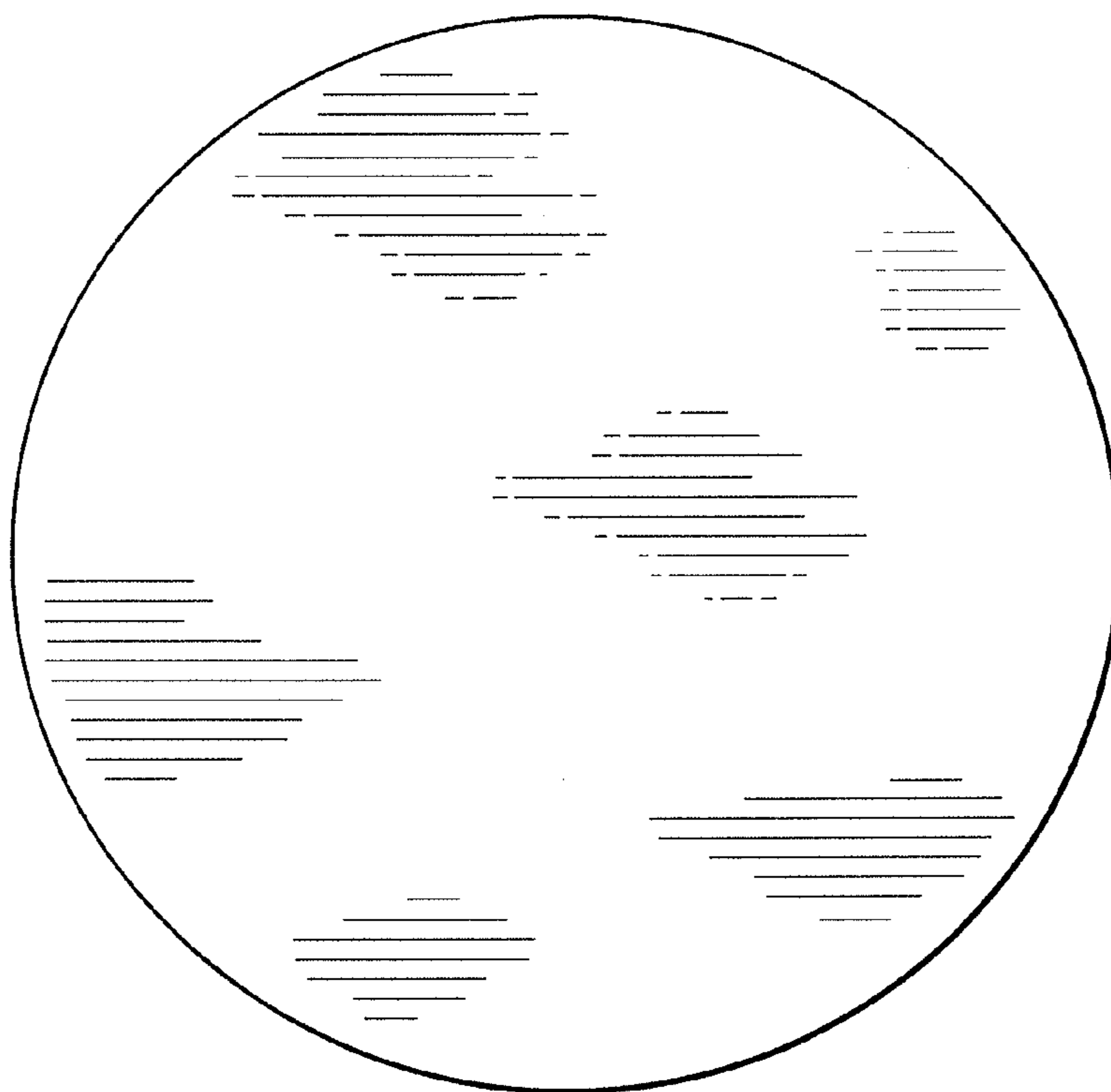

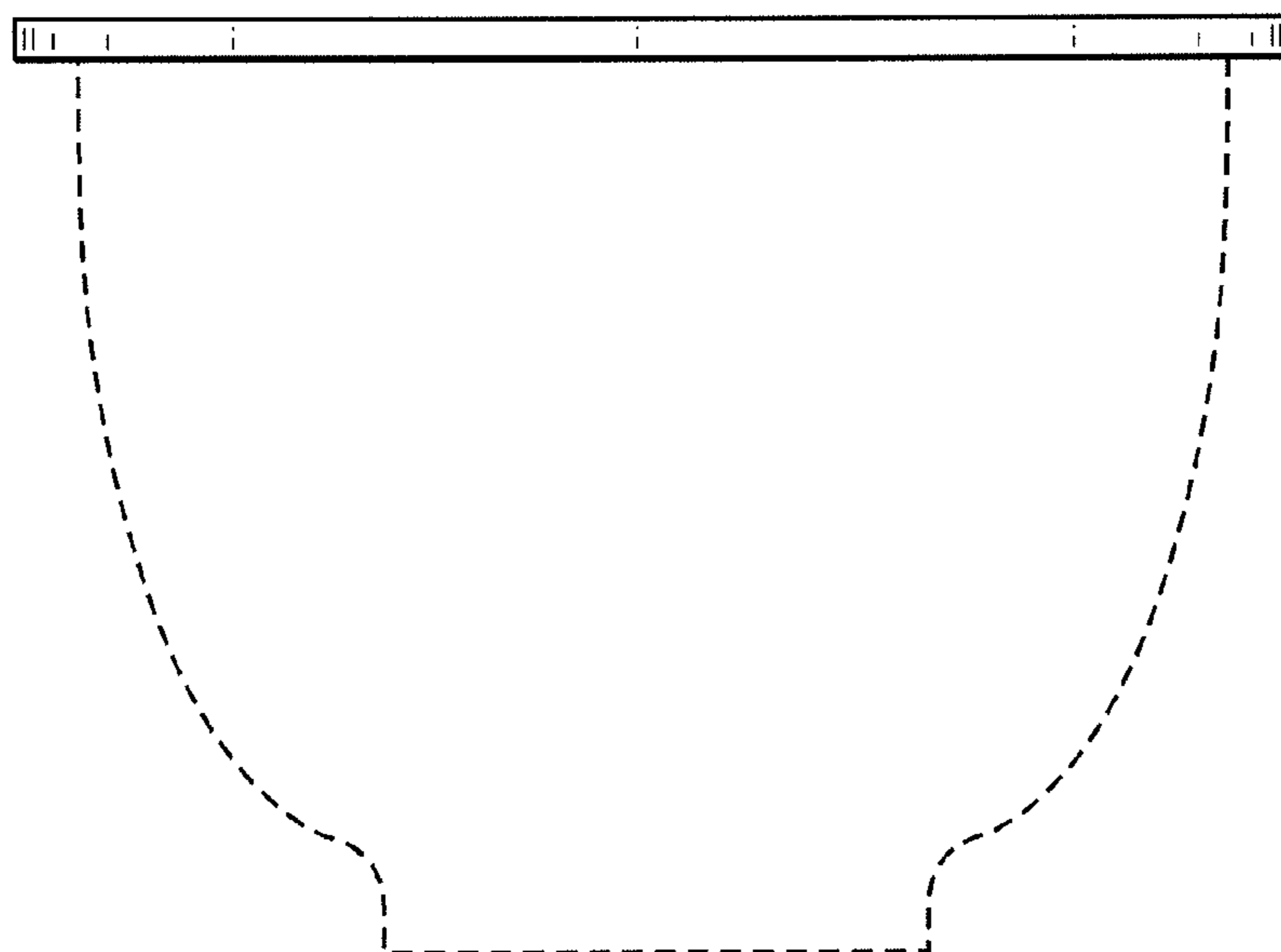

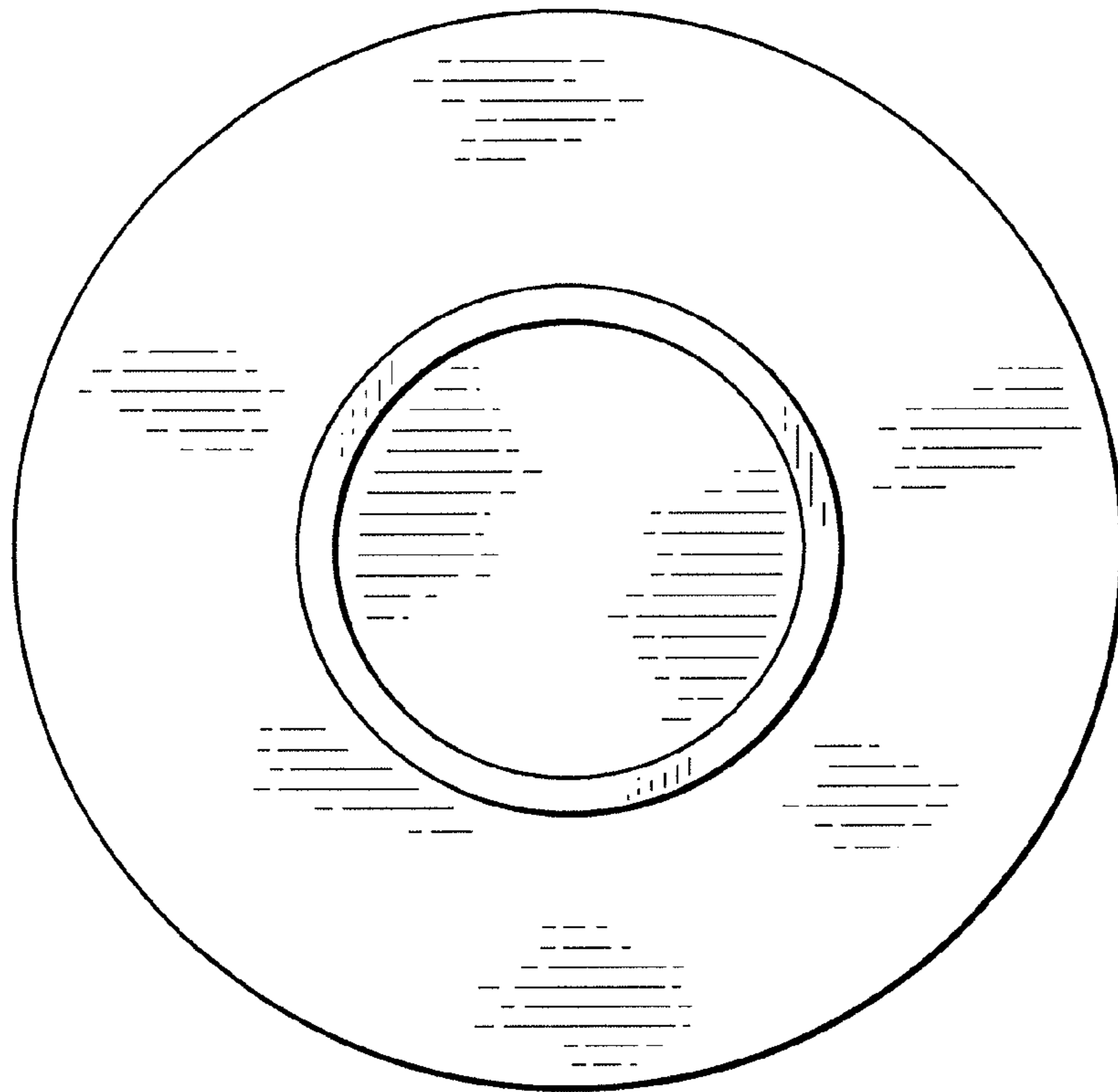

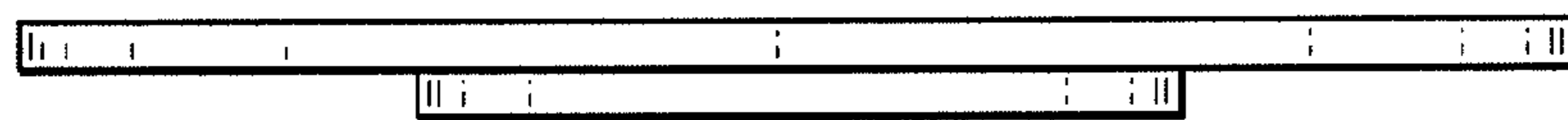

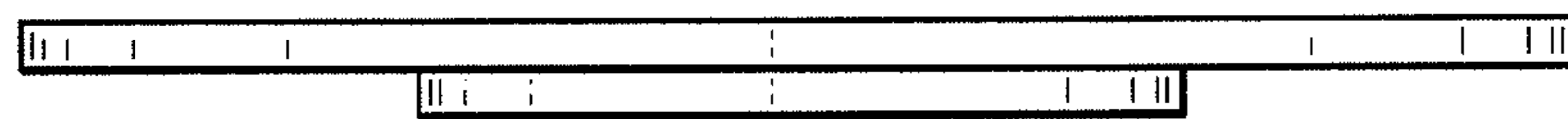

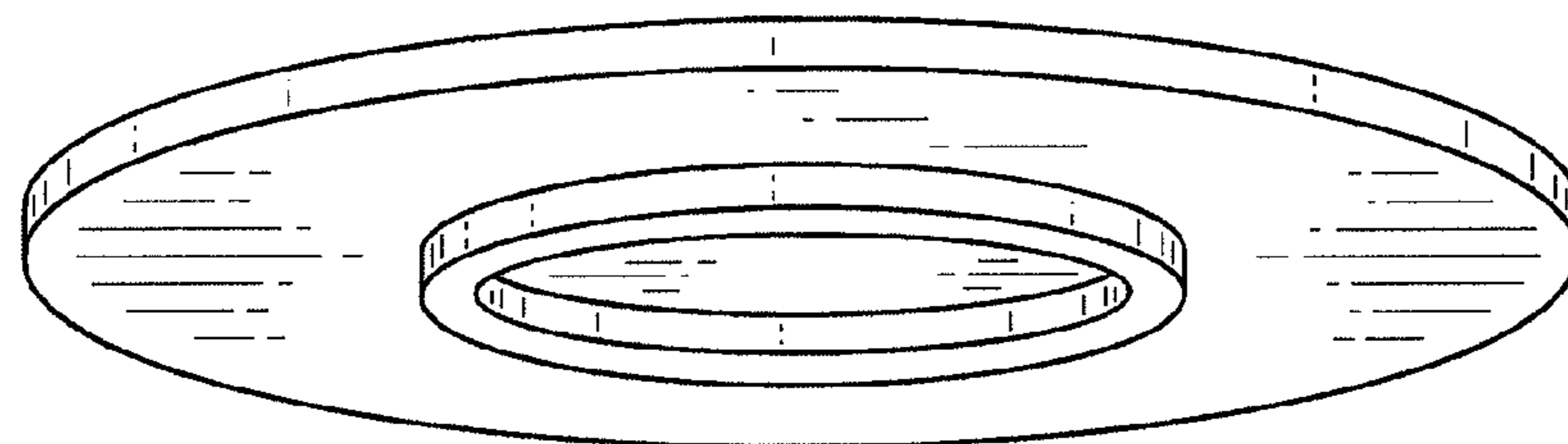
