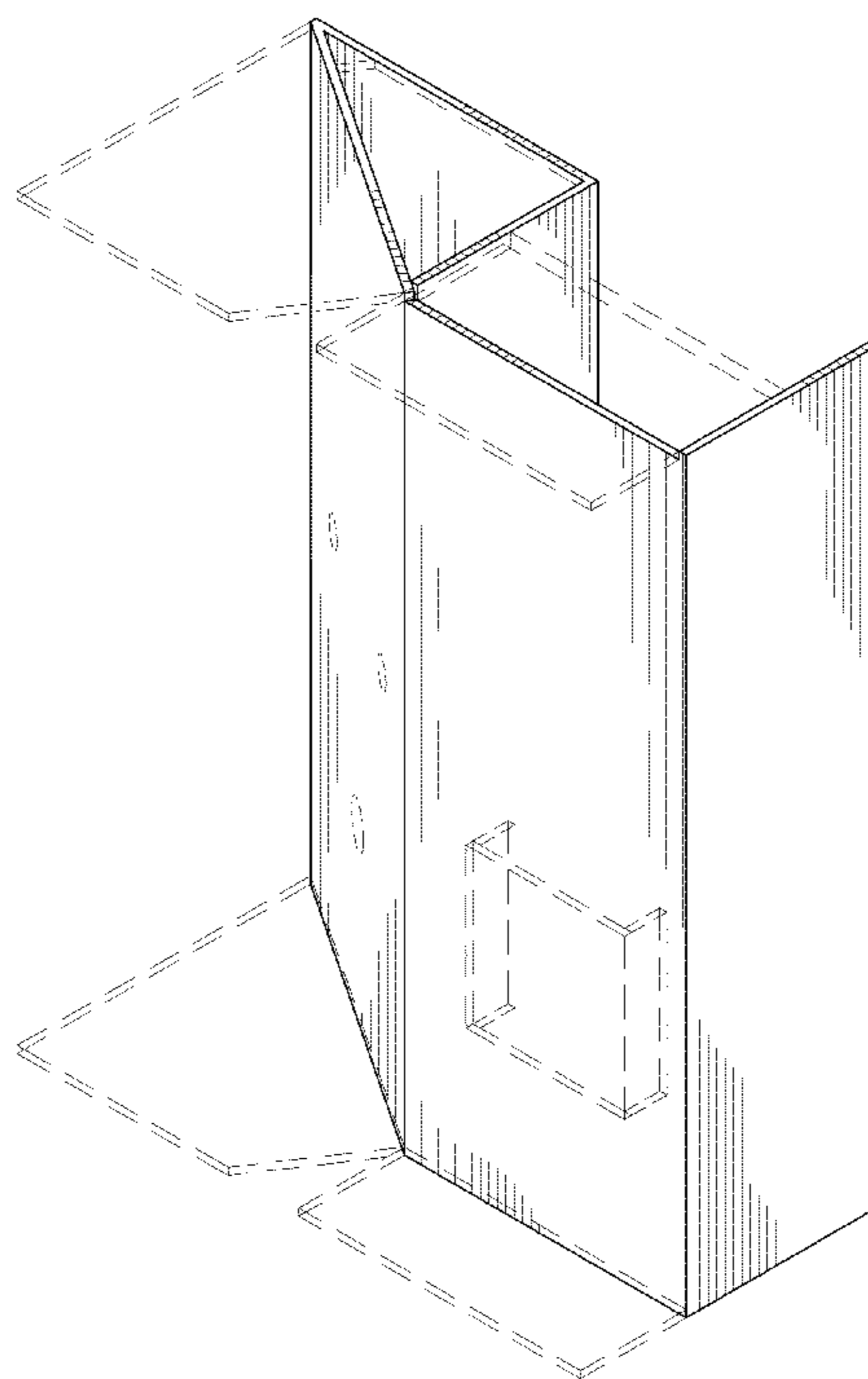
(57) **CLAIM**

The ornamental design for a mounting plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mounting plate showing our design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a top view of the mounting plate in an unfolded state.  
The broken lines in FIGS. 1-8 are for illustrative purposes only and form no part of the claimed design.

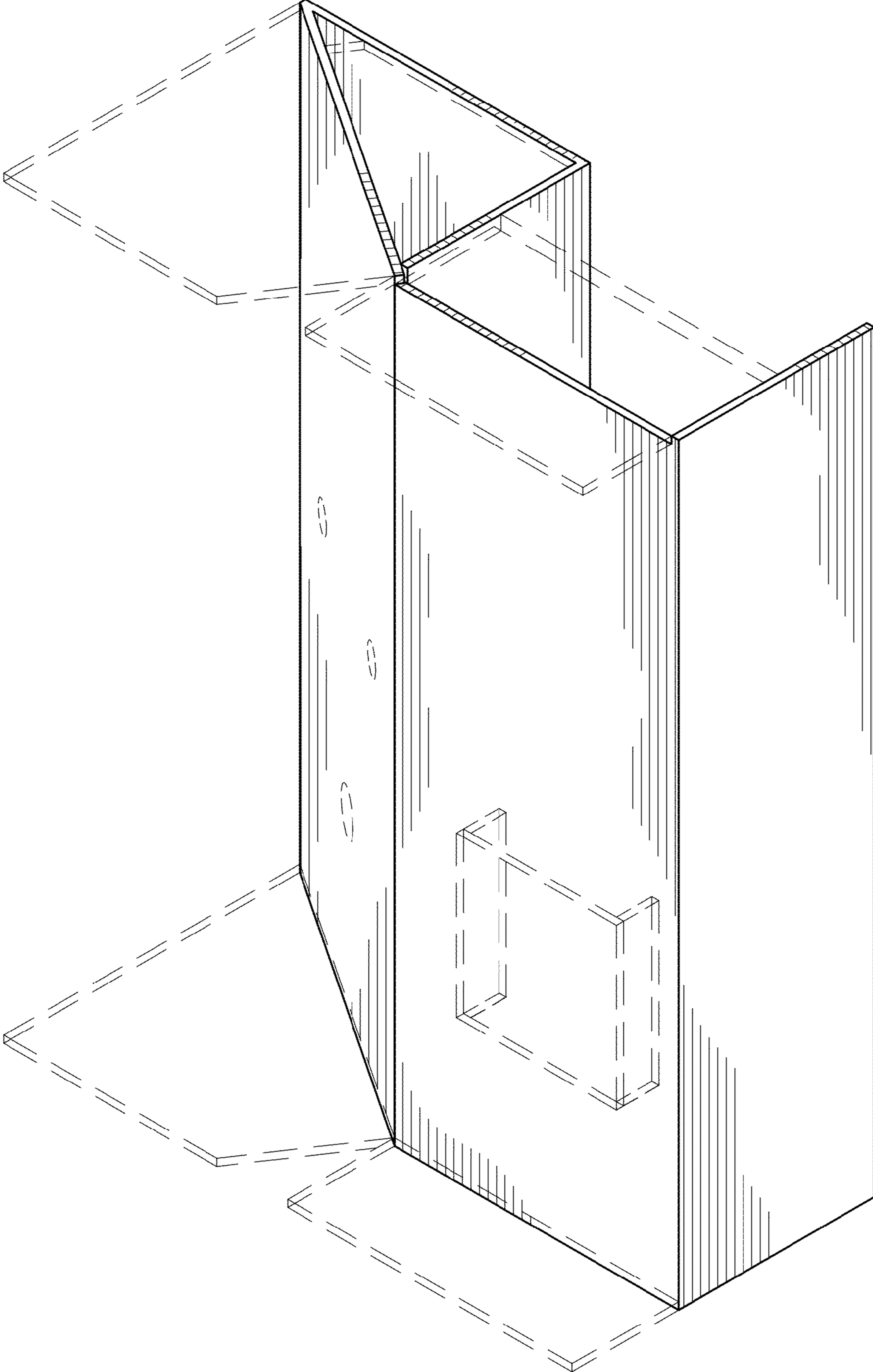

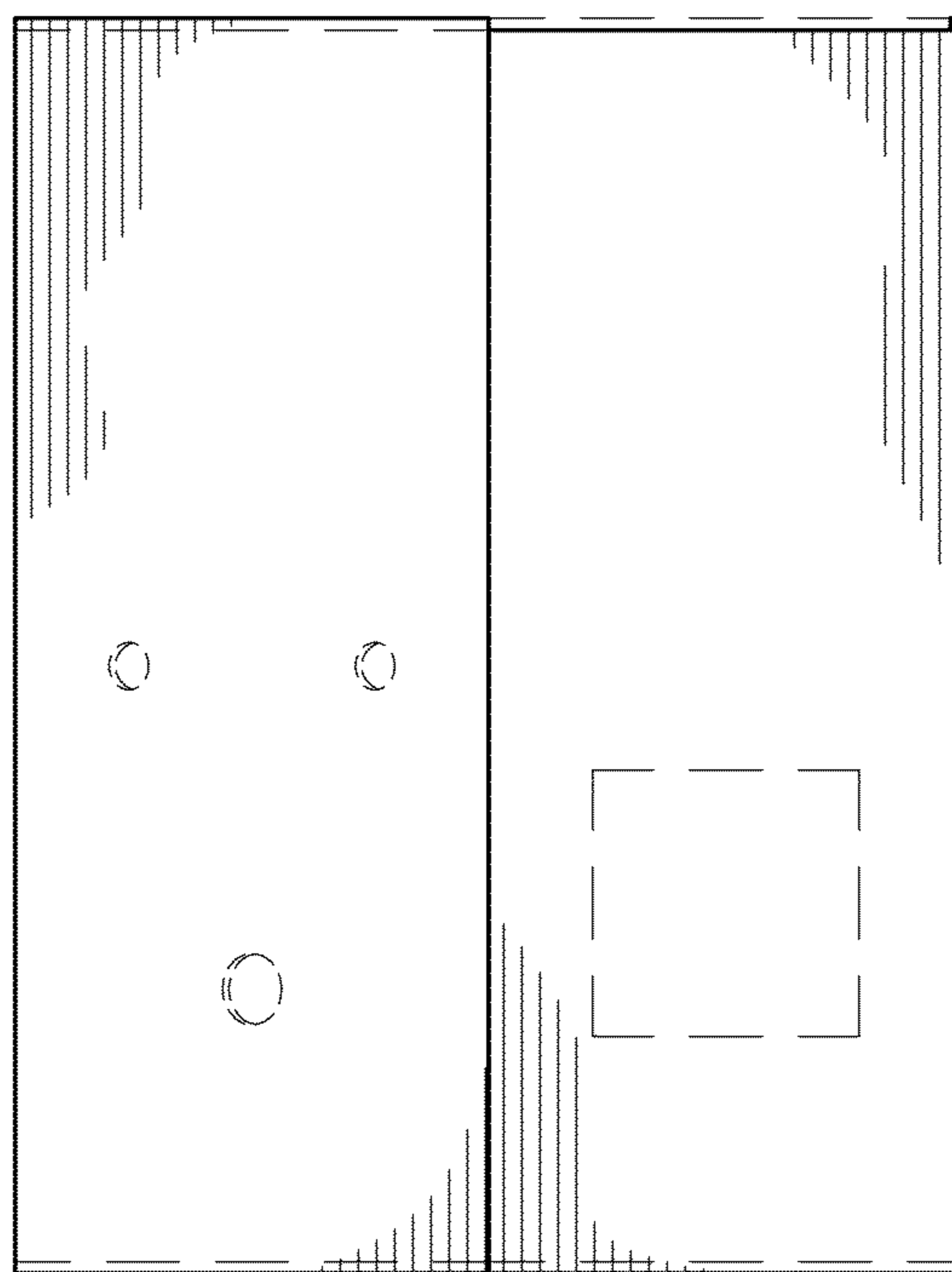

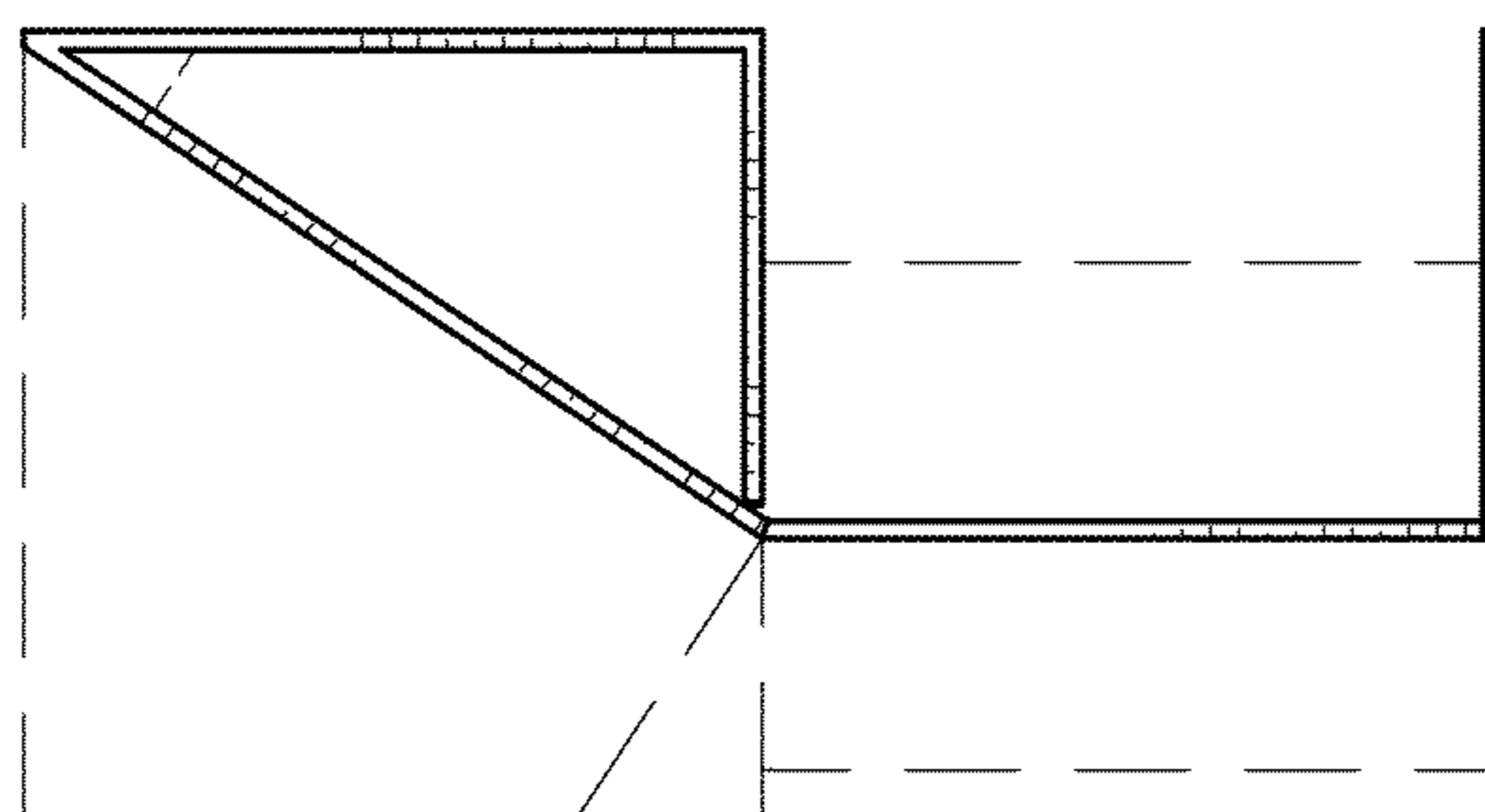

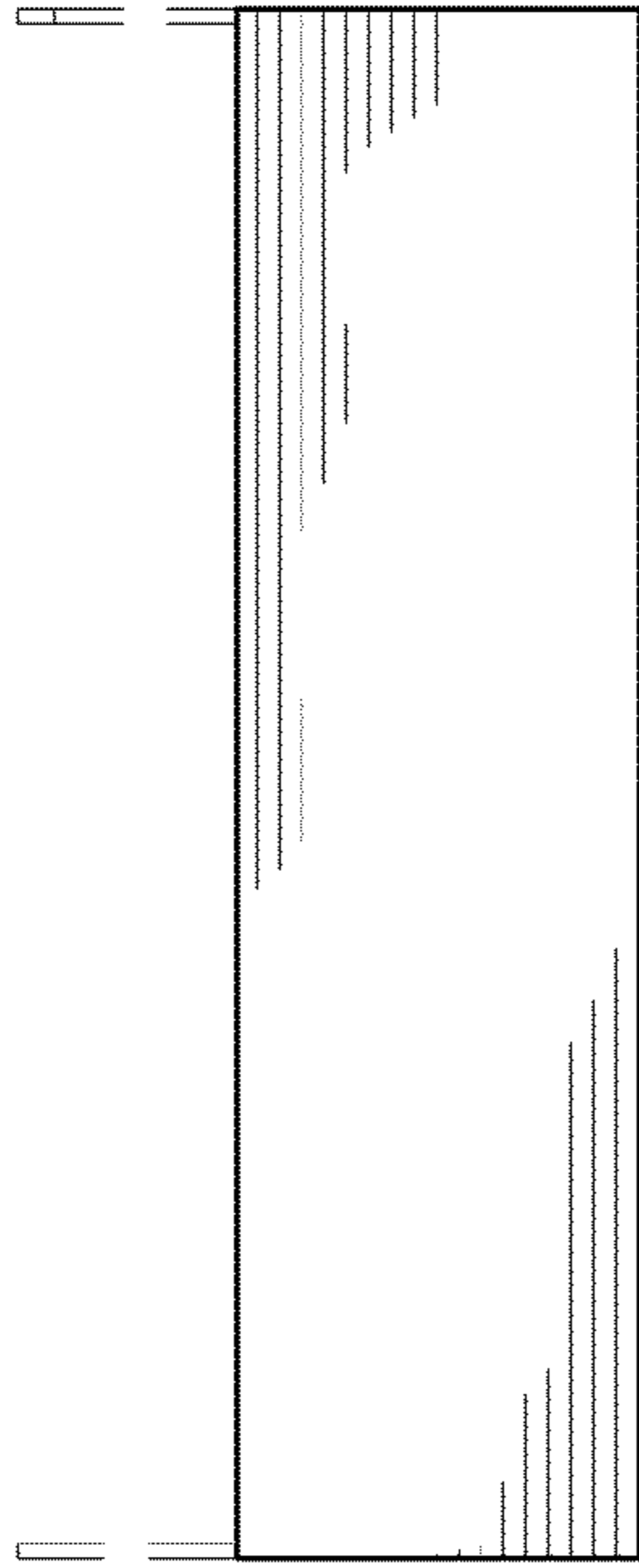

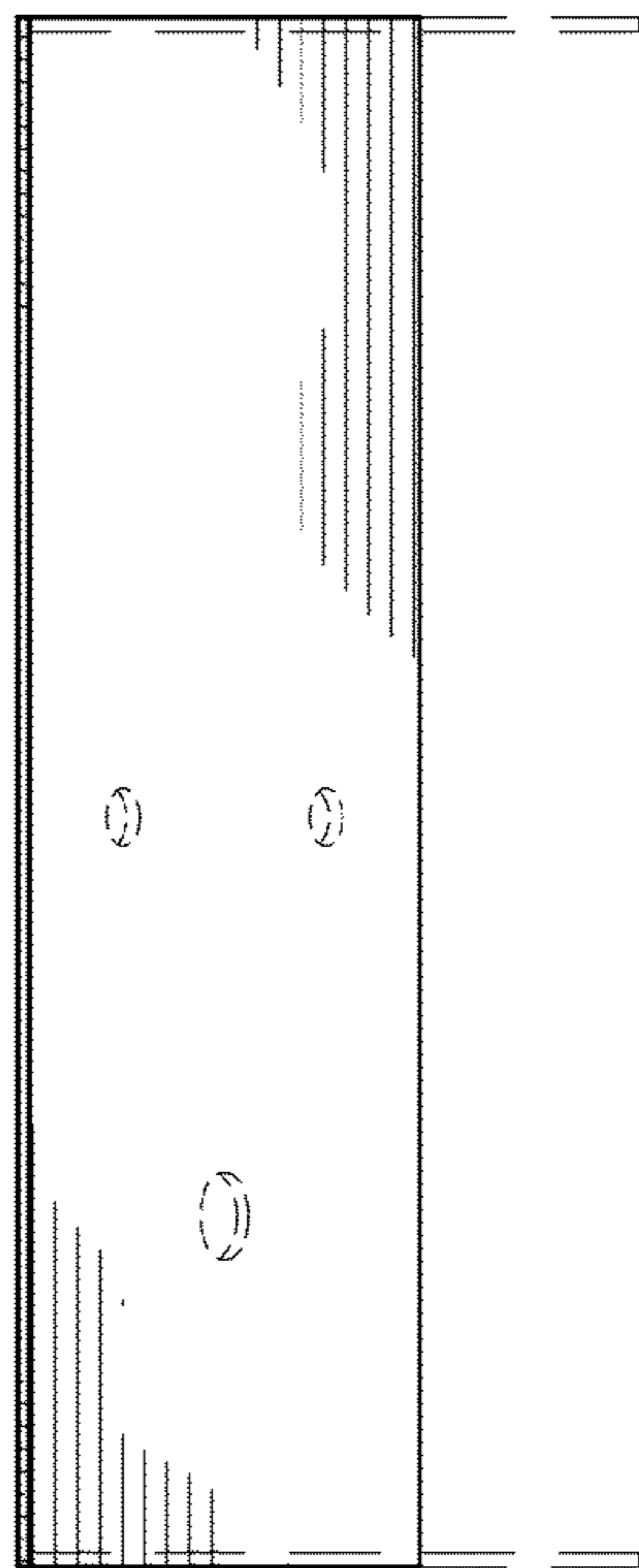

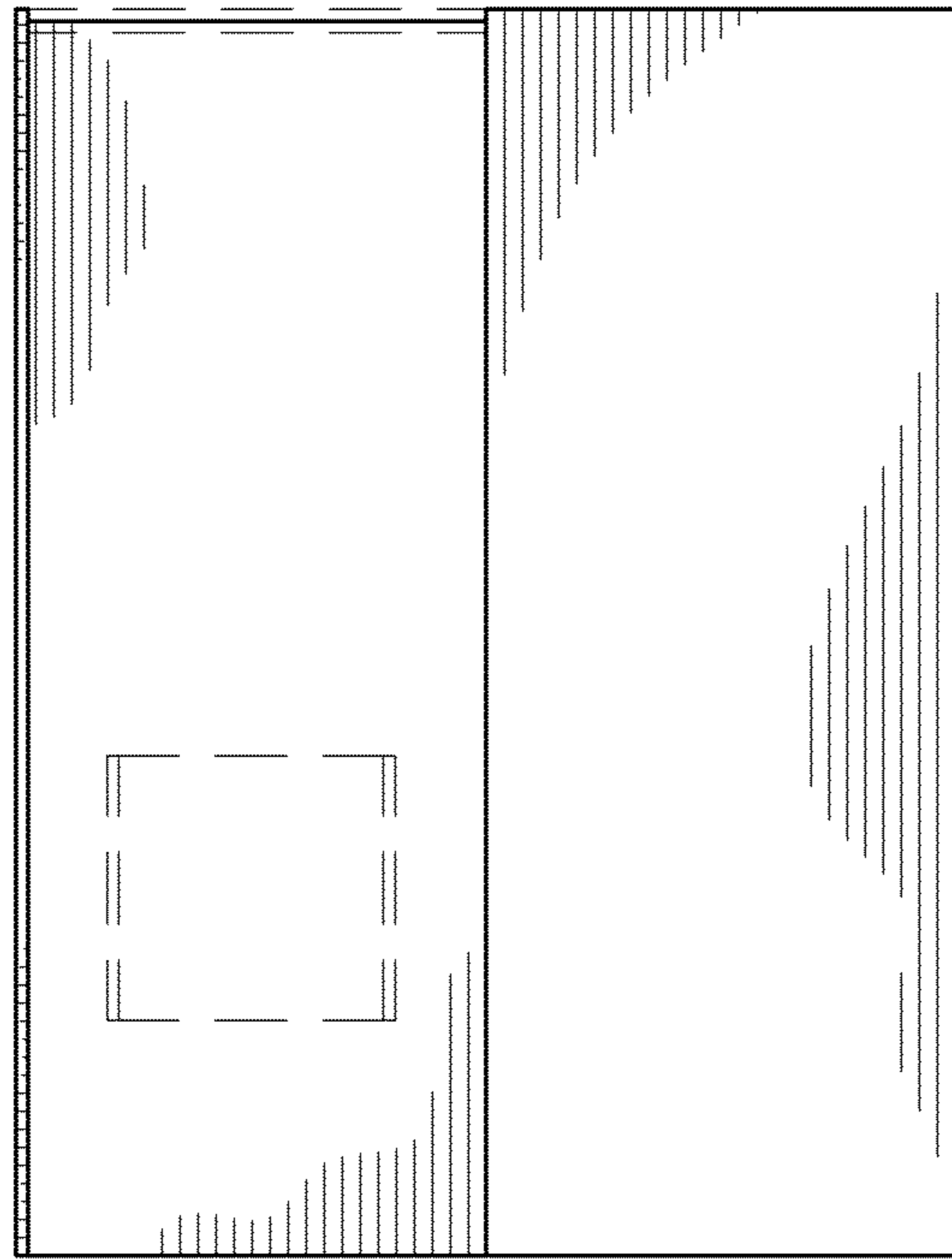

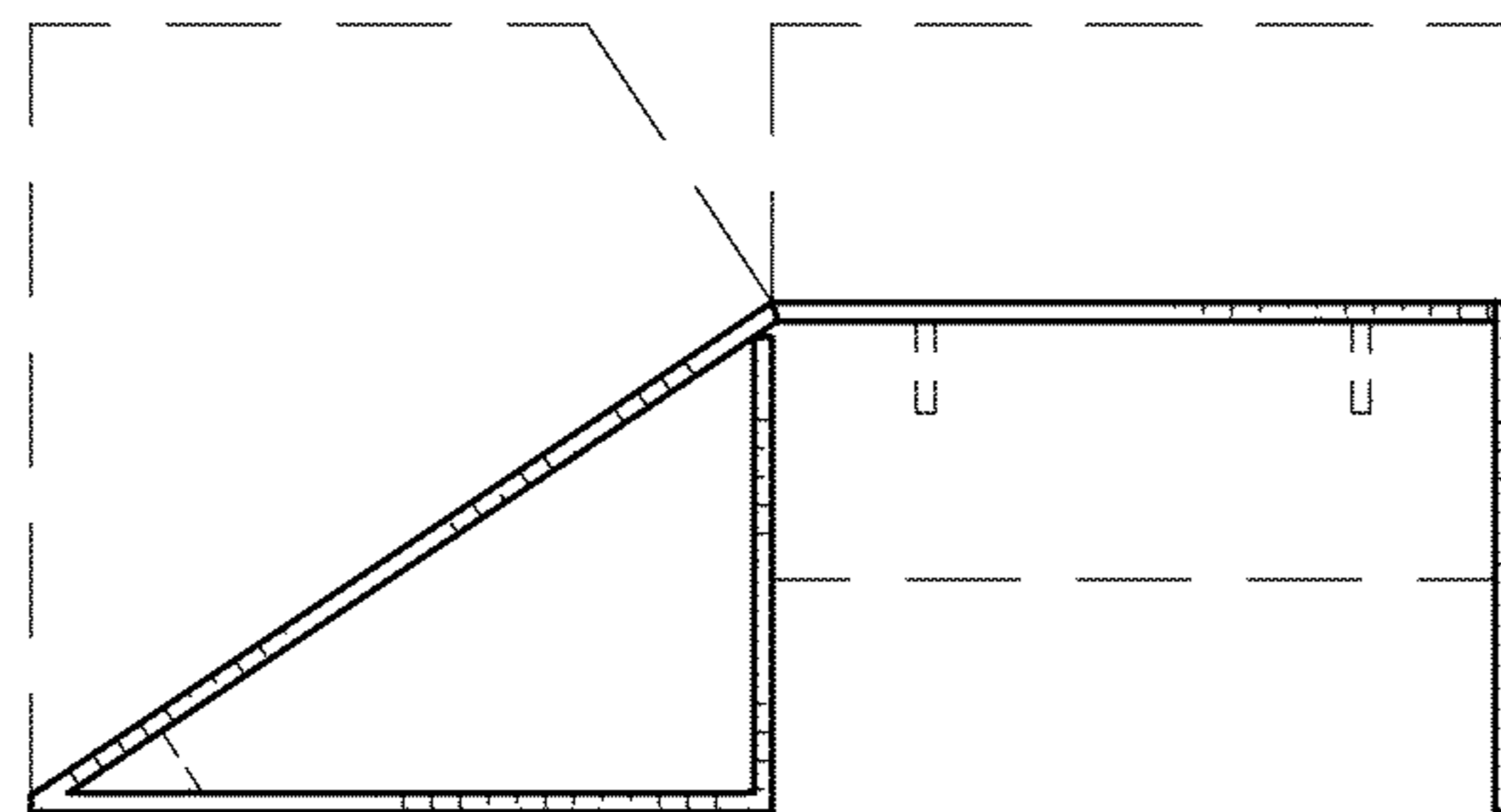

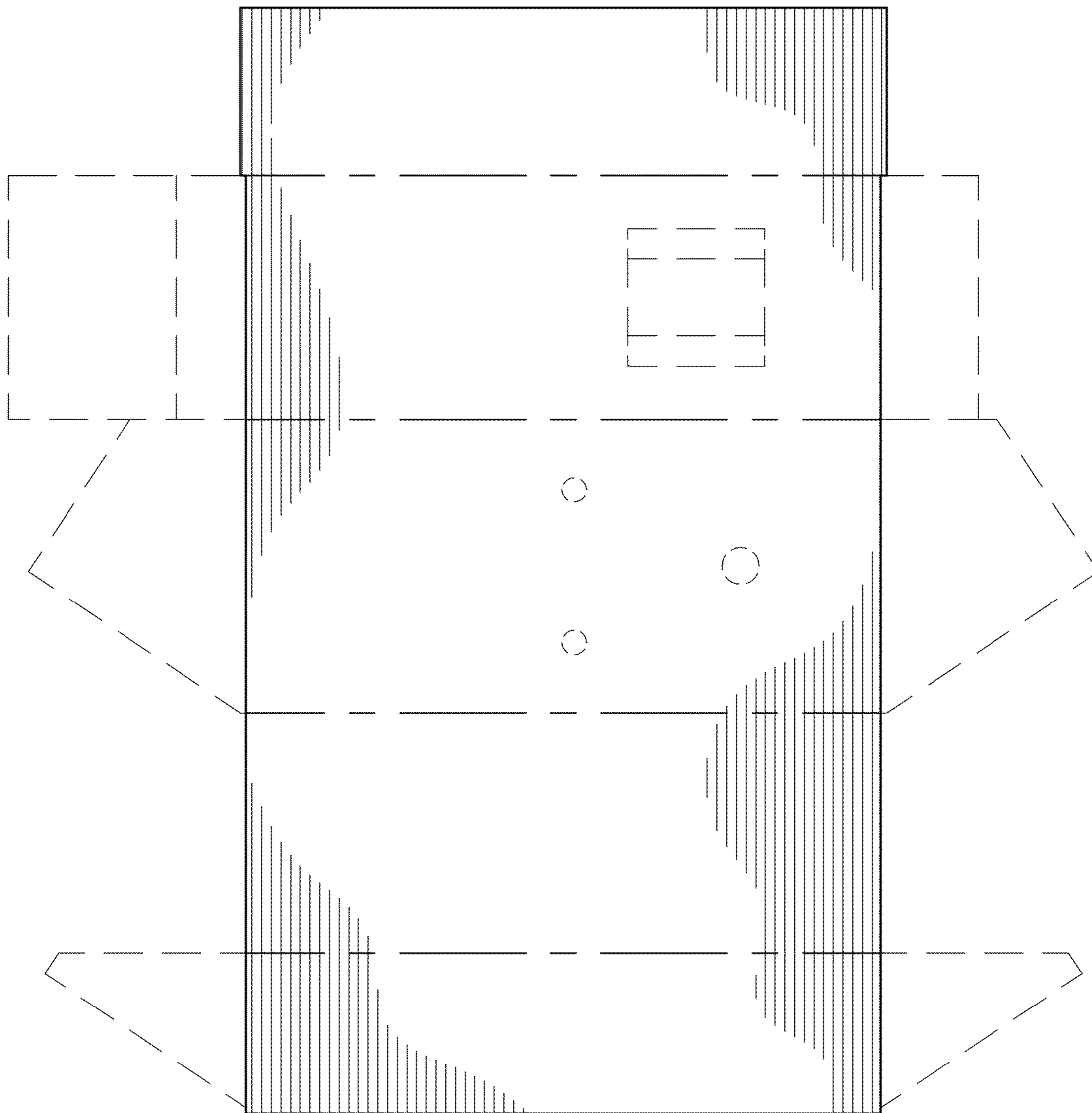
