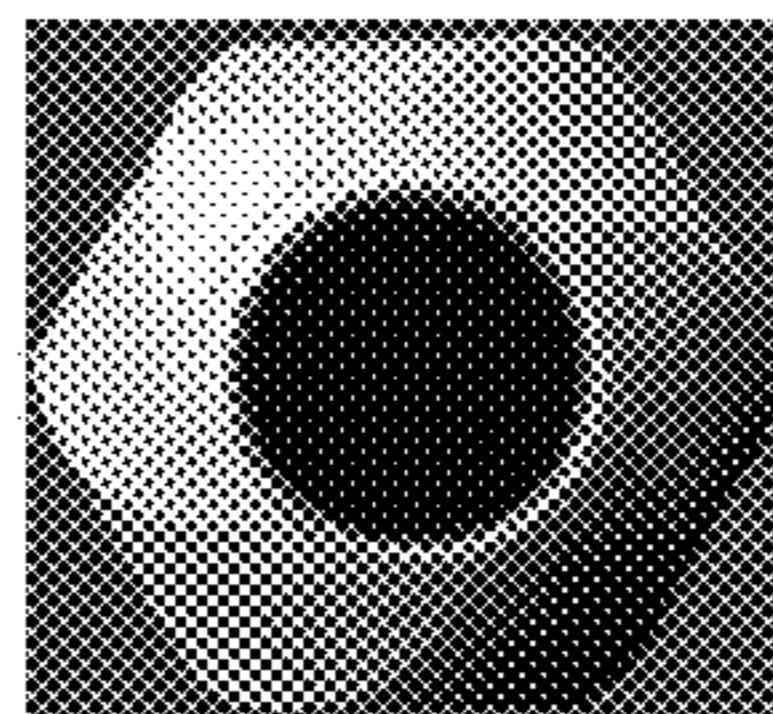
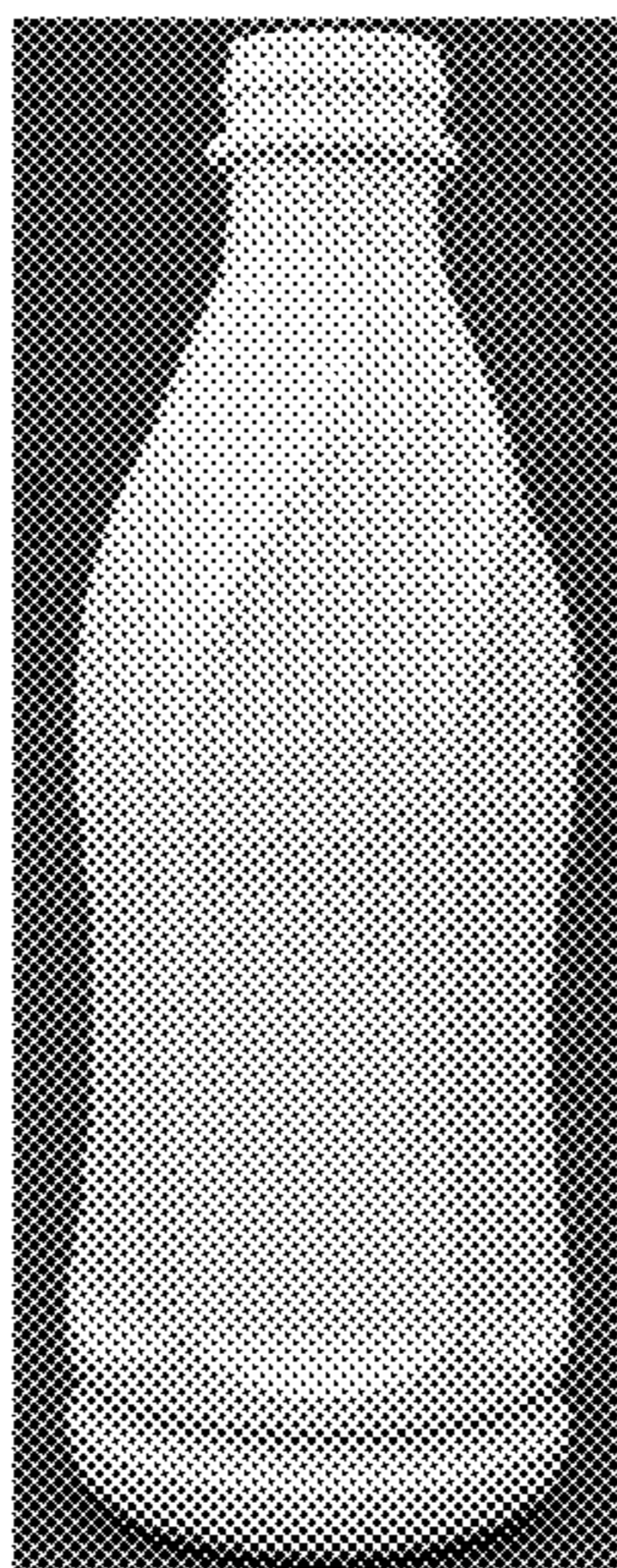
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front perspective view of the container showing our new design;  
FIG. 2 is a right side perspective view thereof, the left side perspective view being identical;

FIG. 4 is a top plan view of the top half of the container of FIG. 1; and,

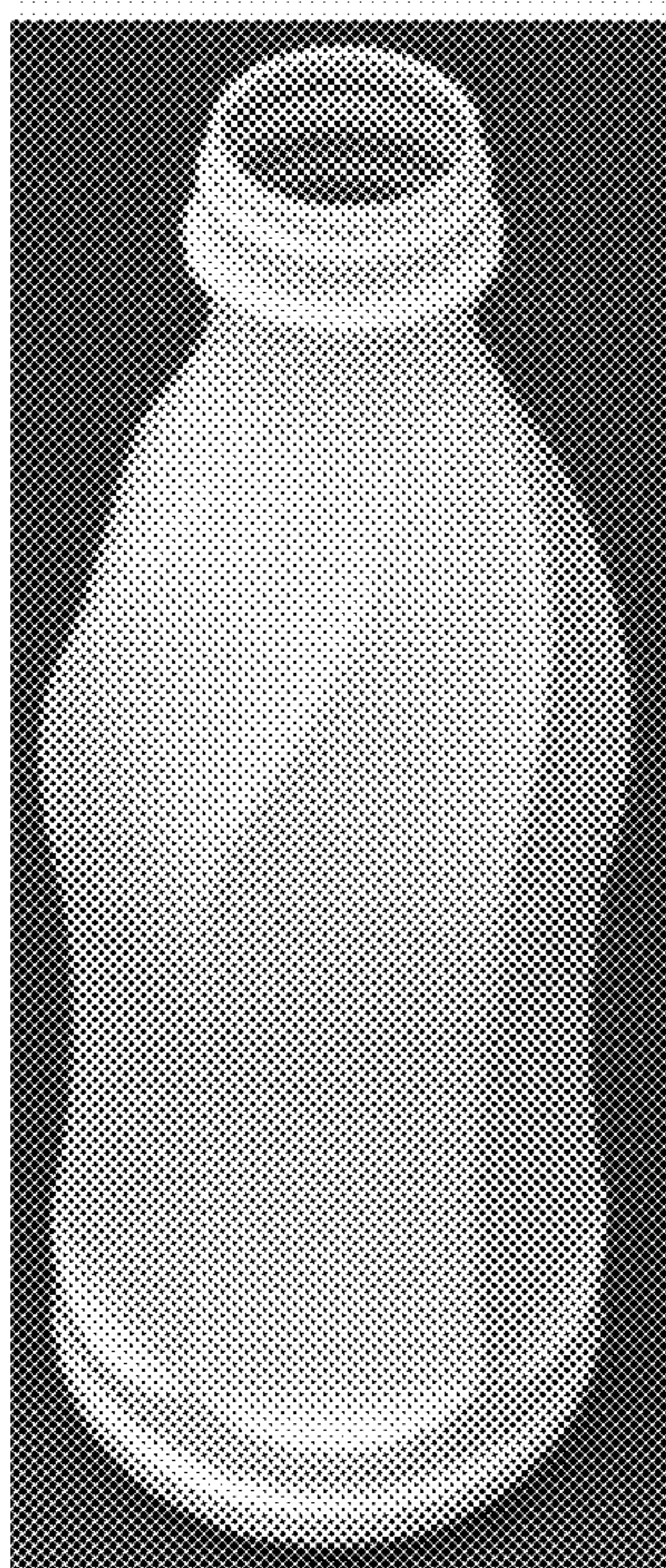

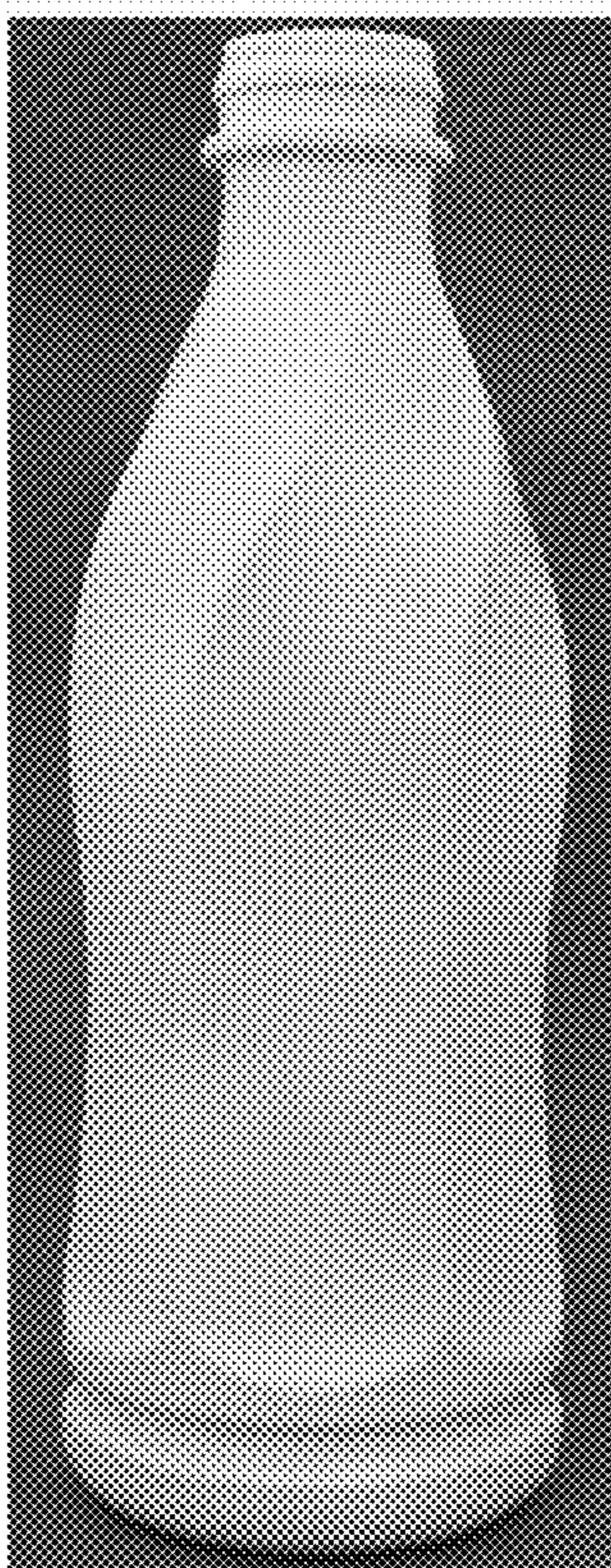

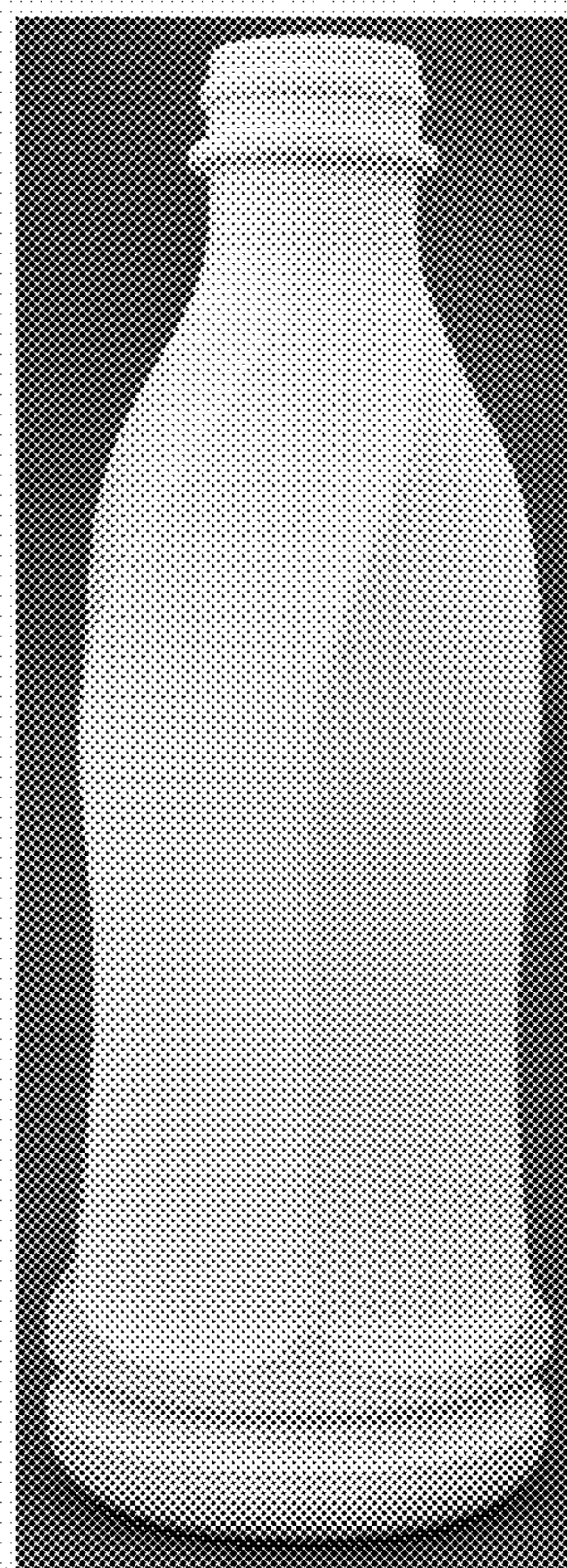

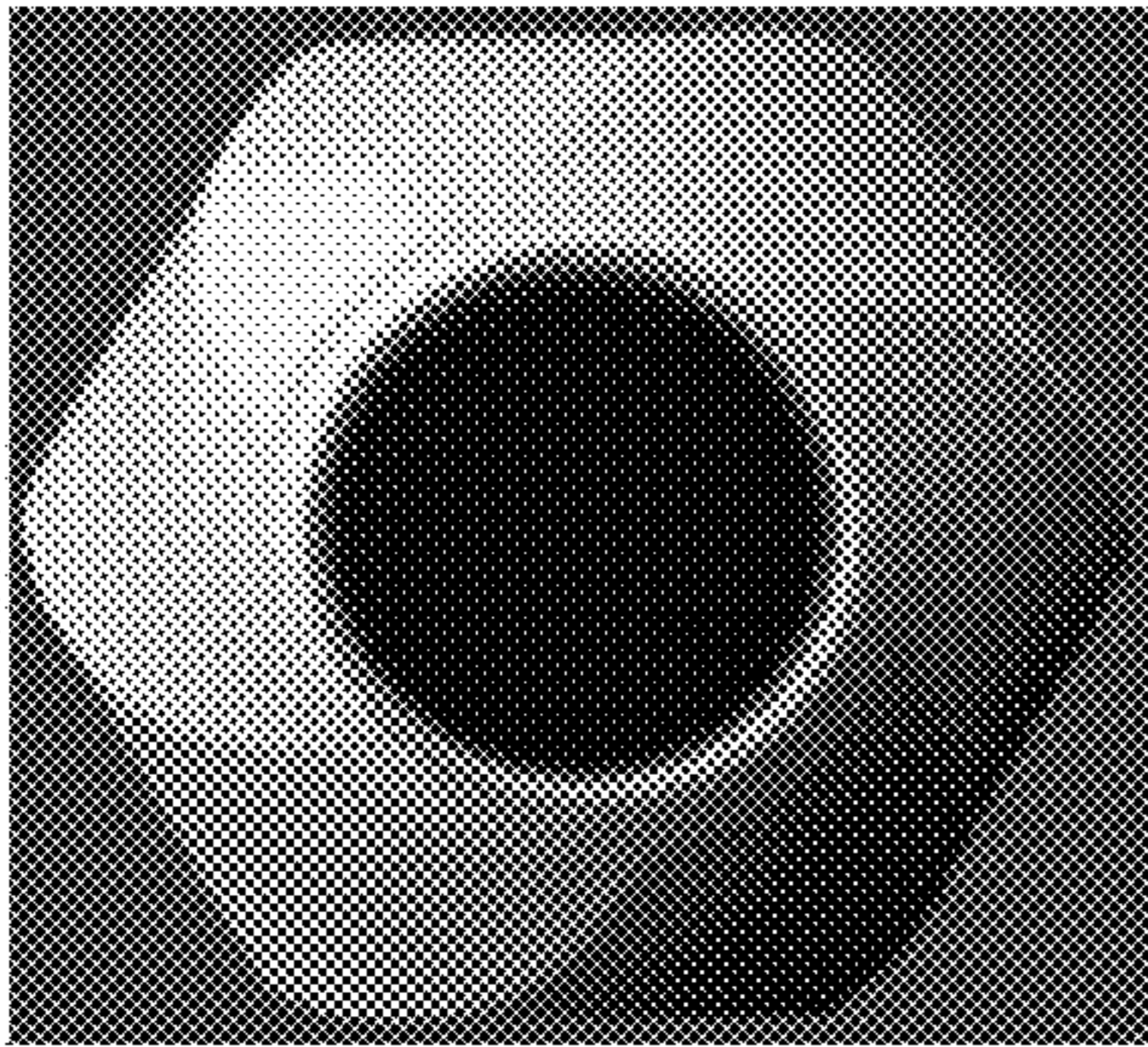
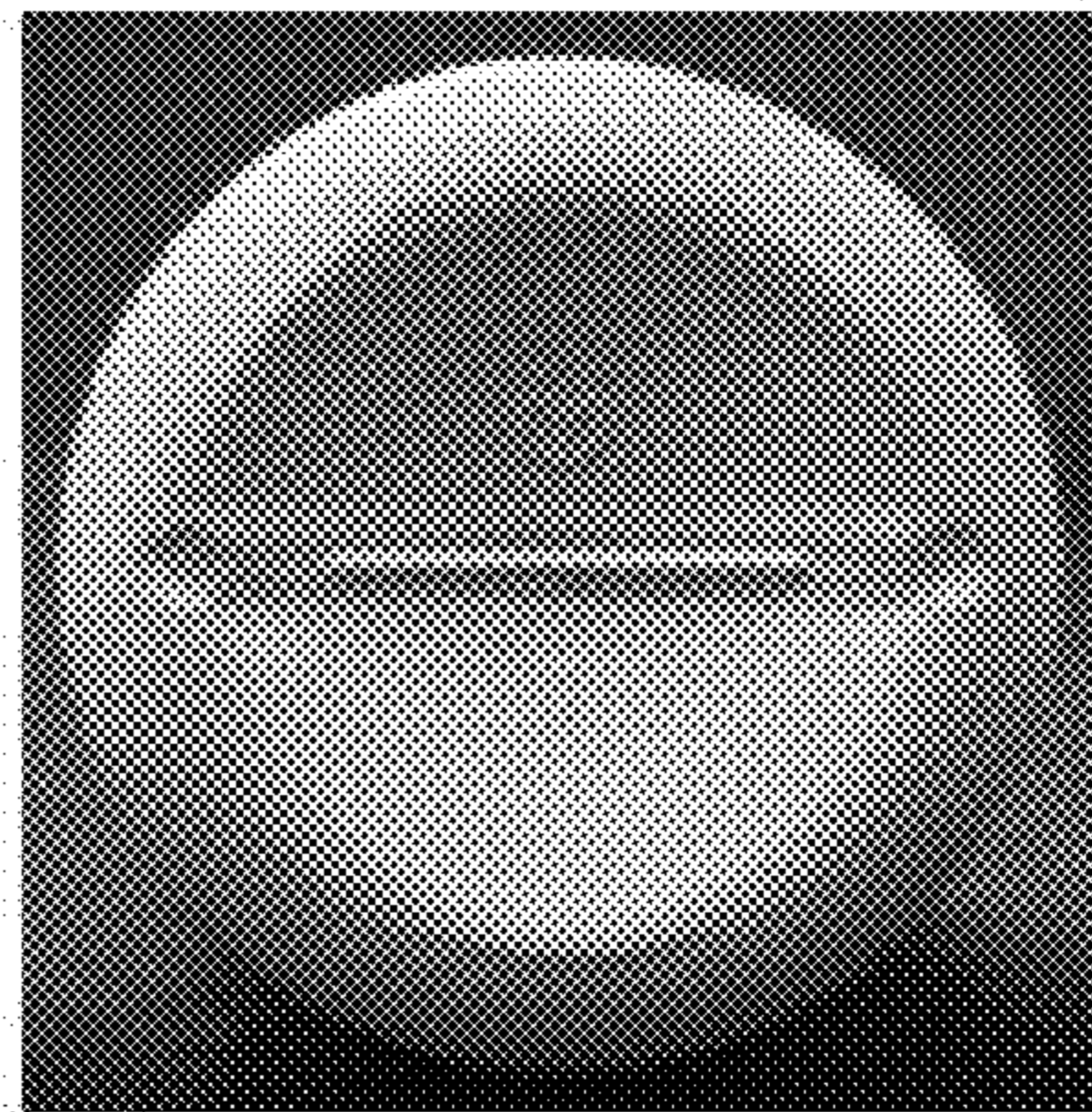
