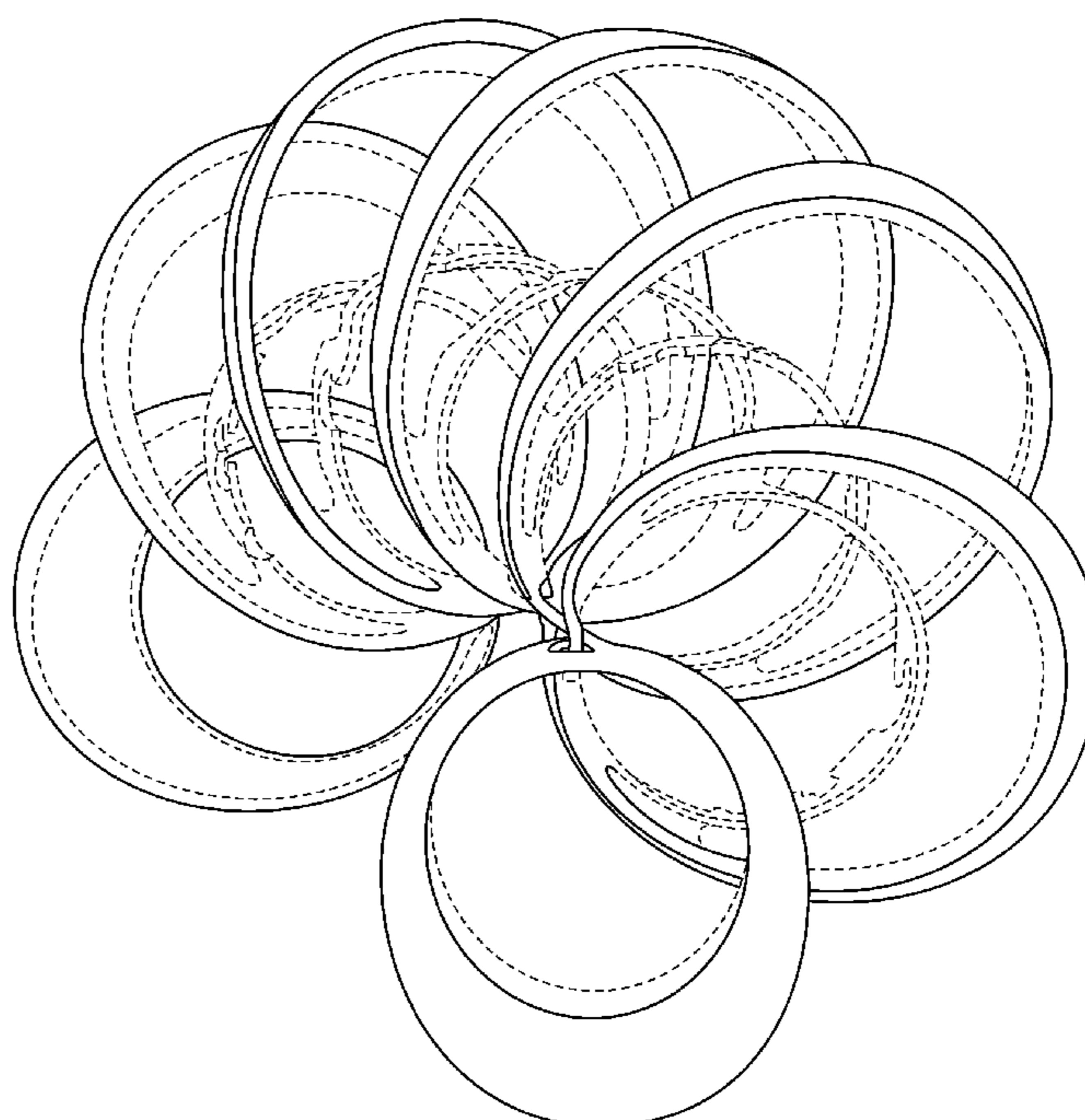
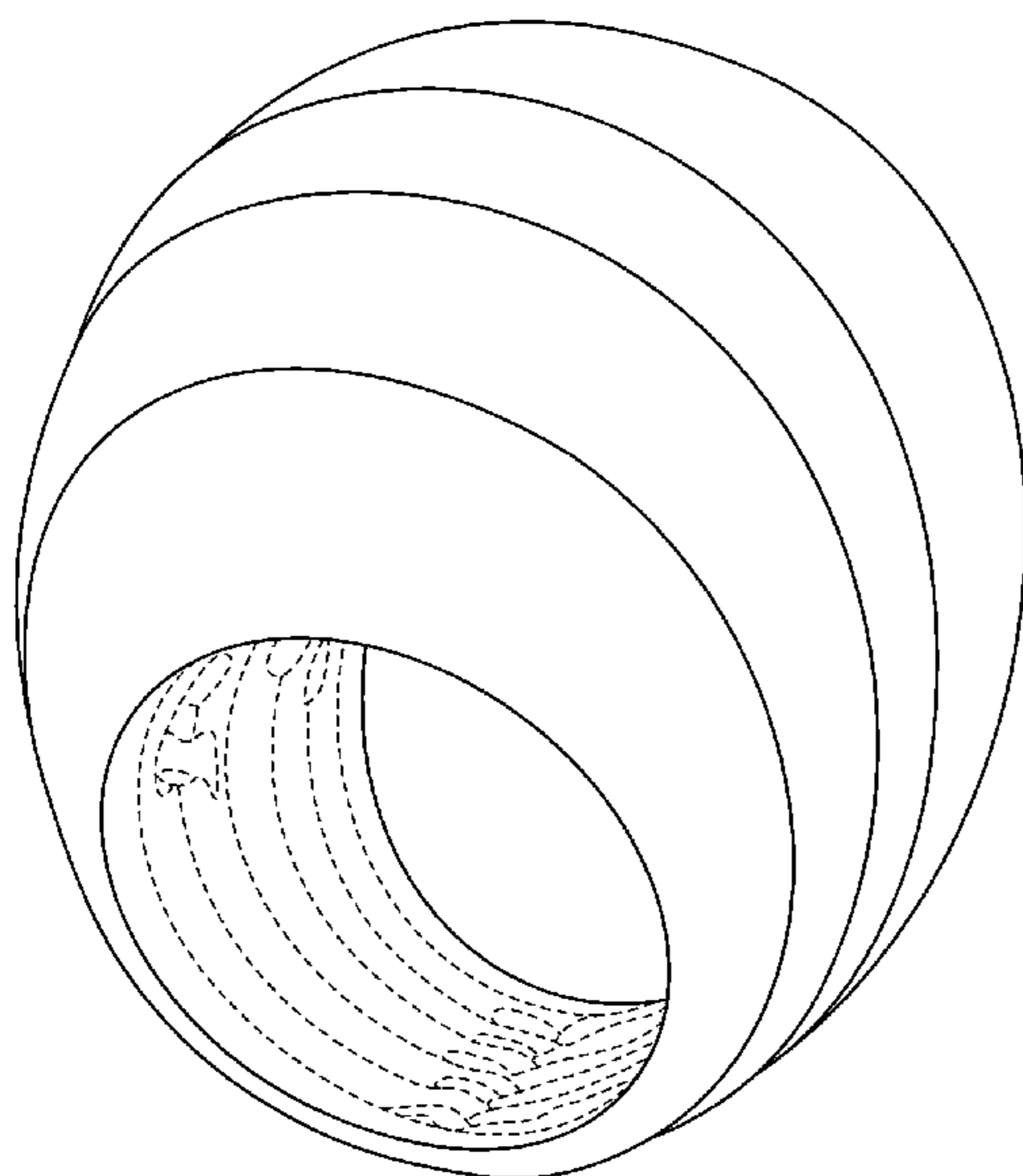
(57) **CLAIM**

The ornamental design for a ring, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of a ring showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a side elevational view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a top view thereof shown in an alternate condition with the bands of the ring expanded;
 FIG. 7 is a top perspective view thereof shown in an alternate condition with the bands of the ring further expanded; and,
 FIG. 8 is a top perspective view thereof shown in an alternate condition with the bands of the ring fully expanded.
 The broken lines illustrate portions of the ring and form no part of the claimed design.

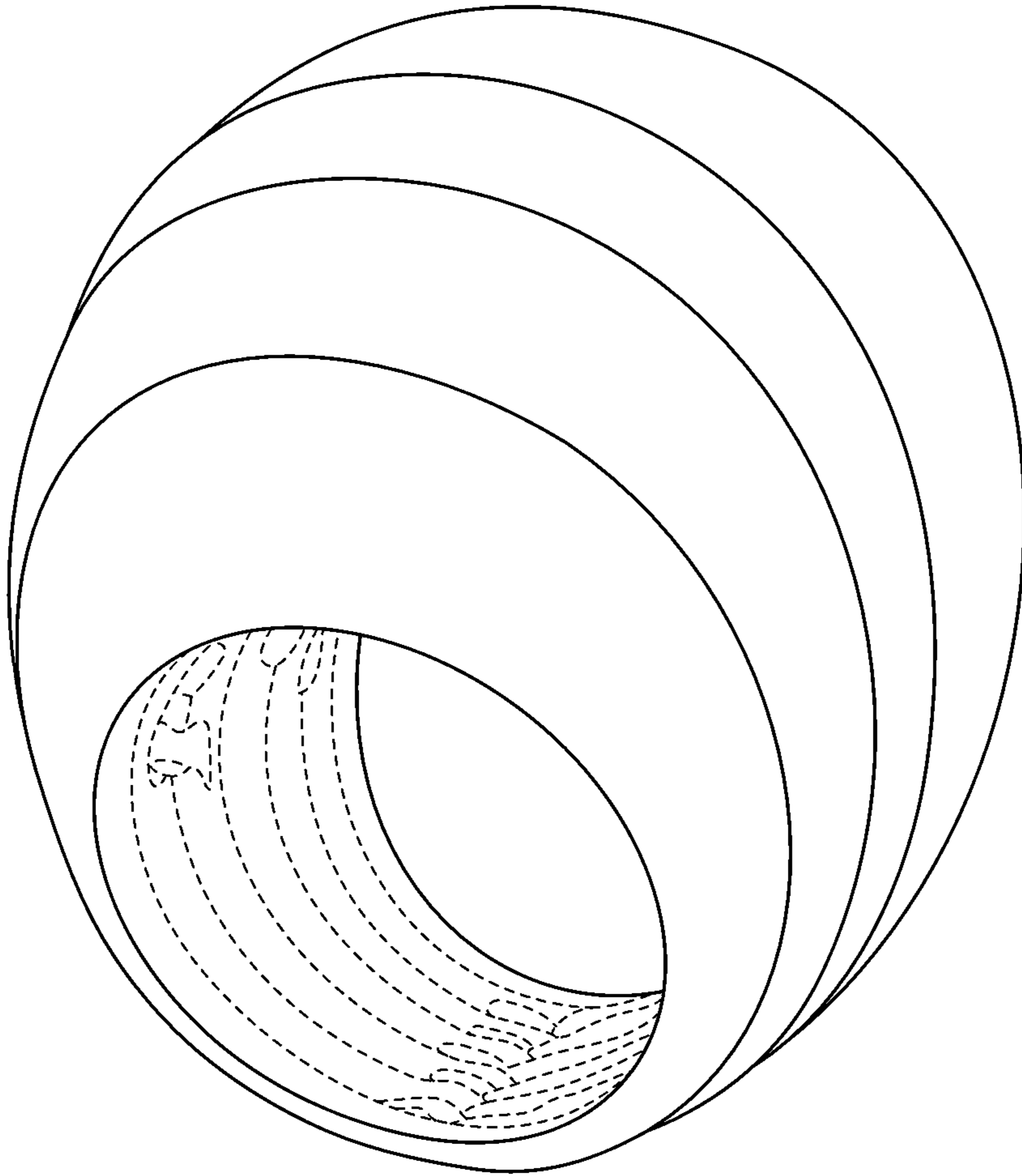

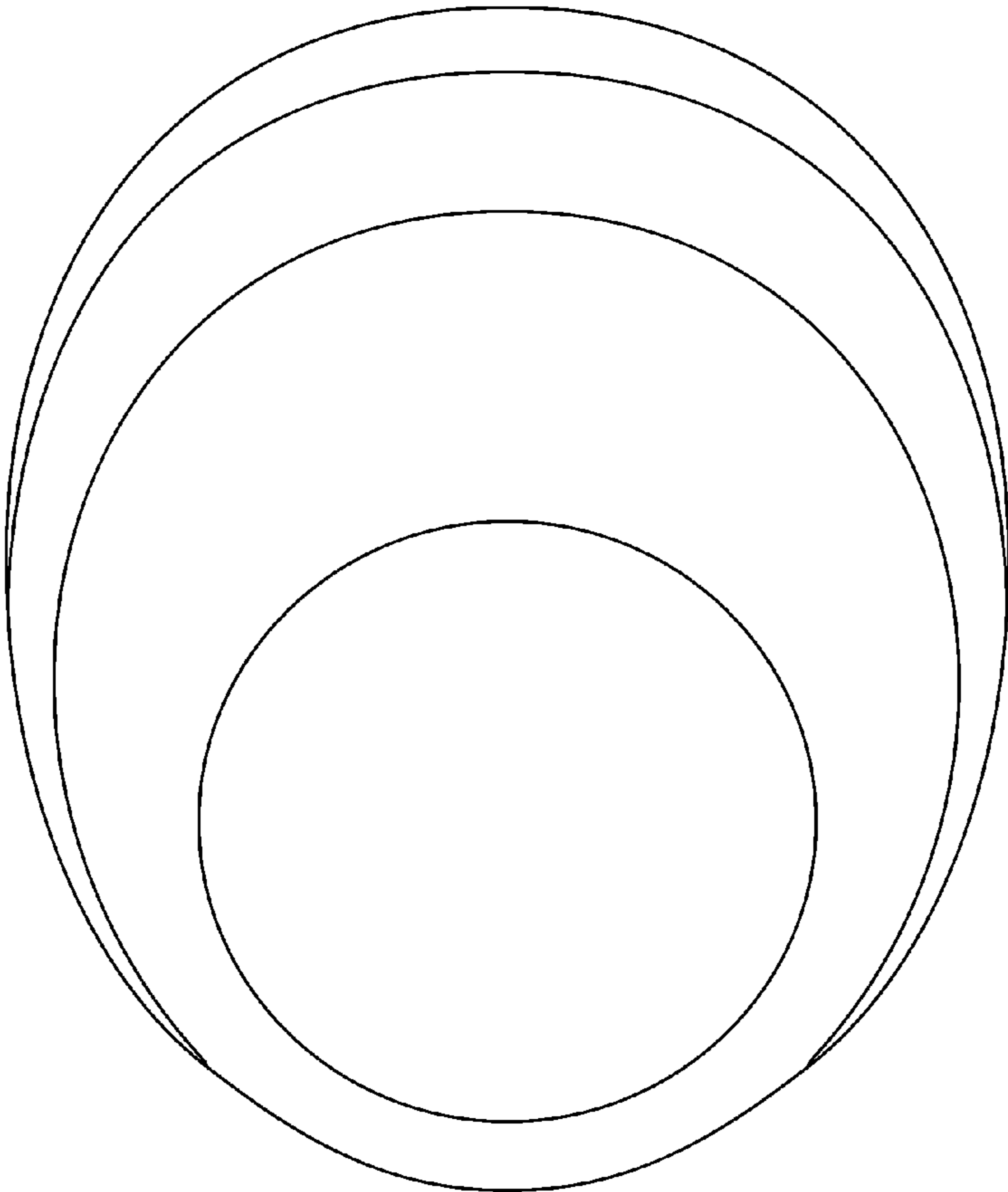

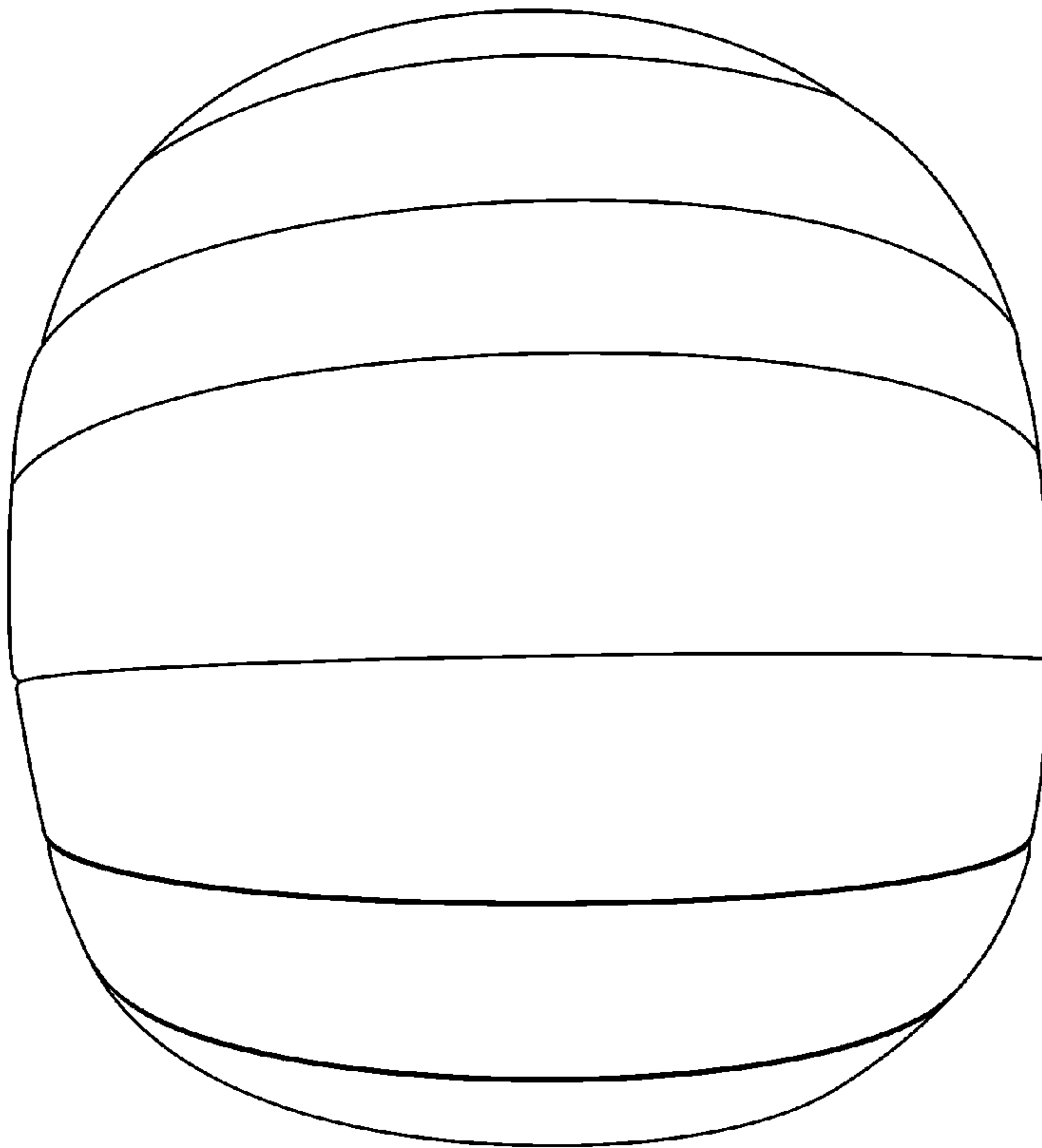

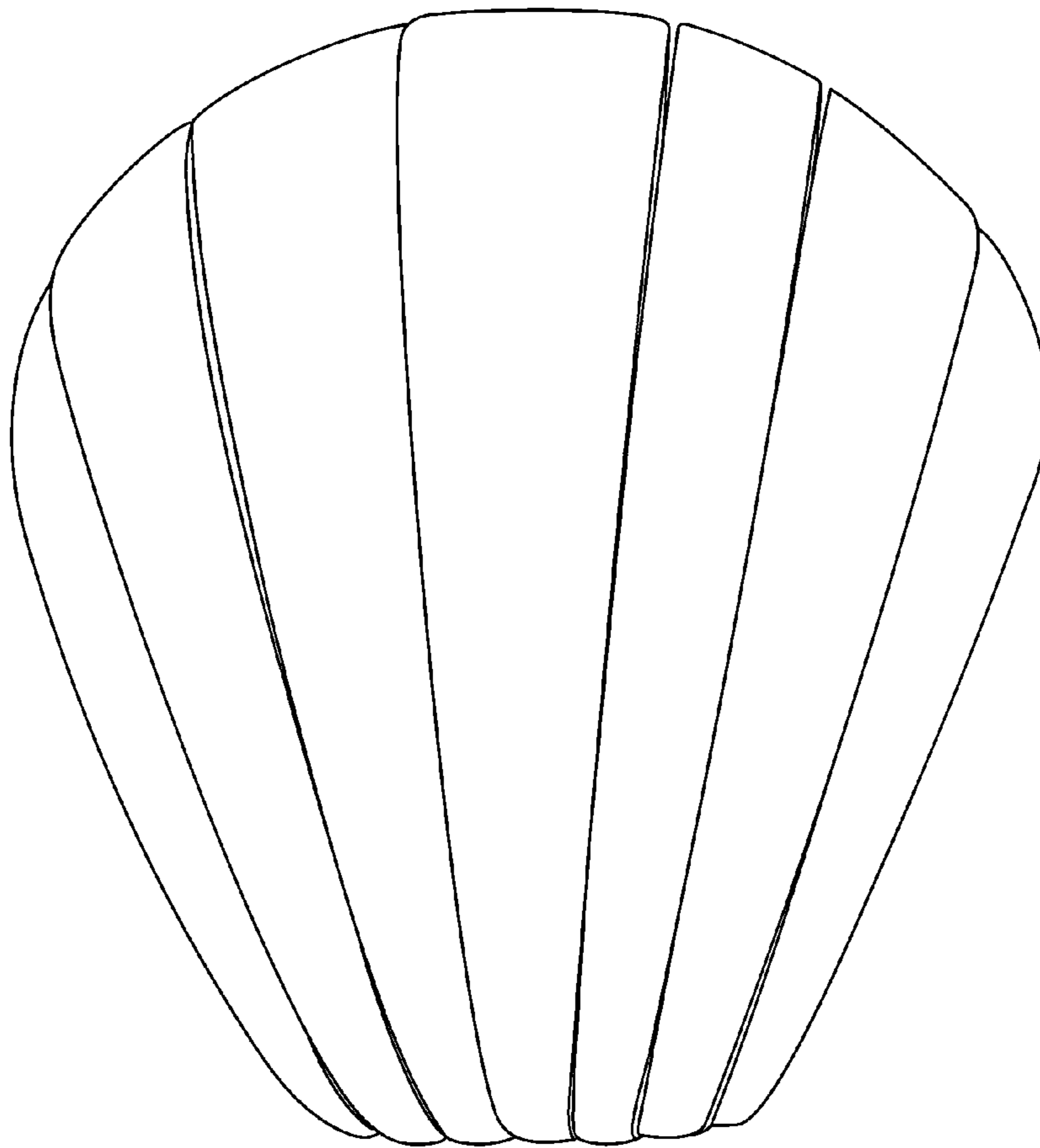

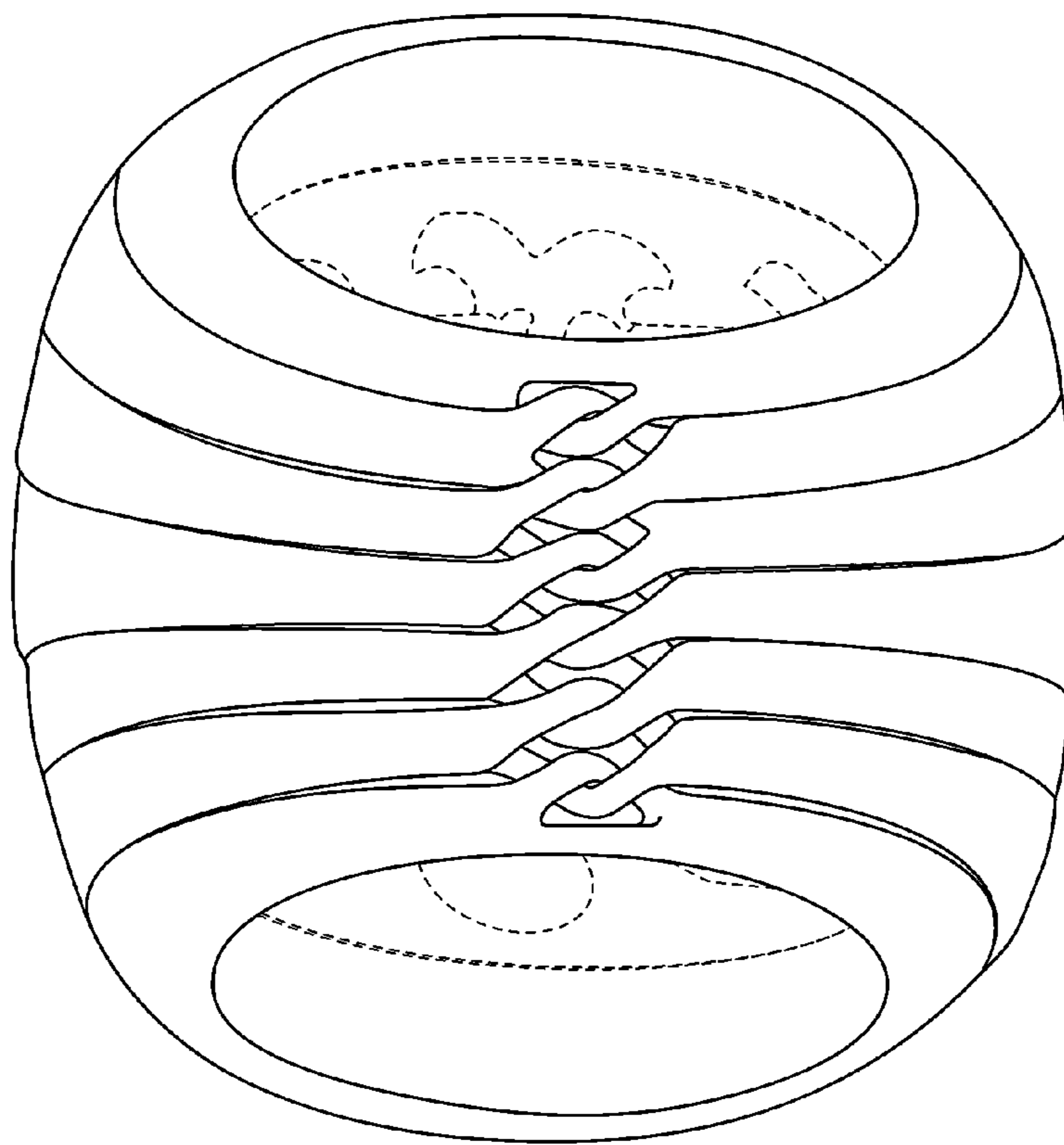

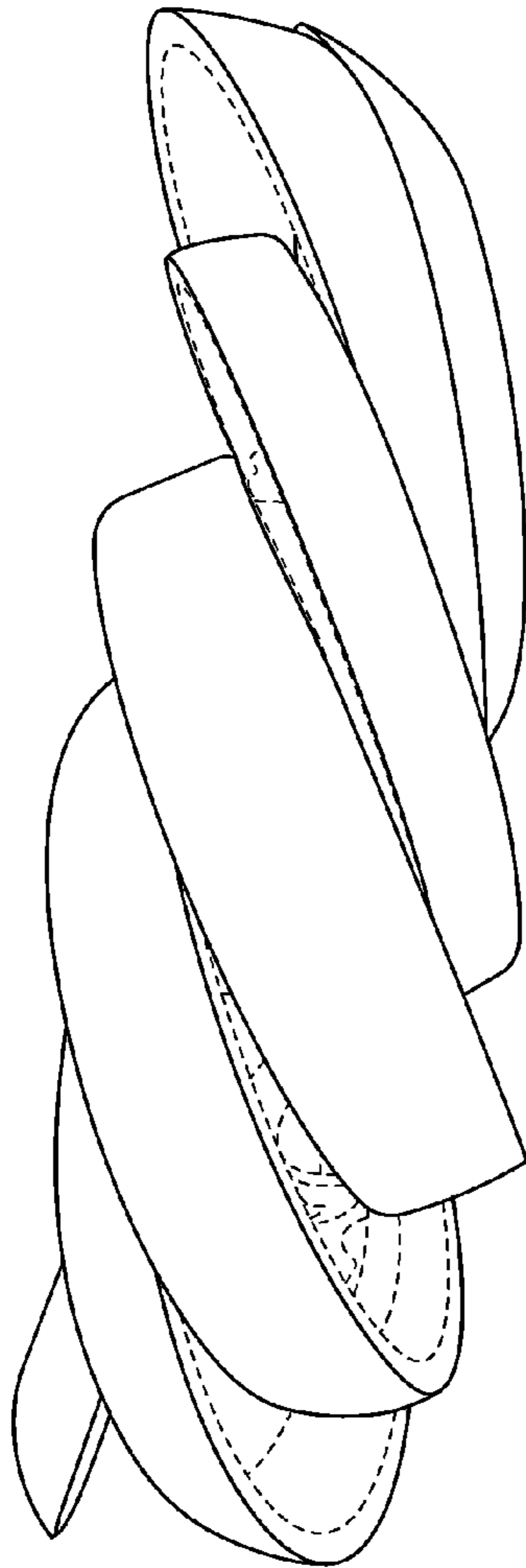

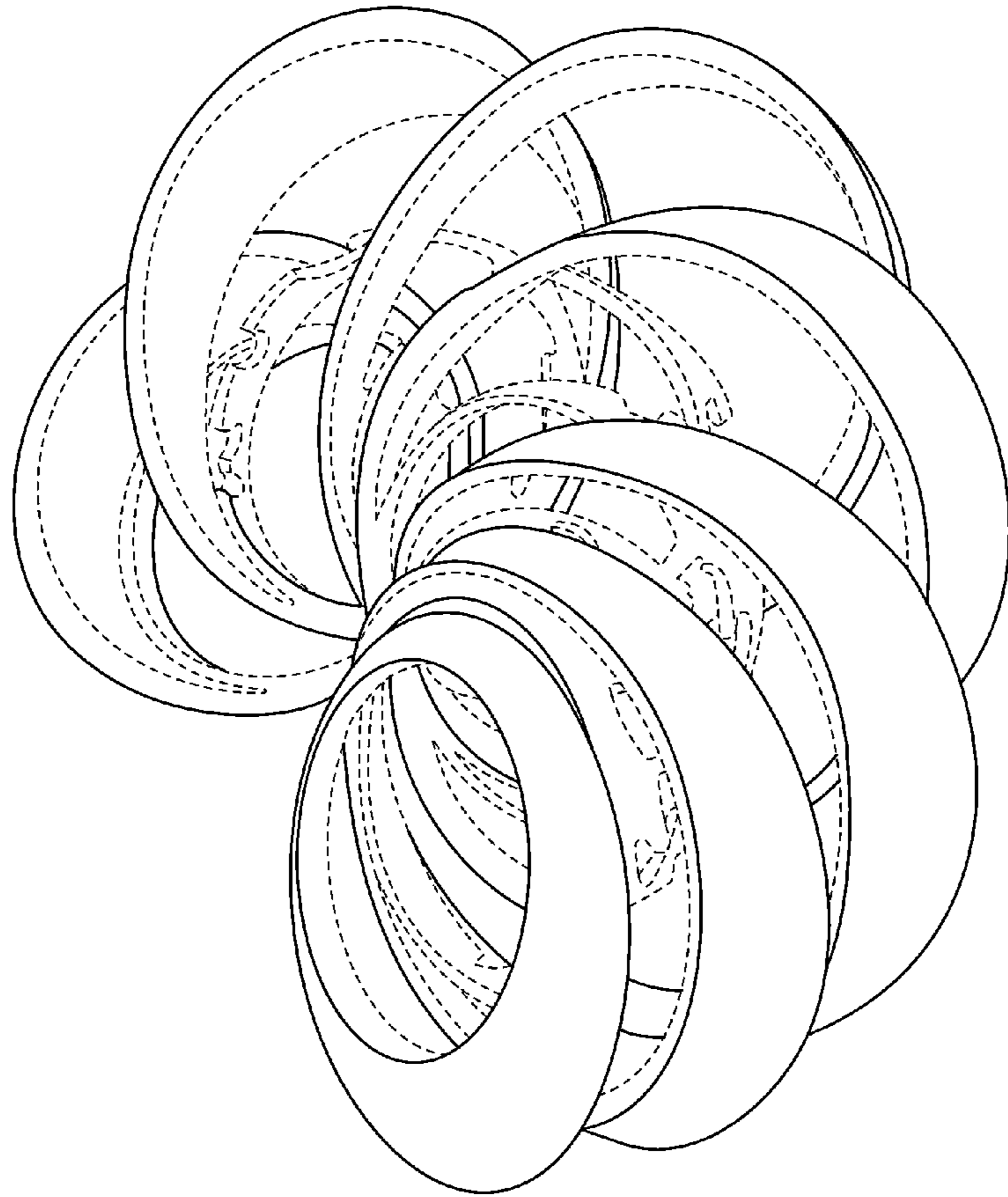

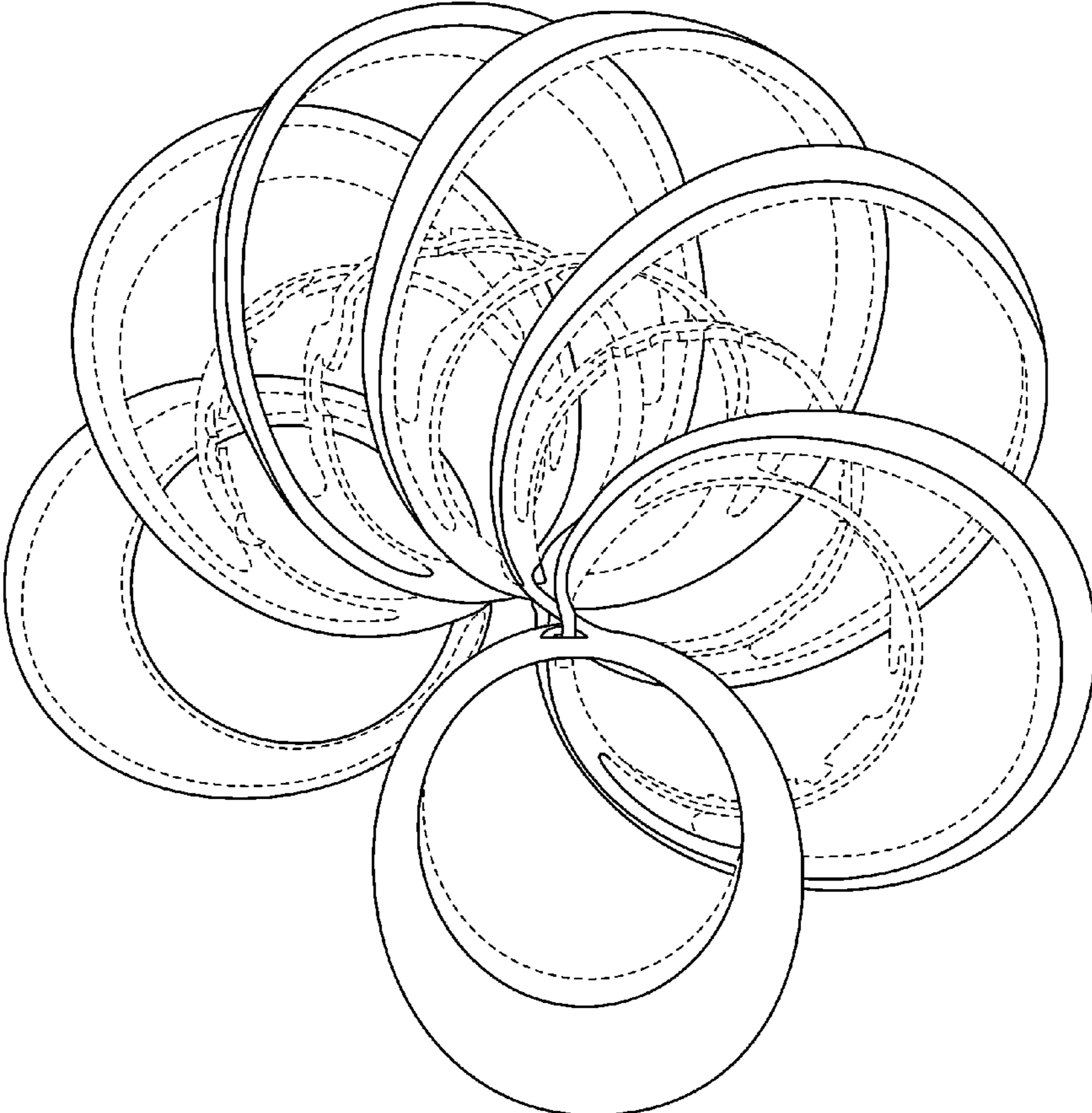
