FIG. 7 is a left side elevation view thereof;

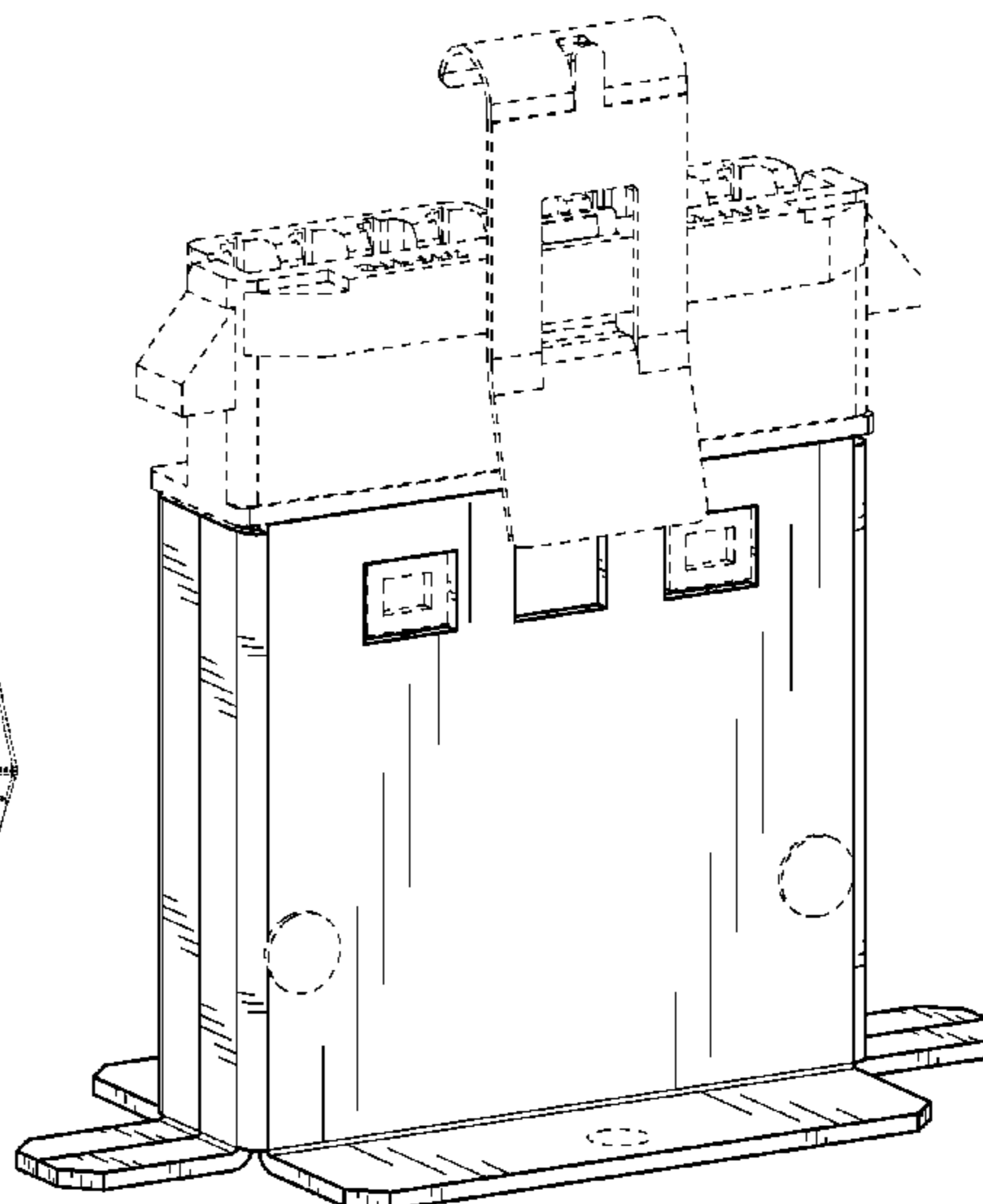
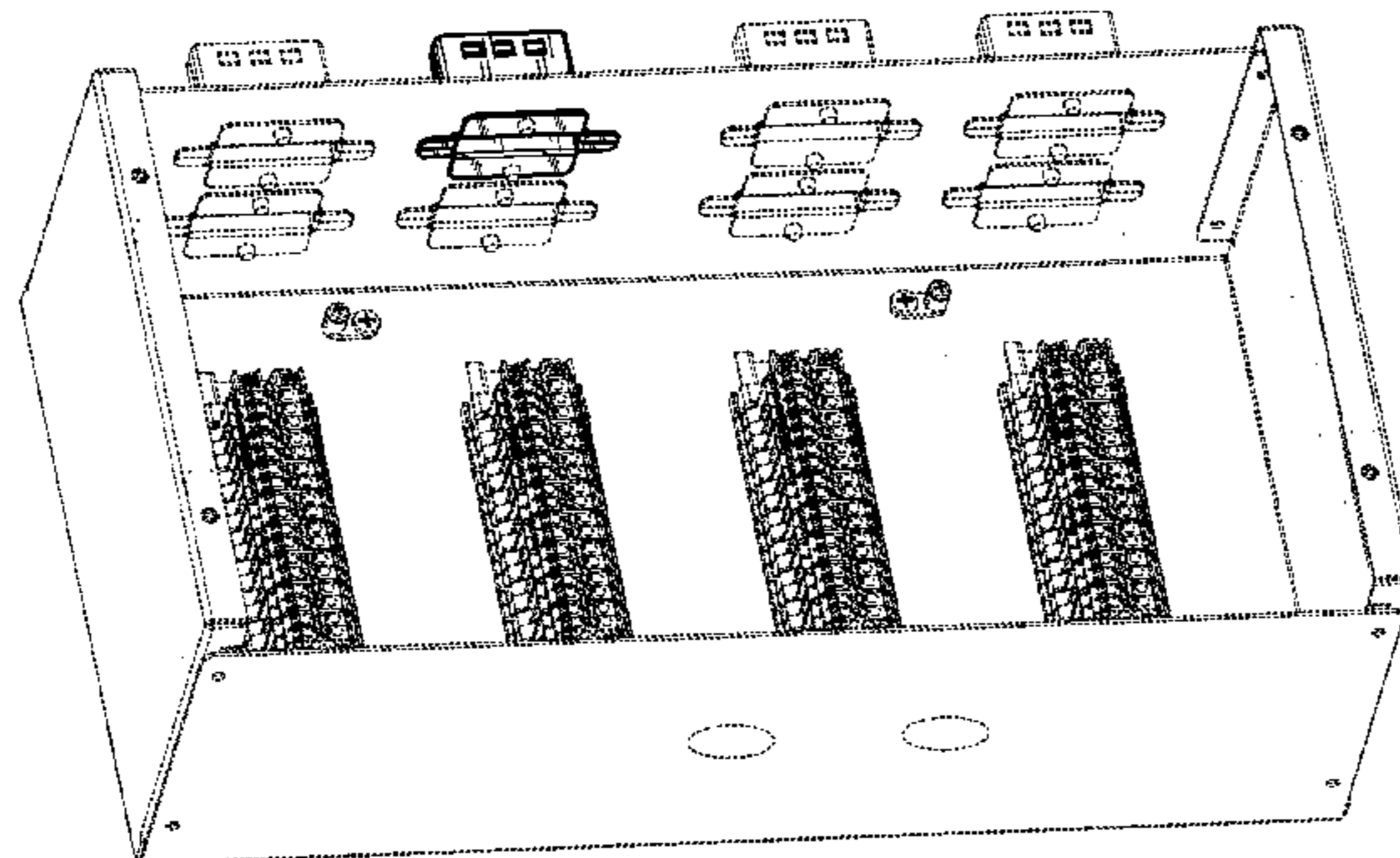
FIG. 8 is a right side elevation view thereof;

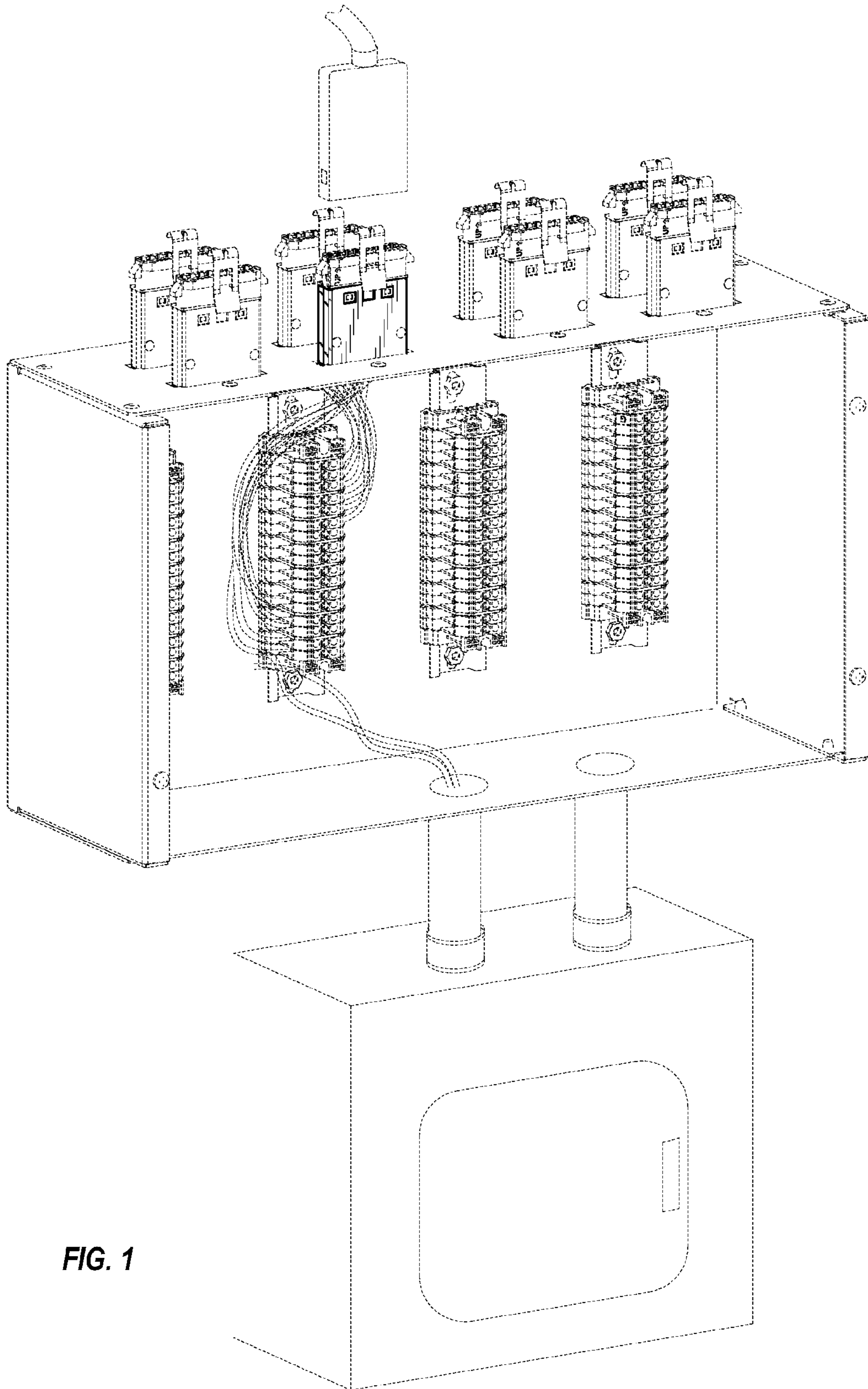

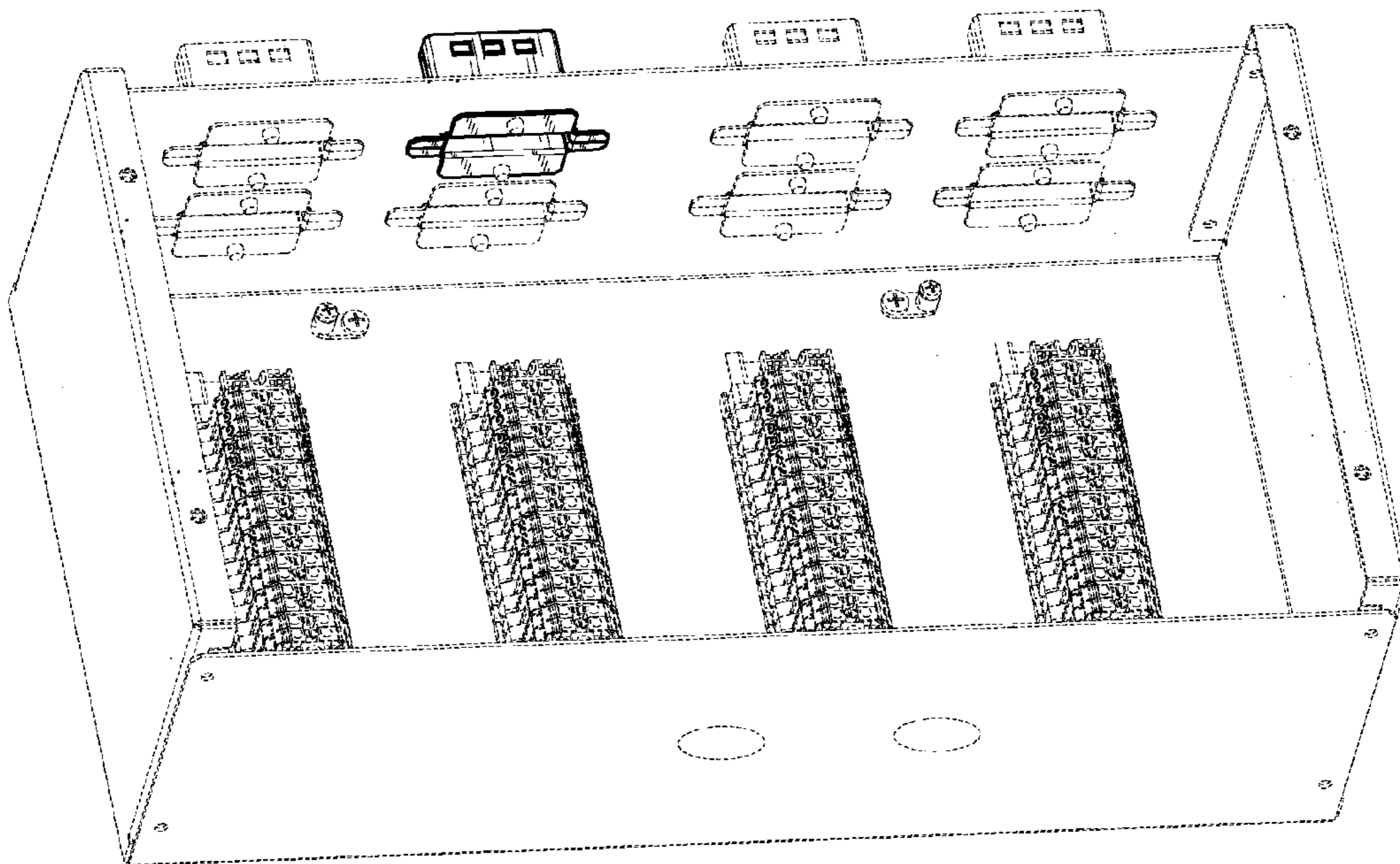

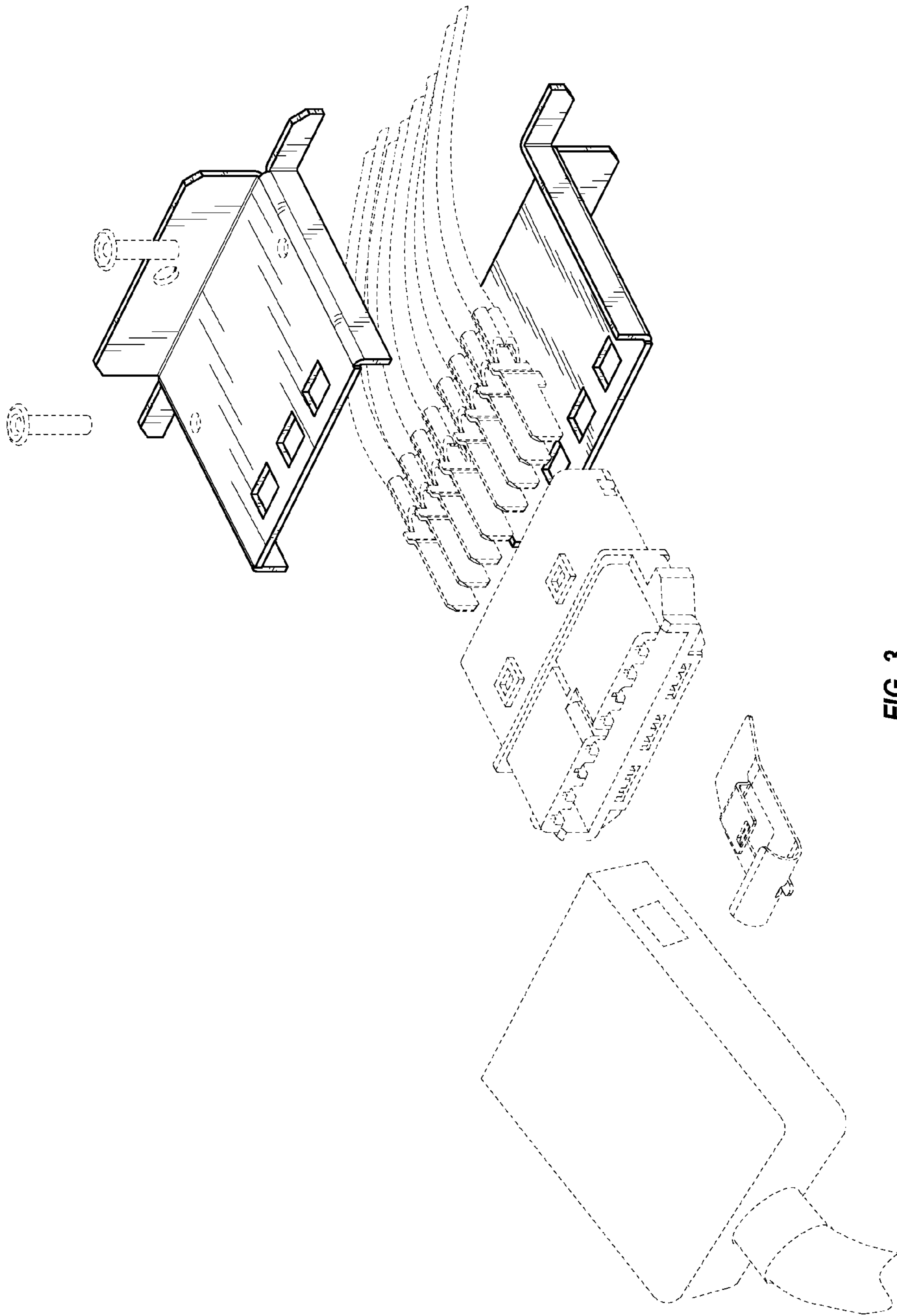

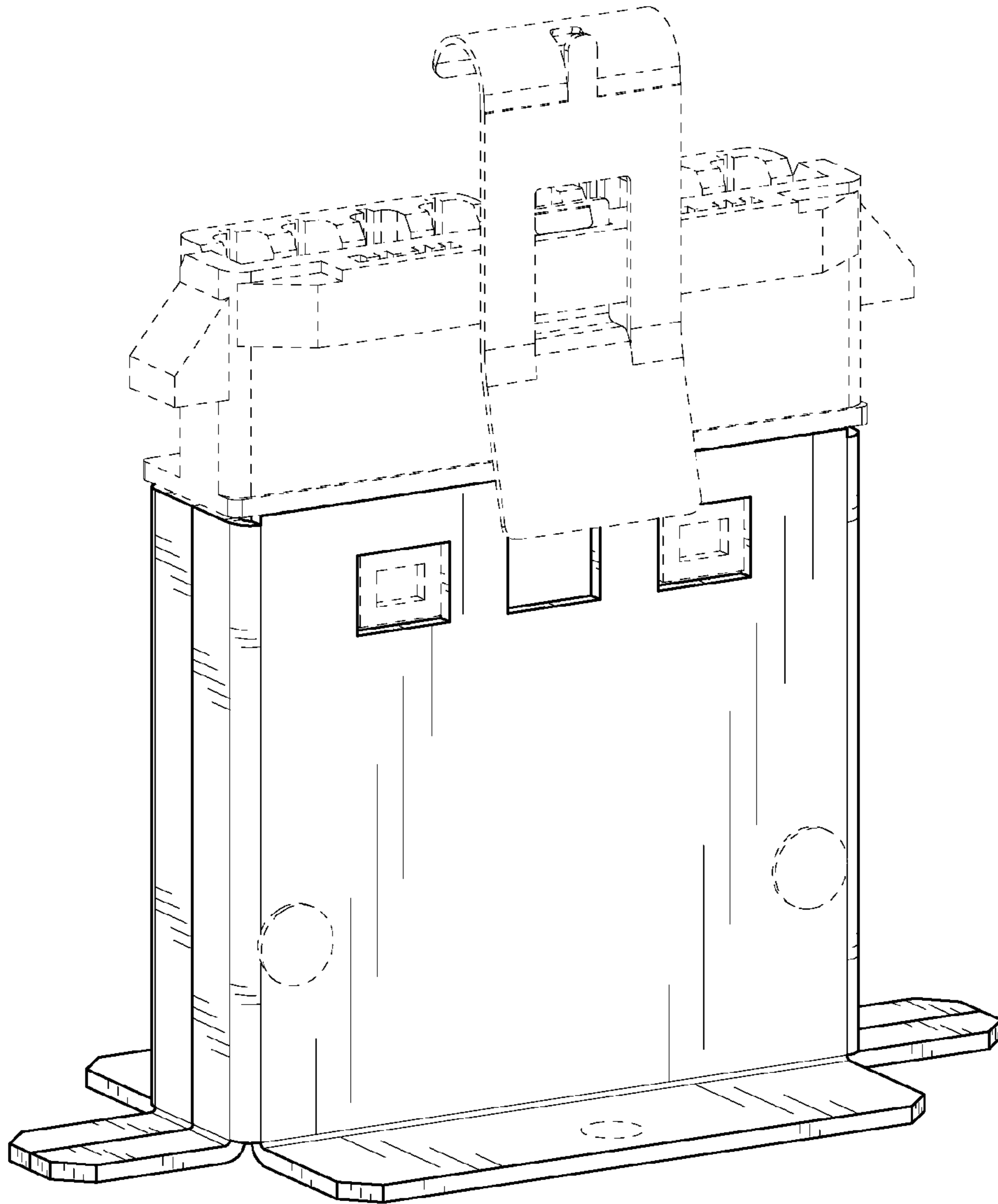

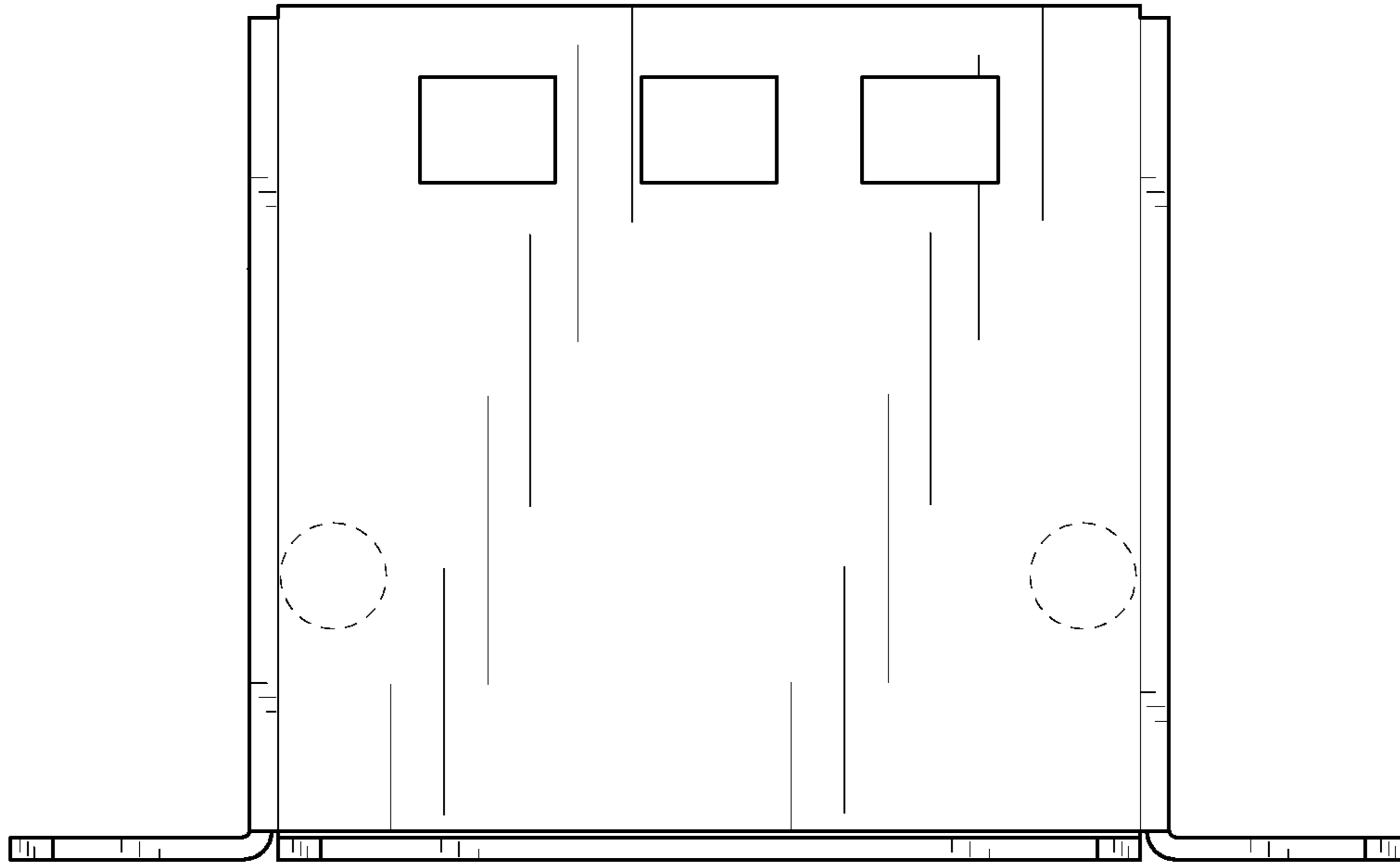

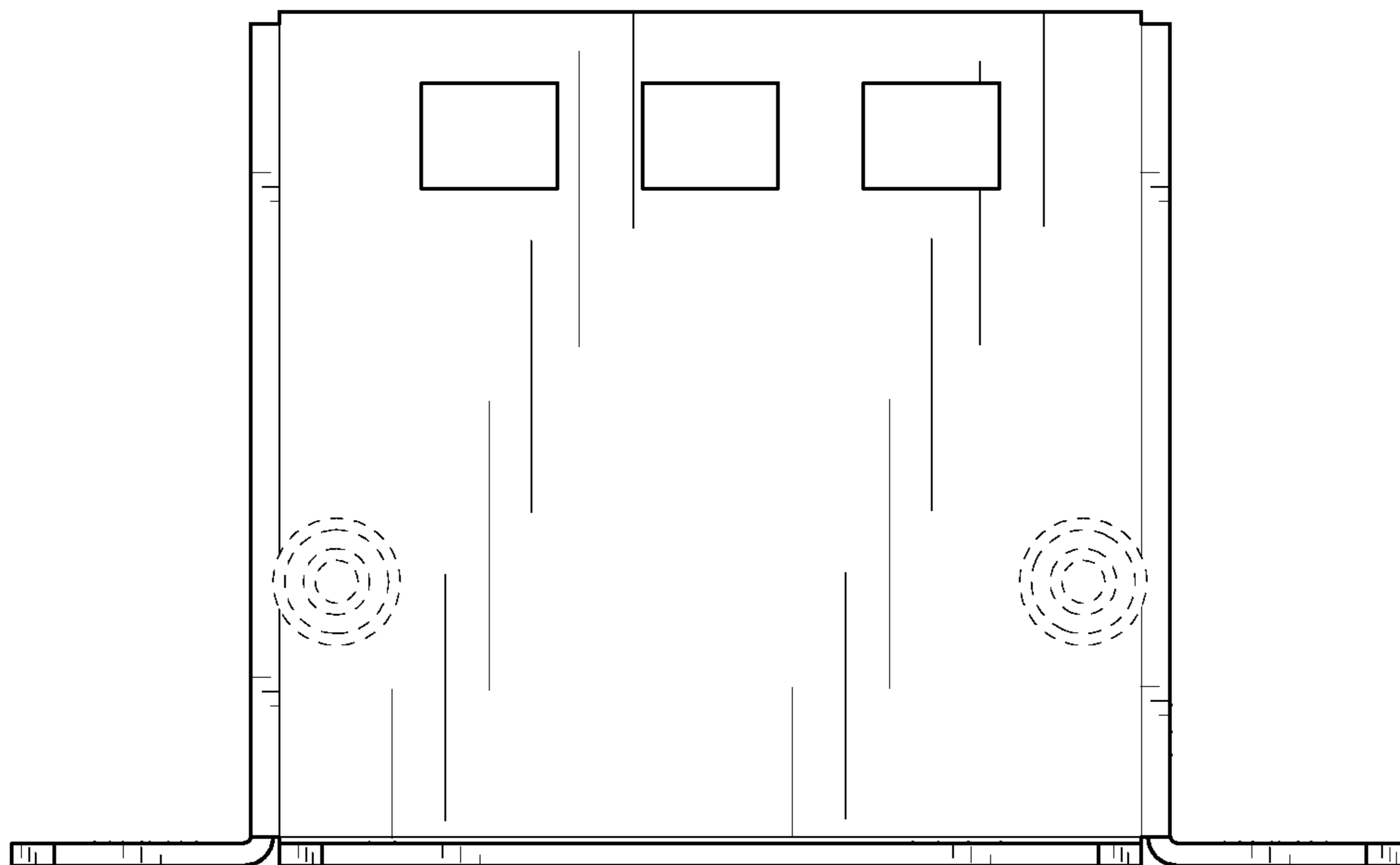

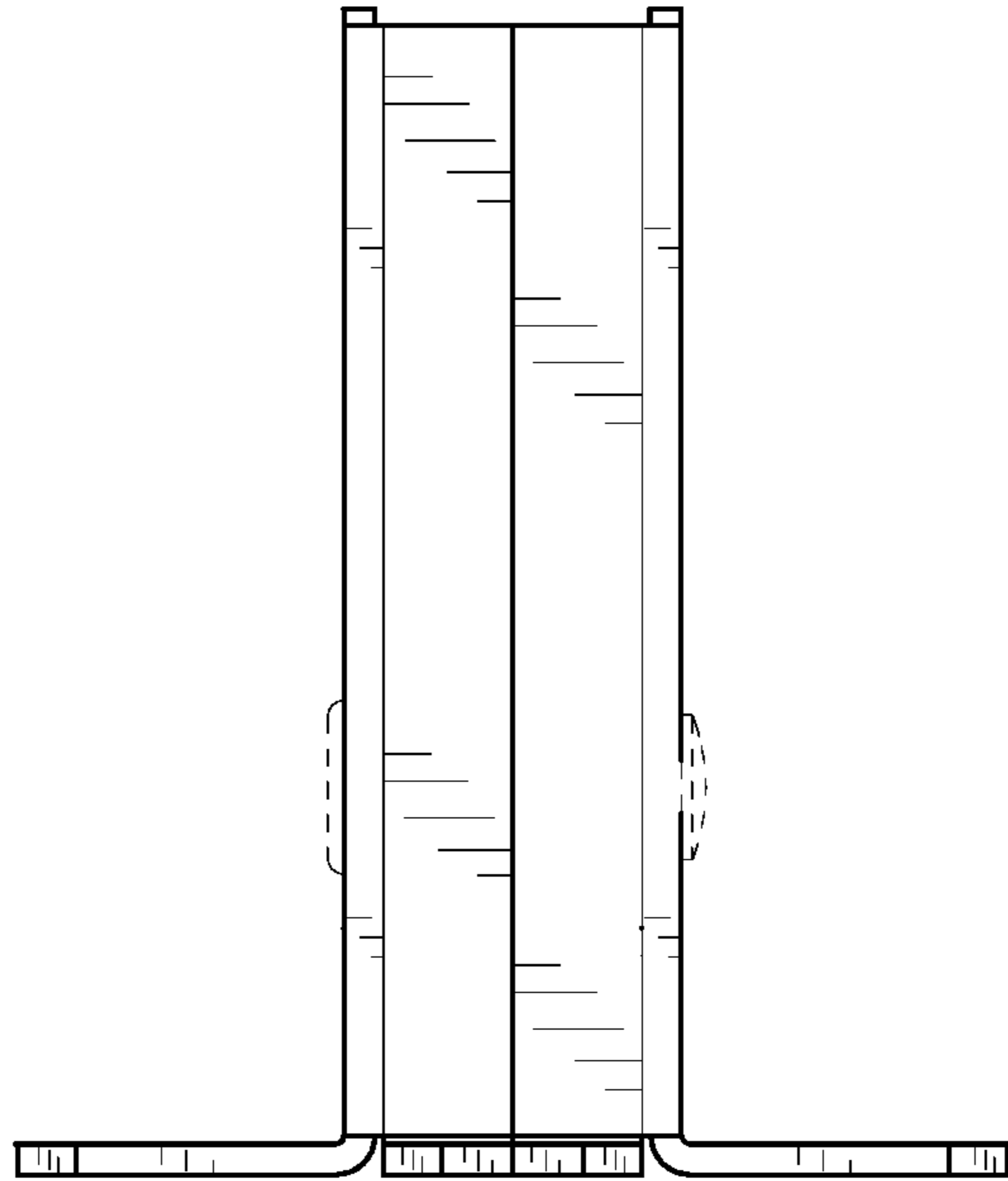

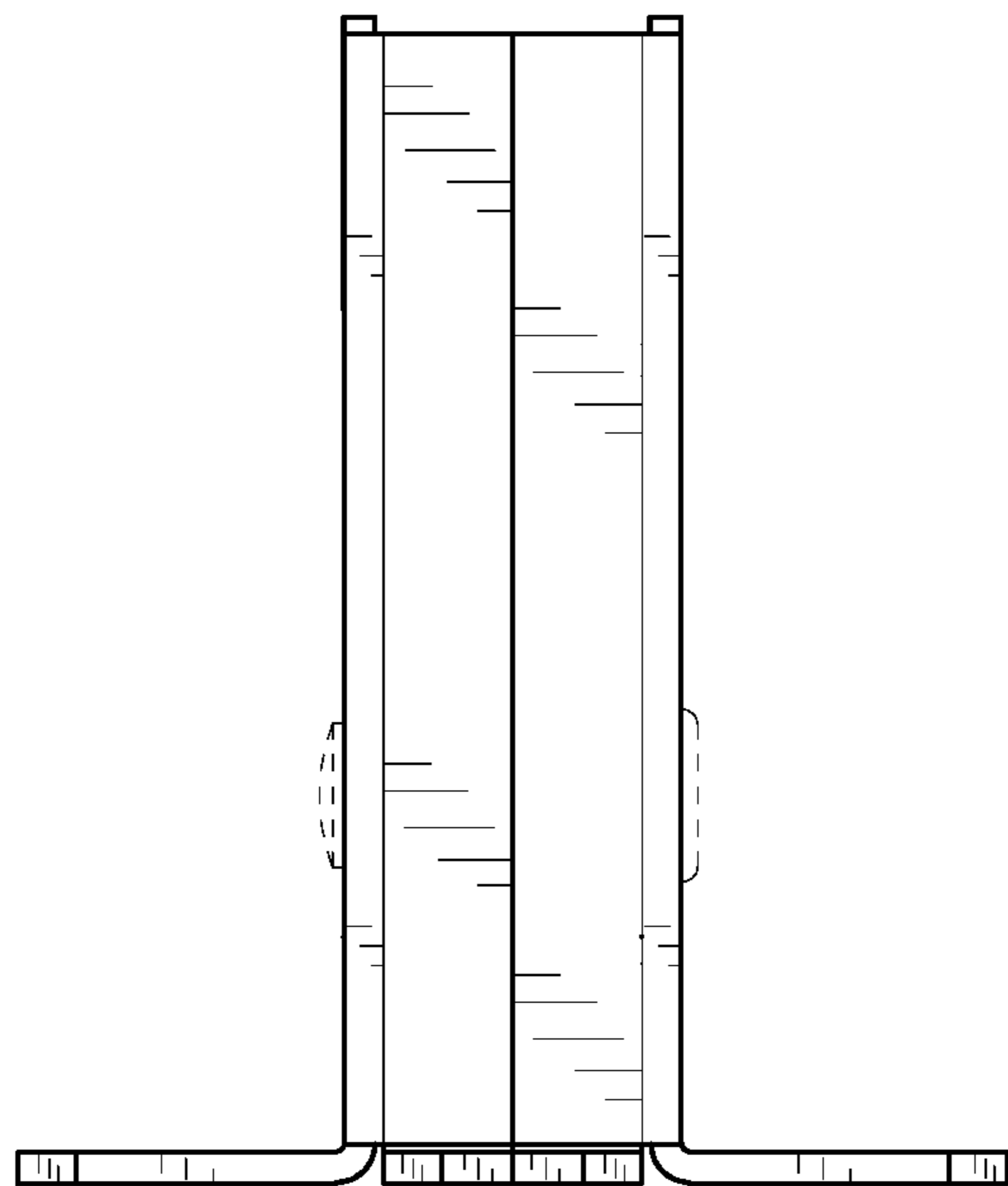

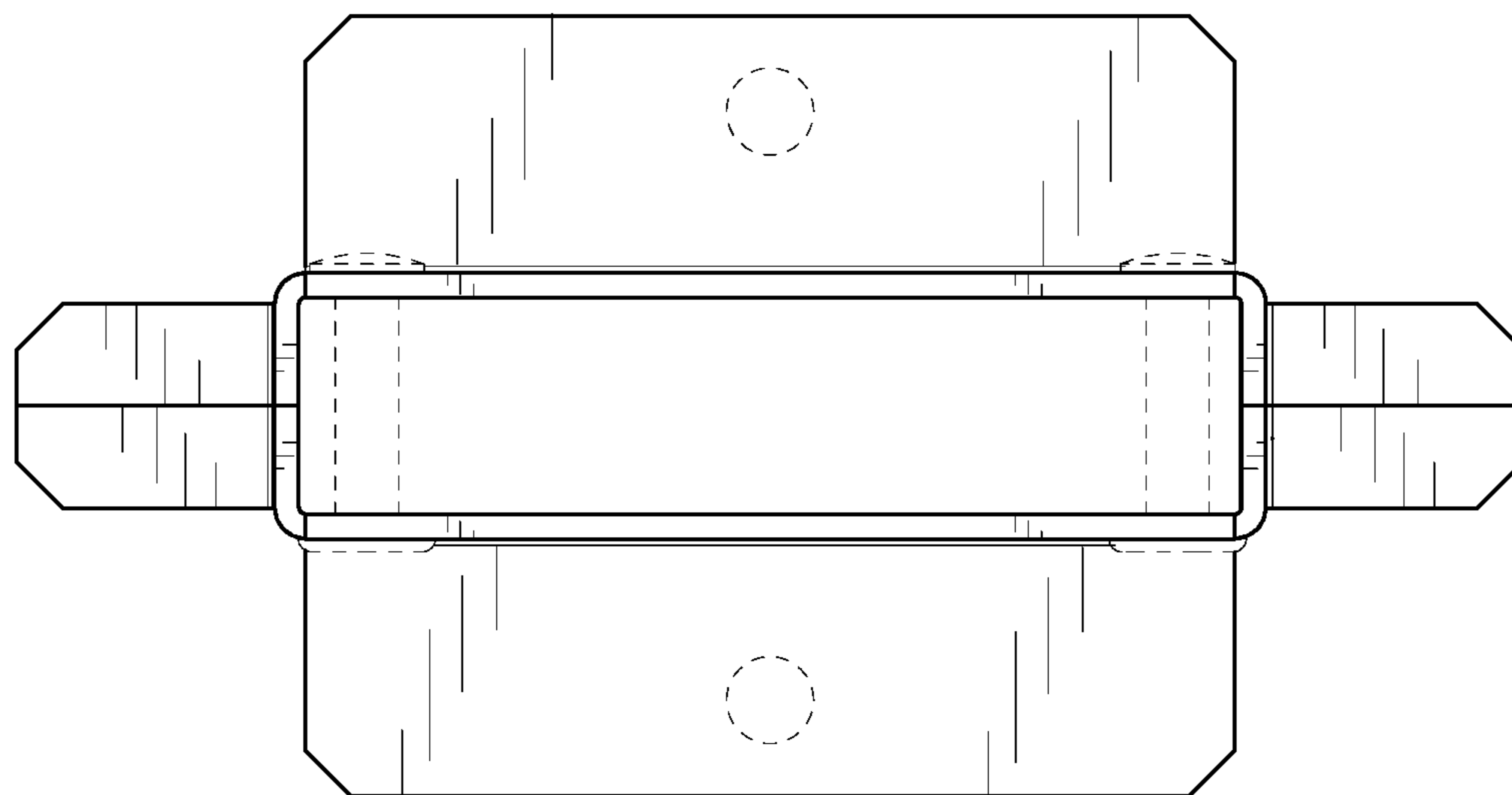

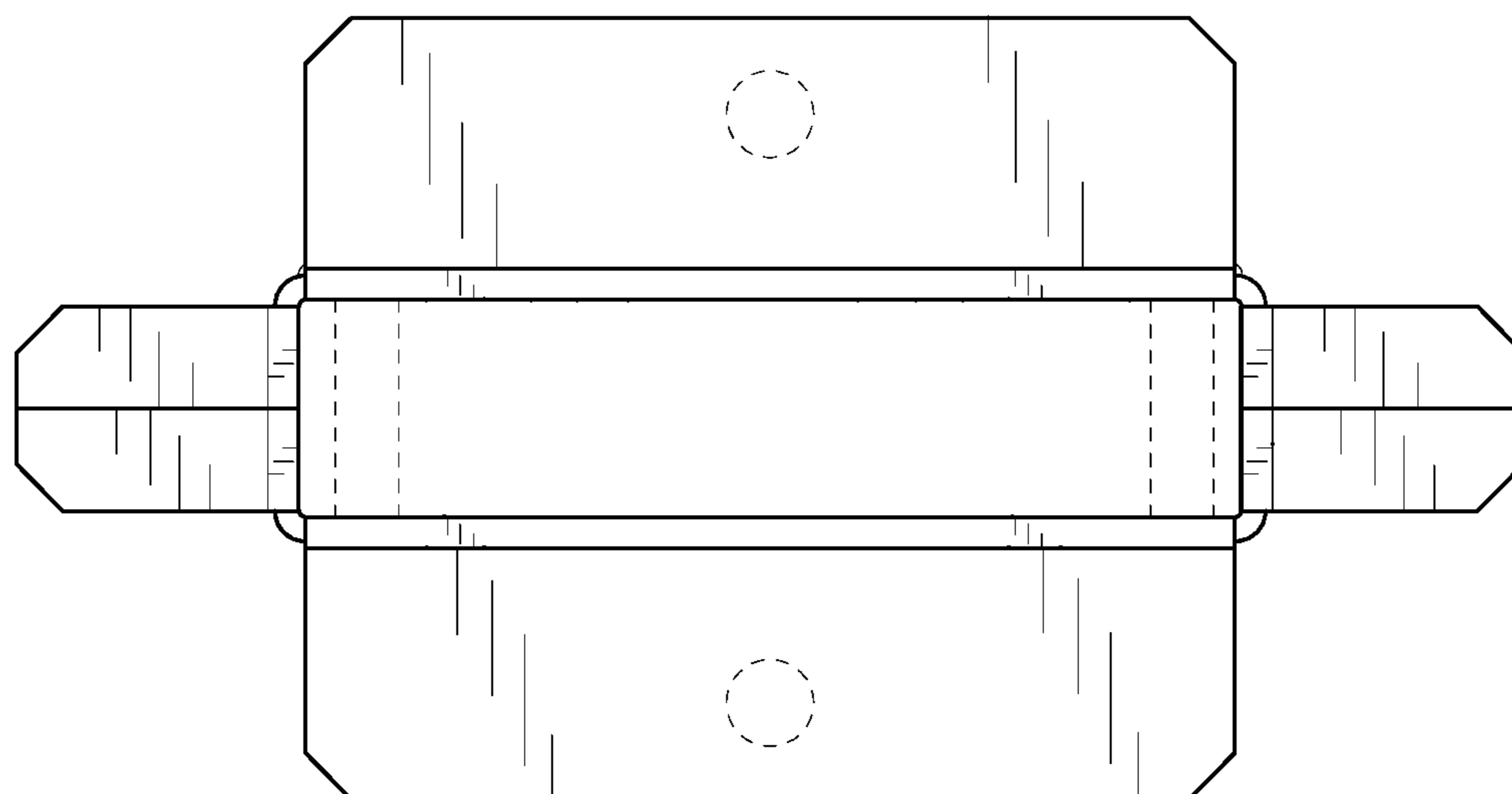
