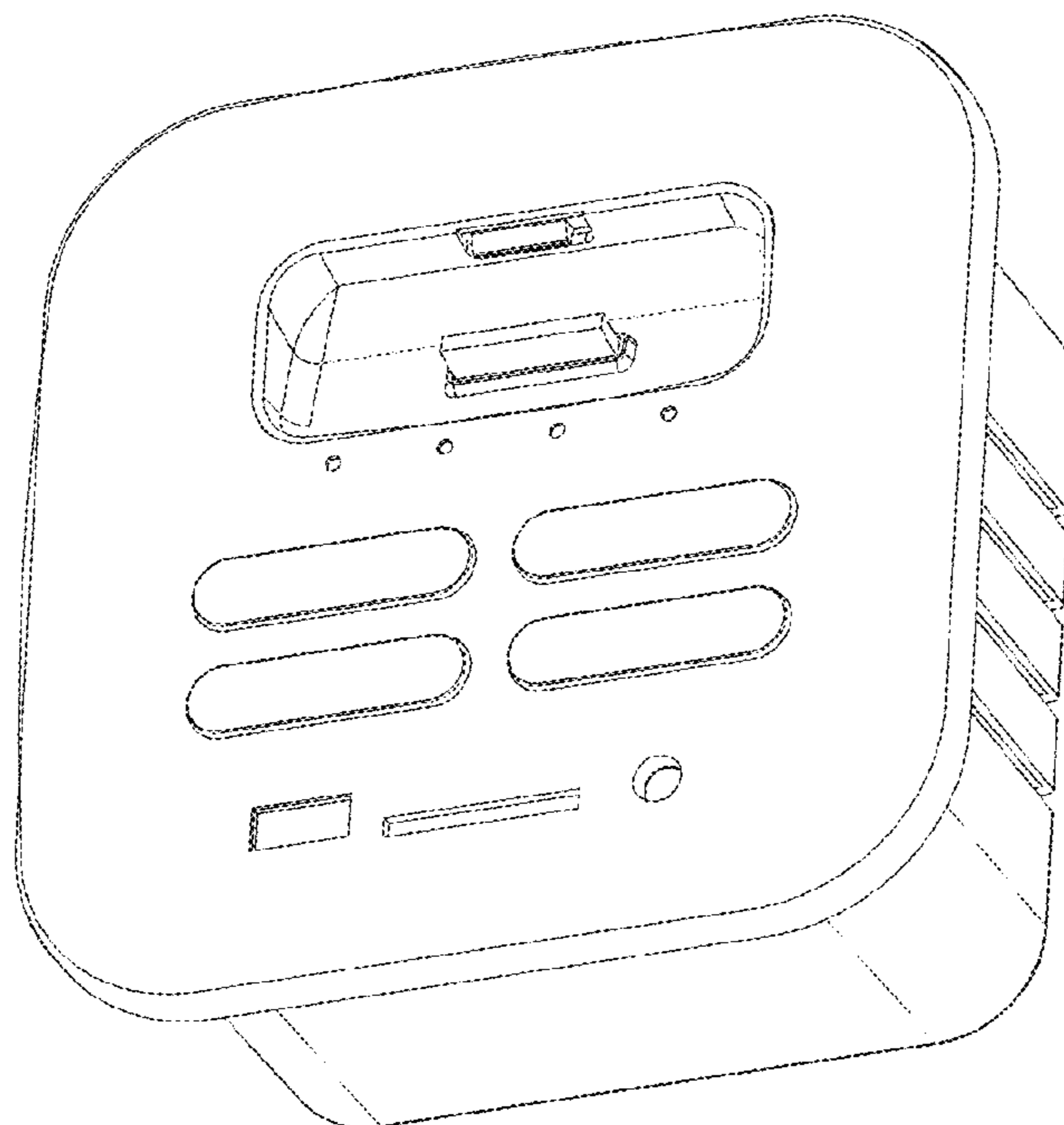
FIG. 1 is a front elevational view of an embodiment of a smart furniture control box showing our new design;

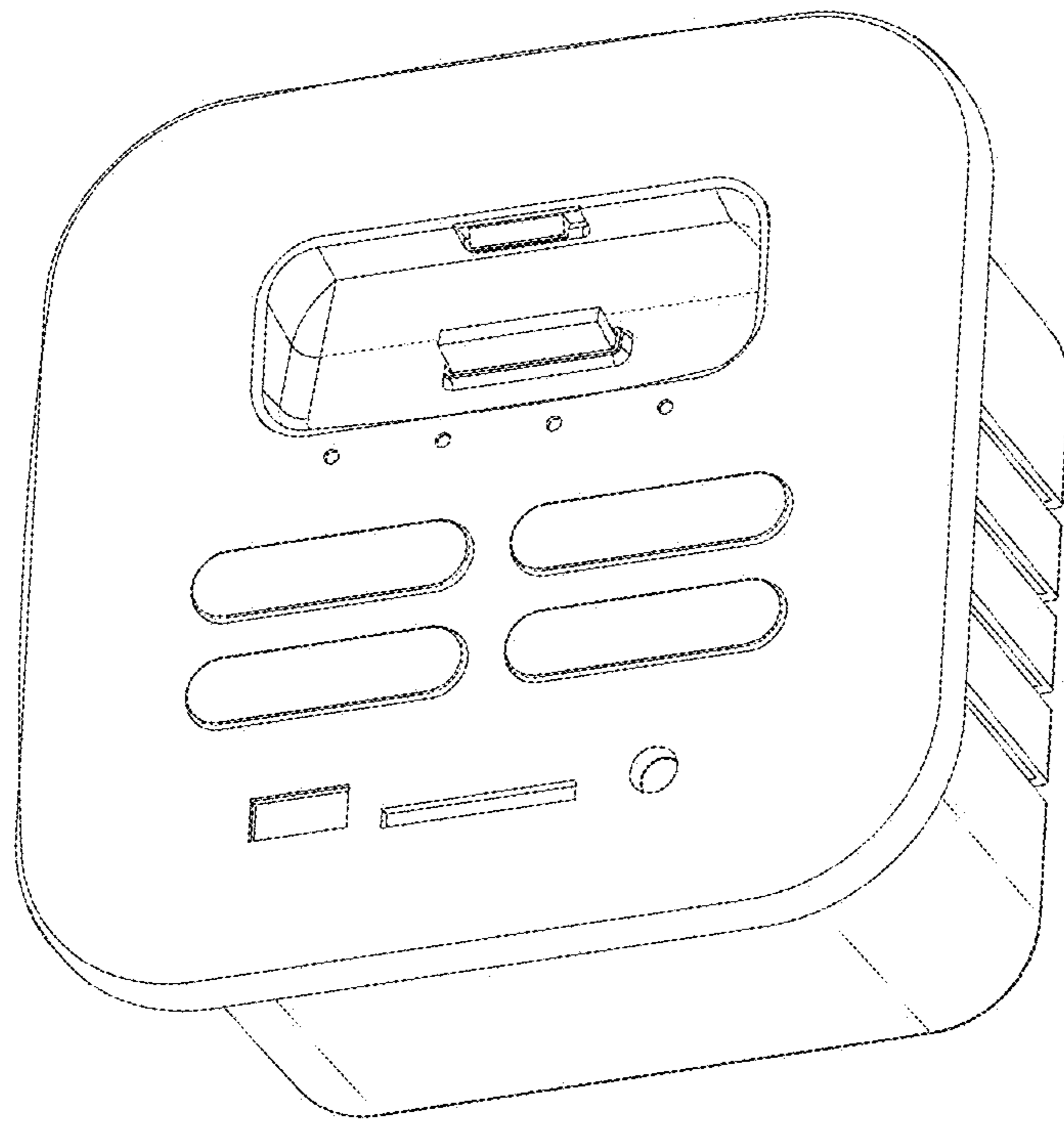

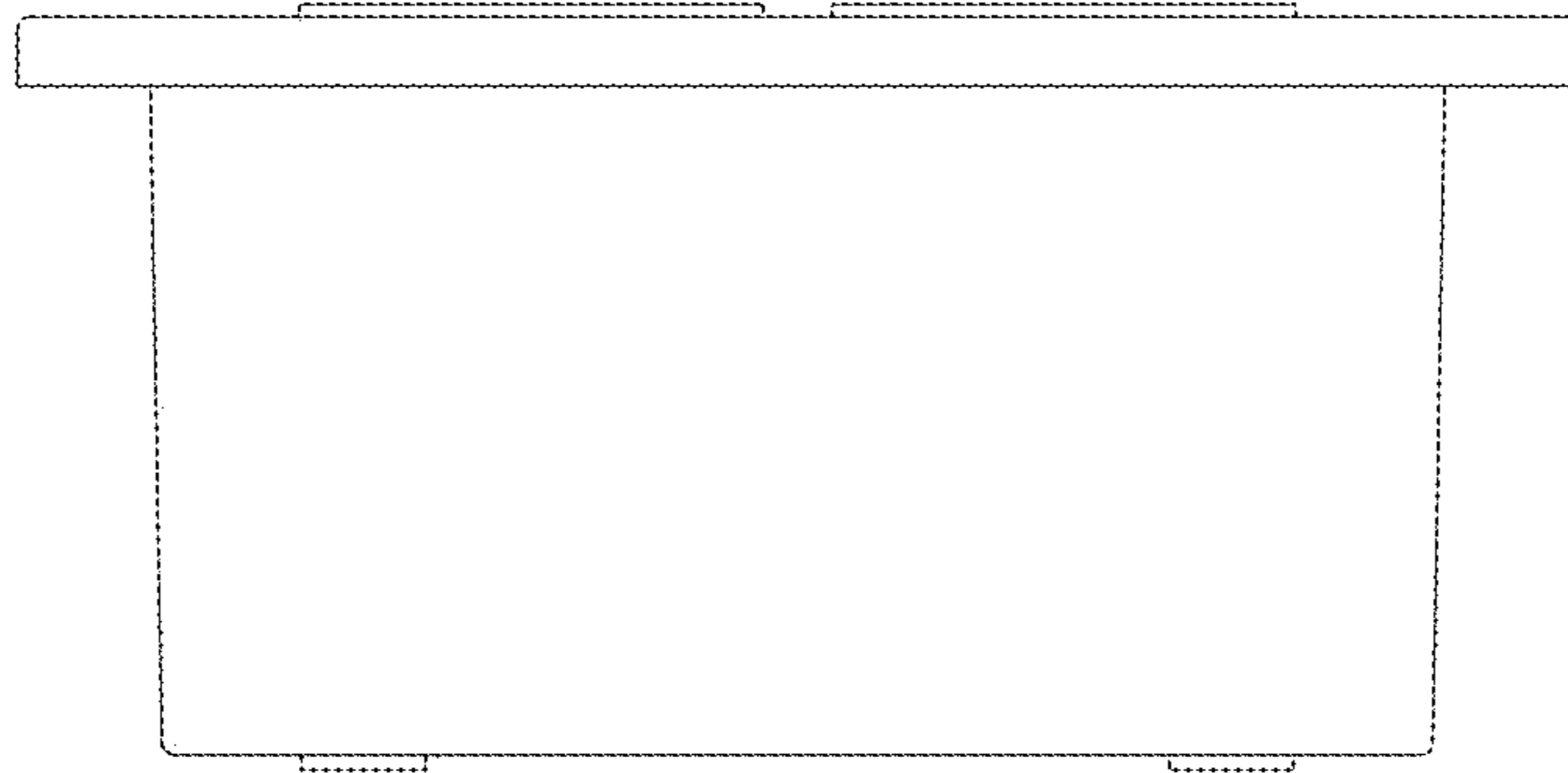

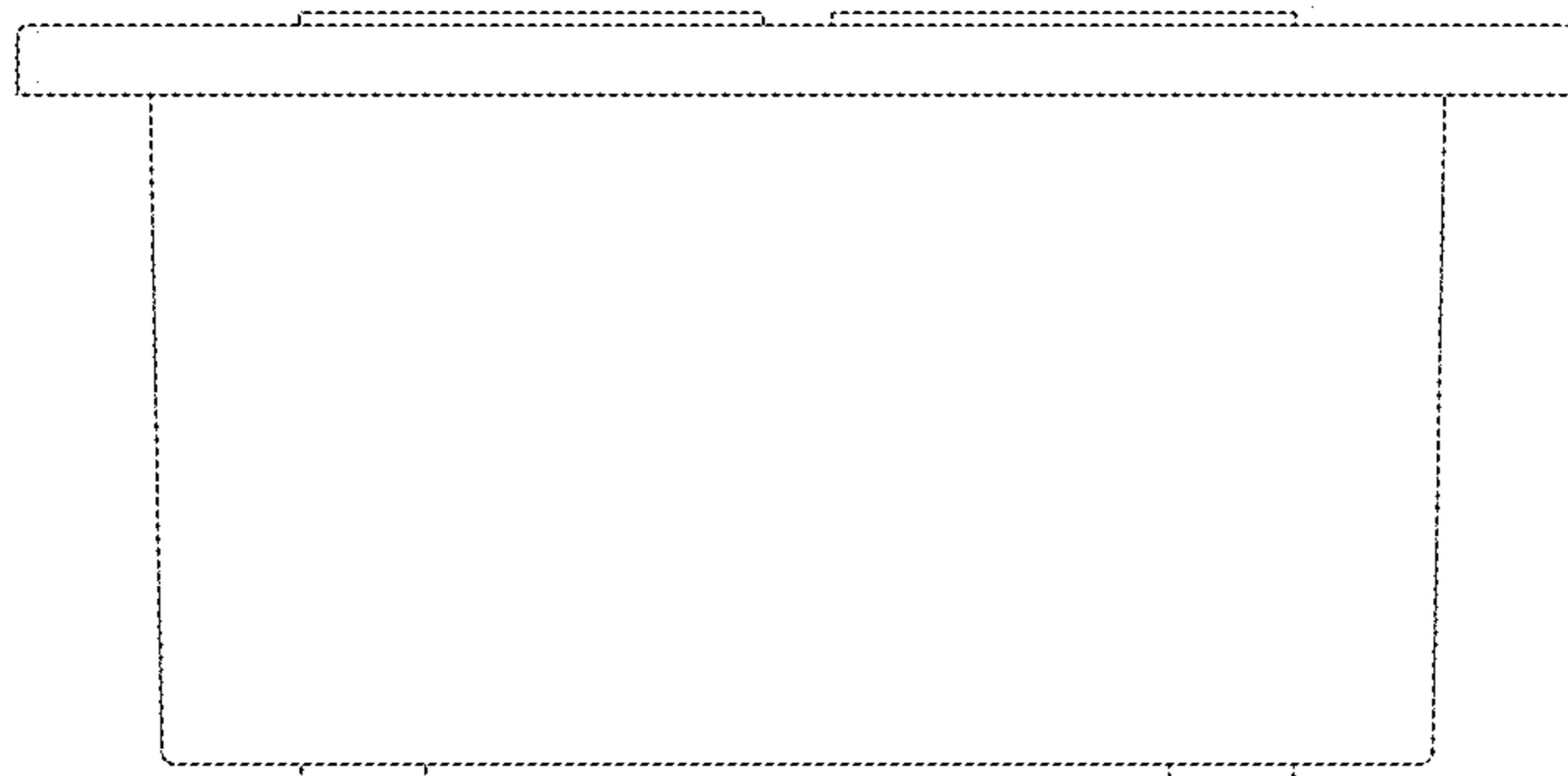

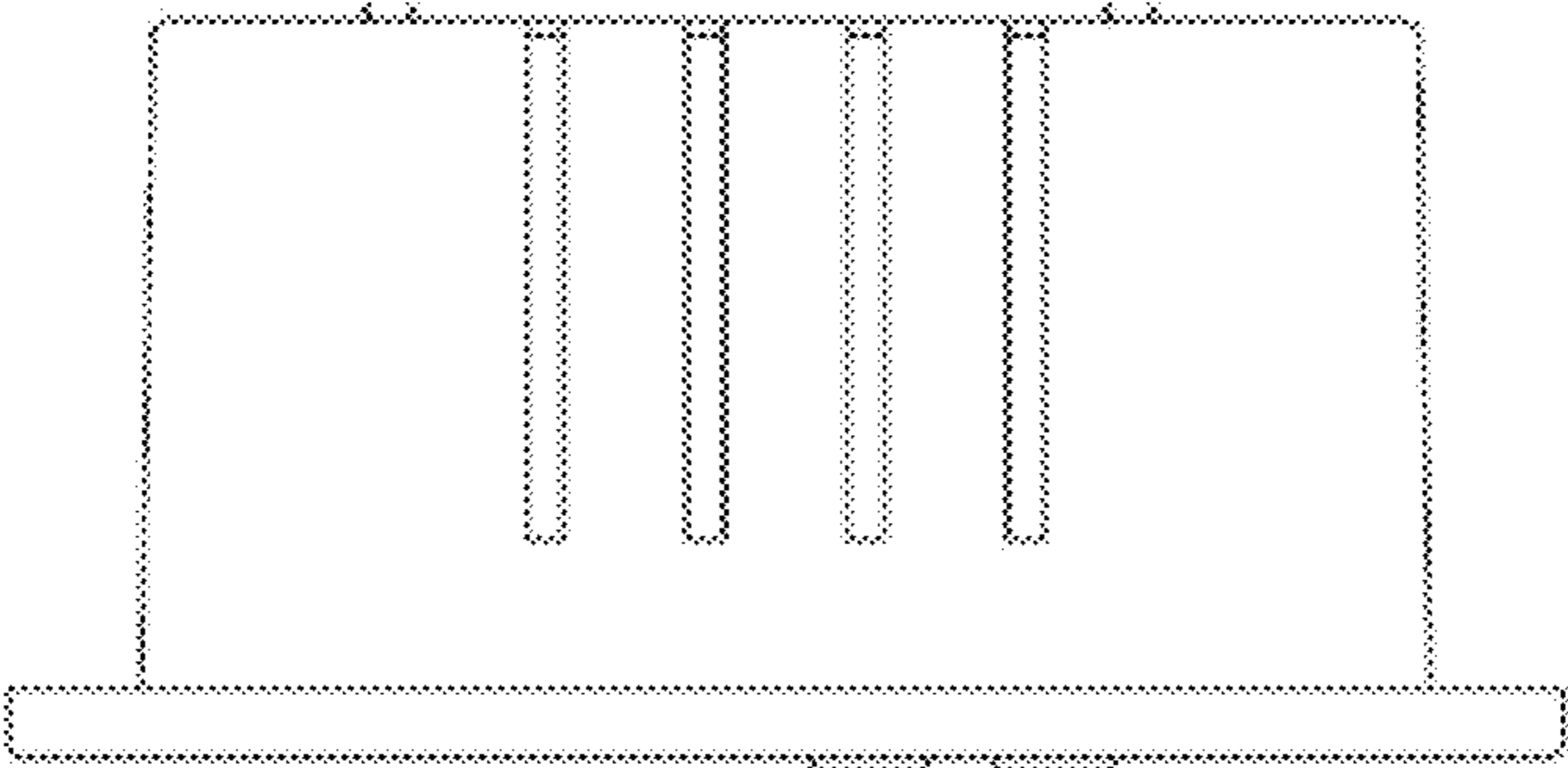

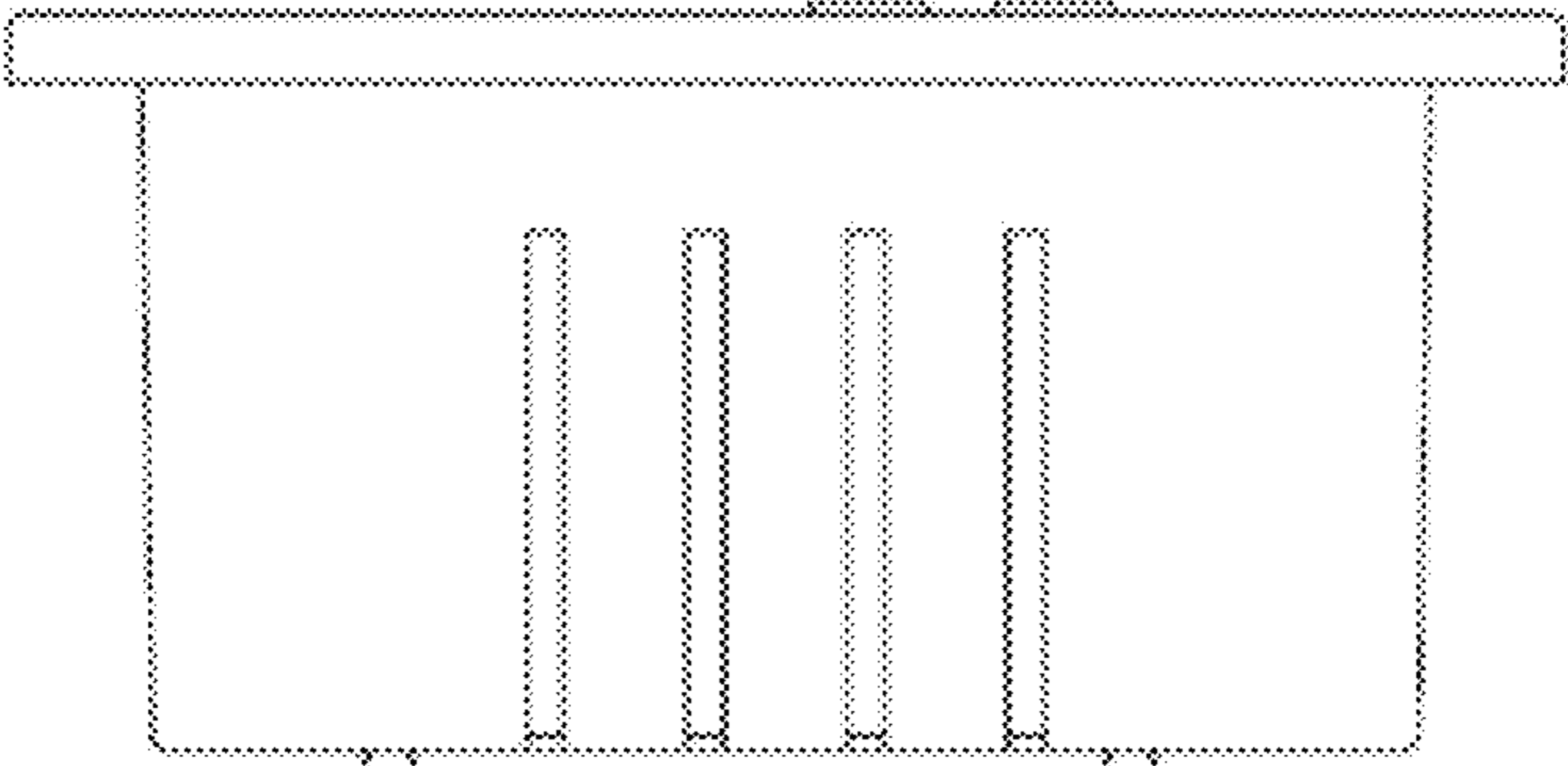

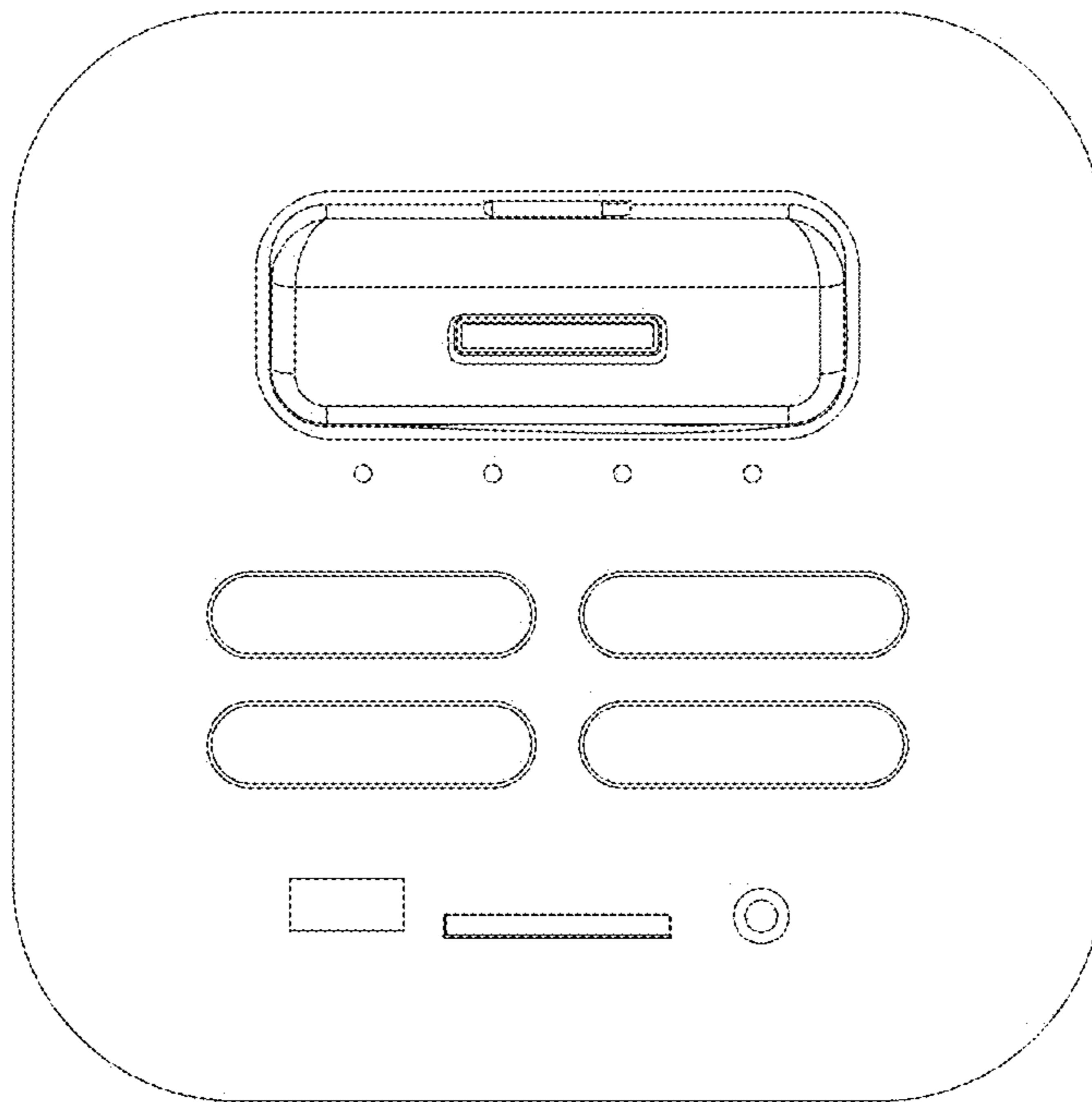

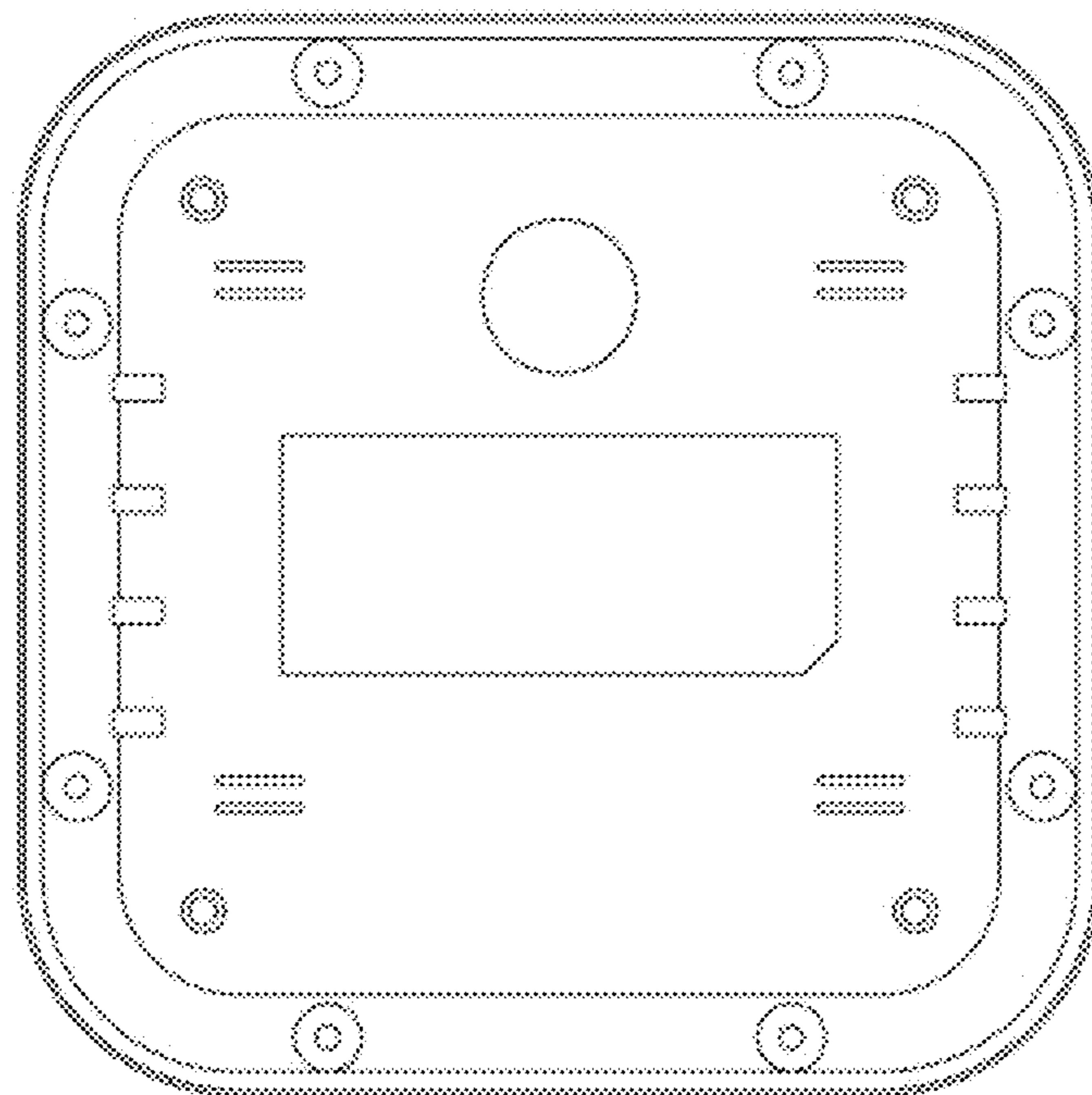
