**DESCRIPTION**

FIG. 1 is a perspective view of a pen of my new design; FIG. 2 is a left side elevation view of the pen of FIG. 1; FIG. 3 is a right side elevation view of the pen of FIG. 1; FIG. 4 is a front elevation view of the pen of FIG. 1; FIG. 5 is a rear elevation view of the pen of FIG. 1; FIG. 6 is a bottom end view of the pen of FIG. 1; FIG. 7 is a top end view of the pen of FIG. 1; and, FIG. 8 is an exploded view of the pen of FIG. 1 showing a cap thereof removed.

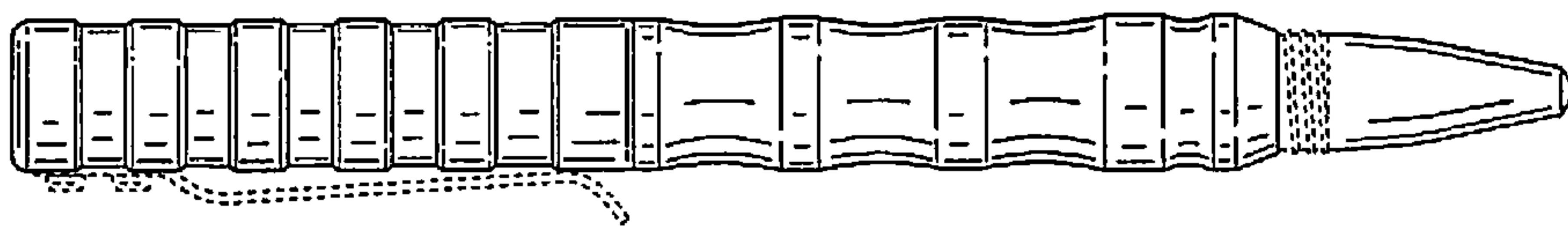

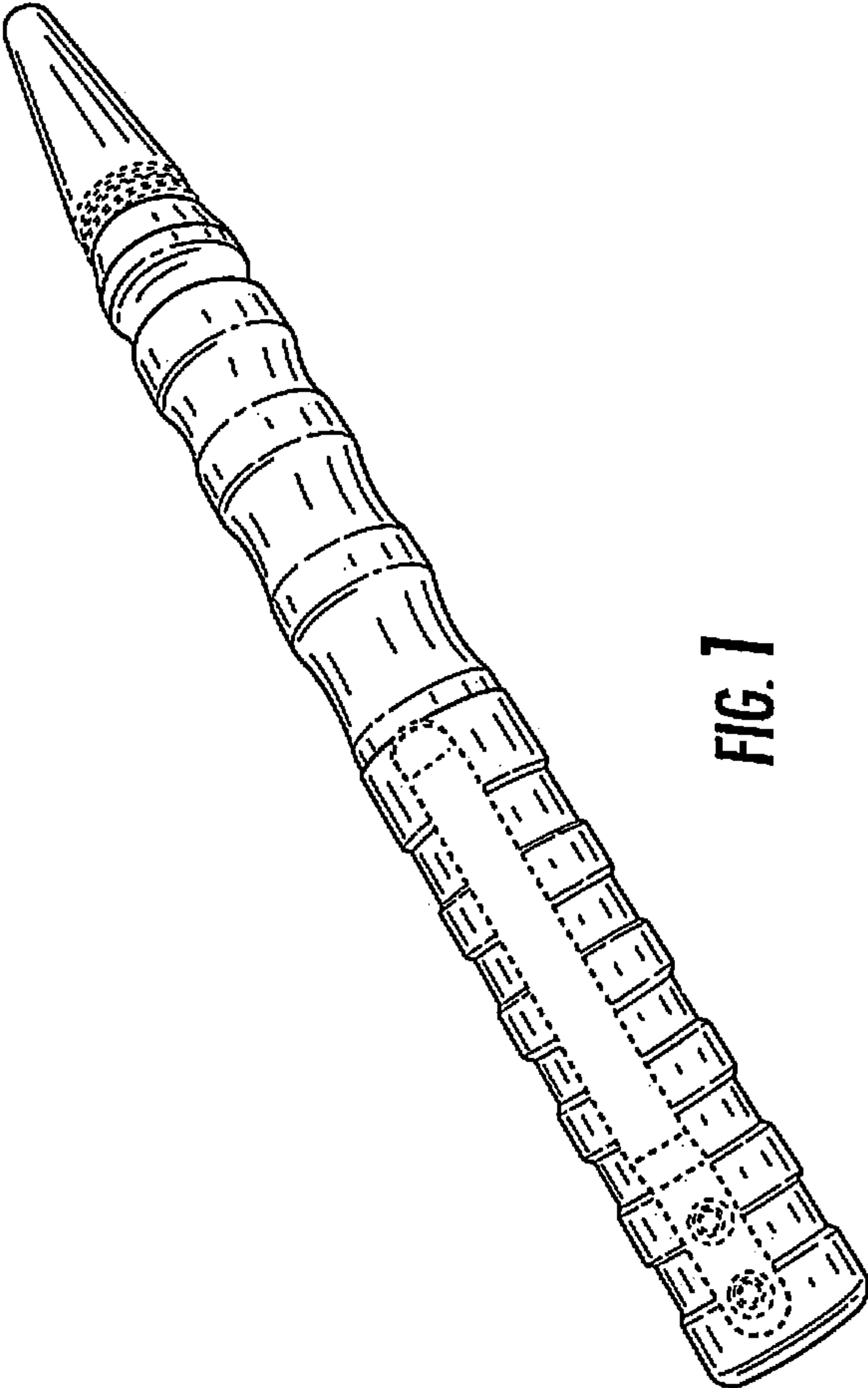

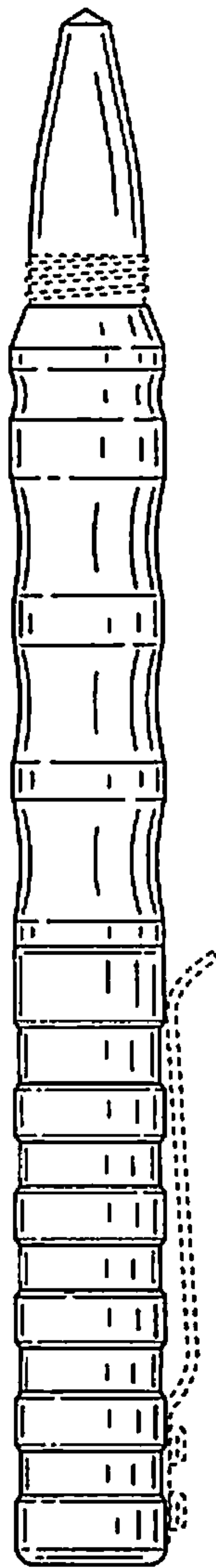

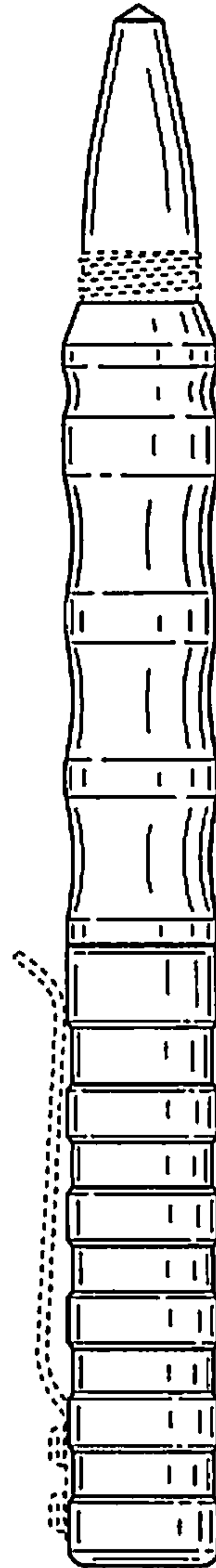
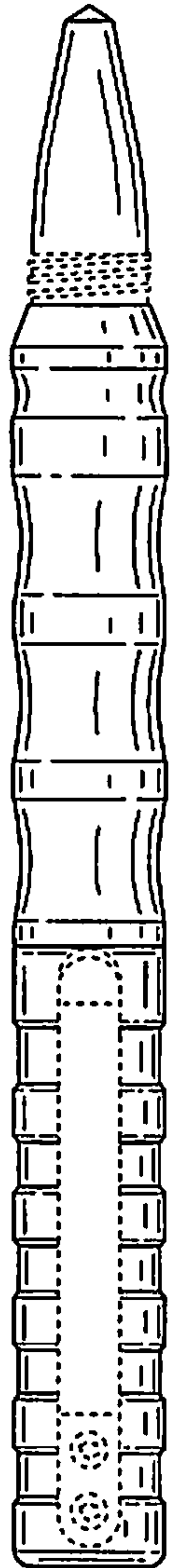
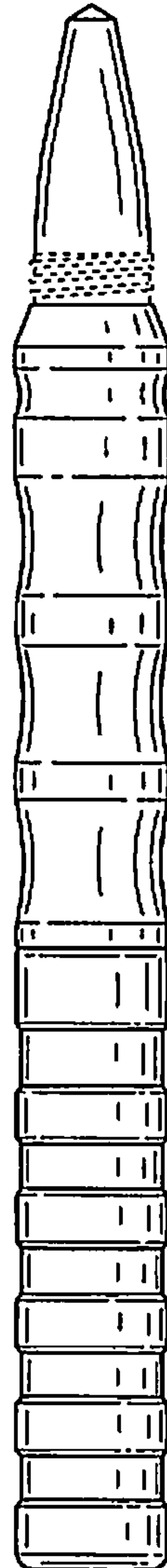


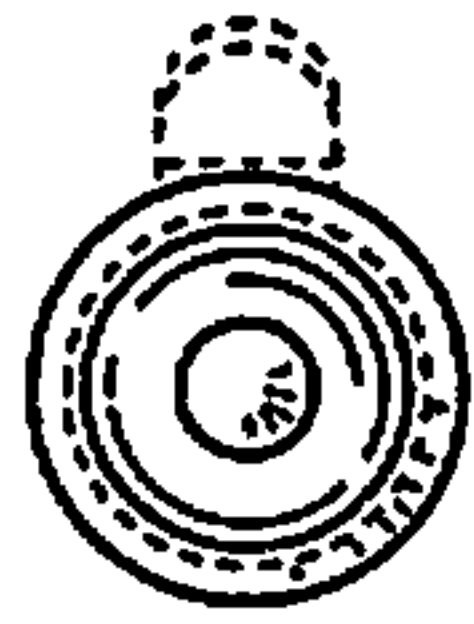

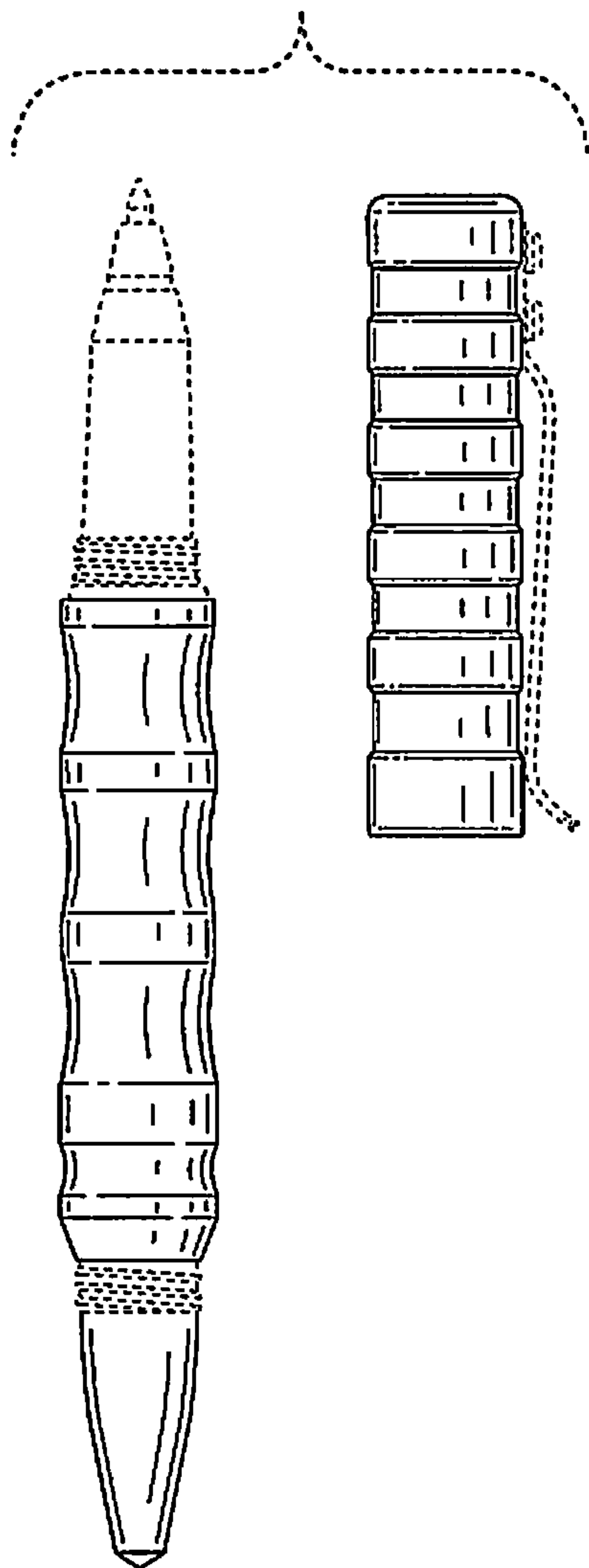
