FIG. 3 is a back view of the doll house of the present invention;

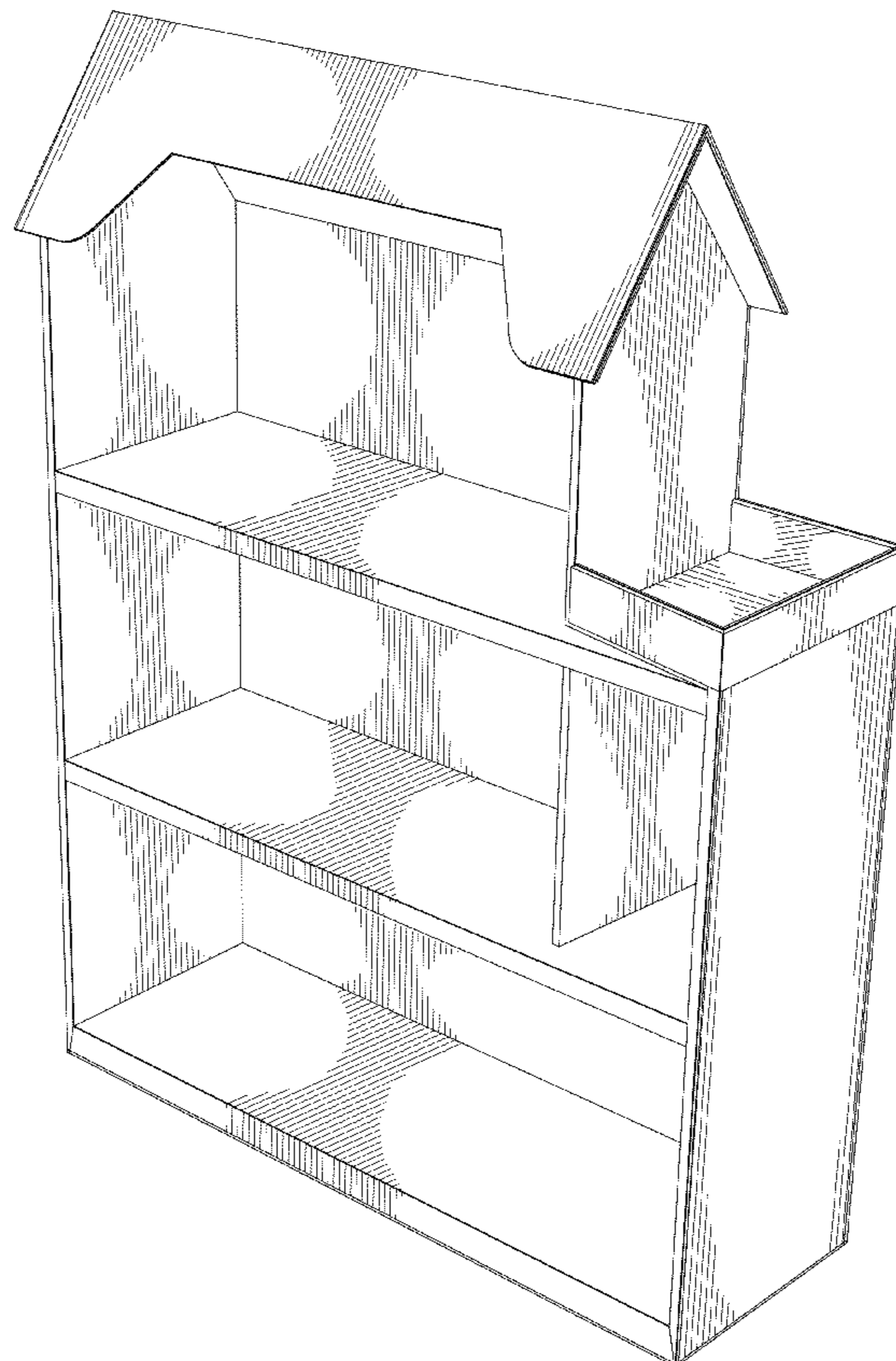
FIG. 4 is a side view of the doll house of the present invention;

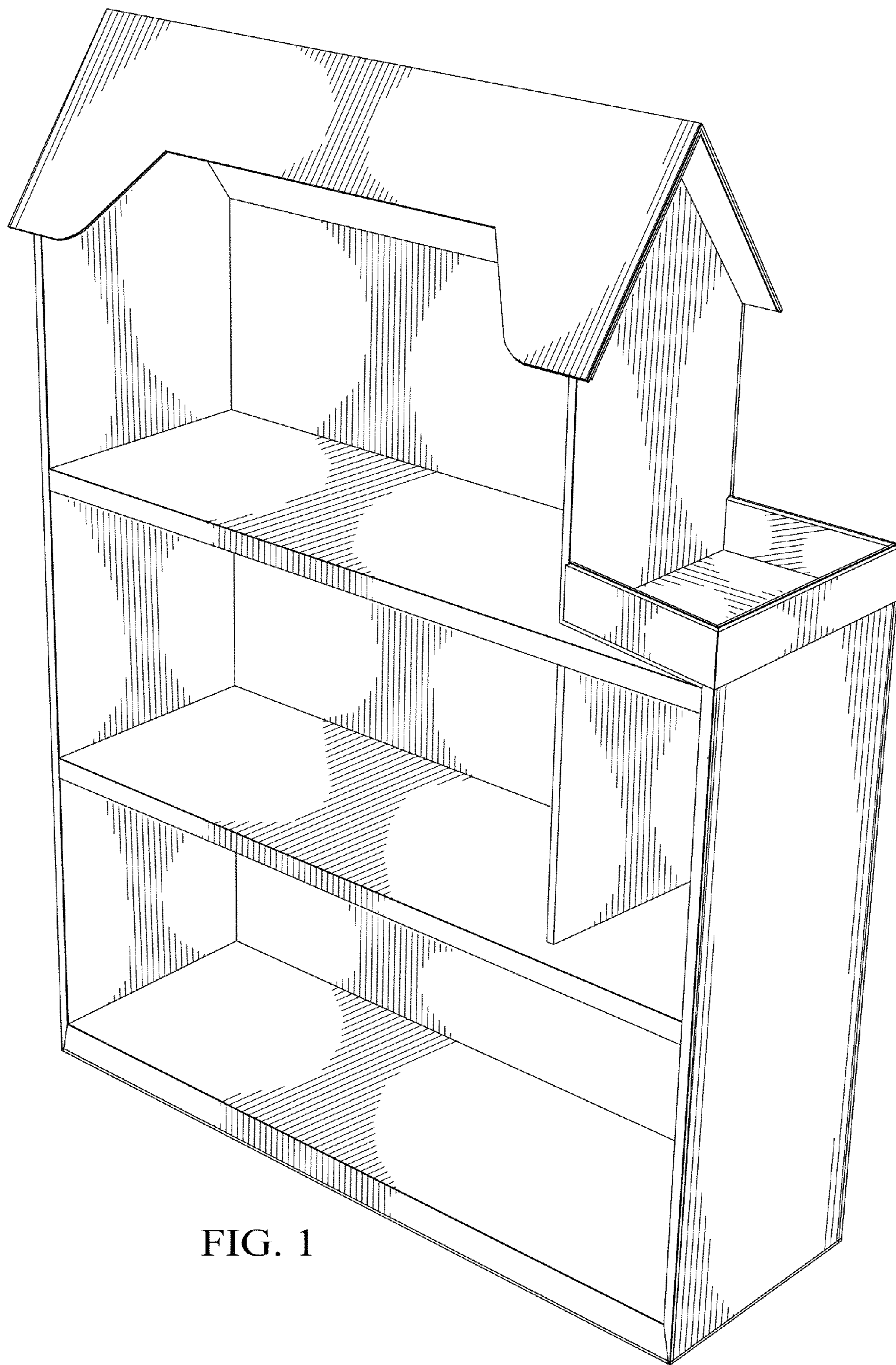

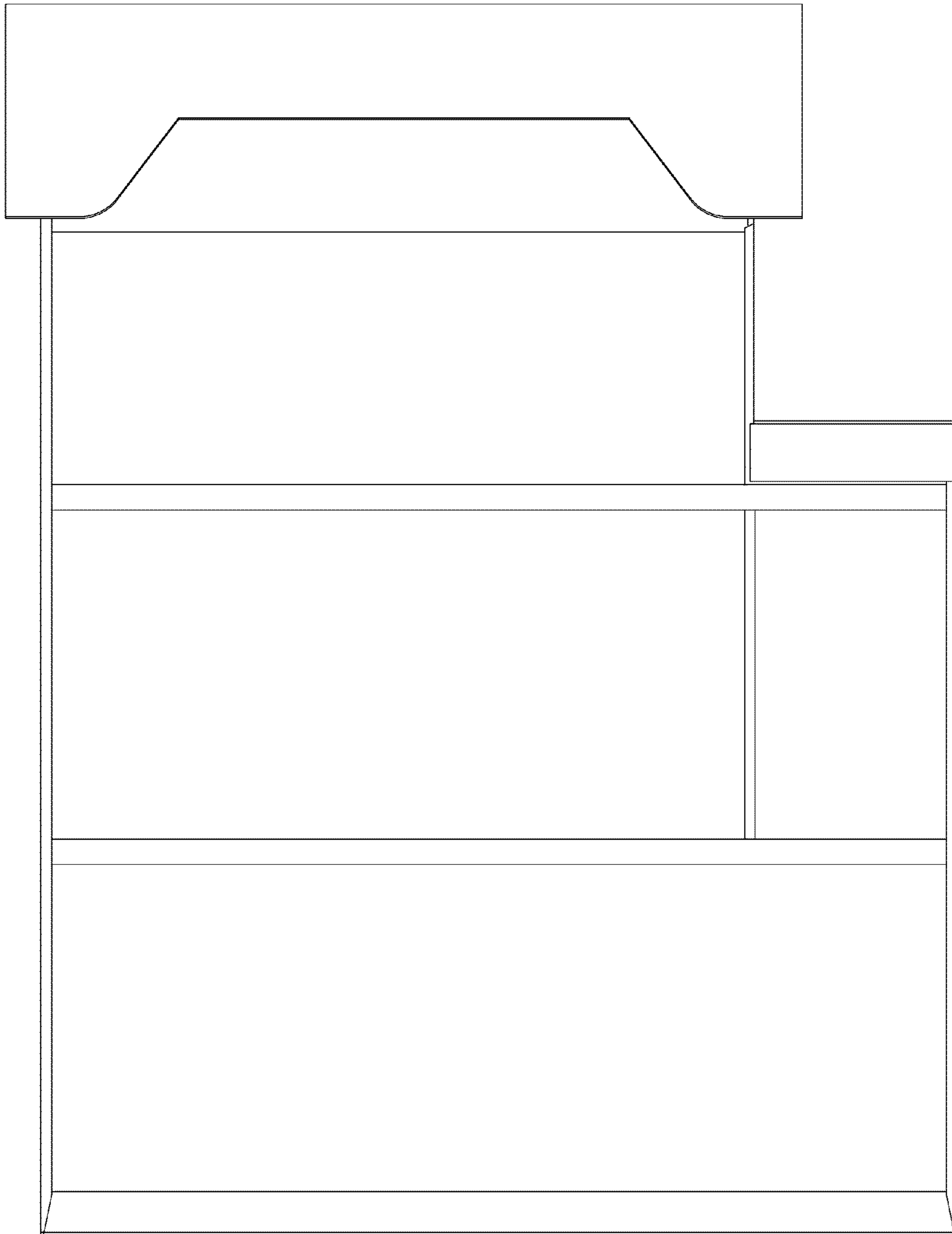

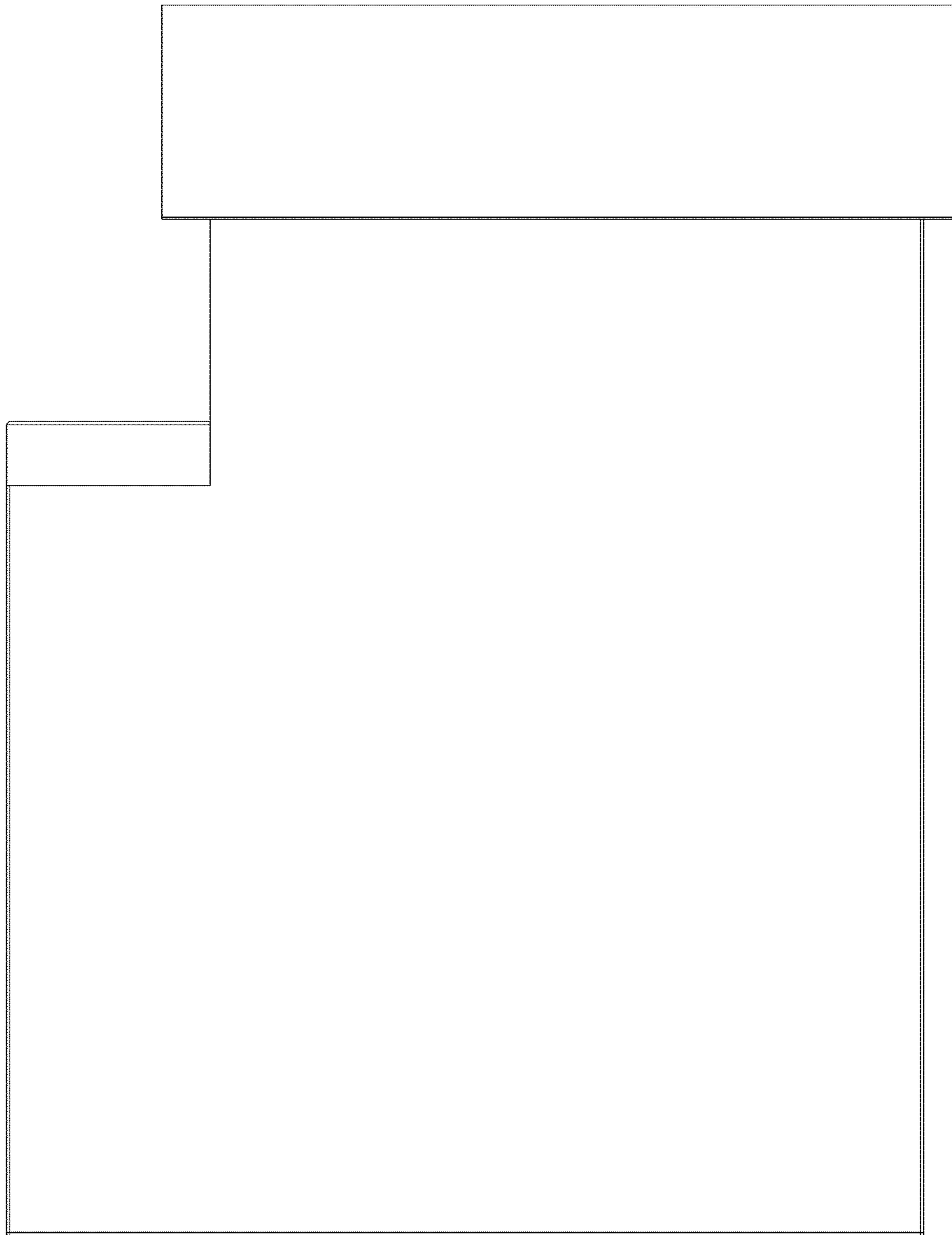

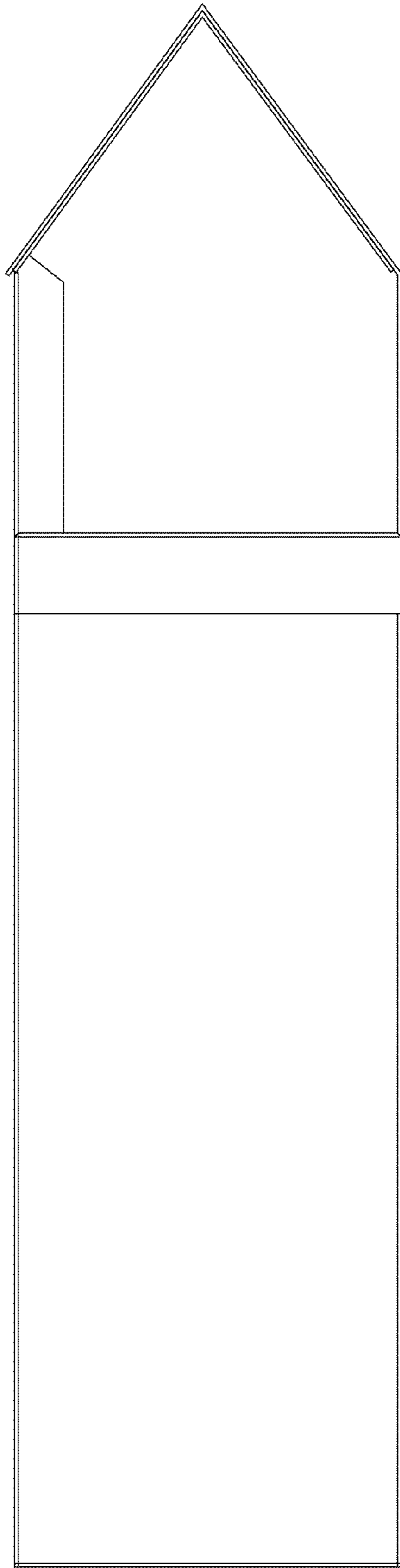

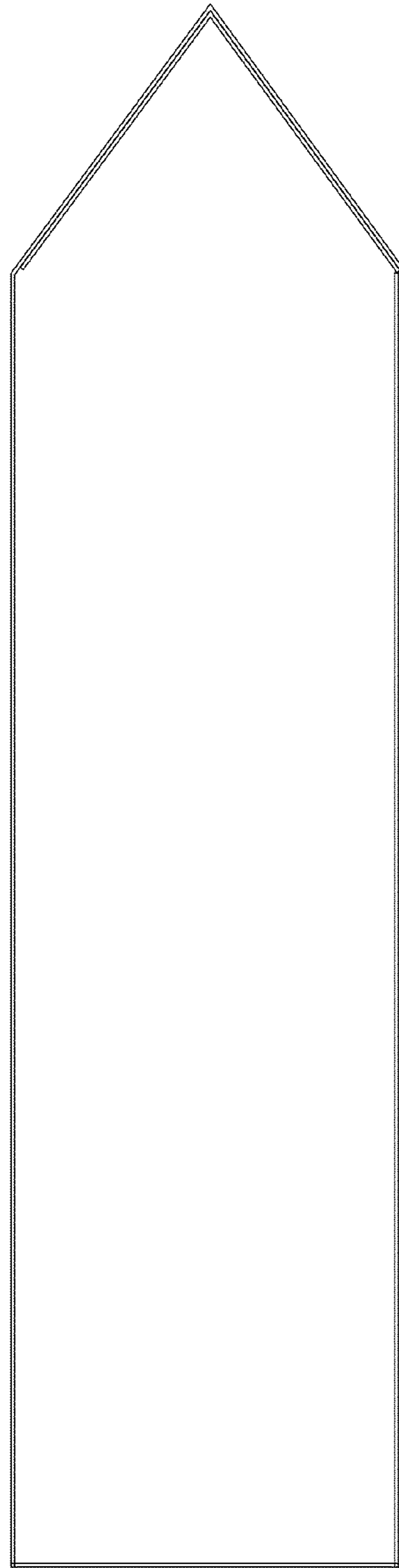

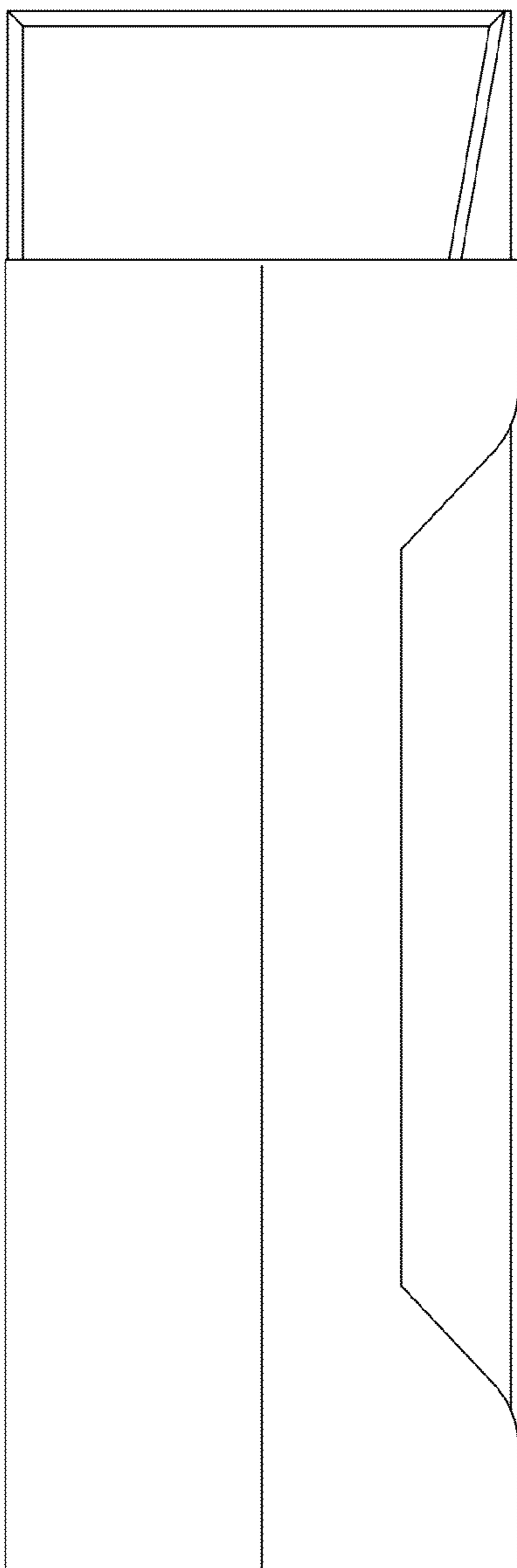

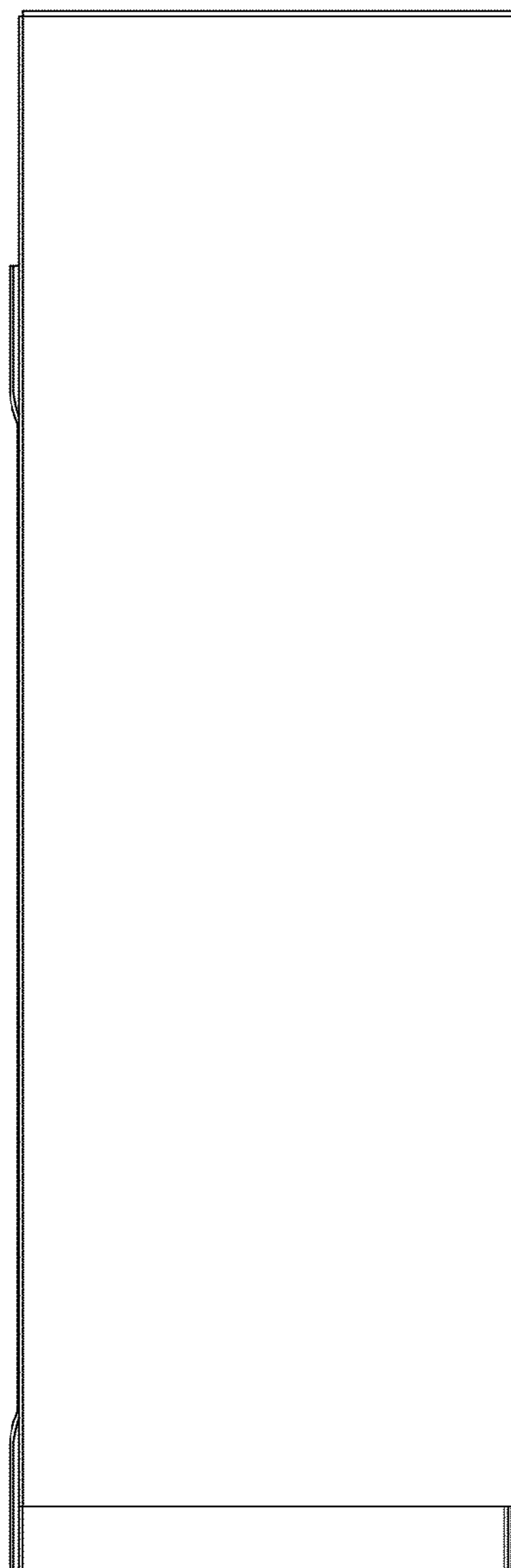
