(57) **CLAIM**

I claim the ornamental design for a golf putter head with shaft attachment, as shown and described.

DESCRIPTION

FIG. 1 is a front, side and top perspective view of the golf putter head with shaft attachment, shown in place on the end of a golf club shaft;

FIG. 2 is a top view of the golf putter head with shaft attachment;

FIG. 3 is a bottom view of the golf putter head with shaft attachment;

FIG. 4 is a front view of the golf putter head with shaft attachment;

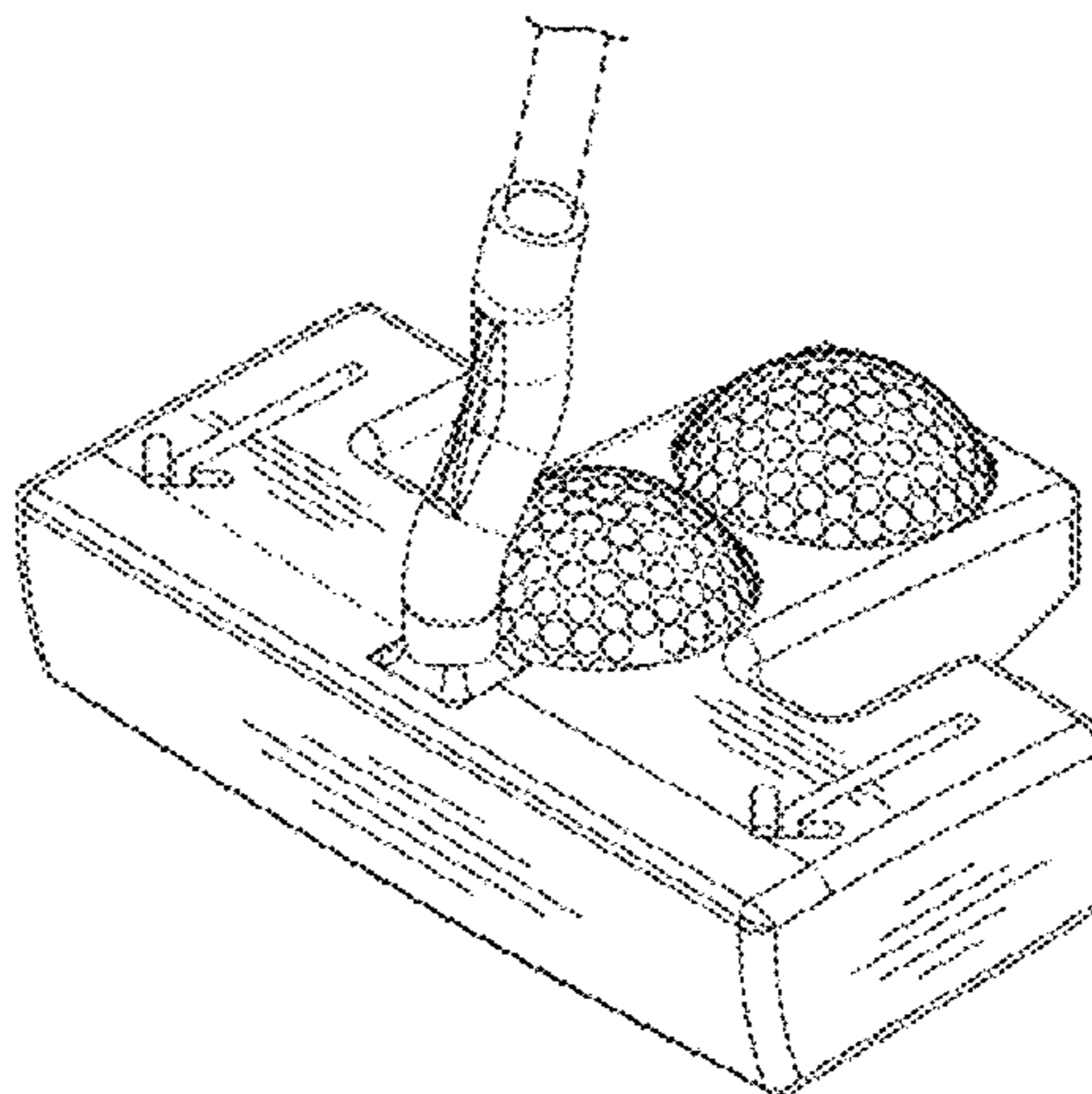
FIG. 5 is a rear view of the golf putter head with shaft attachment;

FIG. 6 is a side elevation view of the left side of the golf putter head with shaft attachment; and,

FIG. 7 is a side elevation view of the right side of the golf putter head with shaft attachment.

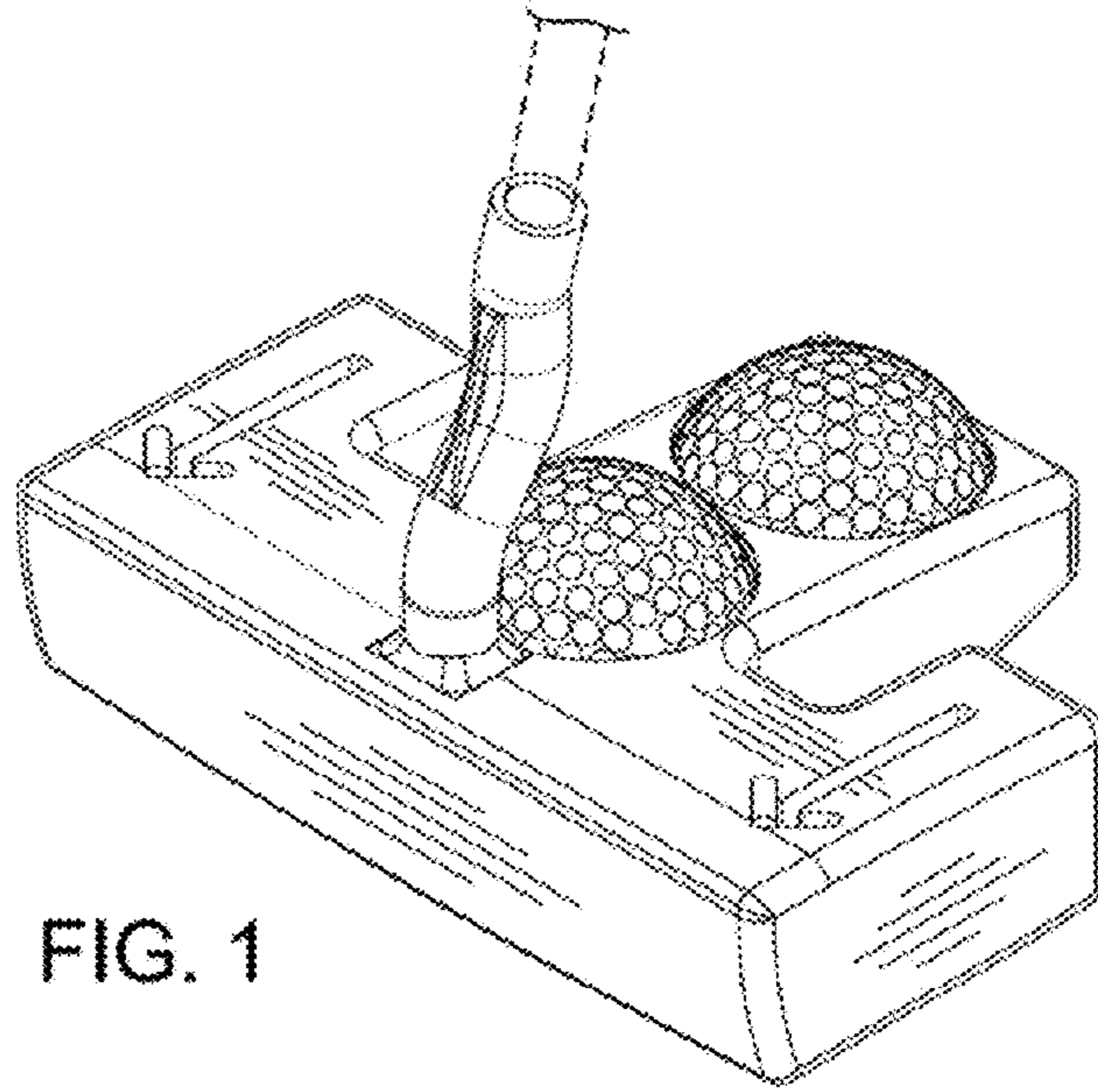

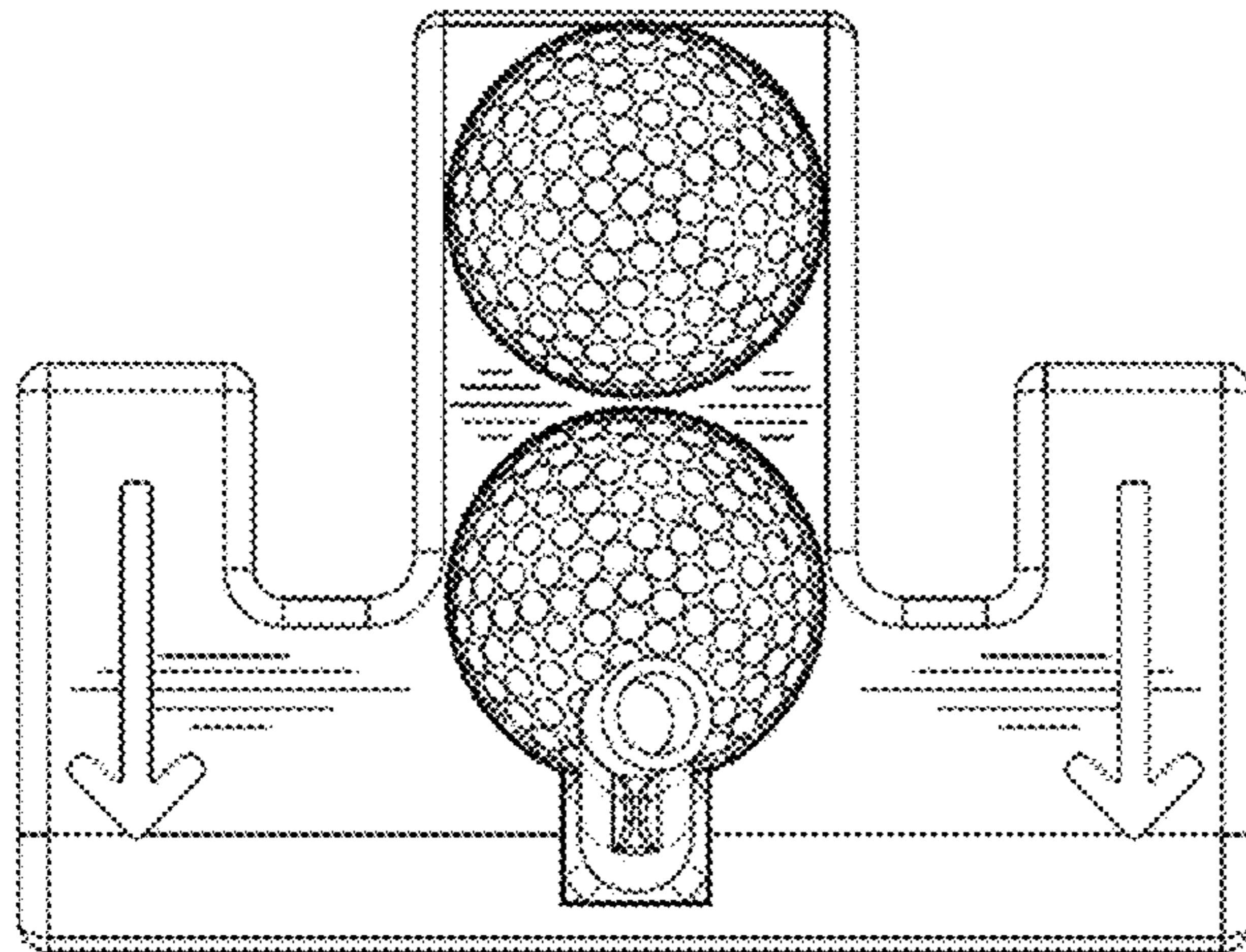

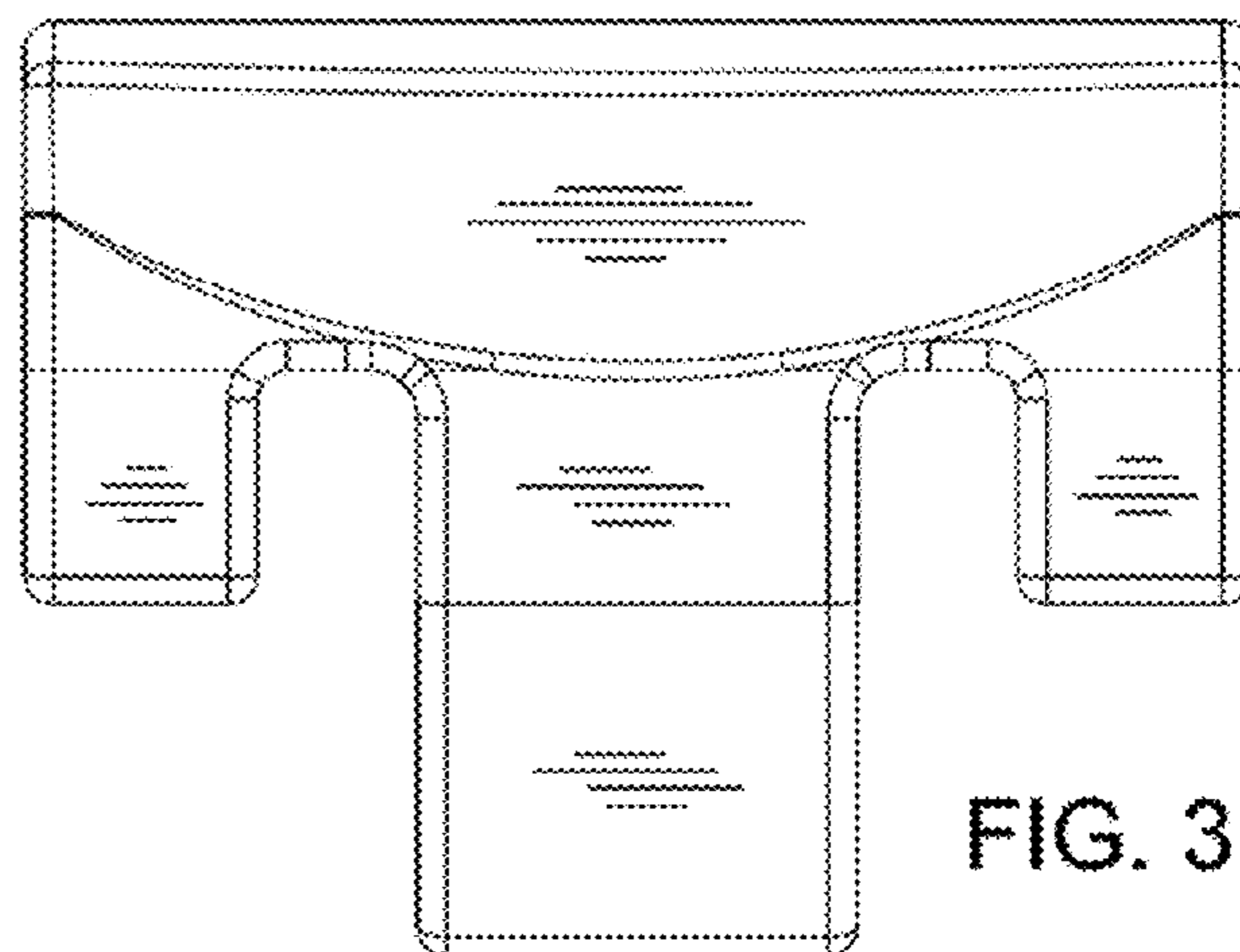

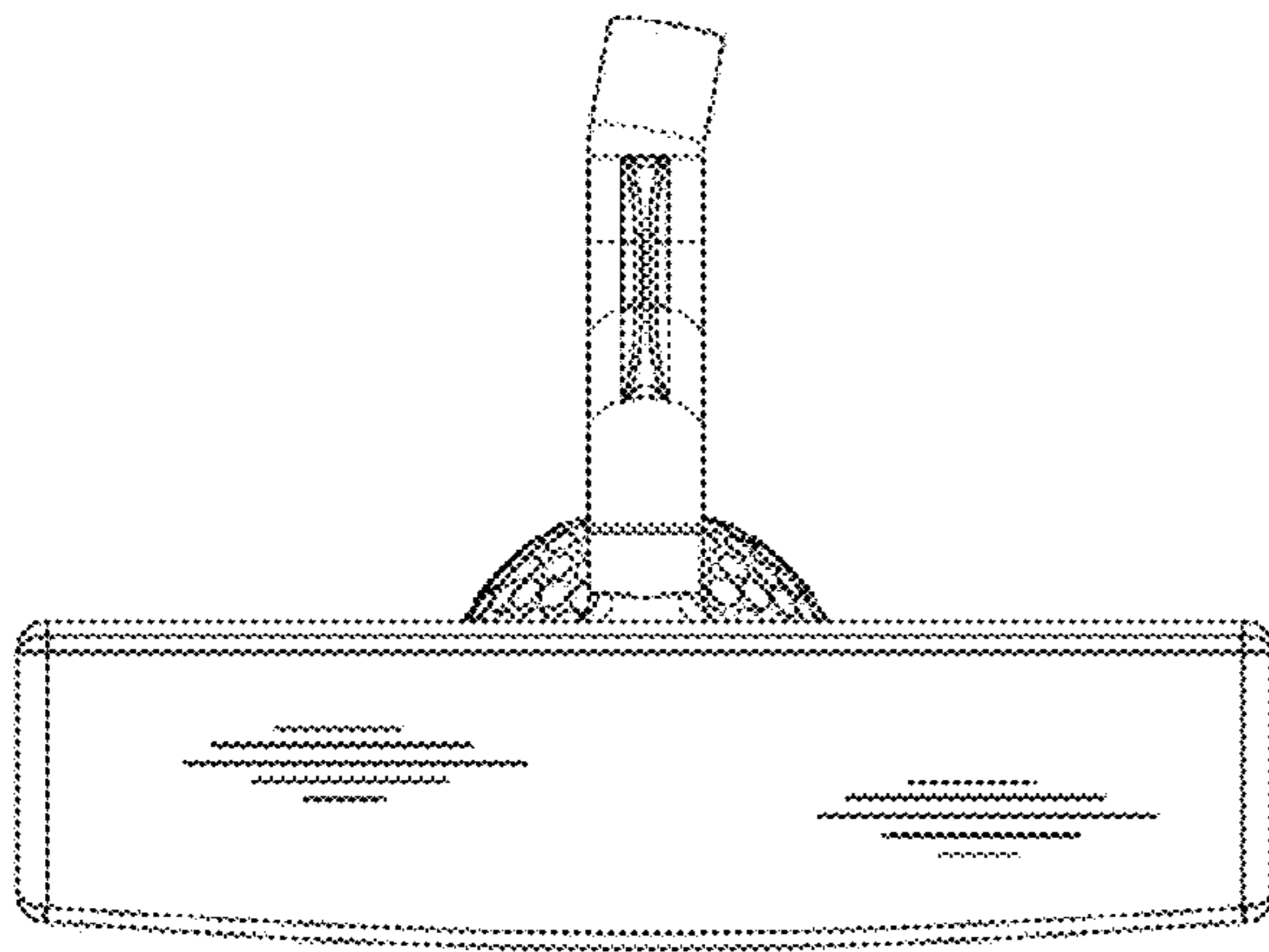

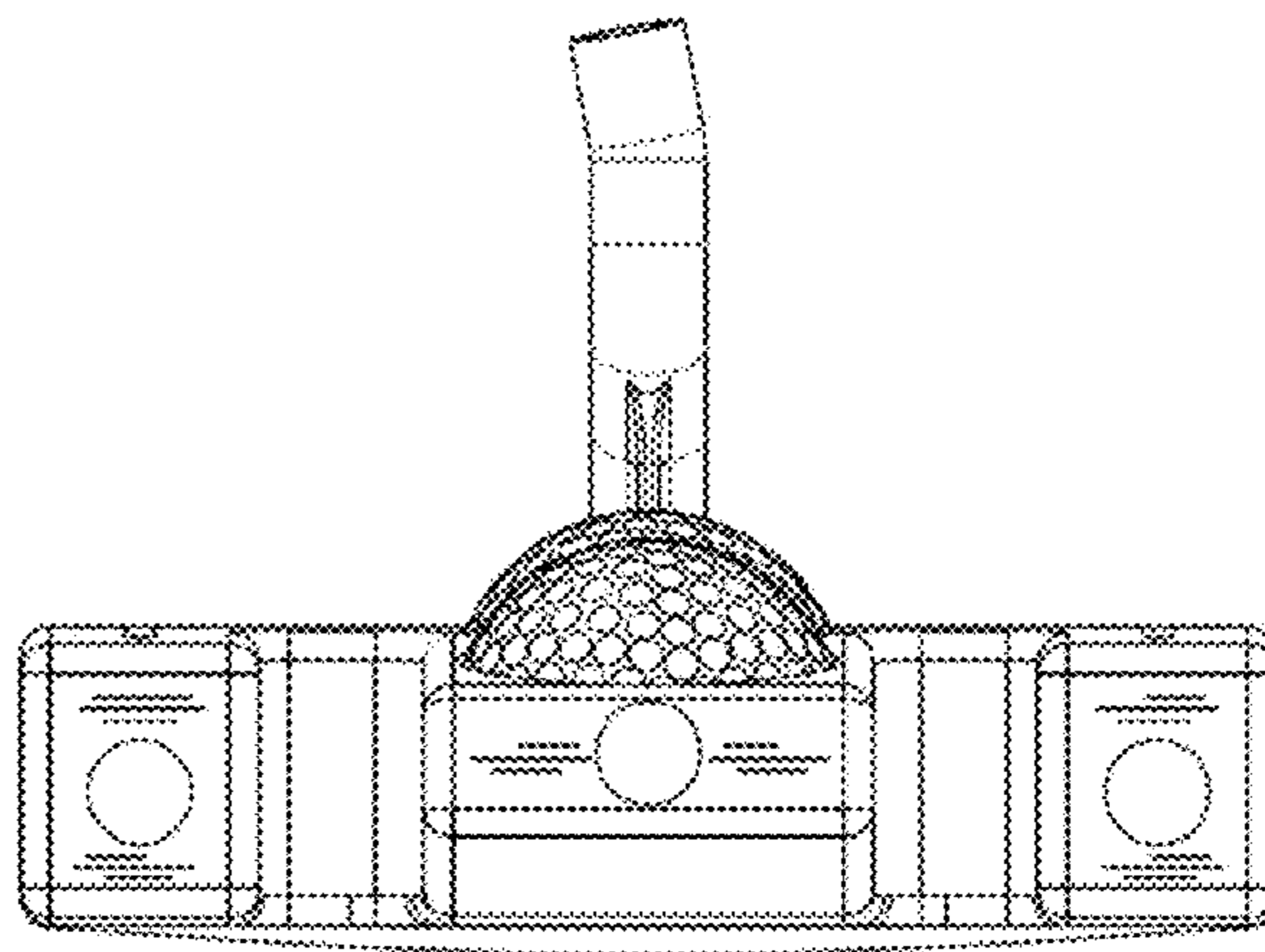

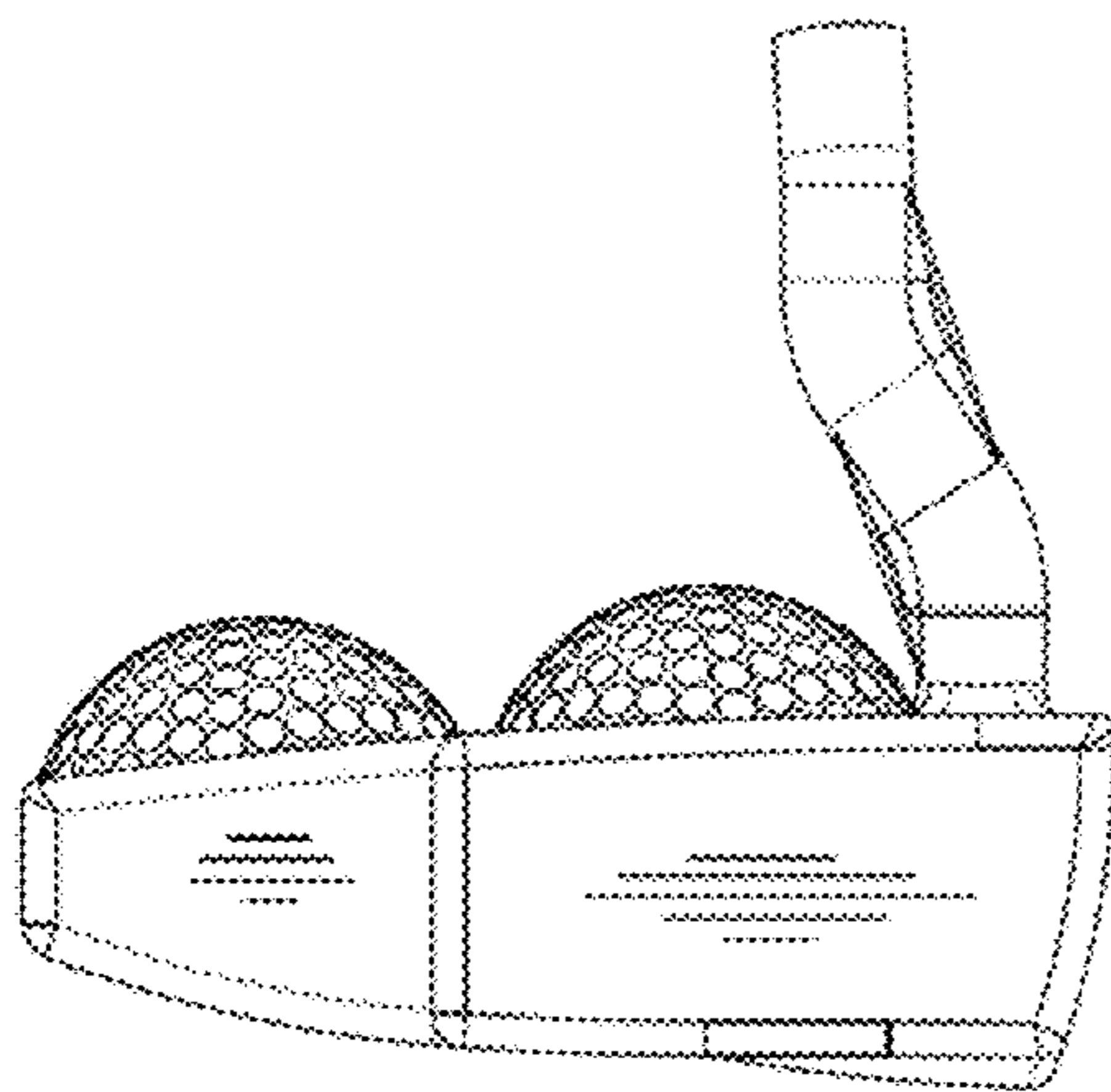
