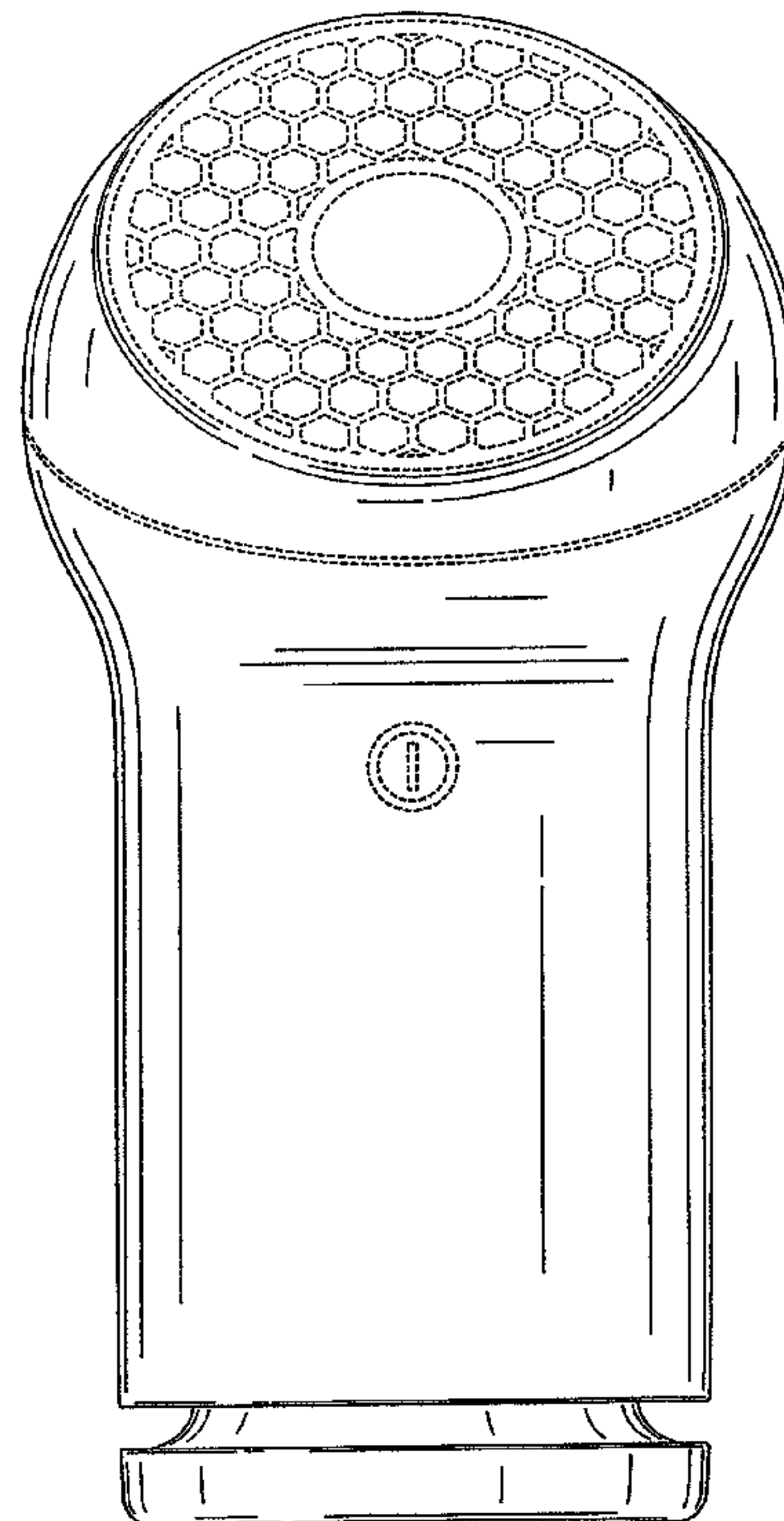
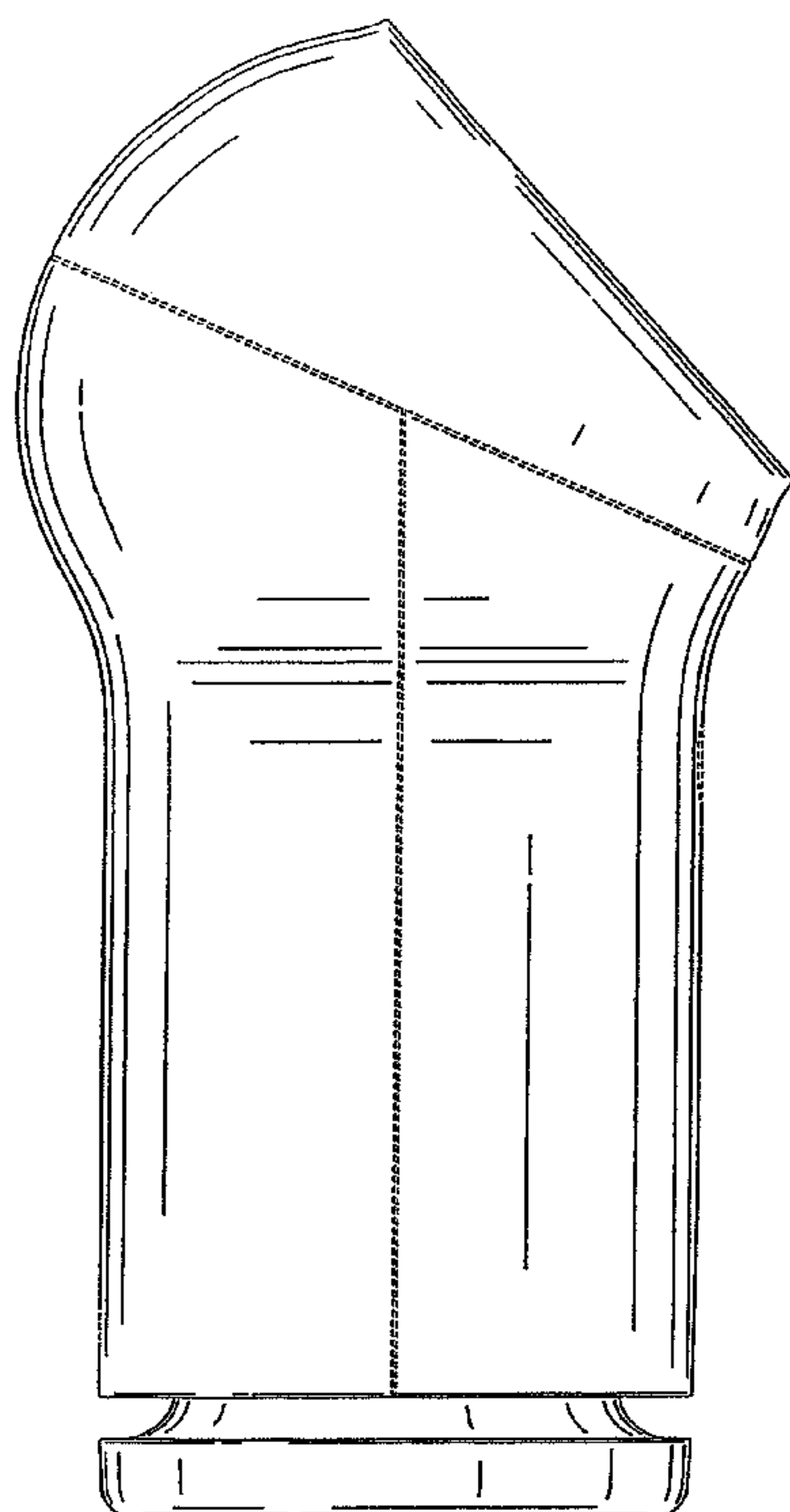
(57) **CLAIM**

We claim the ornamental design for an air moving apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the air moving apparatus according to the present invention;
 FIG. 2 is a right side view of the air moving apparatus of FIG. 1;
 FIG. 3 is a left side view of the air moving apparatus of FIG. 1;
 FIG. 4 is a front view of the air moving apparatus of FIG. 1;

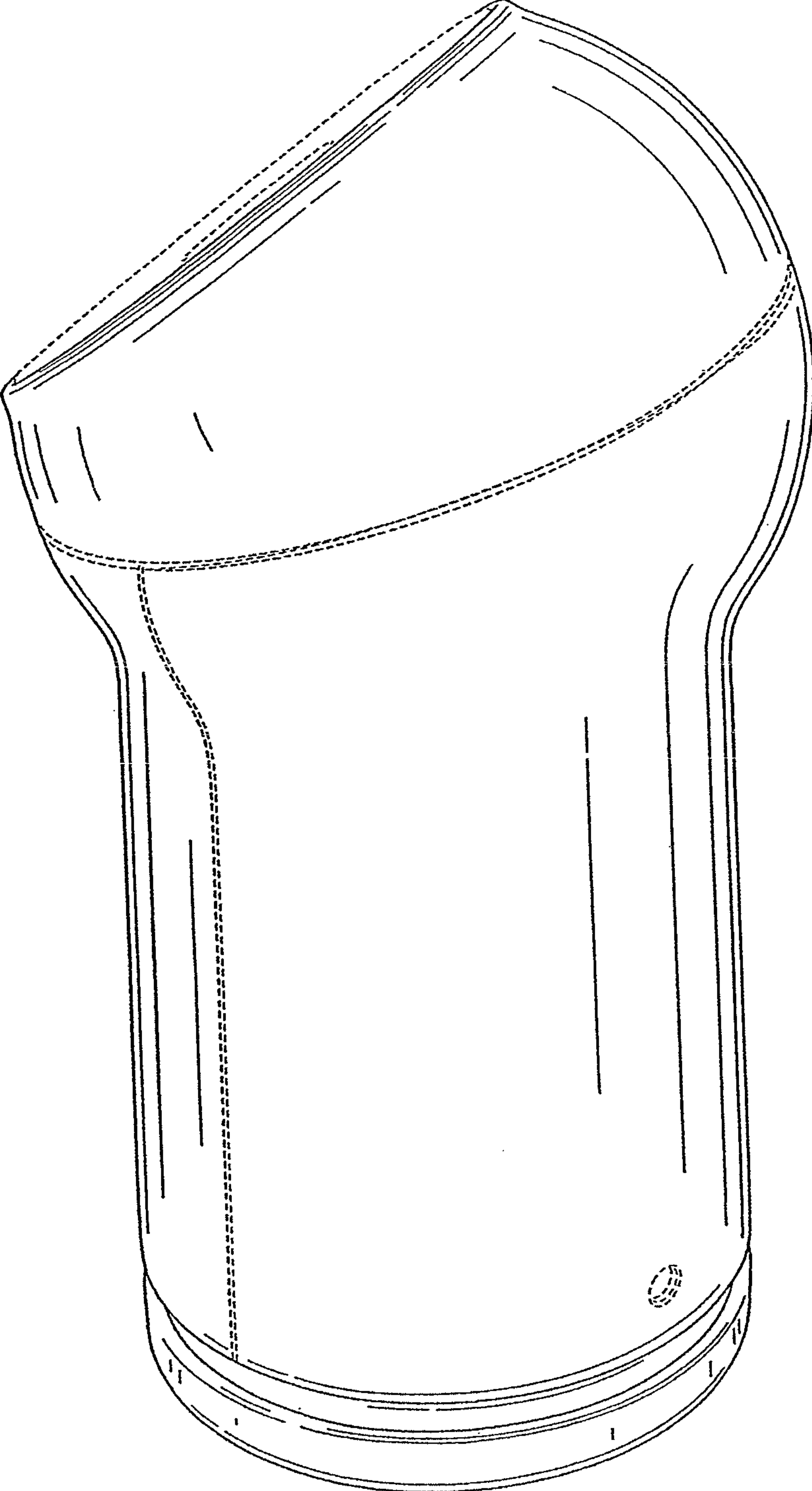

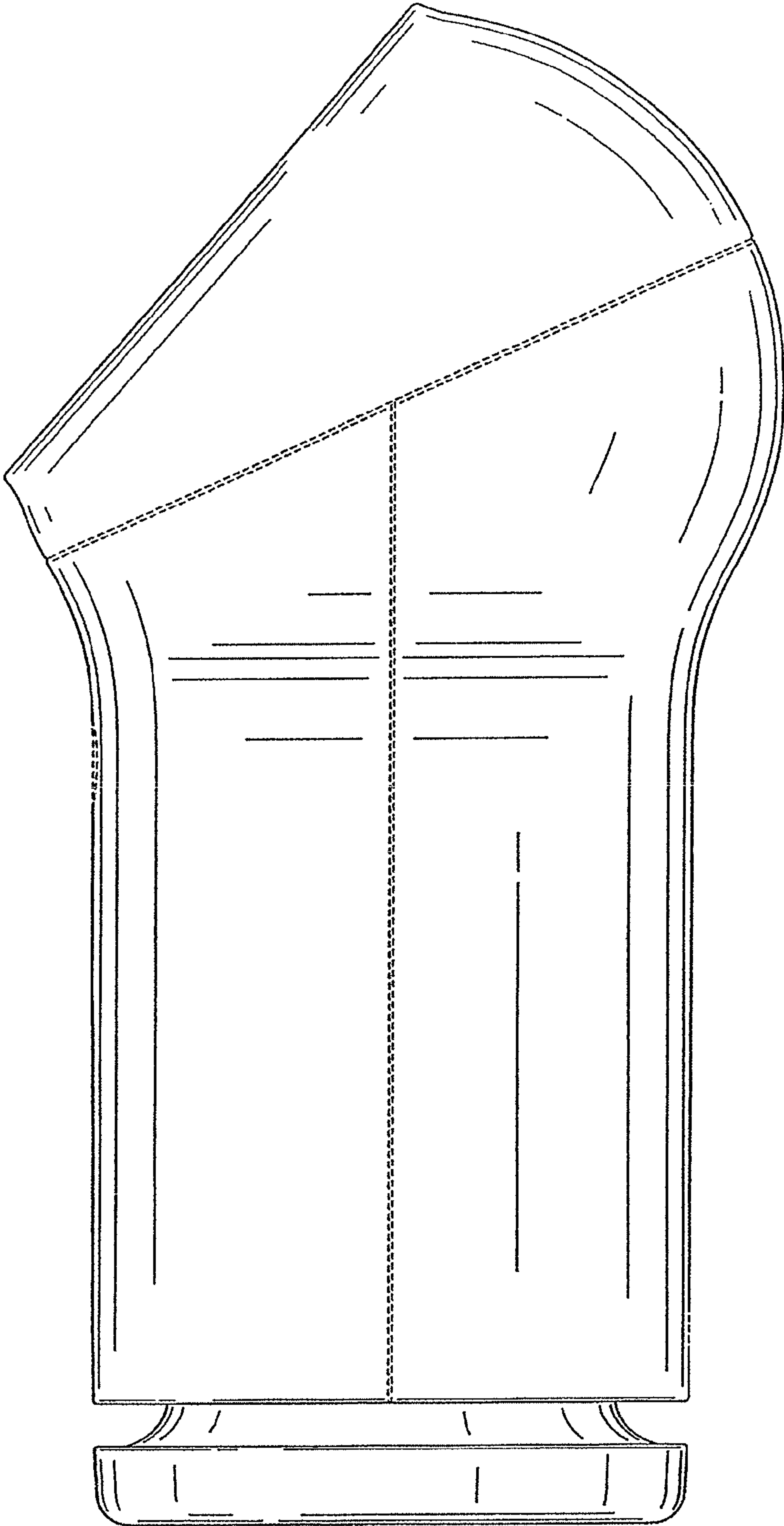

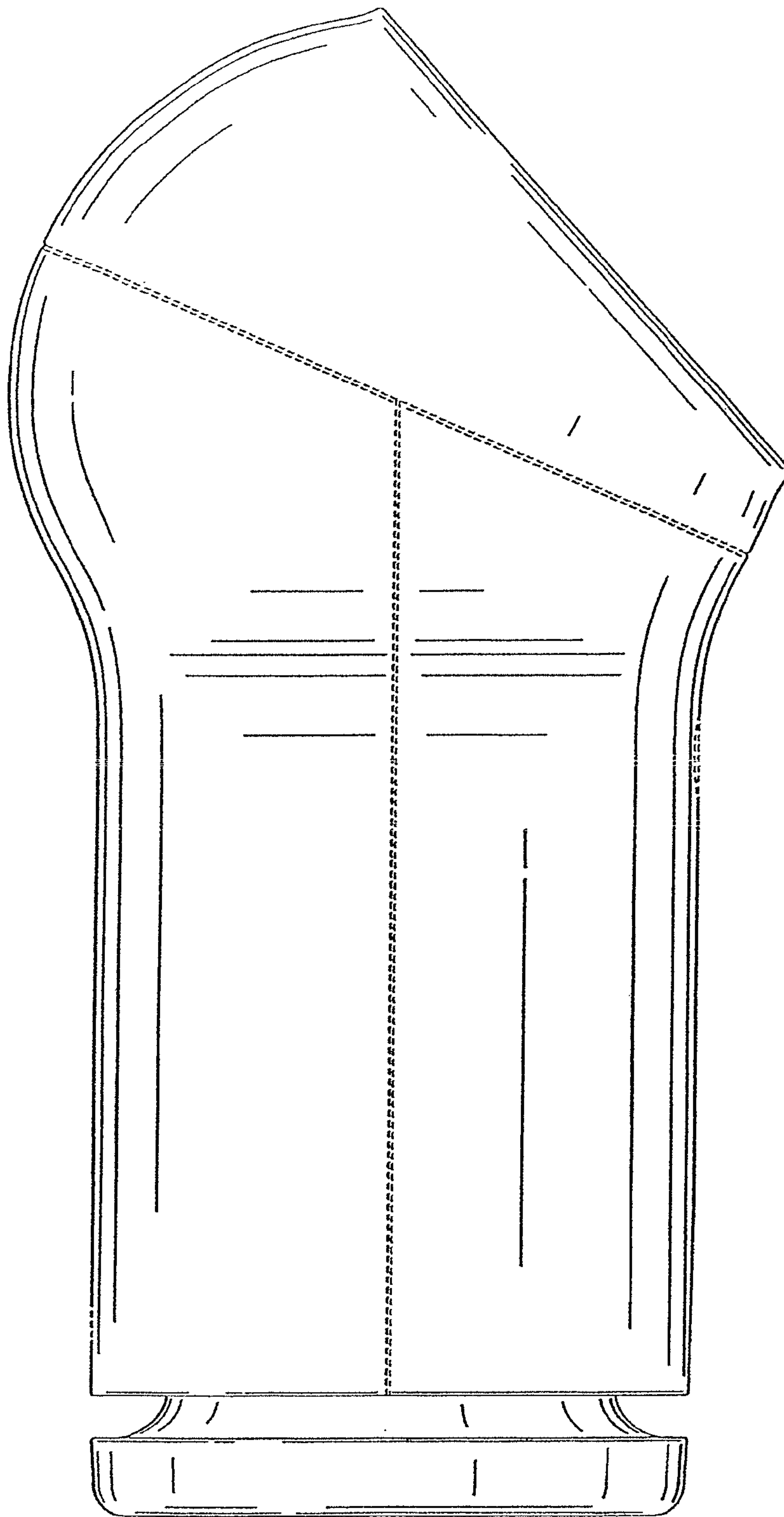

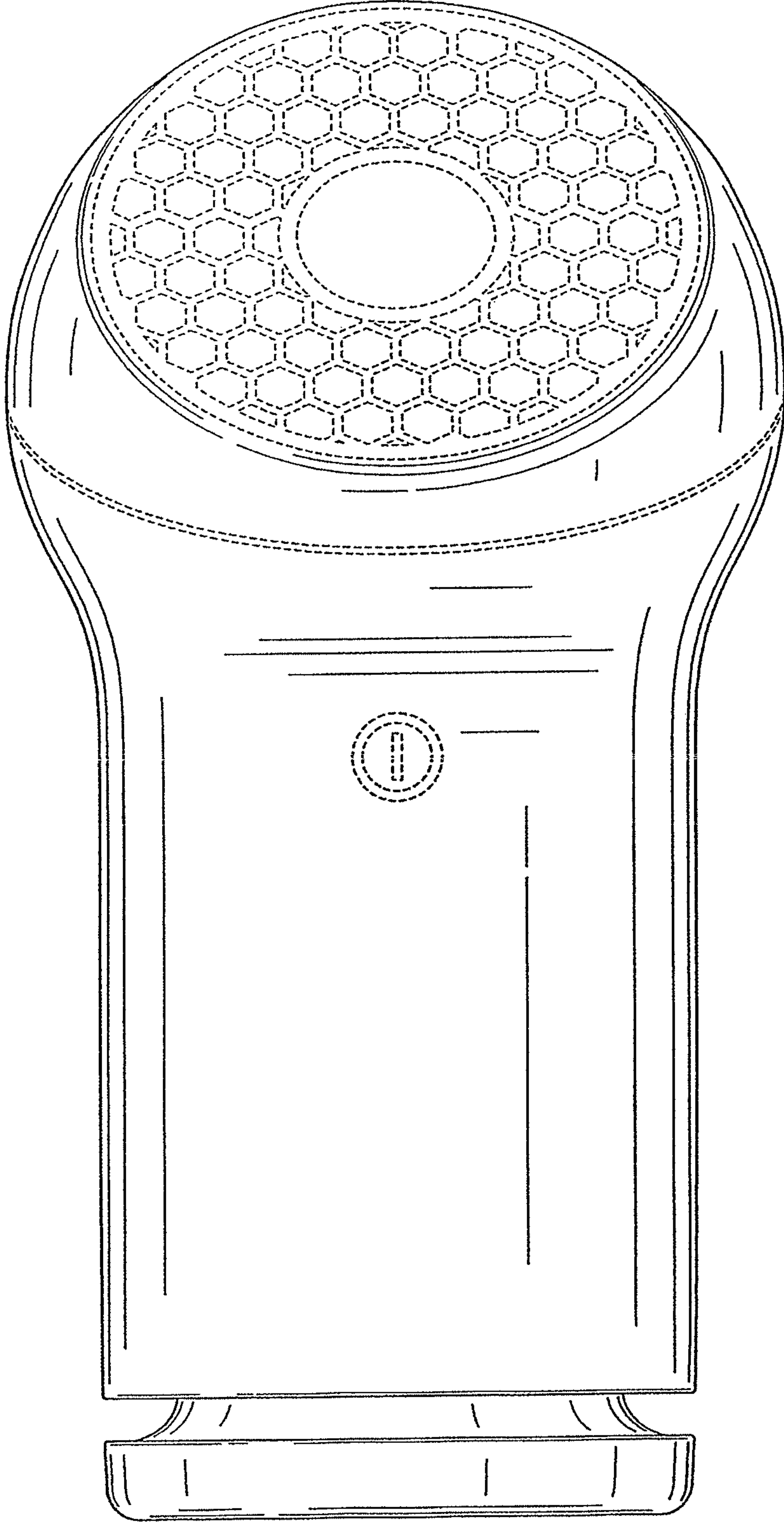

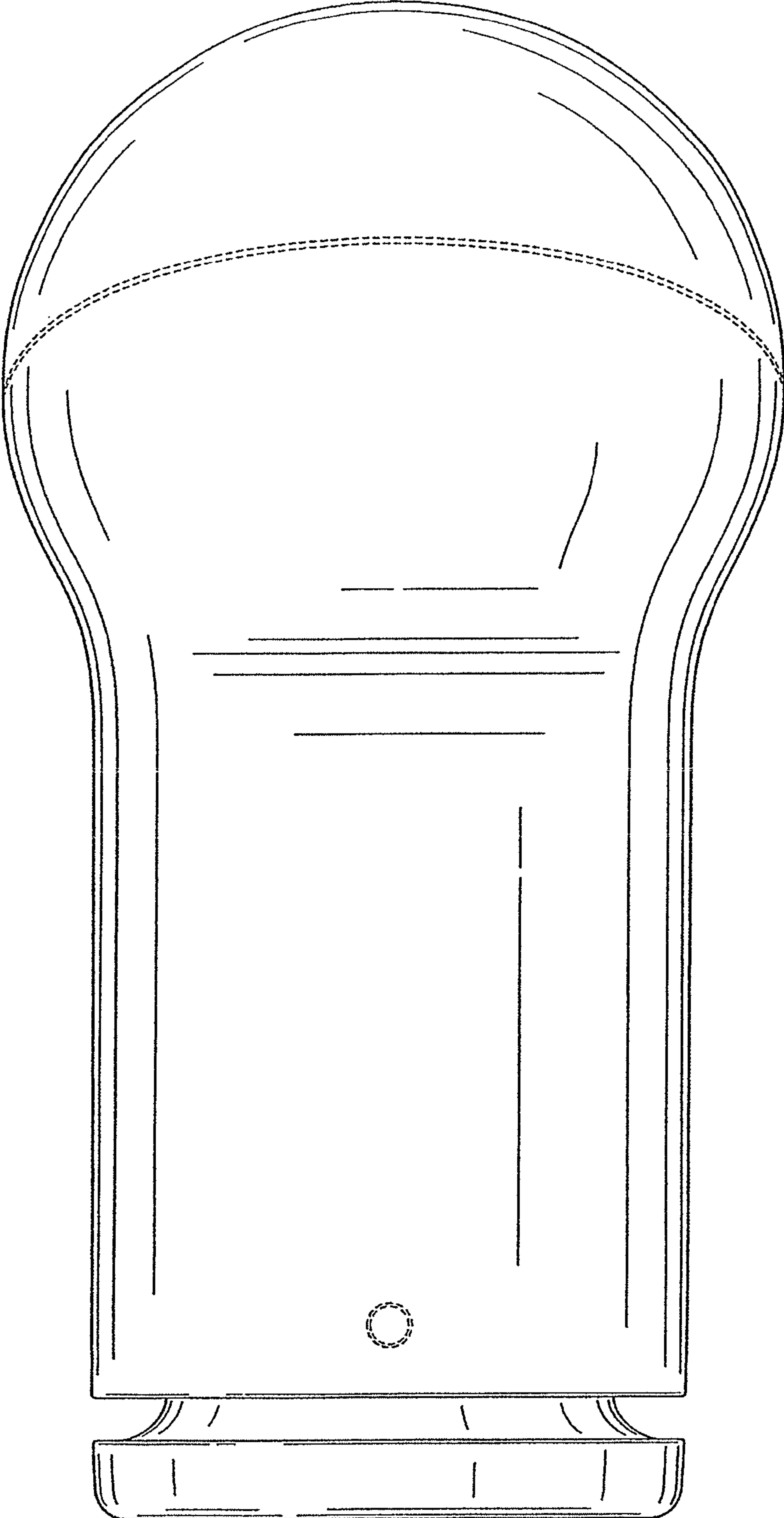

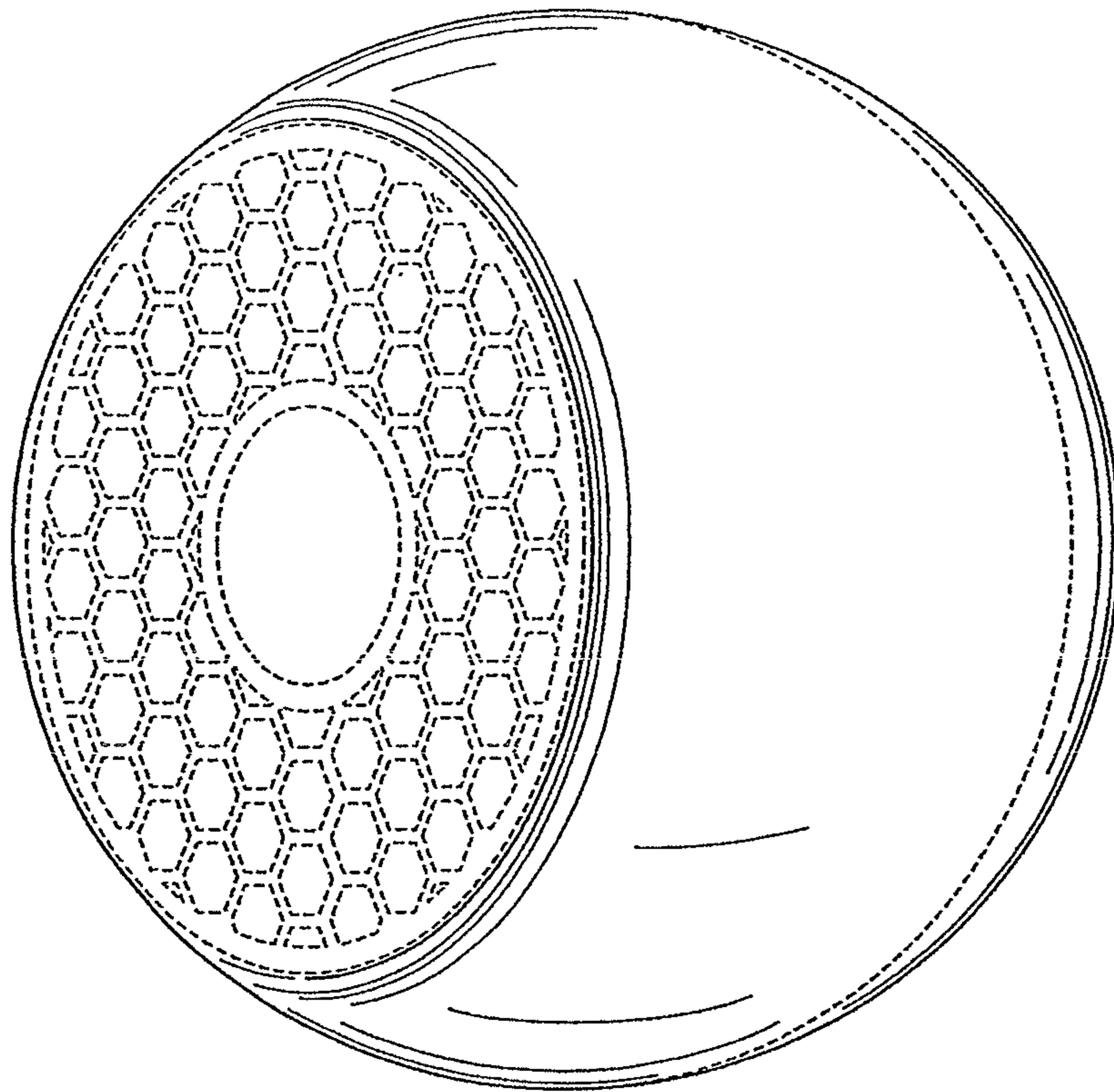

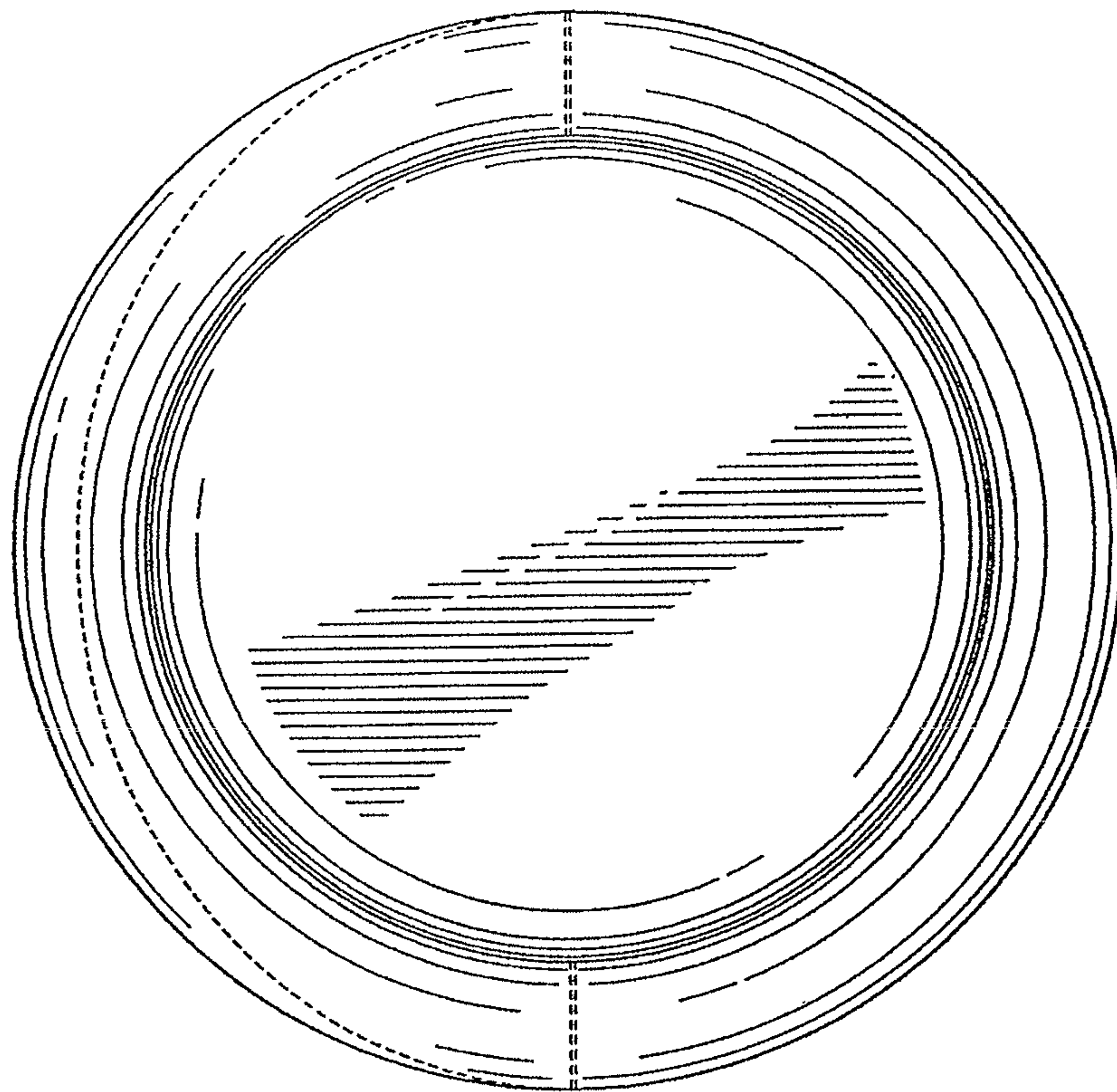
