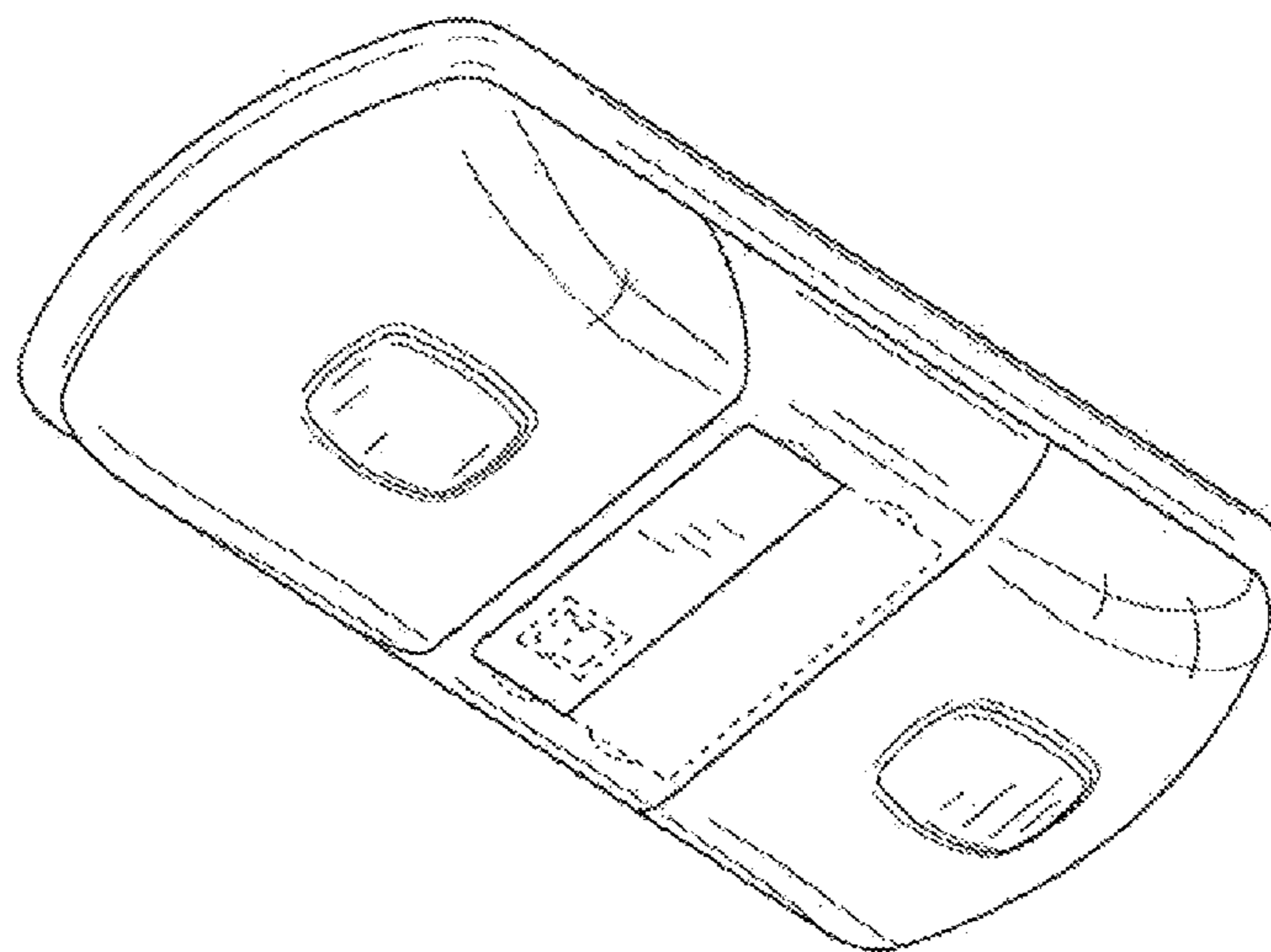
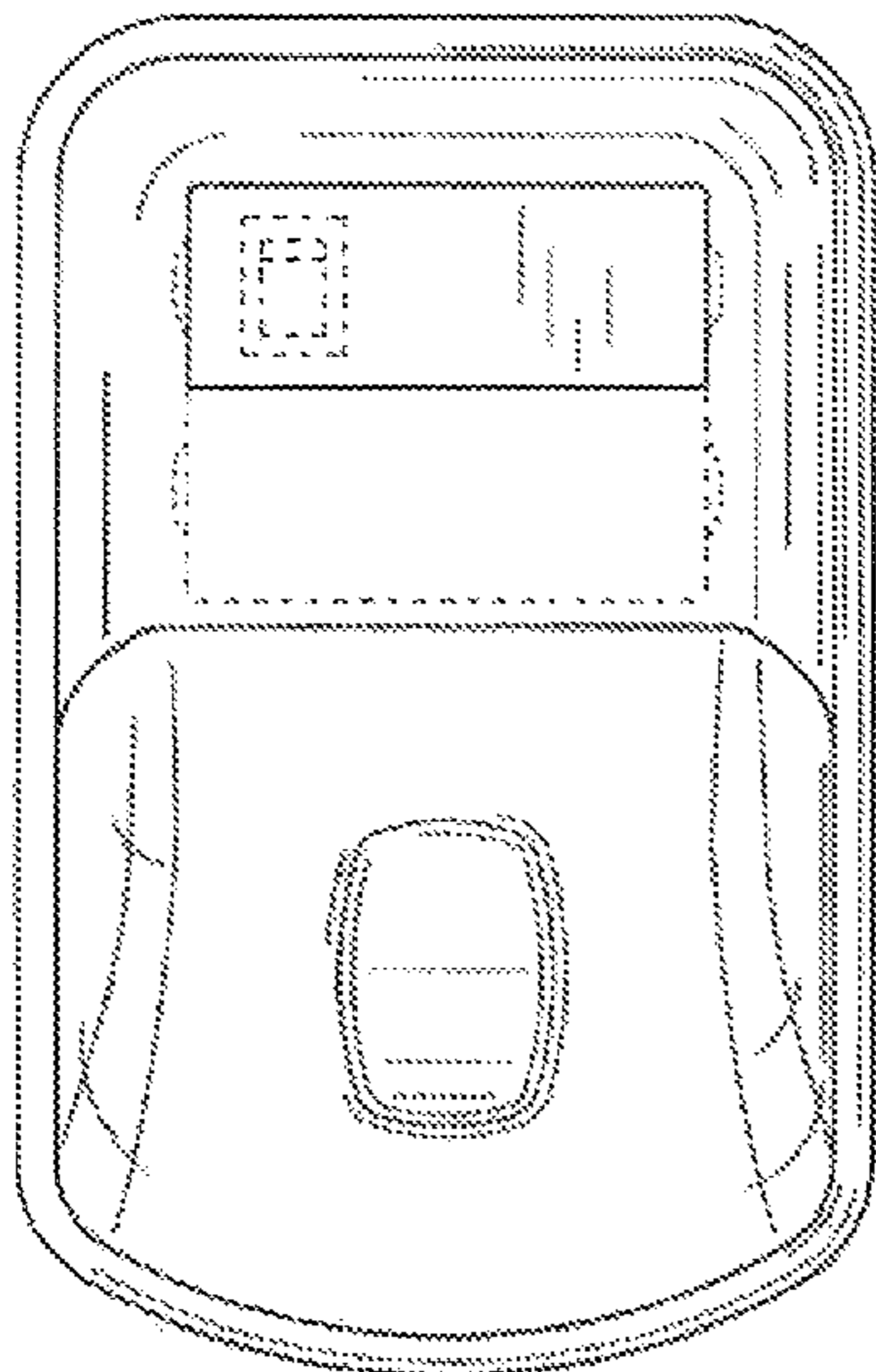
(57) **CLAIM**

The ornamental design for light fixture using modular accessories, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a light fixture using modular accessories having a single light according to a first embodiment of the invention;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a left side elevation view thereof;
 FIG. 7 is a right side elevation view thereof;
 FIG. 8 is a front perspective view of a light fixture using modular accessories having two lights according to a second embodiment of the invention;
 FIG. 9 is a front elevation view thereof;
 FIG. 10 is a rear elevation view thereof;
 FIG. 11 is top plan view thereof;
 FIG. 12 is a bottom plan view thereof;
 FIG. 13 is a left side elevation view thereof; and,
 FIG. 14 is a right side elevation view thereof.

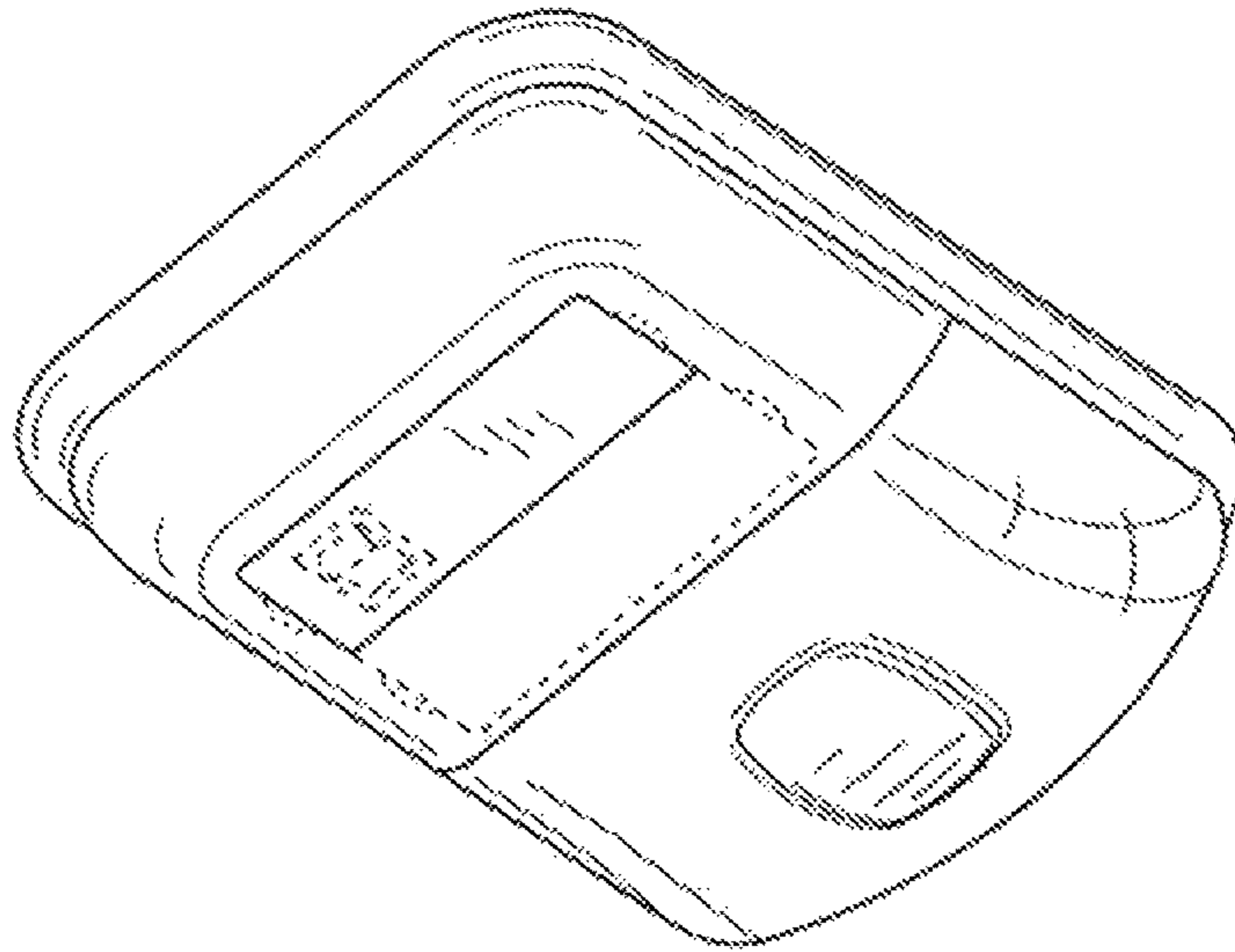

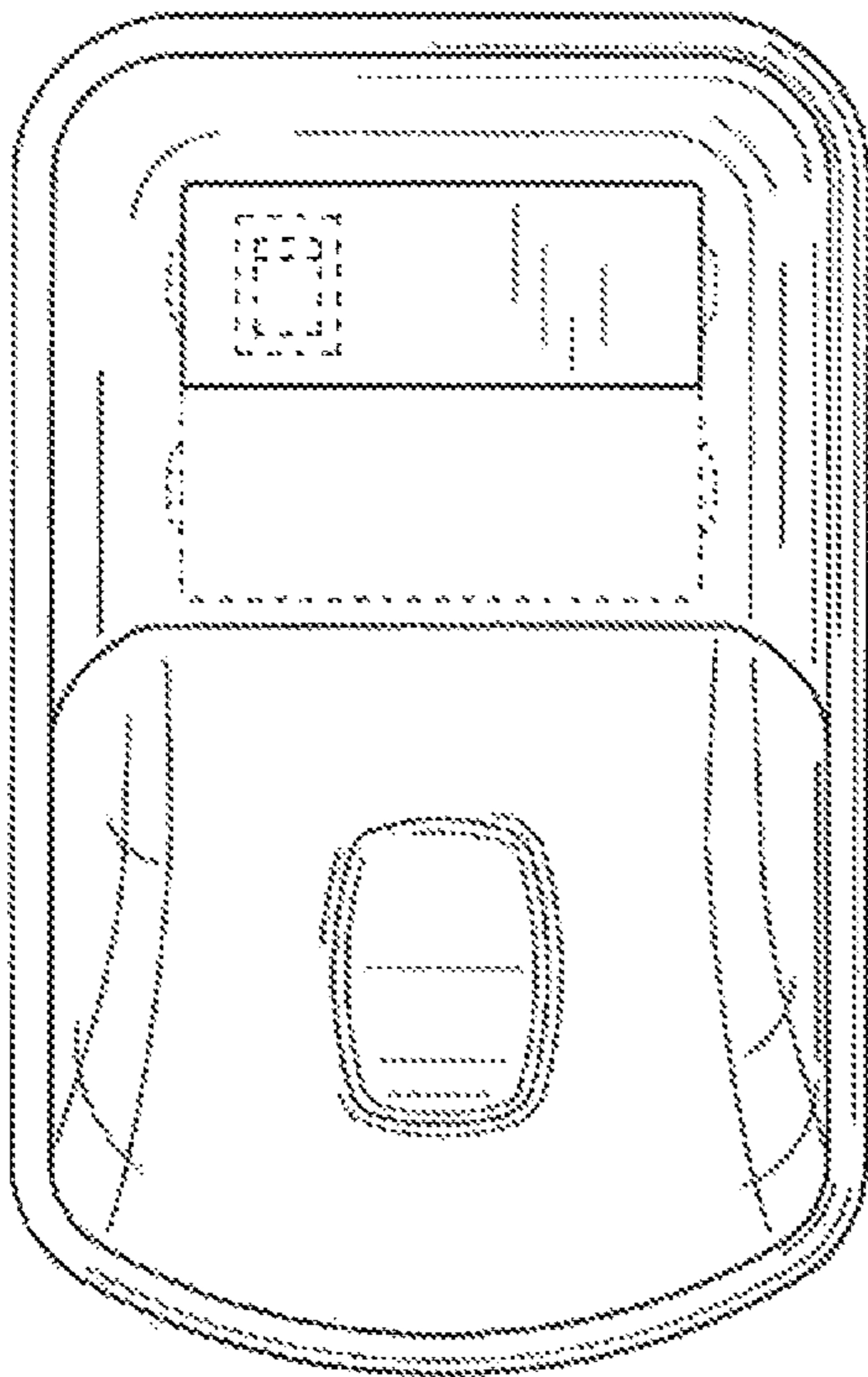

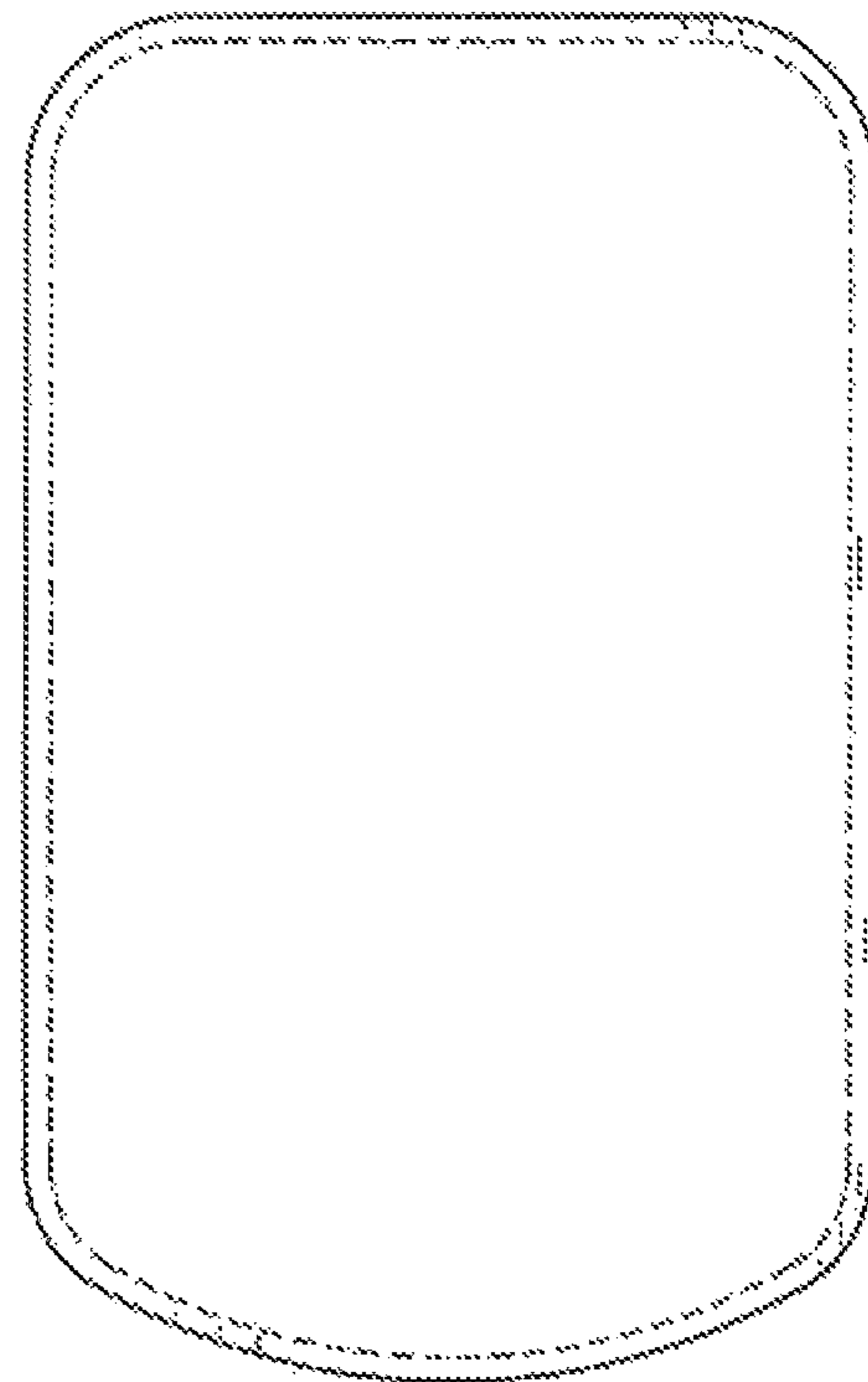

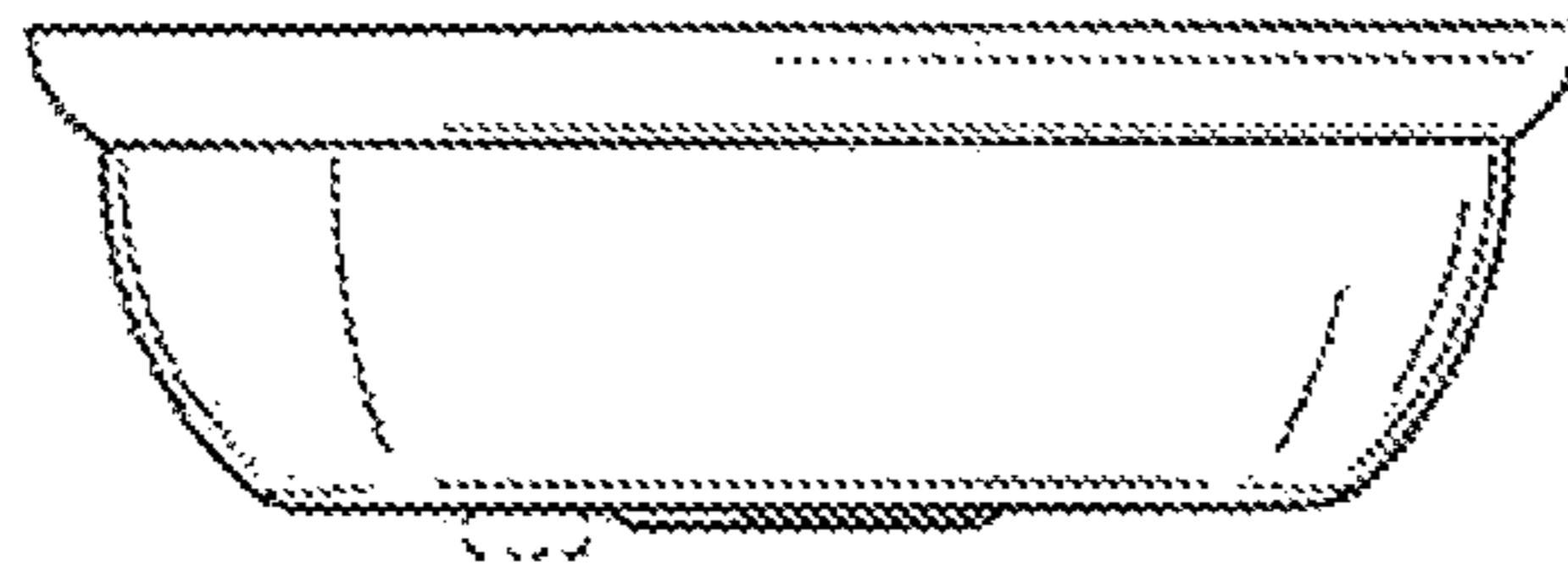

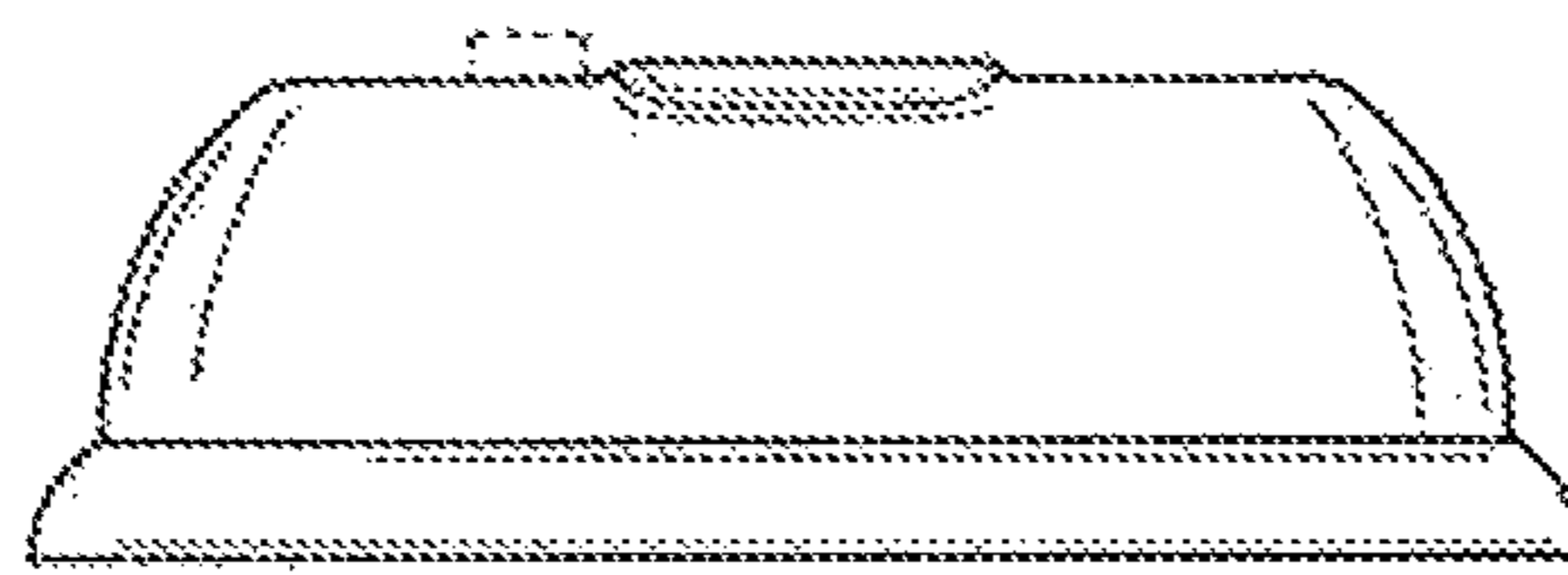

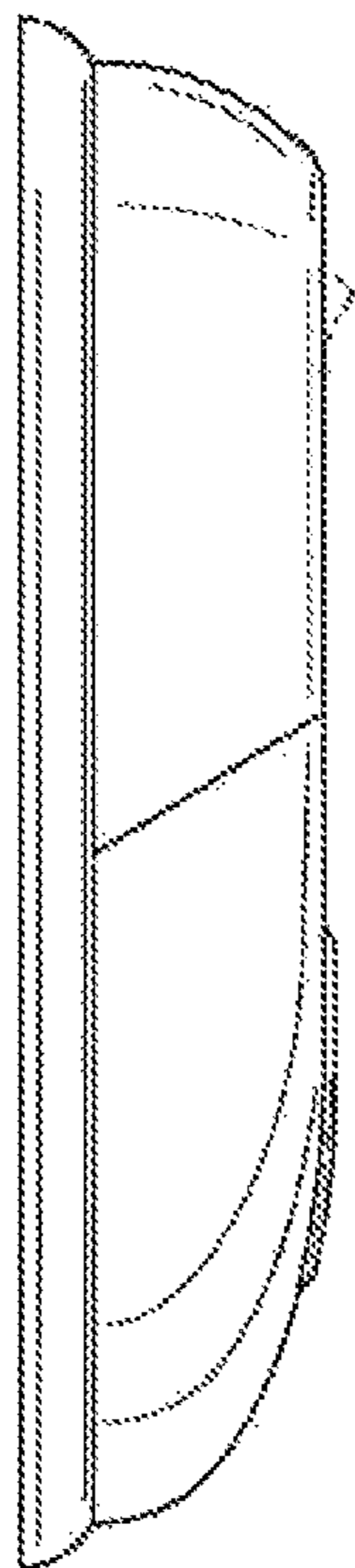

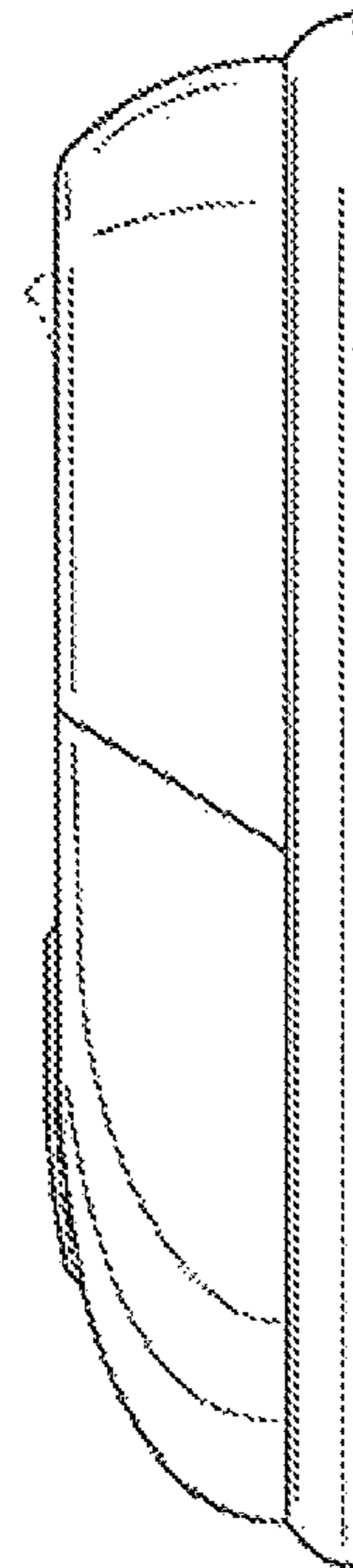

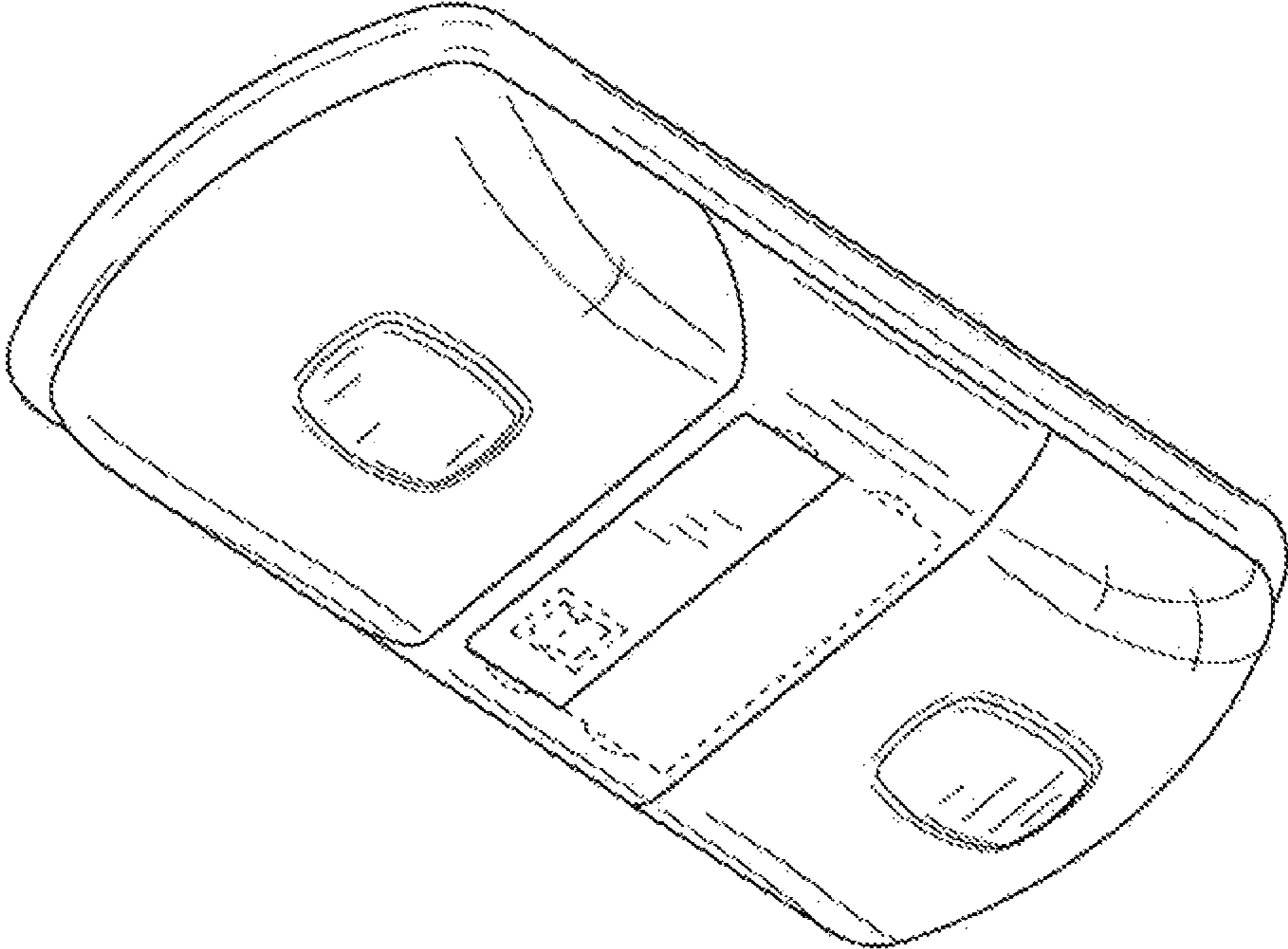

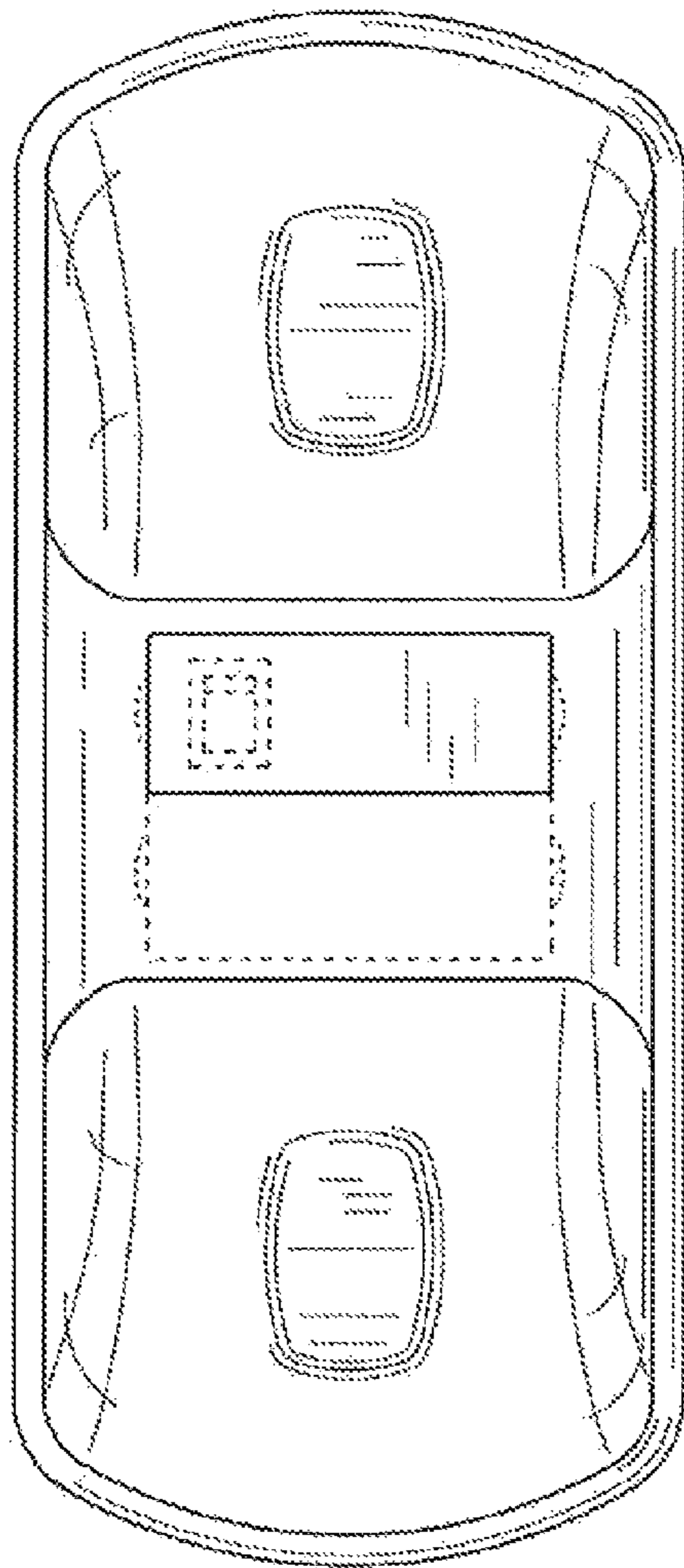

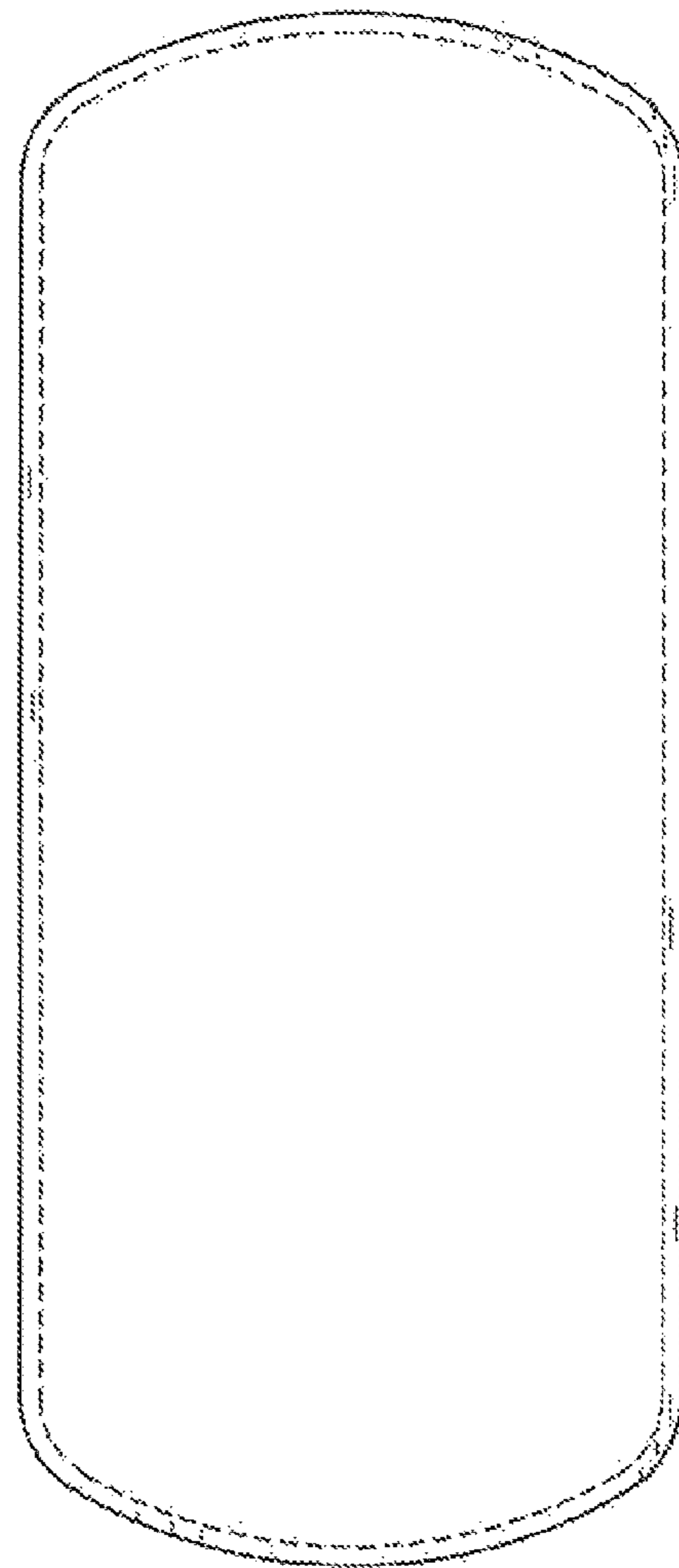

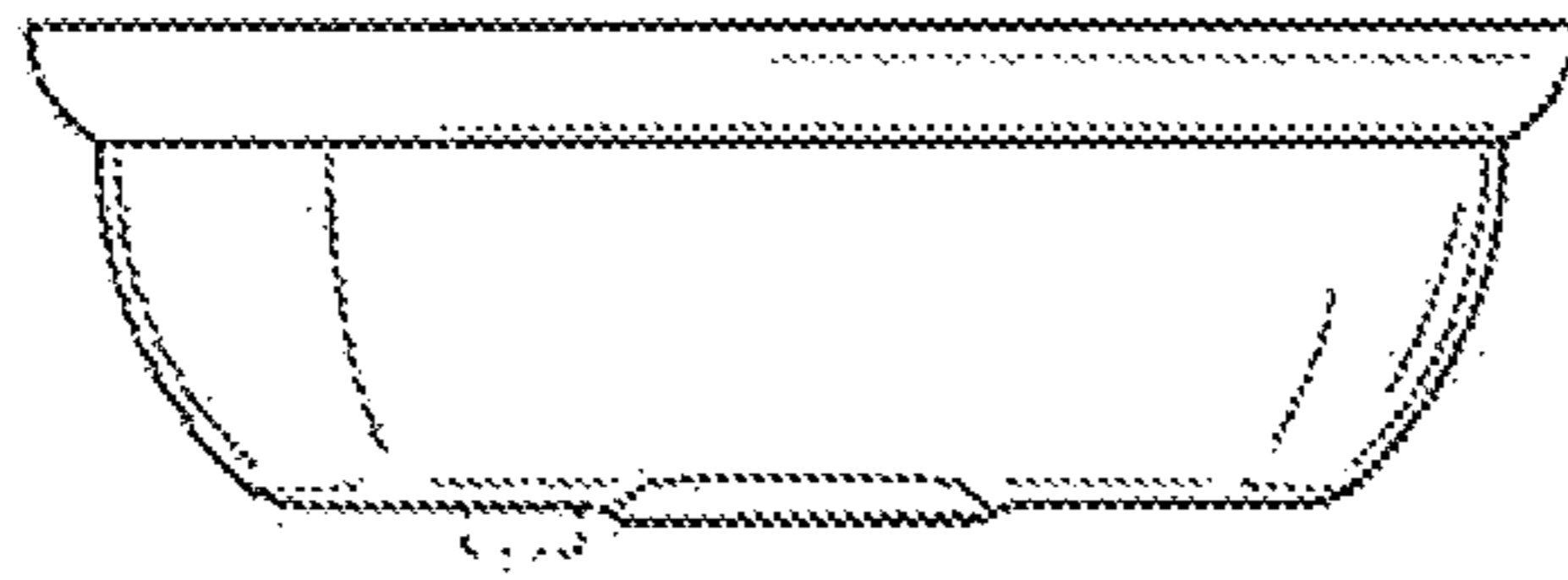

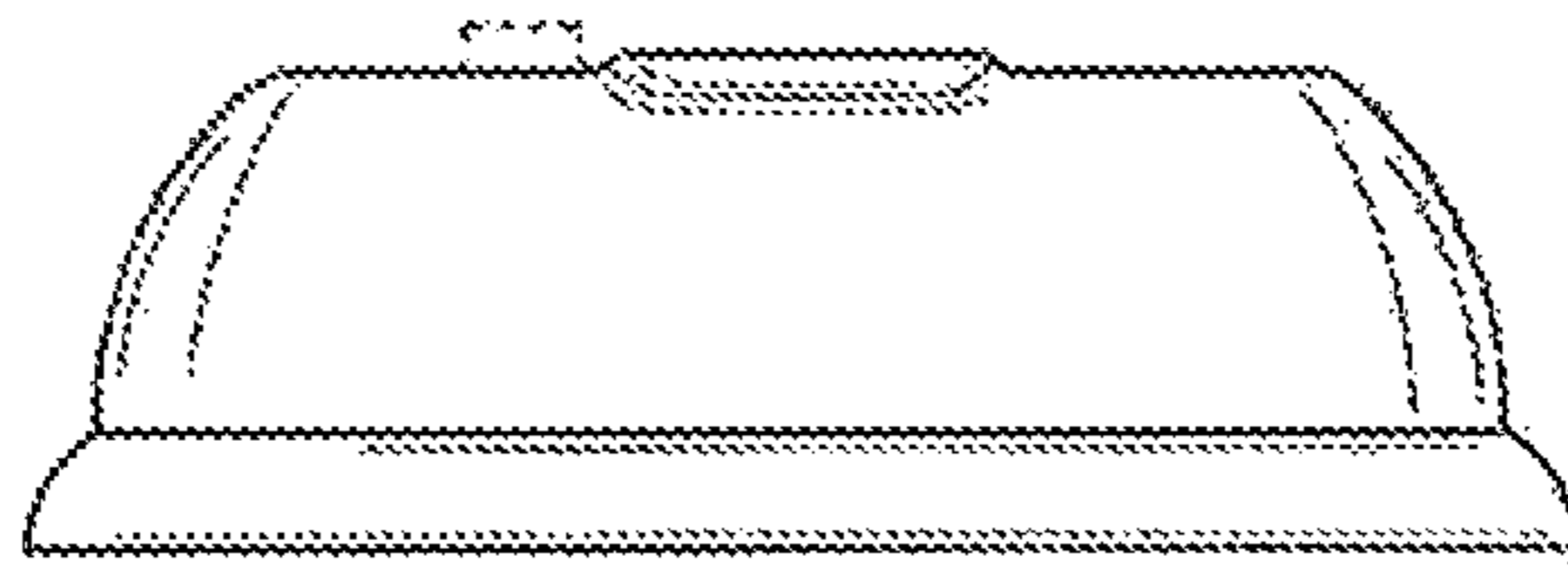

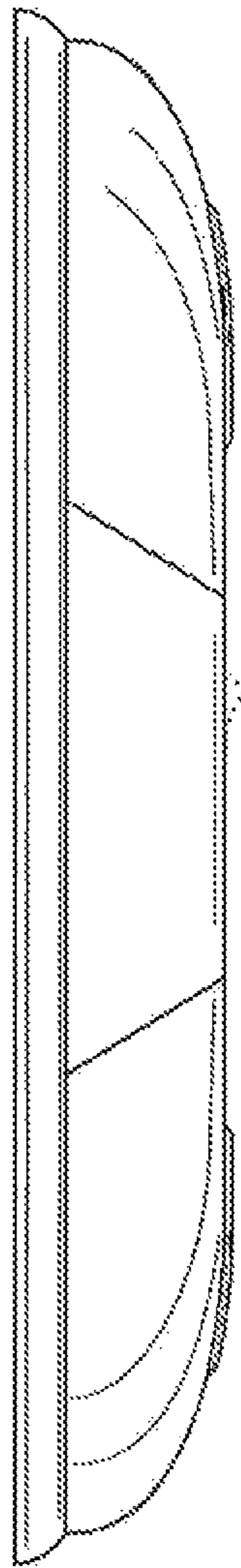

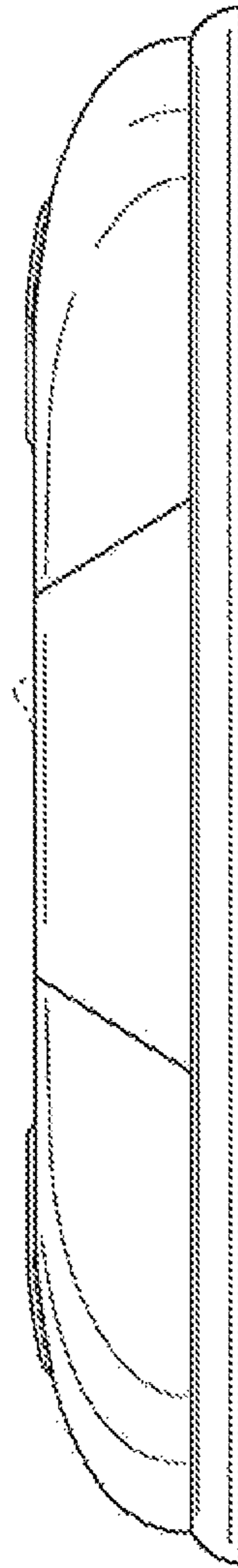
