The ornamental design for a shopping cart handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side view of the shopping cart handle, showing our new design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a perspective view thereof;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a front view thereof.

The broken line in FIGS. 2 and 4 is included for the purpose of illustrating portions of the handle and forms no part of the claimed design.

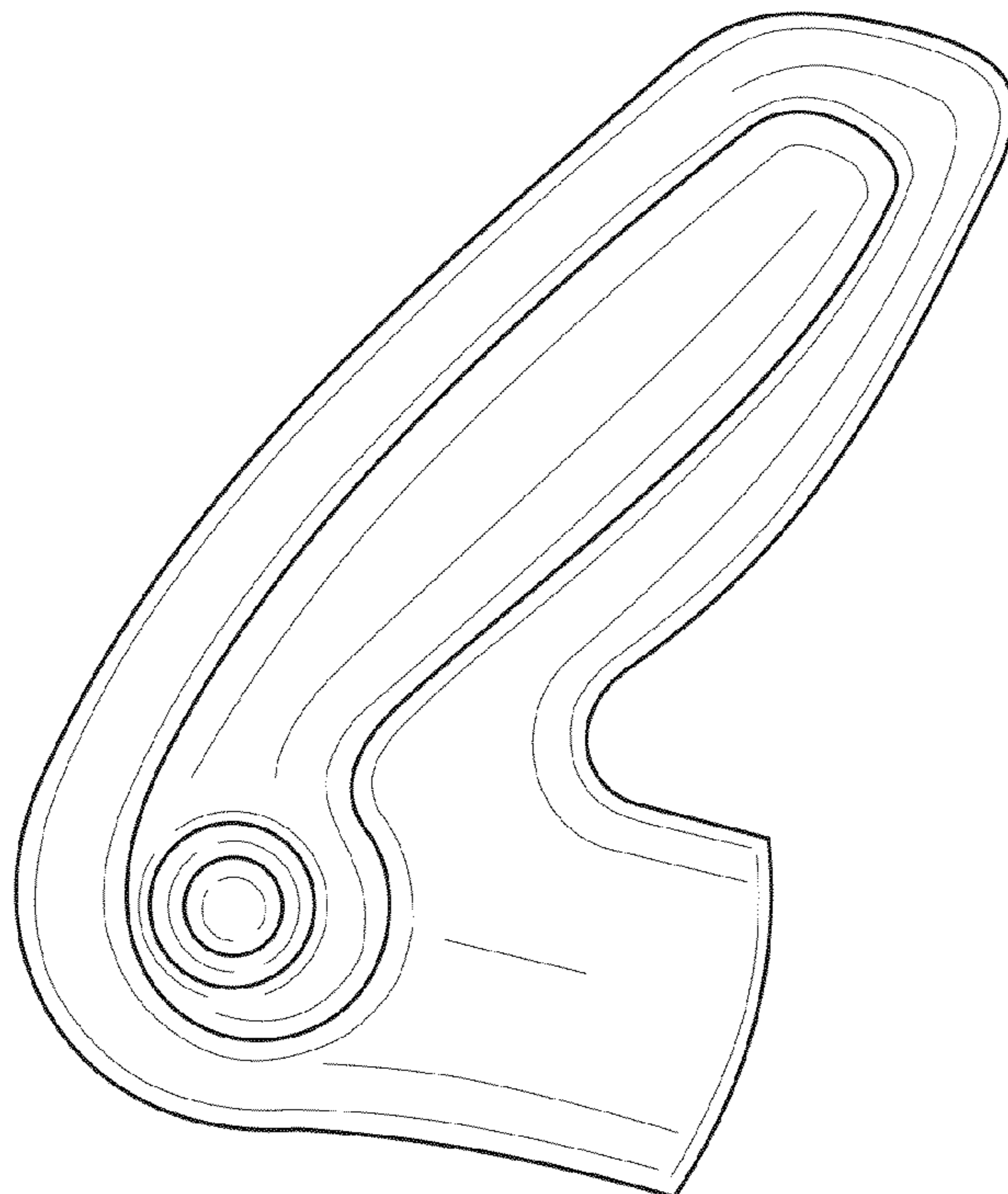

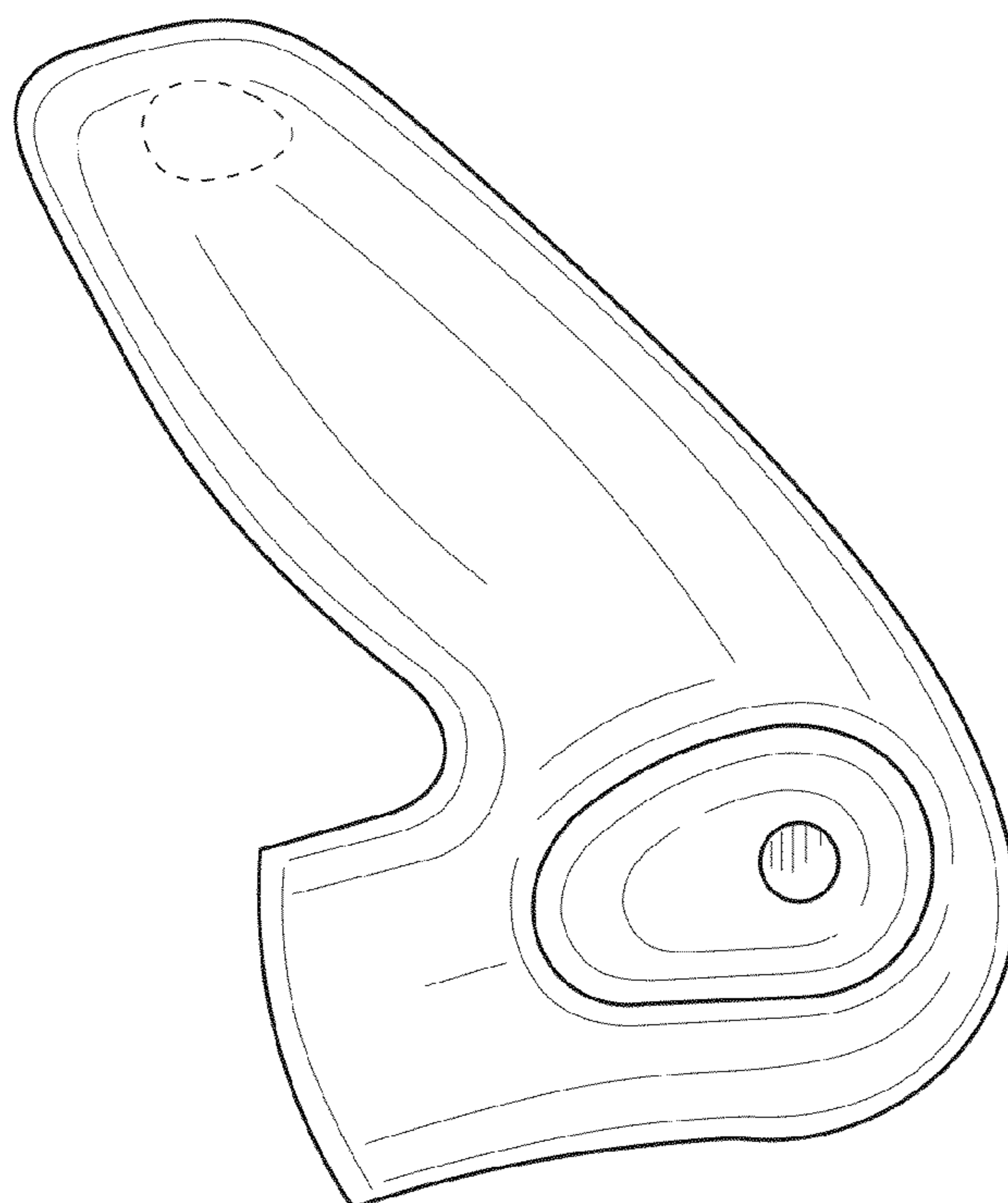
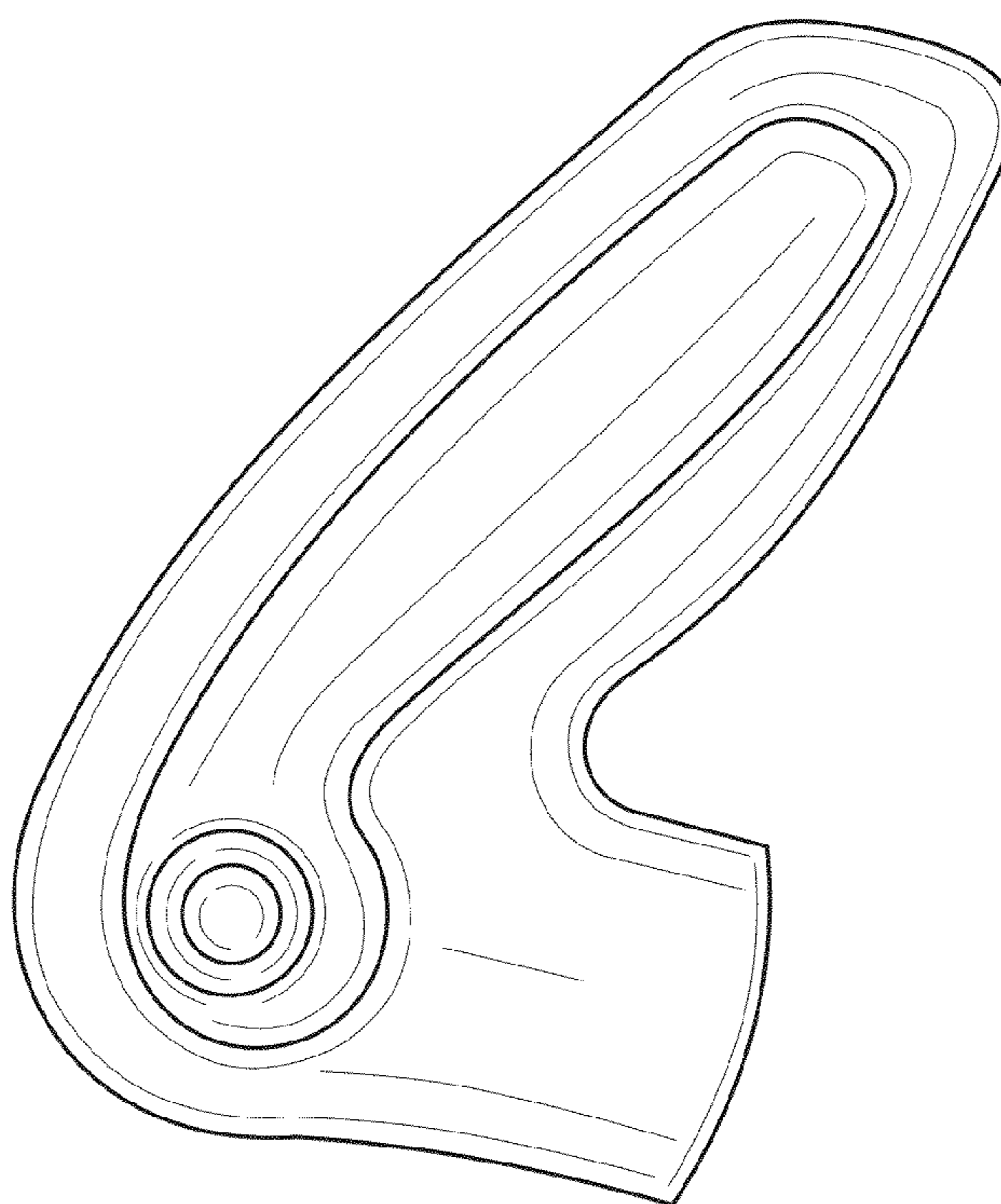

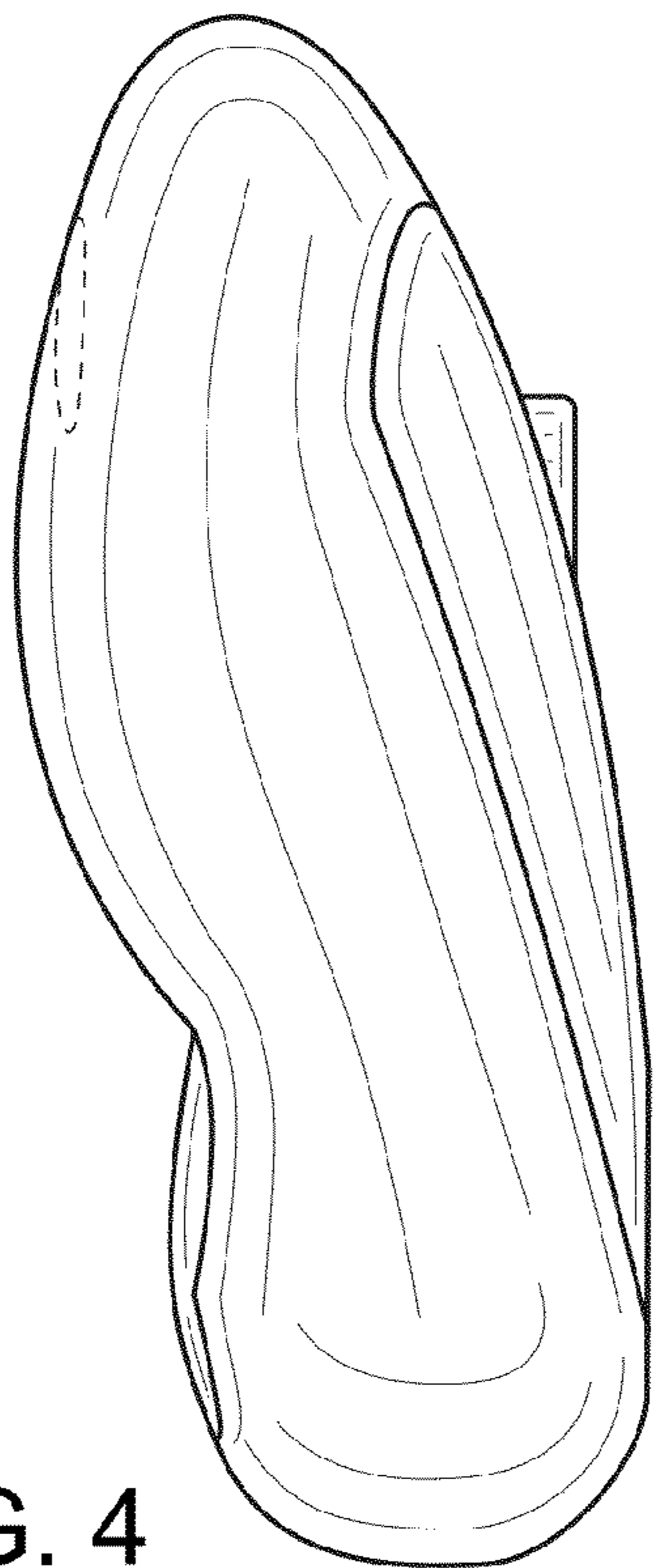

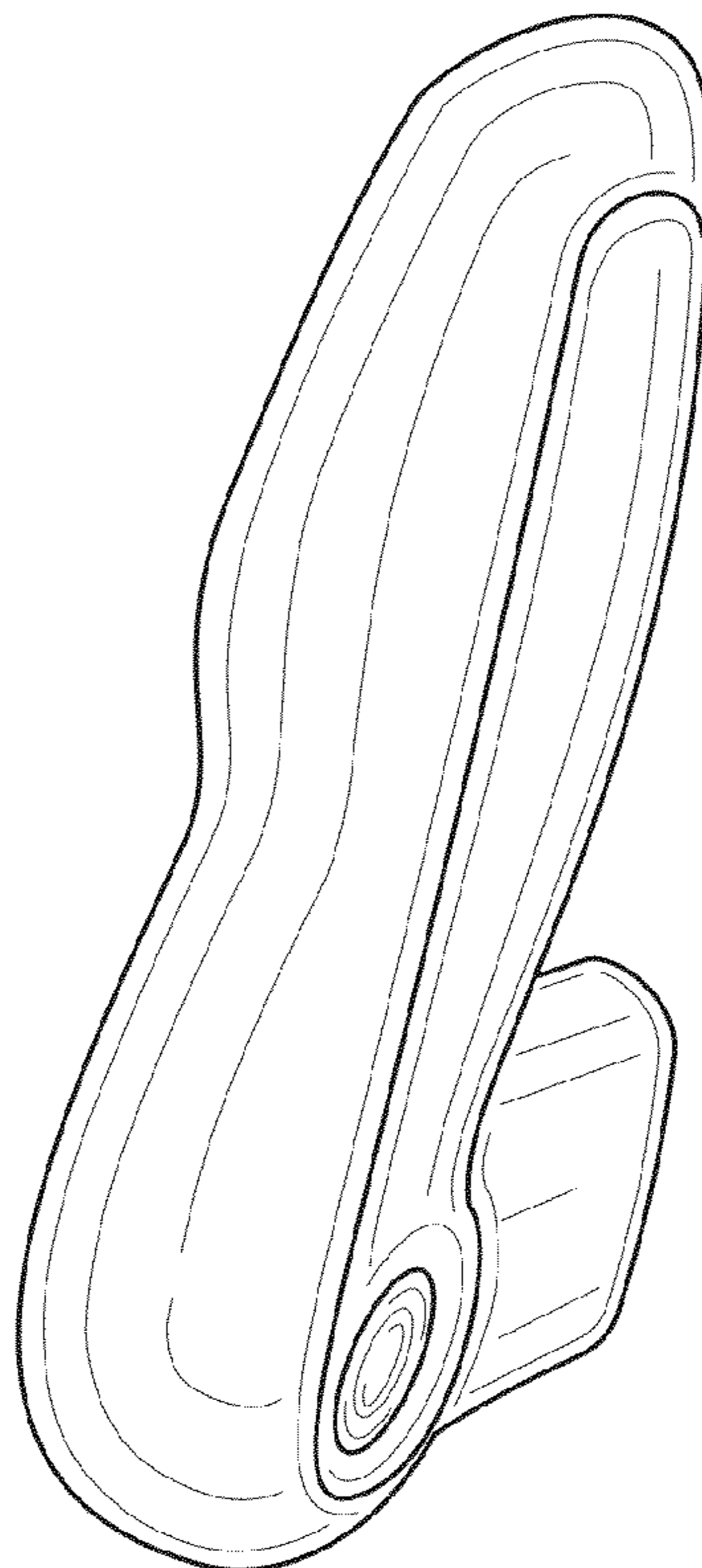
