(57) **CLAIM**

The ornamental design for a square urn, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the preferred embodiment of the square urn incorporating my new design;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof; and

FIG. 4 is a front view thereof with the rear view, left side view and right side view being identical thereto.

FIG. 5 is a perspective view of the alternate embodiment of the square urn incorporating my new design;

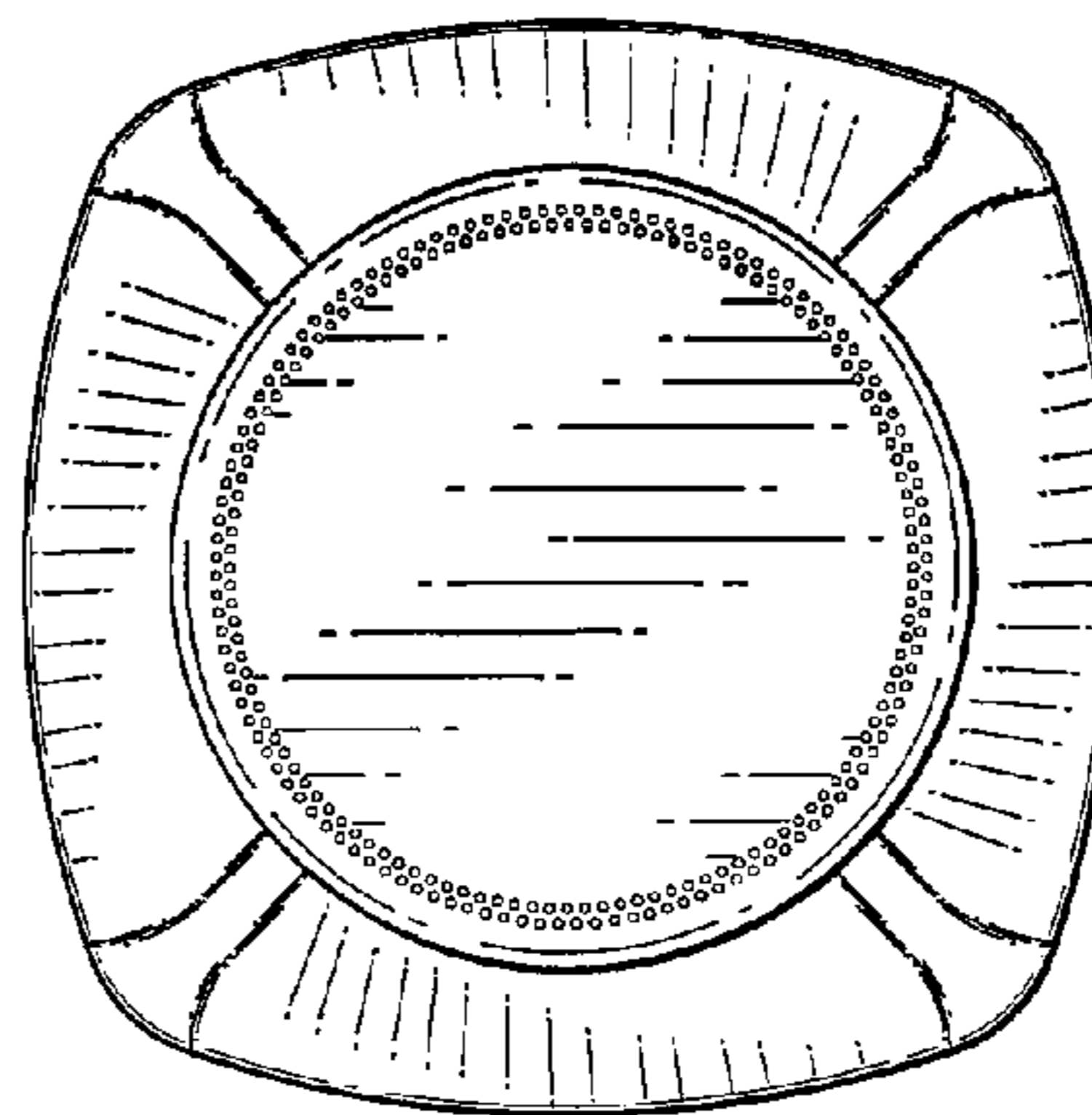
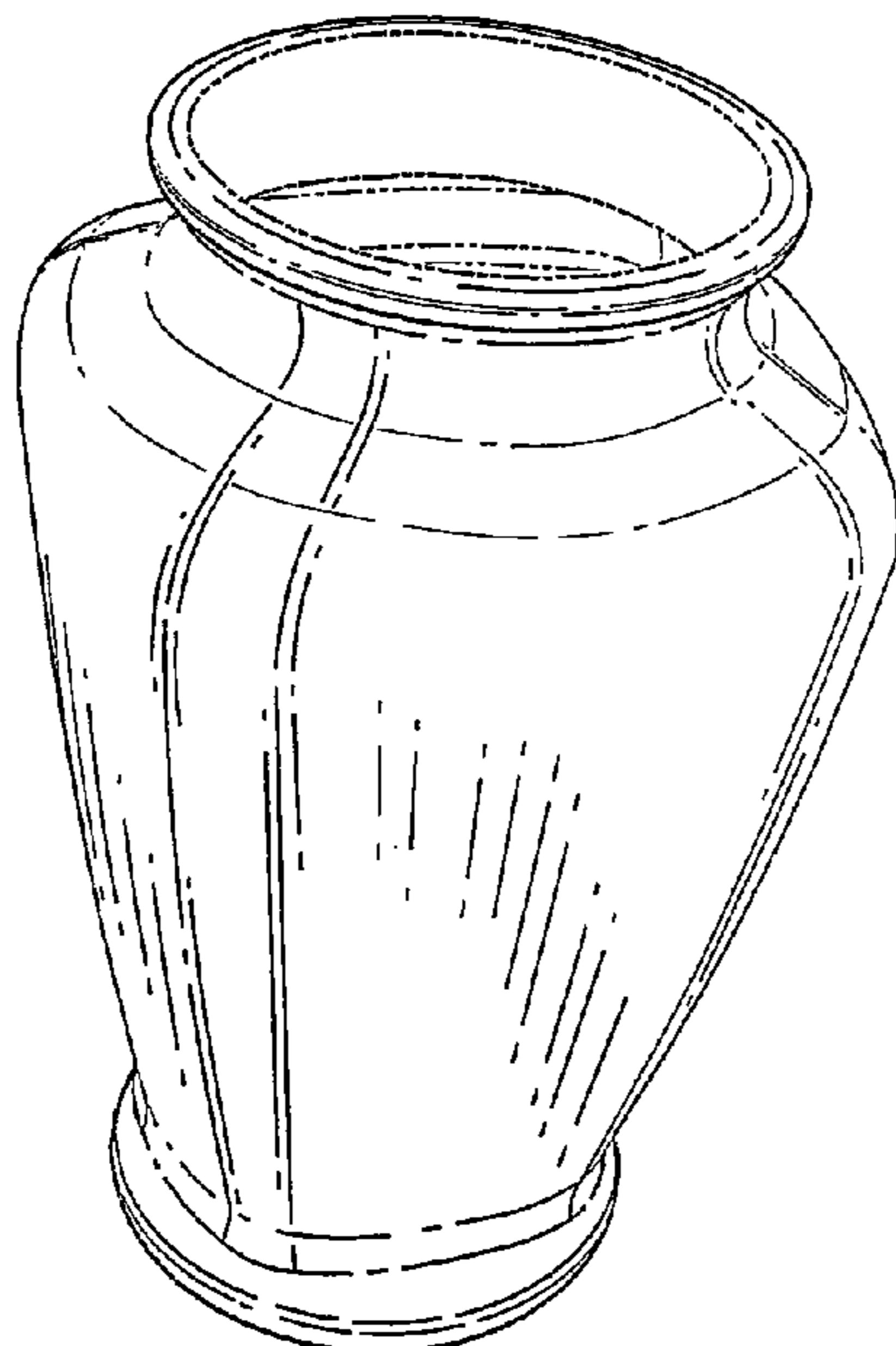
FIG. 6 is a top view of the urn shown in FIG. 5;

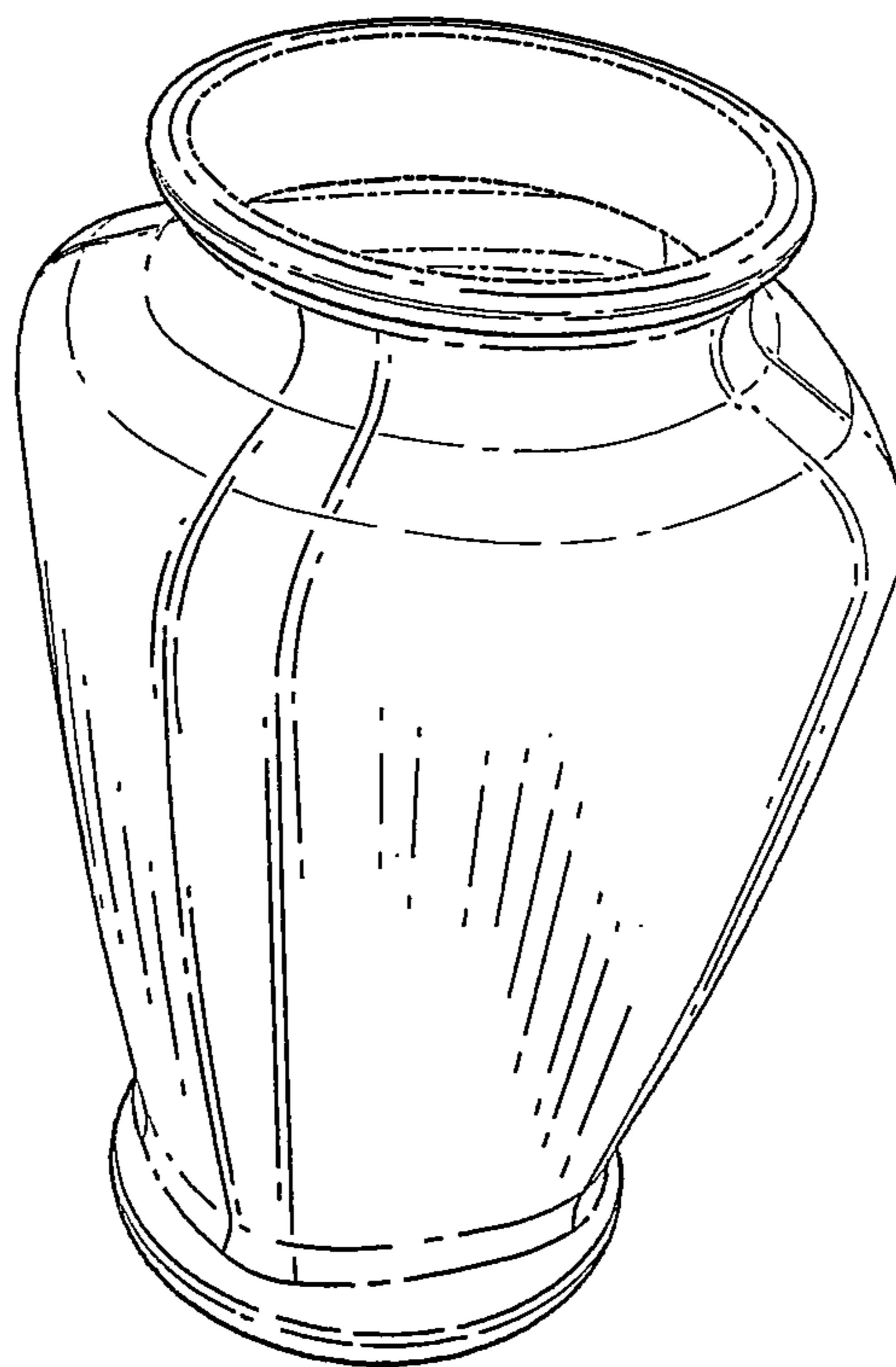

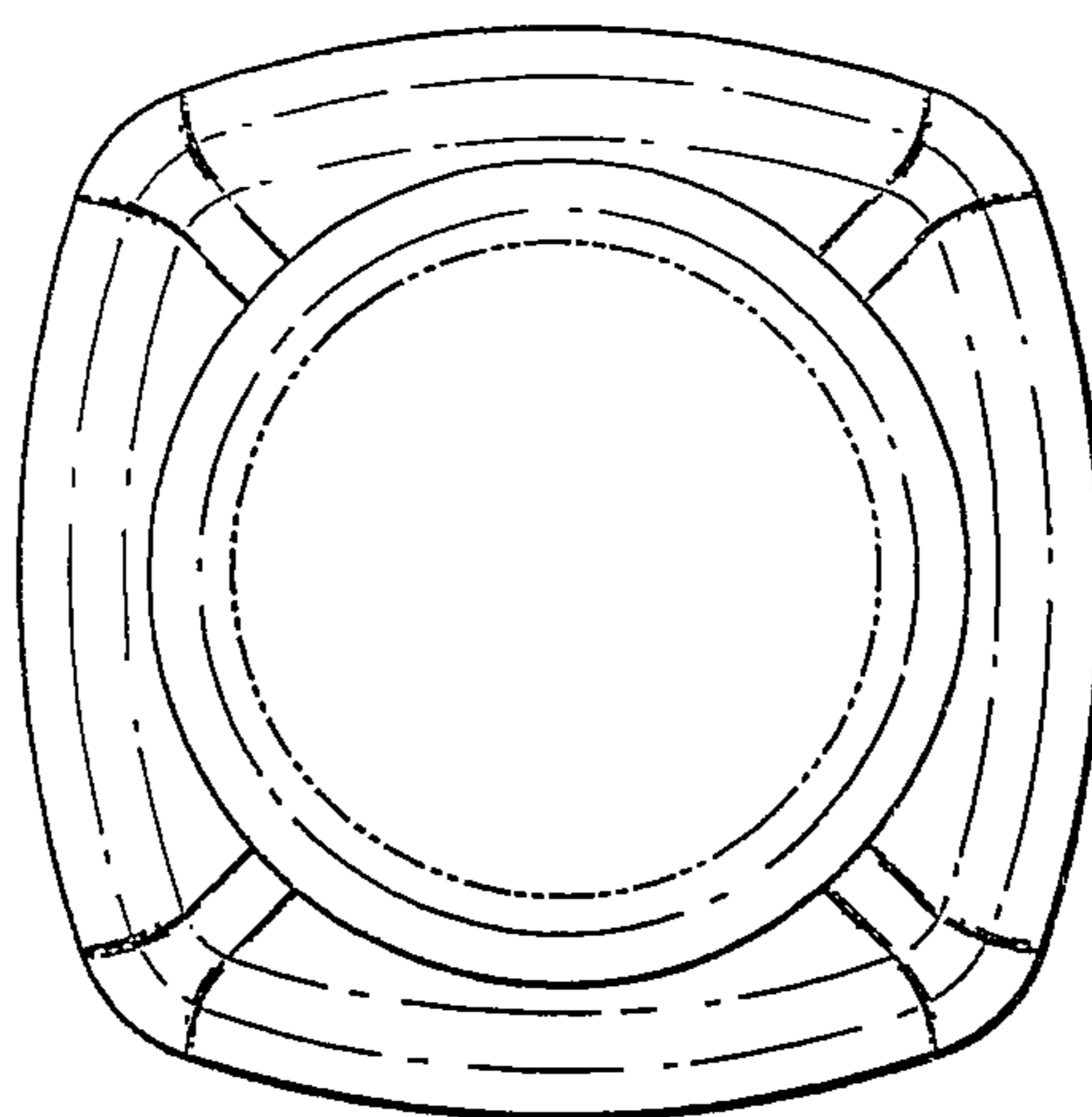

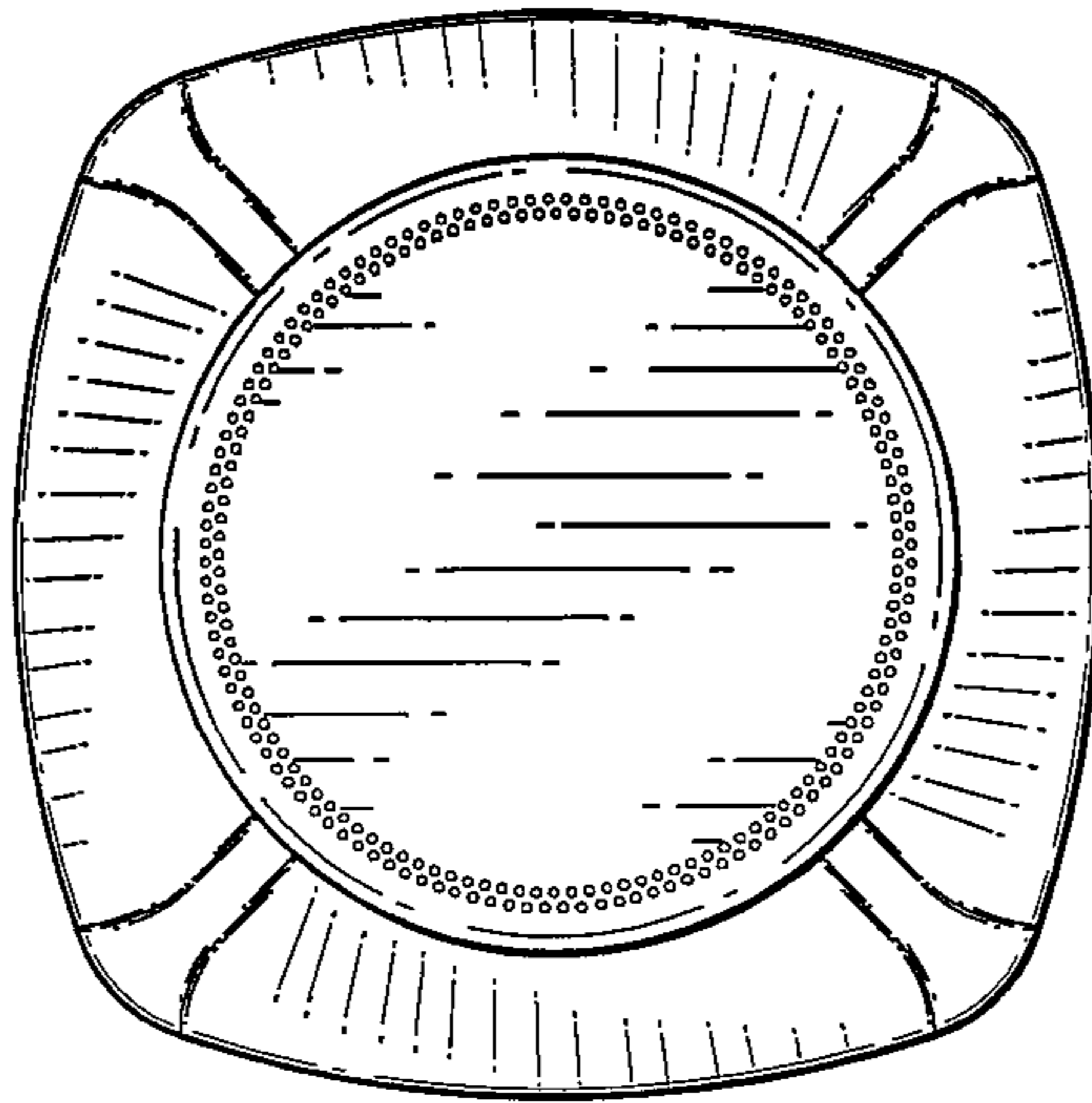

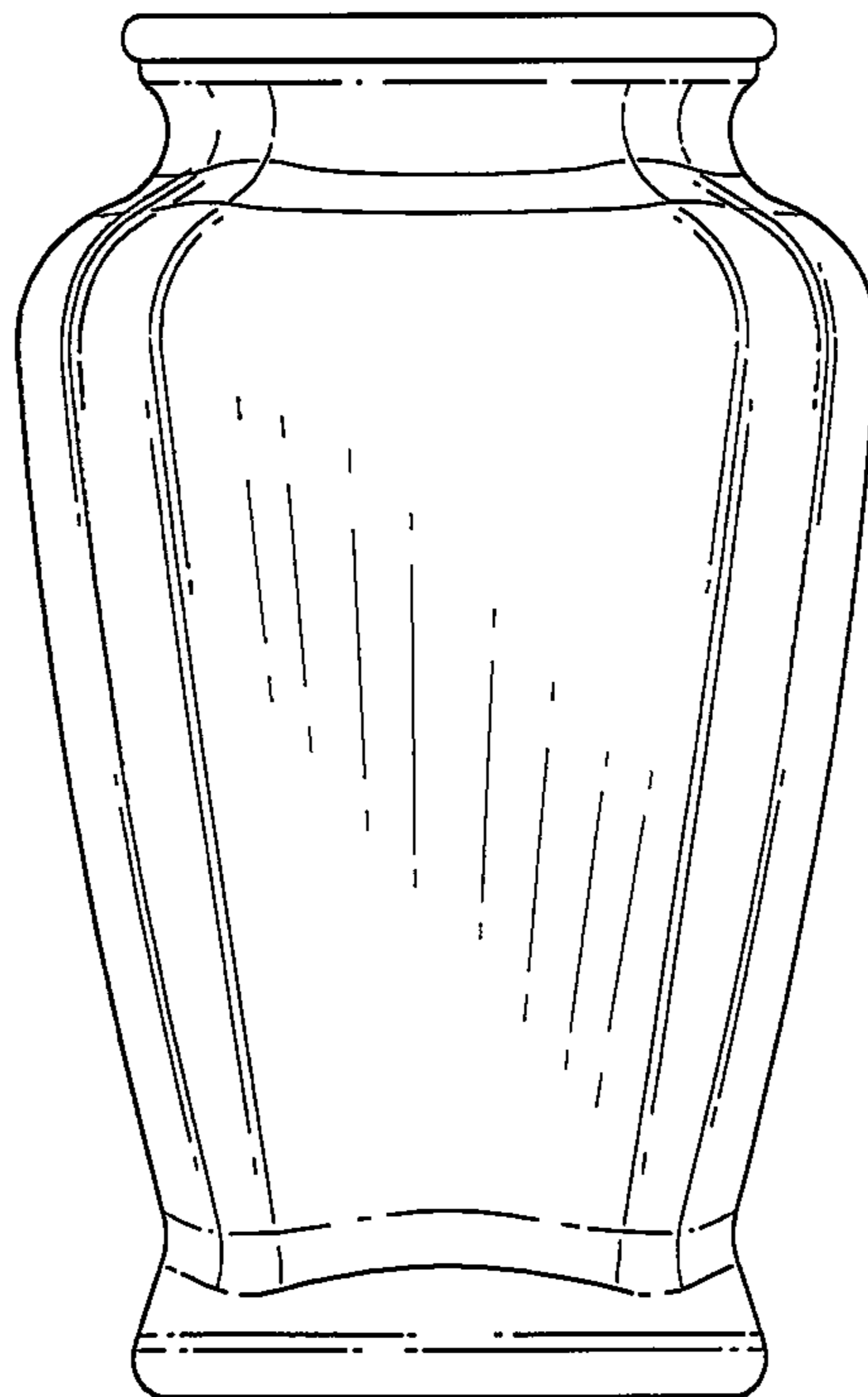

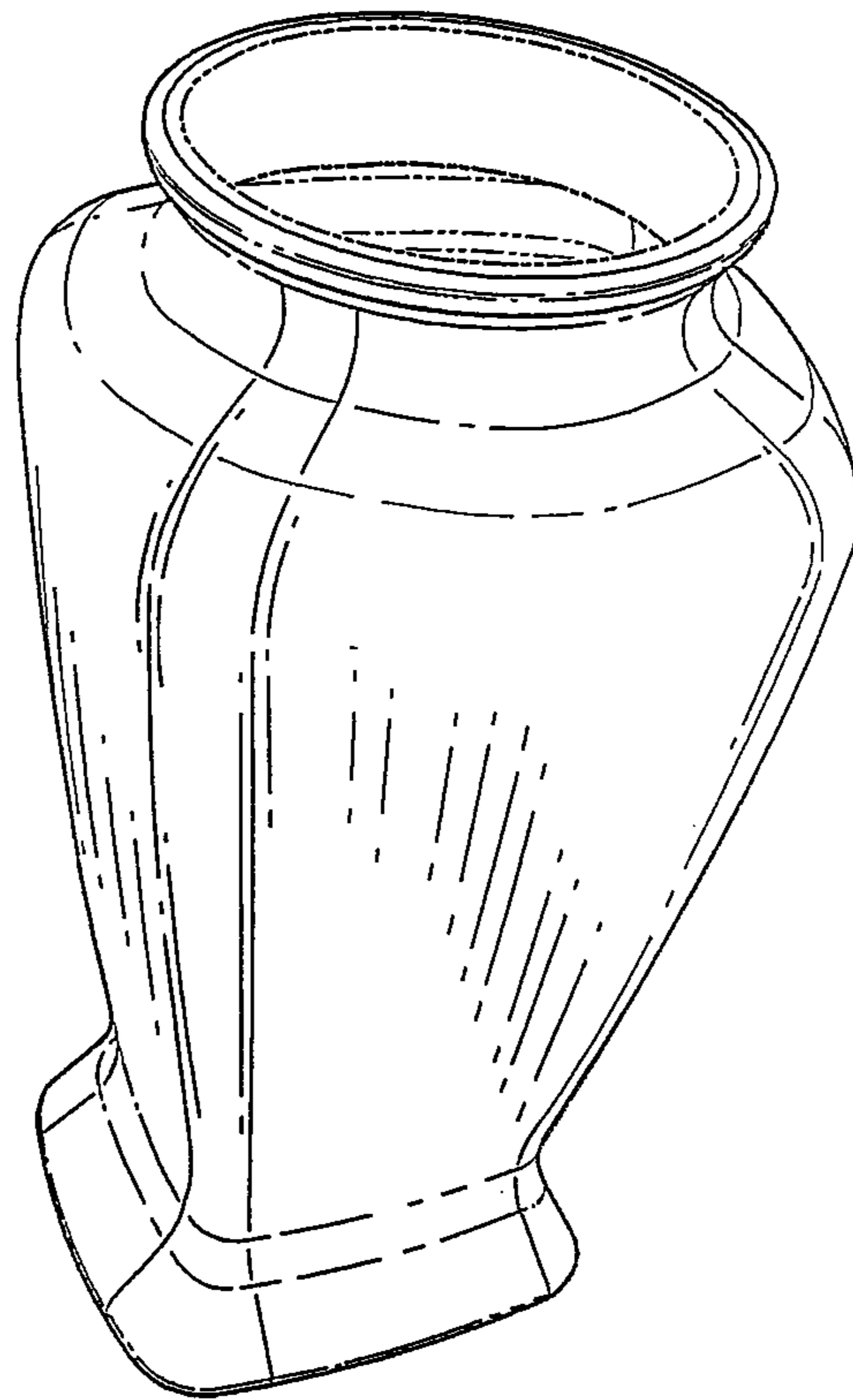

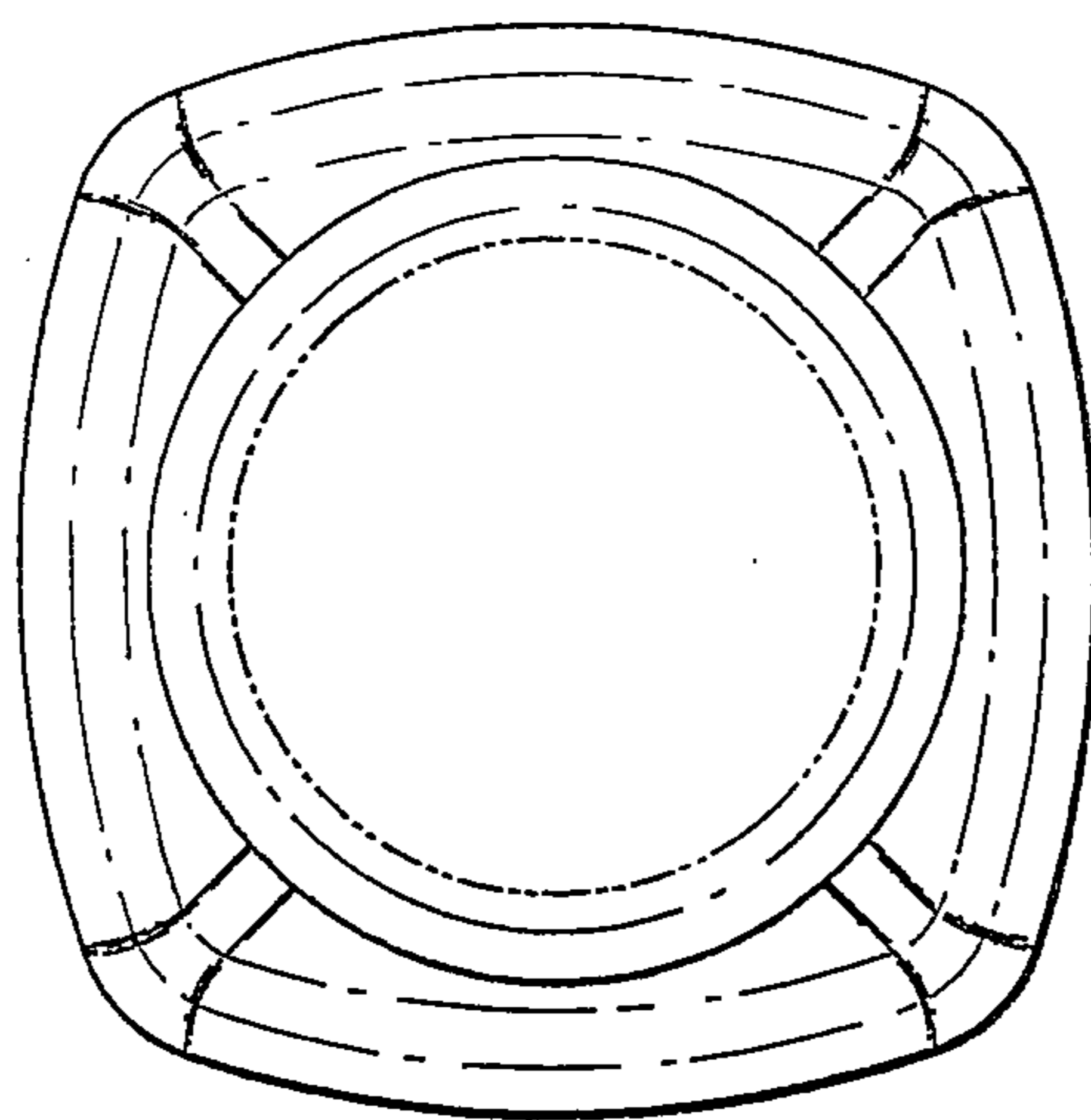

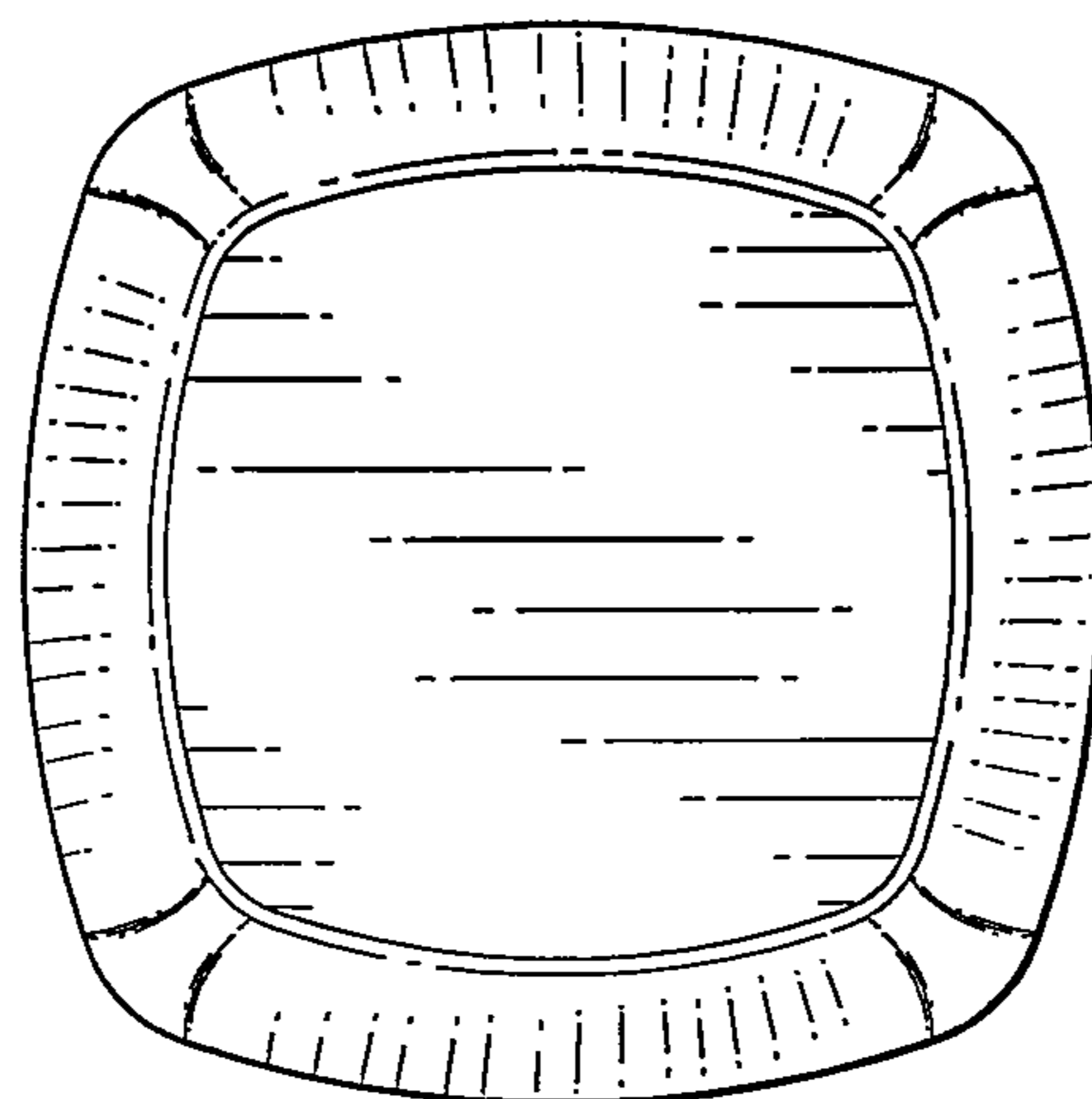

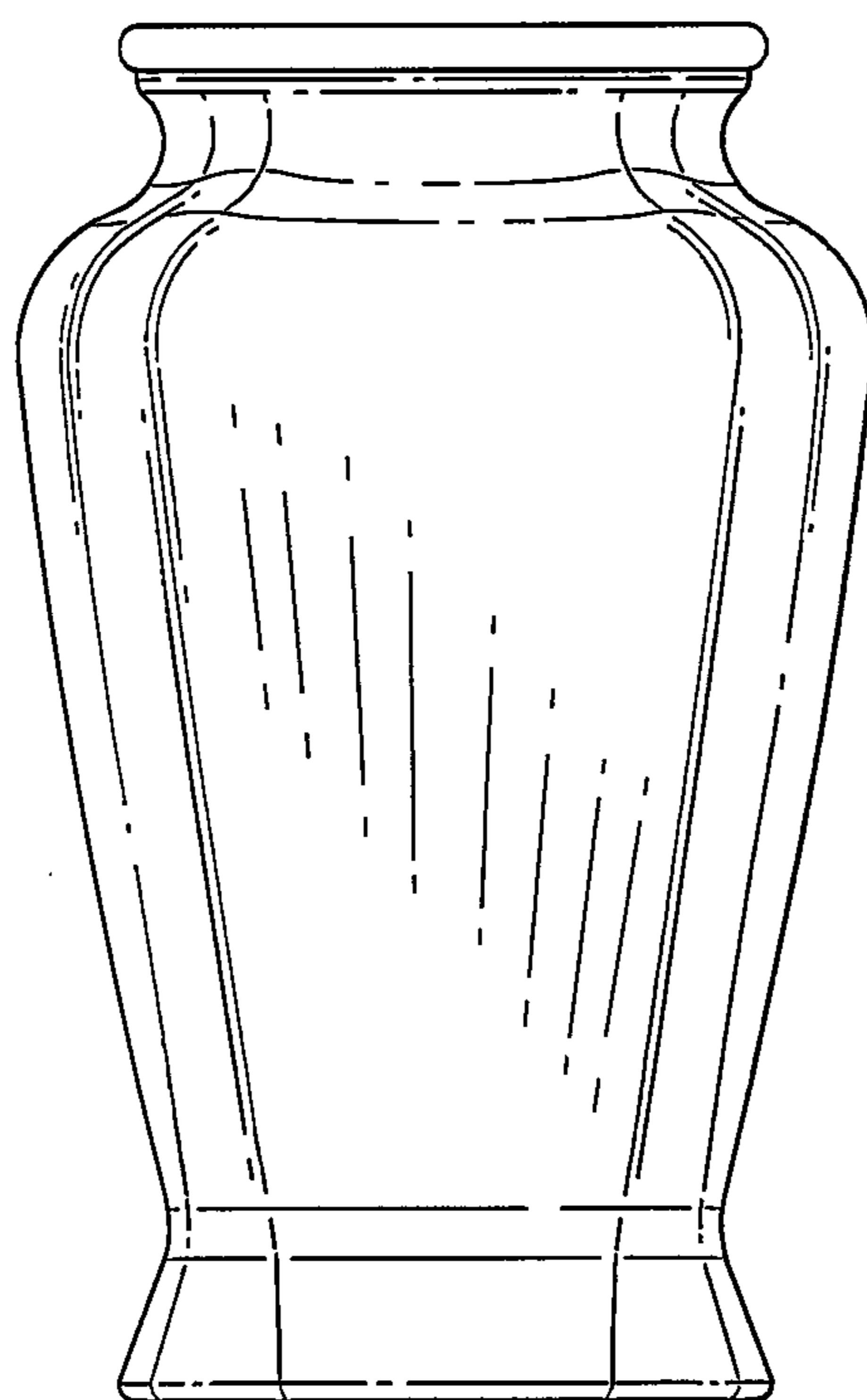
