(57) **CLAIM**

The ornamental design for pants, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the present invention; and, FIG. 2 is a back view thereof.

In all of the FIGURES, the dashed lines shown directly on the surface of the claimed article, throughout the views, are understood to represent stitching.

The broken lines showing portions of a human figure in FIG. 1 and FIG. 2 are for environmental purposes only and form no part of the claimed design.

The lighter and darker grey tonal areas, shown in FIGS. 1 and 2, represent contrasted surfaces unlimited by colors.

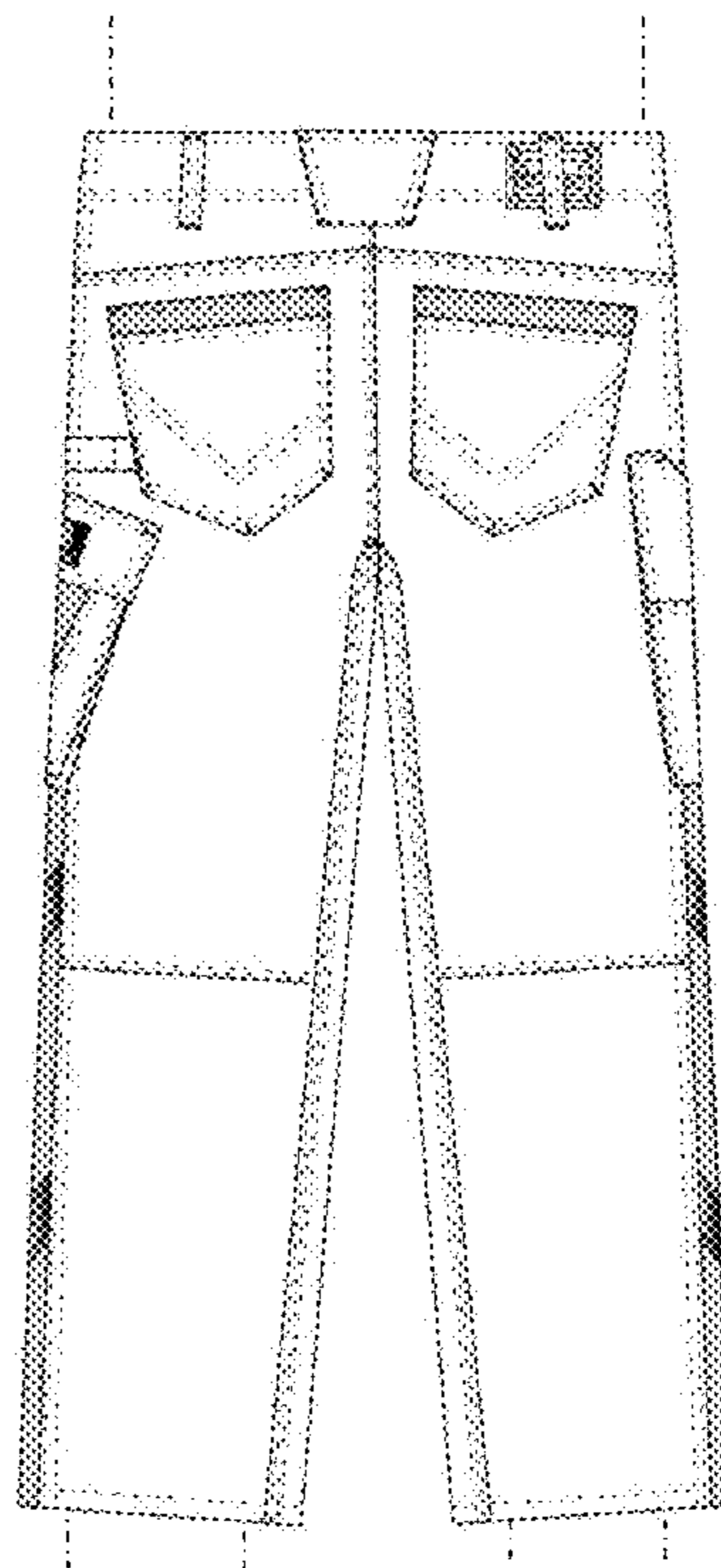
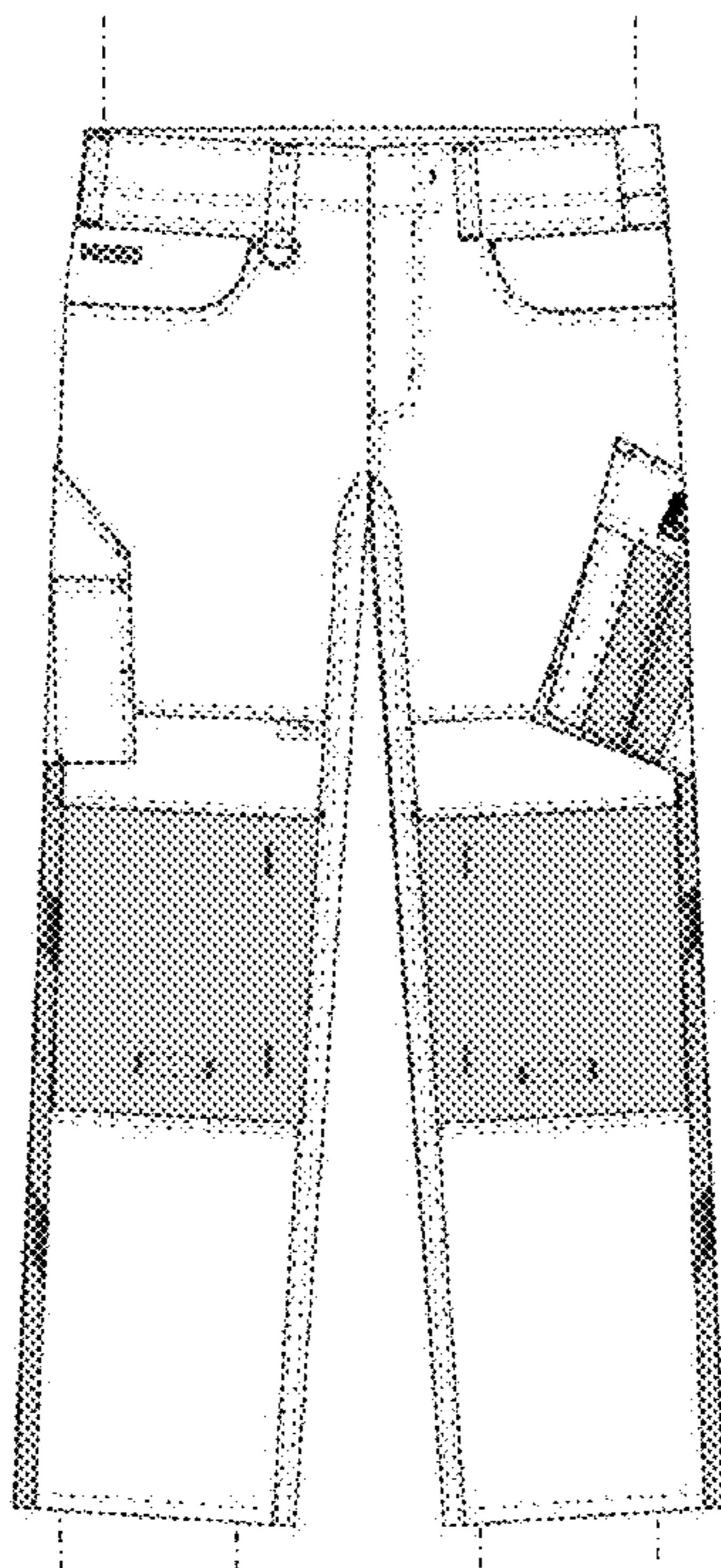

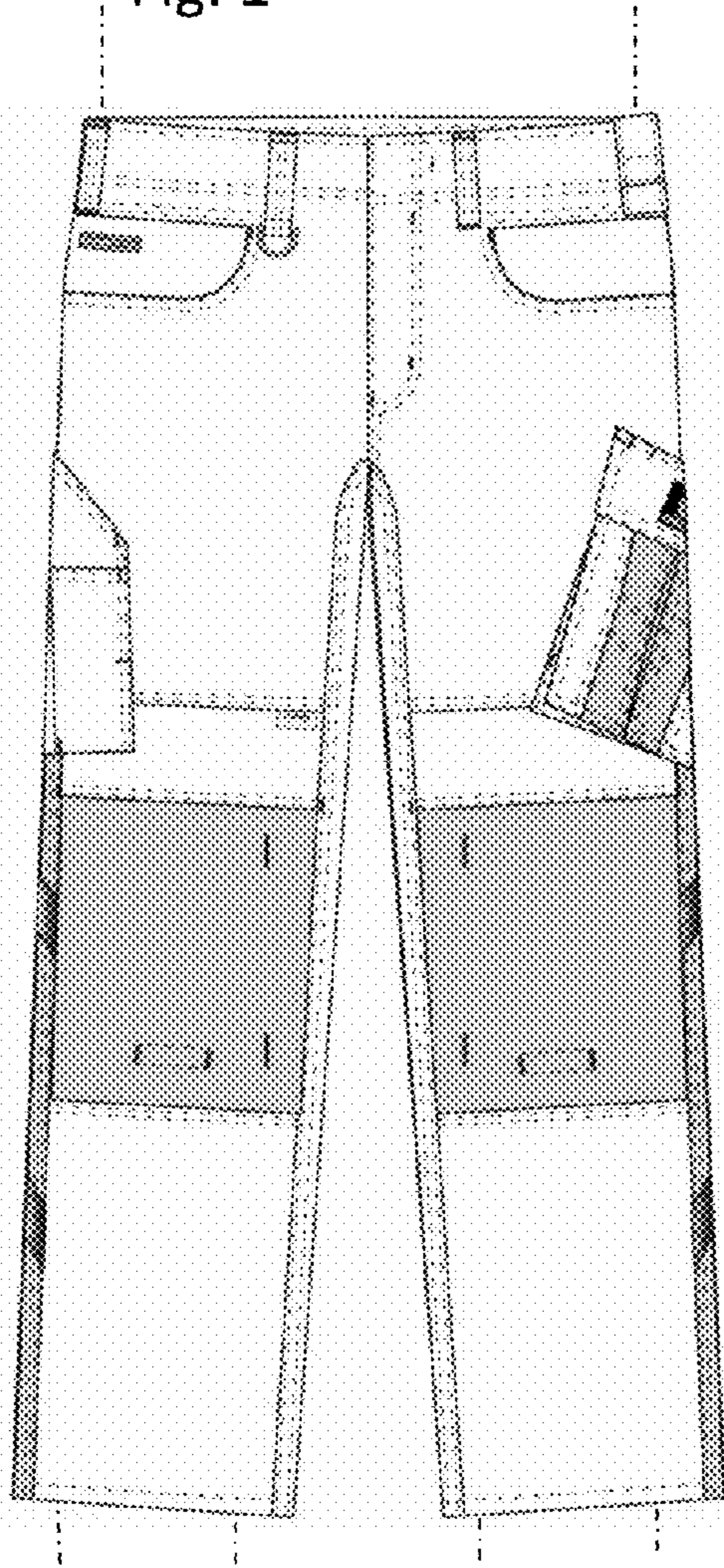
