FIG. 3 is a rear elevation view of the claimed design.

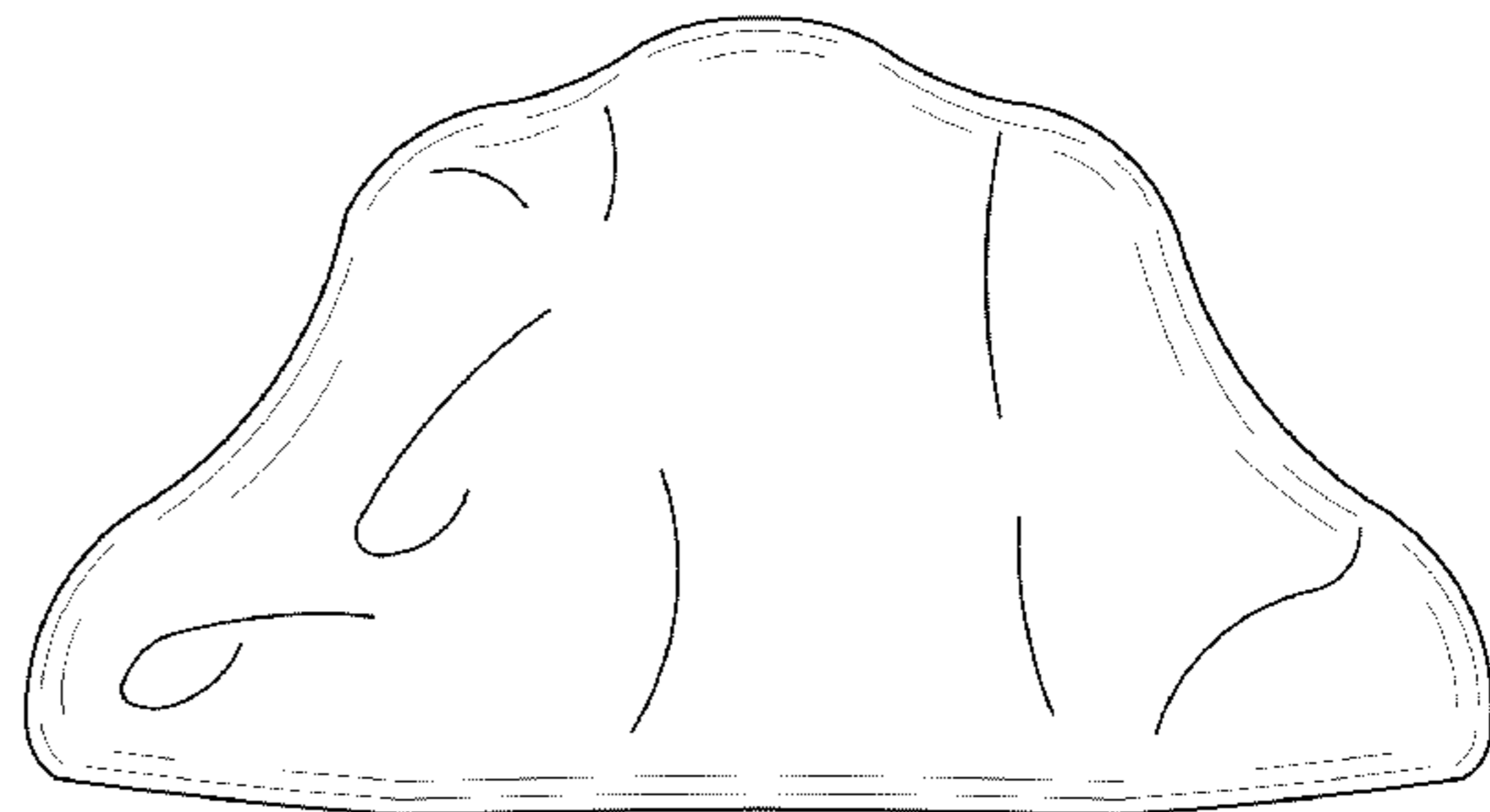
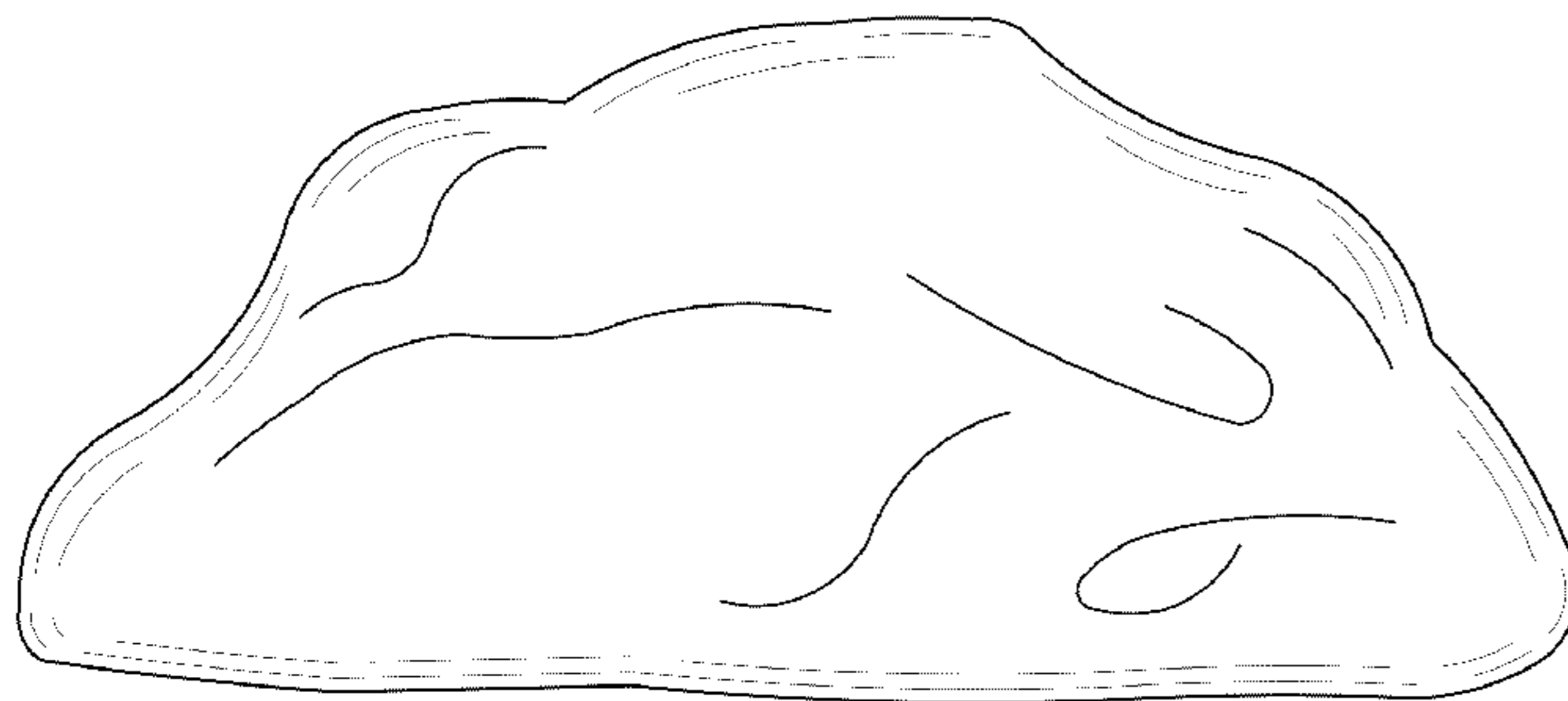
FIG. 4 is a front elevation view of the claimed design.

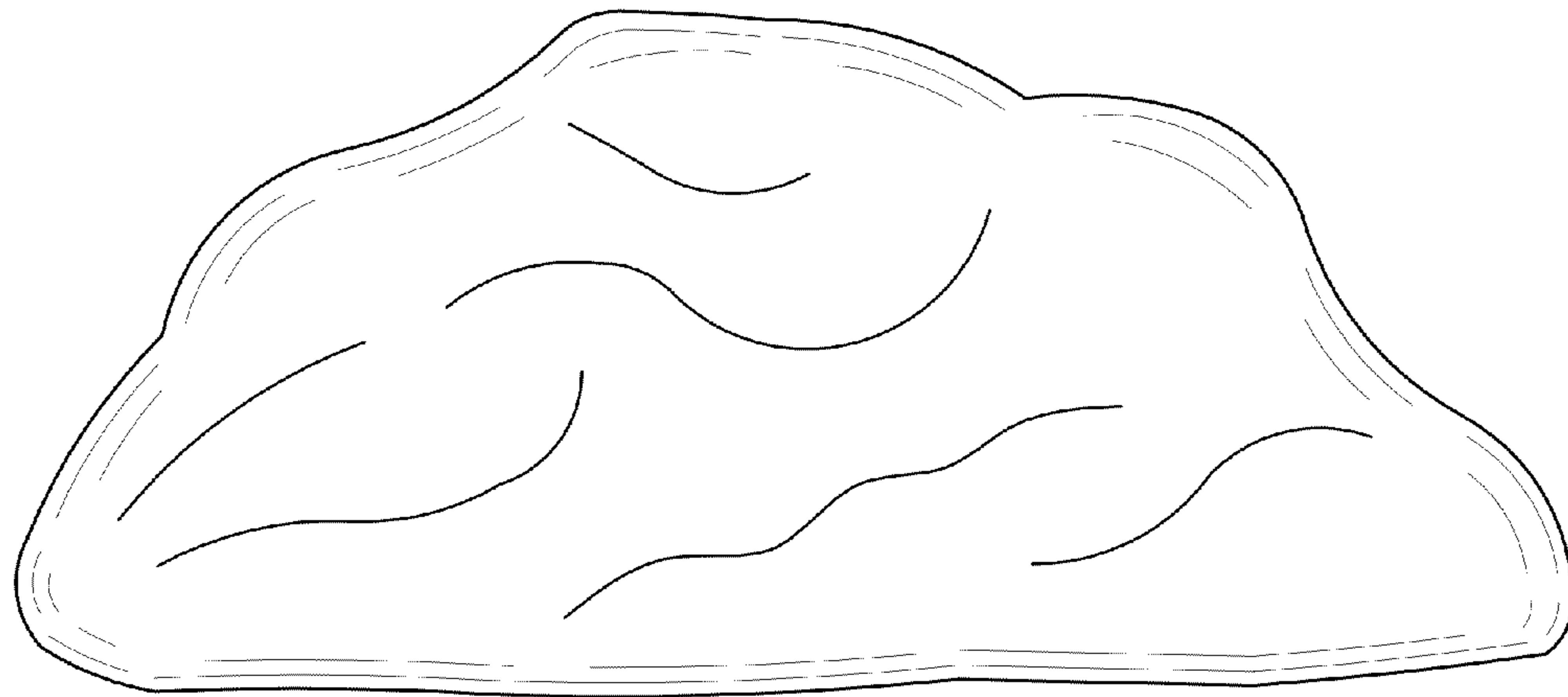

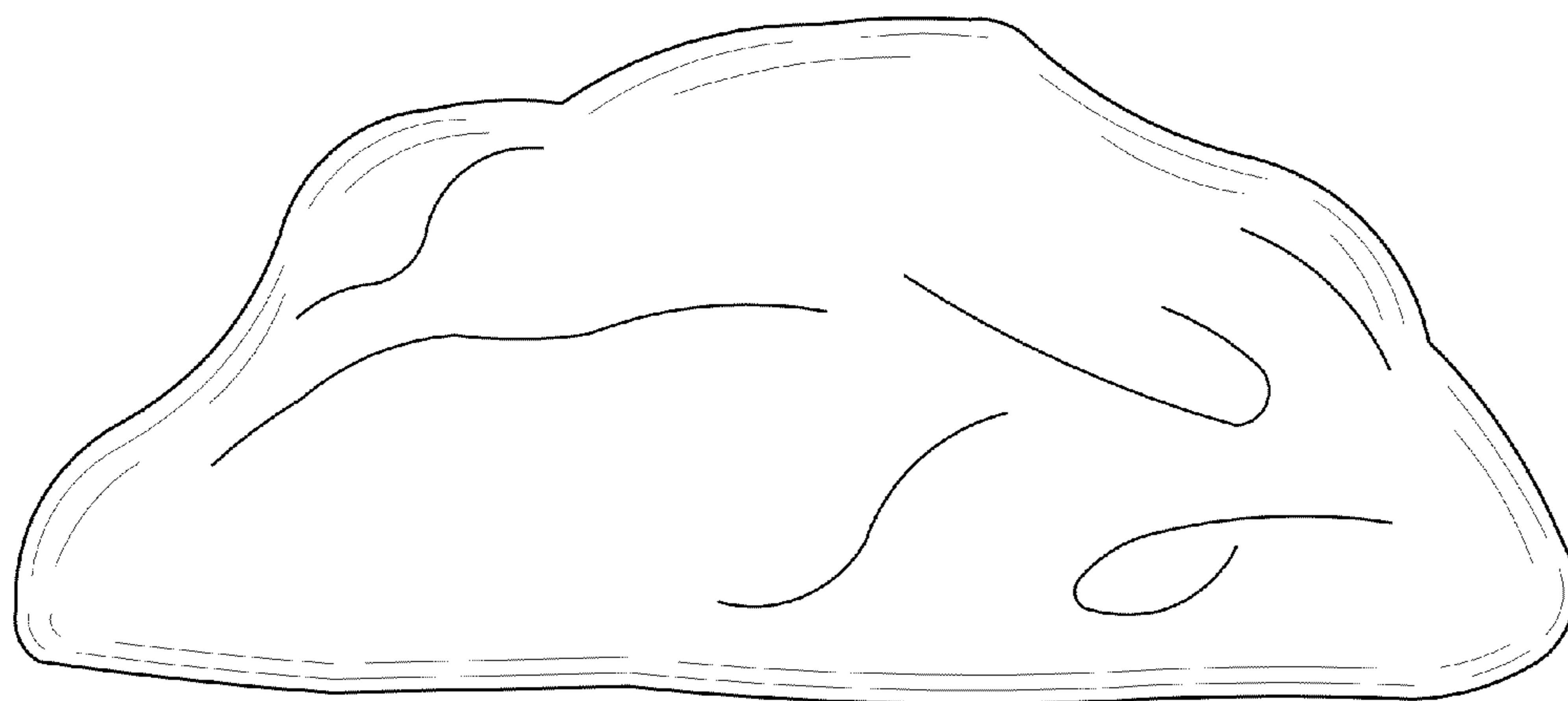

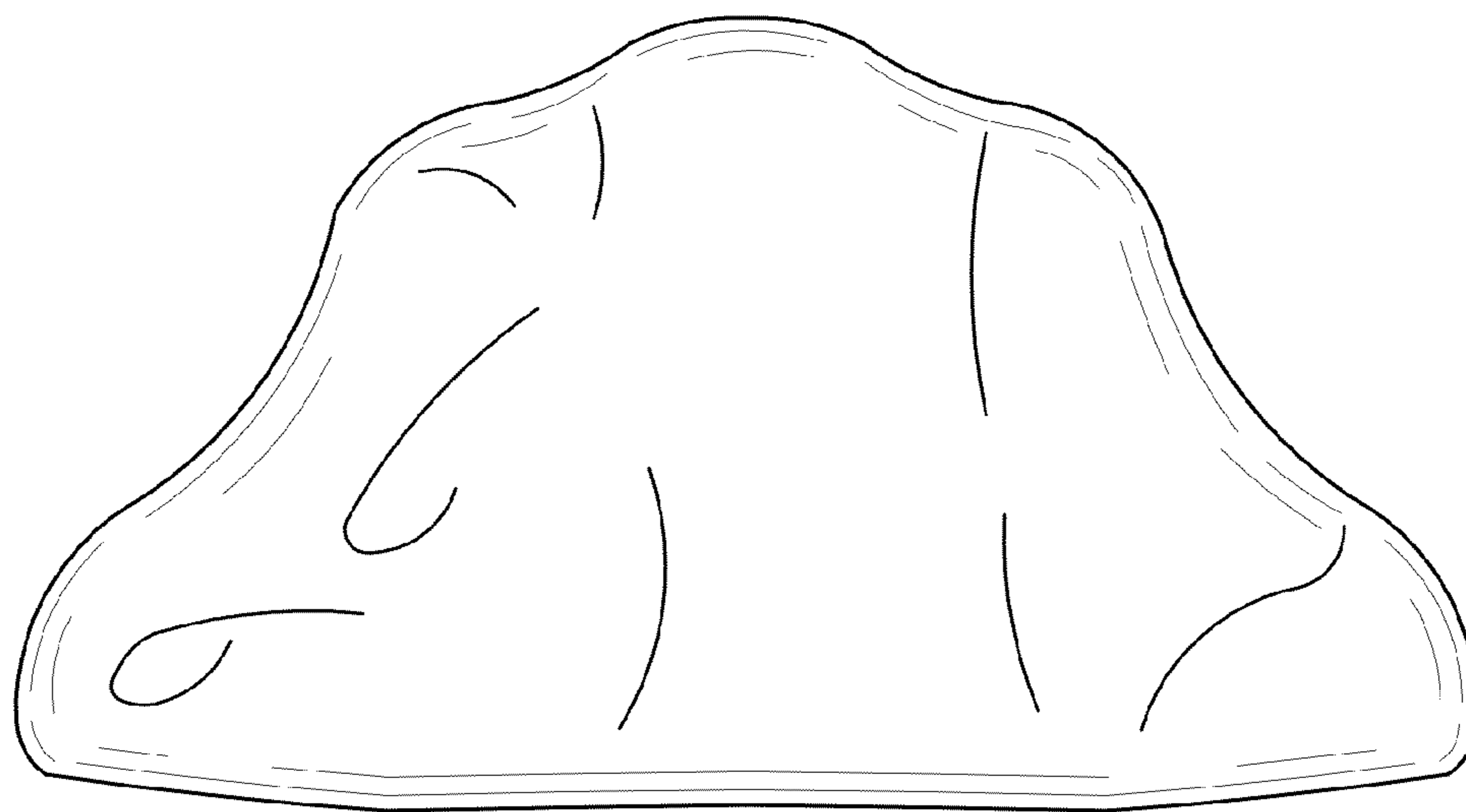

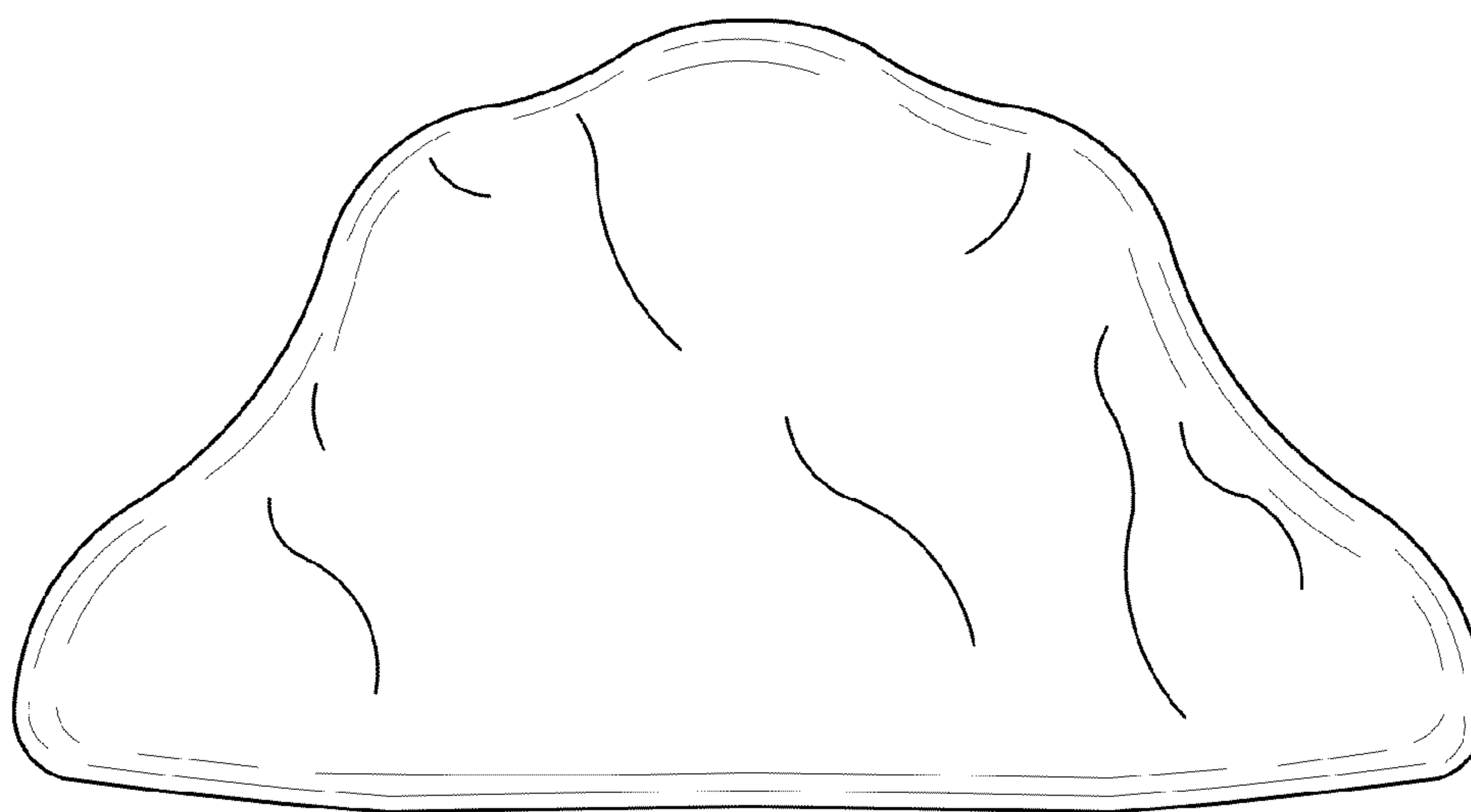

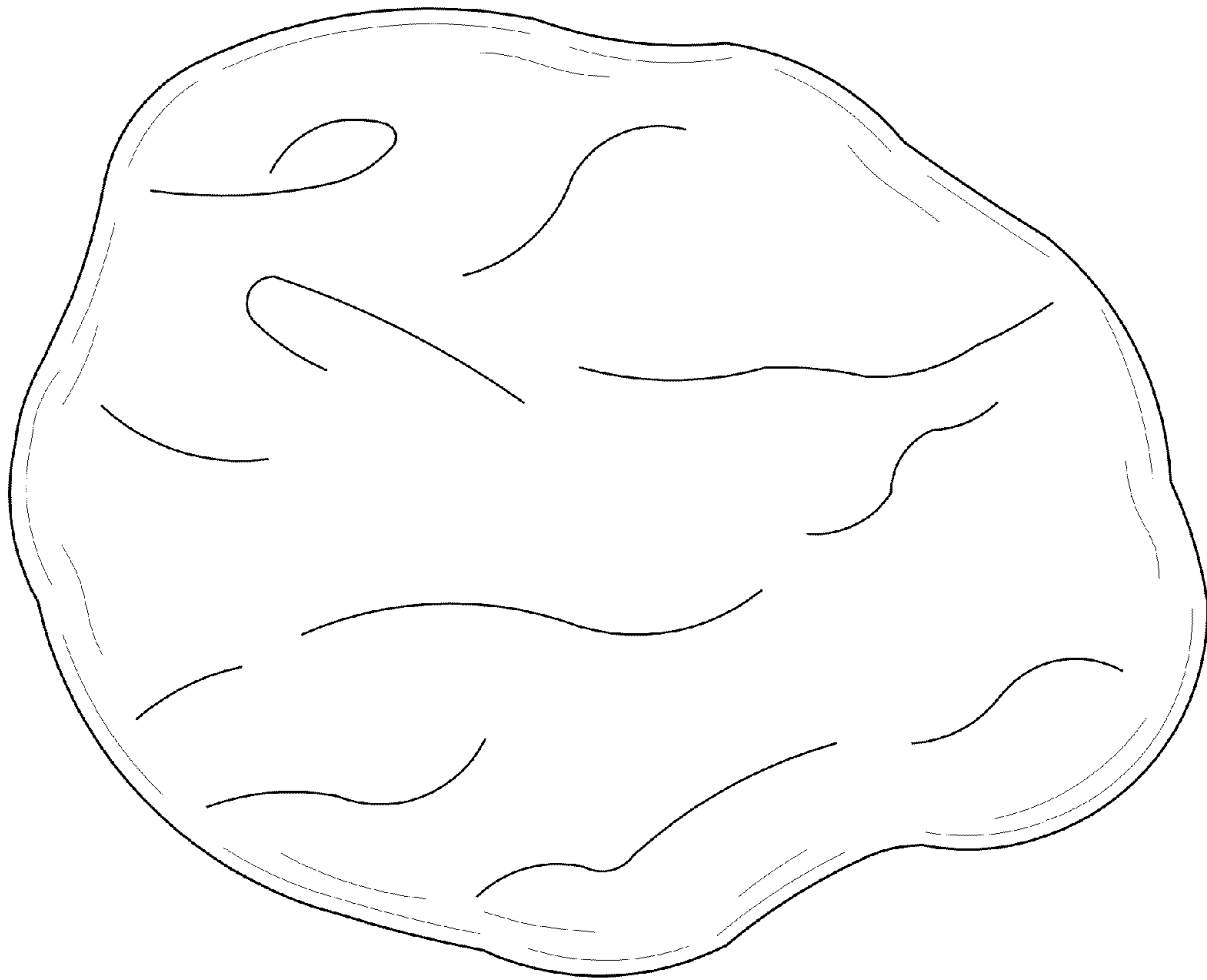

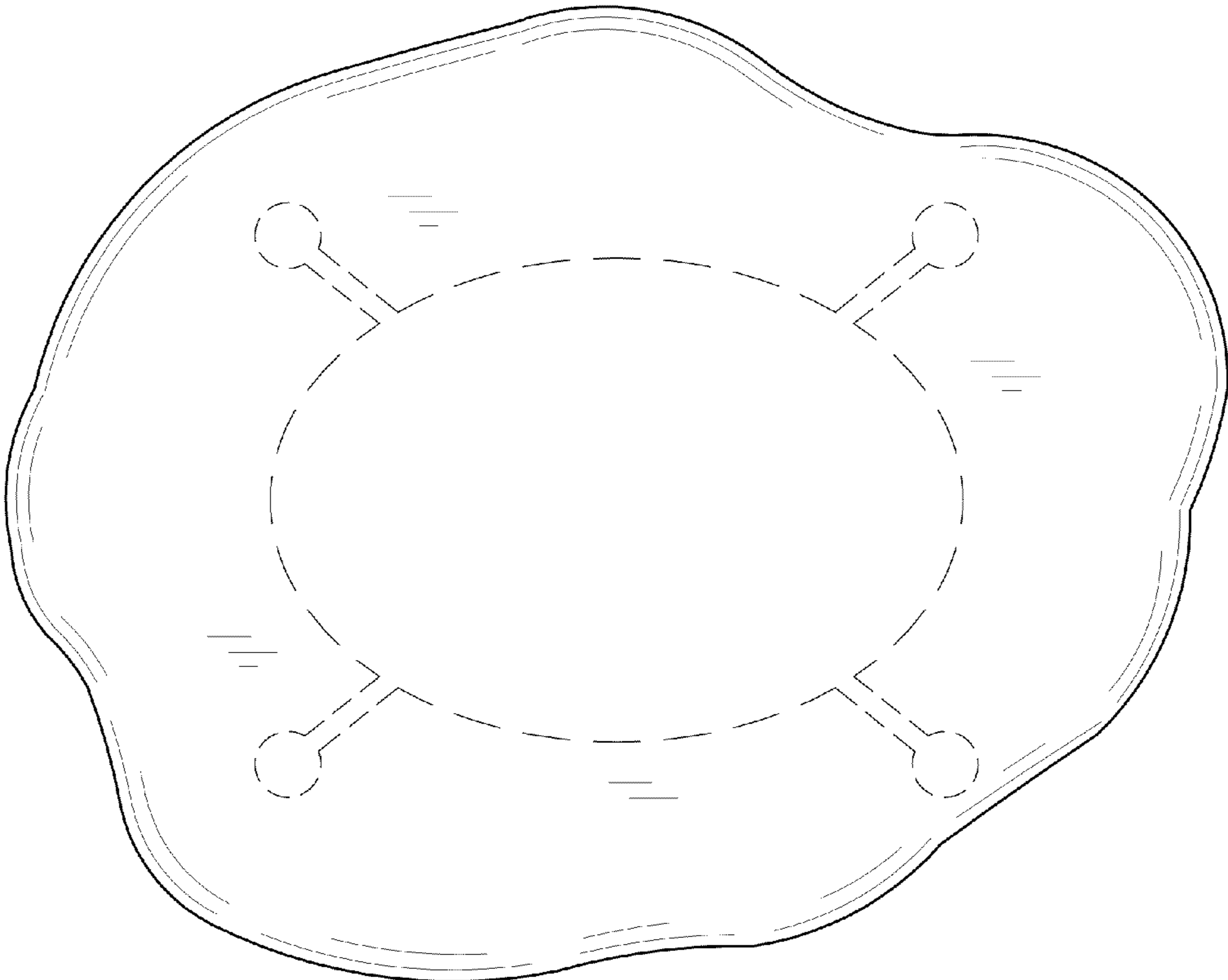
