(57) **CLAIM**

I claim; the ornamental design for carrying bag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a carrying bag showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

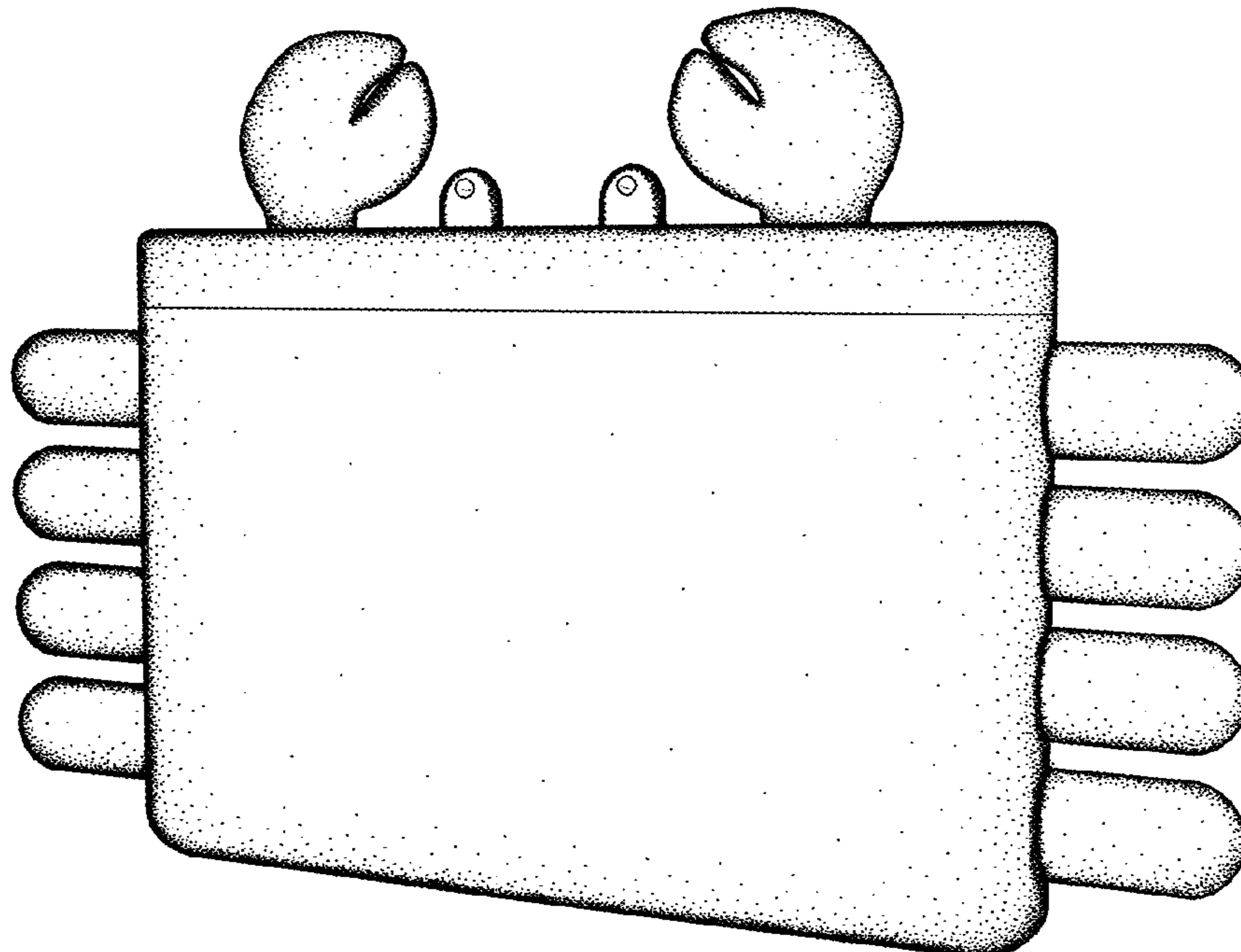
FIG. 8 is another perspective view thereof with a strap shown in broken lines with the carrying bag;

FIG. 9 is a front elevational view thereof with a device shown in broken lines partially inserted within the carrying bag; and,

FIG. 10 is another perspective view thereof with a hand shown in broken lines inserted within the bottom of the carrying bag.

The broken lines showing a strap, a device and a hand are for the purposes of illustrating environment and form no part of the claimed design.

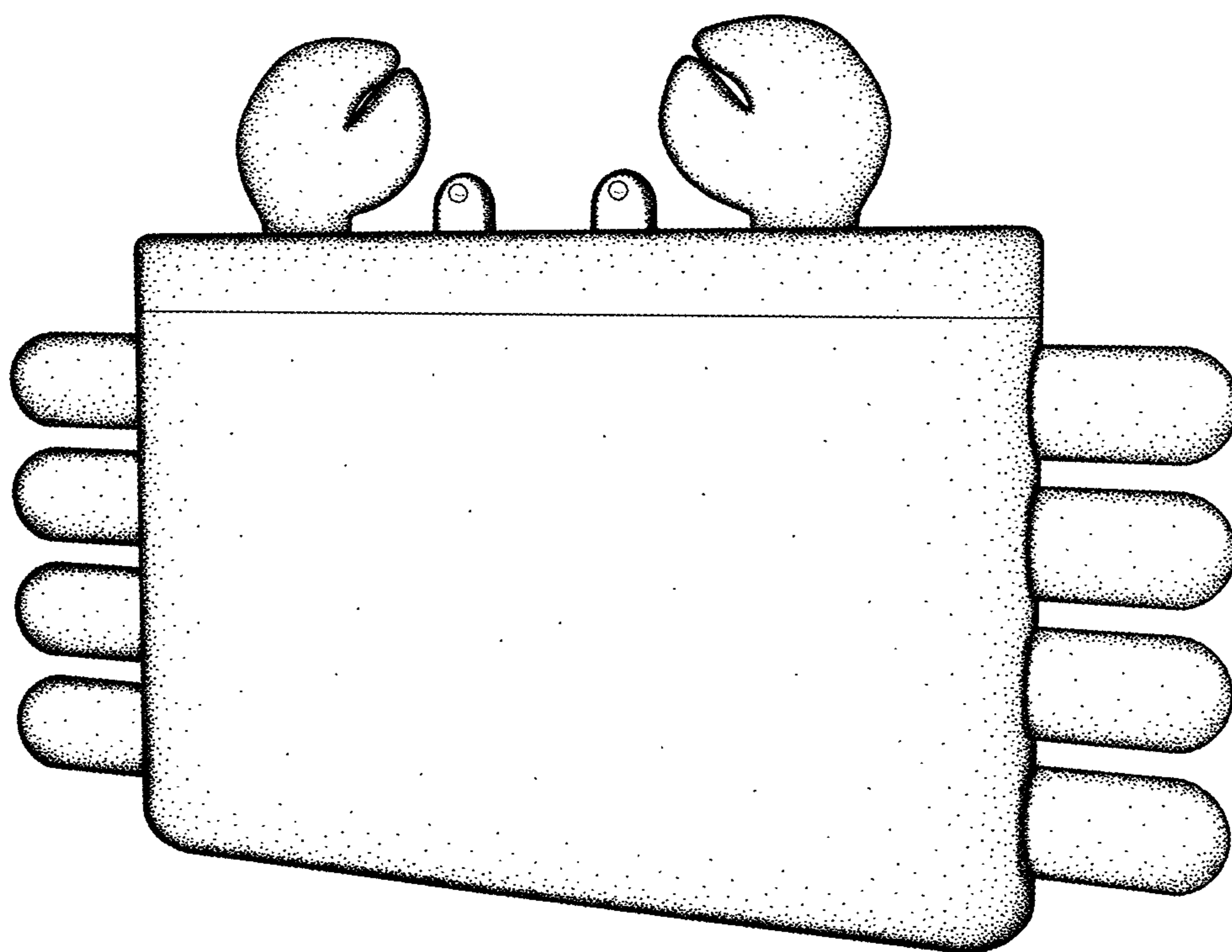

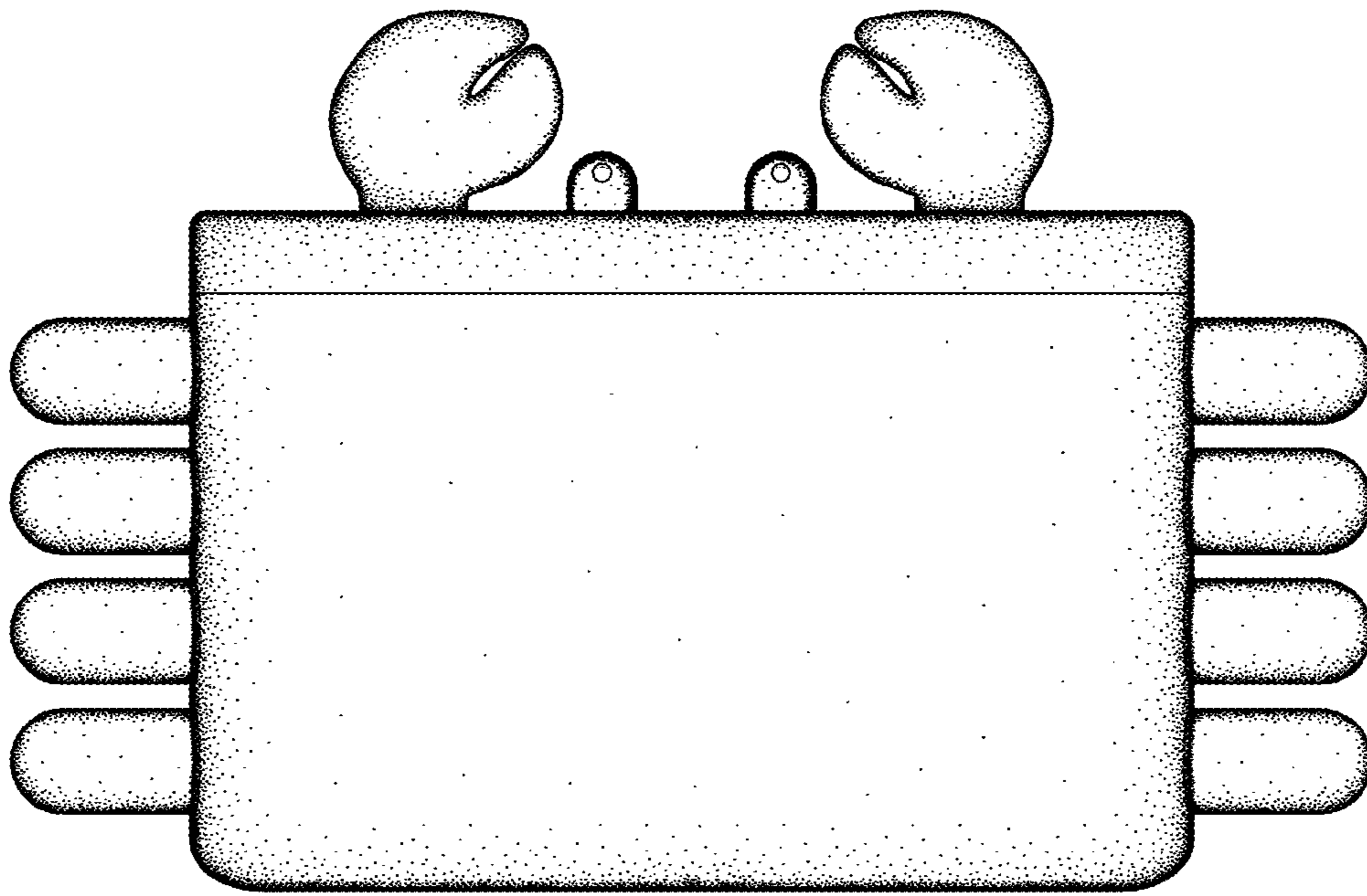

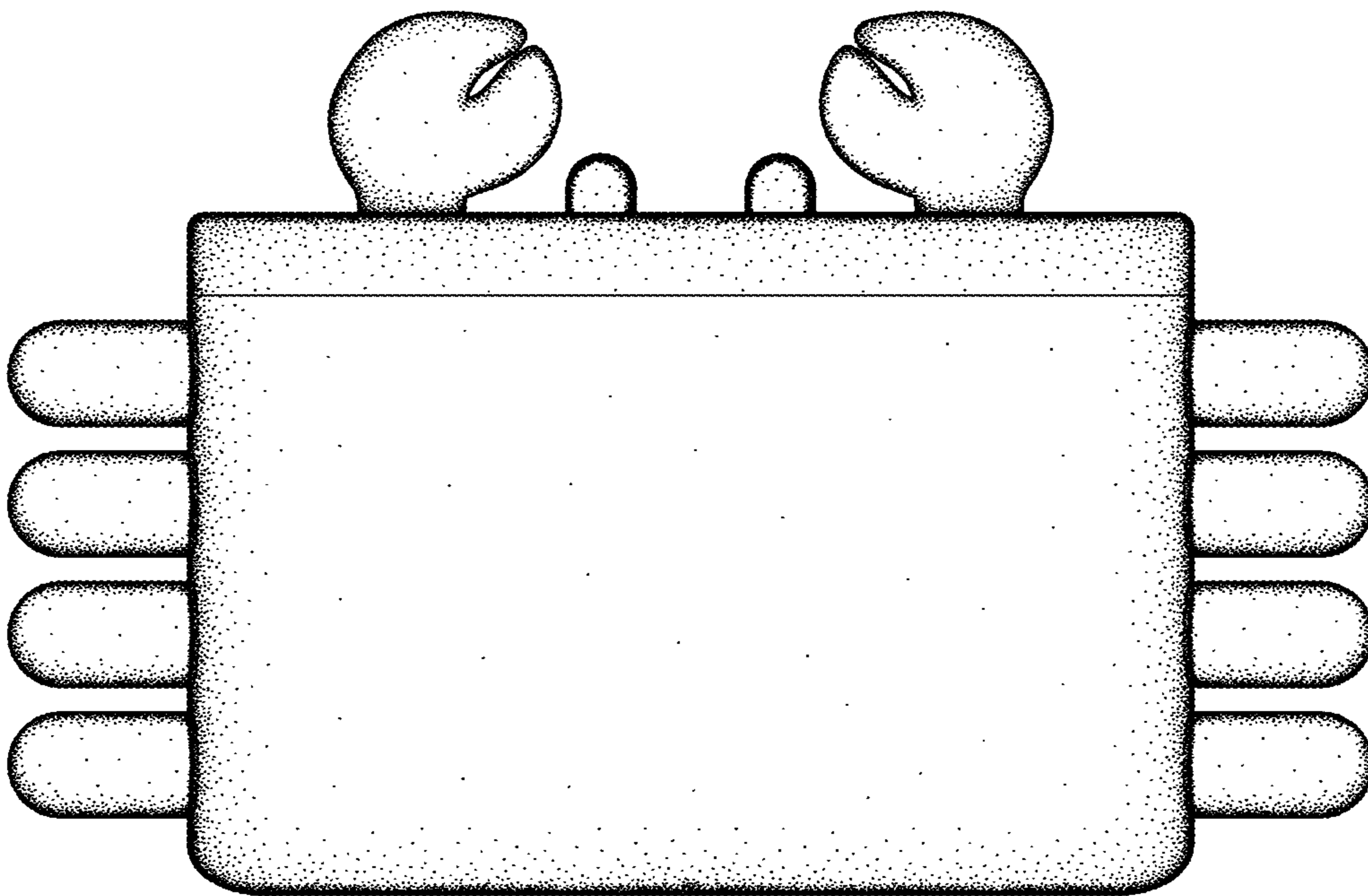

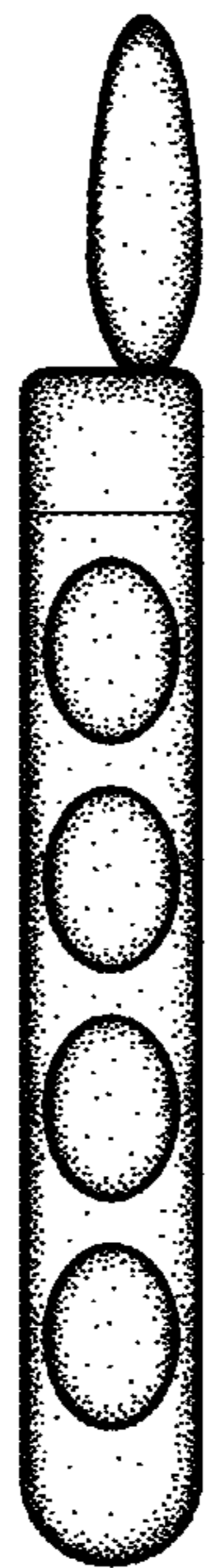

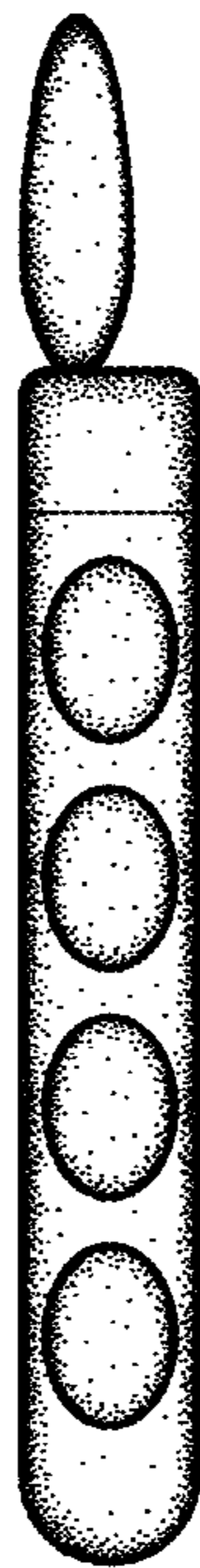

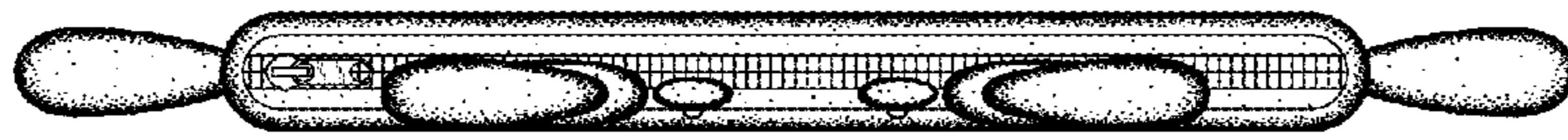

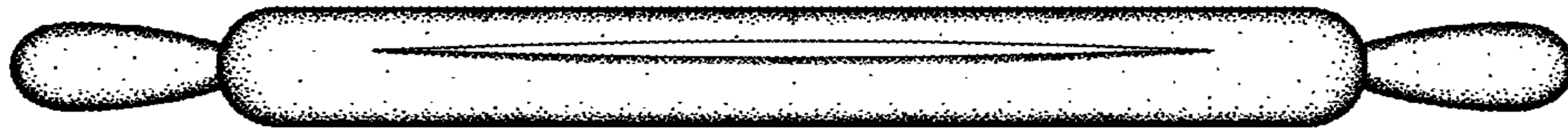

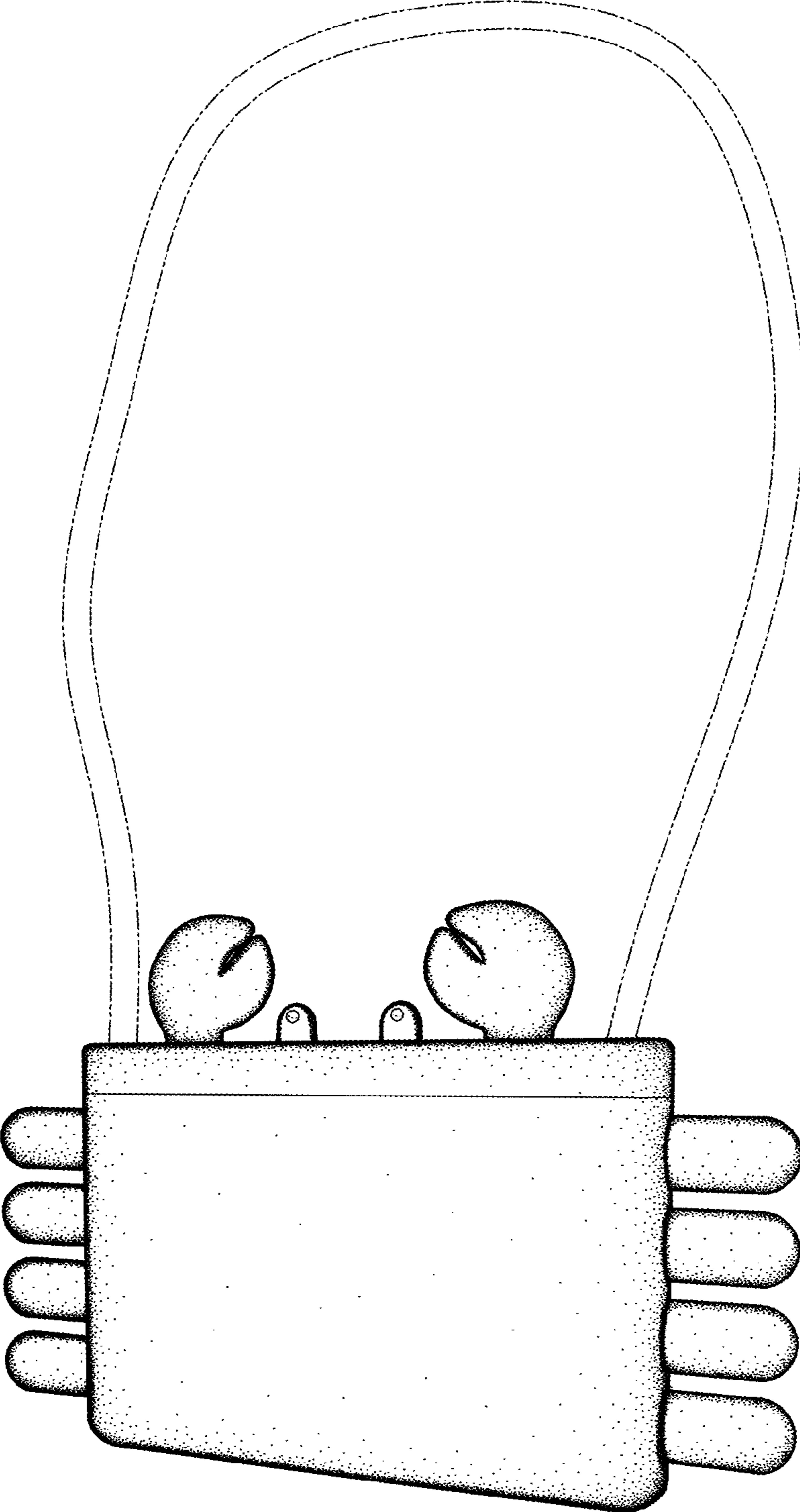

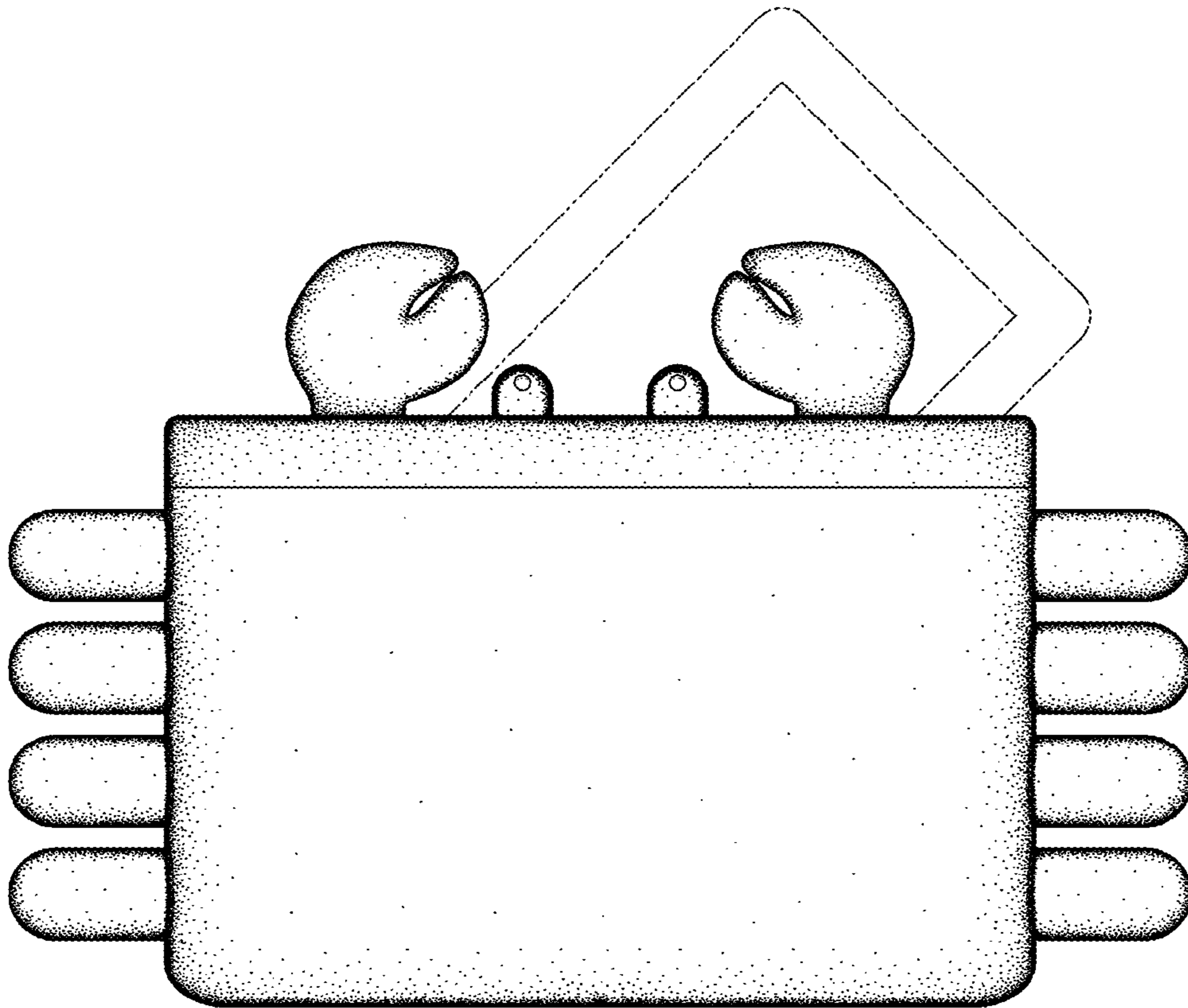

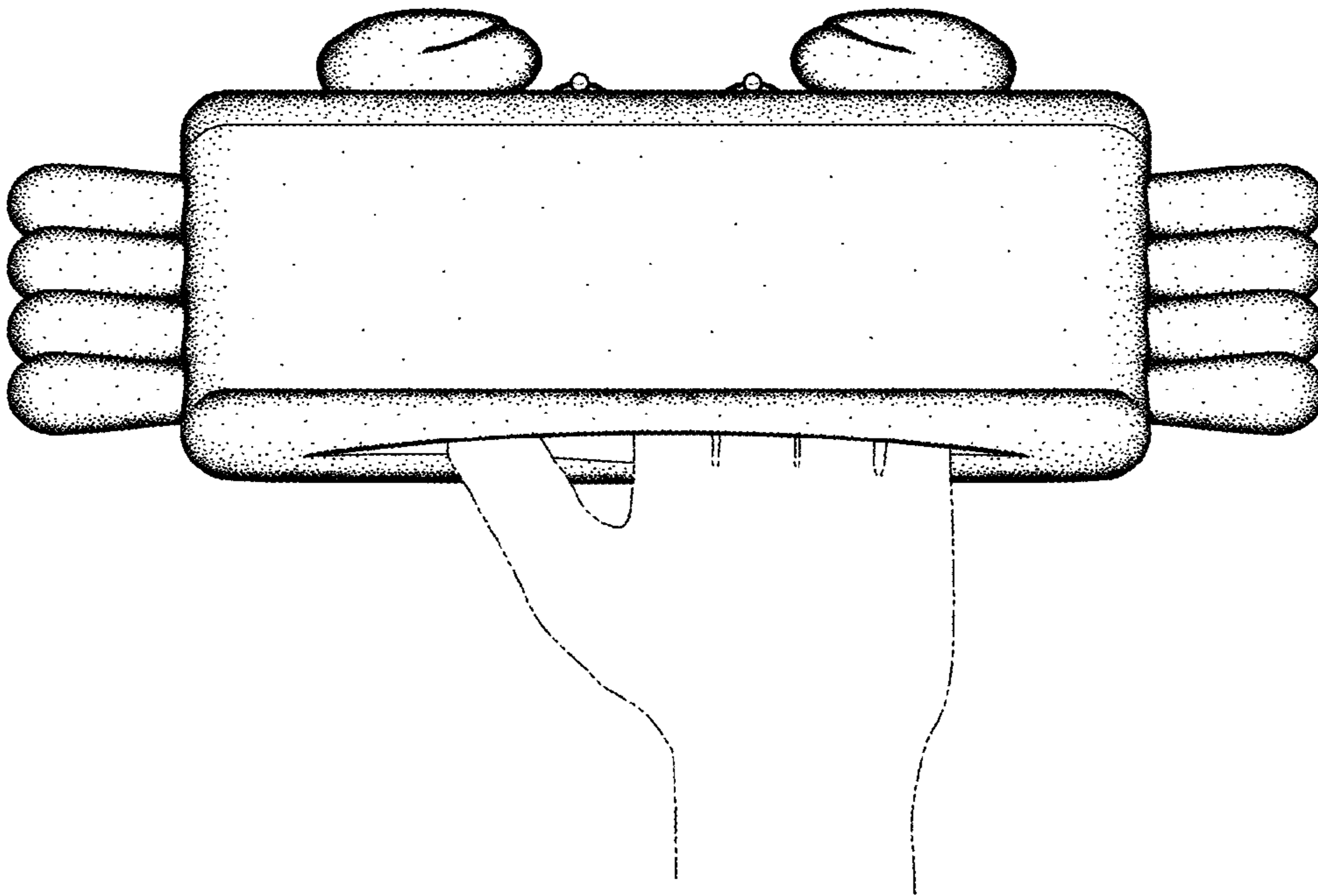
