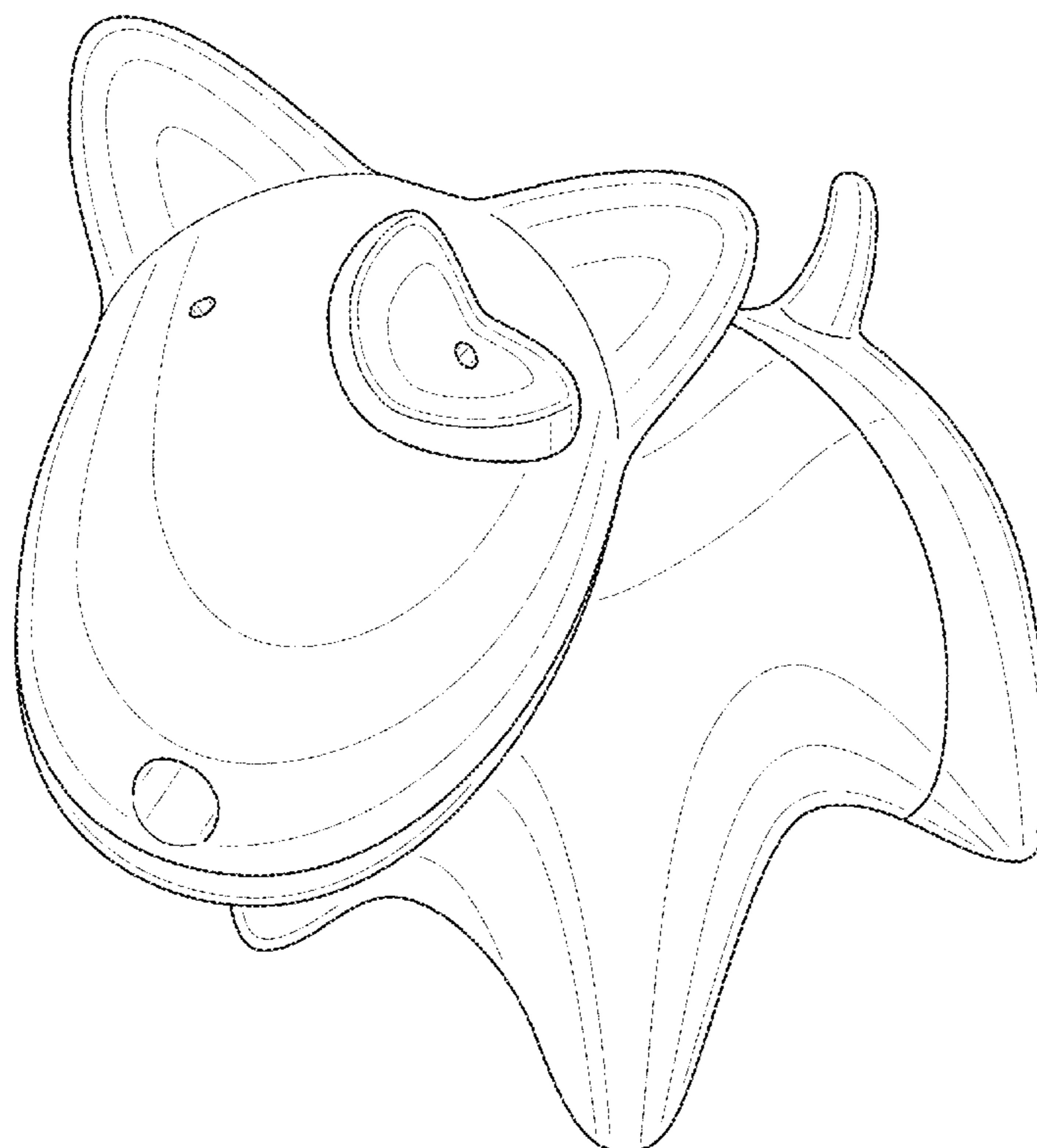
(57) **CLAIM**

I claim the ornamental design for dog shaped container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective overhead view of a dog shaped container of the design;
FIG. 2 is a perspective side view from the left of a dog shaped container of the design;
FIG. 3 is a perspective side view from the right of a dog shaped container of the design;
FIG. 4 is a perspective top view of a dog shaped container of the design;
FIG. 5 is a perspective bottom view of a dog shaped container of the design;
FIG. 6 is a perspective front view of a dog shaped container of the design; and,
FIG. 7 is a perspective rear view of a dog shaped container of the design.

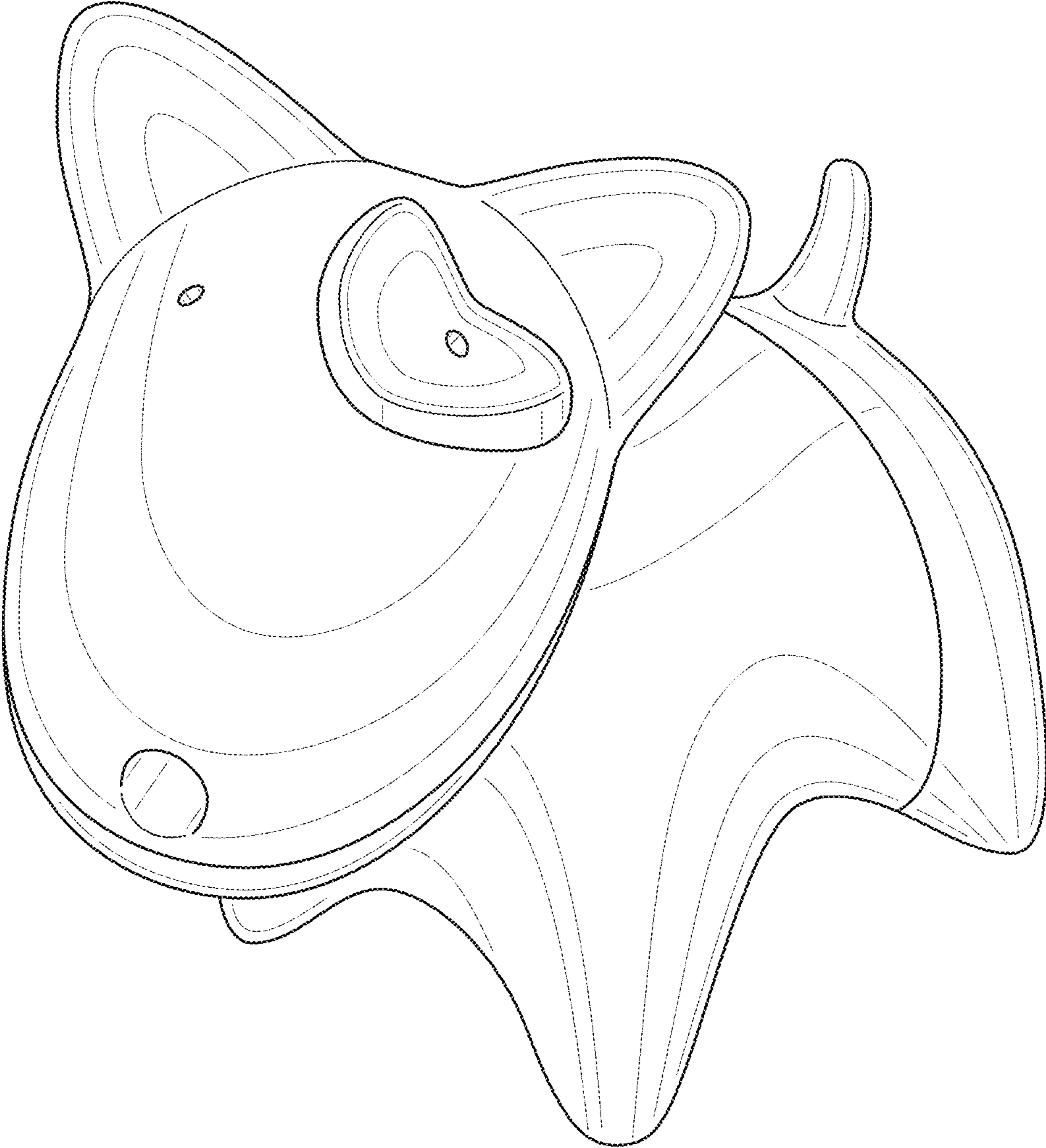

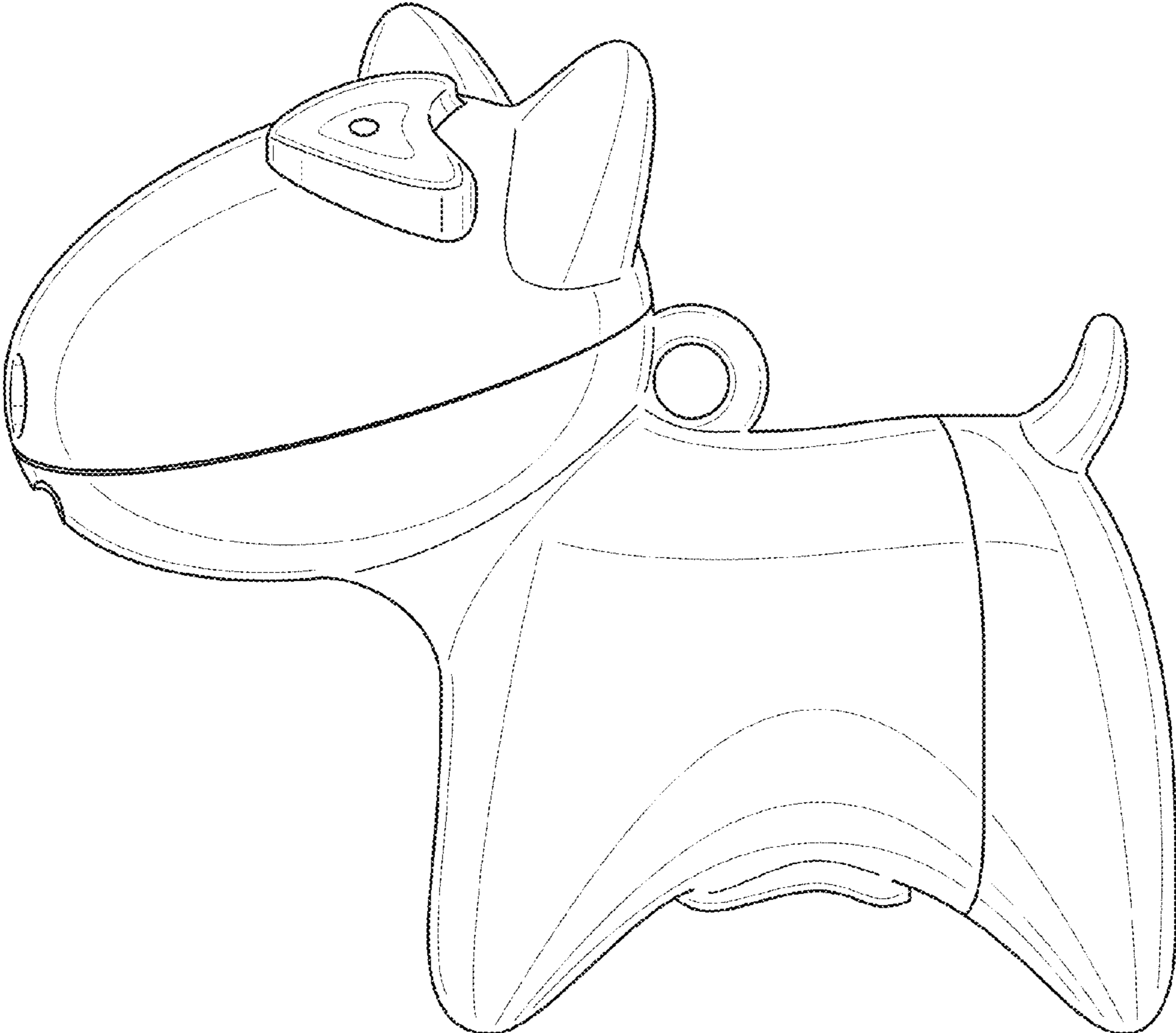

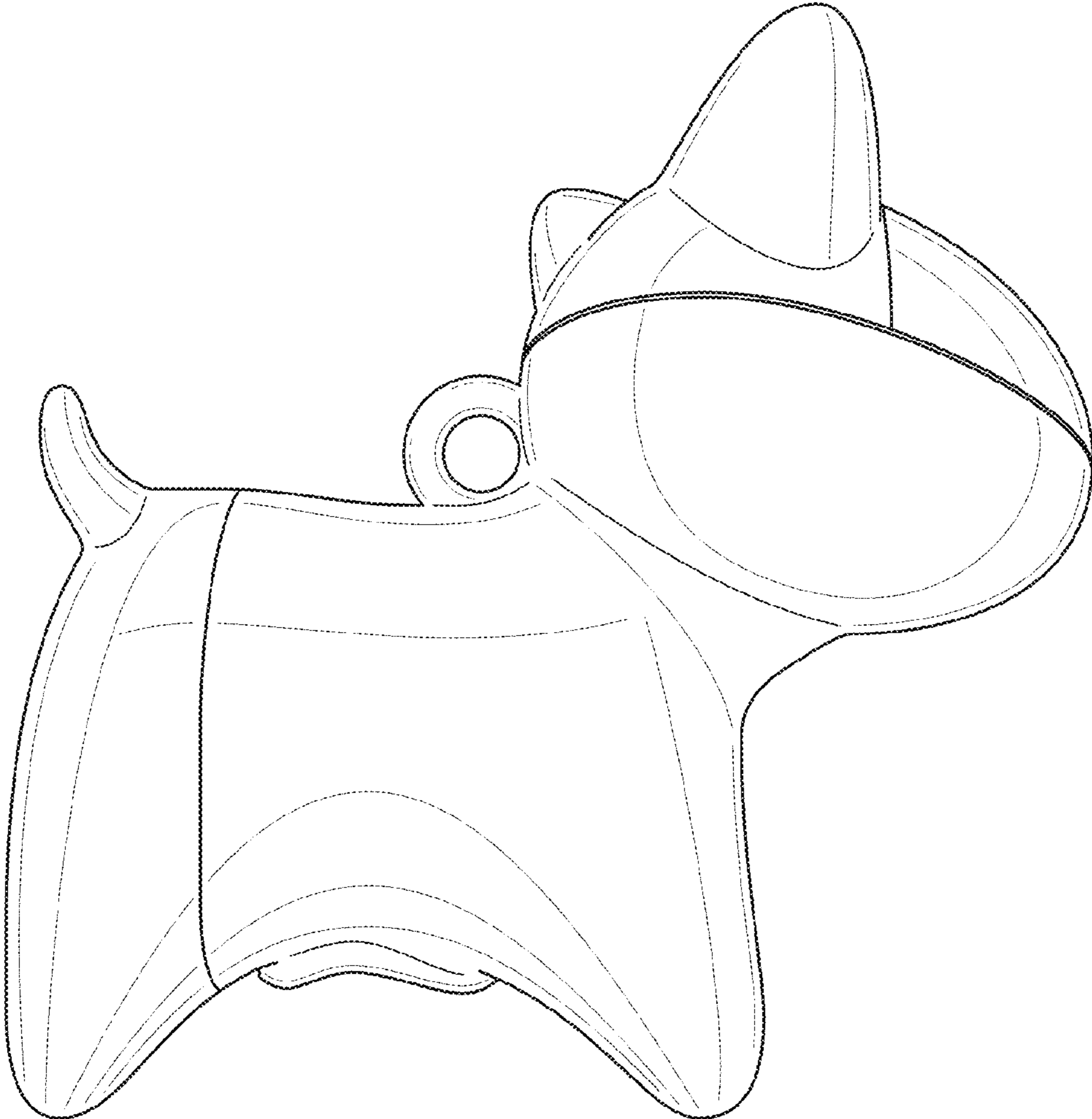

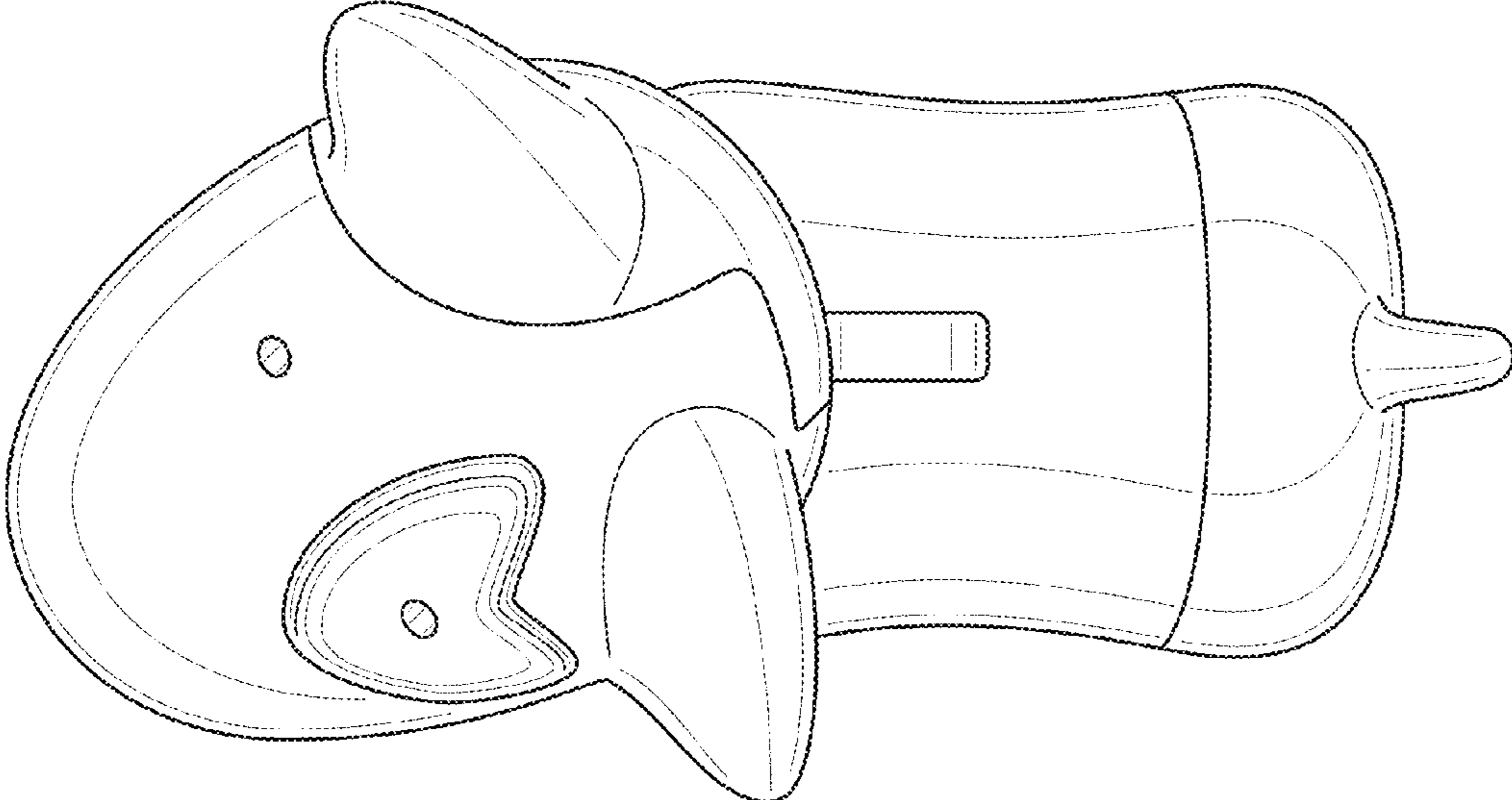

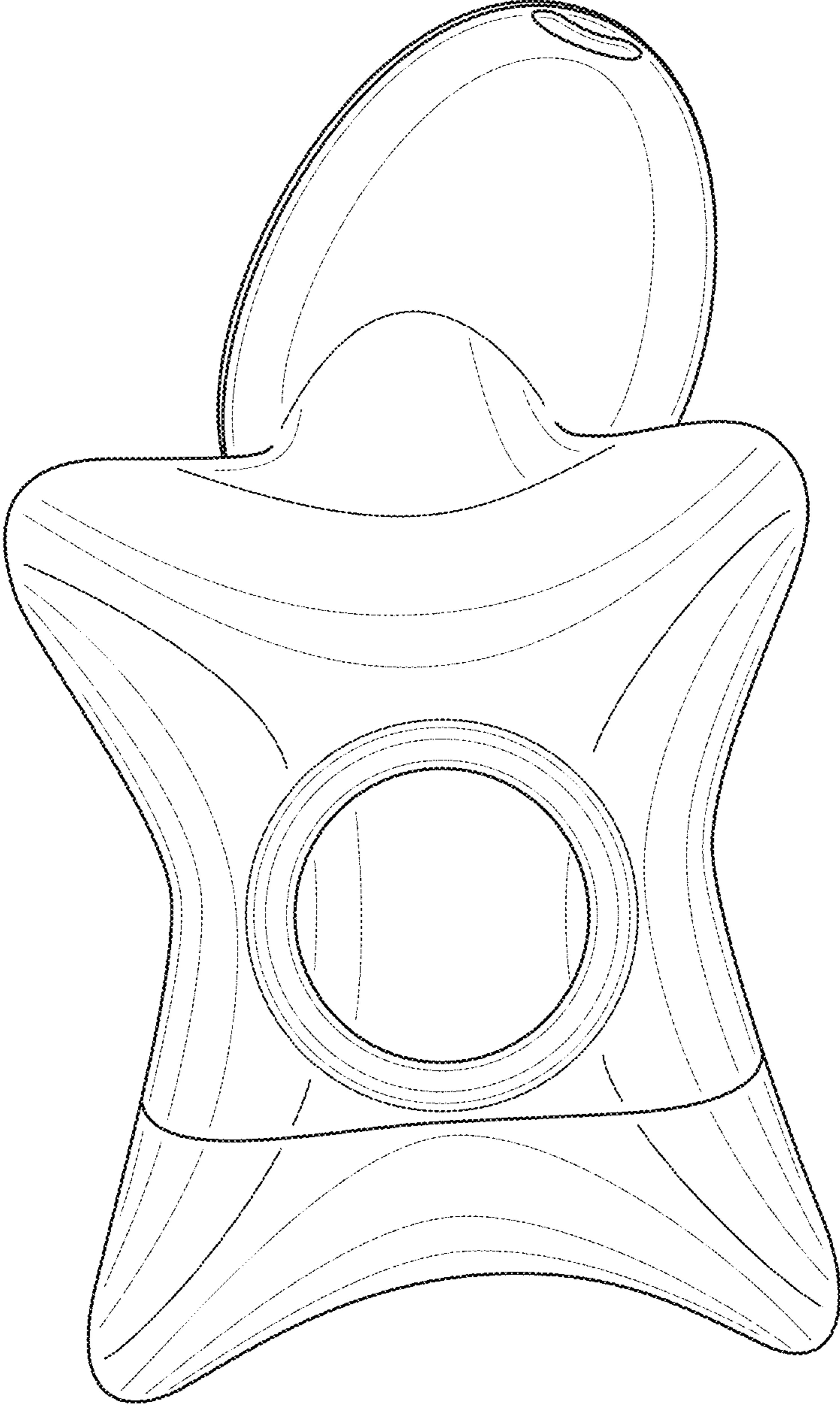

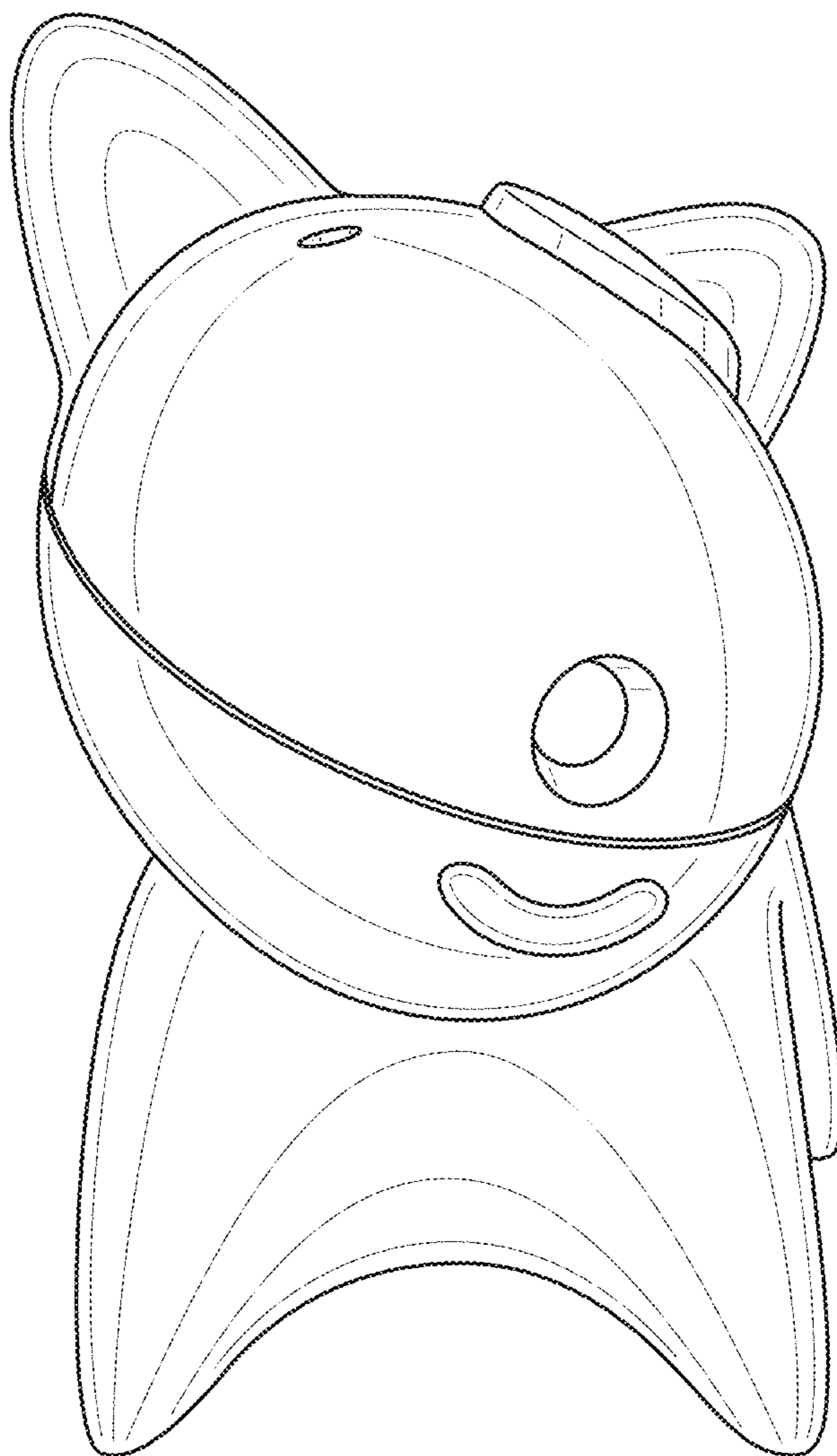

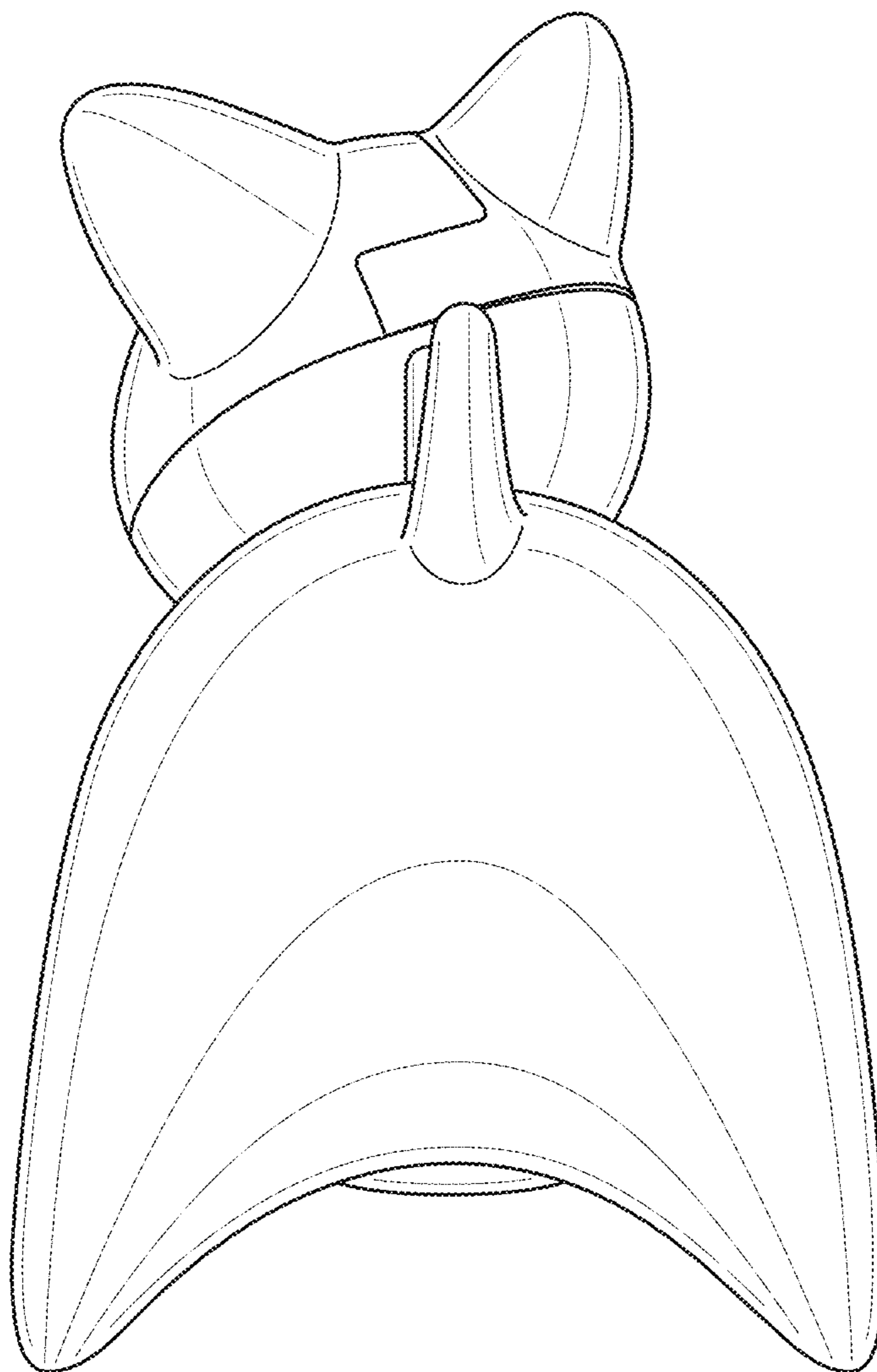
