FIG. 6 is a right side elevational view of the finger ring of FIG.

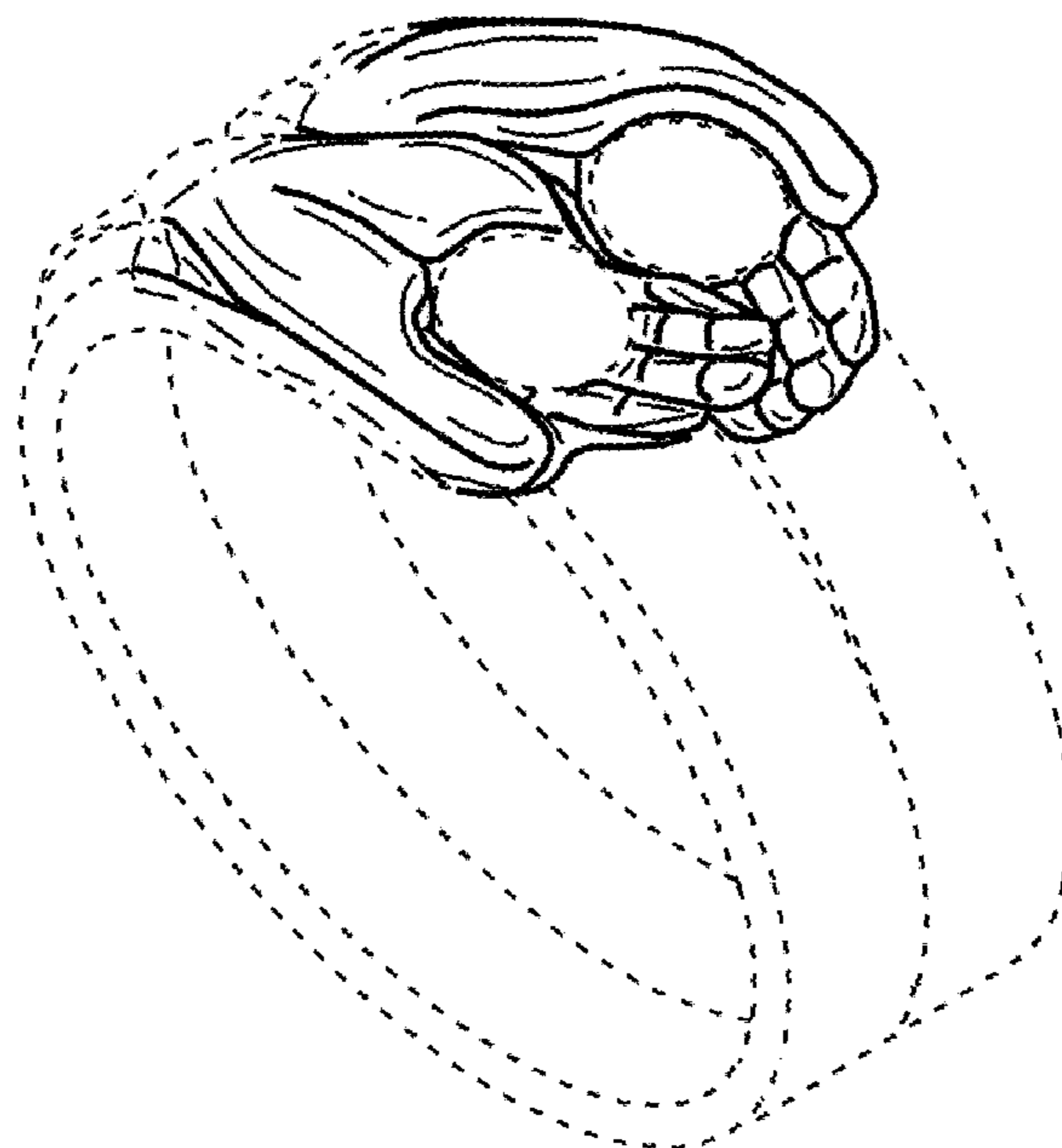

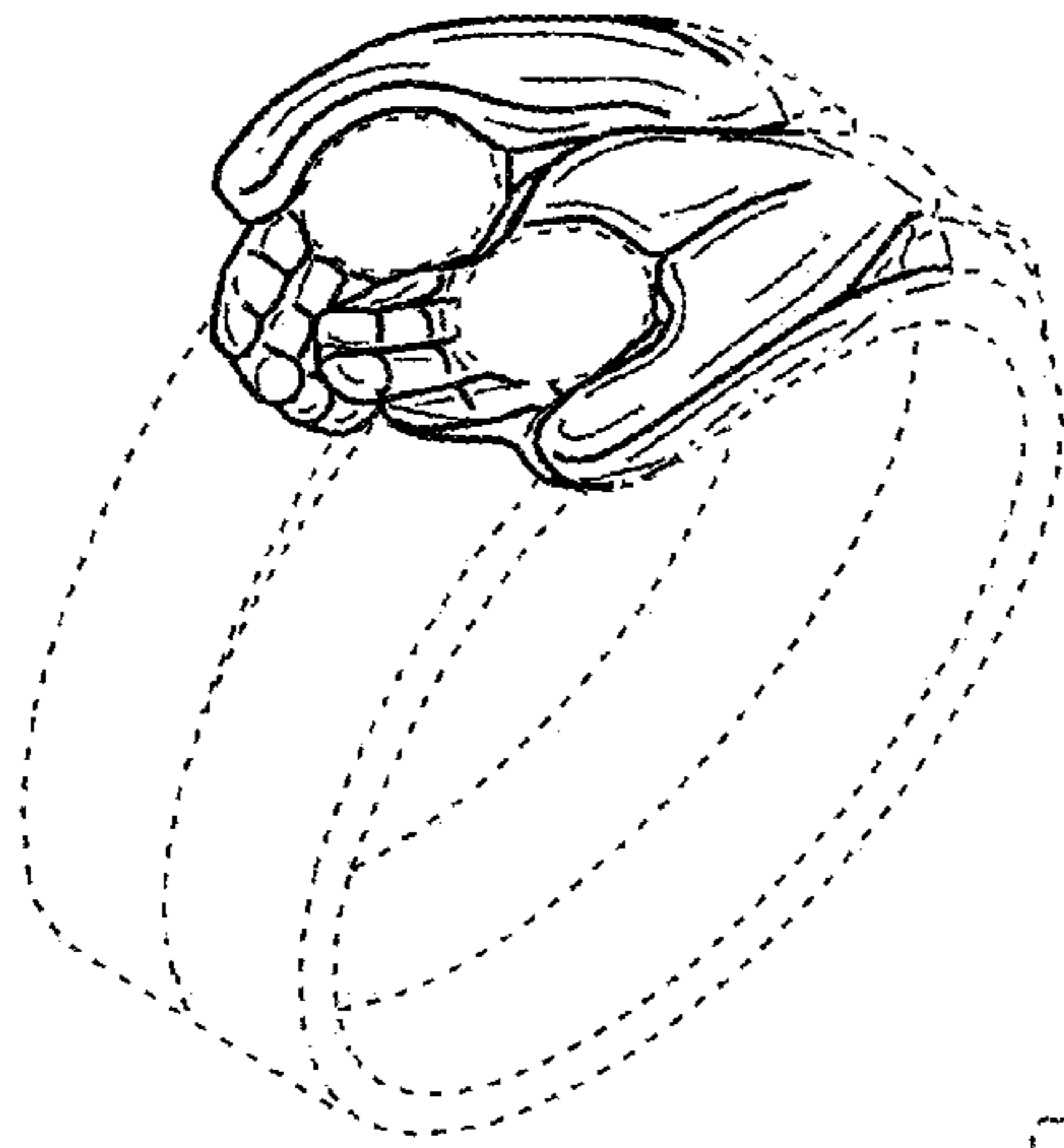

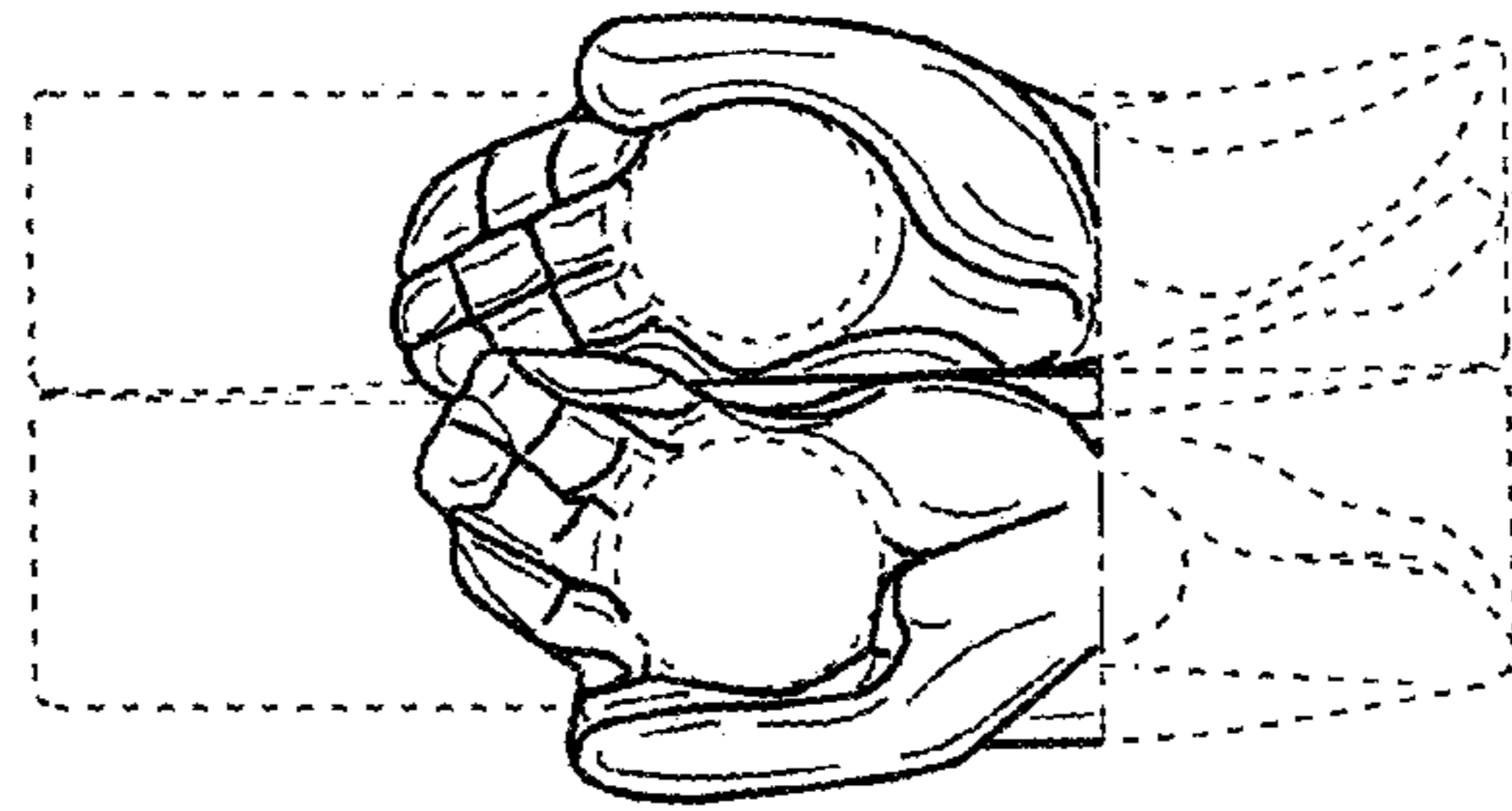

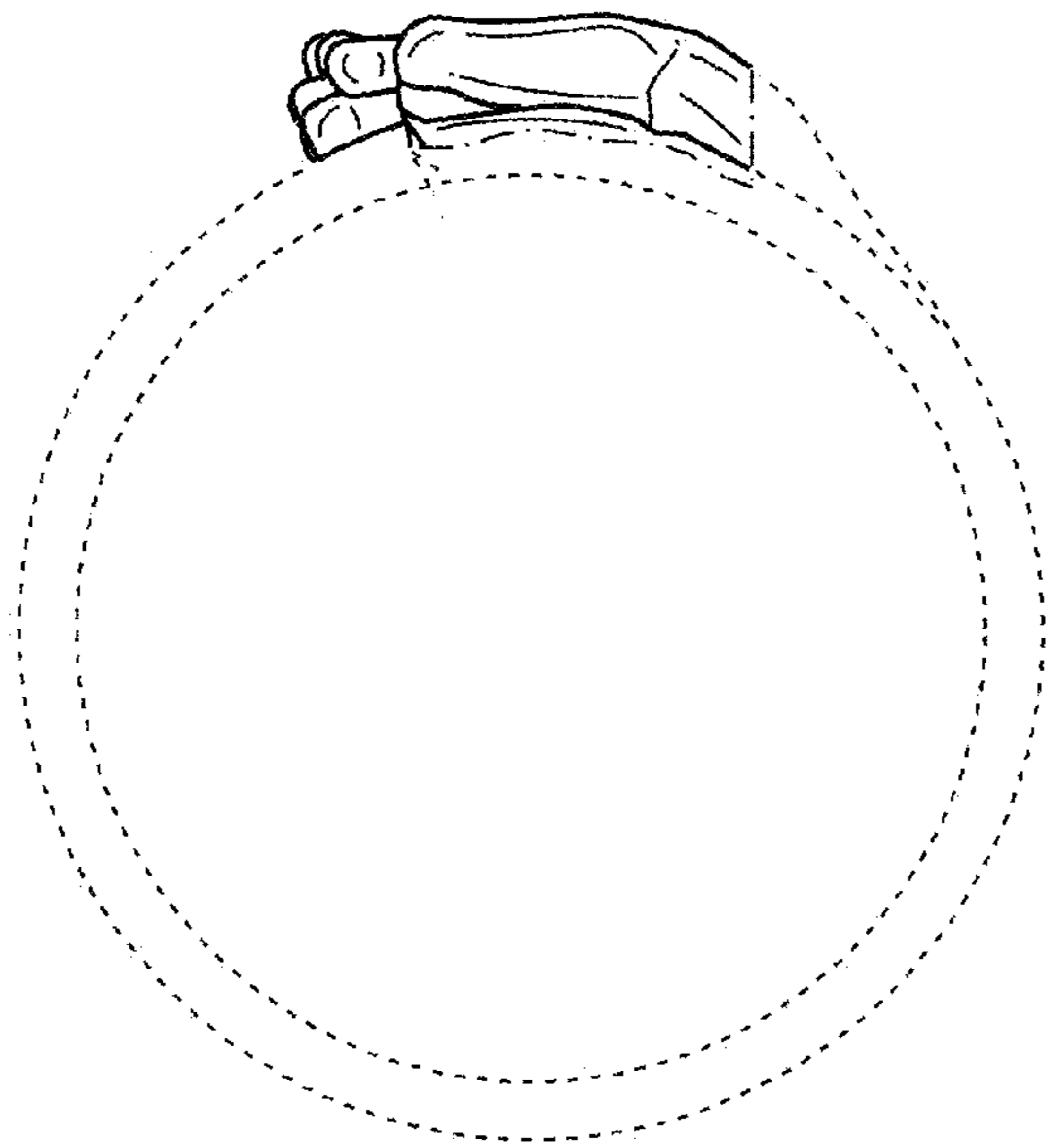

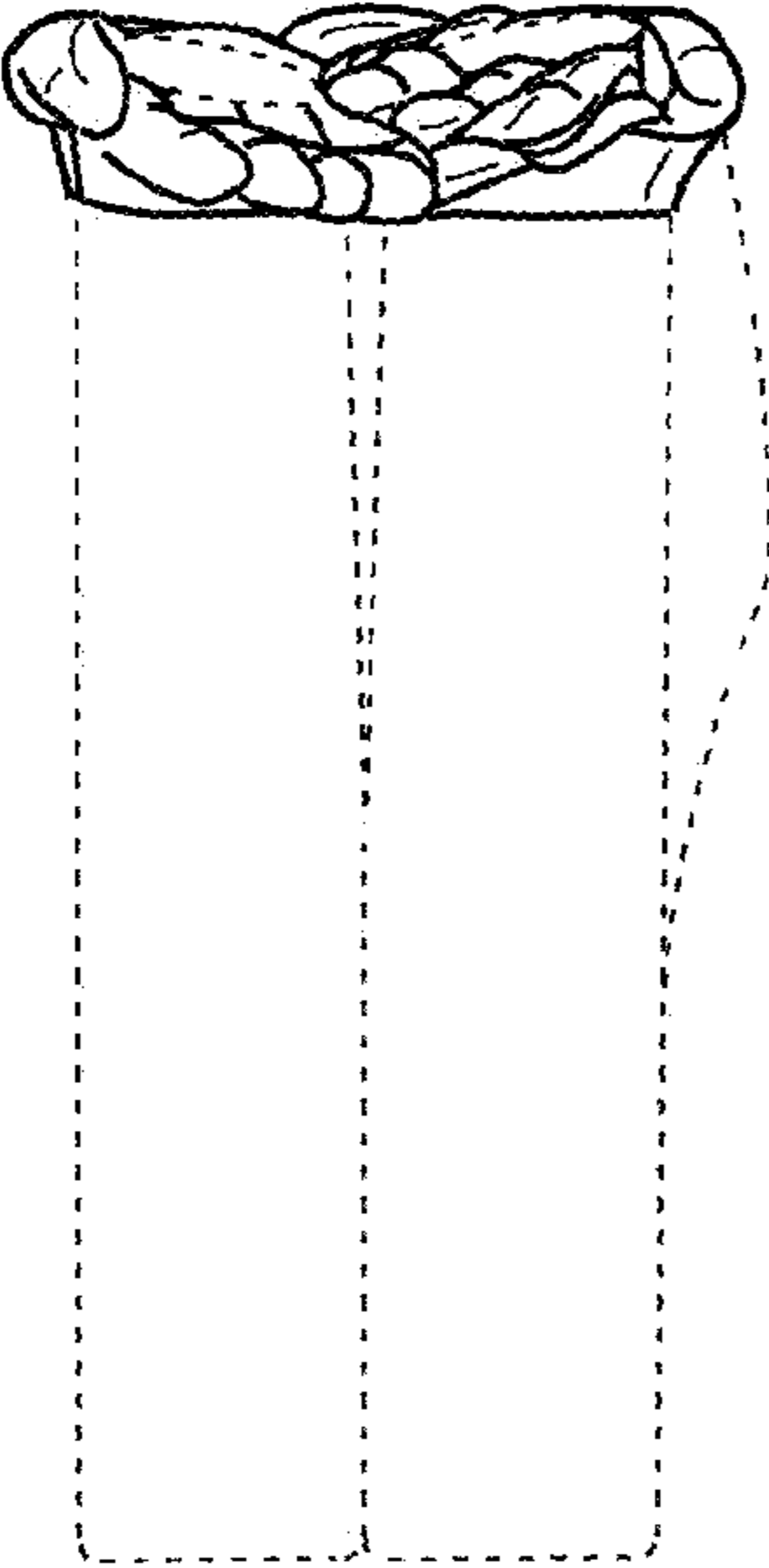
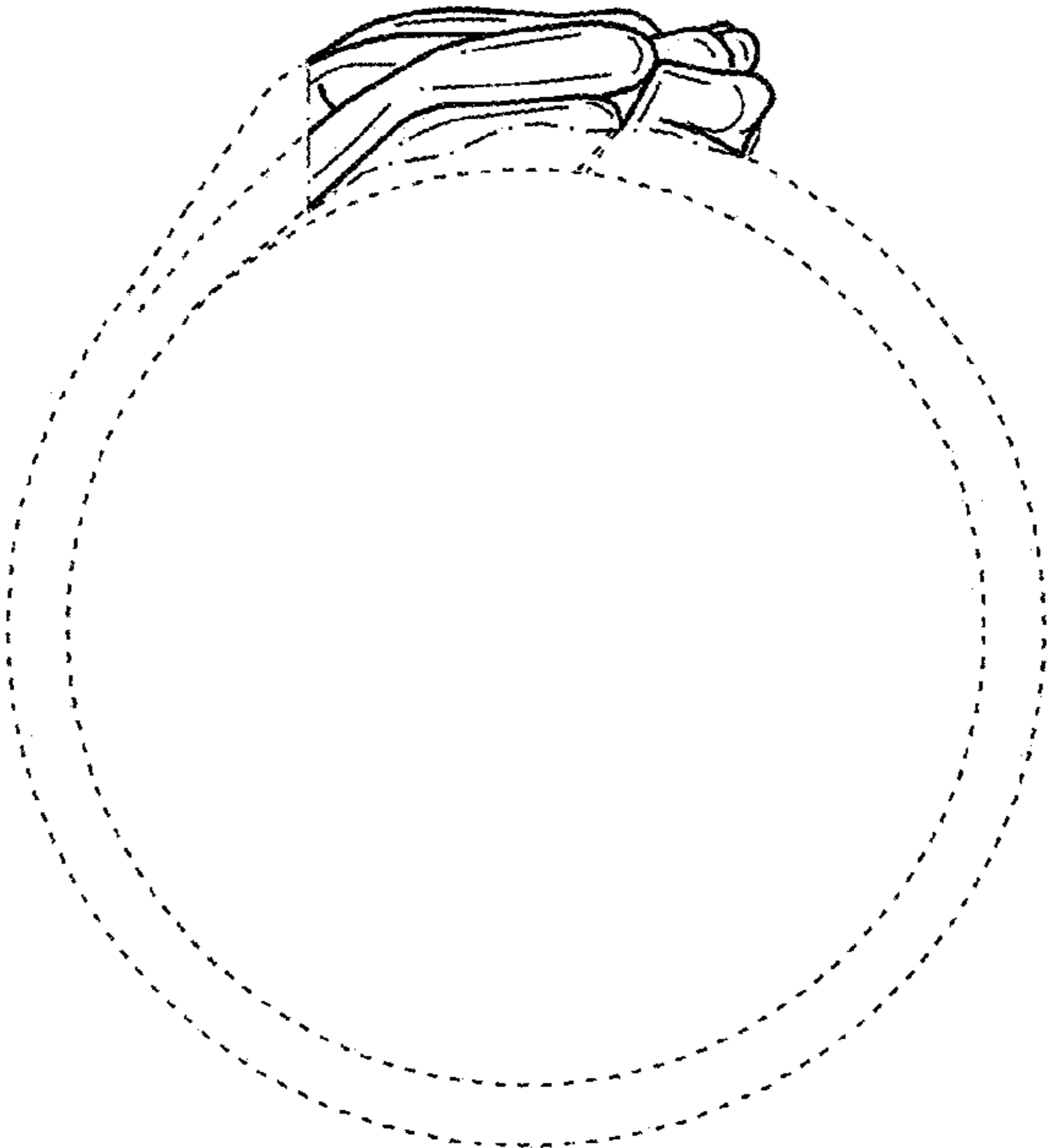

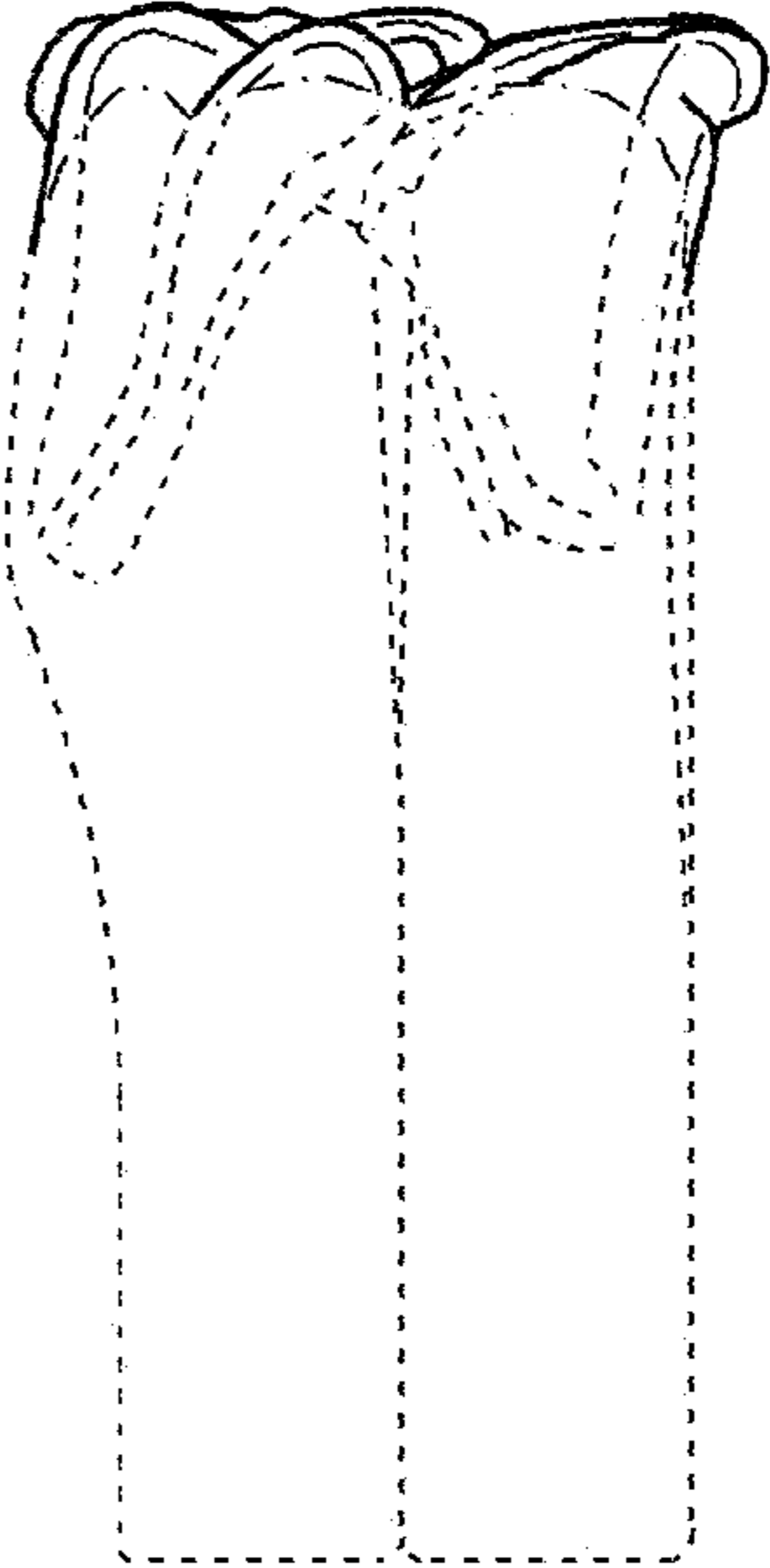

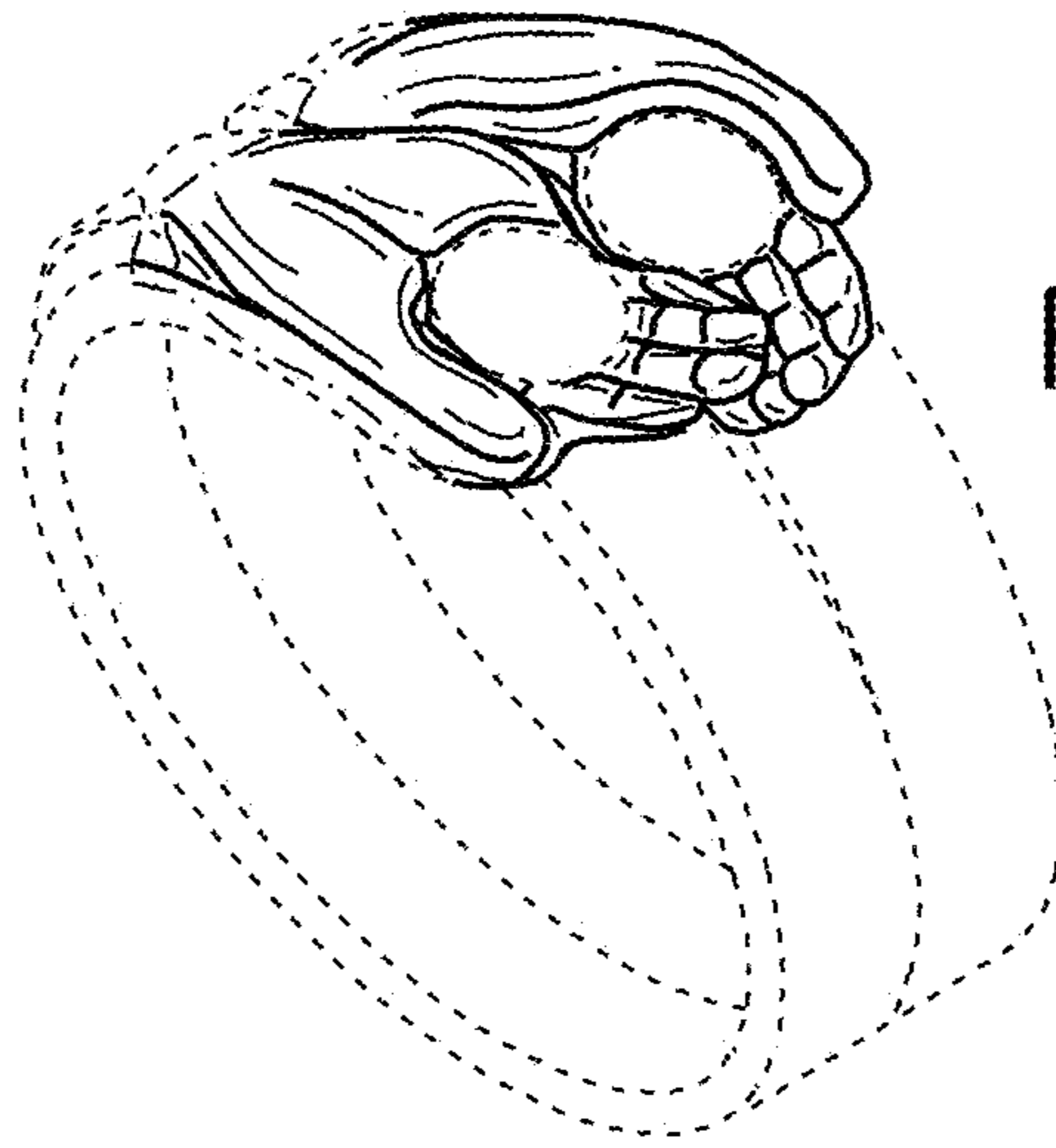

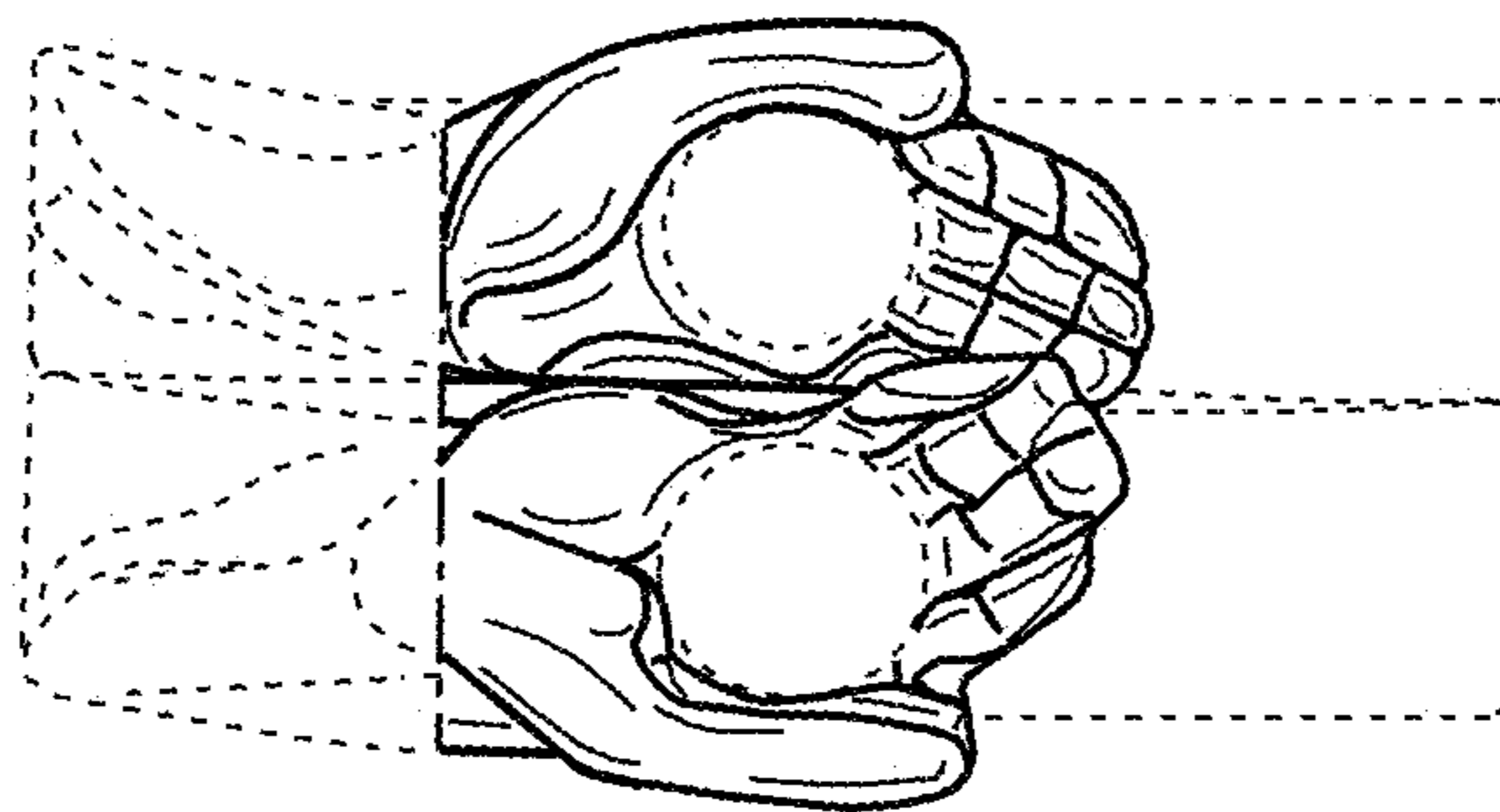
