FIG. 4 is a left view of a gemstone.

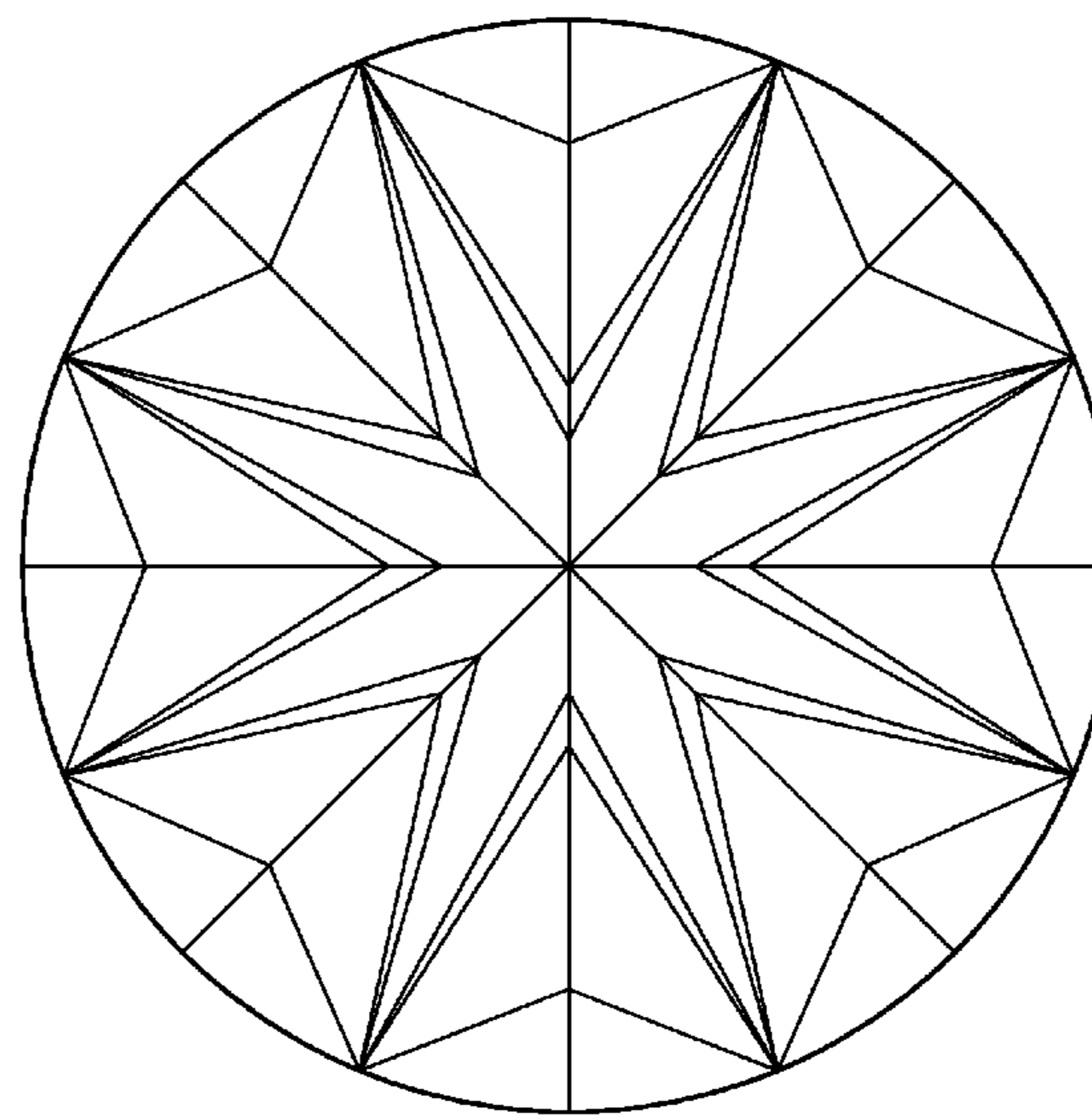
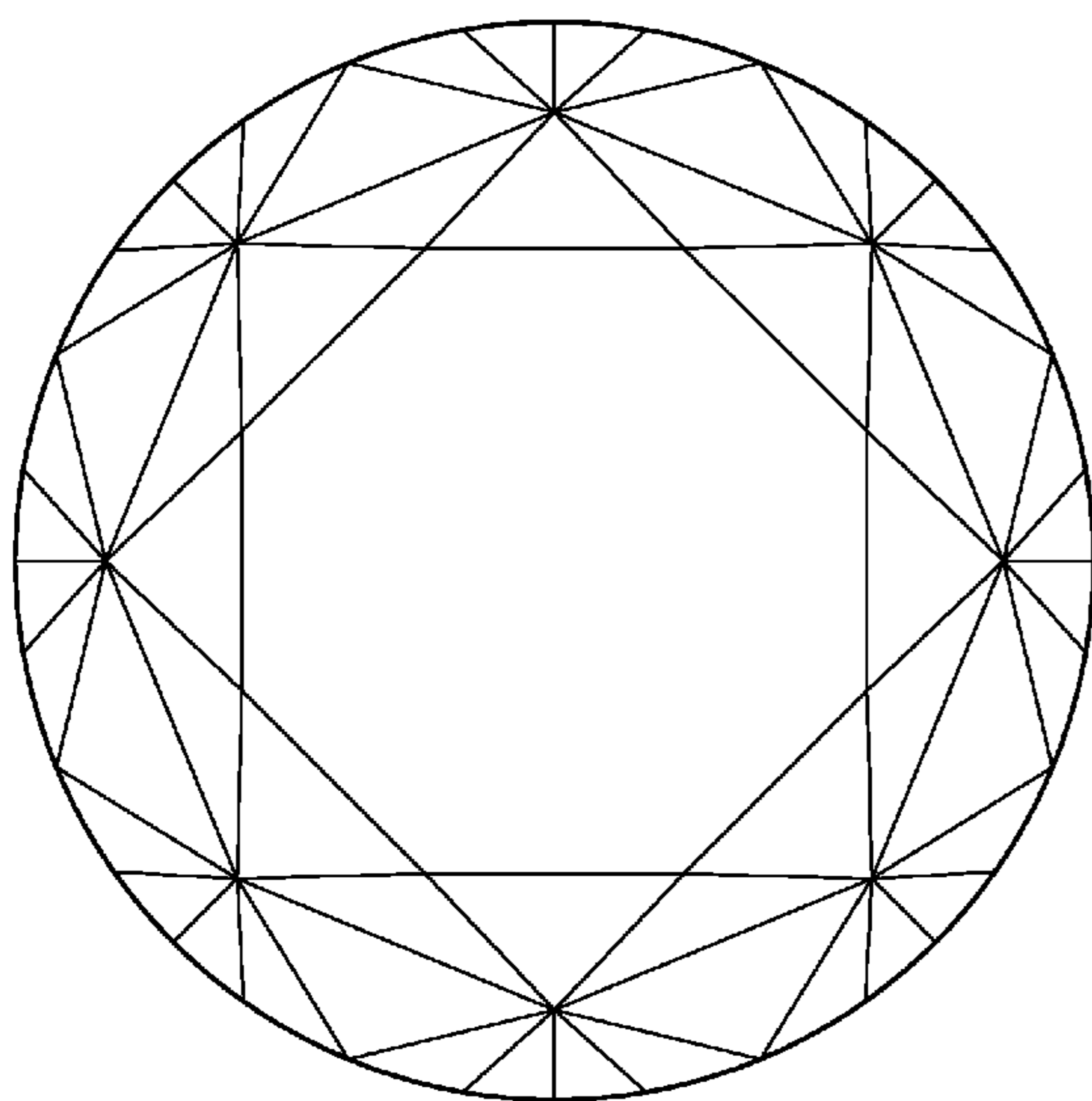
FIG. 5 is a right view of a gemstone.

FIG. 6 is a front view of a gemstone.

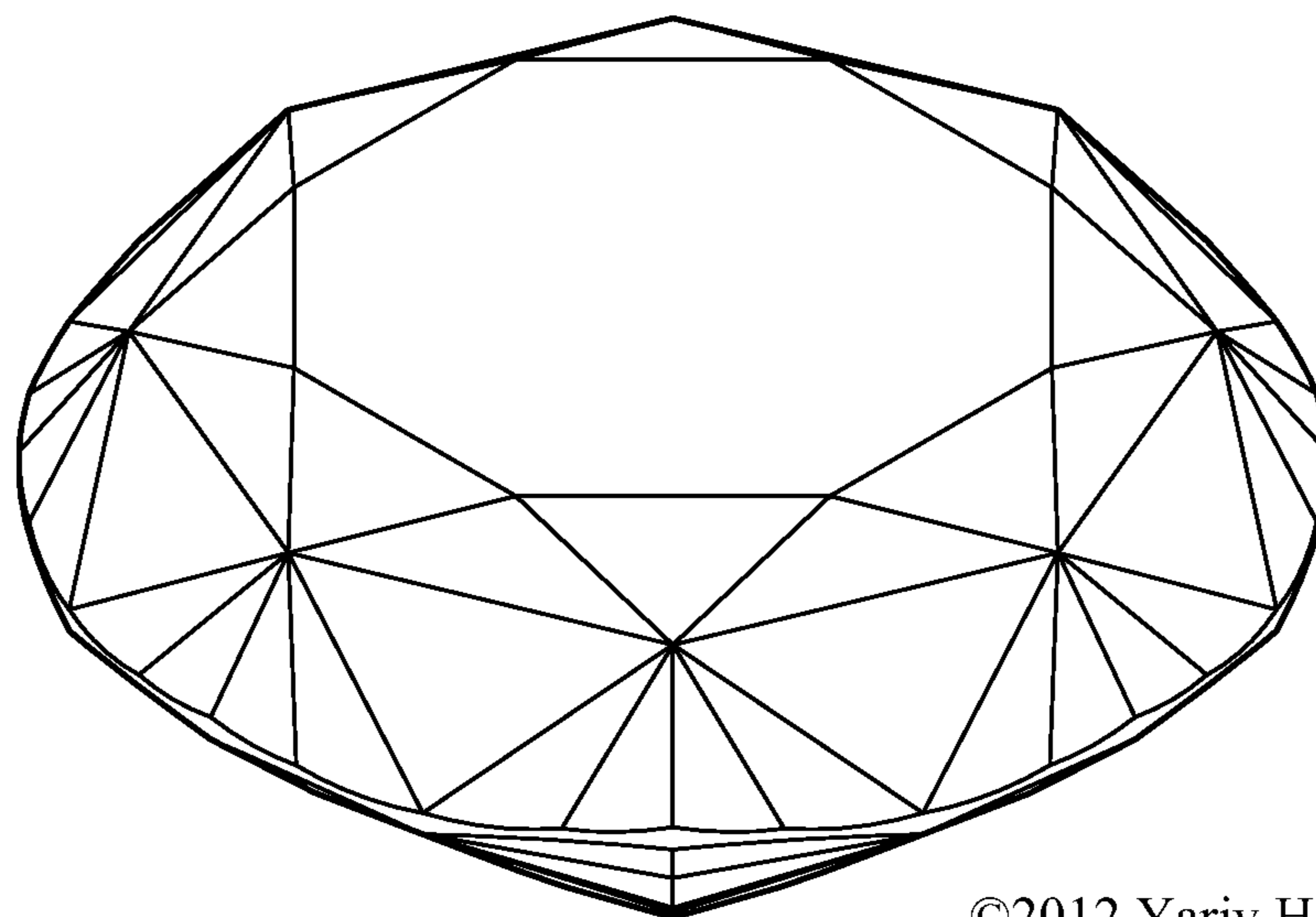
FIG. 7 is a back view of a gemstone; and,

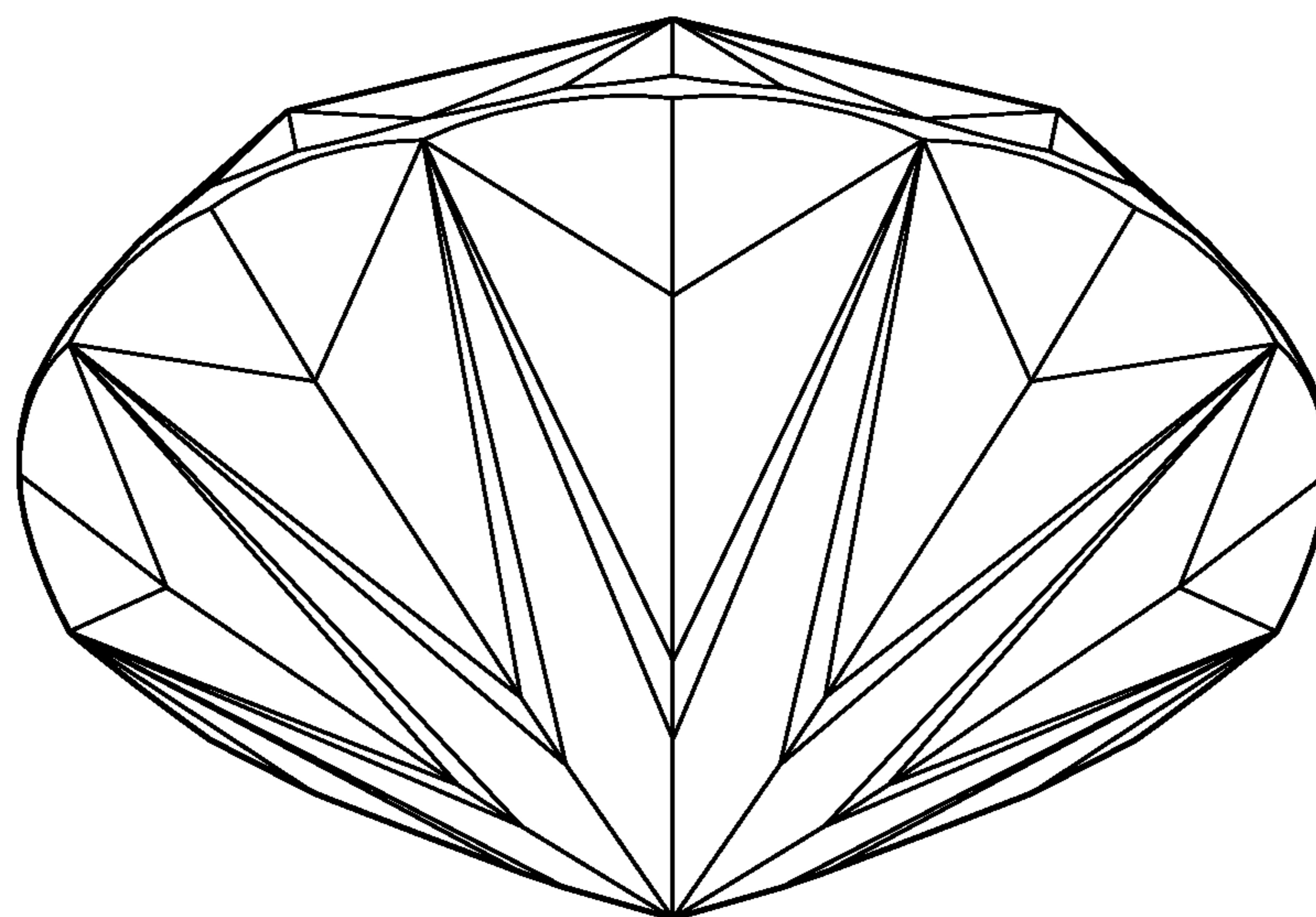

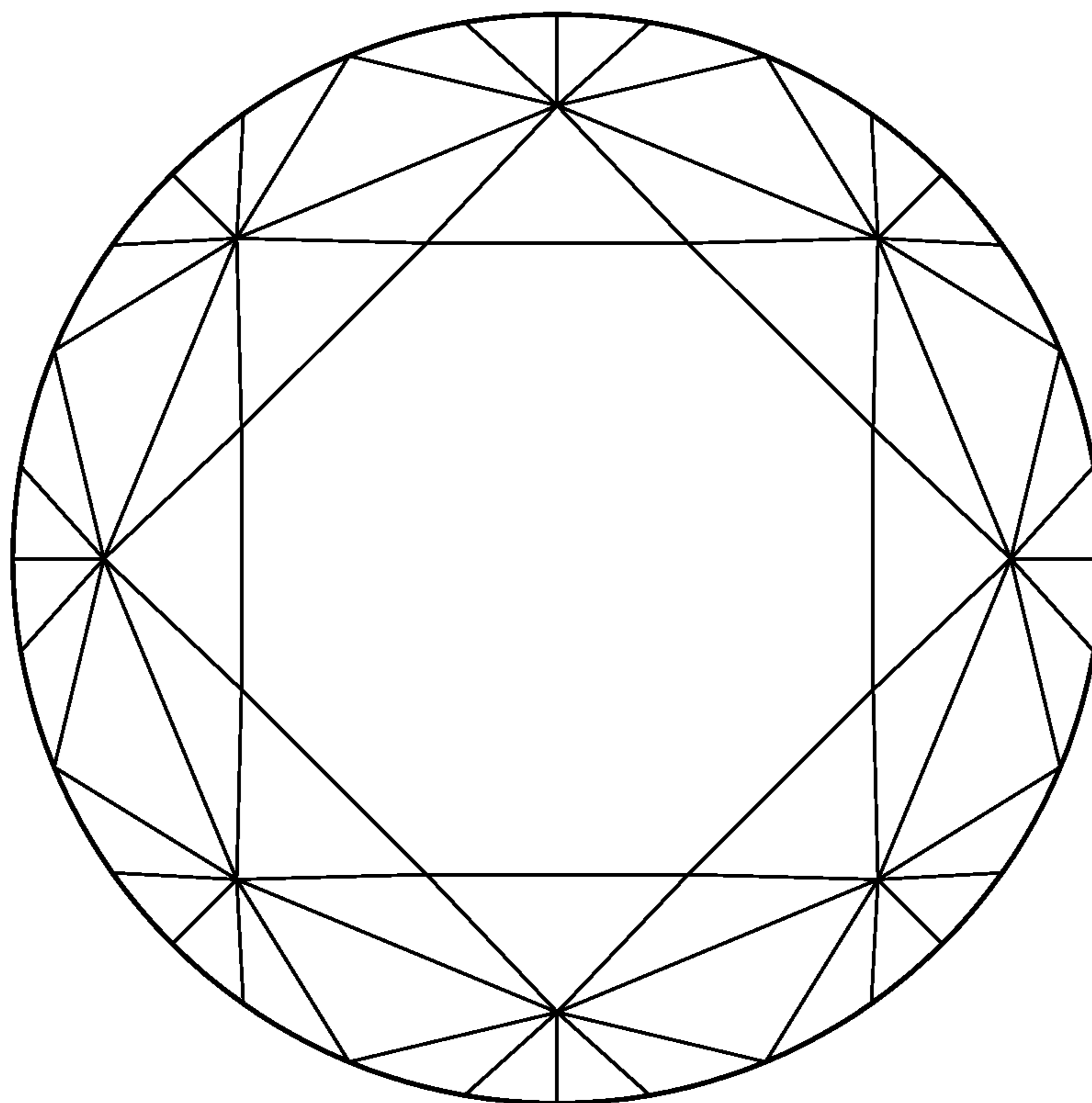

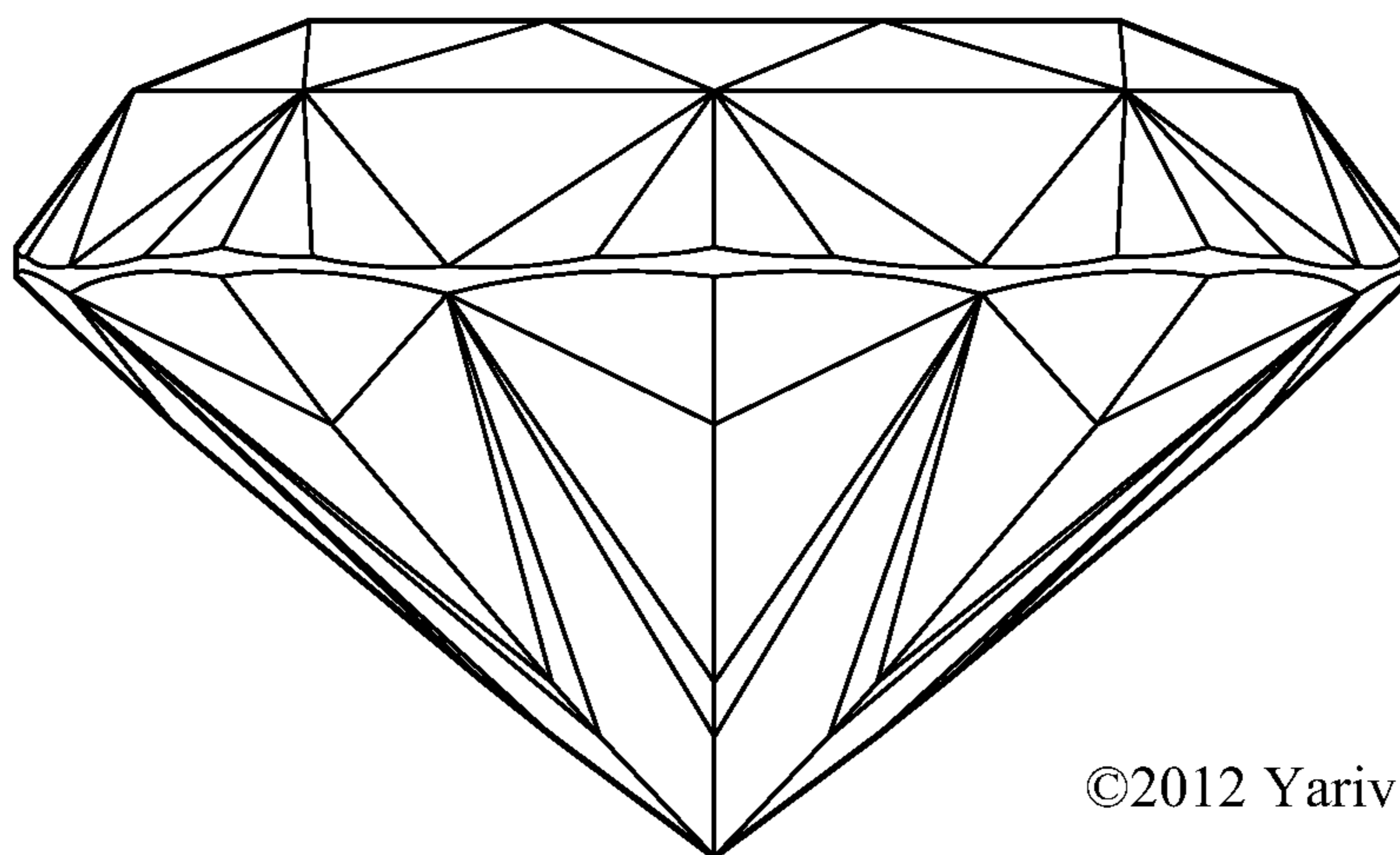

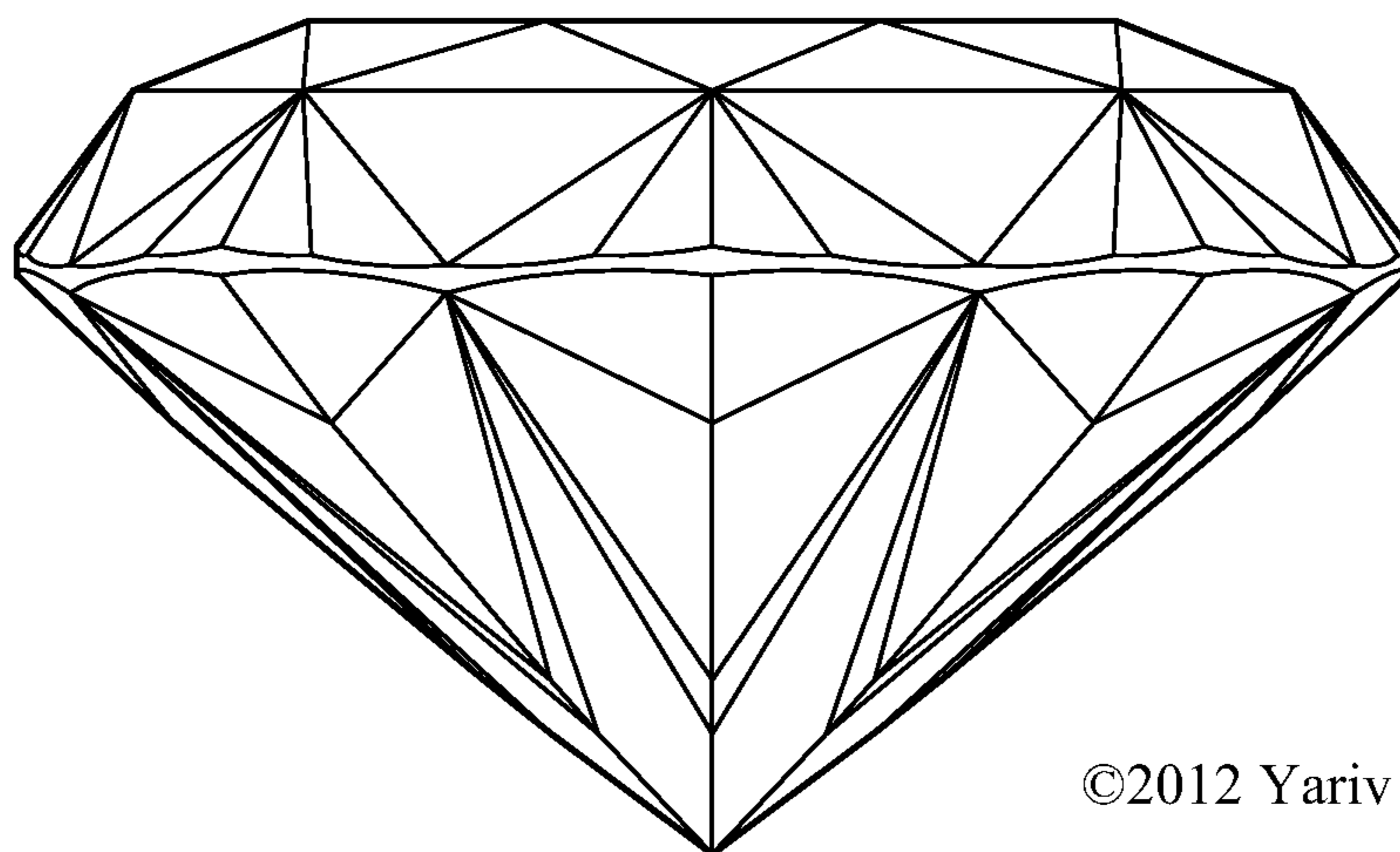

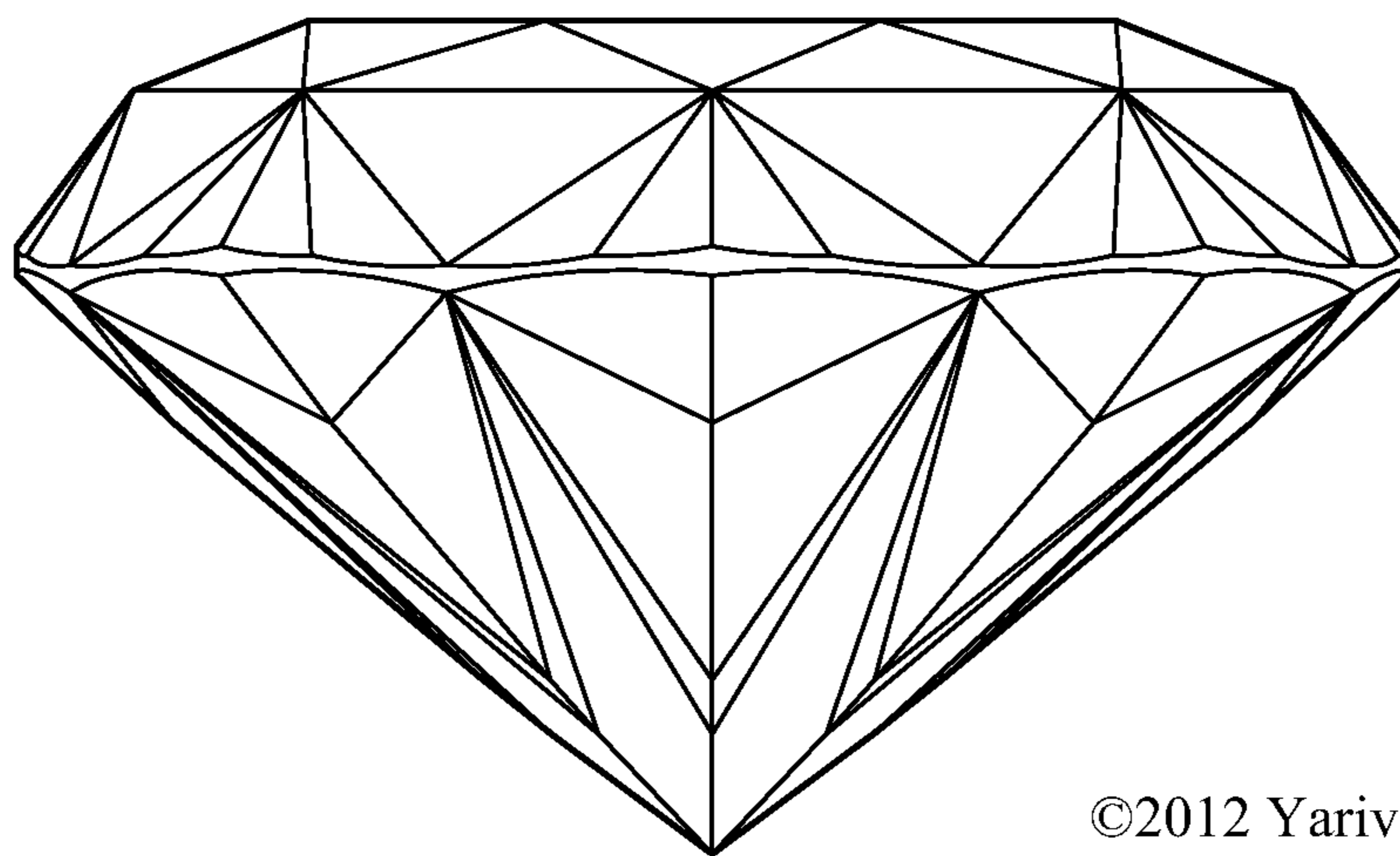

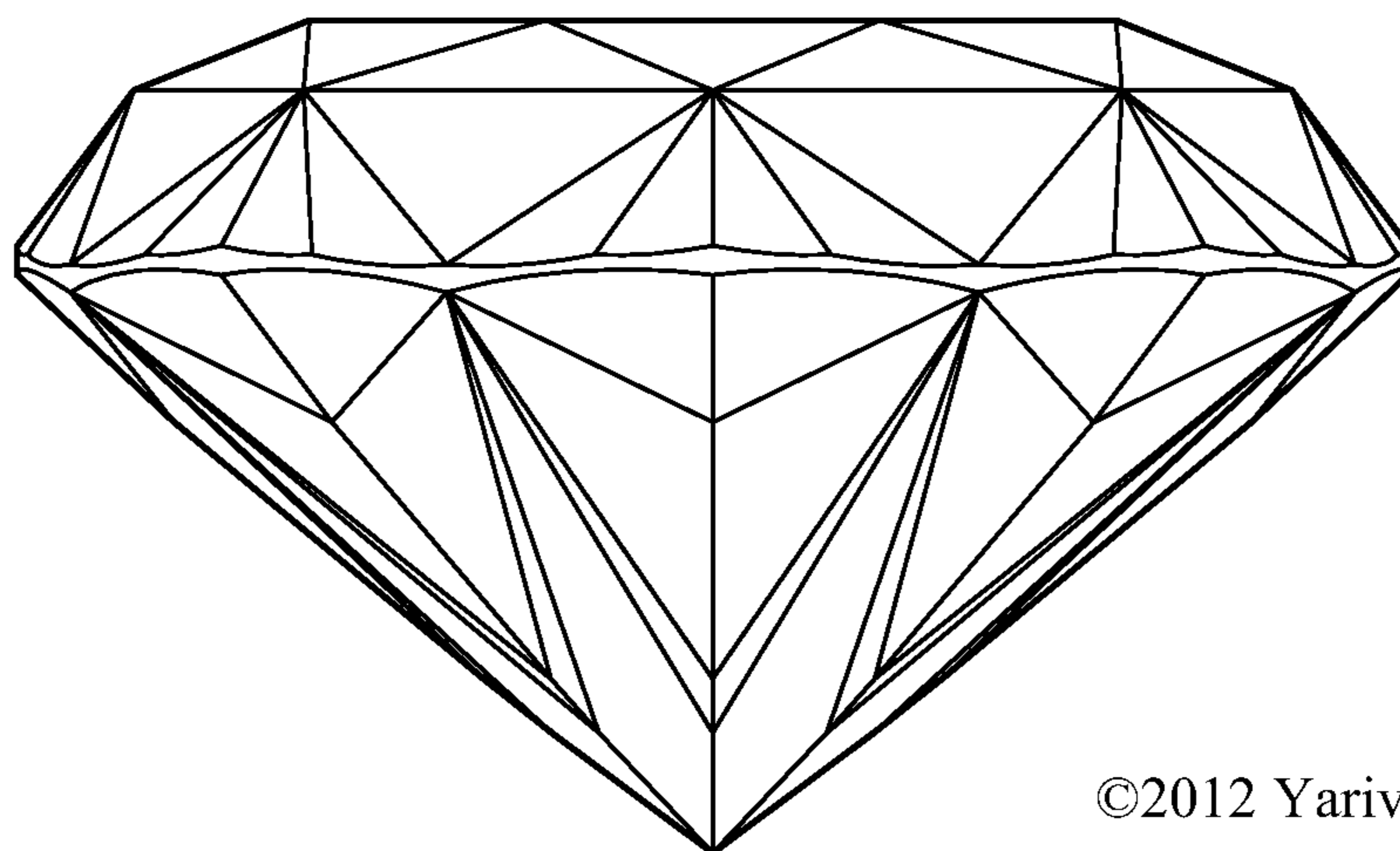

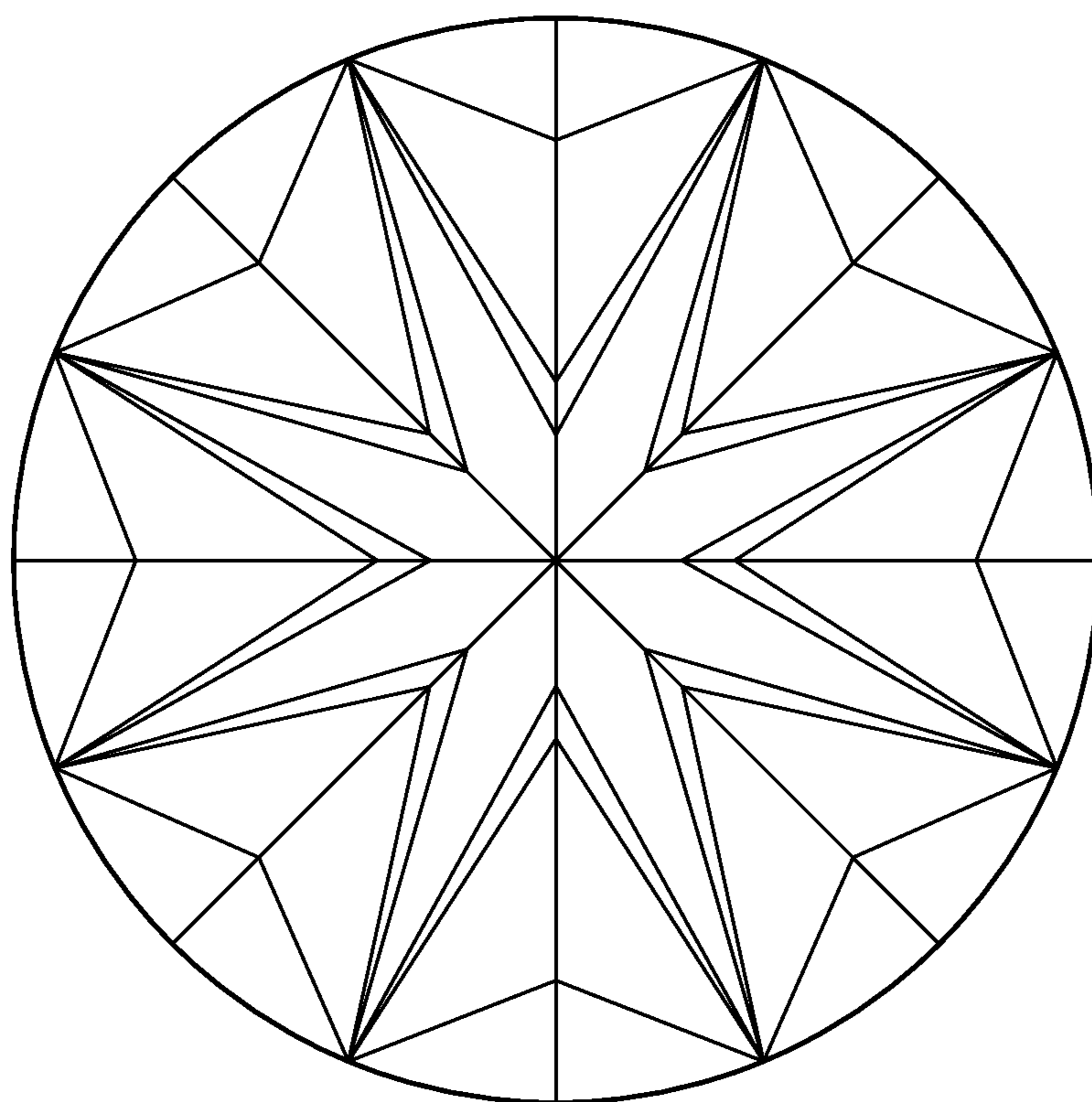
