(57) **CLAIM**

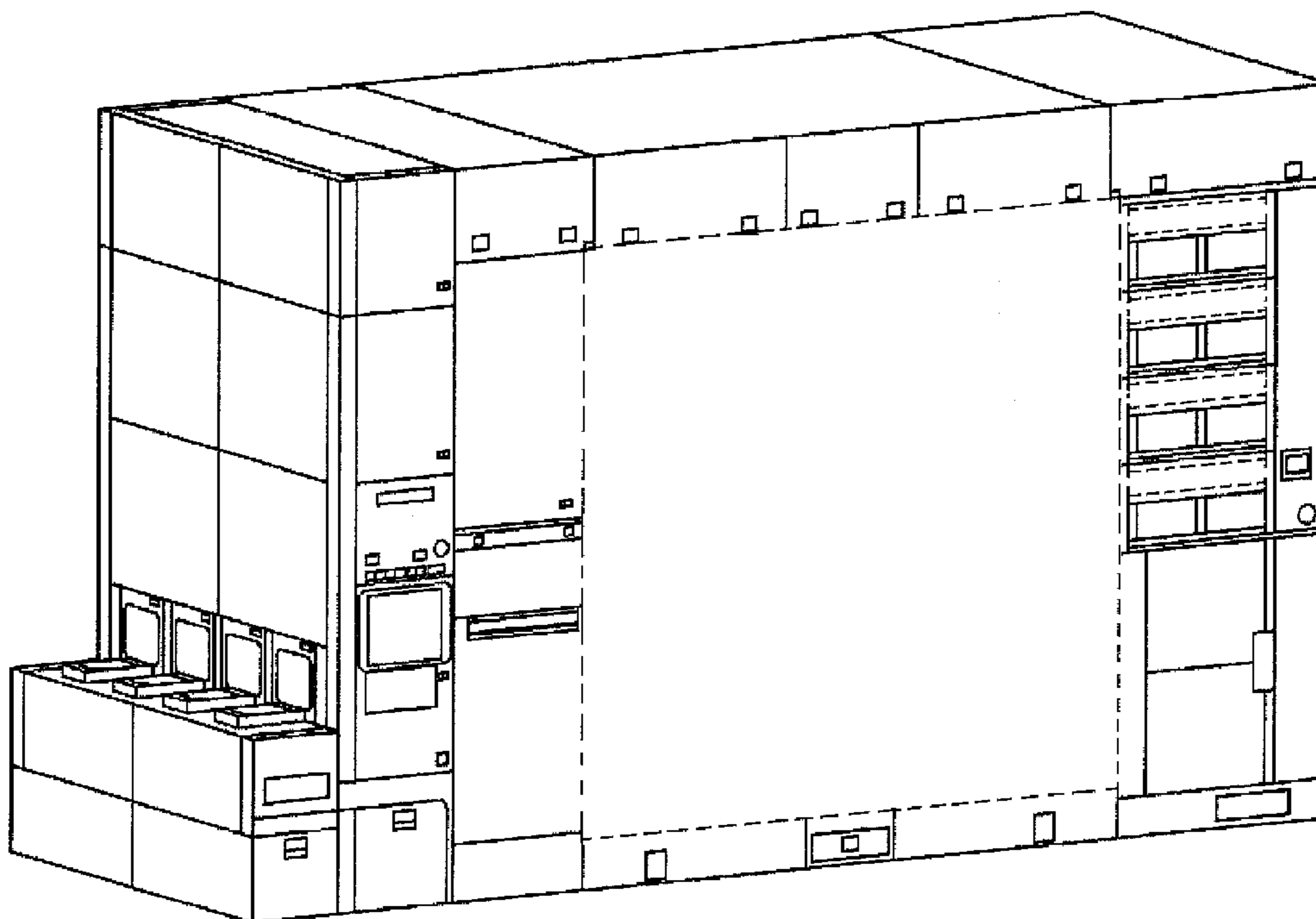
The ornamental design for a coating and developing apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a front, left and top perspective view of the coating and developing apparatus showing the new design; FIG. 2 is a rear, right and top perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; and, FIG. 7 is a top plan view thereof.

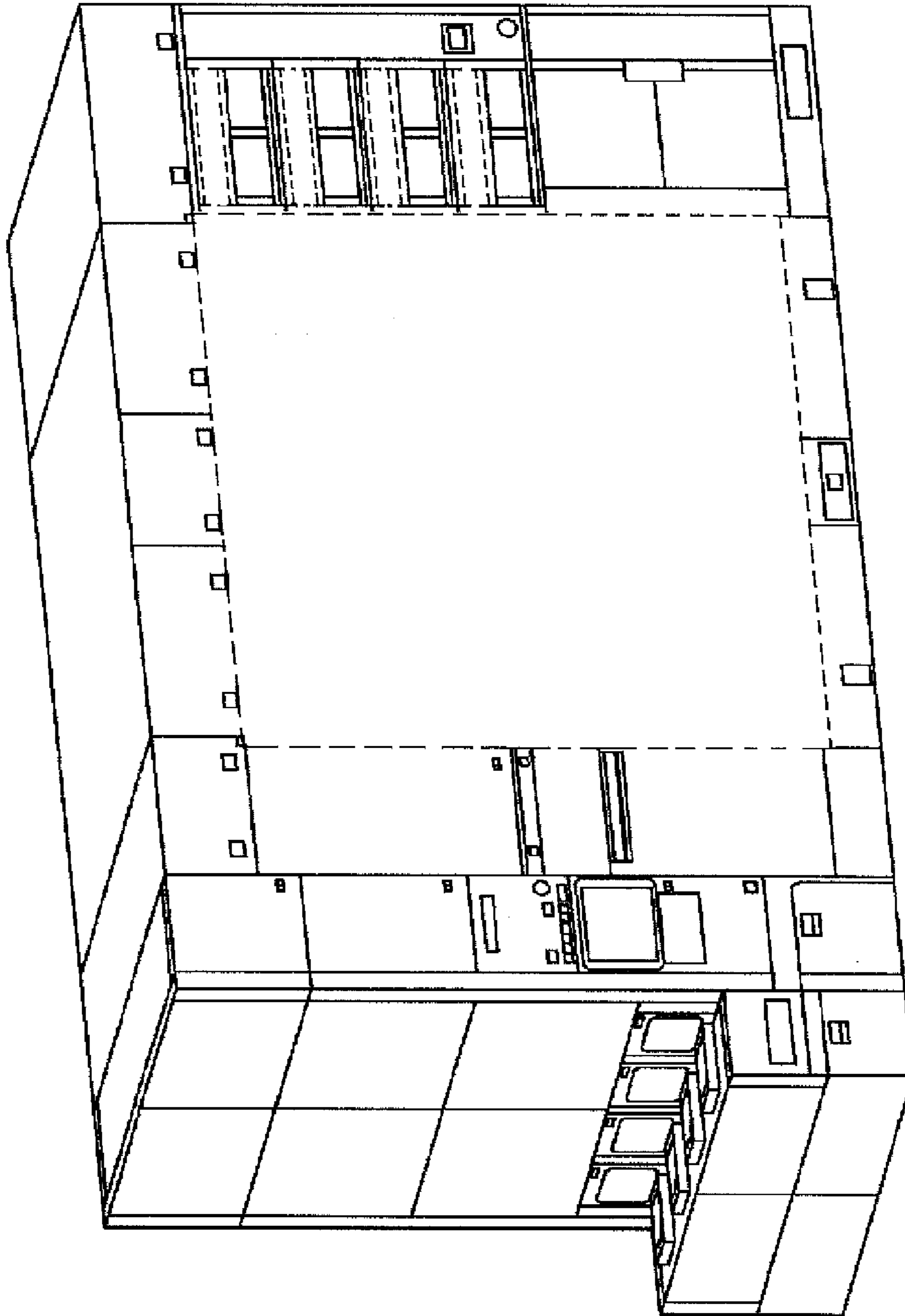

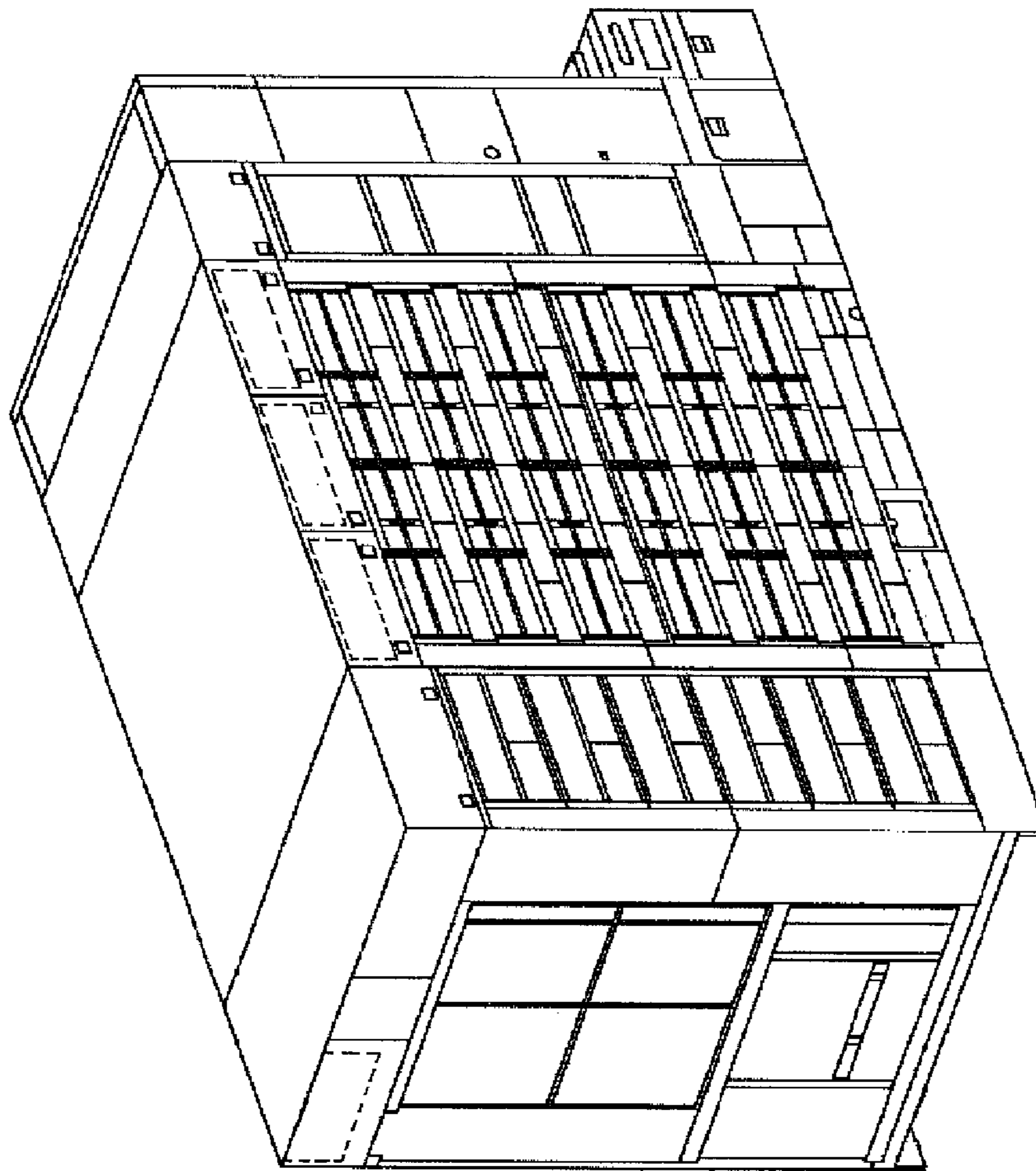

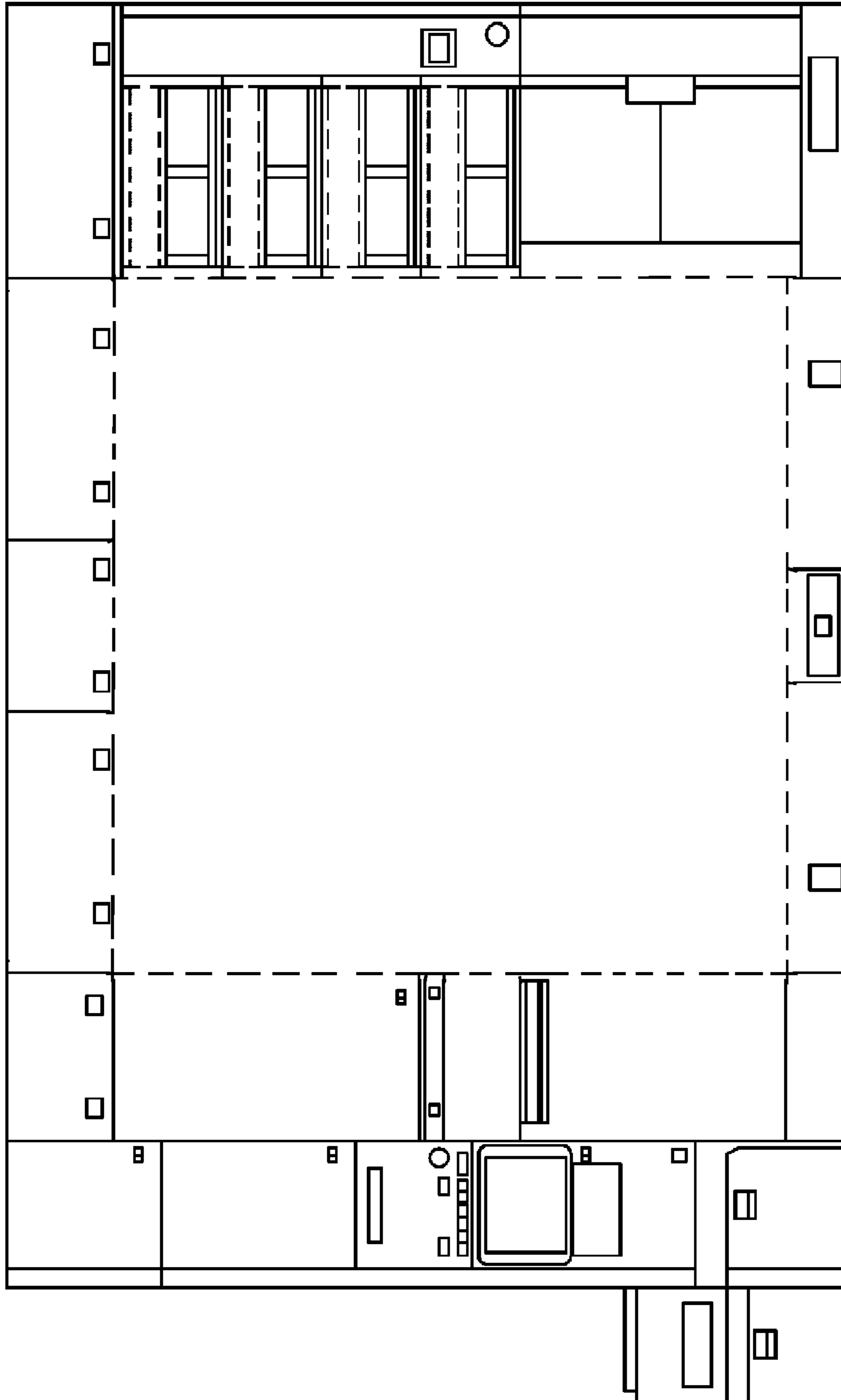

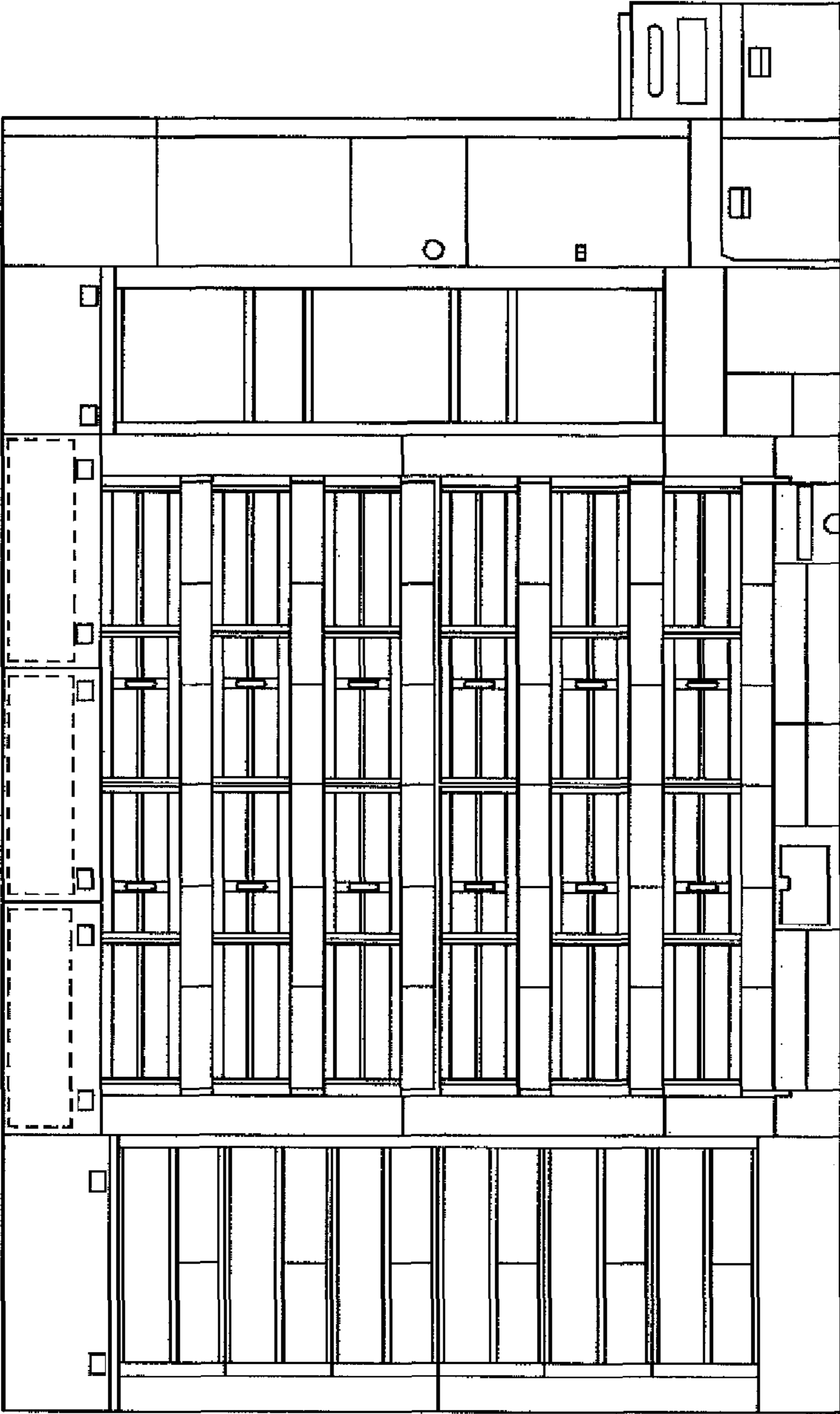

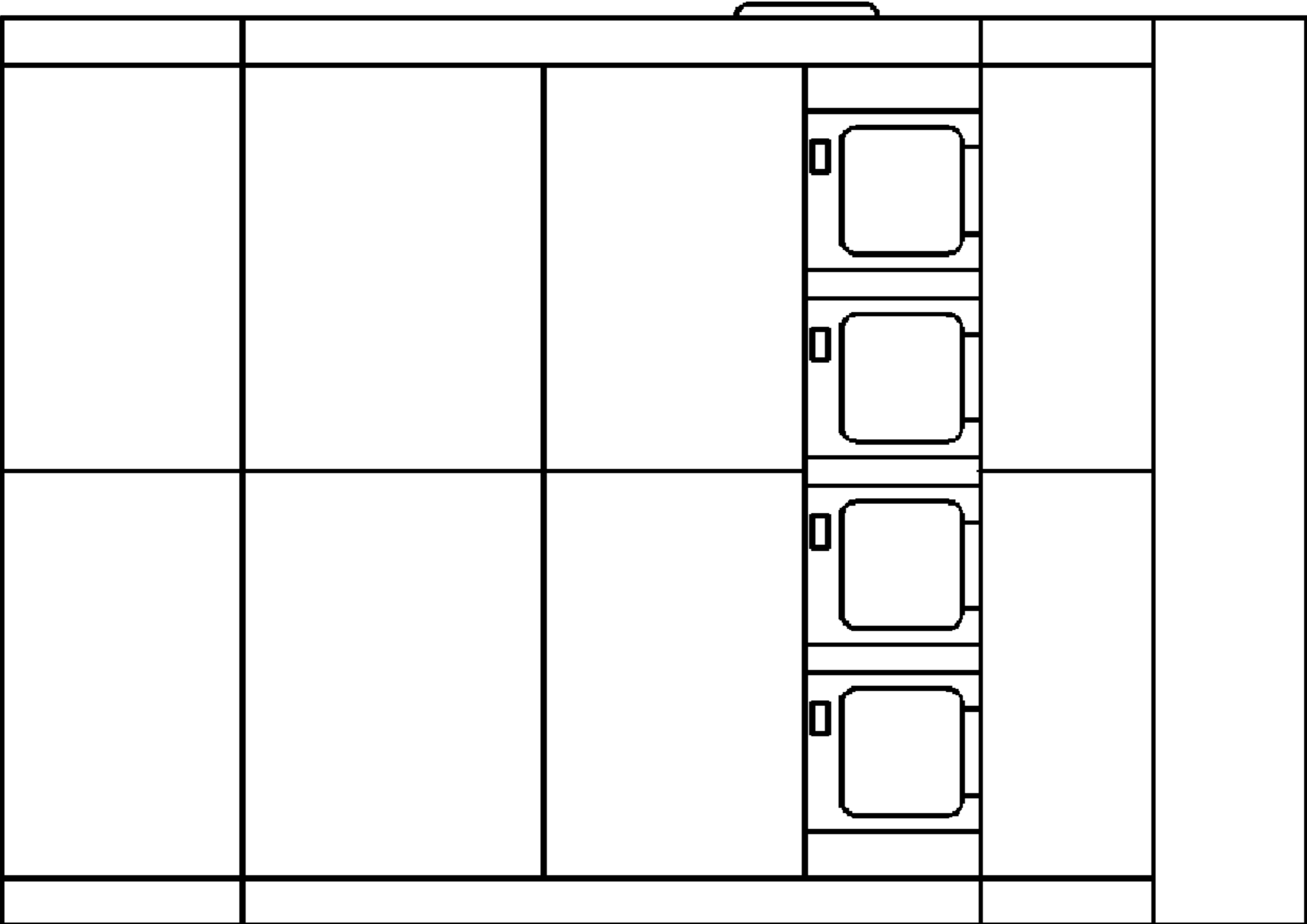

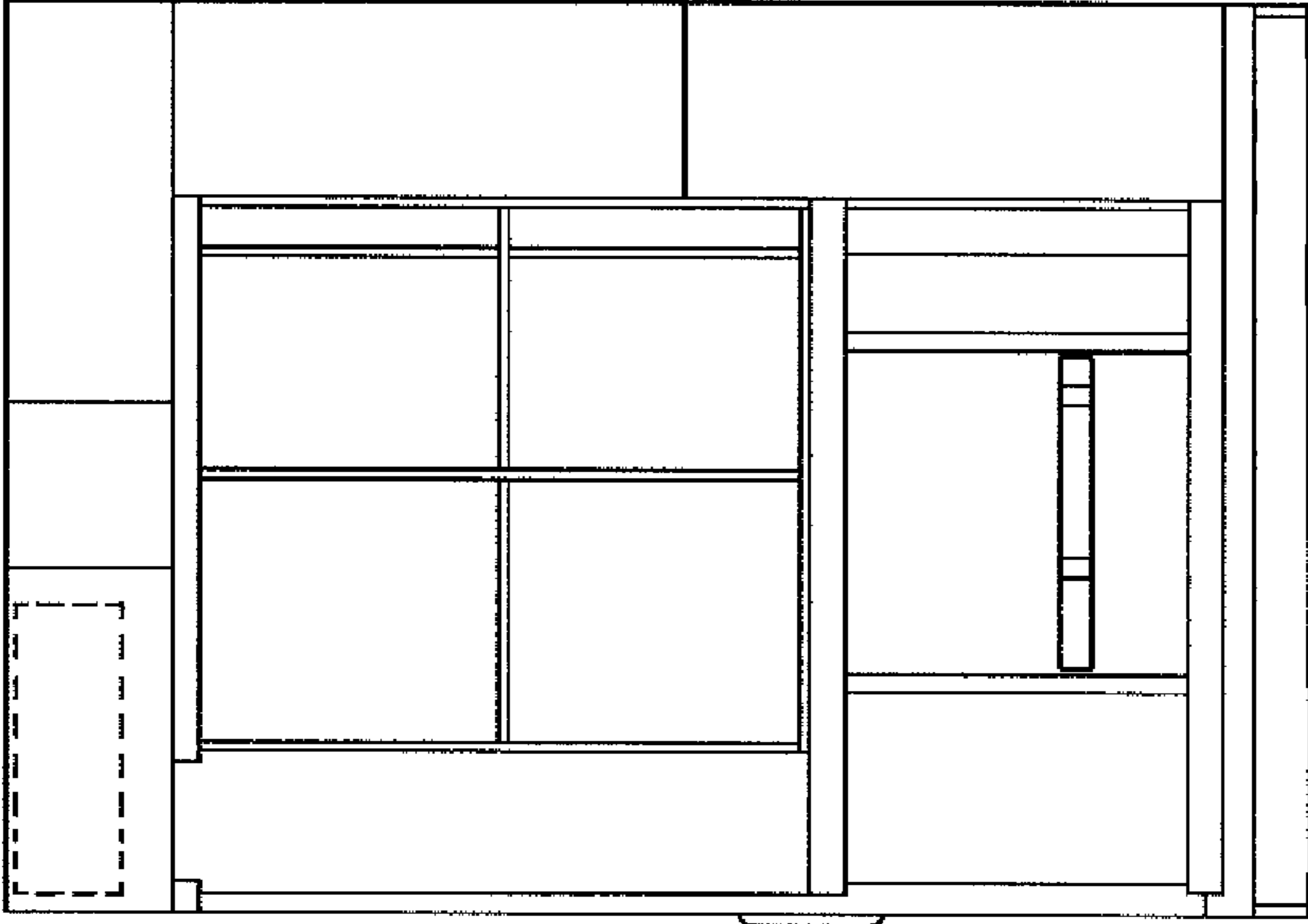

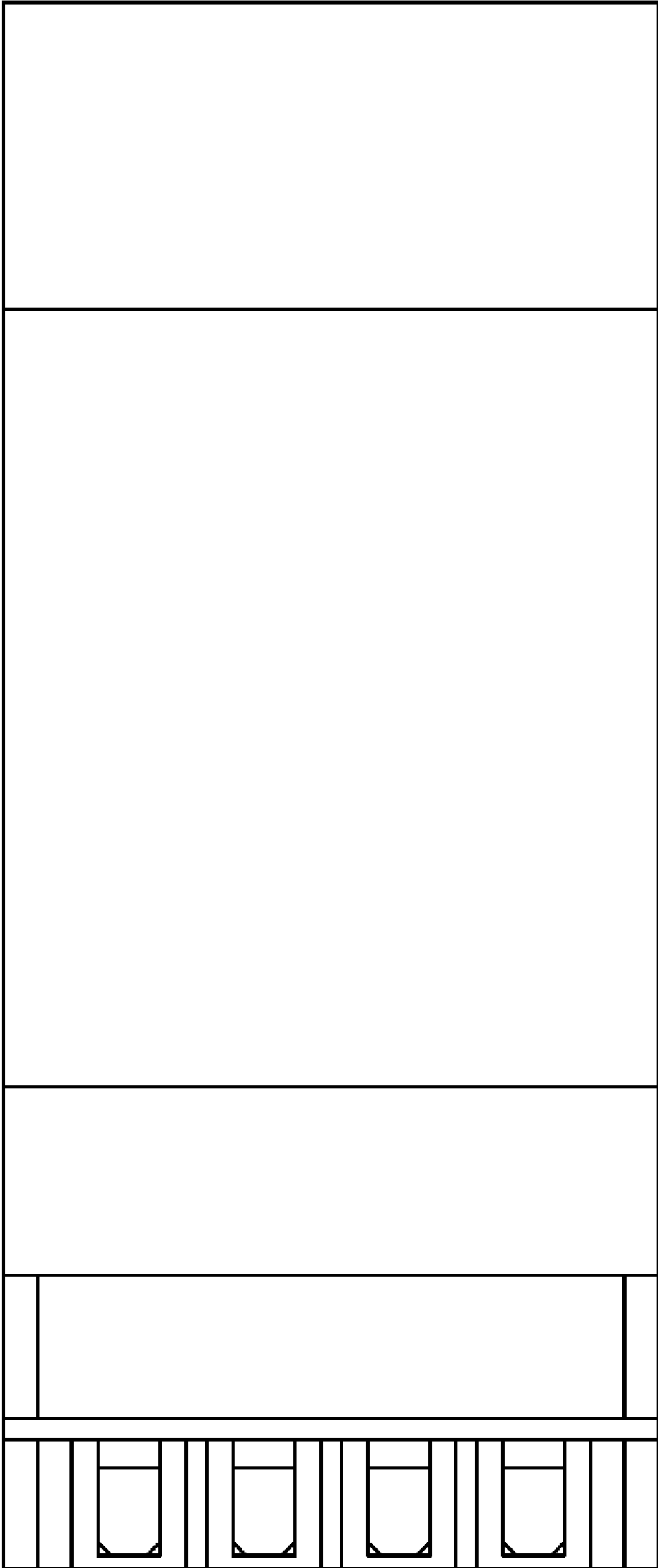
