(57) **CLAIM**

The ornamental design for a pen cap, as shown and described.

DESCRIPTION

FIG. 1 is an upper front right perspective view of a pen cap showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a right side elevation view thereof, with the left side elevation view being a mirror image of the right side elevation view;

FIG. 5 is an enlarged top plan view thereof; and,

FIG. 6 is an enlarged bottom plan view thereof.

The broken lines in FIGS. 1, 5, and 6 illustrate environmental structure and form no part of the claimed design.

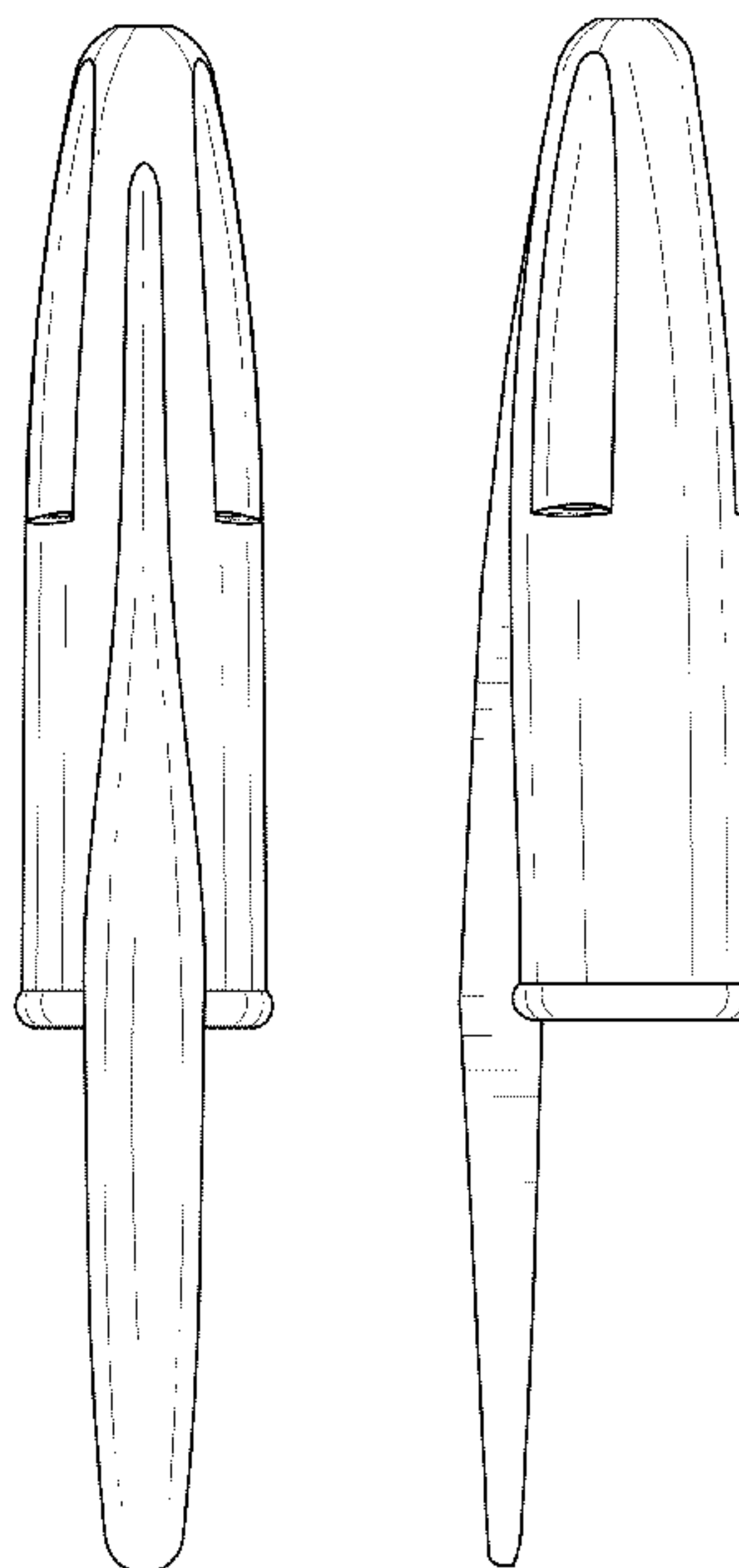

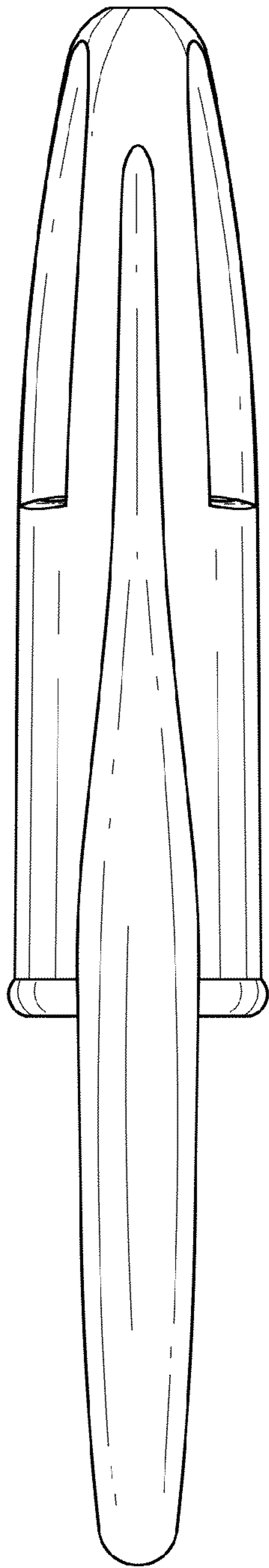

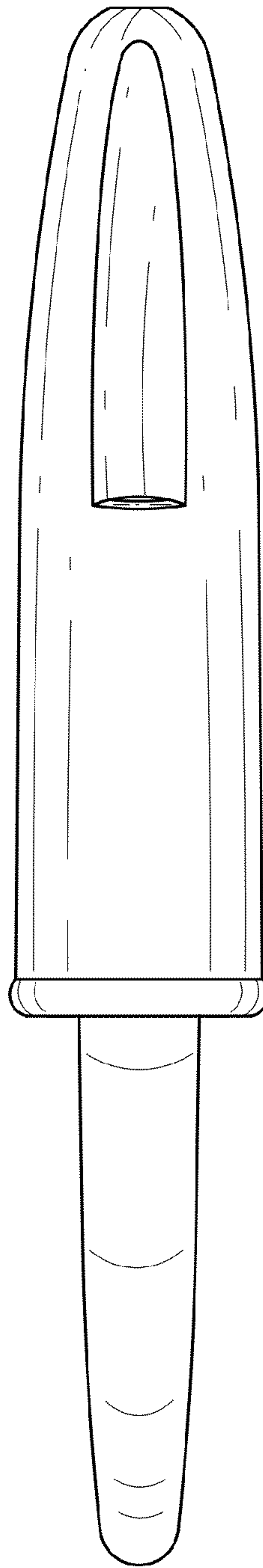
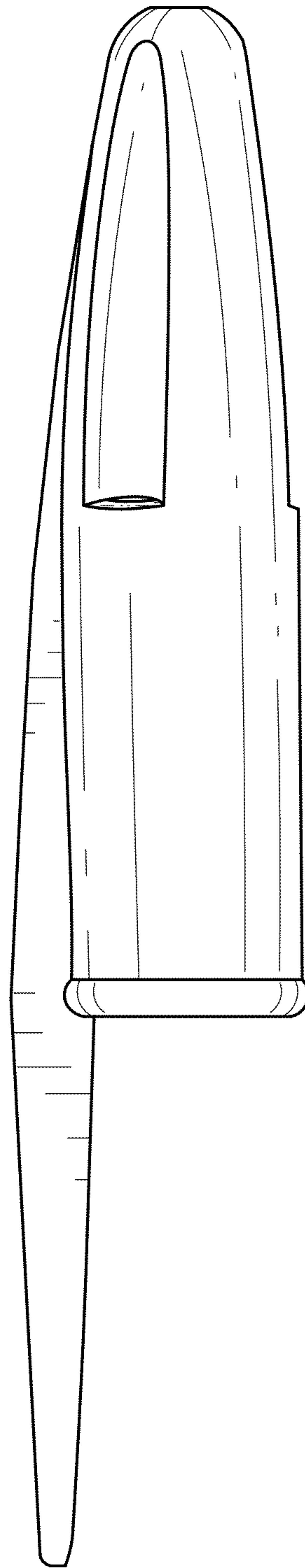

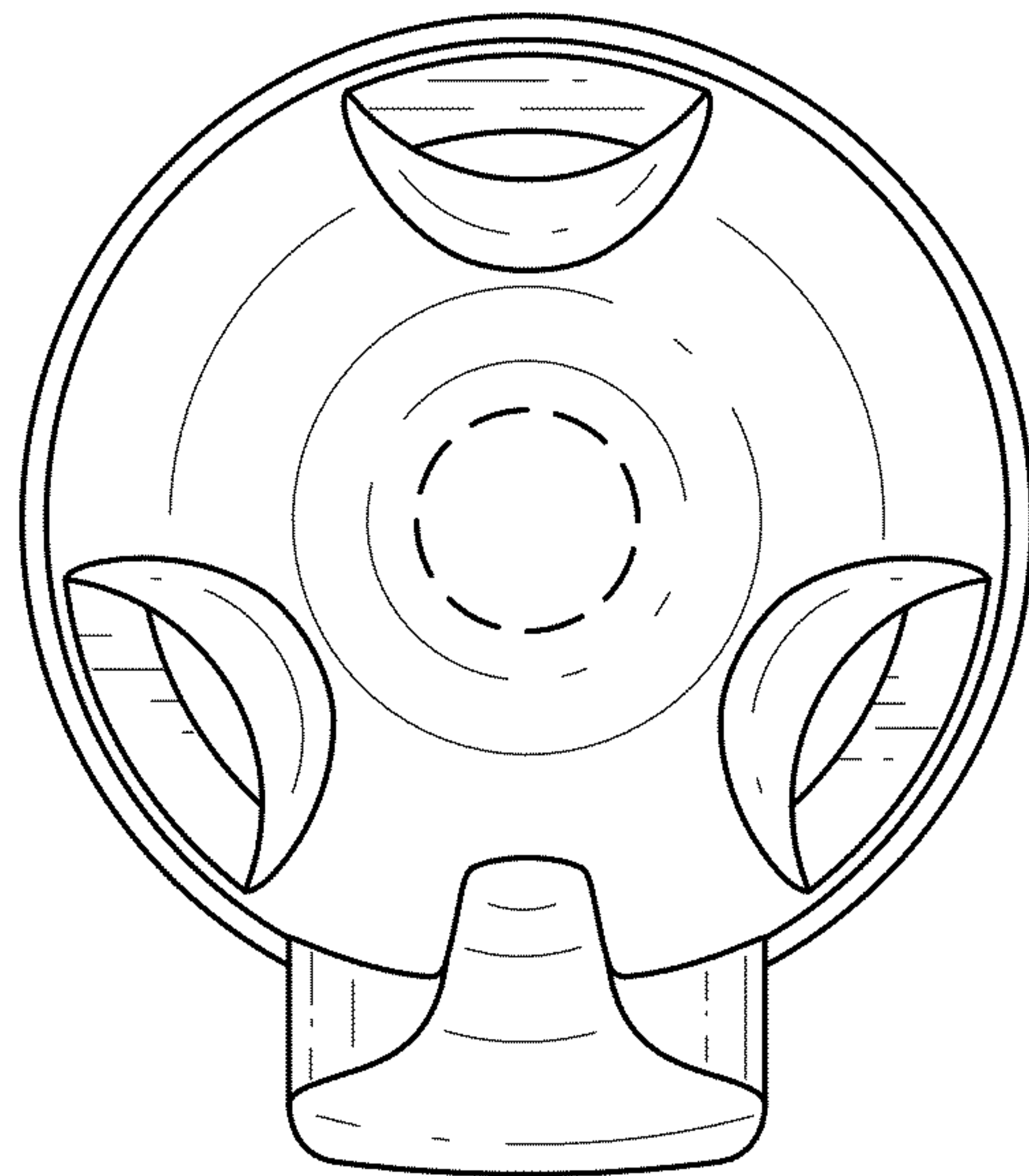

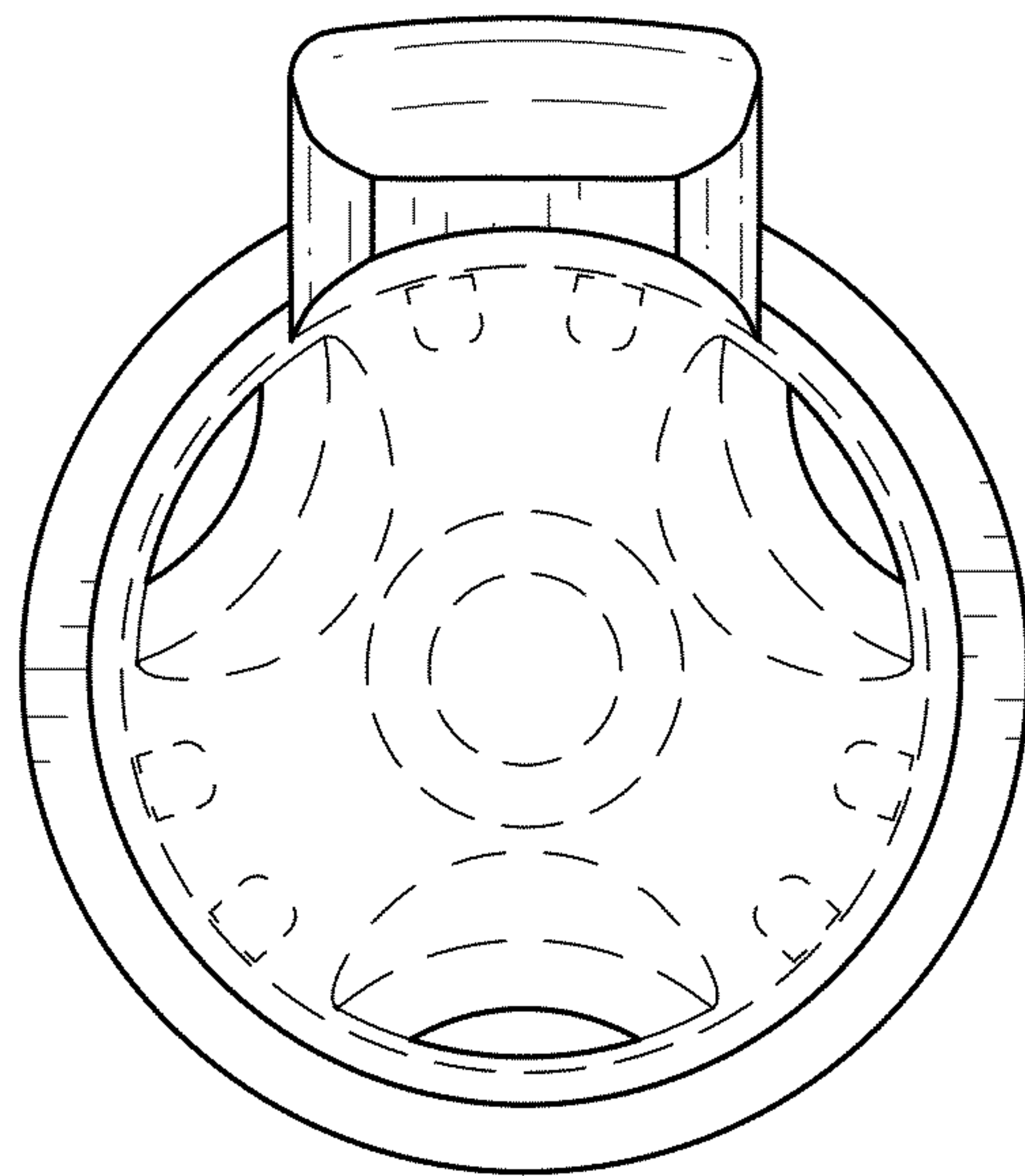
